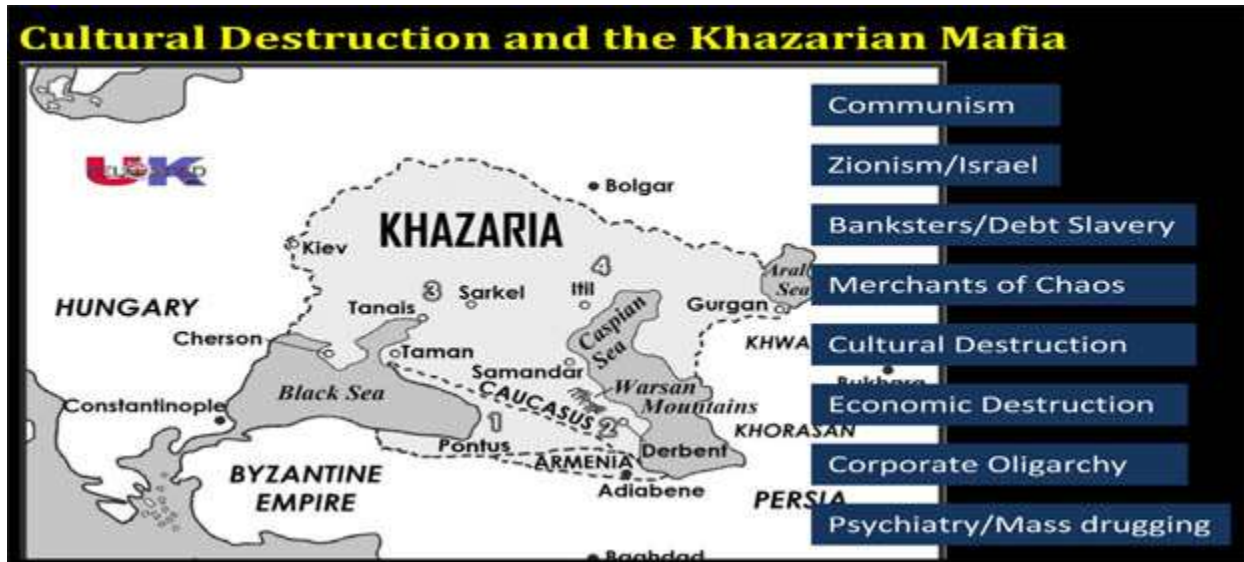
(6) The ascendancy of **New York City as the capital city of New York, the Empire State**, with the founding of the Wall Street bonds and securities trading companies in early 1700s, and then the New York Stock Exchange in 1792.

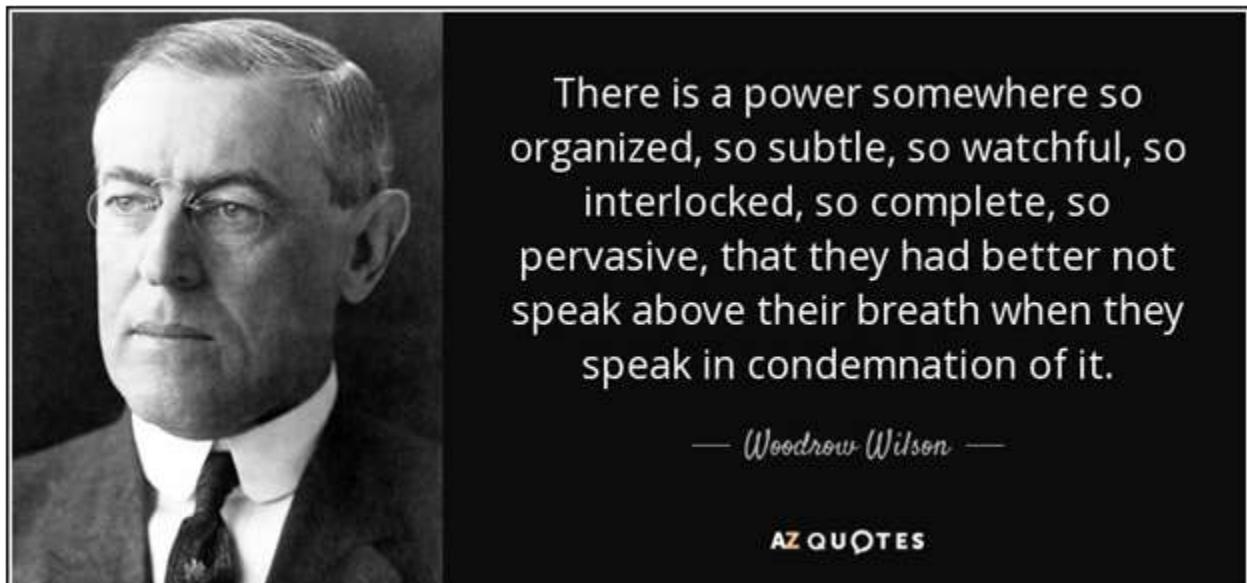

Pfizer 'CHOSE NOT TO' Tell Regulators About SV40 Sequence in COVID Shots – Health Canada Official

A senior Health Canada official says pharma giant Pfizer made a conscious decision to not advise regulators that its mRNA COVID-19 vaccine contained a DNA sequence from the Simian Virus 40 (SV40).

This information appears among multiple emails between staff from key drug regulators, including Health Canada (HC), the U.S. Food and Drugs Administration (FDA), and the European Medicines Agency (EMA). The information was obtained through an access-to-information request.

On Aug. 23, 2023, [Dr. Dean Smith](#), a senior scientific evaluator in HC's Vaccine Quality Division, wrote an email to a colleague at the FDA about SV40.

Health Canada had [obtained](#) confirmation two weeks earlier from Pfizer that SV40 DNA sequences were present in its COVID-19 vaccine.

"I understand that there have been internal discussions at CBER [Center for Biologics Evaluation and Research] regarding the presents [sic] of an SV40 enhancer/promoter sequence, noting that its presence is unrelated to the purpose of the Pfizer's plasmid as a transcription template for their mRNA COVID-19 vaccine," wrote Dr. Smith.

"Pfizer has communicated to us recently, that they apparently chose not to mention this information to EMA, FDA or HC at the time of their initial or subsequent submissions."

Dr. Smith added the information had been independently made public in April 2023, via a pre-print study from U.S. scientist Kevin McKernan.

Mr. McKernan, a genomics expert, had found quantities of DNA in the mRNA shots above the regulatory threshold set out by the health agencies. Dr. Smith wrote that the study had resulted in *"questions coming to agencies."*

'The Epoch Times' had contacted HC on the matter on July 17. The first email related to SV40 within Health Canada released in the access-to-information package was sent two days later, on July 19.

In that email, [Dr. Tong Wu](#) of HC's Vaccine Quality Division reached out to his colleague Dr. Michael Wall, a senior biologist evaluator.

"Co [Pham, executive director of HC's Centre for Vaccines, Clinical Trials and Biostatistics] agreed to have an IAS for the SV40 promoter sequence as we discussed today. We can talk about it tomorrow," Dr. Wu wrote. "IAS" could be a reference to an Issue Analysis Summary to evaluate a new regulatory affair.

As first [reported](#) by 'The Epoch Times' in October, Health Canada was not aware of the SV40 enhancer presence. Since then, the FDA and the EMA have both [confirmed](#) they also weren't aware of its presence.

Health Canada has since [maintained](#) that the SV40 enhancer/promoter sequence is a "residual DNA fragment" in Pfizer-BioNTech COVID-19 vaccine. *"The fragment is inactive, has no functional role, and was measured to be consistently below the limit required by Health Canada and other international regulators,"* the agency has repeatedly said.

'ZERO Checks'

This view has been challenged by Mr. McKernan and others, including Dr. Philip Buckhaults, professor of cancer genomics and director of the Cancer Genetics Lab at the University of South Carolina.

In response to the information released by Health Canada, Mr. McKernan posted a thread on the X platform. *"No prior vaccine in Canada has been approved with such a sequence contaminant,"* he said.

"Pfizer assured [HC] the sequence is not material to plasmid manufacturing," he [added](#). *"This is an overt lie. You cannot make plasmids without the promoter for the antibiotic resistance gene. It is active in mammalian cells. If it's not needed, why is it in there?"*

Mr. McKernan also noted how HC has asked Pfizer for its Polymerase Chain Reaction (PRC) protocol, saying this means *"they have performed ZERO checks on this DNA contamination themselves and are entirely relying on the word of the manufacturer."*

A response to a Canadian Member of Parliament's question tabled in the House of Commons by Health Canada appears to be in line with this observation. *"It is important to assess the results using the authorized validated assays performed by the vaccine manufacturers to ensure that the quality of commercial vaccine lots are comparable to lots shown to be safe and efficacious in clinical studies,"* [said](#) Health Canada in December.

Concerns related to the presence of unintended DNA in the mRNA shots pertain to their potential to integrate into the human genome and cause issues like cancer. The Florida State Surgeon General Dr. Joseph A. Ladapo has [called](#) for a halt of mRNA shots over these risks.

Health Canada said in March in a [document](#) tabled in Parliament that *“any claims that the presence of the SV40 promoter enhancer sequence is linked to an increased risk of cancer are unfounded.”*

Dr. Buckhaults has [started](#) a scientific study to ascertain those integration risks. On April 23, he [wrote](#) on X that he had confirmed previous findings that the amount of DNA in mRNA shots exceeds the limit set by regulators.

“Yes, there was more than 10 ng/dose. I am sure of it now,” he wrote while posting his methodology. This is the same threshold applied by Health Canada.

Even if the amount of DNA was below, there are still concerns the threshold was set for regular vaccines and not the new technology using lipid nano particles (LNP).

Dr. Buckhaults wrote that the *“10 ng limit is not appropriate for LNP encapsulated DNA,”* adding that *“as far as I know there have been no safety studies for this situation. It was not possible because of the abbreviated timeline during the emergency you saw authorization.”*

Seeking ‘Remedy’

In his August 23 email to the FDA employee, Dr. Smith said HC Canada did not view the SV40 issues as an *“urgent risk topic.”* However, the official responsible for evaluating the safety of vaccines expressed concerns about how news of the SV40 could impact the upcoming fall 2023 vaccination campaign.

“It would be unfortunate if the information circulating had a negatively [sic] impact on public acceptance of the vaccine this year or in the future,” he said.

Despite being of this view, Dr. Smith said regulating agencies should work to encourage Pfizer to *“remedy the situation”* before the campaign.

In the email, Dr. Smith said HC believed the upcoming rollout of the fall COVID-19 vaccine campaign meant the agencies should be *“on the same page.”*

Mr. Smith’s email was written a day after Pfizer provided a response to a Quality Clarifax submitted by HC around the SV40 promoter. If deficiencies are identified in Clinical Trial Applications, HC may request additional information, which [is known as a Clarifax](#).

On August 29, HC senior biologist Dr. Wall wrote an email to senior evaluator Dr. Tong Wu, where he said he and Mr. Smith agreed they should not inform Pfizer of their

interaction with the EMA and U.S. FDA on the SV40 promoter, “especially they [sic] do not seem to care much at this moment.”

“However, we cannot say nothing! Please see the following text that Julie and I worked out,” Mr. Wall added, before providing a draft comment to Pfizer’s response that was blacked out.

The same day, Dr. Wall also sent an email to Dr. Wu with a draft of the Clarifax questions to be sent to Pfizer, which included the statement, “Health Canada would continue to work with international regulatory partners to achieve harmonization regarding removal of these sequence elements from the plasmid for future strain changes.”

Pfizer did not respond to a request for comment from ‘The Epoch Times’.

Commenting on DNA contamination, Health Canada reiterated its previous position on the matter.

“Based on its evaluation of the data and scientific information for the vaccine, Health Canada has concluded that the risk/benefit profile continues to support the use of the Pfizer-BioNTech vaccine,” said spokesperson Anna Maddison.

Dr. David Speicher, a Canadian virologist who replicated the findings from Mr. McKernan and Dr. Buckhaults with Canadian mRNA vials, told ‘The Epoch Times’ he’s preoccupied about what’s been revealed in the internal Health Canada emails. He notes that while Health Canada has dismissed the DNA fragments as biologically inactive with no functional role, they judged worthy to hold discussions with other regulators.

“We know from testing several vials that the level of SV40 enhancer-promoter in the XBB.1.5 booster is at similar levels as the others Pfizer COVID modRNA vaccines, making it just as problematic,” he says. “Pfizer has not cleaned up the vaccine, yet the regulators are sadly more concerned about vaccine uptake in the population rather than the health risks from these vaccines.”

Simian Virus 40 (SV40) was Simian virus 40 (SV40) is a monkey virus which was accidentally administered to humans, in the years 1955-'63, through contaminated poliovirus vaccines. The subsequent findings of the transforming and oncogenity activities of the SV40 viral large T (Tag) and small t (tag) antigens, have prompted investigations into the potential of SV40 to induce cancer in humans.

SV40 was the 40th virus found in rhesus monkey kidney cells when these cells were used to make the polio vaccine. This virus contaminated both the

Inactivated Polio Vaccine (IPV) created by Dr. Jonas Salk and the Oral or "Live" Polio Vaccine (OPV) created by Dr. Albert Sabin.

Children were fed sugar cubes with the oral polio vaccine. In 1961, SV40 was discovered by Dr. Bernice Eddy of the National Institute of Health, Division of Biologics when she took the material used to grow polio vaccines and injected it into hamsters. Tumors grew in the hamsters. Her discovery was subsequently validated by Drs. Maurice Hilliman and Benjamin Sweet of Merck.

Upon the discovery that SV40 was an animal carcinogen that had found its way into the polio vaccines, a new federal law was passed in 1961 that required that no vaccines contain this virus. However, this law did not require that SV40 contaminated vaccines be thrown away or that the contaminated seed material (used to make all polio vaccines for the next four decades) be discarded. As a result, known SV40 contaminated vaccines were injected into children up until 1963. In addition, it has been alleged that there have been SV40-contaminated batches of oral polio vaccine administered to some children until the end of the 1990's.

By 1960, the Salk injectable polio vaccine (IPV) had been administered to about 98 million American children and adults, and Sabin's OPV had been administered to about 10,000 Americans and millions in the USSR where the clinical trials had been conducted. It was estimated that 10% to 30% of the vaccines contained live SV40.

An estimated 65 million adults died prematurely of various cancers as a result having received the Salk polio vaccine. Ironically, polio was later determined to have been caused by the spraying of DDT in urban areas. When DDT was banned in 1972, polio disappeared shortly after.

When you consider that at least 270,227,181 people or 81% of the population have received at least one dose, there is serious reason to be concerned about these recent revelations. Overall, 230,637,348 people or 70% of the population are considered fully vaccinated. With a spike in cancers in 2023 and 2024 there is reason to be concerned about the relationship of SV40 in the Covid vaxxes.

Stir them up. Set one against the other. Divide and conquer. [That's the way to soften up a democracy.](#)"— J. Edgar Hoover, Masters of Deceit

["Nothing is real,"](#) observed John Lennon, and that's especially true of politics.

Much like the fabricated universe in Peter Weir's 1998 film [The Truman Show](#), in which a man's life is the basis for an elaborately staged television show aimed at selling products and procuring ratings, the political scene in the United States has devolved over the years into a carefully calibrated exercise in how to manipulate, polarize, propagandize and control a population.

Take the media circus that is the Donald Trump [hush money trial](#), which panders to the public's voracious [appetite for titillating, soap opera drama](#), keeping the citizenry [distracted, diverted and divided](#).

This is the magic of the reality TV programming that passes for politics today.

Everything becomes entertainment fodder.

As long as we are distracted, entertained, occasionally outraged, always polarized but largely uninvolved and content to remain in the viewer's seat, we'll never manage to present a unified front against tyranny (or government corruption and ineptitude) in any form.

Studies suggest that the more reality TV people watch—and I would posit that it's all reality TV, entertainment news included—the more difficult it becomes to distinguish between what is real and what is carefully crafted farce.

“We the people” are watching a lot of TV.

On average, Americans spend five hours a day watching television. By the time we reach age 65, we're watching more than 50 hours of television a week, and that number increases as we get older. And reality TV programming consistently captures the largest percentage of TV watchers every season by an almost 2-1 ratio.

This doesn't bode well for a citizenry able to sift through masterfully-produced propaganda in order to think critically about the issues of the day.

Yet look behind the spectacles, the reality TV theatrics, the sleight-of-hand distractions and diversions, and the stomach-churning, nail-biting drama that is politics today, and you will find there is a method to the madness.

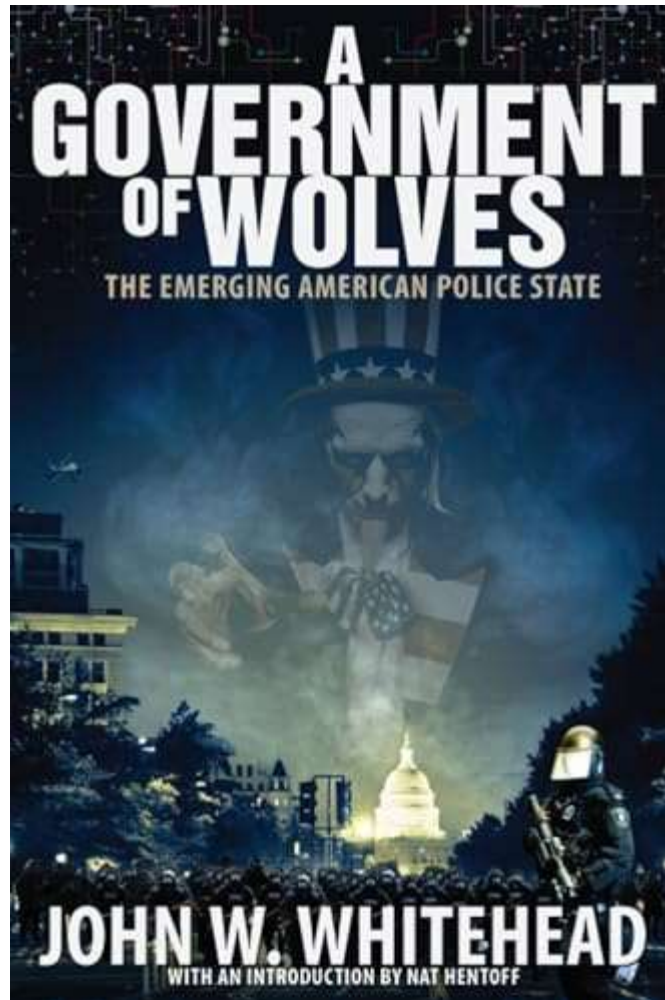
We have become guinea pigs in a ruthlessly calculated, carefully orchestrated, chillingly cold-blooded experiment in how to control a population and advance a political agenda without much opposition from the citizenry.

This is how you persuade a populace to voluntarily march in lockstep with a police state and police themselves (and each other): by ratcheting up the fear-factor, meted out one carefully calibrated crisis at a time, and teaching them to distrust any who diverge from the norm through elaborate propaganda campaigns.

Unsurprisingly, one of the biggest propagandists today is the U.S. government.

Add the government's inclination to monitor online activity and police so-called “disinformation,” and you have the makings of a restructuring of reality straight out of Orwell's *1984*, where the Ministry of Truth polices speech and ensures that facts conform to whatever version of reality the government propagandists embrace.

This “*policing of the mind*” is exactly the danger author Jim Keith warned about when he predicted that “information and communication sources are gradually being linked together into a single computerized network, providing an opportunity for unheralded control of what will be broadcast, what will be said, and ultimately what will be thought.”

You may not hear much about the government's role in producing, planting and peddling propaganda-driven fake news—[often with the help of the corporate news media](#)—because the powers-that-be don't want us skeptical of the government's message or its [corporate accomplices in the mainstream media](#).

However, when you have social media giants colluding with the government in order to censor so-called disinformation, all the while the mainstream news media, which is supposed to act as a bulwark against government propaganda, has instead become the mouthpiece of the world's largest corporation (the U.S. government), the [Deep State has grown dangerously out-of-control](#).

In its article, "*How the American government is trying to control what you think,*" the *Washington Post* [points out](#) "Government agencies historically have made a habit of crossing the blurry line between informing the public and propagandizing."

This is mind-control in its most sinister form.

The end goal of these mind-control campaigns—packaged in the guise of the greater good—is to see how far the American people will allow the government to go in re-shaping the country in the image of a totalitarian police state.

In this way, they will never reach consensus about anything and will be too distracted to notice the police state closing in on them until the final crushing curtain falls.

This Machiavellian scheme has so ensnared the nation that few Americans even realize they are being brainwashed—manipulated—into adopting an "us" against "them" mindset. All the while, those in power—bought and paid for by lobbyists and corporations—move their costly agendas forward.

This unseen mechanism of society that manipulates us through fear into compliance is what American theorist Edward L. Bernays referred to as “[an invisible government which is the true ruling power of our country.](#)”

It was almost 100 years ago when Bernays wrote his seminal work ‘*Propaganda*’:

In almost every act of our daily lives, whether in the sphere of politics or business, in our social conduct or our ethical thinking, we are dominated by the relatively small number of persons...who understand the mental processes and social patterns of the masses. It is they who pull the wires which control the public mind.”

To this invisible government of rulers who operate behind the scenes—the architects of the Deep State—we are mere puppets on a string, to be brainwashed, manipulated and controlled.

All of the distracting, disheartening, disorienting news you are bombarded with daily is [being driven by propaganda](#) churned out by one corporate machine (the corporate-controlled government) and fed to the American people by way of yet another corporate machine (the corporate-controlled media).

Maduro's Venezuela Hires the Rothschild's To Help Restructure Its Foreign Debt

The world is a complex place, in which you may find a socialist Latin American strong man locking arms with one of the most powerful capitalist (and Globalist) families in the world.

Right now, the diplomatic and commercial relations between the U.S. and Venezuela are at a very low point, after the U.S. re-imposed sanctions on the oil and gas industries.

The clueless Joe Biden administration tried to engage dictator Nicolas Maduro, but his utter failure to live up to his promises – to hold a fair Presidential election – have made the return of the sanctions inevitable.

Venezuelans are set to vote on July 28 in a rigged election that will pit Maduro against the opposition candidate, ambassador Edmundo Gonzalez.



Now, Venezuela's government has hired Rothschild & Co. as a 'financial adviser' to provide an overview of its foreign debt obligations.

Bloomberg reported:

"Rothschild is working to map out what the administration owes and to whom, said the people, who asked for anonymity to discuss a contract that has not been made public. Debt mapping is normally a preliminary step taken by a government before it prepares to start a restructuring."

One is left wondering what warrants such secrecy.

"Venezuela owes roughly \$154 billion to overseas lenders — according to an estimate from economist Francisco Rodriguez, a professor at the University of Denver — including global bonds issued by the government and state oil company, which have been in default for more than six years. It's been accumulating interest on those bonds and court judgments for unpaid commercial loans."

Sovereign bonds trade for around 20 cents on the dollar, while defaulted notes issued by Petroleos de Venezuela SA exchange hands for around 11 cents, according to indicative pricing compiled by Bloomberg. The debt has rallied since JPMorgan Chase & Co. laid out a plan to re-weight the securities in widely followed emerging-market debt indexes back in February."

The hiring of Rothschild & Co. comes as Maduro's administration means to reengage with global markets, institutions and ratings firms after years as an international pariah.

Maduro has hinted to be willing to work with creditors, but talks have never progressed.

"Washington doesn't recognize Maduro, and sanctions prohibit the government from selling debt on U.S. markets. Sanctions would need to [be] changed before a debt restructuring could be carried out."

Biden Blocks New Alaska Oil and Gas Leases to Save Polar Bears, Caribou, Blocks Key Mining Road

The Biden administration announced two major wins for the far-left environmentalists last Friday: it will block new oil and gas leasing on 13 million acres in Alaska's federal petroleum reserve to protect local wildlife caribou and polar bears, and it will stop development on an access road for mining companies that was previously approved by the Trump administration.

Biden announced the government is blocking the development of the “Ambler Road,” a 211-mile access road that would have given mining companies the ability to access leased land for mineral development.

The far-left environmentalist group the Sierra Club called the decision a “major victory.”



This Biden decision bans oil and gas drilling in nearly half of the Alaska petroleum reserve. The reserve is 23 million acres of public land for a national emergency oil supply originally intended for the U.S. Navy, created in the early 1920s.

Even though pump prices have remained high for most Americans, and the high prices affect the working poor the most, Biden has been regularly canceling and terminating energy development leases, as he did several times in 2023.

Alaska’s entire Congressional delegation criticized the decisions last week.

“Closing off NPR-A is a huge step back for Alaska, failing to strike a balance between the need for gas oil and natural gas and legitimate environmental concerns, and steamrolling the voices of many Alaska Natives in the decision-making process,” Rep. Mary Peltola, D-Alaska, said in a joint statement issued by the three-member delegation. *“The Ambler Road decision is premature, as real conversations among stakeholders in the region are ongoing. Alaska has a wealth of natural resources that can be responsibly developed to help boost domestic manufacturing and innovation —*

in the end, it should be up to Alaskans to decide what they want developed in their regions.”

This comes on the heels of the news that U.S. crude oil prices have risen 15% year to date due to stronger demand, tighter supplies due to OPEC+ production cuts, and mounting political risks in the Mideast and Eastern Europe.

The size of the land Biden blocked from development, 13 million acres, or 20,000 square miles, is a little smaller than the [footprint of West Virginia](#).



The primary energy development in the area is the ConocoPhillips-owned Willow project. ConocoPhillips' two largest stakeholders [are the Vanguard Group and the controversial BlackRock investment group, who each own about 9% of the firm](#). The ConocoPhillips project is scheduled to open in 2029, it will now not have any competitors.

Vanguard and Black Rock set policies to comply with their master HRH King Charles agenda set forth at COP28 and now showing their ugly faces into the larger global economy. As the O'Biden administration carry out their task of tightening the rope around the neck of the U.S. public, consumers face ever rising prices at the gas pump.



According to ConocoPhillips, [the Willow project will create \\$8-17 billion more in federal tax revenues, thousands of jobs, and produce 600 million barrels of oil](#) over the project's lifetime. The price of a barrel of oil is roughly \$87, so the total value of the project would be \$52.2 billion.

John Podesta, senior adviser to the president for international climate policy, said the pair of decisions would conserve Alaska lands for generations.

"The Biden-Harris administration has now protected more than 41 million acres of lands and waters across the country, leaving a huge mark on the history of American conservation," Podesta said in a statement.

Elsewhere, Biden's administration [promised the public that they would take all steps necessary to keep gas prices low](#).

Alaska Natives criticize the drilling ban in the Western Arctic as it impacts a significant portion of the NPR-A land. Nearly all Alaskan citizens typically [receive an annual check for their share of state dividends from energy proceeds, a program known as the "Permanent Fund Dividend."](#) Last year the checks were for \$1,312.

The decision aims to protect animal species from so-called "global warming" affecting the Arctic. Elites are obsessed with 'saving' the Arctic, [even though their predictions about ice melt, extinction, rising sea levels, never come true](#).

To control prices during the outset of the Russia-Ukraine war, [Biden sold half of America's 'Strategic Petroleum Reserve'](#) and has [struggled to refill it due to rising gas prices](#).

Iran Threatens To Annihilate Israel, Meets with Pakistan - A Nuclear Power

President Raisi has sent a pointed warning to the Israeli Government.

Iranian President Ebrahim Raisi has threatened Israel with annihilation if it attempts to attack Iran again.

Raisi arrived in Pakistan on Monday for a three-day visit. He addressed the recent tensions between Tehran and West Jerusalem at an event in Punjab on Tuesday.

“If the Zionist regime once again makes a mistake and attacks the sacred land of Iran, the situation will be different, and it is not clear whether anything will remain of this regime,” the state news agency IRNA quoted Raisi as saying.

Israel never officially acknowledged an April 1 airstrike on the Iranian consulate in Damascus, Syria that killed seven senior officers of the Islamic Revolutionary Guard Corps (IRGC) Quds Force. Tehran nevertheless retaliated on April 13, firing scores of drones and missiles at several targets in Israel.

Iran has shrugged off a series of reported explosions near the city of Isfahan last Friday, which were rumored to be a response from Israel. West Jerusalem did not acknowledge the reported attack, while criticizing a cabinet minister who spoke about it out of turn. Tehran chose to ignore it rather than deliver the promised swift and severe reprisal.

The Islamic Republic has vowed on multiple occasions to wipe out, destroy or annihilate the *“Zionist regime,”* as it calls Israel.

Speaking in Lahore on Tuesday, Raisi vowed to continue *“honorably supporting the Palestinian resistance.”* He also denounced the US and the collective West as *“the greatest violators of human rights,”* pointing to their support for the Israeli *“genocide”* in Gaza.

So far, more than 34,000 Palestinians in the enclave have been killed in Israeli military operations.

Marking 200 days of war, Hamas calls for Escalation Across All Fronts

Terror group’s spokesman says Iranian attack on Israel ‘set new rules’ for confronting Jewish state, calls increased action against Israel in the West Bank and Jordan.

DUBAI — The spokesperson for Hamas’s armed wing the Izz ad-Din al-Qassam Brigades, Abu Obeida, called on Tuesday for an escalation across all fronts in a televised speech marking 200 days since the start of the Israel-Hamas war in October.

The war began with the shock Hamas assault on October 7, when thousands of terrorists invaded southern Israel, killing nearly 1,200 people, mostly civilians, and seizing 253 hostages.

Israel launched an aerial assault and ground offensive in Gaza in response, vowing to eliminate Hamas and end the terror group's rule of Gaza.

The Hamas-run Gaza health ministry has placed the Palestinian death toll since October 7 at over 34,000 people, although this figure cannot be independently verified and does not differentiate between civilians and combatants. Israel says it has killed some 13,000 Hamas gunmen in battle, as well as some 1,000 terrorists inside Israel on October 7.

In a video aired by Al Jazeera TV, Abu Obeida praised Iran's attack on Israel on April 13, saying the direct strikes with hundreds of explosive drones and missiles *"set new rules, drew important equations, and confused the enemy and those behind it."*

Israel and regional allies largely repelled the attack, with only minor damage to a military base, and one person, a seven-year-old girl, seriously injured.

He also called for an escalation in the West Bank and Jordan, which he called *"one of the most important Arab fronts."*

Jordan, which lies between Iran and Israel, intercepted and shot down dozens of Iranian drones that entered its airspace and were heading to Israel, two regional security sources said earlier this month.

“We call on the Jordanian people to step up their actions and raise their voices,” Abu Obeida said.

He said Hamas was sticking to its demands at the ongoing ceasefire talks – that Israel end its military offensive, pull out forces from Gaza, allow displaced Palestinians to return to northern Gaza and lift the military blockade.

“The government of the occupation is stalling in reaching a hostages-swap deal and is trying to obstruct efforts by the mediators to reach a ceasefire agreement,” Abu Obeida said.

Qatar and Egypt have been trying to mediate a truce that would see the release of Israeli hostages, but Qatar foreign ministry’s spokesman Majed al-Ansari said earlier on Tuesday all concerned parties should *“show seriousness”* in allowing such efforts to succeed.

Israel has said Hamas’s demands for an end to the war are a non-starter.

Washington has argued that Israel has agreed to some major concessions in the talks, but that Hamas has refused to budge on its demands.

Abu Obeida's comments also come as the Gulf state said it had no plans to end Hamas leaders' presence in the country as negotiations continue. *"As long as their presence here in Doha, as we have always said, is useful and positive in this mediation effort, they will remain here,"* al-Ansari told a press conference.

Doha has rebuffed frequent criticism of its mediation from Israel, including by Prime Minister Benjamin Netanyahu. [Reports](#) circled around the past couple of days saying that Hamas's political chiefs were exploring moving their base of operations out of Qatar, with Oman serving as a potential option.

'The Wall Street Journal' noted that if Hamas leaders were to leave Doha, it could be more difficult for negotiations to be held with the terror group.

Qatar has hosted Hamas's politburo leaders since 2012.

The Islamist government of Qatar confirmed on Tuesday that it is open to continuing to host the leadership of the jihadist terror organization Hamas as long as doing so is *"useful and positive."*

Qatar has offered safe haven and extravagant hotel lodgings to Hamas's most senior leaders since 2012. While Hamas is the government of the disputed Gaza Strip, its top "political" leaders live in Doha. Ismail Haniyeh, the top Hamas *"political"* leader, is believed to be worth over \$4 billion and he and his family often show off their wealth.

"He [Haniyeh] and his associates have been photographed flying in private jets, enjoying fine dining, and attending international sporting events," the Foundation for the Defense of Democracies (FDD) observed in January.

Qatari Foreign Ministry spokesman Majed al-Ansari was responding on Tuesday to questions about other senior leaders in Doha expressing frustration with the lack of progress in Qatari-hosted talks between Hamas and the government of Israel.

The talks followed the brutal Hamas invasion and murder, rape, and torture spree within Israel on October 7. Hamas killed an estimated 1,200 people on that day and took 250 hostages, of which 133 are believed to remain in terrorist captivity.

Following October 7, Qatar hosted multiple rounds of discussions between Hamas and Israel intended to result in the liberation of the hostages. Those talks have stalled, however, and the Qataris grumbled last week that their country had experienced unspecified *"exploitation and abuse"* from *"politicians"* looking to promote themselves at the expense of the reputation of Qatar. As a result, Doha was *"reevaluating"* its role as a mediator, officials said.

Ansari clarified on Tuesday that the alleged *“exploitation and abuse”* in question came from Israel, whose leaders had questioned the friendly ties between Doha and the terrorists who had just invaded the country. Qatar is still reevaluating its position as mediator, he said, but not expecting to evict the wealthy Hamas leadership in Doha anytime soon.

“As long as their presence here in Doha, as we have always said, is useful and positive in this mediation effort, they will remain here,” Ansari said, according to the Agence France-Presse (AFP).

“As long as Qatar’s mediation efforts continue, there is no justification for the end [of] the presence of the Hamas political bureau in Doha,” the Qatari outlet al-Jazeera quoted Ansari as saying. *“This office was opened – in coordination with the United States – for the purpose of mediation between both sides. As of now, nothing has changed in that regard.”*

Ansari also accused *“ministers in Netanyahu’s government”* of needlessly antagonizing Qatari, without offering examples of the alleged disrespect.

“We have deep frustration with such statements especially from Israeli officials familiar with our mediation efforts and humanitarian work in Gaza,” al-Jazeera quoted him as saying. *“Attacking the mediator does not show commitment. And this is what we are getting from our Israeli counterparts. We’ve been accused of having ulterior motives. This is simply untrue.”*

“They all know what the Qatari role is, its nature, and its details during the previous stage and they lied,” Ansari concluded.

Qatar enjoys a unique position in the Middle East that allows it to maintain close ties to terrorists such as Hamas and the Afghan Taliban, which it hosted for years before the jihadists seized Kabul as a result of President Joe Biden’s failures in 2021, while also hosting a U.S. military base. Biden elevated ties with Qatar to *“major non-NATO ally”* status in 2022, a privilege Republicans in Congress have challenged after Qatar refused to abandon Hamas following the October 7 atrocities.

Apparently undermining Ansari’s claims to Qatar being a neutral mediator in the ongoing crisis, Islamist Turkish President Recep Tayyip Erdogan – an unabashed supporter of Hamas who met with Haniyeh on Saturday – said that the Qatari government viewed Hamas as *“family.”*

“The sincerity they [Qatar] have towards them [Hamas], their stance toward them, has always been like a member of the family,” Erdogan said on Tuesday, according to al-Jazeera. *“In the coming period, I absolutely do not think it is possible for them to change this approach.”*

The suspected offending comments from Israel that outraged the Qatari government included remarks in January in which Prime Minister Benjamin Netanyahu allegedly called Doha “problematic.”

“Qatar, as far as I’m concerned, is not significantly different from the UN, is not significantly different from the Red Cross, and to some extent it’s even more problematic,” Netanyahu allegedly said.

Prime Minister Mohammed bin Abdulrahman bin Jassim al-Thani announced last week that his country was entering *“a complete re-evaluation of its role”* as a go-between for Hamas and Israel.

“There is exploitation and abuse of the Qatari role,” he claimed, accusing accused *“politicians”* of *“trying to conduct election campaigns by slighting the State of Qatar.”*

While Ansari stated on Tuesday that Qatar was upset with Israeli politicians, al-Thani’s remarks followed the introduction of a bill in the U.S. House of Representatives in early April to strip Qatar of its status as a *“major non-NATO ally.”*

“Major Non-NATO Ally status is a privilege and countries like Qatar must continuously earn,” Sen. Ted Budd (R-NC), who co-sponsored the bill, said at the time. *“Failure to take action against Hamas is beginning to look like tacit support for a foreign terrorist organization designated by the United States.”*

The Qatari embassy in Washington condemned the bill as *“reckless.”*

Iranian anti-ship Missiles Deployed in the Caribbean

While the Western navy group was stuck in the Red Sea, protecting the remnants of shipping there from attacks by drones and Houthi missiles, Iranian-made CM-90 anti-ship missiles appeared in the *"backyards"* of the United States itself. Last week, Venezuela demonstrated them in the arsenal of its fleet, reports the Latin American military portal Zona-Militar.

As part of the celebration of the next anniversary of the Bolivarian Navy of Venezuela (ABV), the country's Minister of Defense Vladimir Padrino Lopez at the Agustin Armario naval base in Puerto Cabello inaugurated a small complex of facilities equipped for the operation and technical support of the CM-90.

The deployment of the new CM-90 anti-ship missiles is believed to be part of the process of retrofitting the new Peykaap missile boats. Designed as another means of coastal defense, these fast and maneuverable vessels are well armed for their size, with

anti-ship missile launchers and torpedo tubes, supplemented in later models with remote weapon stations.

Venezuela also purchased the mentioned missile boats last year from Iran (at least four units), where their similar counterparts are called “Zolfagar” and, in turn, are a “clone” of the North Korean design in its latest version Peykaap-III. Each of these missile boats is capable of carrying up to two anti-ship missiles.

As for the CM-90 cruise missile, it was officially presented by Iran in 2022 at the DIMDEX arms exhibition. It has a diameter of 280 mm and a length of 4,16 m, weighs about 350 kg and is capable of carrying a warhead weighing up to 150 kg. According to Iranian military statements, the missile is equipped with an active targeting radar and a turbojet engine, providing a range of up to 90 kilometers. Being subsonic (speed 0,8 Mach), the CM-90, unlike the simpler variants of the Yemeni Houthis, has some “*protection against enemy air defenses,*” although the latter is regarded with skepticism by Western military experts.

Venezuela's demonstration of its new weapons came at a time when its relations with the United States were once again aggravated, dissatisfied with the results of recent elections that strengthened the power of incumbent President Nicolas Maduro.

The license, which significantly eased U.S. oil sanctions against Venezuela, expired on April 18. However, U.S. President Biden has already announced that it will not be extended, which means significant damage for Venezuela.

Spanish-language military websites also highlight that military relations between Iran and Venezuela have deepened significantly in recent years, reflecting a strategic alliance in the face of external pressure, especially from the United States.

In this regard, another segment being explored by Venezuela, following the trends observed in the Ukrainian conflict, is the development of loitering ammunition based on the models of the Iranian Shahed family, actively used by Russia. The potential Venezuelan analogue has already been designated Zamora V-1

US Bases in Iraq and Syria Come Under Rocket and Drone Attack

U.S. troops in Iraq and Syria came under two separate rocket and drone attacks in less than 24 hours, [Reuters reported Monday](#), citing U.S. and Iraqi officials.

The officials said the attacks were the first since a nearly three-month pause started in February. The Iraqi government and Iran had pressured Iraqi Shia militias to stop targeting U.S. bases after three U.S. Army Reserve soldiers were killed at Tower 22 in Jordan.

A drone attack targeted the Ain al-Asad air base in western Iraq, and five rockets were fired at a base in Rumalyn, a remote area of northeast Syria. No casualties were reported in either attack.

A Pentagon official [later told Stars and Stripes](#) that a fighter jet from the U.S.-led coalition in Iraq and Syria launched an airstrike against a rocket launcher but did not specify where.

The attacks came after an explosion hit a base south of Baghdad that killed one member of the Popular Mobilization Forces (PMF), an umbrella group of Iraqi militias that's part of Iraq's security forces. The cause of the blast is unknown and is being investigated.

Reuters initially reported that after the rocket attacks, a Telegram channel affiliated with Kataib Hezbollah, one of Iraq's most powerful Shia militias, announced that attacks on U.S. forces resumed because there was no progress toward a U.S. withdrawal. However, Kataib Hezbollah denied issuing the statement, [calling it "fabricated news."](#)

Iraqi Prime Minister Mohammed Shia al-Sudani [visited Washington last week](#) but left with no clear timeline for a U.S. withdrawal, and both the US and Iraq left open to the possibility of a continued U.S. presence in Iraq even if the international anti-ISIS coalition ends its mission.

Earlier this year, al-Sudani was calling for an end to the U.S. presence as the U.S. was bombing PMF fighters in response to attacks on U.S. bases in Iraq and Syria. Starting in October 2023, U.S. bases were targeted hundreds of times until the end of January due to U.S. support for the Israeli slaughter of Palestinians in Gaza.

The White House is Considering Declaring a National Climate Emergency and Giving the President Covid-like Powers

On April 20, 2024, Fox Business News reported that President Joe Biden is considering declaring a national climate emergency and giving himself emergency war-like powers. These are special emergency powers intended to enable the federal government to respond swiftly to threats to national security and public safety. This would grant the president significant authority to use emergency powers to combat climate change without the help of the U.S. Congress.

According to Fox News, Joe Biden would have Covid-like authority if he declared a climate emergency. Eusebius (op. cit. iii. 20. 8, 9) records that John was sent to Patmos by Domitian, and that when those who had been unjustly banished by Domitian were released by his successor, Nerva (A.D. 96–98; see Vol. VI, p. 87), the apostle returned to Ephesus.

Thus, the early Christian testimony places the writing of the book of Revelation in the time of Domitian’s reign. The external evidence states that Christians were imprisoned during the time of Domitian. The evidence agrees with Revelation 1:9. Persecution of Christians had reached a peak during Emperor Domitian’s reign (A.D. 81-96).

‘*Covenant Brothers: Evangelicals, Jews, And U.S.-Israeli Relations*’ by Daniel G. Hummel, University of Pennsylvania Press, 352 pages, \$49.95 addresses what many call Christian Zionism Heresy. Here is a scholarly look at a phenomenon that gets little coverage. Daniel G. Hummel writes:

“Evangelical Christianity remains one of the few topics about which it remains permissible, and possibly even praiseworthy, for a Jewish liberal to know nothing. Take evangelical attitudes toward Israel. Almost every time the subject comes up, someone will explain that Christian Zionism conceals, under a cloak of philo-Semitism, a nefarious agenda. Christian Zionists support Israel, supposedly, to hasten the end-times, when, as Bible professor Candida Moss writes, “Jews must convert or die.” Political scientist Elizabeth Oldmixon explains that evangelicals are part of “movement in Christianity that’s as old as Christianity itself,” and want to hasten “a millennium in the future,” in which “the Jews, will convert” or be damned.”

“This narrative is very popular with liberal and leftist Jews. Benjamin Koatz writes of Christians United For Israel’s “esoteric anti-Semitism” and that Christian Zionists believe Jews “will be prodded into conversion by the horrors of anti-Semitism... [or] God will

inspire revelation in our hearts at the last moment, allowing us to proceed willingly into rapture.” The same logic underlies Rabbi Lynn Gottlieb’s article, “Anti-Semitism Behind the Christian Zionist Lobby.”

As Daniel G. Hummel documents in his new book, *“Covenant Brothers: Evangelicals, Jews, and U.S.-Israeli Relations,”* Christian Zionism’s history reveals that the movement is *“less about apocalyptic theology or evangelism”* than about *“mutual and covenantal solidarity.”* Through telling the story of Christian Zionism in intricate, narrative detail and paying attention to the splits and fissures within American Christianity, Hummel dismantles virtually every part of the familiar story. Christian Zionism isn’t age-old; its founders were innovating, largely in response to the Holocaust. Christian Zionists do not secretly want to convert Jews; in fact many argue vociferously against missionizing, flirting with the boundaries of Christian orthodoxy in the process. Nor is the movement fundamentally apocalyptic: end-time prophecies motivate some believers, but by no means the majority. Finally, Christian Zionism isn’t even entirely Christian, since it began with interfaith dialogue and was carefully cultivated by the Israeli government.

Hummel’s story begins in Jerusalem immediately after World War II, with American Christians who came to Palestine and then Israel as missionaries. In 1949, there were more than fifteen thousand Christian missionaries in Israel, more per capita than anywhere else in the world. Yet they were remarkably ineffective. Not only were European Jews deeply inhospitable to Christianity after the Holocaust, but the Israeli state impeded missionary work, placing sharp legal limits on proselytizing and even attempting to limit Christian Bible shipments. Moreover, the Ottoman millet system, which broke citizens into fixed religious groupings, made little space for either conversion or even non-indigenous Christian groups. (Absurdly, Southern Baptists and Lutherans fell under the authority of the Jewish Chief Rabbinate, which refused to perform their marriages, making it impossible for American Protestants to wed in Israel until the mid-fifties.)

More surprisingly, some missionaries found themselves doubting the morality of their efforts. They “sparred with” Jewish academics in Jerusalem, and had their eyes opened to the long history of Christian anti-Semitism, the Jewish background to the Gospels, and the importance of Zionism in Israeli Jewish life. Some began to argue for a shift from converting to what they called “witnessing”: this meant downplaying conversion, embracing Zionism, and honoring Jewish history and culture. American evangelicals like Robert Lindsey started making a point of Jesus’s speaking Hebrew, for instance, and urged their peers to forgo missions. This shift was highly controversial. So, as Hummel documents, Carl Henry, the editor of *‘Christianity Today’* and mid-century evangelical leaders, warred with Donn Odell, his pro-Israel correspondent in Jerusalem, over how to cover Israeli anti-missionary measures. Odell called for *“simple, loving witness for Christ... with no connection to foreign missions”* and attempted to enlist U.S. support for Israel during the Suez Crisis. But Henry ignored geopolitics and focused his magazine’s coverage, Hummel writes, on *“a critical view of religious liberty in the country.”* This split was to play out frequently over the coming decades.

On the fringes, “*witnessing*” even affirmed the religious validity of Judaism. Invented by the Anglo-Irish theologian John Nelson Darby, the theology of covenantal dualism posited “*separate eternal states for Israel and the church*” — that is, that Jews could be saved without becoming Christians. Though this dualism never became mainstream, it constantly hung around the edges of Christian Zionism. Christian Zionists were frequently attacked as heretical by other Christians. For instance, the televangelist Billy Graham, an enthusiastic supporter of Israel, faced repeated critique for disavowing Jewish conversion.

Far from being anti-Semitic, Christian Zionism was fostered and shaped by American Jews and the Israeli government. Institutions like the American Institute of Holy Land Studies — a Christian college in Jerusalem that emphasized Jewish history and whose founder, G. Douglas Young, publically prayed for Israel during the 1967 war as his students drove ambulances through the city — persuaded Israeli officials that Christianity, far from representing a missionary threat, in fact represented an untapped base of support in America. Soon, more than “*half of the institute’s lecturers... were Israeli scholars or government officials.*”

Particularly after 1967, Israel targeted American evangelicals for tourism, with the Ministry of Tourism and El Al Airlines producing pamphlets promising that visitors could “relive the biblical epics.” This influence shaped the direction of the movement. Despite the apocalypticist Hal Lindsey’s massive reach in the United States, the Israeli government preferred Christian Zionists motivated by pragmatism and philo-Semitism, and they effectively marginalized Lindsey’s presence in the tour industry. In the United States, Rabbi Marc Tanenbaum advised Billy Graham and other Christian leaders on how to speak and write about Israel. He was not always successful, but sometimes he wrote the words they preached. Liberal cavils about Christian Zionism’s anti-Semitism often miss that the movement has been in significant part created and shaped by Jews.

The final chapters of Hummel’s book trace the rise of the Christian Right and the recent globalization of Christian Zionism. The first story will be familiar to many readers: the backlash, led by Jerry Falwell, against racial integration and the Supreme Court’s *Roe v. Wade* decision, the increasingly strident involvement of evangelicals in American politics, and the alliance Ronald Reagan and Menachem Begin forged between the American and Israeli right wings, both newly dependent on religious voters and activists.

Liberal Jews today judge Christian Zionism by these right-wing leaders, like Falwell, who notoriously declared that the anti-Christ would have to be Jewish, and Pastor John Hagee, who has implicitly blamed the Holocaust on its Jewish victims. But even here, centering covert anti-Semitism misses the most interesting stories. Although Hagee is best known for his end-time prophecies, Hummel shows his [John Hagee] success has far more to do with his championing of the prosperity gospel. Give to Israel, he preaches, and you will become rich. The Christian Right is far more motivated by capitalist ideology like Hagee’s and by the ideology of a Judeo-Christian civilizational alliance against Muslims than it is by wilder, apocalyptic prophecies.

But more importantly, Hagee and Falwell are no longer the most important Christian Zionist leaders. The center of the movement has shifted overseas. When Hummel visited the *“International Christian Embassy’s Feast of Tabernacles celebration,”* he heard a Nigerian preacher addressing an international audience, with only a muted American presence. The global movement emphasizes Jewish-Christian “reconciliation” and a shared biblical inheritance, often rejecting end-times prophecies. They also associate Israel with far-right, ultra-nationalist politics, as when the Brazilian Pentacostalist Rene Terra Nova *“administered a mass baptism in the Jordan river to a group of Brazilian tourists before leading a chant in support”* of fascist leader Jair Bolsonaro — a gathering that reached large Brazilian audiences through social media.

Hummel has written a masterful, very readable book that manages at once to mount a surprising argument and tell compelling narrative history. Nor is he an apologist for Christian Zionism: he emphasizes repeatedly the *“dark underside of reconciliation”* between Jews and Christian Zionists in *“the erasure of concern for Arab Christians and... Palestinians.”* That critique is inescapable and damning, though of course it applies to Graham, Falwell, and Hagee not because they are Christians, but because they are Zionists.

Reading Hummel, I realized that liberal Jews prefer to imagine Christian Zionists as anti-Jewish because we find it painful to confront the sincerity and integrity of their Zionism. We would prefer to think of their Islamophobia and imperialism as “Christian” and quarantine the American right from Jewish concerns and interests. We would prefer not to reckon with the fact that Israel has become the central symbolic cause of the world’s political right. We would prefer to deny what Christian Zionists announce loudly and repeatedly — that they reject Christian anti-Semitism and love Jews — because we are ashamed to be loved by such people. Progressive Jews caricature Christian Zionism only partly because we so poorly understand evangelicalism. More deeply, we do so because we would rather not understand why Zionism is so attractive to the Christian Right, for to do so would prompt too many questions about our own Zionism.

Christian Zionism, the belief that the current Zionist state of Israel is an unambiguous portent of the imminent return of Christ, is said to be the largest growing cult in America. With some 70 million Christian evangelicals in the U.S. (a large proportion subscribing to Christian Zionist beliefs), unconditional support of Israel on religious grounds translates into massive lobbying power in a country where the “religious right” has seen itself as the leaders in a fight against the infidels of secularism, Islam, socialism and anyone else in their way.

Yet few, if any, scholarly Christian theologians support this view. It is a belief advanced mostly by powerful TV evangelists and lobby groups. The average *“garden variety”* Christian has little to arm themselves against the deluge of almost hysterical demands on Christians that they must support the Zionists’ absolute entitlement to their colonialist project in the Holy Land with its dispossession and ethnic cleansing of Palestinian Arabs.

In practice, this political ideology as exercised through CUFI has meant unbridled support for Israel “as a Jewish state,” alignment with the most far-right political forces in Israeli society, and backing of the ethnic cleansing and killing of Palestinians. While strains of Christian Zionism vary, Hagee holds that the rapture will be preceded by a cataclysmic war, a belief that makes him enthusiastic about conflict and confrontation with Palestinians, as well as with Iran and its allies. In 2005, Hagee declared that *“it is time for America to embrace the words of Senator Joseph Lieberman and consider a military preemptive strike against Iran to prevent a nuclear holocaust in Israel and a nuclear attack in America.”*

The anti-Palestinian, anti-Semitic and anti-Muslim ethos embedded in the Christian Zionism of groups like CUFI is well documented. *“It applies biblical prophecy to a modern nation state and transforms a 70-year struggle for political and human rights into a mythic, ahistorical, world-ending religious conflict,”* says JVP Action’s Fox. *“That’s super dehumanizing to Palestinians, Muslims and Jews, but also is extremely dangerous when you are using the tools of statecraft to basically pursue the end of the world.”*

This ideology is often dressed up as philo-Semitism, or extreme love of Jews. (Elan Carr, the State Department’s Special Envoy for monitoring and combating anti-Semitism, boasted at an event in Tel Aviv in 2019 that the United States is *“still the most philo-Semitic country in world history.”*) But critics note that lurking beneath this supposed adoration is a profound instrumentalization of Jews. *“Christian Zionists essentially think all Jewish people are caricatures of the ancient Israelites—a caricature they associate, in turn, with the modern state of Israel—and that the loyalty of all Jews is, or should be, to Israel,”* says Ben Lorber, a research analyst for Political Research Associates, a social justice think tank. *“Tied in with this, there is a palpable sense in which they despise Jews in the diaspora, especially liberal Jews.”*

While CUFI isn’t the only Christian Zionist organization, it is the most powerful, and it appears to exert considerable influence over a base that is already highly favorable to its goals. A LifeWay Research poll conducted in September 2017 found that 80% of evangelicals believe that the establishment of the modern state of Israel in 1948 and migration of Jews there *“were fulfillments of Bible prophecy that show we are getting closer to the return of Jesus Christ.”*

This dichotomy struggle concerning the Modern State of Israel suggests in my way of thinking that our approach to understanding the Bible is and has been myopic. Myopic is an adjective that means affected by myopia or nearsightedness. As I pointed out in my comments at the beginning, we might find it necessary to re-think Christian Zionism simply because it does not give us a correct rendering of Bible prophecy when understood as History told in advance of its happening. The simple facts are that most Bible prophecy teachers and preachers suffer from this myopic flaw. I suggest to you that the two articles mentioned on page 37 will begin to illustrate the reasons for our need to redefine our view of the Bible. –Pastor Bob JJ
