In Plain Sight: COVID Has Helped Globalists Usher In a Global Cashless Society – WEF Banker

A powerful central banker has gloated to his fellow World Economic Forum (WEF) members that the Covid pandemic has helped globalists usher in a global “cashless society.”

Central Bank of Bahrain governor Khalid Humaidan discussed plans for eliminating physical cash while speaking at the WEF’s “Special Meeting on Global Collaboration, Growth and Energy Development” on Sunday.

During a panel discussion, titled “Open Forum: The Digital Currencies’ Opportunity in the Middle East,” Humaidan told WEF elites that the goal of a central bank digital currency (CBDC) is to replace cash with “100% digital” payments.

He revealed that the pandemic helped to rapidly advance that goal.

“I think the transition to fully digital [currency] is not going to be a stretch, people are used to it, people are engaged in it, and circumstances that help is adoption rates increased because of Covid,” Humaidan said.

Humaidan also bragged that the general public is not resisting the end of cash transactions.

“This is where contactless [payment] started to become something of a necessity, something of a safety, something of a requirement, and because of that there is very little resistance, trust is already there,” the WEF member said.

Humaidan continued by reminding WEF members that central banks control the issuance of cash, manage the supply via interest rates, and that the private sector largely controls the effort.

The central banker noted that it is likely a global CBDC will be no different.

He assured globalist elites in the audience that private central banks would dominate the system.

Humaidan then declared that cash will be completely eliminated.

“At some point in time hopefully we’ll be able to be 100 percent digital,” he said.

Replacing physical money with *“digital cash”* will prohibit the anonymous transfer of funds.

This is a premise already admitted by the financial sector.

Speaking at the Bank for International Settlements (BIS) Innovation Summit in March 2023, European Central Bank (ECB) president Christine Lagarde said that a CBDC will not be private or anonymous.

However, she claimed that *“digital cash”* would have some level of anonymity.

“A digital currency is an alternative, is another means of payment and will not provide exactly the same level of privacy and anonymity as cash, but will be pretty close in terms of complete neutrality in relation to the data,” she said.

The Steady Slide Towards Tyranny: How Freedom Dies from A to Z

The American governmental scheme is sliding ever closer towards a pervasive authoritarianism.

The American people, the permanent underclass in America, have allowed themselves to be so distracted and divided that they have failed to notice the building blocks of tyranny being laid down right under their noses by the architects of the Deep State.

This steady slide towards tyranny, meted out by militarized local and federal police and legalistic bureaucrats, has been carried forward by each successive president over the past fifty years regardless of their political affiliation.

Biden, Trump, Obama, Bush, Clinton: they have all been complicit in carrying out the Deep State's agenda.

Frankly, it really doesn't matter who occupies the White House, because it is a profit-driven, unelected bureaucracy—call it whatever you will: the Deep State, the Controllers, the masterminds, the shadow government, the corporate elite, the police state, the surveillance state, the military industrial complex—that is actually calling the shots.

In the interest of liberty and truth, here's an A-to-Z primer that spells out the grim realities of life in the American Police State that no one seems to be talking about anymore.

A is for the AMERICAN POLICE STATE. A police state *"is characterized by bureaucracy, secrecy, perpetual wars, a nation of suspects, militarization, surveillance, widespread police presence, and a citizenry with little recourse against police actions."*

B is for our battered BILL OF RIGHTS. In the militarized police culture that is America today, where you can be kicked, punched, tasered, shot, intimidated, harassed, stripped, searched, brutalized, terrorized, wrongfully arrested, and even killed by a police officer, and that officer is rarely held accountable for violating your rights, the Bill of Rights doesn't amount to much.

C is for CIVIL ASSET FORFEITURE. This governmental scheme to deprive Americans of their liberties—namely, the right to property—is being carried out under the guise of civil asset forfeiture, a government practice wherein [government agents \(usually the police and now TSA agents\) seize private property they "suspect" may be connected to criminal activity](#). Then, whether or not any crime is actually proven to have taken place, the government keeps the citizen's property and it's virtually impossible to get it back.

D is for DRONES. Nearly 1500 police departments across the U.S. include drones as part of their technological arsenal, and that number is growing. Although drones may be used for benevolent purposes, they have increasingly become [extensions of the surveillance state](#), carrying out warrantless and constant mass aerial surveillance in violation of the Fourth Amendment. New autonomous police drones can ["read a license plate from 800 feet away and follow a vehicle from a distance of 3 miles."](#)

E is for EMERGENCY STATE. From 9/11 to COVID-19 and beyond, we have been the subjected to an "emergency state" that justifies all manner of government tyranny and power grabs in the so-called name of national security. The government's ongoing attempts to declare so-called national emergencies in order to circumvent the

Constitution's system of checks and balances constitutes yet another expansion of presidential power that exposes the nation to further constitutional peril.

F is for FASCISM. A study conducted by Princeton and Northwestern University concluded that the [U.S. government does not represent the majority of American citizens](#). Instead, the study found that the government is ruled by the rich and powerful, or the so-called "*economic elite*." Moreover, the researchers concluded that policies enacted by this governmental elite nearly always favor special interests and lobbying groups. In other words, we are being [ruled by an oligarchy](#) disguised as a democracy, and arguably on our way towards fascism—a form of government where private corporate interests rule, money calls the shots, and the people are seen as mere economic units or data-bits.

G is for GLOBAL POLICE. The federal government has [distributed more than \\$18 billion worth of battlefield-appropriate military weapons, vehicles and equipment](#) such as drones, tanks, and grenade launchers to domestic police departments across the country. As a result, most small-town police forces now have enough firepower to render any citizen resistance futile. By the time you take those small-town police forces, train them to look and act like the military, and then enlist them to be part of the United Nations' [Strong Cities Network program](#), you not only have a standing army that operates beyond the reach of the Constitution but one that is part of a global police force.

H is for HOLLOW-POINT BULLETS. The government's efforts to militarize and weaponize its agencies and employees is reaching epic proportions, with federal agencies as varied as the Department of Homeland Security and the Social Security Administration stockpiling millions of lethal hollow-point bullets, which violate international law. Ironically, while the government continues to push for stricter gun laws for the general populace, the U.S. military's arsenal of weapons makes the average American's handgun look like a Tinker Toy.

I is for the INTERNET OF THINGS, in which internet-connected "things" monitor your home, your health and your habits in order to keep your pantry stocked, your utilities regulated and your life under control and relatively worry-free. The key word here, however, is control. This ["connected" industry](#) propels us closer to a future where police agencies apprehend virtually anyone if the government "thinks" they may commit a crime, driverless cars populate the highways, and a person's biometrics are constantly scanned and used to track their movements, target them for advertising, and keep them under perpetual surveillance.

J is for JAILING FOR PROFIT. Having outsourced their inmate population to private prisons run by private corporations, this [profit-driven form of mass punishment](#) has given rise to a \$70 billion private prison industry that relies on the complicity of state governments to keep their privately run prisons full by jailing large numbers of Americans for petty crimes.

K is for KENTUCKY V. KING. In an 8-1 ruling, the Supreme Court [ruled that police officers can break into homes, without a warrant, even if it's the wrong home](#) as long as they think they may have a reason to do so. Despite the fact that the police in question ended up pursuing the wrong suspect, invaded the wrong apartment and violated just about every tenet that stands between the citizenry and a police state, the Court sanctioned the warrantless raid, leaving Americans with little real protection in the face of all manner of abuses by law enforcement officials.

L is for LICENSE PLATE READERS, which enable law enforcement and private agencies to track the whereabouts of vehicles, and their occupants, all across the country. This data collected on tens of thousands of innocent people is also being [shared between police agencies, as well as with government fusion centers and private companies](#). This puts Big Brother in the driver's seat.

M is for MAIN CORE. Since the 1980s, the U.S. government has acquired and maintained, without warrant or court order, a database of names and information on Americans considered to be threats to the nation. As Salon reports, this database, [reportedly dubbed "Main Core,"](#) is to be used by the Army and FEMA in times of national emergency or under martial law to locate and round up Americans seen as threats to national security. There are at least 8 million Americans in the Main Core database.

N is for NO-KNOCK RAIDS. Owing to the militarization of the nation's police forces, SWAT teams are now increasingly being deployed for routine police matters. In fact, more than [80,000 of these paramilitary raids are carried out every year](#). That translates to more than 200 SWAT team raids every day in which police crash through doors, damage private property, terrorize adults and children alike, kill family pets, assault or shoot anyone that is perceived as threatening—and all in the pursuit of someone merely suspected of a crime, usually possession of some small amount of drugs.

O is for OVERCRIMINALIZATION and OVERREGULATION. Thanks to an overabundance of 4500-plus federal crimes and 400,000 plus rules and regulations, it's estimated that the average American actually commits three felonies a day without knowing it. As a result of this [overcriminalization](#), we're seeing an uptick in Americans being arrested and jailed for such absurd "violations" as letting their kids play at a park unsupervised, collecting rainwater and snow runoff on their own property, growing vegetables in their yard, and holding Bible studies in their living room.

P is for PATHOCRACY and PRECRIME. When our own government treats us as things to be manipulated, maneuvered, mined for data, manhandled by police and other government agents, mistreated, and then jailed in [profit-driven private prisons](#) if we dare step out of line, we are no longer operating under a constitutional republic. Instead, what we are experiencing is a [pathocracy](#): tyranny at the hands of a psychopathic government, which "operates against the interests of its own people except for favoring certain groups." Couple that with the government's burgeoning precrime programs, which will use [fusion centers](#), data collection agencies, behavioral scientists,

corporations, social media, and community organizers and by relying on cutting-edge technology for surveillance, facial recognition, [predictive policing](#), biometrics, and behavioral [epigenetics](#) in order to identify and deter so-called potential “extremists,” dissidents or rabble-rousers. Bear in mind that anyone seen as opposing the government—whether they’re Left, Right or somewhere in between—is now viewed as an extremist.

Q is for QUALIFIED IMMUNITY. [Qualified immunity](#) allows police officers to walk away without paying a dime for their wrongdoing. Conveniently, those deciding whether a cop should be immune from having to personally pay for misbehavior on the job all belong to the same system, all cronies with a vested interest in protecting the police and their infamous code of silence: city and county attorneys, police commissioners, city councils and judges.

R is for ROADSIDE STRIP SEARCHES and BLOOD DRAWS. The courts have increasingly erred on the side of giving government officials—especially the police—[vast discretion in carrying out strip searches, blood draws and even anal and vaginal probes for a broad range of violations](#), no matter how minor the offense. In the past, strip searches were resorted to only in exceptional circumstances where police were confident that a serious crime was in progress. In recent years, however, strip searches have become routine operating procedures in which everyone is rendered a suspect and, as such, is subjected to treatment once reserved for only the most serious of criminals.

S is for the SURVEILLANCE STATE. On any given day, the average American going about his daily business will be monitored, surveilled, spied on and tracked in more than 20 different ways, by both government and corporate eyes and ears. A byproduct of the electronic concentration camp in which we live, whether you’re walking through a store, driving your car, checking email, or talking to friends and family on the phone, you can be sure that [some government agency, whether the NSA or some other entity, is listening in and tracking your behavior](#). This doesn’t even begin to touch on the corporate trackers that monitor your purchases, web browsing, Facebook posts and other activities taking place in the cyber sphere.

T is for TASERS. Nonlethal weapons such as tasers, stun guns, rubber pellets and the like have been used by police as weapons of compliance more often and with less restraint—even against women and children—and in some instances, even causing death. These [“nonlethal” weapons also enable police to aggress with the push of a button](#), making the potential for overblown confrontations over minor incidents that much more likely. A Taser Shockwave, for instance, can electrocute a crowd of people at the touch of a button.

U is for UNARMED CITIZENS SHOT BY POLICE. No longer is it unusual to hear about incidents in which police shoot unarmed individuals first and ask questions later, often attributed to a fear for their safety. Yet the [fatality rate of on-duty patrol officers is](#)

[reportedly far lower than many other professions](#), including construction, logging, fishing, truck driving, and even trash collection.

V is for OPERATION VIGILANT EAGLE. One of several government initiatives dating back to 2009 that call for heightened scrutiny of those who challenge the government's authority, this particular program calls for surveillance of military veterans, characterizing them as extremists and potential domestic terrorist threats because they may be "[disgruntled, disillusioned](#) or suffering from the psychological effects of war." Coupled with a [report](#) that defines extremists as individuals and groups "*that are mainly antigovernment, rejecting federal authority in favor of state or local authority, or rejecting government authority entirely,*" these tactics bode ill for anyone seen as opposing the government.

W is for WHOLE-BODY SCANNERS. Using either x-ray radiation or radio waves, scanning devices and government mobile units are being used not only to "see" through your clothes but to spy on you within the privacy of your home. While these [mobile scanners](#) are being sold to the American public as necessary security and safety measures, we can ill afford to forget that such systems are rife with the potential for abuse, not only by government bureaucrats but by the technicians employed to operate them.

X is for X-KEYSCORE, one of the many spying programs carried out by the National Security Agency that targets every person in the United States who uses a computer or phone. This top-secret program "[allows analysts to search with no prior authorization through vast databases containing emails, online chats and the browsing histories of millions of individuals.](#)"

Y is for YOU-NESS. Using your face, mannerisms, social media and "you-ness" against you, you are now be tracked based on what you buy, where you go, what you do in public, and how you do what you do. Facial recognition software promises to create a society in which every individual who steps out into public is tracked and recorded as they go about their daily business. The goal is for government agents to be able to scan a crowd of people and instantaneously identify all of the individuals present. [Facial recognition programs are being rolled out in states all across the country.](#)

Z is for ZERO TOLERANCE. We have moved into a new paradigm in which young people are increasingly viewed as suspects and treated as criminals by school officials and law enforcement alike, [often for engaging in little more than childish behavior](#) or for saying the "wrong" word. In some jurisdictions, students have also been penalized under school zero tolerance policies for such inane "crimes" as carrying cough drops, wearing black lipstick, bringing nail clippers to school, using Listerine or Scope, and carrying fold-out combs that resemble switchblades. The lesson being taught to our youngest—and most impressionable—citizens is this: in the American police state, you're either a prisoner (shackled, controlled, monitored, ordered about, limited in what you can do and say, your life not your own) or a prison bureaucrat (politician, police officer, judge, jailer, spy, profiteer, etc.).

None of these dangers have dissipated in any way, and yet suddenly, no one seems to be talking about any of the egregious governmental abuses that are still wreaking havoc on our freedoms: police shootings of unarmed individuals, invasive surveillance, roadside blood draws, roadside strip searches, SWAT team raids gone awry, the military industrial complex's costly wars, pork barrel spending, pre-crime laws, civil asset forfeiture, fusion centers, militarization, armed drones, smart policing carried out by AI robots, courts that march in lockstep with the police state, schools that function as indoctrination centers, bureaucrats that keep the Deep State in power.

As I make clear in my book [Battlefield America: The War on the American People](#) and in its fictional counterpart [The Erik Blair Diaries](#), this is how freedom dies.

If there is any means left to us for thwarting the government in its relentless march towards outright dictatorship, it may rest with the Tenth Amendment, which affirms that “we the people” (in the form of juries and local governments) have the power to invalidate governmental laws, tactics and policies that are illegitimate, egregious or blatantly unconstitutional.

Nullify everything.

Nullify the court cases. Nullify the laws. Nullify everything the government does that flies in the face of the Constitution.

It's time to rein in our runaway government, reclaim our freedoms, and restore justice in America.

At the WEF's Annual Meeting of the New Champions or “Summer Davos” in Tianjin, China, Cornell University Professor Eswar Prasad gloated about the “benefits” of a centrally controlled “digital cash” system.

During a panel discussion, he spoke excitedly of a dark future.

“You could have, as I argue in my book, potentially a better, or some people may say a darker world where the government decides that units of central bank money can be used to purchase some things but not other things that it deems less desirable,” Prasad said.

“And that is very powerful with the use of a CBDC, and I think also extremely dangerous with central banks.”

As Slay News [reported](#), Prasad told fellow WEF members that a CBDC could be used to control the public by allowing governments and corporate bureaucrats to decide what they can purchase.

“The government decides that [CBDC] can be used to purchase some things, but not other things that it deems less desirable like say ammunition, or drugs, or pornography, or something of the sort,” he said.

The head of the Bank for International Settlements (BIS), Mexican Bank Governor Agustín Carstens, made clear during an International Monetary Fund (IMF) meeting back in October 2020 that “digital cash” is all about controlling the public. As Slay News reported, Carstens boasted that a CBDC gives globalists “absolute control” over the general public.

He explained that CBDCs can be limited to purchases and merchants that have been approved.

“A key difference with the CBDC is that central banks will have absolute control on the rules and regulations that determine the use of that expression of central bank viability, and also we will have the technology to enforce that,” Carstens said.

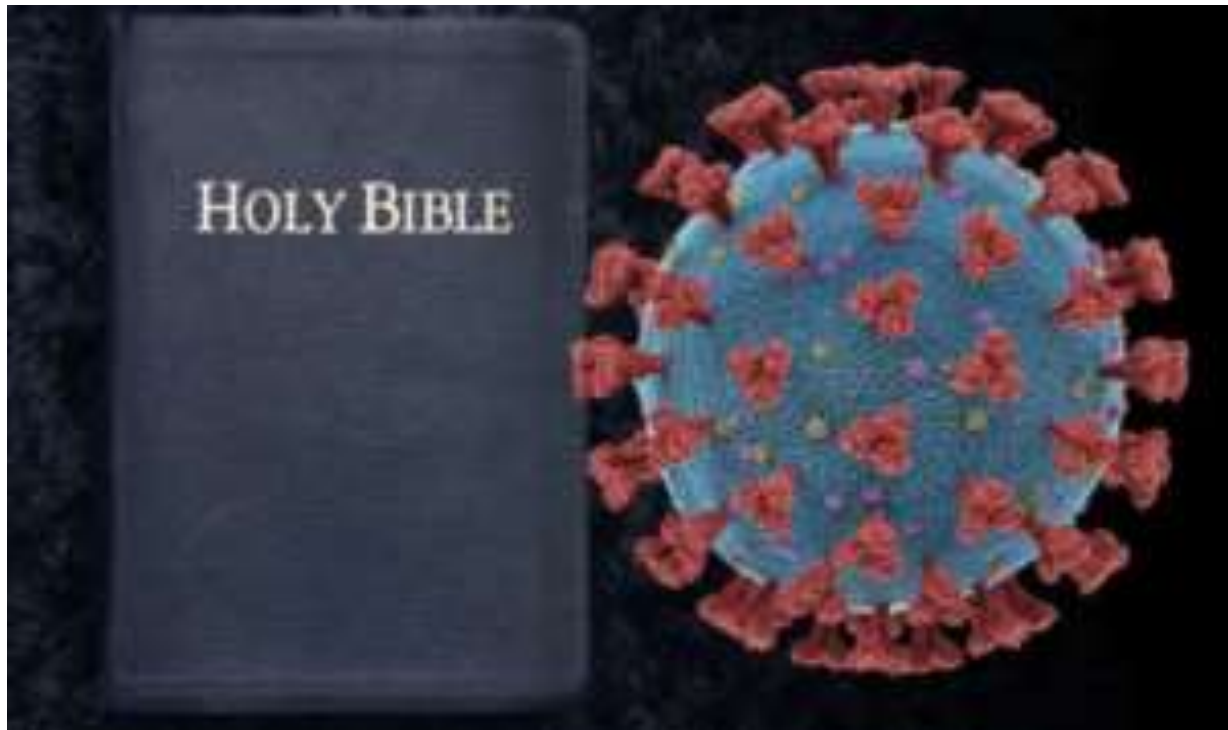

Are Va((ines in the Bible?

*I looked, and behold, an ashen (pale/sickly) horse; and he who sat on it had the name **Death** (Strong's 2288); and Hades was following with him. Authority was given to them over a fourth of the earth, to kill with sword and with famine and with pestilence (Strong's 2288) and by the wild beasts of the earth. **Rev. 6:8***

Since 80% of the world basically just took the same drug supposedly due to a deadly epidemic, and since I believe we're in the last days of the last days, it begs the question— is there anything in the Bible that deals with va((ines?

The answer is yes! Check this out....

In the above verse we see authority was given to the one on the horse named "**Death**" to kill with sword, famine, pestilence and by wild beasts.

It's easy to understand how he could kill by *sword* and *famine*, and even cause people to die from being eaten by hungry *wild animals*. After all, any animals still alive would be ravenous after a lot of fire/scorched earth judgments killed off most of the vegetation.

2288. **thanatos**, from 2348; (properly, an adjective used as a noun) death (literally or

θάνατος

figuratively): — deadly, (be...) death.

But translating the Greek word "thanatos" to mean "pestilence" just doesn't work in the second half of the verse. The KJV and ESV do translate "thanatos" to be "death" at the first usage of the word in the verse as well as in the second usage. So there's obviously debate over what it means.

But it makes no sense to translate the second usage to say, "*Killed by death.*" You don't die from death, you die from a *cause of death*.

That's why the NASB and NIV both translate "thanatos" to mean "pestilence" in the second usage in the verse, which at least is a "cause" of death.

Now this is interesting, check out the definition of "pestilence":

The American Heritage® Dictionary of the English Language, 5th Edition:

pestilence:

noun

- 1) A usually fatal **epidemic** disease.
- 2) A pernicious, **evil** influence or **agent**.
- 3) Any contagious or **infectious epidemic disease** that is virulent and devastating.

Interesting that the word "*epidemic*" is used, since we're all waiting on the next "epidemic shoe" to fall. The CDC and WHO continue to warn us that the next epidemic will be 100 times worse than Covid.(4)

From the Century Dictionary:

Pestilence

noun /

That which is pestilential or pestiferous; that which produces or tends to produce **malignant disease**.

Whoa, Nellie! Can you see where this is headed? The covid va((ine is causing malignancy/cancer to be springing up everywhere...more diagnosed every day!

Agent of Change

Also in the above definitions is the word "**agent**." The way it is used means it could mean either an "**agent of evil influence**" or an "**evil agent**."

“Agent”:

*a substance that brings about a **chemical** or physical effect or causes a **chemical reaction**: i.e., there is an urgent need for new antimicrobial **agents** to combat **infections** | the bleaching agent used is hydrogen peroxide.*

ORIGIN

Late Middle English (in the sense “someone or something that produces an effect”): from Latin agent - “doing,” from *agere*.

Wikipedia gives an example of use: *He later applied this movement to all body tissues and this movement is **the agent of change in dysfunctional tissues**.*

Makes me think of all those tissue clots the morticians are seeing but are forbidden to talk about.

The word “agent” is used quite often in drug descriptions. Consider this description:

Antimicrobial. An **antimicrobial** is an **agent** that kills microorganisms (microbicide) or stops their growth (bacteriostatic **agent**).

The First Horseman

This nation has a lot of unique characteristics that only can fit the United States.(2)

The KJV and the NASB translate the Greek word “**pharmakia**“ to mean “**sorcery**.”

Sorcery: *Magical power; the use of **witchcraft** or magic arts.*

Not a bad translation as all this does come from Satan, but using the word "sorcery" makes it easy to miss the real meaning. The Greek word “pharmakia,” from where we get our English word “pharmacy,” basically means “**drugs**.” It should read:

*for by your **drugs** **all nations** were deceived. **Rev. 18:23b***

All means all. All the nations of the world got tricked by the drugs from this nation.

"*Pharmakia*" is also used in Rev. 9. The word is used right after John describes how another 1/3 of the earth dies, after 1/4 of the earth had already died, making 1/2 the earth having died!

John says:

The rest of mankind, who were not killed by these plagues, did not repent of the works of their hands... they did not repent of their [drugs/pharmakia]. Rev. 9:20, 21

So *pharmakia/pestilence*; i.e; "drugs," are a huge problem in the 7-Year Tribulation as described in the Book of Revelation. And since vaccines are drugs, and they are already being distributed worldwide, these vaccines ARE in the Bible as last-days worldwide phenomena!

Throwing Kids' Health Under the Bus? FCC Wants to Put Wi-Fi on School Buses

Citing mental and physical health concerns, parents, politicians and safe technology advocates are pushing back against an FCC initiative to put Wi-Fi on school buses.



Parents, politicians and safe technology advocates are pushing back against a Federal Communications Commission (FCC) initiative to put Wi-Fi on school buses.

Patricia Burke of Safe Tech International in an April 29 Substack post accused the federal regulatory agency for telecommunications of being “the bully boarding the bus.”

Burke cited evidence of eye damage from excessive screen time and the risk of exposing kids to increased cyberbullying and addictive social media apps via unsupervised internet access while riding to and from school.

“It is time to stop throwing children’s health, including eyesight and mental well-being, under the bus,” Burke said.

Last October the FCC announced it would allow money from its E-Rate program to fund the installation of Wi-Fi on school buses starting in fiscal year 2024.

The E-Rate program is funded through taxes on consumers’ phone bills, according to the U.S. Senate Committee on Commerce, Science, and Transportation.

The program is designed to make *“telecommunications and information services more affordable for schools and libraries.”* But the FCC argued that expanding it to include

internet services on school buses was warranted to *“ensure that the millions of students caught in the Homework Gap can more fully engage in their learning.”*

FCC Chairwoman Jessica Rosenworcel said the program’s expansion would especially help kids who live in rural areas, where broadband connections are sparse, and who ride long distances on the bus.

Soon after the FCC’s announcement, parents Maurine and Matthew Molak challenged the FCC’s initiative in court.

The Molaks, whose 16-year-old son died as a result of cyberbullying, are co-founders of David’s Legacy Foundation, a nonprofit working to stop cyberbullying of children and teens *“through education, legislation and legal action.”*

On Dec. 20, 2023, they filed a petition for review before the U.S. Court of Appeals for the 5th Circuit, arguing the FCC’s ruling to allow E-Rate funding for school bus Wi-Fi *“exceeds the FCC’s statutory authority”* and is undermining their nonprofit’s mission to eradicate cyberbullying by *“enabling unsupervised social-media access by children and teenagers.”*

“When it came to my attention,” Maurine Molak told The Defender, *“that our own federal government had decided to fund kids’ unsupervised access to the internet on school buses, I felt I needed to take action.”*

She said the FCC’s decision would exacerbate cyberbullying and kids’ exposure to harmful and addictive social media.

“I ask myself, why is the FCC creating new opportunities for online bullying, for girls to develop eating disorders, and for increased emotional distress? That’s why I’m fighting to get it [the FCC’s ruling] overturned,” she added.

The FCC on Feb. 6 moved to dismiss the Molaks’ lawsuit.

Sen. Ted Cruz (R-Texas) and other senators on April 9 filed an amicus brief in support of the Molaks’ case.

An amicus brief is filed by non-parties to litigation to provide information that has a bearing on the issues and assist the court in reaching the correct decision.

“Addictive and distracting social media apps are wreaking havoc on our kids,” Cruz said in an April 11 statement. *“The FCC’s decision to fund children’s unsupervised access to social media on bus rides to and from school is both dangerous and unlawful.”*

Joining Cruz in filing the amicus brief were Sens. Marsha Blackburn (R-Tenn.), Mike Braun (R-Ind.), Ted Budd (R-N.C.), James Lankford (R-Okla.), Cynthia Lummis (R-Wyo.) and Pete Ricketts (R-Neb.).

The senators claimed the FCC's move to expand E-Rate funding to cover Wi-Fi on school buses is illegal because federal law confines the use of such funding to "classrooms and libraries."

According to a press release, by expanding E-Rate subsidies to school buses, "the agency is attempting to extend a separate, temporary COVID-era program — the Emergency Connectivity Fund ... which the FCC cannot do without specific congressional direction."

The Emergency Connectivity Fund previously helped schools obtain wireless internet infrastructure to support remote during the COVID-19 pandemic. Ostensibly, schools were able to use the funds to get Wi-Fi on school buses.

The amicus brief stated:

"Whether the FCC should fund Internet access beyond the school classroom or library — such as making Wi-Fi available to unsupervised children on school buses — and with what safeguards is a fiercely debated legislative question."

"While Congress decided to expand such access with appropriated funds during the COVID-19 pandemic, that program sunsets on June 30, 2024. Once limitations are set by Congress, they must be followed — not thwarted — by the federal regulators charged with their enforcement."

Additionally, Cruz, Budd and Sen. Shelley Moore Capito (R-W.Va.) in October 2023 introduced legislation that would limit school children's use of social media apps by prohibiting schools or school districts from receiving E-Rate or Emergency Connectivity Fund subsidies unless they prohibit access to social media on subsidized networks and devices.

The proposed legislation, called the "Eyes on the Board Act of 2023," would "promote parental limits and transparency on screen time" by requiring schools receiving E-Rate subsidies to adopt a screen time policy as a condition of receiving federal funding.

The bill also would require the FCC to create a database of schools' internet safety policies.

School bus Wi-Fi poses health risks to kids

Meanwhile, other critics of putting Wi-Fi on school buses said it could jeopardize kids' health in ways beyond social media addiction and cyberbullying.

Burke pointed out that neuropsychiatrist Dr. Ooha Susmita told Business Insider that reading in a moving vehicle can cause motion sickness because it creates a "sensory mismatch."

The passenger's inner ear perceives the motion of the moving car, while their eyes are tracking the stationary book or screen.

“This sensory conflict, leading to a disruption in the body’s normal sense of balance,” Susmita said, “can result in symptoms such as nausea, dizziness, sweating, and sometimes, vomiting.”

Excessive use of a smartphone may be linked to myopia — or nearsightedness — according to a 2021 peer-reviewed systematic review published in The Lancet Digital Health.

As The Defender reported, the authors of a February 2023 review of the latest science on pediatric health and electromagnetic fields (EMF) and radiofrequency (RF) radiation concluded that children are “uniquely vulnerable” to the EMR/RF radiation emitted by wireless devices, such as tablets and smartphones.

The authors, including lead author **Devra Davis, Ph.D., M.P.H.**, were “*distinguished experts in medicine, epidemiology, toxicology, physics, biochemical engineering and public health who collectively have published more than 1,000 papers.*”

In their review, Davis and her co-authors referenced more than 200 studies that associate wireless EMF/RF radiation with negative biological effects including oxidative stress and DNA damage, cardiomyopathy, carcinogenicity, sperm damage, memory damage and neurological effects.

Children’s unique physiology, including smaller heads and more fluid in their brains, results in proportionately greater absorption of RF radiation than adults, they said.

For instance, children can absorb up to 30 times more the amount of RF radiation in their hippocampus and 10 times more in the bone marrow of their skull.

Davis said, “*The science indicates that wireless radiation acts like a classic endocrine disruptor*” and can impair memory, behavior, fertility and brain development, as well as lead to cancer and neurological illness.

The FCC did not immediately respond to The Defender’s request for comment about its E-Rate program funding.

New 6G Wireless Tech Is 500 Times Faster Than Average 5G Smartphones

Fifth-generation or '**5G**' connectivity for cellular technology has only been the standard for networks for around five years, but with **6G** already on the horizon, developers are looking for ways to take full advantage of the next generation's expansive bandwidth.

A technology demo carried out in Japan has shown a prototype wireless device reaching 100 Gbps data transfer speeds, which is 10 times faster than **5G** at its peak, and 500 times faster than an average **5G** smartphone.

A two-hour, medium-quality Netflix movie streamed to a phone is around 1.5 GB in size, so in practical terms we're looking at being able to shift eight or nine of these films every single second.

The result of extensive research and development by Japan's telecommunications company NTT, the Japanese mobile phone operator DOCOMO, and electronics corporations NEC and Fujitsu, the device makes use of high frequency bands in the 100 GHz and 300 GHz range, allowing it to pack in significantly more data than previous generation standards.

It's a work in progress with a current trade-off in terms of range, but the experiment showed a stable connection over 100 meters (328 feet). Advances in communications technology will in fact need different forms of transmitters and receivers as the **6G** network is eventually built out, much of it relying on innovations like this.

Speaking of hardware, it's worth noting that this demo required a lot of state-of-the-art equipment. As the technology is developed though, the size and the costs of that equipment is gradually going to come down.

It's also important to remember that the 10 Gbps top speed for **5G** is a technical ceiling, under perfect conditions, using the most powerful and well-optimized hardware. According to Opensignal, the average **5G** speed for smartphones on T-Mobile in the U.S. – the country's best carrier for **5G** speeds – currently comes in at 186.3 Mbps.

In other words, **6G** promises vastly improved speeds. That's going to be useful in everything from high-resolution movie downloads to communications between autonomous vehicles, according to the researchers.

As with **5G**, there will also be a leap forward in terms of bandwidth, or network capacity: more devices able to stay connected at the same time. If you've ever lost phone signal at a packed concert or sports game, you'll be familiar with network congestion, and that's something that **6G** should all but eliminate.

In certain situations, we might see **6G** make Wi-Fi largely redundant, something that has already started to happen with **5G**. There might be no need to run a physical cable up to the front door of your home or office.

Looking at it more broadly, think about many more devices getting online at faster speeds, packed with more components and sensors that can talk to the web (and to each other). Nokia estimated that **6G** might be commercially available by 2030.

In the meantime, we'll have to put up with the 'new' **5G** networks that already seem almost sluggish by comparison of what's to come.

For the first time in history, the senior leaders of the Anglican Communion held their Primates' Meeting in Rome. This is the most important assembly in the Anglican Church and is attended by the archbishops and presiding bishops from throughout the world to discuss and vote on important business. The top leaders also made time to visit Pope Francis in the Vatican, where the Pope called for greater cooperation between the two religions.

Pope Francis also declared His primacy over all of Christianity during His meetings with the Anglicans, reminding them that as "*Bishop of Rome*," the Pope is fulfilling His "*Petrine Ministry*." In fact, relations between Christians ... presuppose and from now on call for every possible form of practical cooperation at all levels: pastoral, cultural and social, as well as that of witnessing to the Gospel message. Our differences do not diminish the importance of the things that unite us: they cannot prevent us from recognizing one another as brothers and sisters in Christ by reason of our common baptism. In this regard, I express my gratitude for the work of the Anglican-Roman Catholic International Commission over the past fifty years, which has made great efforts to overcome various obstacles that stand in the way of unity.”*^[1]

• *“Dear Primates of the Anglican Communion, thank you for choosing to meet this year in the City of the Apostles Peter and Paul. It is a gift for me to feel close to the communities that you represent. I realize that the role of the Bishop of Rome is still a controversial and divisive issue among Christians. Yet, in the splendid phrase of Pope Gregory the Great, who sent Saint Augustine as a missionary to England, the Bishop of Rome is servus servorum Dei, the servant of the servants of God. Again, in the words of John Paul II, “this designation is the best possible safeguard against the risk of separating power, and in particular the primacy, from ministry. Such a separation would contradict the very meaning of power according to the Gospel: ‘I am among you as one who serves’ (Luke 22:27)”. [5] For this reason, it is necessary to engage in a patient and fraternal dialogue on this subject, a dialogue in which, leaving useless controversies behind, strives to understand how the Petrine ministry can develop as a service of love for all.”*^[1]

So much for all the false, sweet, smooth speeches given at the ecumenical gatherings. On the one hand, Rome tells us not to focus on doctrine but rather on the common ground we share, but on the other hand, Rome is attempting to resurrect the doctrine of Papal supremacy. THE GREAT REPLACEMENT THEORY—IT’S NOT GREAT AND IT’S NO LONGER A THEORY

One Saturday mid-May two years ago, a white man armed with an AR-15-style rifle entered a supermarket in Buffalo, New York, and [killed 10 people](#), almost all of whom were African American.

The gunman was suspected of having posted a 180-page racist diatribe in which he repeatedly referenced what was then still passed off to be an extremist conspiracy theory known as the “*great replacement*.”

Marketed as a set of racist, anti-semitic, paranoid lies and delusions, the [Great Replacement theory](#) had bubbled up around the world more than a century ago.

In the U.S. this “theory” had since been expressed as:

The false idea that an elite cabal of Jews and [d]emocrats is replacing white Americans with [b]lack, [h]ispanic, and other people of color by encouraging immigration and interracial marriage—with the end goal being the eventual extinction of the white race.

The “*conspiracy*” evolved from a series of ideas that, over time, stoked the fears of white people: The massive influx of immigrants of color into Europe beginning approximately in the 1890s fostered some of these fears and resulted in “*white extinction anxiety*.”

In the U.S., this ‘anxiety’ resulted in policies [targeting immigration](#) in the late 19th and early 20th century.

Collectively, a global movement arose which attracted a wide range of [white supremacist, xenophobic and anti-immigration conspiracy theories](#). These theories were formally codified in the work of [Frenchman Renaud Camus](#), first in his

2010 book “L’Abécédaire de l’in-nocence” and elaborated in his 2011 book “[Le Grand Remplacement](#).”

Camus argued that ethnic French and white Europeans were being replaced physically, culturally, and politically by nonwhite people. He believed that liberal immigration policies and the dramatic decline in white birth rates were threatening European civilization and traditions.

Of recent, the theory has become a major idea to be either adamantly believed or adamantly dismissed, depending on which side of the political aisle you are seated.

As many [as 60% of the French population](#) believing some aspects of it. According to that survey, they are worried or at least concerned they might be replaced. In the U.K. [and the U.S.](#), close to [one-third of those polled](#) believe that white people are systematically being replaced by nonwhite immigrants. Some in the U.S. fear that America might lose its culture and identity as a result.

Today the [acceptable answer](#) to the question “*Are American citizens being displaced by the foreign-born?*” depends on who is asking.

Concerned citizens are told not to believe their lying eyes, while the progressive Left celebrates a majority-minority future as a moral triumph.

The controversies surrounding the Great Replacement Theory and the reality of America’s transforming demographics are converging into a fearful reality that “ongoing population changes will transform our national culture and represent a deliberate policy of replacing white citizens” with manipulable subjects of color.

The United States faces an invasion which poses existential concern to both the security and sovereignty of our vanishing republic. Meanwhile, “large corporations and their political cheerleaders continue to clamor for the increased import of foreign labor” at the expense of American citizens.

The displacement of American labor under the H-1B program and similar guest worker visas drags down wages for all citizens, not just those put out of work, but has long been defended by corporate interests as a “necessity” to fill jobs that Americans either “won’t take” or “aren’t qualified” to fill.

The American political Left, therefore, describes the Great Replacement Theory as: A racist conspiracy narrative that falsely asserts there is an active, ongoing, and covert effort to replace white populations in current white-majority countries.

However, the political Left touts the electoral benefits of demographic replacement while condemning people who believe this replacement is destructive.

To wit:

– When he was Vice President, Joe Biden described the ongoing border crisis in 2015 as a positive. ‘There is a second thing in that black box: an unrelenting stream of immigration, nonstop, nonstop,’ he said at the time. ‘Folks like me who are Caucasian, of European descent, for the first time in 2017 we’ll be in an absolute minority in the United States of America, absolute minority. Fewer than 50 percent of the people in America from then and on will be white European stock,’ he said. ‘That’s not a bad thing, that’s a source of our strength,’

– In 2021, Senator Dick Durbin (D-IL) gave a floor speech in the U.S. Senate and bragged that ‘The demographics of America are not on the side of the Republican Party. The new voters in this country are moving away from them, away from Donald Trump, away from their party creed that they preach,’

– That same year, Representative Yvette Clark (D-NY) touted the importance of illegal immigration for her district in terms of accruing political power, outright stating ‘We have a diaspora that can absorb a significant number of these migrants. And you know, when I hear colleagues talk about, you know, ‘the doors of the inn being closed,’ ‘no room at the inn,’ I’m saying, you know, I need more people in my district just for redistricting purposes,’ and

– During the latest Senate attempt to provide amnesty for illegal immigrants, Senator Chris Murphy (D-CT) told MSNBC host Chris Hayes that their strategy to push through legislation has failed to deliver ‘for the people we care about most—the undocumented Americans that are in this country.’

While the political Left attempts to smear anyone concerned about the mass importation of foreign citizens, the reality is progressives are pushing policies designed to supplant the interests of American citizens.

NOTE: Unchecked immigration and its consequent demographic transformation disenfranchises voters.

And the reality is demographic replacement is not a theory.

Replacement is indeed taking place, and it is an attack on American citizenship and American civic culture. Further, the replacement of white people with non-white people is very much political.

American taxpayers have been fleeced to provide overly generous handouts to both citizens and non-citizens alike, blurring the distinction between the two, and anyone who notices or objects is labeled a racist by the political Left.

Perhaps most disturbing is the human toll these policies are taking on American citizens:

The death of Kate Steinle on a San Francisco pier in 2015 at the hands of an illegal [alien], the murder of Mollie Tibbetts in Iowa in 2018 by an illegal [alien], and the recent

murder of Laken Riley on the campus of the University of Georgia, also by an illegal [alien], underscore the painful price that citizens are paying for policies designed to supplant their interests to facilitate the unraveling of the American founding.

NOTE: The Obama/Biden Regime—in the wake of a now-public Freedom of Information Act (FOIA) request—has gone beyond federal policies to mass import and provide a semblance of legal status to hundreds-of-thousands of aliens. The Regime:

Admitted to using its CBP One phone app to import via air travel over 320,000 illegal immigrants into the interior of the United States since late 2022. All paid for courtesy of the citizen taxpayers actively being harmed by this mass importation agenda. And as recently as March of 2024, every Senate Democrat voted in favor of allowing illegals to count in the census for purposes of apportionment for House seats and the Electoral College.

Other examples of similar questionable behavior from around the country:

– **Washington State:** Funneled nearly \$340 million of COVID “relief funds” to a program that sent out \$1,000 stimulus checks to illegal immigrants.

– **Colorado:** Passed a law that grants licensing permits, rent and utility subsidies, and other state benefits to illegal immigrants.

– **California:** Passed a law that expands Medicaid eligibility to all illegal immigrants at a cost of \$6.5 billion annually. The state is also considering legislation that expands a taxpayer-backed zero down, no payment home “loan” program to illegal immigrants.

– **Oregon:** Passed a law that expands a Medicaid program for illegal immigrants, conferring eligibility for the program regardless of “immigration status.”

– **New York City:** Attempted to pass a law, which was later struck down, allowing non-citizens to vote in local New York City elections.

– **Washington D.C.:** Passed a resolution allowing non-citizens to vote in local D.C. elections.

These initiatives fray the relationship citizens have with their government, but more distressingly, they render the concept of citizenship meaningless within the broader constitutional framework. And this is the masked reality of the replacement occurring within the United States.

Final thought: As American birth rates decline and the foreign-born population increases, demographic replacement of American citizens—the so-called “Great Replacement Theory”—is clearly not just a theory, but a reality. [[There have been many examples of this so-called “conspiracy theory” but the evidence has been all over the landscape in the past twenty or so years. Most recently I recall the fact that Tyson Foods was going to lay-off 50,000 workers. A week did not pass when it was

announced by Reuters News that Tyson was planning to hire as many immigrants for workers at \$15 an hour. Numerous companies put out the employment signs and notices, “hiring” but white folks are not welcome. In a poll released last week, The Associated Press and the NORC Center for Public Affairs Research found that about 1 in 3 Americans believe an effort is underway to replace U.S.-born Americans with immigrants for electoral gain.

On a regular basis, many adherents to the more extreme versions of the “great replacement” theory converse through encrypted apps online. They tend to be careful. They know they’re being watched. Tucker Carlson, Fox News’ most popular personality, has noted views that are more easily embraced by some white people who are concerned about a loss of their political and social power.

“I know that the left and all the gatekeepers on Twitter become literally hysterical if you use the term ‘replacement,’ if you suggest the Democratic Party is trying to replace the current electorate, the voters now casting ballots, with new people, more obedient voters from the Third World,” he said on his show last year. “But they become hysterical because that’s what’s happening, actually, let’s just say it. That’s true.”

A study of five years’ worth of Carlson’s show by *‘The New York Times’* found 400 instances where he talked about Democratic politicians and others seeking to force demographic change through immigration.

Fox News defended the host, pointing to repeated statements that Carlson has made denouncing political violence of all kinds. That “The Great Replacement” is a “theory” is a joke since it has been the American Council of Catholic Bishops that have been running a program for decades intending to bring into the U.S. those of the Roman Catholic faith from Central and South America for the purpose of to change the religious picture in the U.S.

Months before officials in New York City allowed migrants to displace students in public schools, or officials in Chicago turned O’Hare International Airport into a refugee center, the former general counsel for the Illinois Department of Children and Family Services made a frightening prediction about illegal immigration.

“This is going to be a catastrophe for our health-care system, our criminal justice system, our educational system,” Elizabeth Yore said in December. “We’re not going to recognize our society in two years. The crime and the chaos in the schools is going to be unimaginable. We are going to be paying for this for decades, generations.”

The fact that Yore, a conservative Catholic, made that criticism holds more than casual significance — especially since the United States Conference of Catholic Bishops effectively supports open borders.

As *'FrontPage Magazine'* twice reported, the USCCB uses taxpayer dollars to fund its human trafficking campaign, thereby enriching that body. But the payment it exacts for exploiting poor Latin American migrants exceeds the monetary.

The bishops use immigration as a weapon to implement Pope Francis' globalist vision, which demands the eradication of national identity and legitimate national self-interest. Finally, it explains the bishops' opposition to controlling illegal immigration through such means as *"a tripling of Border Patrol agents, especially at ports of entry, and the use of sophisticated technology such as ground sensors, surveillance cameras, heat-detecting scopes, and reinforced fencing,"* as a joint pastoral letter from American and Mexican bishops stated in 2003.

"That such measures might, in fact, deter or detect individuals trafficking children, the bishops ignored," Marjorie Murphy Campbell, a Catholic lawyer, wrote for *The Christian Review*, a website founded by the former publisher of a conservative Catholic magazine, *'Crisis'*.

But Francis is no outlier. His globalist agenda reflects six decades of papal policy, as *'FrontPage'* Magazine often reported. Starting with the Second Vatican Council, which lasted from 1962-65, Catholic leaders began advocating radically egalitarian and utopian solutions to besetting world problems. Implementing those solutions demanded globalist reorganization, preferably under one supranational body that would hold nations accountable.

Encyclicals from Popes John XXIII, Paul VI and Benedict XVI refined that policy. In 1963, John, who convened the council, used his encyclical *Pacem in Terris* to advocate creating an international *"public authority with power, organization and means"* that operates in *"a world-wide sphere of activity"* to devise and impose policy, he wrote. *"Consequently, the moral order itself demands the establishment of some such general form of public authority."*

In 1967, Pope Paul VI reinforced that appeal in his encyclical, *Populorum Progressio*.

"Such international collaboration among the nations of the world certainly calls for institutions that will promote, coordinate and direct it, until a new juridical order is firmly established and fully ratified," Paul wrote before quoting his own address to the United Nations. *"Who can fail to see the need and importance of thus gradually coming to the*

establishment of a world authority capable of taking effective action on the juridical and political planes?”

In 2009, Benedict offered the most detailed approach, as *‘FrontPage’* reported upon his death. In *Caritas in Veritate*, he advocated replacing the UN with “*a true world political authority*” to secure “*the common good*” by regulating national economies, diplomacy and international law. It would have power “*to ensure compliance with its decisions from all parties,*” he wrote, “*so that the concept of the family of nations can acquire real teeth.*”

Such an agency, Benedict continued, would “*manage the global economy to bring about integral and timely disarmament, food security and peace; to guarantee the protection of the environment and to regulate migration.*” Protecting the environment would involve “*a worldwide redistribution of energy resources.*” (Emphasis added)

Francis built on that foundation with two encyclicals of his own: *Laudato Si* on environmental sustainability and *Fratelli Tutti* on economic redistribution. In 2019, Francis expressed the papal commitment to globalism when the Pontifical Academy of Social Sciences met:

“The nation-state cannot be considered as an absolute. In the current situation of globalization, the nation-state is no longer able to procure on its own the common good of its populations. The common good has become global and nations must affiliate themselves for their own benefit. When a supranatural common good is clearly identified, it necessitates a specific, legally and concordantly constituted authority capable of facilitating its fulfillment.” (Emphasis added)

In March 2021, during an interview to promote his book, *‘God and the World to Come’*, Francis said that a “*new world order*” must emerge from the aftermath of the COVID-19 pandemic:

“Let us all keep in mind that there is something worse than this crisis: the drama of wasting it. Instead, we can heal injustice by building a new world order based on solidarity, studying innovative methods to eradicate bullying, poverty and corruption, all working together, each for their own part, without delegating and passing the buck.” (Emphasis added)

That November, Francis reiterated that call to the Paris Peace Forum:

“Faced with the consequences of the great storm that has shaken the world, our conscience therefore calls us ... not to follow the easy path of returning to a ‘normality’ marked by injustice, but to accept the challenge of assuming the crisis as ‘a concrete opportunity for conversion, transformation, to rethink our lifestyle and our economic and social systems.’”

Unfettered immigration serves the globalist agenda by eroding national law, identity and culture. Europe provides the prime example. Francis encourages millions of Middle Eastern Muslims to migrate there, regardless of problems concerning assimilation, yet never encourages them to become Christians.

As Francis' apostolic representatives in the United States, the bishops engage in two tactics to promote his interests.

Los Angeles Archbishop Jose Gomez represents the velvet glove. Gomez, born in Mexico, addressed the Catholic Napa Institute in 2011, the year he became archbishop, on immigration's role in American culture.

After acknowledging and praising the pivotal role Calvinist immigrants to New England and the Founding Fathers played in forging the nation's identity, Gomez directed attention to Spanish colonization in Florida and California.

"It is the story not of colonial settlement and political and economic opportunity," Gomez said. "It is the story of exploration and evangelization. This story is not Anglo-Protestant but Hispanic-Catholic. It is centered, not in New England but in Nueva España — New Spain — at opposite corners of the continent."

By forgetting *"our country's roots in the Hispanic-Catholic mission to the new world,"* Gomez continued, *"we end up with an idea that Americans are descended from only white Europeans and that our culture is based only on the individualism, work ethic and rule of law that we inherited from our Anglo-Protestant forebears."*

Gomez then disregards the rule of law by ignoring the illegal status of many immigrants and focusing on their potential.

"These immigrants — no matter how they came here — are people of energy and aspiration," he said. *"This is why I believe our immigrant brothers and sisters are the key to American renewal. And we all know that America is in need of renewal — economic and political, but also spiritual, moral and cultural renewal. I believe these men and women who are coming to this country will bring a new, youthful entrepreneurial spirit of hard work to our economy. I also believe they will help renew the soul of America."* (Emphasis added)

Catholics, of course, have their own pivotal role to play.

"Catholics need to lead our country to a new spirit of empathy," Gomez said. *"We need to help our brothers and sisters to start seeing the strangers among us for who they truly are — and not according to political or ideological categories or definitions rooted in our own fears."*

The second tactic is the iron fist, which San Diego Cardinal Robert McElroy represents. In 2017, while still a bishop, McElroy encouraged his audience to act as “*disruptors*” by encouraging disobedience to immigration law.

“We must disrupt those who would seek to send troops into our streets to deport the undocumented, to rip mothers and fathers from their families,” he said. *“We must disrupt those who portray refugees as enemies, rather than our brothers and sisters in terrible need.”*

McElroy’s inflammatory rhetoric not only imitates the “*resistance*” narrative Trump’s enemies embraced. It silently equates American immigration authorities to Gestapo agents seeking Jews.

In August 2022, McElroy received his reward when Francis made him a cardinal.

But rhetoric means nothing without action. As ‘*FrontPage*’ reported, an investigation from the Heritage Foundation discovered that Catholic Charities linked almost 3,400 separate mobile phones to anonymous contacts in 433 of the nation’s 435 Congressional districts. The investigation also traced 22,000 cell phones from all NGOs to 431 districts.

“Of the 52 congressional districts with the highest density of devices,” the foundation reported, *“71 percent were Republican congressional districts.”*

By supporting and profiting from illegal immigration, the bishops not only have declared war against their countrymen. By trying to implement Francis’ agenda, the bishops essentially act as agents of a hostile foreign government.

Maureen Mullarkey, a conservative Catholic commentator, powerfully summarized the significance of their position.

“By admonishing voters to ‘humanize globalization,’ the bishops position themselves in the vanguard of a globalist world freed from competing national aims and interests,” she wrote. *“To a clerical elite impatient for the withering away of the national state, an open border is the staging ground for assault on citizenship and national sovereignty.”*

Not for nothing does Mullarkey call the USCCB “*a fifth column in cope and chasuble.*” There is a very well-known cliché that goes like this: “All roads lead to Rome” and as noted in a previous report (page 20) on Pope Francis reminded Anglican Leaders of Rome’s Supremacy over All of Christianity During His Call for Greater Cooperation. It doesn’t end there. If Florida and Texas flip, then Democrats will hold power FOREVER. So via jihad by illegal invasion, including sending jihadists and islamists among the illegals, America is in real trouble! Carbon dioxide is a pollutant, the Environmental Protection Agency says. It's been drilled into us for more than 30 years that we have to cut our CO2 emissions if we don't want the world to end too soon. But we know that the climate scare is in no way related to protecting the sky. The data tell us so.

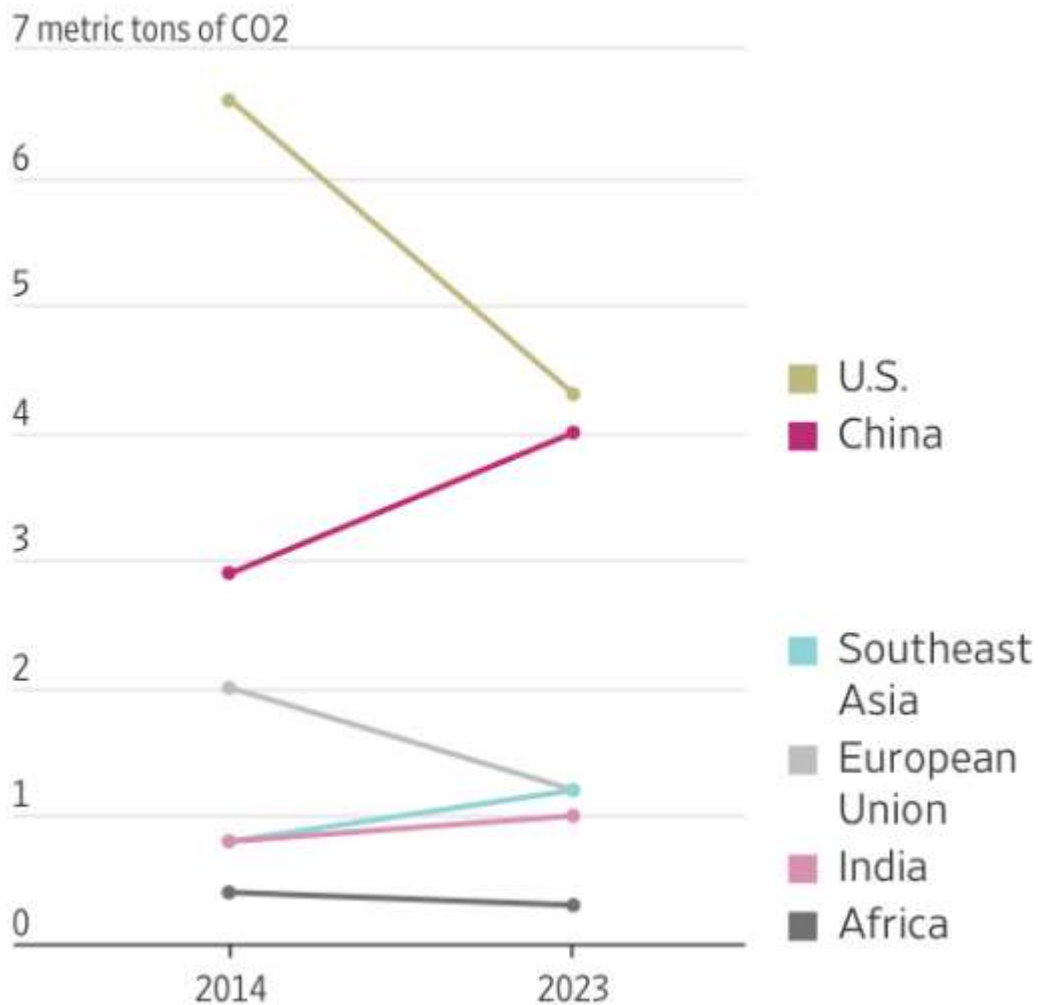
Over the last three calendar years, 2021, 2022, and 2023, "no country has reduced its carbon emissions more than any other major nation on a per capita basis," the Committee to Unleash Prosperity tells us.

"Even though our GDP is about 50% higher than China's, our per capita emissions are roughly the same," says the group.

The data also tell us that though China's emissions grow every year, *"ours have come down every year over the last decade."*

Yet the U.S. is continually singled out as the worst greenhouse gas offender, while China – and India – escape the wrath of the climate kooks, from Greta Thunberg to Democratic New York Rep. Alexandria Ocasio-Cortez to actor Leonardo DiCaprio, who actually [praised China's efforts](#) to reduce greenhouse gas emissions."

The [CTUP chart above](#) shows a sharp decrease in U.S. emissions and a modest drop in European Union emissions. But look at the increases in India, Southeast Asia, and China, particularly the latter. Can anyone remember when climate alarmists traveled to Beijing, Mumbai, or Jakarta to publicly chastise the nations these capitals represent for their emissions? When was the last time a U.S. lawmaker demanded that these countries cut their fossil fuel use?

Benjamin Netanyahu: “*We Just Started The Sacrifice Ritual Of The Red Heifer*” In Jewish tradition, the red heifer sacrifice is a major purification ritual. Using the ashes of the red heifer, people were cleansed of impurities from contact with a corpse. Since the time of Moses, only nine red heifers have been offered as sacrifices. With a tenth sacrifice looming, many people are recalling a prophecy that suggests such a sacrifice could signal the end of the world.

What is the red heifer sacrifice? Is there any connection between it and the end of the world? Join us as we look at the red heifer sacrifices and their significance over the centuries. The red heifer prophecy is tied to the belief that the sacrifice of the red heifer heralds the arrival of the last days and is a necessary condition for the second coming of Christ.

Jewish tradition notably awaits the tenth red heifer, which is thought to be required for the purifying rites connected to the reconstruction of the Third Temple in Jerusalem. Let's review the background information regarding the red heifer and its prophecy.

Since 1967, non-Muslims have been allowed to visit Al-Aqsa but not pray at the holy site. Yet that status quo is rapidly eroding in recent years as Israeli Jewish settler groups work alongside the government to take control of the compound.

Under Jewish law, the ashes of a red heifer (young female cow) must be scattered across Haram al-Sharif before Jews can ascend it and rebuild the Third Temple. While the hunt for a red heifer has long been considered a fringe initiative touted by Temple Mount activists, new research reveals the Israeli government is now involved in this endeavor.

According to Jerusalem-focused non-profit [Ir Amim](#), the Israeli government authorities helped the temple mount activist group, the Temple Institute, and Boneh Israel, an Evangelical organization, import five cows from the United States last year to be used for the red heifer sacrifice.

The Ministry of Agriculture allegedly assisted in bypassing standard regulations in order to import the live cows from the U.S., which is prohibited. In a press release, Boneh Israel and the Temple Institute claim they received permission to import the cows through the Ministry of Agriculture.

The Ministry of Jerusalem Affairs and Heritage also assisted in the project. The Ministry's Director General, Netanel Isaac, disclosed in a speech at the cows' welcome ceremony in September 2022 that the agency has been funding the development of the Mount of Olives area where Temple Mount activists plan to initiate the red heifer ritual sacrifice. Additionally, the ministry is involved in transferring the cows to a visitor center and farm created for the red heifer project at the Tel Shiloh archaeological site in the occupied West Bank. Currently, the cows are being held at a kibbutz (Jewish commune) in the Jordan Valley. [One of the cows is reportedly](#) already at the Israeli settlement research center, however.

Ir Amim emphasized that while this project is being spearheaded by the current Israeli leadership, government assistance actually began during the previous government under former Israeli Prime Ministers Yair Lapid and Naftali Bennett, which was deemed more moderate and politically diverse than Benjamin Netanyahu's present coalition.

Senior Ir Amim Field Researcher, Aviv Tatarsky, explained that only 15 years ago, the idea of Jews praying at Haram al-Sharif was a radical notion promoted by right-wing extremists. Yet now it's firmly rooted in the Israeli mainstream.

"The change is that nationalistic and fundamentalistic ideologies are dominant in Israeli society," Tatarsky said. "They have won over Israeli society."

The Israeli ministries involved and the Temple Institute did not respond to requests for comment. Boneh Israel could not be reached before the deadline.

DANGEROUS IMPLICATIONS

Despite the Israeli government's vow to keep with the status quo at Al-Aqsa, settlers involved in the red heifer project underscore the aim is Jewish ascension on Haram al-Sharif in order to reconstruct the Third Temple — implying the destruction of the Dome of the Rock.

While Jewish settlers are increasingly storming Haram al-Sharif, many rabbis today forbid this as ancient Jewish law dictates the red heifer's ashes are required to purify the area before Jews can ascend. Because of this, most religious Jews don't even enter the compound, and those who do may only walk on certain parts. With the red heifer ritual, the number of Jews storming Al-Aqsa may then multiply.

"It could lead to maybe hundreds of thousands of Haredis [ultra-Orthodox Jews] or Sephardis [Spanish Jews] who might actually break into the mosque and cause a real religious war," Dr. Abdallah Marouf, an Islamic history professor at Istanbul 29 Mayıs University and ex-media official at Al-Aqsa Mosque, told *MintPress News*.

Senior figures involved in this initiative have told media outlets the project's ultimate goal is to rebuild the Third Temple, destroyed by the Romans in 70 C.E.

"The prophecies came true, and the Jews are back in Israel," Byron Stinson, responsible for raising the cattle and bringing them to Tel Aviv, told the [Jerusalem Post](#). *"Now they need to build a Temple. But it's like buying a really nice car. If you don't have the key, you aren't going anywhere. The red heifer is the key to making the Temple work like it's supposed to."*

Stinson is part of Boneh Israel and [also founded](#) the Father's House Foundation, a U.S. tax-exempt charity organizing trips to Israel. In addition to Stinson's Father's House Foundation, other U.S.-based, tax-exempt non-profits are also mixed into this red heifer endeavor, like P.E.F. Israel Endowments Fund and Biblical Faith, which accept donations for the [Temple Institute](#). [Boneh Israel is backed by Reshit](#), an Israeli settler group headed by Tzachi Mamo, another key person in the red heifer project.

Reshit is currently working with the Jerusalem Affairs Ministry to develop the "Northern Trail" project, a tourist walking route from Damascus Gate to Sheikh Jarrah highlighting settler homes and sites of Jewish history. In developing the route, the state and settlers are attempting to erase Palestinian identity by [expanding existing Israeli sites](#). In 2023, [the organization received](#) 17,635 shekels (around \$4,600) from the Israeli Education Ministry.

Mamo told the [Christian Broadcasting Network](#) that he bought a plot of land on the Mount of Olives in 2011 meant for performing the red heifer sacrifice.

“And we hope that in a year and a half from today, we can make here in this area the ceremony of the red heifer that actually will be the first step to the Temple,” Mamo told CBN.

According to land registration documents reviewed by Ir Amim’s Tatarsky, the land is registered under an unknown company and was originally owned by Palestinians.

Additionally, Ir Amim’s research notes that the Jerusalem Development Authority is currently working to build a promenade on the Mount of Olives leading to the location where Mamo intends to hold the red heifer ritual.

While the Red Heifer project seeks to obtain Jewish sovereignty over Al-Aqsa, Marouf has faith that the Palestinian people will fight to preserve the status quo, which [they’ve done in previous instances when the sanctity of Al-Aqsa was under threat](#).

“It’s happening now. However, that doesn’t mean that it will happen,” Marouf said. *“A very important element in this equation is the Palestinian people in Jerusalem, who have proved to be the main obstacle against Israeli settler rights groups and the Israeli government.”*

On October 7, 2023, Hamas led a stunning coordinated attack, which took place on Shemini Atzeret, a Jewish holiday that closes the autumn thanksgiving festival of Sukkot. Many IDF soldiers were on leave, and the IDF’s attention had been focused on Israel’s northern border rather than on the Gaza Strip in the south. [Reports suggested that the attack was an effort to stop the sacrifice of a red heifer.](#) That was confirmed in a CBN broadcast. Link to the CBN broadcast: <https://youtu.be/-bqKTZ4S7Ek?t=606>

The assault began about 6:30 AM with a barrage of at least 2,200 rockets launched into Israel in just 20 minutes. During that opening salvo, Hamas used more than half the total number of rockets launched from Gaza during all of 2021’s 11-day conflict. The barrage reportedly overwhelmed the Iron Dome system, the highly successful antimissile defense system deployed throughout Israel, although the IDF did not specify how many missiles penetrated the system. As the rockets rained down on Israel, at least 1,500 militants from Hamas and the PIJ infiltrated Israel at dozens of points by using explosives and bulldozers to breach the border, which was heavily fortified with smart technology, fencing, and concrete. They disabled communication networks for several of the Israeli military posts nearby, allowing them to attack those installations and enter civilian neighborhoods undetected. Militants simultaneously breached the maritime border by motorboat near the coastal town of Zikim. Others crossed into Israel on motorized paragliders.

About 1,200 people were killed in the assault, which included families attacked in their homes in kibbutzim and attendees of an outdoor music festival. That number largely comprised Israeli civilians but also included foreign nationals. A March 2024 United Nations report found evidence that some were victims of sexual violence before they

were killed. Adding to the trauma was the fact that it was the deadliest day for Jews since the Holocaust.
