The Christmas holiday for much of the world becomes controversial and evokes unspeakable emotions like few that I can recall. The “War on Christmas” has become an annual feature of the holiday season in the U.S., with much of the debate centering around religious displays on publicly-owned property. This cultural conflict is fueled by disparate understandings of Christmas and American history between religious conservatives and secular progressives. The pagan roots of Christmas, the founding of America, and legal precedent, shows that historical fact tends to fall on the side of secularists arguing against government-sponsored religious displays at Christmas.

In ancient pagan times, the last day of winter in the Northern Hemisphere was celebrated as the night that the Great Mother Goddess gives birth to the baby Sun God. It is also called Yule, the day a huge log is added to a bonfire, around which everyone would dance and sing to awaken the sun from its long winter sleep.

In Roman times, it became the celebrations honoring Saturnus (the harvest god) and Mithras (the ancient god of light), a form of sun worship that had come to Rome from Syria a century before with the cult of Sol Invictus. It announced that winter is not forever, that life continues, and an invitation to stay in good spirit.

The first day of winter in the Northern Hemisphere occurs between the 20th and 22nd of December. The Roman celebrated Saturnalia between 17 and 24 December.

To avoid persecution during the Roman pagan festival, early Christians decked their homes with Saturnalia holly. As Christian numbers increased and their customs prevailed, the celebrations took on a Christian observance. But the early church actually did not celebrate the birth of Christ in December until Telesphorus, who was the second Bishop of Rome from 125 to 136AD, declared that Church services should be held during this time to celebrate "The Nativity of our Lord and Saviour." However, since no one was quite sure in which month Christ was born, Nativity was often held in September, which was during the Jewish Feast of Trumpets (modern-day Rosh Hashanah). In fact, for more than 300 years, people observed the birth of Jesus on various dates.

In the year 274 A.D., the solstice fell on 25th December. Roman Emperor Aurelian proclaimed the date as "Natalis Solis Invicti," the festival of the birth of the invincible sun. In 320 A.D., Pope Julius I specified the 25th of December as the official date of the birth of Jesus Christ.

A.D. is short for Anno Domini, or "Year of our Lord," as proclaimed by the Roman Catholic Church. Some non-Christians prefer the alternative designation "CE" for "Common Era."

In 325 A.D., Constantine the Great, the first Christian Roman emperor, introduced Christmas as an immovable feast on 25 December. He also introduced Sunday as a holy day in a new 7-day week, and introduced movable feasts (Easter). In 354 A.D., Bishop Liberius of Rome officially ordered his members to celebrate the birth of Jesus on December 25th.

However, even though Constantine officiated December 25th as the birthday of Christ, Christians, recognizing the date as a pagan festival, did not share in the emperor's good intentions. Christmas failed to gain universal recognition among Christians until quite recently.

In England, for instance, Oliver Cromwell banned Christmas festivities between 1649 and 1660 through the so-called Blue Laws, believing that Christmas should be a solemn day. When many Protestants escaped persecution by fleeing to the colonies all over the world, interest in joyous Christmas celebrations was rekindled there. Still, Christmas was not even a legal holiday until the 1800s. And, keep in mind, there was no Father Christmas (Santa Claus) figure at that time.

The popularity of Christmas was spurred on in 1820 by Washington Irving's book '*The Keeping of Christmas*' at Bracebridge Hall.

In 1834, Britain's Queen Victoria brought her German husband, Prince Albert, into Windsor Castle, introducing the tradition of the Christmas tree and carols that were held in Europe to the British Empire.

A week before Christmas in 1834, Charles Dickens published '*A Christmas Carol*' (in which he wrote that Scrooge required Cratchit to work, and that the U.S. Congress met on Christmas Day). It was so popular that neither the churches. Nor the governments. could not ignore the importance of Christmas celebrations.

In 1836, Alabama became the first state in the US to declare Christmas a legal holiday.

In 1837, T.H. Hervey's '*The Book of Christmas*' also became a best seller.

In 1860, American illustrator Thomas Nast borrowed from the European stories about Saint Nicholas, the patron saint of children, to create Father Christmas (Santa Claus).

In 1907, Oklahoma became the last U.S. state to declare Christmas a legal holiday. Year by year, countries all over the world started to recognize Christmas as the day for celebrating the birth of Jesus.

Today, many of the pagan uses are reflected in Christmas. Jesus was born in September 11, 3 B.C., yet his birth is celebrated on December 25, the time of solstice. The Christmas celebrations end the 12th day of Christmas (January 6), the same amount of days that the return of the sun was celebrated by ancient and Roman pagans. It thus is no surprise that Christian puritans – or even conservative Christians – often are upset that Christmas “is not as religious as it was meant to be,” forgetting that Christmas was not celebrated at all until fairly recently.

The passion and fervor on both sides makes sense given the historical assumptions of each. But who's right? Fortunately, this is not a debate about religious doctrine, but largely about historical facts which can be researched and verified. Of course, you have to be careful to avoid the propaganda on both sides, but honest research will reveal that, for the most part, the secular progressives and non-Christians are right—especially about Christmas. It's not likely that God intended the birth of the Saviour to be honored. Jesus Christ said “***if you love me, keep my commandments.***” –(John 14:15).

Not until it became clear that Christmas was here to stay did Christians rekindle their efforts to claim the holiday for themselves with mantras such as “Jesus is the reason for the season.” Yet the most popular Christmas traditions, movies and songs remain secular. As historian Stephen Nissenbaum put it in *The Battle for Christmas*, “Christmas has always been an extremely difficult holiday to Christianize.” Tradition is not sufficient enough to revere events or special days because in our world someone is looking to add some money-making scheme to part one of their hard-earned income. Constantine's church is always venerating some saint to fill the Vatican's coffers.

“As one irate Italian wrote on social media of the Vatican manger scene, “Ugliness is the first thing you notice, followed by a lack of familial warmth and the distancing guaranteed by the cylindrical figures. If you wish to judge harshly, the cylinders call to mind the sacred poles of Satanic cults condemned in the Bible.”

Traditionally, a manger scene is intended to evoke feelings of piety and devotion — not pity and revulsion — over the birth of Jesus in Bethlehem, and thus this particularly regrettable work offends not only aesthetic sensibilities, but also the religious reverence of the faithful.



The Vigilant Citizen web site describes it this way: In a way, this year’s Nativity scene is a sad reflection of the year 2020. It is a collection of expressionless and socially-distanced figures that do not interact with each other while standing under the neon glow of phone and computer screens.

It also reflects how the occult elite reared its ugly head this year, poisoning every aspect of our lives with its toxic agenda. Through a display that is thoroughly anti-Christian, the elite sought to prove that its toxic ideology is also embedded in the Vatican.

While “Monumental Nativity” was created decades ago, it was selected for this year’s 2020 Nativity scene for a specific reason: It contains specific symbols while conveying a specific energy. The CICV lists "ethical behavior" as one of its "principles of governance" and is tasked with "answering the challenge by Pope Francis to apply principles of morality to business and investment practices."

The pope, however, has not raised fundamental moral issues with his key partners in the CICV under the category of "ethical behavior," even though the Church condemns abortion and homosexuality as "intrinsically evil" and pornography as a "grave offense." Talk about speaking out of both sides of his mouth, this Jesuit must have great script writers.

A majority of the pope's "guardians" (as the council members are called) include the Rockefeller Foundation, Ford Foundation, Kering group, Allianz, MasterCard, Estée

Lauder, Guardian Life Insurance Company of America, California state treasurer Fiona Ma and Johnson & Johnson — who are on record promoting abortion, pansexuality, the Marxist Black Lives Matter (BLM) and uncontrolled immigration.

Papal biographer and political theorist Paul Kengor told Catholic laity groups that *"many of these 'guardians' are terribly wrong on vital social-moral matters of great value to the Church:*

In those areas, they're well outside of and, in fact, stand in grave violation of Church teachings. That does make them suspect in my eyes and in the eyes of many faithful Catholics."

Michael Voris, a devout Roman Catholic expressed it this way, *"If we can't trust them on the most vital social-moral matters of the day, then how can we trust them as 'guardians' of responsible 'capitalism?'"* As a Bible-believing Christian, I concur wholeheartedly.

While Kengor questions how Francis intends to "'reform' 'capitalism' via these globalist-elite 'guardians,'" Alexander Tschugguel, director of the St. Boniface Institute, is warning Catholics to *"be deeply concerned by what is currently being sold to us under the slogan of 'inclusive capitalism.'"*

The pope has little affection from the majority of the Roman Catholic Institution. Note carefully, I use the term "institution" as it is not a "church" in the Biblical sense of the meaning. In "Blessed Hope #39" I provided the basis from which the Roman antichurch traces its roots back to Babylon and "Sun" (not "Son") worship. The St. Boniface Institute was founded to give Catholic laity the possibility to speak out. From the heart of Europe, the Institute fights for the restoration of Catholic culture and traditions, for a church that follows our Lord and Saviour Jesus Christ! Catholic lay groups vent but little of what they say is given much of an ear in the Vatican. Remember, Rome never changes.

Speaking to Church Militant, a Roman Catholic lay group, Tschugguel explained: *"I think it is no coincidence that this new council was founded shortly after the World Economic Forum (WEF) started to promote the idea of the 'Great Reset.' The proposals being put forward by the WEF and this new council seek to undermine free initiative and private property. They go against Catholic social teaching, especially the teachings of Pope Leo XIII."* Tschugguel is on target as under the Global Reset ownership of private property will end. This is why the U.S. has been under global attack from the "Sustainable Development" crowd. It remains to be seen how the 2nd largest land owner in the U.S., Ted Turner will relinquish ownership of private property.

"What is behind the 'Great Reset' and 'inclusive capitalism' is nothing but pure communism," Tschugguel, who became famous for throwing Pachamama statues into the river Tiber during the Amazon Synod, warned." The Amazon Synod was a pan-

American summit held in Rome in 2017, which was filled with controversy, promotion of much of what even Catholics are repulsed by in the way of reform and debauchery.

Homosexuality, promiscuity and other abandonment of Christian morality have been identified in the U.S. Congressional Record as fundamental steps in weakening sovereign nations to communist takeover, in that they weaken the family and increase dependence on the State.

It is important to understand that the sentiment in the Roman Catholic Institution today is much closer to Protestants than perhaps was the case in the days of Martin Luther and the Reformation era begun in 1517. If we can't trust them on the most vital social-moral matters of the day, then how can we trust them as 'guardians' of responsible 'capitalism?'

Catholics on social media are excoriating Pope Francis for being "unequally yoked" with organizations like the Rockefeller Foundation which supported the racist pseudoscience of eugenics in Nazi Germany, but *"today, though, they act as if this ugly part of their legacy never happened."*

The Rockefeller Foundation, now part of CICV, also funded America's two most destructive sexual revolutionaries: Dr. Alfred Kinsey and his "child rape-based sexual freedom agenda" and Margaret Sanger, founder of abortion giant Planned Parenthood. This somehow seems inconsistent with traditional Catholic teachings.

What few people understand is that the Jesuits or "Society of Jesus" in reality is a divisive factor in the goal of destroying the "church" from within. The fact that Popes Francis and Arturo Sosa sit at the throne of the world's largest religious institution is proof positive that it is an Anti-Christ Institution. It reeks of Marxist and Vatican communism.

The initiative pushes Prince Charles *"sustainable development,"* a UN push to eliminate private property. The elimination of nationalism is very much central to this agenda. You need to go all the way back to Adam Weishaupt's goals for society to understand and grasp that this New World Order is not new by any sense of the imagination. It is a repackaged Old World Order but in egalitarian language.

Adam Weishaupt was born in 1748 of Jewish parents but grew up in the Catholic faith. When his father, George Weishaupt, died in 1754, young Adam was turned over to be raised by the Jesuits by his godfather, Baron Ickstatt, who was curator of the University of Ingolstadt in Bavaria. He converted to Protestantism when studying law at Ingolstadt.

He studied classic religion and theology and the Eleusian and Mithrian mysteries, and also the works of Pythagoras. We don't know much about his childhood or his early life, and even his name itself is somewhat of a mystery.

Adam means "the first man", "Weis" means "to know" and "haupt" means "leader",

which makes Adam Weishaupt's name mean "the first man to lead those who know". He graduated from the University of Ingolstadt in 1768, and was made a tutor and catechist. In 1772 he was made a professor of Law. The term "Illuminati" means the enlightened ones and is today a code word for the Jesuits. It had great appeal to the Renaissance "man" of Europe when the Protestant Reformation had led many to reject the Roman Catholic Church. Ingolstadt is located north of Munich and a heartland of Catholicism in Germany.

He was initiated as a Freemason in 1774 in either Hanover or Munich, but he found that no one in his order truly understood the occult significance of the ceremonies. He decided to found his own organization, which he did on the first of May 1776. Hence, the term "May Day" is associated with rebellion and revolution.



This organization was first known as "The Order of Perfectibilists" but became famous as the "Ordo Illuminati Bavaensis", or the Illuminati for short.

Only five people were present at the first meeting of the order, but it grew rapidly and only a few years later it had chapter houses all over Germany, Austria, France, Italy, Hungary and Switzerland.

Weishaupt and his co-conspirators, notably Baron Knigge and a lawyer named Zwack, had soon established a network of agents around Europe that infiltrated courts and other places of power and reported back useful gossip and information to Weishaupt.

The Illuminati's true goals were shrouded in mystery. Because of Weishaupt's strong anti-clerical and anti-royalistic views, some have assumed that the Illuminati were some sort of proto-communistic organization dedicated to bringing about a proletarian revolution.

Others have seen them as anarchists, or descendants of the Cathars, or the Knights Templar and the Assassins of Hassan En Sabbah, the "Old Man on the Mountain", with whom the Knights Templar were rumored to be in contact with.

Yet others have seen them as Satanic agents dedicated to nothing less than the domination of the planet and the bringing about of the Kingdom of Satan on Earth. From where I sit and from my years of research and study this is my conclusion.

It is true that Weishaupt's plans certainly was hostile to the Church of Rome and the monarchies of Europe, and that he seemed to harbor what would today be called "socialistic" leanings, but Weishaupt wasn't an atheist or agnostic. There is little doubt that Weishaupt was a deeply religious man in his own way. Weishaupt said in a speech held shortly before the French revolution:

"Salvation does not lie where strong thrones are defended by swords, where the smoke of censers ascend to heaven or where thousands of strong men pace the rich fields of harvest. The revolution which is about to break will be sterile if it is not complete."

This statement has often been taken as to mean that Weishaupt was in fact a sort of communist, and in a sense he was. One could think the above quote a statement by Trotsky.

However, as the Illuminati's true goals has always been disputed it is difficult to find out what exactly was the political, if such a dirty word may be used, or ideological *raison d'être* of the order.

Of course, the easiest way to be able to make an educated guess is to study the actions of the order. In the year 1784 the Illuminati attempted a coup against the Hapsburgs, but the plot was revealed by police-spies that had infiltrated the order on orders from the king.

This led to the total ban of all secret societies in Bavaria, and membership was punishable by death. This edict was signed in June 1784. Weishaupt was forced to flee to a neighboring province in February 1785 and in March another edict was passed, this one specifically outlawing the Illuminati.

The Illuminati was forced to go underground in Bavaria and had to move its revolutionary efforts elsewhere. France and Austria to a lesser degree became home.

Disaster again struck for the order when in July 1785 lightning struck an Illuminati courier, a man named Lanz, and killed him and the horse he was riding. Sewn into his riding coat was found extensive documents that outlined the Illuminati's plans for world domination and revolution, and also named several high ranking Illuminati members, among them Zwack and Weishaupt.

Zwack was arrested and his home raided in October, 1786. Weishaupt's activities after 1790 are disputed, several different versions of his life after 1790 exists. In Robert Anton Wilson and Robert Shea's famous *trilogy Illuminatus!* for instance, it is suggested that Weishaupt traveled to America and assumed the role of George Washington. Any evidence to that suggestion has never been discovered.

Others claim that Weishaupt died in obscurity in 1830. We know that Weishaupt and Baron Rothschild teamed up together with the House of Rothschild became the source of funding from the time of the Congress of Wilhelmsbad in July of 1782. Freemasonry and other secret orders formed what we call the Illuminati today.

The French Revolution of 1789 has been widely attributed to the machinations of the Illuminati, and its role has been described as everything from "negligible" to "sole cause". Both statements are an exaggeration, but it cannot be denied that several persons who were intensively involved in the revolution was active members, among

others the Comte de Mirabeau, famous author, orator, Freemason and arch-enemy of the Marquis de Sade.

Mirabeau is reported to have said in a speech at the international Freemason convention in Wilhelmsbad in 1782 that he was a member of an organization that was influenced by the Knights Templar, and that their goal was to destroy the Church and the monarchy so that the "Religion of Love" could be established in France.

Of course, the Illuminati was not the only secret revolutionary conspiracy around. There were plenty of others in these turbulent years just before the revolution. For instance, the Marquis de Luchet, who were opposed to the Illuminati but supportive of the revolution, said in a speech:

"There exists a conspiracy in favor of despotism, against liberty, of incapacity against talent, of vice against virtue, of ignorance against enlightenment. This society aims to govern the world."

These inner conflicts among those who supported the revolution were also seen in other secret societies in France during this period. By the year 1788, almost every lodge of Freemasons in Europe, as well as all courts, had been infiltrated by the agents of the Illuminati. Freemasonry is well-entrenched in the courts, law enforcement, and jurisprudence of all variations.

Despite this many of the established lodges in France remained loyal to the king, and only a few took part in the revolution. It is interesting to note that the very first time anyone saw revolutionaries wearing the Phrygian cap, supposed symbol of the Illuminati and the Phrygian mysteries, was at the forced interruption of a theatrical performance of 'Le Suborneur' by the Marquis de Sade on Monday the 5th of March 1792. If you take close notice of video footage of the riots in Wisconsin and Oregon, you would have seen the revolutionary Phrygian cap. It is even found on the seal of the U.S. Senate shown below. You may recognize the Smurf character to the left.



It is like Ambrose Bierce wrote about the Freemasons in his *The Devil's Dictionary*:

"An order with secret rites, grotesque ceremonies and fantastic costumes, which originating in the reign of Charles II, among working artisans of London, has been joined successively by the dead of past centuries in unbroken retrogression until now it embraces all the generations of man on the hither side of Adam and is drumming up distinguished recruits among the pre-Creational inhabitants of Chaos and the Formless Void.

The order was founded at different times by Charlemagne, Julius Caesar, Cyrus, Solomon, Zoroaster, Confucius, Tothmes and Buddha. Its emblems and symbols have been found in the Catacombs of Paris and Rome, on the stones of the Parthenon and the Chinese Great Wall, among the temples of Karnak and Palmyra and in the Egyptian Pyramids -always by a Freemason."

Ludwig XVI, the French king, wasn't unaware of the revolutionary activities and general displeasure among the populace. In June, 1789 he tried to introduce some social reforms that he hoped would calm the populace.

The king's greatest mistake was when he demanded that the monarchy would be preserved and that the nobles were to retain the right of veto in all future reforms. This led to minor rebellions that spread and finally culminated in the taking of the Bastille.

Mirabeau said in a speech shortly thereafter:

"The idolatry of the monarchy has received a death blow from the sons and daughters of the Order of the Templars."

This statement suggests that the Illuminati had ties to both the Cathars and the Knights Templar. Under the later period of the revolution the influence of the Illuminati becomes marked. The red Phrygian caps are used as symbol of the revolutionaries, the symbol of the Illuminati, the eye in the triangle, is present on many revolutionary documents printed in these days.

Two years after Ludwig XVI failed escape attempt, on the 21st of January 1793, he was executed, and it is said that when the king's head fell an old man cried from the crowd:

"De Molay, thou art avenged!"

Jacques De Molay was the leader of the Knights Templar who was burned at the stake for witchcraft in March 19, 1314 by the machinations of Philip the Fair and Pope Clement V. De Molay was last grand master of the Knights Templar, an order of knighthood founded during the Crusades that had attained extensive power and wealth. He failed to exercise effective leadership at the time of the suppression of the order by King Philip IV the Fair of France and Pope Clement V.

It should perhaps be mentioned that before his execution De Molay was held prisoner in the Bastille, the first "victim" of the Revolution. After the French revolution the Illuminati

faced new difficulties, partly because of the confused political and social situation in France, and partly because the rest of the royal houses of Europe panicked when they realized what had happened in France and banned all secret societies.

Persecutions of Freemasons and Rosicrucian's began, and in 1792 an ex-grandmaster of a Knights Templar inspired organization was lynched in Versailles by an angry mob. Suspicion of all secret societies was widespread, and increased when Robinson's *'Proofs of a Conspiracy'* was published in 1798. This volume contained an outline of the orders supposed survival after its suppression as the German Union, and how it had engineered the Revolution.

The book caused widespread fear in Europe and New England, and was one of the main reasons for the ban against secret societies in most of Europe.

After the rise of Napoleon Bonaparte the days of the Illuminati in France were numbered. Most of the existing Lodges of Freemasons and other secret societies were infiltrated by the agents of Napoleon, who made sure to remove all possible subversive organizations in order to consolidate his power.

Most conventional historians will argue that the Illuminati, if it survived at all after the events of 1785-86, now was utterly crushed. We can only wish that were true!

The very core tenet of Marxism and its two versions called socialism and communism is to actually replace the family structure. In Russian communism, Stalin was paranoid about any possible resistance. Children were taught that the state was their parent instead of their biological parents, and if those creatures spoke anything against the state then the children should report them. Karl Marx's view on religion also explains his view of family. *"Religion is the sign of the oppressed creature, the heart of a heartless world, and the soul of soulless conditions. It is the opium of the people."*

The lofty idea of socialism is appealing to many, but they never talk about what lies below the slogan and surface. The reason I say socialism is collapsing, not capitalism, is rather simple. We do not live under pure capitalism for that is what existed before socialism's introduction with, actually, the Republican, Teddy Roosevelt using the label "progressive." What enraged Marx so much was the British system of Long Lease keeping the property in the family for generations. This is why so many people fled to America after hearing that it was the American Dream to own your own home and leave it to your children. Marx was against the ownership of property outright under communism, whereas under socialism you could own your own property but you were taxed and regulated at every step of the way.

What is behind the 'Great Reset' and 'Inclusive Capitalism' is nothing but pure communism. Traditionally there have been two versions of communism/socialism: one Marxist and one Vatican. Pope Francis and black pope Arturo Sosa have in their own way that the Vatican should dominate. Marx would not have agreed with the Vatican's view. According to its grants database, Ford gave the African Field Epidemiology Network (AFEN) \$1 million for "sexual and reproductive health and rights" and \$800,000 to AIDS United, which campaigns for "reproductive justice." AFEN contends that "mandatory

pre-abortion counseling is a barrier to accessing safe abortion services" and campaigns to end this practice in Africa.

In 2019, Estée Lauder's Make-up Art Cosmetics, pledged \$500,000 to Planned Parenthood over two years to help expand its chat program providing abortion information. The cosmetic company also agreed to donate to the abortion giant 100% of proceeds from its VIVA GLAM lipsticks.

In 2016, the Center of the American Experiment think tank reported that the *"Black Lives Matter movement will receive millions of dollars in funding from the Ford Foundation."*

The CICV pledges "peace and justice" as a "key priority" area, campaigning primarily for "LGBTQ+ rights," BLM activism, climate change and open-door immigration policies.

"For more than 25 years, Johnson & Johnson has been a leader in supporting the LGBTQ+ community through its employee policies, business practices and public advocacy," as "the company aims to be a strong ally during Pride Month — and beyond," its website states.

The glaring concern is that this partnership ends up as a public relations bonanza for the executives involved.

In 2019, a MasterCard campaign added 10 new street signs below Christopher Street and Gay Street in New York City. The new signboards read: Lesbian, Bisexual, Transsexual, Queer, Intersex, Asexual, Non-Binary, Pansexual, Two Spirit, +, and #Acceptance streets. –(picture on page 7).

Later at a panel discussion with the New York City Human Rights Commission, MasterCard unveiled the True Name card which allows gay and transgender or non-binary individuals to obtain a debit, credit or prepaid card with their preferred name on it.

The familiar names associated with the new "Sustainable Capitalism" or "Sustainable Development", whatever you choose to call this is simply literary and rhetorical spin for communism! "Sustainable Development" is the destiny for the world, and it eliminates private property, something that was endemic with the U.S. Constitution.

The global luxury group, Kering, declares its commitment to "promote LGBTQIA+ diversity and inclusivity within the group," and says it is "extremely proud to celebrate and support Pride Month."

Salesforce, an American cloud-based software company headquartered in San Francisco, supports BLM and promotes the "new left-wing original sin" of unconscious bias.

Elites always benefit most from 'Inclusion'. In his academic study *"From Tolerance to Equality: How Elites Brought America to Same-Sex Marriage,"* Darel Paul describes "corporate America" as "normalization's most powerful ally" in the gay agenda.

"The country's largest firms began to normalize LGBT families by extending employment benefits to same-sex partners," writes Professor Paul. *"Perhaps the most far-reaching corporate contribution to normalization is an increasing use of LGBT-themed advertising to mainstream audiences."*

"Homosexuality has become so normal among Fortune 500 firms that they even market products generally associated with children with gay-inclusive ads," Paul observes.

"And alas, why would Francis choose such people when there are millions of faithful Catholic businesspeople who support responsible 'capitalism' and are loyal to the Church's social-moral teachings?" asks Kengor,

Alongside Pope Francis, Cardinal Peter Turkson, head of the Dicastery for Promoting Integral Human Development, has been appointed to offer "moral guidance" to the council.

Cardinal Turkson, who has previously condemned using the term "reproductive rights" for abortion and rejects gender ideology and homosexuality as human rights issues, has not denounced the abortion and pansexual agenda of the "guardians of Inclusive Capitalism." Perhaps this can be chalked off to his hope to become the first Black pope. Turkson was born in Ghana and has yet to explain how he accumulated his personal wealth reported to be at least a million dollars+. Cardinal Turkson was on the short list of candidates when the Jesuit Gorgio Bergoglio was selected/elected pope by the Black Nobility in 2013.

Since 2000, Ms. Forester de Rothschild has been a busy lady, a member of the Board of Directors and Nominating & Governance Committee of The Estee Lauder Companies. She has also served on the Boards of The Economist Group, Gulfstream, General Instruments, Bronfman-Rothschild and Weather Central. Ms. Forester de Rothschild serves, or has served, on the Board and Executive Committee of the Peterson Institute for International Economics, the McCain Institute for International Leadership, the ERANDA Rothschild Foundation (de Rothschild family foundation), and she is a member of the Council on Foreign Relations and Chatham House. In addition, she served as a member of the National Information Infrastructure Advisory Committee and the Secretary of Energy Advisory Board under President Clinton, and as a member of the United Nations Advisory Committee on Inclusive Financial Services. Ms. Forester de Rothschild is also Chairperson of E.L. Rothschild LLC, a family office. Ms. Forester de Rothschild graduated Magna cum Laude and Phi Beta Kappa from Pomona College in Claremont, CA and from Columbia University School of Law, NYC with a Juris Doctor with honors (Harlen Fiske Stone Scholar).
