WASHINGTON (AP) — In his most forceful pandemic actions and words, President Joe Biden on Thursday ordered sweeping new federal vaccine requirements for as many as 100 million Americans in an all-out effort to increase COVID-19 vaccinations and curb the surging delta variant.

Speaking at the White House, Biden sharply criticized the tens of millions of Americans who are not yet vaccinated, despite months of availability and incentives.

*“We’ve been patient. But our patience is wearing thin, and your refusal has cost all of us,”* he said, all but biting off his words. The unvaccinated minority *“can cause a lot of damage, and they are.”*

Republican leaders — and some union chiefs, too — said Biden was going too far in trying to muscle private companies and workers, a certain sign of legal challenges to come.

Gov. Henry McMaster of South Carolina said in a statement that *“Biden and the radical Democrats (have) thumbed their noses at the Constitution,”* while American Federation of Government Employees National President Everett Kelley insisted that *“changes like this should be negotiated with our bargaining units where appropriate.”*

On the other hand, there were strong words of praise for Biden’s efforts to get the nation vaccinated from the American Medical Association, the National Association of

Manufacturers and the Business Roundtable — though no direct mention of his mandate for private companies.

The expansive rules mandate that all employers with more than 100 workers require them to be vaccinated or test for the virus weekly, affecting about 80 million Americans. And the roughly 17 million workers at health facilities that receive federal Medicare or Medicaid also will have to be fully vaccinated.

Biden is also requiring vaccination for employees of the executive branch and contractors who do business with the federal government — with no option to test out. That covers several million more workers.

Biden announced the new requirements in a Thursday afternoon address from the White House as part of a new *“action plan”* to address the latest rise in coronavirus cases and the stagnating pace of COVID-19 shots.

Just two months ago Biden prematurely declared the nation’s “independence” from the virus. Now, despite more than 208 million Americans having at least one dose of the vaccines, the U.S. is seeing about 300% more new COVID-19 infections a day, about two-and-a-half times more hospitalizations, and nearly twice the number of deaths compared to the same time last year. Some 80 million people remain unvaccinated.

*“We are in the tough stretch and it could last for a while,”* Biden said.

After months of using promotions to drive the vaccination rate, Biden is taking a much firmer hand, as he blames people who have not yet received shots for the sharp rise in cases killing more than 1,000 people per day and imperiling a fragile economic rebound. In addition to the vaccination requirements, Biden moved to double federal fines for airline passengers who refuse to wear masks on flights or to maintain face covering requirements on federal property in accordance with Centers for Disease Control and Prevention guidelines.

He announced that the government will work to increase the supply of virus tests, and that the White House has secured concessions from retailers including Walmart, Amazon, and Kroger to sell at-home testing kits at cost beginning this week.

The administration is also sending additional federal support to assist schools in safely operating, including additional funding for testing. And Biden called for large entertainment venues and arenas to require vaccinations or proof of a negative test for entry.

The requirement for large companies to mandate vaccinations or weekly testing for employees will be enacted through a forthcoming rule from the Occupational Safety and Health Administration that carries penalties of \$14,000 per violation, an administration official said.

The rule will require that large companies provide paid time off for vaccination.

Meanwhile, the Centers for Medicare & Medicaid Services will extend a vaccination requirement issued earlier this summer — for nursing home staff — to other healthcare settings including hospitals, home-health agencies and dialysis centers.

Separately, the Department of Health and Human Services will require vaccinations in Head Start Programs, as well as schools run by the Department of Defense and Bureau of Indian Education, affecting about 300,000 employees.

Biden's order for executive branch workers and contractors includes exceptions for workers seeking religious or medical exemptions from vaccination, according to press secretary Jen Psaki. Federal workers who don't comply will be referred to their agencies' human resources departments for counseling and discipline, to include potential termination.

An AP-NORC poll conducted in August found 55% of Americans in favor of requiring government workers to be fully vaccinated compared with 21% opposed. Similar majorities also backed vaccine mandates for health care workers, teachers working at K-12 schools and workers who interact with the public, as at restaurants and stores.

Biden has encouraged COVID-19 vaccine requirements in settings like schools, workplaces and university campuses. On Thursday, the Los Angeles Board of Education voted to require all students 12 and older to be fully vaccinated in the nation's second-largest school district.

Walmart, the nation's largest private employer, said in late July it was requiring that all workers at its headquarters in Bentonville, Arkansas, as well as its managers who travel within the U.S. be vaccinated against COVID-19 by Oct. 4. But the company had stopped short of requiring shots for its frontline workers.

CVS Health said in late August it would require certain employees who interact with patients to be fully vaccinated by the end of October. That includes nurses, care managers and pharmacists.

In the government, several federal agencies have previously announced vaccine requirements for much of their staffs, particularly those in healthcare roles like the Department of Veterans Affairs, and the Pentagon moved last month to require all service-members to get vaccinated. Combined, the White House estimates those requirements cover 2.5 million Americans. Thursday's order is expected to impact nearly 2 million more federal workers and potentially millions of contractors.

Biden's measures should help, but what's really needed is a change in mindset for many people, said Dr. Joshua Sharfstein, vice dean at the Johns Hopkins Bloomberg School of Public Health in Baltimore.

*“There is an aspect to this now that has to do with our country being so divided,” said Sharfstein. “This has become so politicized that people can’t see the value of a vaccination that can save their lives. Our own divisions are preventing us from ending a pandemic.”*

More than 177 million Americans are fully vaccinated against the coronavirus, but confirmed cases have shot up in recent weeks to an average of about 140,000 per day with on average about 1,000 deaths, according to data from the Centers for Disease Control and Prevention.

Most of the spread — and the vast majority of severe illness and death — are occurring among those not yet fully vaccinated. So-called breakthrough infections in vaccinated people occur, but tend to be far less dangerous.

Federal officials are moving ahead with plans to begin administering booster shots of the mRNA vaccines to bolster protection against the more transmissible delta variant. Last month Biden announced plans to make them available beginning on Sept. 20, but only the Pfizer vaccine will likely have received regulatory approval for a third dose by that time.

Officials are aiming to administer the booster shots about eight months after the second dose of the two-dose vaccines.

The response that is usually chorused back is this: "*Why, a lot of people have died for a lie; so what does it prove?*"

Yes, a lot of people have died for a lie, but they thought it was the truth. Now if the resurrection didn't take place (i.e., was false), the disciples knew it. *“Let me be blunt,”* Biden said. *“My plan also takes on elected officials in states that are undermining you in these life-saving actions. Right now local school officials are trying to keep children safe in a pandemic while their governor picks a fight with them and even threatens their salaries or their jobs. Talk about bullying the schools.”*

*“If they’ll not help, if these governors won’t help us beat the pandemic, I will use my power as president to get them out of the way,”* he added. *“The Department of Education has already begun to take legal action against states undermining protection that local school officials have ordered.”*

Republican governors have begun to issue their responses to the federal government’s overreach and the president’s threats. Florida Governor Ron DeSantis actually issued a statement in opposition to Biden’s executive order before it was officially issued.

*“How could we get to the point in this country where you would not let them earn a living because of their choice on the vaccine?”* Gov. DeSantis said. *“I just think that’s fundamentally wrong. I do not believe that people should lose their jobs over this issue, and we will fight that.”*

The Biden administration has said repeatedly that it would not issue federal vaccine mandates.

In December, then President-Elect Biden made the pronouncement that he wouldn’t make vaccines mandatory. Watch:

*“I don’t think it should be mandatory. I wouldn’t demand it to be mandatory,” Biden said at a news conference in Wilmington, Del. “Just like I don’t think masks have to be made mandatory nationwide.”*

*“I’ll do everything in my power as president of the United States to encourage people to do the right thing and when they do it, demonstrate that it matters,” he said.*

On July 25, White House Press Secretary Jen Psaki also said a vaccine mandate was *“not the federal government’s role.”* In May, Psaki effectively said the same thing, as well.

*“President Joe Biden’s administration had no plans to impose a federal vaccination mandate or database, White House press secretary Jen Psaki confirmed at a Friday press briefing,” the Daily Caller reported.*

However, on Thursday is going to break his administration’s promises to the American people and issue the most sweeping set of federal vaccine mandates in U.S. history, affecting thousands of employers and tens of millions of Americans.

*“Biden to mandate all employers (100 workers or more) require COVID-19 vaccinations or weekly virus tests, affecting as many as 100 million Americans,”* PBS reported.

*Businesses that don’t abide by the new virus policy will face “substantial fines up to nearly \$14,000 per violation,”* a senior Biden admin official said.

*“In addition, Biden will require health care workers at Medicare & Medicaid participating hospitals and other health care settings to be vaccinated, impacting more than 17 million workers,”* PBS added.

On Thursday, it nonetheless issued one of the most sweeping overreaches of executive power in generations. Let the lawsuits begin.

The president admits that he cannot outright force everybody to get a vaccination. He also can’t force businesses to make their employees get a vaccination. But he believes he has the authority to impose regulations on businesses through the Labor Department, which controls the Occupational Health and Safety Administration. This amounts to 2/3rds of all American workers.

Biden is asking OSHA to mandate vaccinations or weekly testing [for workplaces that have 100 or more workers](#). Under OSHA, such an order would come down as a safety regulation.

It is not OSHA’s first experience with COVID-era regulations. This summer, OSHA handed down new regulations for health care workplaces that required them to provide protective equipment, ventilation and the ability to socially distance from other workers. OSHA also required health care providers to give paid time off to workers to get vaccinated and additional time off if they suffer side effects. OSHA did a 180-degree turn on their own regulations.

OSHA will work under a rule called an “emergency temporary standard.” If businesses don’t comply, the government will “take enforcement actions,” which could include “substantial fines up to nearly \$14,000 per violation,” according to officials.

By the way, [employment websites are starting to see employers](#) who do not require COVID-19 tests emphasizing that fact in their “help wanted” ads. [Insider reports](#), “*One site listed multiple openings for nurses at rural nursing homes that said: ‘No Job required.’*”

Big companies with thousands of employees may become impatient with workers who have to be tested every week. It could get expensive for companies to pay for all of that testing, and some companies have already said they will charge the cost of testing to their employees.

Pima County (Tucson), Arizona, tried offering a \$300 bonus and three days off as a carrot to entice employees to get vaccinated. Now it will try a stick, too. County employees who turn down vaccinations will pay up to \$1,570 a year more in health insurance.

Under Biden's new order, all federal employees must be vaccinated. The option to remain unvaccinated and instead get regularly tested is off the table. White House press secretary Jen Psaki said there will probably be a 75-day grace period, which would mean enforcement would not happen until sometime in November.

On the same day as the president's new order, the nation's second-largest school district, Los Angeles Unified public schools, voted to require all eligible students to be vaccinated. CNN reports:

The proposal approved Thursday requires all eligible students 12 years of age and older to receive their first Covid-19 vaccine doses by no later than November 21, and to be fully vaccinated by December 19. Students who participate in in-person extracurricular activities, including sports, face an earlier deadline of October 3 for a first dose of the vaccine and a second dose no later than October 31.

The district, which includes more than 600,000 students, already mandates the vaccine for teachers and staff, requires face coverings be worn by all, and tests all students and staff for infections weekly.

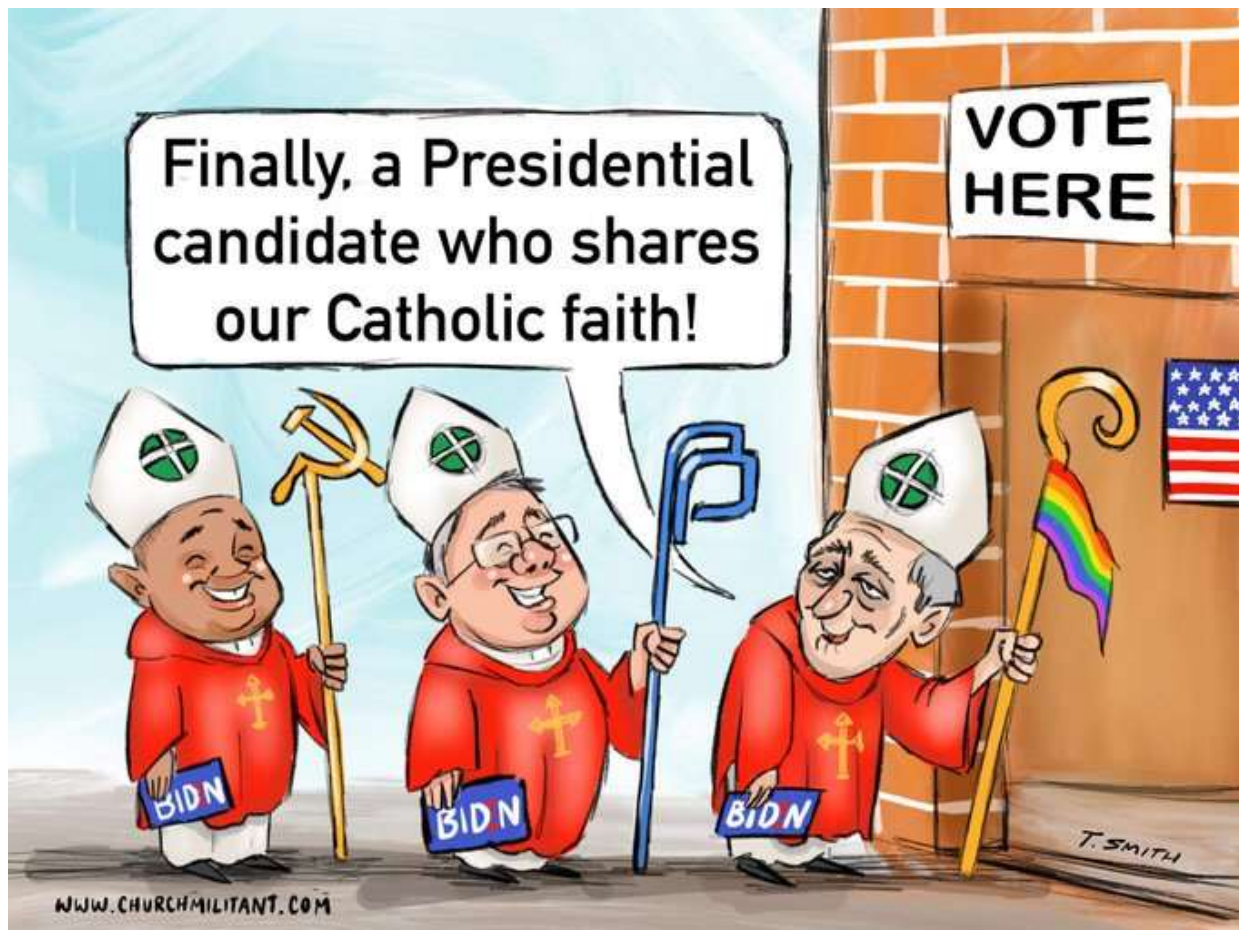
Biden leaned on governors to require teachers and students nationwide to be vaccinated. He added the 300,000 educators in federal Head Start programs to the mandatory vaccination list, since they are paid with federal funds.

The president said he will also make COVID-19 testing more plentiful. He is using the Defense Production Act to speed up the production of 25 million rapid tests that the federal government will send to clinics. Big retailers including Walmart and Amazon have pledged to sell at-home test kits with no markup. Incidentally, Ohio makes test kits free and available at 246 public libraries. 160,000 of the tests have been handed out so far and they come with free telehealth connections so that people use them correctly.

Biden's plan also includes a booster shot campaign, starting the week of Sept. 20 — if the Food and Drug Administration approves the idea. As best I can envision with a dozen Republican governors seeking court redress, it will ultimately end up at the Supreme Court for final adjudication. Since the Supreme Court is dominated by Jesuit-trained or Jesuit Justices, I am not optimistic and this will go badly for the American workers.

Seven of the nine Supreme Court justices are Catholic: Justices Clarence Thomas, Samuel Alito, Sonia Sotomayor, Neil Gorsuch, Brett Kavanaugh and Amy Coney Barrett along with Chief Justice John Roberts are Catholic. There are no Protestant Supreme

Court justices. The fact that the most recent appointees to the Court were Neil Gorsuch, Brett Kavanaugh, and Amy Coney Barrett were nominated and appointed by President Donald J. Trump is suspect given Donald J. Trump's close ties between several Mafia families of the Black Nobility. Trump himself attended his first two years at Jesuit Fordham University. There is more to this subject than most are aware of. 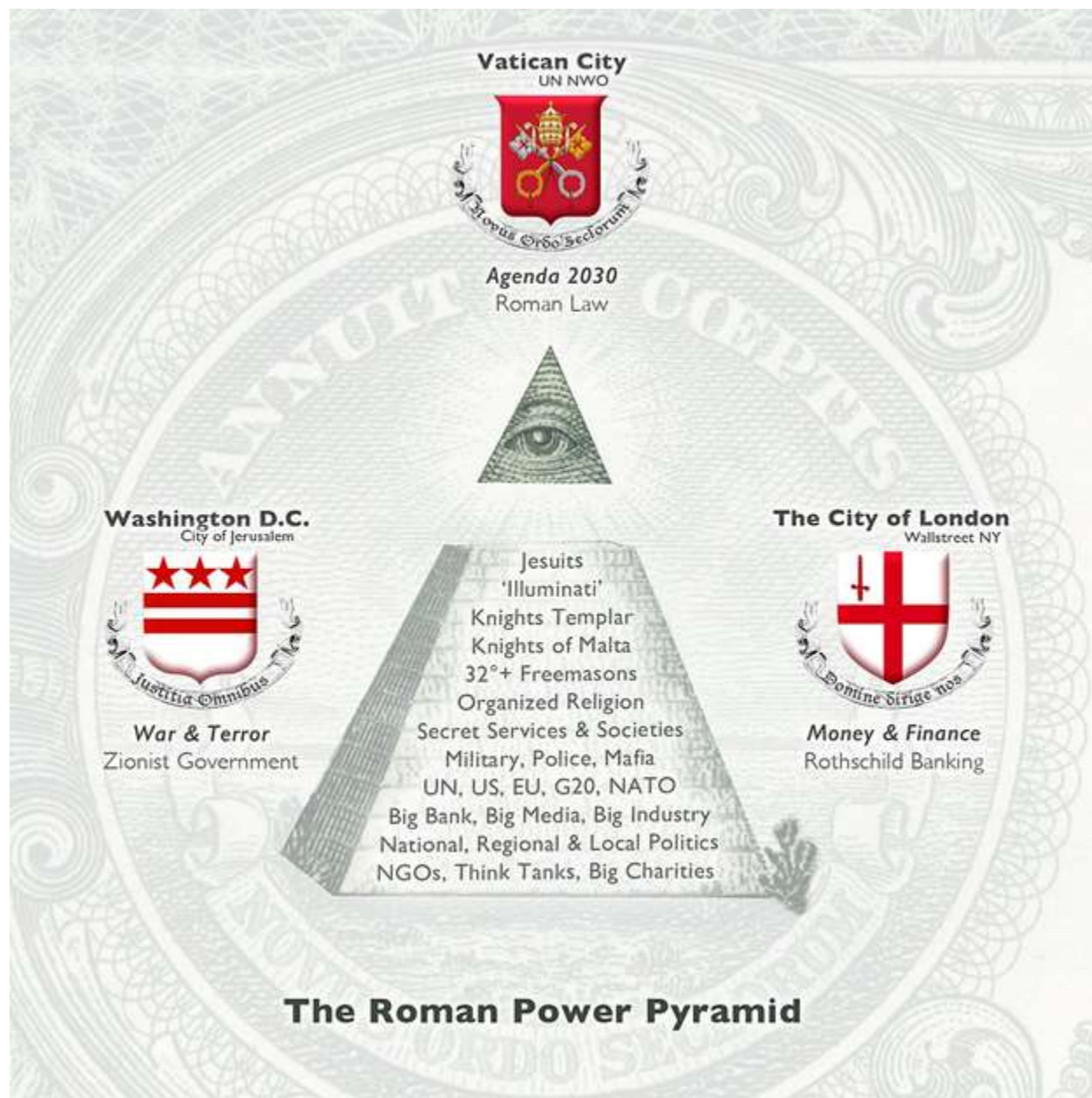

I am not an attorney, but I can read "Black's" Law Dictionary and I know the U.S. Constitution as well as the Bill of Rights. 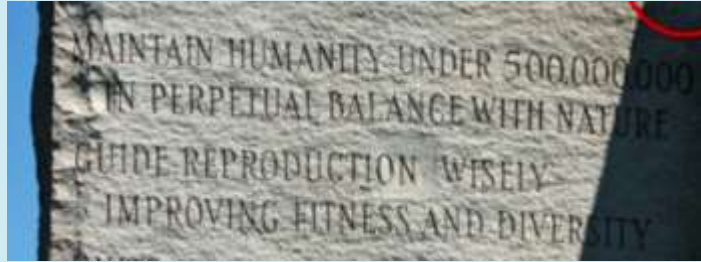

They'll do what they can to buy more time to get as many vaccinated as quickly as they can, while they can.

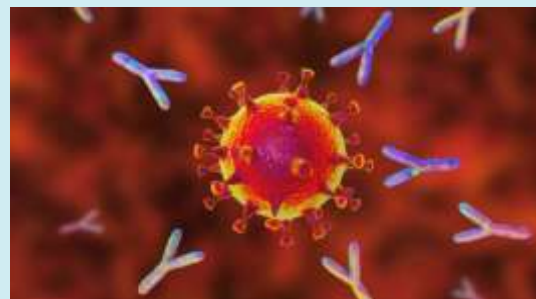
