The Leading Reasons for an Imminent Rapture

The past three week I have been receiving questions asking if I am a “prepper” or do I have a plan for what is coming? If they mean, “do I have food buckets” or “survival” foods or MREs, things like that, my answer is no! I do distill my own water and I keep on hand a couple dozen cranberry juice containers of distilled water, and I do that since I live ten miles out of town. We get our water from a lake west of town and the local water system is not the best for drinking out of the tap.

America is breaking down. Its response to Covid was tepid at best and it took 22 months to rebel, whereas the people of France and Belgium were actively pushing back over a year ago. As John Whitehead said today,

“This breakdown - triggered by polarizing circus politics, media-fed mass hysteria, racism, classism, fascism, fear-mongering, political correctness, cultural sanitation, virtue signaling, a sense of hopelessness and powerlessness in the face of growing government corruption and brutality, a growing economic divide that has much of the population struggling to get by, and militarization and militainment (the selling of war and violence as entertainment) - is manifesting itself in madness, mayhem and an utter disregard for the very principles and liberties that have kept us out of the clutches of totalitarianism for so long.”

In Washington, DC, a tribunal of nine men and women spoke with one voice to affirm that the government and its henchmen can literally get away with murder and not be held accountable for their wrongdoing. The Supreme Court’s latest rulings are yet another painful lesson in compliance, a reminder that in the American police state, “we the people” are at the mercy of law enforcement officers who have almost absolute discretion to decide who is a threat, what constitutes resistance, and how harshly they can deal with the citizens they were appointed to ‘serve and protect.

All across the country, from California to Connecticut and every point in between, men and women who have worked faithfully and diligently at their jobs for years are being

terminated for daring to believe that they have a right to bodily integrity; that they should not be forced, against their conscience or better judgment, to choose between individual liberty and economic survival; and that they - and not the government, or the FDA, or the CDC, or the Corporate State - have dominion over their bodies. Conveniently enough, this COVID-19 pandemic has created yet another double standard in how “we the people” navigate this country: while “we the middling classes” are subjected to vaccine mandates and denied even the right to be skeptical about the origins of the COVID virus, let alone the efficacy of the so-called cure, the government, corporations and pharmaceutical companies have been shielded from liability with blanket immunity laws that ensure we are little more than guinea pigs for their questionable experiments.

And then in Pennsylvania, a man traveling on a commuter train harassed, assaulted and then raped a woman over the course of 40 minutes and more than two dozen train stops while fellow travelers, watching and filming the attack, did nothing. Not a single witness called 911. Not a single bystander intervened to help the woman. Despite the fact that the man was outnumbered and could have been overwhelmed by those on the train, no collective effort was made to ward off the attack. Only when it was too late, when the damage had been done and the train had pulled into its last stop, did police show up to intervene.

There is an allegory here for what is happening to our country and its citizens, who have also been waylaid by a madman (the Deep State), stripped of their safety nets (their rights undermined and eroded), and savaged out in the open by a fiend (the American Police State and its many operatives - the courts, the legislatures and their various armies) that is devoid of humanity while those not in the immediate crosshairs watch safely from a distance without making a move to help.

This is madness, yet there is a method to this madness.

This is how freedom falls and tyranny rises.

Remember, authoritarian regimes begin with incremental steps: over-criminalization, surveillance of innocent citizens, imprisonment for nonviolent—victimless—crimes, etc. Bit by bit, the citizenry finds its freedoms being curtailed and undermined for the sake of national security. And slowly the populace begins to submit.

No one speaks up for those being targeted.

No one resists these minor acts of oppression.

No one recognizes the indoctrination into tyranny for what it is.

Historically this failure to speak truth to power has resulted in whole populations being conditioned to tolerate unspoken cruelty toward their fellow human beings, a bystander syndrome in which people remain silent and disengaged—mere onlookers—in the face of abject horrors and injustice.

Time has insulated us from the violence perpetrated by past regimes in their pursuit of power: the crucifixion and slaughter of innocents by the Romans, the torture of the Inquisition, the atrocities of the Nazis, the butchery of the Fascists, the bloodshed by the Communists, and the cold-blooded war machines run by the military industrial complex.

We can disassociate from such violence. We can convince ourselves that we are somehow different from the victims of government abuse. We can continue to spout empty political rhetoric about how great America is, despite the evidence to the contrary.

We can avoid responsibility for holding the government accountable.

We can zip our lips and bind our hands and shut our eyes.

In other words, we can continue to exist in a state of denial. Yet there is no denying the ugly, hard truths that become more evident with every passing day.

1. The government is not our friend. Nor does it work for “we the people.”

2. Our so-called government representatives do not actually represent us, the citizenry. We are now ruled by an oligarchic elite of governmental and corporate interests whose main interest is in perpetuating power and control.

3. Republicans and Democrats like to act as if there’s a huge difference between them and their policies. However, they are not sworn enemies so much as they are partners in crime, united in a common goal, which is to maintain the status quo.

4. The lesser of two evils is still evil.

5. Some years ago, a newspaper headline asked the question: “What’s the difference between a politician and a psychopath?” The answer, then and now, remains the same: None. There is virtually no difference between psychopaths and politicians.

6. More than terrorism, more than domestic extremism, more than gun violence and organized crime, the U.S. government has become a greater menace to the life, liberty and property of its citizens than any of the so-called dangers from which the government claims to protect us.

7. The government knows exactly which buttons to push in order to manipulate the populace and gain the public’s cooperation and compliance.

8. If voting made any difference, they wouldn’t let us do it.

9. America’s shadow government—which is comprised of unelected government bureaucrats, corporations, contractors, paper-pushers, and button-pushers who are actually calling the shots behind the scenes right now and operate beyond the reach of

the Constitution with no real accountability to the citizenry—is the real reason why “we the people” have no control over our government.

10. You no longer have to be poor, black or guilty to be treated like a criminal in America. All that is required is that you belong to the suspect class—that is, the citizenry—of the American police state. As a de facto member of this so-called criminal class, every U.S. citizen is now guilty until proven innocent.

11. “We the people” are no longer shielded by the rule of law. By gradually whittling away at our freedoms—free speech, assembly, due process, privacy, etc.—the government has, in effect, liberated itself from its contractual agreement to respect our constitutional rights while resetting the calendar back to a time when we had no Bill of Rights to protect us from the long arm of the government.

12. Private property means nothing if the government can take your home, car or money under the flimsiest of pretexts, whether it is asset forfeiture schemes, eminent domain or overdue property taxes. Likewise, private property means little at a time when SWAT teams and other government agents can invade your home, break down your doors, kill your dog, wound or kill you, damage your furnishings and terrorize your family.

13. We now find ourselves caught in the crosshairs of a showdown between the rights of the individual and the so-called “emergency” state, and “we the people” are losing.

14. All of those freedoms we cherish—the ones enshrined in the Constitution, the ones that affirm our right to free speech and assembly, due process, privacy, bodily integrity, the right to not have police seize our property without a warrant, or search and detain us without probable cause—amount to nothing when the government and its agents are allowed to disregard those prohibitions on government overreach at will.

15. If there is an absolute maxim by which the federal government seems to operate, it is that the American taxpayer always gets ripped off.

16. Our freedoms—especially the Fourth Amendment—continue to be choked out by a prevailing view among government bureaucrats that they have the right to search, seize, strip, scan, spy on, probe, pat down, taser, and arrest any individual at any time and for the slightest provocation.

17. Forced vaccinations, forced cavity searches, forced colonoscopies, forced blood draws, forced breath-alcohol tests, forced DNA extractions, forced eye scans, forced inclusion in biometric databases: these are just a few ways in which Americans continue to be reminded that we have no control over what happens to our bodies during an encounter with government officials.

18. Finally, freedom is never free. There is always a price—always a sacrifice—that must be made in order to safeguard one’s freedoms.

We cannot remain silent in the face of the government's ongoing overreaches, power grabs, and crimes against humanity.

Evil disguised as bureaucracy is still evil. Indeed, this is what Hannah Arendt referred to as the banality of evil.

As I make clear in my book 'Battlefield America: The War on the American People and in its fictional counterpart' The Erik Blair Diaries, such evil happens when bureaucrats (governmental and corporate) unquestioningly carry out orders that are immoral and inhumane; obey immoral instructions unthinkingly; march in lockstep with tyrants; mindlessly perpetuate acts of terror and inhumanity; and justify it all as just "doing one's job."

Such evil prevails when good men and women do nothing.

By doing nothing, by remaining silent, by being bystanders to injustice, hate and wrongdoing, good people become as guilty as the perpetrator.

There's a term for this phenomenon where people stand by, watch and do nothing—even when there is no risk to their safety—while some horrific act takes place (someone is mugged or raped or bullied or left to die): it's called the bystander effect.

It works the same whether you're talking about kids watching bullies torment a fellow student on a playground, bystanders watching someone dying on a sidewalk, passengers on a train filming a fellow traveler be raped without intervening to help, or citizens remaining silent in the face of government atrocities.

We need to stop being silent bystanders.

It's time to stand up for truth—for justice—for freedom—not just for ourselves but for all humanity. Tomorrow may be too late."

Unethical and potentially illegal fetal organ harvesting is occurring at the University of Pittsburgh and its medical center, a panel of pro-life activists said last week.

The panel was organized by the Pennsylvania Family Council and held at the First Trinity Evangelical-Lutheran Church in downtown Pittsburgh.

The University of Pittsburgh, a self-styled fetal tissue "hub," made headlines recently for experiments which grafted fetal scalps onto the backs of lab rats with funding from Dr. Anthony Fauci's National Institute of Allergy and Infectious Diseases.

Panelist David Daleiden, founder of the Center for Medical Progress, argued that the fetal experiments and organ harvesting at the University of Pittsburgh might be conducted on live fetuses.

Daleiden's Center for Medical Progress obtained a grant application to the National Institute for Health (NIH) in which Pitt asked for federal tax dollars to fund its experiments on aborted babies.

In its grant application, Pitt promised that it would minimize *"ischemia time ... to ensure the highest quality biological specimens"* in its fetal experimentation. Daleiden explained that ischemia is typically defined as the lack of blood circulation to the organs. If the fetus has died and the heart has stopped pumping blood, then ischemia has begun.

He said that Pitt could thus be indicating that the blood is still pumping and the fetus is alive as its scientists harvest the organs. Dr. Ronna Jurow, an OB-GYN who previously worked at Planned Parenthood, agreed with Daleiden's assessment and told Fox News that *"there's no question"* the fetus would be alive during the organ harvesting. The University of Pittsburgh has strongly denied this claim.

Daleiden argued that the University of Pittsburgh also uses racial quotas in these experiments.

In its grant application, Pitt specified that its fetal experiments should use 50 percent minority fetuses, including 25 percent black fetuses. Allegheny County, the county where Pitt is located, is around 80 percent white and 13 percent black.

Former Pennsylvania Superior Court Judge Cheryl Allen argued that these numbers aren't coincidental. True to the mission of Planned Parenthood founder Margaret Sanger, abortion providers routinely target the black community, insisted Allen. She announced that a jaw-dropping 40 percent of all black babies in the state of Pennsylvania are aborted.

"How could Pitt justify working with such an organization?" asked Allen. Planned Parenthood *"owes their very existence to racism,"* lamented the exasperated judge.

Allen read aloud the Pitt Office of Equity, Diversity and Inclusion's "Antiracism Statement" which promises to end *"racial and ethnic discrimination."*

Allen, the first African American woman elected to the Pennsylvania Superior Court, said Pitt was hypocritical for promising to address "anti-Blackness" but at the same time disproportionately experimenting on black fetuses.

Panelist Cecily Routman, president of the Jewish Pro-Life Foundation, argued that the experiments on babies occurring at Pitt are similar to medical experiments conducted on Jews in Nazi Germany. She recalled that Jews would be awake while Nazi doctors at Auschwitz experimented on them and extracted their organs — without anesthesia.

Routman pointed out that the country who 75 years prior defeated the Nazis is conducting similar experiments on defenseless babies.

Routman said, “*never again*’ becomes ‘*once again*.’”

Daleiden said that these experiments are conducted under the advisement of Planned Parenthood employees. He said that a medical director of Planned Parenthood of Western Pennsylvania, Dr. Beatrice Chen, is an employee of both the university and the university’s medical center.

Chen is listed as a vice chair of the Institutional Review Board at the university, acting as an ombudsman overseeing Pitt’s fetal studies. Chen is a director of family planning at University of Pittsburgh Medical Center Magee-Women’s Hospital.

Daleiden claimed that Planned Parenthood, along with the University of Pittsburgh Medical Center, where some of Pitt’s own professors work, supplies aborted fetuses to Pitt’s fetal tissue bank. He said he received this information from Planned Parenthood Western Pennsylvania employees while filming undercover.

Pitt denies that any such “*procurement relationship*” exists between the university and Planned Parenthood.

Daleiden argued that federal law prohibits collaboration between the researchers and the institution that performs the abortions. Pitt may also be in violation of NIH, NIAID, and Department of Health and Human Services statutes that prohibit experimentation on live fetuses, he said.

The NIH and the NIAID have together awarded Pitt close to \$2 million to fund projects that included grafting fetal scalps onto rats. In addition, HHS funded Pitt’s GenitoUrinary Development Molecular Anatomy Project (GUDMAP), where university researchers operated from a tissue bank with organs of aborted fetuses to the tune of at least \$2.7 million dollars.

Pitt received the eighth highest amount of federal funding from the NIH out of every other American university, medical school research institution, and teaching hospital in fiscal year 2020. The NIH doled out \$507 million to the university.

Pitt denied that it has broken any state or federal law, but it has hired a law firm to investigate its own practices.

In response to the reports on Pitt’s experiments, nearly 100 senators and House members sent a letter to the NIH, HHS, and Department of Justice demanding the release of primary documents detailing methods used to procure fetal tissue for Pitt’s experimentation projects.

The letter demanded to know whether Pitt was breaking federal law by harvesting organs from “*babies who were old enough to live outside the womb.*” The letter also called into question whether Pitt broke fetal tissue trafficking and partial birth abortion laws.

The purpose of this Blessed Hope is directed to those who will be left behind, or might realize they are on very thin ice as we close in on the Rapture of Bible-believing Christians. A UN Climate Change Conference will run from October 31st through November 12th, 2021. My intuition tells me this will be a culminating event of the major names: Prince Charles, Klaus Schwab, and Pope Francis!

President Vladimir V. Putin of Russia will not attend a UN climate summit later this month that is seen as pivotal to reducing emissions of planet-warming gasses, but he may deliver a speech by video link, the Kremlin said on Wednesday.

Mr. Putin’s spokesman, Dmitri S. Peskov, did not explain the decision on the summit in Glasgow but emphasized that climate change remained high on Russia’s agenda. *“The issues that will be discussed in Glasgow right now form one of the priorities of our foreign policy,”* Mr. Peskov said. A Russian delegation is still expected to head to Scotland for the conference.

Mr. Putin, speaking at an energy conference in Moscow last week, had said he was reluctant to attend because of the risk of spreading coronavirus. He said his entourage would include about a hundred people and the travel would pose risks. Mr. Putin, who has been vaccinated, had to isolate in September after exposure to the virus.

Russia is the world’s fourth-largest emitter of greenhouse gases but has been seen as dragging its feet on policies to curb pollution. It is also a major exporter of oil, coal and natural gas, the fossil fuels that are the main culprits in climate change. Mr. Putin has suggested that some policies intended to slow climate change are in fact aimed at harming Russia’s energy exports.

The country has participated in past efforts to control emissions, most recently with a pledge in 2015 to cap climate-warming pollution at levels below those it emitted in 1990. But because of the industrial collapse that followed the end of the Soviet Union, Russia was already emitting less in 2015 than it had in 1990. The commitment did little to help lower global greenhouse gas pollution.

Last week, Mr. Putin announced a new plan for Russia to become carbon-neutral by 2060. The plan suggests that Russia should be given more credit for carbon absorbed

by the country's vast forests in Siberia and that this absorption can be increased through new forest management practices, such as fighting wildfires more aggressively.

Chinese officials have not confirmed whether Xi Jinping, China's top leader, will attend the event. But if he did appear, it would likely be remotely; Mr. Xi has not publicly left the country since Covid-19 spread from the Chinese city of Wuhan in January 2020.

Xie Zhenhua, China's top climate negotiator, told *'Reuters'* on Tuesday that global climate officials would have to wait for confirmation from China's Ministry of Foreign Affairs, *"and only after they make an announcement will we tell you."*

The Chinese government has otherwise publicly supported the COP26 effort and promoted some of its own climate goals, including plans to curb emissions and to stop building new coal-fueled projects abroad. In September, Han Zheng, a Chinese vice premier, held a virtual meeting with Alok Sharma, the British cabinet minister who is COP26's president-designate, and said the summit *"will send a strong political signal,"* according to an account on state media.

The heir to the British throne is warning that a UN Climate Change Conference in Glasgow could be our last chance to save the planet from climate change. In an interview released on October 11, Prince Charles emphasized that Australian Prime Minister Scott Morrison should attend next month's climate event despite Australia's Covid-19 travel ban, because *"if we don't really take the decisions that are vital now, it's going to be almost impossible to catch up."*

This is not the first time Prince Charles has warned we have had our last chance. In 2014, he said a Climate Change Conference in Paris was our *"last chance,"* and in 2009, he said a Climate Change Conference in Copenhagen was our *"last chance."* Yet global temperatures have only risen by about a degree since the Copenhagen conference, and an upcoming period of low solar activity will likely slow even this mild warming. Yet none of this will stop Prince Charles's ambitious plan to revolutionize the world economy.

Last August, Prince Charles wrote an editorial for the *'Daily Mail'* declaring that the climate change crisis can only be solved by businesses and governments working together. He wants businesses to sign a charter called the Terra Carta, which commits them to put *"sustainability"* at the heart of their activities. When this charter talks about *"sustainability,"* however, it means meeting the carbon reduction targets set by the Paris Climate Accords. Meeting these reduction targets would weaken the manufacturing sectors of the United States and Britain while empowering multinational corporations that manufacture goods in countries where environmental regulations are less stringent.

More than 400 companies have already signed the Terra Carta, and Prince Charles hopes to use the Glasgow summit to convince even more companies to do so. Along with Pope Francis and World Economic Forum founder Klaus Schwab, Prince Charles has launched a project called the "Great Reset" in the wake of the covid-19 pandemic.

Instead of free markets, this globalist project says the world should implement wealth taxes, government regulations and massive infrastructure spending programs in its quest to “Build Back Better” after the pandemic and halt climate change.

“The prince believes that as countries and businesses around the world look to rebuild after this crisis, there is a unique but narrow window of opportunity to accelerate the sustainability agenda in a way that puts people and planet first,” said a Sustainable Markets Initiative spokesman in an interview with the Telegraph. *“Before industries simply return to the old ways of doing things, this group, led by the prince and Professor Schwab, is setting out to show we have a chance to recover by doing things differently and with a lot less negative impact on the world we live in.”*

Comments like this one have caused the editors at Vanity Fair to ask: *“Is Prince Charles Using the Pandemic to Take on Capitalism?”* The answer to their question is a resounding “Yes.” Coronavirus lockdowns reduced carbon emissions by 2.8 billion tons in 2020. A Nature journal piece notes how these lockdowns mentally prepared people for the *“personal carbon allowances”* necessary to meet the carbon reduction targets set by the Paris Climate Accords.

Now the World Economic Forum is seeking guidance from the Catholic Church on how to use Catholic social doctrine to undermine free markets. This is alarming. Prince Charles is heir to the throne of the nation primarily responsible for spreading free markets around the world, yet he has chosen to team up with the pope and a German engineer to destroy those markets.

On Dec. 8, 2020, Pope Francis established what he calls the Council for Inclusive Capitalism with the Vatican. Led by the pope and Cardinal Peter Turkson, it includes numerous leaders from Fortune 500 companies with 200 million employees in 163 countries and \$2.1 trillion in market capitalization - more money than the gross domestic product of Italy. It is led by a core group of 27 leaders it calls the Guardians for Inclusive Capitalism, which include the chairmen and chief executives of Allianz, Bank of America, BP, Dupont, Johnson & Johnson, Mastercard, Merck and Visa.

Many have said this real-life organization seems like something out of a conspiracy theory forum, but its goals are aligned with Professor Schwab’s World Economic Forum and Prince Charles’s Sustainable Markets Initiative. They want to use something akin to Catholic social doctrine to establish a “third way” between capitalism and communism.

Like Pope Francis and Klaus Schwab, Prince Charles is espousing a philosophy sometimes called state capitalism but which used to be called corporatism. While pure socialism is direct government control of resources (and people), corporatism permits people to engage in private enterprise but manages them heavily through corporations. These corporations group people together according to their interests and social functions so they can regulate behavior.

Before the Second World War, fascist dictators like Francisco Franco of Spain, Benito Mussolini of Italy and Adolf Hitler of Germany ran openly corporatist economies with the blessing of the pope. And after World War II, Latin American Catholic dictators like Juan Perón of Argentina and Augusto Pinochet of Chile did the same thing. Now global elites want to use COVID-19 and the threat of climate change to restore this tyrannical system. In his book *'The Coming of Neo-Feudalism: A Warning to the Global Middle Class'*, Joel Kotkin, a fellow of urban studies at Chapman University, warns that the government's alliance with big business will result in the formation of a "*cognitively superior ruling class*" that will govern the world like a feudal aristocracy, treating people like serfs who are too stupid to be allowed opinions. But even he does not realize the extent to which corporate feudalism will make a comeback.

Following a remarkable epoch of greater dispersion of wealth and opportunity, we are inexorably returning towards a more feudal era marked by greater concentration of wealth and property, reduced upward mobility, demographic stagnation, and increased dogmatism. If the last seventy years saw a massive expansion of the middle class, not only in America but in much of the developed world, today that class is declining and a new, more hierarchical society is emerging. We have been witnessing the decline of the middle class of America since about the 1990's but seeds of it were evident as early as the days of President Reagan when he fired the Airline Traffic Controllers.

The new class structure resembles that of Medieval times. At the apex of the new order are two classes—a reborn clerical elite, the clerisy, which dominates the upper part of the professional ranks, universities, media and culture, and a new aristocracy led by tech oligarchs with unprecedented wealth and growing control of information. These two classes correspond to the old French First and Second Estates.

Revelation 17 reveals that a powerful religious entity will become a guiding force over a great economic powerhouse that intoxicates all nations with its wealth and splendor. Revelation 18:3 says that "***the merchants of the earth have become rich through the abundance of her luxury***". These verses are talking about the merger of state, corporate and religious power. We see this merger today, and the Prince of Wales is helping it happen. Nothing can change the fact that this creature is a male, but Richard has a serious mental disorder and we are all supposed to go along with it. It's probably going to be a hate crime soon just disrespecting Richard's pronouns and new name.

We are so far from a meritocracy it is not even funny. Levine is not in a position of authority because he is good at his job, despite being a transgender freak. He is a 4-star admiral because he is destroying public health and is afflicted with severe mental illness, and he wants to encourage the same in our children. If you want a good reason for the Rapture of Bible-believing Christians, here is a fine specimen of mental health gender confusion why we are in very deep bovine excrement!

Without further comment, I will list the leading reasons for why I see an imminent Rapture of Christian believers and below it, I will comment on each item and why it is significant:

- The FDA's 17-0 Vote to vaccinate 28-million children ages 5-12
 - Israel announced its plan to attack Iran's nuclear facilities
 - The U.S. State Department "green" lighted an Israeli attack on Iran
 - The actions of the above 2 points will likely result in the Ezekiel 38/39 War
 - China is on the verge of "financial" bankruptcy
 - China has been preparing an invasion and taking back the island nation of Taiwan
 - The U.S. is also on the verge of "financial" bankruptcy
 - The WEF is this weekend meeting at Davos, Switzerland to plan their next move in bringing on the New World Order "Great Reset"
 - The global "supply chain" is part of the WEF plan for undermining and destroying economic capitalism
 - The Deep State is undermining and destroying the Republic and transitioning the U.S. into a Chinese communist state
1. The FDA decision to authorize the poison Vaxxing of the young 5-12 – Before it is all over evil Dr. (death) Fauci will get it lowered to age 2. Fauci has been talking that children down to the age of 2 will have to be vaxxed for over a year. I see this action this week as the straw that breaks the camel's back with our Lord. The Bible is replete with passages that express God's love for little ones. He may have allowed adults "free will" to choose for themselves to be vaxxed, as a test of man's faith and trust; however, children are unable to make decisions of informed consent in this matter of their eternal destiny. Isaiah 49:15-16 compares His love for a childlike His love for Zion. Parents risk God's judgment should they decide to have their children given this harmful "gene" therapy. I have shared hundreds of pages of information on the danger of the Spike Protein that re-writes one's God-given DNA. military barracks in Syria. The U.S. forces were alerted to a surprise attack the day before and chose not to sleep in the barracks that night when the attack occurred. Exploded Iranian munitions were found in the barracks following the destruction. No American lives were lost. The surprise attack provided the reason for “green” lighting an Israeli attack on Iran.

4. The Ezekiel 38/39 War scenario does not explicitly state per se it is a pre-emptive war against Israel or if it is a retaliatory war resulting from an Israeli attack which then results in the Gog-Magog alliance coming against Israel. This war could provide a distraction that would be taken advantage of by China’s plan to attack Taiwan.
5. China is on the verge of “financial collapse” and bankruptcy. China’s largest real estate developer Evergrande was reported to have made an “interest” payment to its bondholders last week, but reports on Thursday, October 27th indicated Evergrande had missed “interest” payments for a third month in a row on \$300-billion in financial debt. China’s wealth is largely in real estate, 65% vs. 27% in the U.S. Evergrande along with the next three real estate ventures are all in the early stages of bankruptcy. This will have a powerful effect in keeping China from becoming the world “reserve currency” of the world, which it has been aiming for several years. This has actually kept the U.S. Dollar strong in international financial circles.
6. China has been actively preparing to attack the island of Taiwan, in its decades-long plan to take back control of the island originally called Formosa. The CCP are willing to risk a war with the U.S. in this venture. They believe they control Joe Biden and that Biden will enable them to achieve their coveted goals. They see the U.S. military as unwilling to go to war with China.
7. The U.S. is itself also on the verge of financial bankruptcy. With an unpayable National Debt of \$29-trillion dollars and off-book obligations and commitments of \$230-trillion dollars, the U.S. will not be able to pay the interest on the National Debt by 2025. By 2025, the interest on the National Debt will consume every dollar taken in by the IRS and leave zero for such things as the military or salaries of the government employees, senators, legislators, and judges, etc. The Biden administration wants to spend \$3.5-trillion for next year which has been delayed by a stop-gap spending bill that ends in six or seven weeks.
8. The World Economic Forum meets this weekend at Davos, Switzerland. You can’t visit this event and a ticket costs \$27,000 for this “invited guests only” event. The elite are watching the world economic collapse in real-time and will “rubber stamp” the plan for next year of how they tighten the noose around the New World Order. 1,000 private jets today are flying into Davos with the world’s elite!
9. The global supply chain was intentionally sabotaged and has destroyed the “just-in-time” inventory system begun in the 1960s. Shortages and increased shipping costs are destroying economic capitalism. The cost of a shipping container for a cargo of

goods between Shanghai, China and Los Angeles, CA has risen from \$2,000 to \$19,000. Now, it turns out that the U.S. is not sending empty 20' and 40' containers back to China. There was as of this week just over 103 container ships waiting to dock and unload at West Coast terminals. The Biden administration is blaming the congestion on Covid-19; a lack of drivers; and a port worker slowdown, but the real cause of this delay is payments! Goods from China are not paid for until they are unloaded and consigned to a customer via a trucking company or a railroad for final destination. We are in an economic war phase with China of what will become a hot war down the road. Slow down payment for goods creates a cash shortage up and down the line from manufacturing in China to delivery to your local retail big box stores or the local tire store, etc. We can only speculate who is really behind the slowdown of payments to China. You can be sure that none of this helps the Chinese government and its economy. China is now faced with shorter work weeks, down to two-days a week because of a reduction in electricity created by coal shortages and their required obligations to reduce their environmental pollution.

10. The Deep State has been undermining the Republic for decades, largely laws and public regulations being used to transfer wealth, but also limiting and deterring investment and growth. Thousands of new regulations are written every year at the local level all the way up to the national and international level through the UN. Global warming and/or climate change has been a focus for decades. The list is so long and vast that one can hardly find a point to begin with. People are banned from collecting rain water from their property, banned from planting gardens, flowers, and the list goes on and on endlessly. I know of one situation in which a farmer had to remove a pond he built for his livestock watering. The U.S. Department of Agriculture paid farmers in California not to plant or ranch at a ratio of \$1.50 per dollar of their last year's income. Why? Who benefits?

The destruction of the Republic is a defeat to the free world and a step towards global government. We are in this period described as the beginning of sorrows is mentioned by Jesus Christ in Matthew 24:4-8 (Mark 13:5-8). It is a period of time characterized by specific signs that indicate His return is near. These signs also cause an increase in pain and sorrow that the Bible likens to a woman as she goes through her pregnancy and is about to give birth.

Prince Charles has been more visible in the past two months and the media is giving him more exposure in his anticipated "coming out" activities in his role as the Antichrist! With all I have said, get ready to have your "boarding" pass for the imminent Rapture flight!

The doctrine of the Pre-tribulation Rapture is a fundamental of the New Testament faith. I find more than enough clear Scripture to settle the timing of the Rapture and to be convinced that it is an essential doctrine. Among other things, the Pre-Tribulation Rapture is necessitated by the clearly taught doctrine of the imminency of Jesus Christ's return and by the doctrine of the distinction between the church and Israel and a proper interpretation of Daniel's 70th Week, shown in the following study. All of this is based on

a consistent normal-literal interpretation of prophecy, which is a fundamental of Bible interpretation, as far as we are concerned in the days that we are living.

I agree with the following statement by Charles Ryrie: *“If plain or normal interpretation is the only valid hermeneutical principle and if it is consistently applied, it will cause one to be a dispensationalist. As basic as one believes normal interpretation to be, and as consistently as he uses it in interpreting Scripture, to that extent he will of necessity become a dispensationalist”* (*‘Dispensationalism,’* revised 1995, pg. 20).

God’s people are to live in expectation of the Lord’s coming for them at every moment. We are taught to look for the coming of Christ, not the Antichrist. Jesus, Paul, James, and Peter taught this -(Matthew. 24:42, 44; 25:13; Mark 13:32-37; Romans. 13:12; Philippians 3:20; 4:5; 1st Thessalonians 1:9-10; 5:4-9; Titus 2:12-13; James 5:8-9; 1st Peter 4:7). The early Christians lived in expectation of Christ’s imminent return and the literal fulfillment of the prophecies -(1st Thessalonians 1:9-10). The imminent Rapture has extreme practical implications. It is a powerful motivator for godly, pilgrim living, and it gives constant urgency to the task of world evangelism.

This is what I have believed for 54 years because this is what I find in the Bible. I have been a devoted student of Bible prophecy and have examined all positions on prophecy, as far as I know, certainly all of the positions on the timing of the Rapture.

There was a time when the Pre-tribulation Rapture was not clear in the 1800s when the literal interpretation of prophecy was being recovered and emphasized. At first the emphasis was on premillennialism as opposed to post or amillennialism. But soon the issue of the timing of the Rapture came to the fore and was settled in the hearts of the majority of Biblicists, whether non-denominational fundamentalists or fundamental Baptists.

The doctrine of the Pre-tribulation Rapture was the predominant view of the Bible Conference/Prophetic movement of the last half of the 19th century, of the Bible Institute movement, of the Revivalist movement, of the fundamentalist movement of the first half of the 20th century, and of the fundamental Baptist movement of the last half of the 20th century. It has been the predominant view driving the modern world missionary movement. These movements encompass all of the major Biblicist movements of the last century and a half. The doctrine of the Pre-tribulation Rapture is under attack today from many sides, from theological modernism, from New Evangelicalism, from the emerging church, from Reformed Calvinism, even from a few voices from among non-denominational fundamentalism (Bible churches) and fundamental Baptists.
