Events are churning so fast that it was only a few hours after I posted Blessed Hope #80, that several points of my suggested list of events that could bring on the Rapture were actively in play on the world scene. Lurking in the wings on the world stage the False Prophet is doing his part, whether it is mandating the vaxx, or greasing the path for immigrant invasion of the U.S. and Europe. They are all inter-connected, designed to destroy the EU and North America. - "The issue for those who do not believe in God is to obey their conscience." (Independent, 10/5/15)
- "The death penalty is inadmissible." This heresy opposes God's Word (Genesis 9:6) and the Catechism of the Catholic Church. (Vatican News, 10/13/17)

Only the Truth Can Set Catholics Free

Tragically, Catholics who are not abiding in God's Word, cannot discern truth from error and are easily deceived. They cannot discern between the all-sufficient Savior who offered Himself once for all sin, from an imposter who is offered every day by a sinful priest. Catholics cannot discern the true Gospel, that offers eternal life, from a false gospel, that offers only conditional life and a false hope. The only way Catholics can be set free from religious deception is to abide in God's Word to learn the truth that will set them free -(John 8:31-32).

The False Jesus of Catholicism

God's Word tells us that Jesus offered Himself once for all sin for all time and there are no more offerings for sin -(Hebrews 10:12,14,18). The counterfeit Christ of Roman Catholicism is offered 200,000 times each day on altars throughout the world as a sacrificial "victim" for past sins (CCC, 1367). God's Word tells us Jesus will return a second time the same way He left, after the tribulation, in wondrous glory (Acts 1:11; Mat. 24:27,30; Heb. 9:28). The Catholic Jesus returns from heaven every day at the command of a priest (CCC, 1374).

When Catholics worship and trust the false Christ of the Eucharist, they are committing the most serious sin of idolatry and must be warned. Furthermore, another Jesus always leads to another gospel, which has no power to save (Rom. 1:16; Gal. 1:6-9). It is because of our love for Catholics that we have published this Gospel tract contrasting the true Christ from their false Christ.

Brother Mike Gendron is not representative of the Ecumenical Movement that began with Vatican II in 1965. When I entered pastoral ministry in 1965 as a young Methodist pastor, it was at a pivotal time for the church in the world. Prior to Vatican II, Rome called Protestants "heretics", and following the Jesuit "kiss and hug" celebrations, Rome called Protestants "lost brethren". Many of my fellow senior pastors left the Methodist Church, choosing to retire than to participate in this charade known as ecumenism. My district superintendent at our monthly Saturday morning breakfast meeting would offer words of caution to us newer student-pastors in the district about what we could and should not say. Vatican II was a Jesuit plan and orchestrated for a single purpose!

For the past half-century, the Jesuits achieved exactly what they set out to do in Vatican II, mute the voice of Biblical Christianity that traditional Protestant denominations once believed and taught.

Pope Francis released a video message advocating more left-wing politics on Saturday, in the latest attempt by the Vatican to reassure the world that Catholicism is on the side of <u>social justice</u>. The pope praised deceased felon George Floyd as a "Good Samaritan," and provided a moral endorsement of violent BLM rioters.

"Do you know what comes to mind now when, together with popular movements, I think of the Good Samaritan?" the Pope declared. "Do you know what comes to mind? The protests over the death of George Floyd. It is clear that this type of reaction against social, racial or macho injustice can be manipulated or exploited by political machinations or whatever, but the main thing is that, in that protest against this death, there was the Collective Samaritan who is no fool!"

"This movement did not pass by on the other side of the road when it saw the injury to human dignity caused by an abuse of power," the Catholic figurehead continued. "The popular movements are not only social poets but also collective Samaritans."

The pope went on to repeatedly invoke the term "social justice," and proclaimed that "In my experience, when people, men and women, have suffered injustice, inequality, abuse of power, deprivations, and xenophobia in their own flesh – in my experience, I can see that they understand much better what others are experiencing and are able to help them realistically to open up paths of hope. How important it is that your voice be heard, represented in all the places where decisions are made. Offer your voice in a collaborative spirit; speak with moral certainty of what must be done."

There has never been any doubt that Pope Francis was a champion of Marxist and communist rhetoric, his reputation extends decades back to his roots in Argentina. He aligned himself with dictators and used his office as an instrument of control and subjugating the masses living in poverty. But now, Francis is using his track record as a socialist and Marxist on the world stage through Prince Charles, Klaus Schwab, and Bill Gates "Great Reset" and "Sustainable Development."

This past weekend the pope also met with fellow Catholic Joe Biden's "double" to discuss the "climate crisis" as well as the abortion-tainted COVID-19 shots. Justices Barrett and Kavanaugh voted against religious liberty and for COVID tyranny this past week.



Justices Amy Coney Barrett and Brett Kavanaugh voted against religious liberty and for COVID tyranny when they joined Chief Justice John Roberts and the far-left wing of the Supreme Court to deny a preliminary injunction to a group of medical professionals seeking an exemption from Maine's vaccine mandate.

If that decision has you scratching your head, this Blessed Hope will explain the religious switch. Pied Piper traitor Donald Trump nominated these two Jesuit-trained Georgetown University lawyers.

Back on February 22, 2016, James O'Shea writing for the Irish Central, raised this question: "Is Donald Trump secretly part of a Jesuit plot to take over America? Conspiracy theorists have a field day as Jesuits respond to latest Donald Trump "plot."

Presidential hopeful GOPs Donald Trump: When the age that we live in becomes chaotic, cruel or unjust, we often turn to art to try and understand it.

"If you thought the Donald Trump presidential race was strange to begin with, did you ever think he's just part of a worldwide Jesuit conspiracy and a secret agent for the St. Ignatius battalions?"

That's the phony baloney claim made recently which has since gone to top of the Google search charts and drawn a response from a prominent Jesuit in the magazine 'America'.



As a conspiracy theory this knocks Obama born in Kenya into a cocked hat.

But as Father Jim McDermott of Jesuit 'America' magazine writes, it is one that has clearly gained followers.

He writes "I know, it's just one crazy link. Except it's the one ranked highest by Google."

"It is also not the only post in the top 10 with a similar message. In fact only two of the top ten links about Donald Trump and Jesuit don't have something to do with the apparent Jesuit-Trump conspiracy that no one has had the courtesy to let me know we are in on. (If you only have time to sample one piece from this magical universe, may I suggest the first few minutes of this YouTube post about why, during the "Jesuit Paris Attacks," a woman believes Donald Trump got switched out by his clone. It begins "I was watching Fox News this morning."

It seems where the Donald is concerned no theory is outlandish enough.

The author of the viral reddit post states Donald Trump is a "false flag" candidate, or not what he appears to be and writes:

"Donald Trump has been the subject of media frenzy as of late. It seems that a considerable amount of those who subscribe to alternative sources of information are Trump supporters. They see him as some kind of rebel, going against both the Republican and Democratic parties."

"Could it be though, that Donald Trump is a "false flag candidate" being used to secure the vote of the ever-increasing independent constituency in order to inevitably lull the US into a false sense of positive political novelty and thus to subsequently impose Jesuitical right-wing fascism leading to a nationwide race war as devised by the masters of class adversarialism, the Sons of Loyola?"

The article goes on: "It very well could be. Here is why:

"Trump claims to be Presbyterian, yet he attended Jesuit Fordham University for two years and then transferred to the covertly Jesuit-controlled University of Pennsylvania. Ah that's it Donald attending Fordham University made it clear he was a Jesuit stooge. There's also an anti-semitic passage saying the Jews and Jesuits are all in this together--SURPRISE.

He even investigates Trump's children. At the end the writer concludes: "There you have it; Trump, in addition to being affiliated with both Jesuit Fordham and covertly Jesuit U. Penn, has at least three children who are all alumni of Penn and notorious Jesuit Georgetown University!"

"Whether it be Trump, Jeb Bush, Hillary Clinton or even Bernie Sanders that ends up winning the 2016 election, all of these candidates are connected to Rome and all will only serve to implement the tyrannical, neo-Romanist policies of the Papacy and its professed soldiers of the Jesuits."

I always thought Sanders, who is Jewish was really a secret Jesuit archbishop didn't you? Bishop Bernie.

Lord what is the word coming to Donald Trump a secret Jesuit agent, the pope trying to take over America (he's a Jesuit too, though he did just accuse Trump of not being Christian, which puts something of a spanner in the works for this plot).

Maybe we can start a new rally cry Vote for Donald Trump's clone (let's call him Dolly after the first cloned sheep. Our slogan? Hello President Dolly, goodbye impostor Donald.

The above was a debunking effort by the Jesuit magazine 'America' to hit head-on the rumors circulating that Donald Trump was a Jesuit troll candidate!

Now, all that was in June, 2016. It is interesting confirmation of how hind sight is 20/20 in late 2021. In hind sight we have quite a revelation from the events since 2016. The Internet was full of "predictive programming" of the Donald becoming the president more than decade prior to 2016! Then what about 2024?

The 6-3 ruling against religious liberty means that the group of Maine healthcare providers now face being mandatorily vaccinated for COVID against their religious beliefs or lose their jobs. "With Maine's new rule coming into effect, one of the applicants has already lost her job for refusing to betray her faith; another risks the imminent loss of his medical practice," Neil Gorsuch noted in his dissent.

Barrett and Kavanaugh provided the following explanation for voting the way they did (via <u>Business Insider</u>):

Barrett, joined by Kavanaugh in a concurring opinion, briefly remarked on their decision to block the request, citing the fact that the case was brought on the shadow docket, or as an emergency appeal. Shadow docket cases do not involve oral arguments or full rulings that are part of normal cases.

Barrett said the shadow docket should not be used for such a case, and that **the court should not make this decision** "on a short fuse without benefit of full briefing and oral argument," implying she and Kavanaugh could vote differently if the case came before the court in a different way.

This vote by Brett Kavanaugh and Amy Coney Barrett against religious liberty and in support of COVID tyranny shouldn't come as a surprise — their failure to protect and defend the Constitution is something conservative brethren warned about when Trump and McConnell pushed their nominations through the system.

Before her appointment to the Supreme Court, Amy Coney Barrett's judicial track record revealed that she was a conservative fraud, not a strict constructionist of the Constitution. Instead, Barrett's past showed that she was a big government, police state advocate who would continue the assault against our constitutionally protected liberties.

Constitutional attorney Robert Barnes reviewed over 40 cases involving Barrett and concluded that she would be a disaster as a Supreme Court justice when it comes to protecting liberty — particularly, religious liberty in the age of COVID tyranny:

"Coney Barrett has sided with the government on the lockdowns, on uncompensated takings, on excusing First Amendment infringements & Fourth Amendment violations... [and] exclaimed the benefits of Jacobson, the decision that green-lit forced vaccines & carved out an emergency exception to Constitutional protection in 'public health' or 'emergency' cases used to justify forced sterilizations & detention camps."

Barrett concurred with the majority in <u>Illinois Republican Party et al. v. J.B. Pritzker, Governor of Illinois</u> to keep an illegal lockdown in place — effectively shredding the Constitution in the name of so-called safety — and she tried to hide her concurring vote behind the precedent established in 1905 in <u>Jacobsen v. Massachusetts</u> in order to avoid taking responsibility for her decision.

The Jacobson decision gave the green light to forced vaccines, and it carved out the emergency exception to Constitutional protection in "public health" or "emergency" cases used to justify <u>state-mandated vaccinations</u>. It was also the legal basis used in *Korematsu v United States* where the court ruled in 1942 that the <u>internment of Japanese Americans</u> was acceptable.

Back in August, 2021, Barrett <u>rejected a request</u> to block Indiana University's vaccine requirement for students without providing any reason for doing so. She made the decision without consulting other justices as she could have done and suggested that there was no legal justification for the request.

When Anthony Kennedy resigned, Donald Trump and Mitch McConnell picked Brett Kavanaugh to replace him, and they promised that he was also a "strict constructionist." But as we knew then and still know today, that was a lie.

Kavanaugh's appointment to replace Kennedy was a bad deal for conservatives and the Constitution from the very beginning, and David Leach opposed his confirmation for several reasons:

- His appointment was part of a <u>secret deal between Trump and Kennedy</u>
- His opinion that a <u>sitting US President is above the law</u>
- His track record of rulings against the Fourth Amendment
- His testimony before the Senate that Roe v. Wade is "settled law"

Ironically, Washington, D.C. District Judge Colleen Kollar-Kotelly — a Clinton appointee, by the way — barred the Biden administration from firing unvaccinated federal employees last week, siding with plaintiffs who claimed that their employer's refusal to allow a religious exemption to the vaccine mandate would result in irreparable harm.

With the recent FDA authorization of the COVID <u>vaccine for children ages 5 to 11</u>, and with the CDC likely to sign-off on distribution, vaccine mandates for children are pretty much a done deal. <u>Based on what we've witnessed so far from Barrett and Kavanaugh, if a religious liberty challenge to such a mandate reaches the Supreme Court, it's highly unlikely that children will be spared from COVID tyranny.</u>

The Judiciary was designed by the Founding Fathers to be the weakest branch of government; the real power is supposed to belong to "we the people" via the legislative branch and the individual states. In post-Constitutional America, unelected judges have taken that power from us. History of Judicial Activism began a new era in the 1960s.

In the early 1960s justices on the Supreme Court discovered a way to subvert the will of the people and began overturning existing laws and creating new laws. No one has the power to remove them from office since they are appointed for life.

Just like Trump's other Supreme Court appointee, Neil Gorsuch — the justice who reinterpreted Title VII of the Civil Rights Act to include the LGBT agenda — Amy Coney

Barrett and Brett Kavanaugh are judicial tyrants working to destroy religious liberty, and COVID tyranny provides the perfect opportunity for them to continue doing so.

In a desperate attempt to save their jobs, Donald Trump and Mitch McConnell claimed that the Republican Party had saved the courts and had put America back on the path to being the Constitutional Republic envisioned by the Founding Fathers. Not only was that a lie, their appointments to the Supreme Court have accomplished the exact opposite. Amy Coney Barrett and Brett Kavanaugh voted against religious liberty and for COVID tyranny, and they're likely to do so again in the future.

David Leach writes for 'The Strident Conservative', and his analysis corroborates what James O'Shea stated five years ago. Unfortunately, and no thanks to Vatican II, Americans either do not know their history or choose to be drawn into the Jesuit Vatican II scheme to subvert Protestant America. The Supreme Court is Roman Catholic, Jesuit-dominated on 7-2 decisions in most cases that matter to Rome!

The point is not so much that Donald Trump was present on a Catholic, Jesuit university campus — but the courses he took and what he gained from them. Every Jesuit college or university in the United States offers an iteration of the same core curriculum. And although Trump never released his college transcripts there is a slim chance he would have been able to finagle his way out of certain required courses. That means that during either his freshman or sophomore year, Donald Trump would have had to take a required course in either theology or philosophy. He likely took both.

The Jesuits almost always rule from within: they start an organization via their faithful controlled followers or infiltrate an already established one whose leadership they either install or, if already in place, control via any means necessary, including bribery, extortion, kidnapping and murder of family members and close associates. This method has worked for hundreds of years across the world, and is still in wide use today. When any important Jesuit issue is threatened, they find some clever means to convince Americans to vote in favor of the Jesuits' preference.

Stan Szymanski this past Tuesday reported that Dr. Marco Metzler, former Fitch analyst and now of DMSA (Deutche Mrkt Screening Agentur GmbH) has announced that the past due interest payment on China Evergrande Group's offshore international bonds that all of the western media reported as supposedly paid by Evergrande could not be confirmed. Today, he is stating that a second interest payment (\$47.5 Million) allegedly made by Evergrande according to the western media last night has not been paid, once again contradicting mainstream media reports.

According the GMBH News Release dated today (10/29/21)...'For the second time in a week, China Evergrande Group has apparently technically defaulted on interest payments to international investors.'... and in the opening paragraph goes on to say...'Should the Evergrande insolvency not only drag down China's real estate sector, but the entire economy of the country, we will see even bankruptcies of major international banks - such as HSBC, fears DMSA senior analyst Dr. Marco Metzler.'

But there has been no official confirmation of any payment of that interest by the close of business at Hong Kong banks'...continued Metzler. Besides Encouraging Angels, the only other known doubts that concur with Metzler appear in a recent report in the 'Financial Times' Metzler says in the press release. In that document, Dr. Metzler goes on to state that no one replied to their inquiries as to an actual confirmation of the payments to creditors by Evergrande.

"Thus, the bankruptcy has apparently already technically occurred," analyzes Metzler. Evergrande tried to raise capital through the sale of assets. The environment for asset sales is abysmal. The company tried to sell some of its assets to Hopson Development Holdings which fell through. According to reports, the deal would have been worth 20.04 billion Hong Kong dollars (\$2.58 billion), according to filings.

This is, of course horrible news for a company who has over \$300 billion of debt. How much good would \$2.6 billion from the failed Hopson deal done for Evergrande anyway? \$2.6 Billion is less than 1% of Evergrande's indebtedness. A drop in the bucket! Evergrande is indeed, bankrupt no matter what the mainstream brokers of financial information 'report'.

Stan Szymanski said, I have had friends basically say to me 'If Evergrande defaults, so what? That doesn't affect us'. In fact one friend sent me research from Janney dated 9/22/21 that stated: ...'While the U.S. is not immune to disruptions in other parts of the world, we do not view the situation in China as a contagion risk that will derail the bull market.'...

What a difference 6 weeks can make. Dr. Metzler's take on Evergrande is paradoxically opposed to the Janney position on the company as detailed in the press release from GmbH: ...'Metzler considers it quite possible that Evergrande could drag China's entire real estate sector down with it. This could have serious (huge) implications for major international banks such as HSBC. According to their figures for the third quarter of 2021, Hong Kong's largest bank alone has extended loans totaling 19.6 billion U.S. dollars to Chinese real estate groups. Assuming a recovery rate of five percent in the event of an industry-wide wave of bankruptcies triggered by Evergrande, HSBC alone would have to write off around USD 18 billion.

If one also considers the limited possibilities of international banks to access assets in China, there is much more at stake for HSBC: the default of the entire portfolio of Chinese corporate loans. And that, after all, is worth around \$196 billion. "Such immense lending to Chinese companies, without a guaranteed possibility of accessing collateral in China itself in the event of bankruptcy, is irresponsible in my view," says financial expert Metzler. With a return of five percent, HSBC would have to write off around 186 billion dollars in this case. That would correspond to almost the entire equity capital of the bank. And it would probably lead immediately to its bankruptcy. This would make HSBC a victim of the Chinese financial virus, which would then spread rapidly throughout the international financial markets. "The Great Reset - the final meltdown of the current global financial system - has long since ceased to be a purely intellectual thought experiment," concludes Dr. Metzler.

Since the rest of the financial media is not telling the truth about the interest paying ability of Evergrande, and actually reporting that the company has made payments when they have in fact not, I am inclined to buy the narrative of Dr. Metzler who has correctly analyzed the situation and told the truth.

However, while it's Chinese funded, a Tajik parliament spokesman said the base will host a special forces unit of the national police, and rejected that Chinese troops would be directly deployed there. But the question of joint training operations wasn't ruled out. This is just where the bleeding begins.

The Taliban is getting money and weapons. The CCP is getting access to minerals. Sounds like a good deal, until everyone realizes it will take 3 troops for every worker to keep the operation going. One to watch the worker, one to watch the soldier's back so the worker doesn't kill him, and the third to watch the other two solders so they stay sober and loyal. Physical size and strength is the only thing that keeps you from being hurt in these situations.

One thing is for sure, if the CCP cannot acquire assets in the next 90 days to get creditors to back-off in the credit markets, their economy will crash. When it does, 1.3 billion Chinese will swarm the CCP leadership and the results will be complete

An astonishing thing took place recently involving two United States fast-attack submarines, and what happened is an ominous sign that REAL trouble in the Pacific is much closer than any of us have been told.

On October 20, the USS Jimmy Carter, the single most advanced nuclear-propelled submarine in the U.S. Navy, popped-up near San Diego, and headed into port.

Two tug boats moved the sub to the dock, but the crew DID NOT go ashore. Instead, the tarps were placed along the entire dock to prevent satellite surveillance from seeing what was taking place. Normally they merely cover the screw, so that the enemy cannot extrapolate the sound it might make in the water by its design. This time, they covered the entire loading area so that material-handling equipment like fork-lift trucks could load the cargo in secret onto the sub. It could not wait for a clear satellite window. It could not wait for nightfall. It had to be done quickly, perfectly hidden in plain sight, and quickly.

It gets even better.

Three days ago, on October 25, another submarine from the same fast attack class, the USS Seawolf (lead boat in its class), popped-up outside San Diego just like the USS Jimmy Carter five days earlier, was brought to dock by two tugboats and the entire operation that was done with the USS Jimmy Carter, was done with the Seawolf. Two

of the world's fastest and most secret nuclear-powered subs, in less than a week arrived at the same port, docked near the world's most advanced Marine base.

It is publicly known that the USS Jimmy Carter features a unique 100-foot long extension called the Multi-Mission Platform (MMP), and it is an open secret of sorts that it is primarily focused on espionage missions, such as inspecting, manipulating, and even recovering objects of interest sitting deep on the ocean floor. The USS Seawolf, as well as her sisters, USS Connecticut and USS Jimmy Carter, were originally conceived primarily as advanced nuclear-powered attack submarines.

By the way, fast attack subs are sub-killers. They are ship killers. They are designed to locate and follow enemy missile subs and boats with the assignment of sinking them at a moment's notice. They don't carry nuclear weapons. They carry fast torpedoes and other weapons. Rumor has it they can travel at speeds up to 60 miles an hour underwater. No one really knows for sure.

This is or was top secret operation. It was vital to get this done, and it was done on an expedited time table. Once whatever was loaded into these subs, the subs were towed away from the dock and put immediately back to sea.

I need to impress upon you how warfighting operates. This war is one of ideologies that you see. But there is also the test of metal and blood that keeps the world free and at peace. The weaponry that was loaded onto these two subs is so terrible and so new, it had to be expedited, hidden from sight, and immediately placed in harm's way. Much of that he learned at Regis High School, a no-tuition, Jesuit-run boys college-prep school in New York City that is renowned as an academic haven. Fauci, a member of the class of 1958, told a group of alumni last May that attending the school "was the best educational period I could ever have imagined having."

Fauci also is a graduate of College of the Holy Cross in Worcester, Massachusetts, another Jesuit institution. "I take great comfort in knowing that when he speaks that he is speaking the truth and nothing but the truth," Jesuit Father Daniel Lahart, Regis' president, told National Catholic Reporter.

"I worry about a pandemic," Fauci said last May. Now, less than a year later, his worries are a reality and he has emerged as the public face of the fight against coronavirus. (Source: catholiccourier.com)

Dr. Fauci gave a speech on January 10, 2017, just ten days prior to the inauguration of Donald Trump. The event was sponsored by the Center for Global Health Science and Security, which is part of one of America's leading Jesuit universities, Georgetown University. In his speech, Anthony Fauci made the following disturbing comment:

"The issue of pandemic preparedness... if there's one message I want to leave with you today based on my experience... is that there is no question that there will be a challenge in the coming administration in the arena of infectious diseases, both chronic diseases in the sense of already ongoing disease and we have certainly a large burden of that, but also there will be a SURPRISE OUTBREAK." Was Dr. Fauci psychic or knew something the rest of the nation did not know?

In 1992, the Defense Department investigated Redfield after he was accused of

Jeffrey von Arx, president of Fairfield, she commented, "I believe that, in founding the Center for Ignatian Spirituality in 2014, Fr. von Arx has assured that Ignatian spirituality will guide those at Fairfield and even worldwide, who seek the gift it so uniquely can provide, while it continues to inform and influence the environment of learning at Fairfield."

The donation will also fund scholarships for those studying at the Center for Ignatian Spirituality. An official video from the Center offers a testimony from one woman who says, "It wasn't limited to Catholicism. I felt it was a broader belief."

Father von Arx, remarking on the donation, said, "The scholarships make possible the dreams of many worthy young men and women, and the Center will help meet the needs of today's world, while renewing the formative prayer tradition at the heart of the mission of the Society of Jesus."

Maryann Trump Barry caught national attention when then-Republican nominee Ted Cruz called her a "radical pro-abortion extremist." She was appointed to the federal bench by Bill Clinton, and in 2000 she helped strike down a New Jersey law that would have banned partial-birth abortions. Barry was awarded an honorary doctorate from Fairfield in 2011 and credits the Society of Jesus with "quite literally saving my life."

The China – Jesuit Partnership. Who owns China?

I am a historian by my college major and I follow the geo-political world news sites and so my understanding of geo-political events are not limited to the mainstream media. What I am going to share in closing off this Blessed Hope was posted by the Editor of cairnsnews by Bob Thompson* (first published CN, April 11, 2020) (cairnsnews is from New South Wales, Australia).

Back in the mid-nineties I had occasion to meet a man who had a close connection to the Order of Jesuits and the Vatican. As circumstances evolved I saved the man's life. We developed a friendship and this led to him opening up to me about his strange life and history. I will call him Max.

One day he reacted to a comment I made that maybe the communist Chinese regime wasn't held in serfdom to the financial and political power of the old Satanist families of Europe which the Jesuit order represented. His response was, "I am disappointed in you. I thought you were smarter than that! I thought you knew more than most people!"

So I asked him to enlighten me, knowing that he had spent many years in China but what he confided in me was unexpected.

Chairman of Chinese Communist Party Deng Xiaoping partnered with wealthy European Jesuit families to relocate western manufacturing. During the later years of the Mao Zedong dictatorship the Jesuits sent Max into China to offer a partnership between the corrupt, wealthy European Jesuit families and the Chinese Communist Party.

Mao responded to this offer by throwing Max into jail. He remained there for quite a while until the Chinese leadership changed when Deng Xiaoping became Chairman in 1978 until retirement in 1992.

The Vatican again sent Jesuit emissaries into China with a renewed offer and Max was released from jail. The business deal was finally put into place and today has changed the world.

Socialist China had become an impoverished, backward country with a massive military and police force. The Jesuits offered to use their power over western nations through front organizations like the Masonic Lodge, banking industry, Catholic politicians and the various socialist assets such as environmental groups which they owned in Western Europe, America, Canada, Australia, New Zealand and the United Kingdom to transfer western industries to China.

These undercover organizations, some holding tax-free status in Commonwealth nations, pushed the free trade agenda upon the west to allow slave labor manufacturing of Chinese goods. In exchange the Chinese communists were to agree to share the profits from this trade deal with the same old Jesuit families in Europe.

Hawke's ATO emissary shut down a Sydney manufacturing business.

I met with a Sydney manufacturer at the time who made high quality fittings for gas and water installations. He was visited by a representative of PM Hawke's office.

The businessman was given an ultimatum, "shift your plant to China or you will be destroyed," the government agent told him. "All costs will be paid by the government."

He refused the treacherous offer and a few weeks later had a visit from the Australian Tax Office. He was accused of tax fraud. His bank accounts were closed while the ATO conducted an investigation.

Consequently the businessman was unable to pay staff or suppliers. The ATO kept up the charade until he was made bankrupt. The business was sold and the plant and equipment went to a Chinese buyer.

One of the most destructive parts of the Jesuit – China deal was how China's much touted economic "miracle' was funded. China was allowed to establish a two-tiered monetary system. Their banks did not borrow from the global banksters and did not have to accept so-called foreign investment.

Just as the Australian Treasury created \$130 billion by adding extra zero digits in their computers a week ago, and how Donald Trump created \$2 Trillion interest-free by merging the Federal Reserve with Treasury. You will have to pay the interest on that Trump-created debt!

Australia funded large infrastructure projects such as the Snowy River Scheme and the Nullabor Railway in the same manner. Debt-free, no extra taxes, no user pay and no foreign ownership.

After the Chinese deal there were no howls from the Jesuit-controlled media about 'funny money', a reference to U.S. Federal Reserve Notes. China went from a third world cesspit into a massive economic powerhouse in a few decades thanks to the crushing economic loss to Australia and the U.S.

President Trump had begun to claw back America's former status as a manufacturing giant usurping China but the party duopoly of Australia continues to drag its feet under the weight of cash-backs, foreign bank accounts of politicians and bureaucrats and compromise on a scale that would make Indonesian politicians blush.

Now we are confronted by the Wuhan virus disaster and we have to manage with the loss of our own medical manufacturing industries which were shifted to China. The cost of this treasonous transfer of our industrial capacity to the police state of China is clear. This was the ultimate aim of the Jesuits in partnership with Communist China.

The Jesuit connections with China began in the 18th century mission of priest Matteo Ricci, as a papal emissary to the court of the Manchu Qing Dynasty, and have since never relented, with the continuing presence of Jesuits in Macau, a base for liaison and cooperation on the mainland.

Much of the anti-American tilt of late across Asia and Europe is a coordinated policy of the Jesuit order aimed at quelling the conservative American Catholic faction over Taiwan and Hong Kong policy, and suppressing any other points of resistance.
