We are now very close to our “Departure” time! Events are coalescing and converging so quickly, as the birth pangs of a mother delivering her baby! I am not sure I will remember all the key things I wanted to include in this Blessed Hope that I have been mentally noting. The world is on the precipice of a war between China and Taiwan and the U.S., Japan, and Australia are allied in Taiwan’s defense. The bold and brazen Chinese a few months ago did something that has the Pentagon worried and up at night.

In August of 2021, China tested a space superweapon, demonstrating a Fractional Orbital Bombardment System (FOBS) that orbited around the Earth a Hypersonic Glide Vehicle (HGV), which de-orbited to simulate an attack on a terrestrial target. **It is the first time any nation has combined these technologies, which have revolutionary implications, enabling an EMP, nuclear, or possibly even conventional attacks, against any target on Earth, in 45 minutes or less, with little or no warning.**

Defense and intelligence community professionals almost universally acknowledge China’s test of the FOBS/HGV combination is a major threat, potentially a “game changer” with even JCS Chairman Mark Milley likening the test to Sputnik. Yet Sputnik merely foreshadowed a new era in military technology, whereas the FOBS/HGV is an actual revolutionary space weapon.

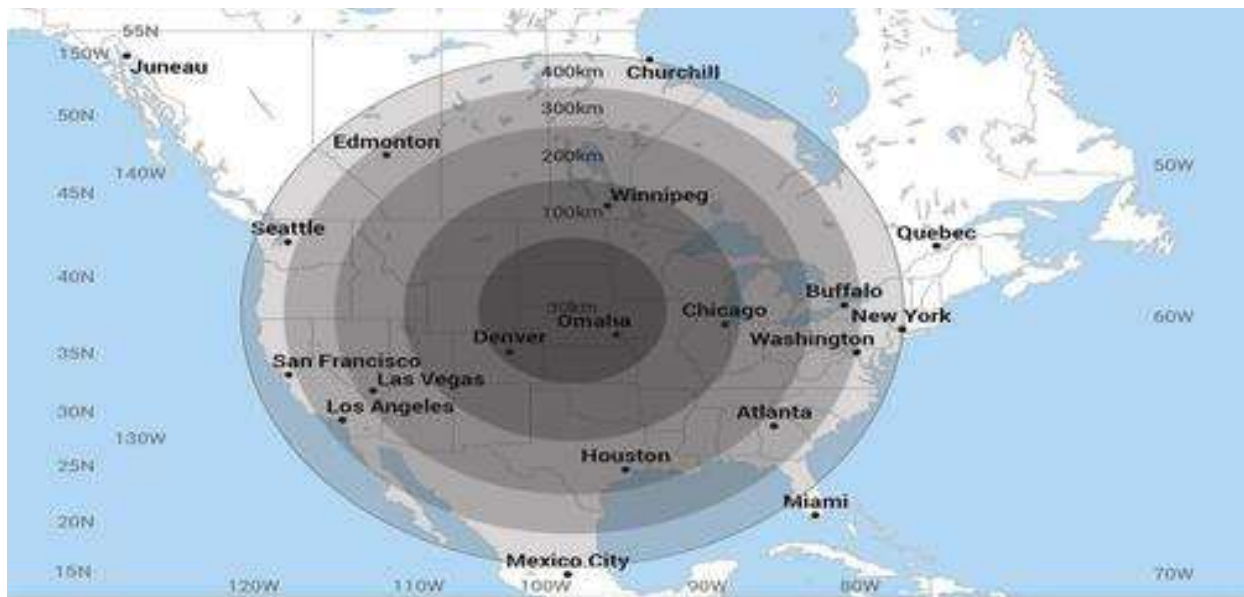
As former senior defense official, Dr. Mark Schneider warns: **“Another important aspect of such a weapon is its potential to launch a surprise nuclear EMP attack. Such an attack would be devastating. This is now a demonstrated capability that does not require the use of an ICBM, an SLBM, or any other type of ballistic missile. This has critical implications for attack warning.”**

U.S. intelligence and defense officials were, again, taken by surprise. **“We had no idea China could do this,”** according to a senior intelligence officer, reflecting the views of a shocked intelligence and defense community in the U.S. and worldwide, as reported by ‘Financial Times’ that broke the story on October 16, 2021, coincidentally during the 59th anniversary of the 1962 Cuban missile crisis.

A FOBS warhead could make a surprise nuclear electromagnetic pulse (EMP) attack, paralyzing U.S. electrical grids, communications, and potentially military command control-communications-intelligence (C3I) and U.S. nuclear retaliatory forces—thereby winning a nuclear war with a single blow.

A nuclear weapon detonated at the right height crossing over Nebraska would destroy 98% of the national electrical grid of the country. So the CCP are in a position to re-take Taiwan, and blackmail the U.S. leadership into either a “stand down” on Taiwan or face a ‘new normal’ of back to the year 1820.

So the U.S. is facing multiple revolutionary technological existential threats that could overturn the balance of strategic power, defeat nuclear deterrence, and tempt China or Russia or both to launch World War III. We are far beyond a “Sputnik moment” - yet Washington is divided on how, and even on whether, to respond.

NUCLEAR EMP ATTACK SCENARIOS

EMP field coverage increases with increasing height-of-burst. A balloon or jet aircraft could loft a nuclear warhead to an altitude of 30 kilometers which, targeted over New York City, would also cover Washington, D.C., New York State, New Jersey, Pennsylvania, Virginia, Maryland, Delaware, and most of New England.

The map above shows the coverage of an EMP attack from 30 km up to 400 km altitude. 400 kilometers is 248 miles, (a kilometer is .62 miles), and so it is easy to see how large an EMP (electrical magnetic pulse) will impact the nation if China chooses to attack the U.S. It is the preferred weapon of attack since it wipes out anything that depends upon electrical power, and leaves no nuclear damage to the agriculture and infrastructure. However, it would within a matter of a few hours result in 104+ nuclear power plants to become like Chernobyl meltdowns from a lack of cooling water. Since China covets American real estate for feeding its people, that fact could be beneficial to those of us depending on creature comforts of heat, running water, and electricity. None the less, a lack of genuine leadership and a house divided cannot stand is reason

for real concern. China is in many ways being backed into a corner with the Evergrande real estate bankruptcy hanging over its lost “trust” among the rest of the world.

We are now in a world where the majority of the reporting press outlets said that Evergrande made its interest payments on bonds when it did not as reported by DMSA? None of the authorities in the U.S. (to my knowledge) stood up and called it Bovine Excrement on the Chinese even when over \$20 Billion of offshore (likely mostly U.S.) money has been invested in Chinese Real Estate Debt.

- > – Simulate a partial recovery of the economy.
- > – Hide statistics of side effects and deaths from injections.
- > – Passing off the side effects of the injections as “natural” effects of the virus and the disease.
- > – Recover the notion of a variant as a natural mutation of the virus.
- > – Justify the maintenance of coercive measures by not applying the herd immunity threshold.
- > – Punish health professionals for the illegal exercise of care and healing. –
- > Result, doubts and feelings of betrayal among the vaxx, discouragement among opponents.

Phase 4: Install Apartheid and the QR code. (June 2021-October 2021)

- > – Voluntarily plan for shortages.
- > – Impose the vaccination pass (QR code) to reward the vaccinated, punish the resistant.
- > – Create an Apartheid of the privileged against the others.
- > – Take away the right to work or study from non-vaxx.

- > – Confirm the obligation to vaccinate semi-annually or annually.
- > – Impose food rationing and a diet based on the Codex Alimentarius.
- > – Extend the measures to emerging countries.
- > Result, Third stage of digital control. Extension of the N.O.M. to the whole planet. (What does N.O.M. stand for?)

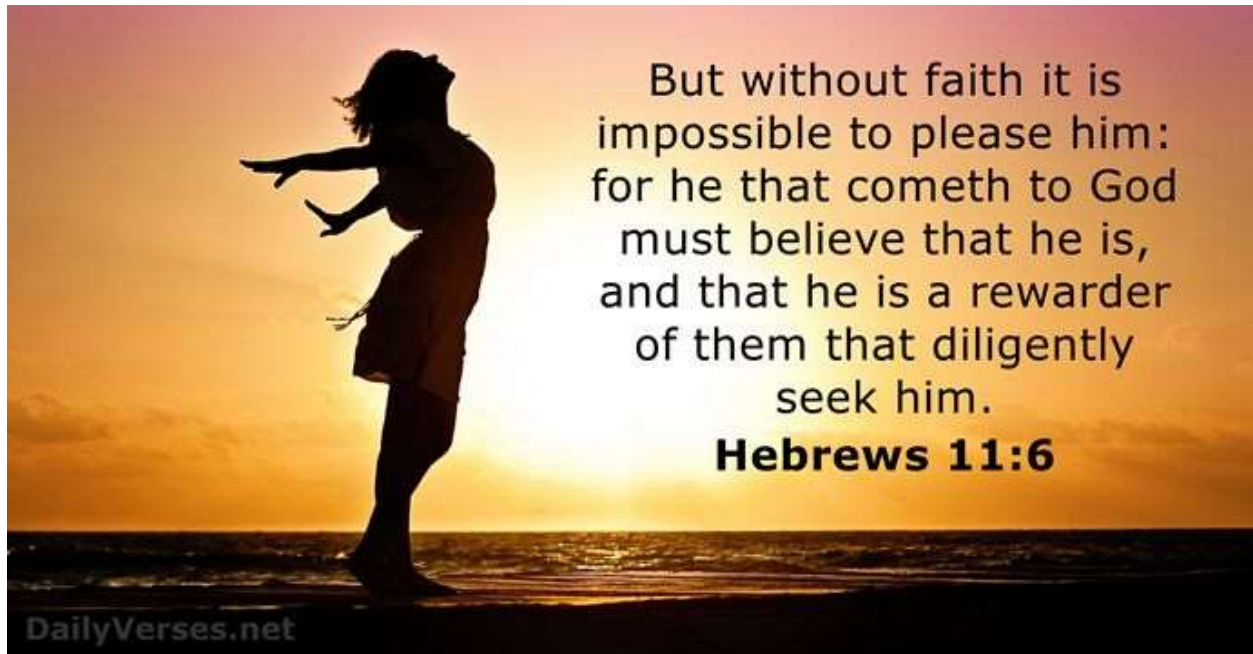

It began on "Black Thursday," Oct. 24, 1929. Over the next four days, stock prices fell 22% in the stock market crash of 1929. That crash cost investors \$30 billion, the equivalent of \$396 billion today, or about the debt of Evergrande today! The Depression had begun earlier in August when the economy contracted. Economic contraction is the best indicator of an economic recession or a depression!

Benjamin Fulford, independent journalist in Japan said yesterday, November 16th, 2021, *"a formal declaration of war by the Anglo Saxon five eyes group has now been made against the Khazarian mafia, otherwise known as the Nazi Fourth Reich."*

This is partial confirmation that mass murder was taking place in hospitals by using “false positive,” test results to force people into death wards.

One of the top vaccine criminals who is about to be removed is Canada’s Justin Castro Trudeau. Castro ordered “ten times more vaccines than there are Canadians –including the moose- and that’s racketeering because he is getting a kickback for every dollar spent [on vaccines].”

There is also a disinfection process taking place in Asia. In Japan, the removal of Rothschild agent Aso Taro and all his cronies from both power and control of finance has taken place. Also, vaccine pushing Governor Koike Yuriko of Tokyo has not been seen in public since November 2nd. Many other politicians, gangsters, “Japan handlers,” financiers etc. have also vanished.

I previously addressed the means by which the Global Reset will be introduced as a measure to counter China’s efforts to replace the Rothschild’s as the global money middle men between sovereign states. The CCP will deliberately stiff the world investors and the massive derivatives market will then commence to unwind as counterparties to those derivatives begin to fall like a long string of dominos. All national economies are debt-based, thus their currencies are fiat constructed. The global Rothschild-controlled 189 central banks are the brains behind the new “cashless” system. As a result, a debt jubilee of sorts will be declared, the forgiving of all private and public debts, thus facilitating a worldwide “reset” to zero. The price or cost to be part of Libra Blockchain will be that you will take the “Mark” of the Beast, in this case the Vaxx and the upgrades of the human body through a series of “booster” shots to

achieve this symbiosis needed in bringing this on line very soon. The huddled masses will see this stipend as their economic security. One will own nothing, and they probably will not like it after they find out what it includes. The Biden/Harris administration Build Back Better will begin by giving amnesty to 7 million illegals that have flooded the country! Deep in the Biden bill the House approved are billions for illegals that will come out of Social Security, even though they do not have social security numbers! Retirees were told solvency of Social Security was good through 2034 but the government has other plans after September of 2022!

In creating a “National Pandemic Emergency”, it provided justification for such sweeping actions that override individual physician medical decision-making and patients’ rights. The CARES Act provides incentives for hospitals to use treatments dictated solely by the federal government under the auspices of the NIH. These “bounties” must be paid back if not “earned” by making the COVID-19 diagnosis and following the COVID-19 protocol.

The hospital payments include:

- A “free” *required* PCR test in the Emergency Room or upon admission for every patient, with government-paid fee to hospital.
- Added bonus payment for each positive COVID-19 diagnosis.
- Another bonus for a COVID-19 admission to the hospital.
- A 20 percent “boost” bonus payment from Medicare on the *entire hospital bill* for use of remdesivir instead of medicines such as Ivermectin.
- Another and larger bonus payment to the hospital if a COVID-19 patient is mechanically ventilated.
- More money to the hospital if cause of death is listed as COVID-19, even if patient did not die directly of COVID-19.
- A COVID-19 diagnosis also provides extra payments to coroners.

CMS implemented “value-based” payment programs that track data such as how many workers at a healthcare facility receive a COVID-19 vaccine. Now we see why many hospitals implemented COVID-19 vaccine mandates. They are paid more.

Outside hospitals, physician MIPS quality metrics link doctors’ income to performance-based pay for treating patients with COVID-19 EUA drugs. Failure to report information to CMS can cost the physician 4% of reimbursement.

Because of obfuscation with medical coding and legal jargon, we cannot be certain of the actual amount each hospital receives per COVID-19 patient. But Attorney Thomas Renz and CMS whistleblowers have calculated a total payment of at least \$100,000 per patient.

What does this mean for your health and safety as a patient in the hospital?

There are deaths from the government-directed COVID treatments. For remdesivir, studies show that 71–75 percent of patients suffer an adverse effect, and the drug often had to be stopped after five to ten days because of these effects, such as kidney and liver damage, and death. Remdesivir trials during the 2018 [West African Ebola outbreak](#) had to be discontinued because *death rate exceeded 50%*. Yet, in 2020, Anthony Fauci directed that remdesivir was to be the drug hospitals use to treat COVID-19, even when the COVID clinical trials of remdesivir showed similar adverse effects.

In ventilated patients, the death toll is staggering. A National Library of Medicine January 2021 report of 69 studies involving more than 57,000 patients concluded that fatality rates were 45 percent in COVID-19 patients receiving invasive mechanical ventilation, increasing to 84 percent in older patients. Renz announced at a [Truth for Health Foundation Press Conference](#) that CMS data showed that in Texas hospitals, 84.9% percent of all patients died after more than 96 hours on a ventilator.

Then there are deaths from restrictions on effective treatments for hospitalized patients. Renz and a team of data analysts have estimated that more than 800,000 deaths in America's hospitals, in COVID-19 and other patients, have been caused by approaches restricting fluids, nutrition, antibiotics, effective antivirals, anti-inflammatories, and therapeutic doses of anti-coagulants.

We now see government-dictated medical care at its worst in our history since the [federal government mandated](#) these ineffective and dangerous treatments for COVID-19, and then *created financial incentives* for hospitals and doctors to use only those “approved” (and paid for) approaches.

Our formerly trusted medical community of hospitals and hospital-employed medical staff have effectively become “bounty hunters” for *your* life. Patients need to now take unprecedented [steps to avoid going into the hospital](#) for COVID-19.

Patients need to take active steps to plan before getting sick to use [early home-based treatment of COVID-19](#) that can help you save your life.

Our government incentivized diagnosing people going to the ER for something that was most likely a severe cold, calling it Covid. The hospital system was paid off dearly for killing people using the recommended NIH treatment protocol that was pre-determined to be followed, despite it was the worst treatment therapy that could be given to a sick person. They in plain words “murdered patients!”

U.S. states are rolling out digital driving licenses which could soon become COVID passport. It's only a matter of time before the two are merged, and your entire identity, including your medical history, finances and more, could be stored in a mobile app that's increasingly required to partake in society.

Such information integration was planned two decades ago when Mark Lerner was informing the readers of the national plan of the REAL-ID plan, and implementation kept being delayed by a half dozen states dragging their feet until the government began to deny air travel without a REAL ID driver's license.



Vaccine passport

An international standard for mobile drivers' licenses and mobile IDs was approved for publication August 18, 2021, clearing the way for global use.

Mobile IDs will act as a digital identity that will ultimately tie in to retail, health care, law enforcement and travel sectors. Ultimately, the IDs will also act as vaccine passports, making it easy to display whether you've gotten a COVID-19 injection — and any other future injections that come about — in order to go about your daily life. Some have speculated that the introduction of digital IDs and vaccine passports in the U.S. is laying the infrastructure for a social credit system like the one being used in China.

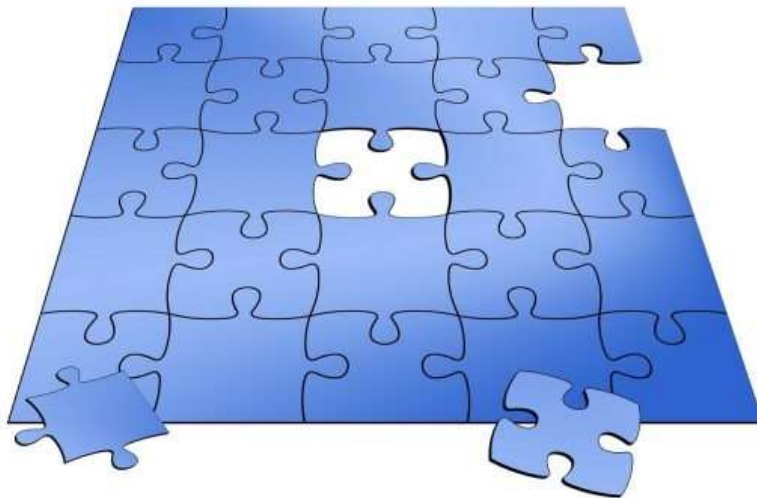

For two years now we have been witnessing a global coup d'état, in which a financial and ideological elite has succeeded in seizing control of part of national governments, public and private institutions, the media, the judiciary, politicians and religious leaders.

All of these, without distinction, have become enslaved to these new masters who ensure power, money and social affirmation to their accomplices. Fundamental rights, which up until yesterday were presented as inviolable, have been trampled underfoot in the name of an emergency: today a health emergency, tomorrow an ecological emergency, and after that an internet emergency.

I am suggesting this "prince" is the missing piece of the Rapture puzzle. Prince Charles will be 80 in 2028. Israel also will be 80 in 2028, since its creation in May of 1948. What I see as significant of Charles is in that this missing piece fits the time frame of Daniel's final 70th Week in an uncanny way. Turning 73 on November 14th Prince Charles would be 80 years old in 2028, at the time of the Second Coming of Jesus Christ.

Prince Charles is the Antichrist, although most of the Christian community will not know this on a larger scale. Even the Bible alludes to this mystery of Mr. Big. I used to think that Katherine Austin Fitts was referring to Jacob Rothschild, but since she is a Bible-believing Christian, I think she is referring to Prince Charles. Most of the Bible prophecy voices are afraid to touch this topic. I have addressed this subject many times and provided the evidence in a number of articles. Interestingly, Israel had one of the largest delegations to the meeting in Scotland this past weekend. The meaning of that begs answers in what Prince Charles may have discussed with Naftali Bennett about achieving Net-Zero methane or perhaps something else for the Middle East. **Is it possible or could Prince Charles have signed the treaty with the many as part of the (COP26) global leader meeting?** I'm only speculating here as I would think the Daniel 9:27 **"And he shall confirm the covenant with many for one week....."** would get the attention of the world media! Israel will be the center of geo-politics during the "seven" year period leading up to the Second Coming. Thus it makes perfect sense for Israel to have had a large delegation at the COP26 conference.

Prince Charles turned 73 on November 14, 2021. That fact becomes an incredible piece of the larger puzzle when knowing Prince Charles is the Antichrist. This allows for Prince Charles to go public at this time frame like a missing piece of the puzzle. The kings are world powers throughout history. At present, there have been 6 world powers. These are (in chronological order): Egypt, Assyria, Babylon, Medo-Persia, Greece and Rome. The 7th king will be world government (aka, the New World Order). The man of sin, the Antichrist, is the 8th and final king and will arise out of the 7th kingdom. The “stone” referred to in Daniel 2:31-35, cut out of the mountain without hands will be the Second Coming of the precious Lord Jesus Christ in power, preeminence and prophetic fulfillment.

This is an astonishing as well as fascinating teaching in the Word of God, and an important key to understanding and unlocking Bible prophecy. **Prince Charles is the 8th king Charles of the Holy Roman Empire spoken of in Revelation 17:11;** and the Antichrist, who will be of the 7th world power according to Revelation 17:11, and he will be a part of the New World Order. I included a chart that listed the names of the other 7 king Charles in my link above to the Satanic Talmud and the Synagogue of Satan – part 6. I would add that this section of Scripture silences those who would have you to believe the book of Revelation has been changed in some way to support Christian Zionism. That is senseless trash, as Erasmus compiled the Textus Receptus Greek Text in 1516 A.D. Israel's return to the land did not even begun to be discussed until 1897 at the First Zionist Congress.

2028 minus Daniel's ***Shabua*** “seventieth week” of seven years = 2021. **Watch for Prince Charles to take his cue in the coming days as the eighth, and I believe we are likely to be Raptured out of here.** Even the elite of the world from the Queen down are worried about their loss of their power and unforeseen chaos that has come about with radical change in the global political/economic/religious system. The world is devolving in such a way that only a potential supernatural event will save humanity. Note that I am only saying “potential” here and alluding to a short-term solution of a span lasting 42 months.

I have been mulling this over in my mind frequently and I do not think that I am grasping at straws here in my suggestion that Prince Charles turning 73 on November 14th is a picture that frames the Daniel 9:24-27 scenario as the perfect fit of this piece of the puzzle into the grand picture of God's Plan for dealing with the unrepentant nation of Israel and a Godless world. Prince Charles will be 80 in 2028, as will be Israel, and at that time many believe Jesus Christ will rule and reign for a millennium, of 1,000 years. –(Revelation 20) Furthermore, in breaking down the verse into smaller thoughts, the COP26 event might have been "THE" moment spoken of in the signing of Daniel 9:27: **"And he shall confirm the covenant with many for one week:"** As noted earlier, the time element in all of the discussions between Charles and the pope, as well as the agenda laid out for the attending nations was precisely "Seven" years!

The present time frame for the "Blessed Hope" Pre-Trib Pre-Millennial Rapture has never been as promising as it is right now. The cascading events of weather extremes, seismic activity, hunger, starvation, pestilence, drought, economic gridlock of commerce, transportation logistics, global financial collapse centered on the U.S. dollar consequence effecting the entire world. UPDATE

Since posting Blessed Hope #83 yesterday, Saturday, November 20, 2021 mid-day, my intuition has been pointing me back to that Prince Charles had fulfilled the prophecy of Daniel 9:27. The first thing I did when getting up was to check how many sovereign states were at the COP26 Climate Conference. That specific information was not given a week ago. COP26 stands for the 26th Conference of Parties to the UNFCCC. The “parties” are the **196** countries that ratified the treaty plus the European Union. The United Kingdom, partnering with Italy, is hosting COP26 in Glasgow, Scotland, from Oct. 31 through Nov. 12, 2021, after a one-year postponement due to the COVID-19 pandemic.

“And he shall confirm the covenant with many for one week: and in the midst of the week he shall cause the sacrifice and the oblation to cease, and for the overspreading of abominations he shall make it desolate, even until the consummation, and that determined shall be poured upon the desolate.” -(Daniel 9:27)

It may have been presumptuous for those thinking that the Antichrist would necessarily be signing a treaty with Israel, when in fact the Antichrist is signing a treaty with the nations of the world for an altogether different reason.

The antecedent of the “He” who would confirm a covenant is the future prince who was yet to come. Some commentators suppose that the “prince who was to come” and who makes the covenant “for one seven” is the same as “the Messiah the Prince” in vs. 25. But Jesus was put to death before the seventieth week. The new covenant that was put into effect by his death and the shedding of his blood was God-given and not limited to one “seven” of years. It will never be broken.

That prince who is to come destroyed Jerusalem and the Temple in 70 AD (confirmed in Luke 21:20). His people were the Romans, not the people of the Messiah. The Romans made no covenant with the Jews after the death and resurrection of Jesus. The signs Jesus prophesied were not all fulfilled in the destruction carried out by the armies of Titus. All this shows us that Daniel’s seventieth week of years is still to come. This gives us grounds for taking the coming Tribulation to be seven years long. Most premillennialists agree. It does not tell us a reason for a covenant, we have read into the text our inferred reasons. That changed with Prince Charles actions at COP26.

Some people claim the seventieth seven of years followed immediately after the crucifixion of Christ. But the fact that the Roman destruction of the city and Temple came forty years after the death of Jesus and the fact that the Roman destruction came before the seventieth week of years show that there is a gap between the sixty-ninth

and seventieth week. Since God does not look at time the way we do (2nd Peter 3:8), it is not contrary to the way the Bible reveals things for the gap to extend to the time of the Great Tribulation at the end of this age. The ruler or prince to come fits the little horn already prophesied in Daniel 7:8, 24f. He would be an “antichrist,” a counterfeit Christ. Note that “*anti*” in the Greek primarily means “*instead of*” or “*in place of.*” He will not call himself the antichrist. He may say he is Christ or that he is the final manifestation of a long line of prophets, gods and goddesses.

In the middle of the seventieth “*seven,*” or week of years, the ruler to come will break the covenant with the Jews (possibly made with respect to a land dispute; cf. 11:39) by stopping their sacrifices and offerings in what will be a restored temple. This will be a time of trouble and distress -(Jeremiah. 30:7; Daniel 12:1). On a “*wing*” of that temple He will set up “*an abomination that causes desolation.*” This does not refer to the pagan altar and the statue of Zeus that Antiochus IV Epiphanes set up in the Temple in December, 167 BC. Jesus prophesied that this abomination that causes desolation that Daniel saw was still to come -(Matthew 24:15; Mark 13:14). Thus the Antichrist will set up that abomination in a Temple yet to be built in Jerusalem (see 2nd Thessalonians. 2:3f; Revelation. 13:14f). But the Antichrist would not last forever. A decreed end would be poured out upon him. Revelation 19 gives us the details of how that will be accomplished.

All talk?

Considering the voluntarily, non-legally binding nature of the agreements and their lack of detailed plans, the results of COP and similar meetings have often been criticized as being “all talk.” It remains to be seen whether the new commitments will lead to substantial change.

But in the words of U.S. climate envoy John Kerry, as quoted in the ‘*Washington Post*’:
“The alternative is you don’t say anything, you don’t do anything. You don’t have any promises. You don’t have any commitments. And you’re sitting there just waiting for the deluge.”

As the conference drew to a close, COP26 President Alok Sharma [said](#) that the conference had fulfilled its pledge to “*keep alive*” the hope of limiting warming to 1.5 degrees. “*But the pulse is weak. It will only survive if we keep our promises.*”

A great deal has been written and discussed about COP26 and the two week of meetings held at Glasgow, Scotland.

The top 9 decisions at COP26:

1. The Glasgow Climate Pact
2. No coal by 2040 or 2050 – for some countries
3. An end to many overseas fossil fuel projects
4. A pact to protect the world’s forests

5. Fossil fuel cars sales will be massively cut from 2035
6. China and the US will work together
7. Methane faces the axe
8. India grudgingly joined the climate fight
9. Sustainable agriculture became a genuine aim

Prince Charles gave the keynote address at COP26, and having listened to his address three times, it is evident that he is deeply frustrated with the way the nations of the world are dealing with the perceived issue of climate change.

Relative to what I have stated in regards to Israel and Prince Charles, turning 80 in 2028, and Prince Charles style of consensus style leadership, it seems uncanny and somewhat mysterious that the Bible prophecy was fulfilled last week and few if any recognized its significance. I would not expect it to raise eyebrows in the largely amillennial Christian community but I thought others in the Pre-millennial Pre-Trib Rapture Bible-believers would be awake to what I have been inferring over the past few Blessed Hope articles.
