The Mark of the Beast via the MERSCorona Virus.

This Blessed Hope is focused upon the **“Big Picture”** of Covid-19. Although it is very comprehensive, it represents the agenda that was unleashed on the world on October 31, 2019. The Plan appears very close to what has played out over the past two years. The release of the Covid hoax was not due for three years. The Antichrist New World Order team was unable to provoke a war between China vs. U.S. on their planned time frame, thus forcing them to go the next phase. The globalists made serious mistakes and in their arrogance they blew their cover and now the world is in push back in a huge way. Clif High and Ben Fulford both confirmed that war plan fizzled. Not that it was not close or still on the agenda, it simply did not occur on their timeline but merely delayed their plan.

Otherwise, there are certain points that have not fully been hatched. Some of the points would not have been fully understood last year, not at least until what has been taking place from the lock downs to detainment camps such as in Australia; mandatory vaccines such as in Austria; total lockdown for the unvaxxed in Germany. Failure to provoke a war between the two largest countries does not mean they will abandon that portion of the plan. Even as current as today we can see signs of their ramping up for an EMP attack using their Klub-Kar container box missile system launched from a cargo vessel at sea.

Last year the CEO of Pfizer made a statement that has had my attention for months. He said *“That they had broken the Code of Life”*. I am a lone “Watchman” at this sight but at the time I heard him say that on a video clip, I saved it but did not follow up on it to clarify what he may have meant. I thought I had a good idea of what that was but let it stay in the back of my thoughts. “Breaking the Code of Life” is referring to the human genome. “¹²How art thou fallen from heaven, O Lucifer, son of the morning! how art thou cut down to the ground, which didst weaken the nations! ¹³For thou hast said in thine heart, I will ascend into heaven, I will exalt my throne above the stars of God: I will sit also upon the mount of the congregation, in the sides of the north: ¹⁴I will ascend above the heights of the clouds; I will be like the most High. ¹⁵Yet thou shalt be brought down to hell, to the sides of the pit.”—(Isaiah 14:12-15)

When the Human Genome was fully mapped in 2003, at a cost of three billion dollars, scientists wasted no time in getting around to launch into their “Holy Grail” objective to use the powers of science to extend life to an age of 120 years and ultimately towards immortality. In 2003, I did a pulpit-supply three-Sunday series on this passage of Isaiah 14. Basically, I knew it meant that God would never share His Creative powers with man even through modern science. I saw it as “crossing the Rubicon.”

‘Crossing the Rubicon’ is a phrase made famous by Julius Caesar, when he rebelled against the authorities of the Roman Republic and seized power for himself. The Rubicon River in northeastern Italy marked a provincial boundary of the Republic. As military commander, Caesar had authority over his legions north of the Rubicon, but legally had to surrender that authority south of the Rubicon. In crossing the Rubicon and not relinquishing authority, Caesar was passing the point of no return. He would either become emperor or be executed for treason.

If you are my age, mid-80s, you might have noticed how the world began falling apart in 2005 and following. As a student of history, world stability, social cohesion, and culture improvement, all has been in what we recognize to be as spiraling downwards. People today have overcome a heap of obstacles. Man has crossed mountain ranges, traversed oceans, and attained the icy poles of our planet. We have made it to the bottom of the oceans and the peaks of the highest mountains. We have even begun to vanquish that monstrous barrier of space. But as far as attaining spiritual heights, as far as reaching what truly makes us happy, I think we as the human race are further away than we have been for a very long time. This is a fact in the gender confusion and the insanity of the LGBTQP chaos caused everywhere. School districts in many states have adopted same-sex bathrooms or have begun the process.

For most of you CRISPR might mean the quality of your chicken at KFC or the French fries at your favorite steak house. The CRISPR-Cas9 System has enabled man to play god or at least put the mad scientists on a par with God! The technical term states:

CRISPR is a ubiquitous family of clustered repetitive DNA elements present in 90% of Archaea and 40% of sequenced Bacteria. The 300-500bp (base pairs) leader located upstream of CRISPR loci is a conserved, AT-rich sequence, and is considered a

promoter of CRISPR array. CRISPR array consists of repetitive sequences (repeats) interspersed with several variable sequences (spacers). Repeats are typically 21–48 nucleotides in length with the potential to form hairpin structures. The variable spacer sequences in CRISPR array are derived from previous invading mobile genetic elements (MGEs), e.g. bacteriophages and plasmids. Prokaryotes with CRISPR-Cas9 immune systems capture short invader sequences within the CRISPR loci in their genomes, and small RNAs produced from the CRISPR loci (crRNAs) guide Cas proteins to recognize and degrade (or otherwise silence) the invading nucleic acids. Complete genome sequencing studies showed the presence of common sequences flanking the multiple CRISPR loci in multiple prokaryotic species. Comparison of the genes that flank the CRISPR loci in the genomes of different species showed a clear homology among those genes, which was later designated as CRISPR-associated genes, Cas. Cas genes encode proteins with a variety of nucleic acid-manipulating activities such as nucleases, helicases and polymerases, and are often located adjacent to the CRISPR region. In laymen's terms, it simply means you can create designer babies, edit, add, and remove DNA, to life in general!

By 2002, over the next few years, CRISPR-Cas9 technology has been rapidly and widely adopted by the scientific community to target, edit, and modify the genomes of a vast array of cells and organisms while elucidating and refining the mechanism of CRISPR-Cas9 library genome editing. CRISPR-Cas9 has been harnessed for applications in screening for drug targets, human gene therapy, and pathogen gene disruption. The technology is still classified "Experimental" but it has already been let out of the box, unofficially so to speak!

The CRISPR / Cas 9 system was first exploited by Danisco in 2008. The company used it to improve the immunity of bacterial cultures against viruses and many food manufacturers now use the technology to produce cheese and yoghurt.

Key among gene editing technologies is a molecular tool known as CRISPR–Cas9, a powerful technology discovered in 2012 by American scientist Jennifer Doudna, French scientist Emmanuelle Charpentier, and colleagues and refined by American scientist Feng Zhang and colleagues. What you may not know, however, is that the CRISPR mechanism was originally discovered back in the 90s by a particularly humble microbiologist, Francisco Mojica, Professor at the University of Alicante.

The use of CRISPR–Cas9 to edit genes was thrust into the spotlight in 2012 when the team of George Church, Jennifer Doudna, Emmanuelle Charpentier, and Feng Zhang harnessed it as a tool to modify targeted regions of genomes. Given its potential to revolutionize gene editing, Science named CRISPR Breakthrough of the Year in 2015.

In a world first, CRISPR, the powerful gene-editing tool that can "cut and paste" DNA, and has been used inside the human body for the first time. CRISPR is able to find its way into those cells and correct the gene — a cut-and-paste scenario that sees a tiny

DNA edit made to remove the mutation. If you grasp this you will understand why CRISPR is of great importance in the quest for the “Holy Grail” ~ “Immortality!”

Covid was a huge global experiment, and humanity is the “lab animal test subjects.” It will explain many of your unanswerable questions. Covid has many facets, all of which created confusion to the world’s best scientists. Think of it as a set of multiple experiments wrapped up into an enigma that was labeled a “novel rogue virus”. Humanity is considered expendable and so there was no real concern regarding its collateral damage. The weekly reports at Robert Kennedy’s Children’s Defense Fund “Defender’s” page presents the VAERS victim data of adverse reactions, deaths, and public pain! But what the public is unaware of is what those many lab experiments at play contained in the unknown contents of the various vaxxes really mean aside from their health.

It has been my initial belief that Covid-19 was originally released as a “Depopulation” Eugenics program, and I still believe that to be the case. However, I suspected that there were multiple agendas involved that were piggybacked onto the larger plan which muddied the waters in offering explanations. We are lab animals for the Artificial Intelligence Transhumanism project, testing how much Wi-Fi the human body can handle through **5G**. We have been exposed to Graphene Oxide, spike Protein (PEG), Polysorbate 80, and other pathogens which can be inserted to test the human body for many things such as load limits, tolerances, etc.

It was the Indian scientists that in March, 2020, discovered that 18 fragments of the HIV1 genome and 4 fragments of the SARS2 genome had been inserted into the Covid-19 virus with “surgical precision”. As the 2005 Nobel Peace Prize Laureate Dr. Luc Montagnier confirmed the Indian scientist’s findings, the virus had been inserted with 92% of the equivalent of the HIV1 virus; not enough to kill you immediately, but enough to make you ill over a period of months until you died from a depleted immune system in maybe a car accident or any number of innocuous death events. Months ago I learned that it was Dr. Death, Anthony Fauci who pressured the Indian scientists to withdraw their paper from the scientific literature, or they might not ever again receive NIH grant funding.

As Dr. Judy Mikovits will tell you, Dr. Fauci will destroy your career if you cross him. Dr. Judy Mikovits is on public record that 55-millions who are vaxxed are likely to die, as a result of having the unknown XMRV gene in their bodies. The XMRV gene dates back to the Swine flu epidemic of the 1970s and corruption of the blood supply during the HIV-AIDS period of the 1980 at a time when the nation’s blood supply was not screening out blood donations by drug addicts and homosexuals. Dr. Mikovits estimates 55-million Americans will die because of the spike Protein in the vaxxes will cause the immune system to attack their own bodies because they have the XMRV gene in their blood, which can pass from mother to child. Dr. Mikovits accuses Dr. Fauci of trying to cover up for his past crimes by requiring everyone to be vaxxed with

any of the four major Covid-19 vaxxes being given. Dr. Mikovits has written most recently her two book *'Plague'* and *'Plague of Corruption'* and her story of Dr. Fauci and the XMRV gene. This is just one of a number of thread plots to what we are faced with labeled as the euphemism of Covid.

The chief benefactor of Dr. Anthony Fauci and most of the world health agencies, academic research labs is none other than Mr. Microsoft himself, Bill Gates, and supporter of Planned Parenthood and Eugenics fame. Bill Gates has given China and Chinese universities millions to do work banned in the U.S. The Bill and Melinda Gates Foundation have reportedly sent \$54 million to fund "global health" projects in China since the outbreak of COVID-19. This includes major sums of cash to institutions controlled by the Chinese Communist Party (CCP), as well as collaborators of the Wuhan Institute of Virology. 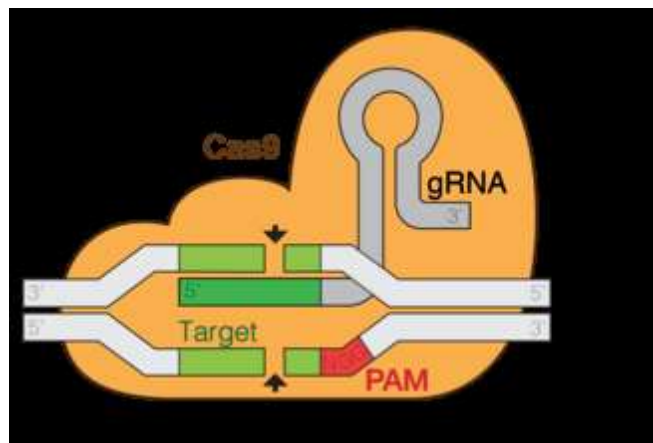

Covid-19

- **Definition: A virus is a submicroscopic infectious agent that replicates only inside the living cells of an organism.**
- **Previously, there have been 7-8 prior coronavirus strains such as MERS, SARS.**
- **COVID-19's genetic sequence was generated by scientists in January, 2020, which documented that CRISPR gene technology was used to perform genetic editing of the coronavirus virus cell at its DNA level.**



CRISPR (clustered regularly interspaced short palindromic repeats)

CRISPR gene editing is a genetic engineering technique in molecular biology by which the genomes of living organisms may be modified. It is based on a simplified version of the bacterial CRISPR-Cas9 antiviral defense system. By

delivering the Cas9 nuclease complexed with a synthetic guide RNA into a cell, the cell's genome can be cut at a desired location, allowing existing genes to be removed and/or new ones added in vivo. -Wikipedia

Although, the 4 inserts represent discontinuous short stretches of amino acids in spike glycoprotein of 2019-nCoV, the fact that all three of them share amino acid identity or similarity with HIV-1 gp120 and HIV-1 Gag (among all annotated virus proteins) suggests that this is not a random fortuitous finding. 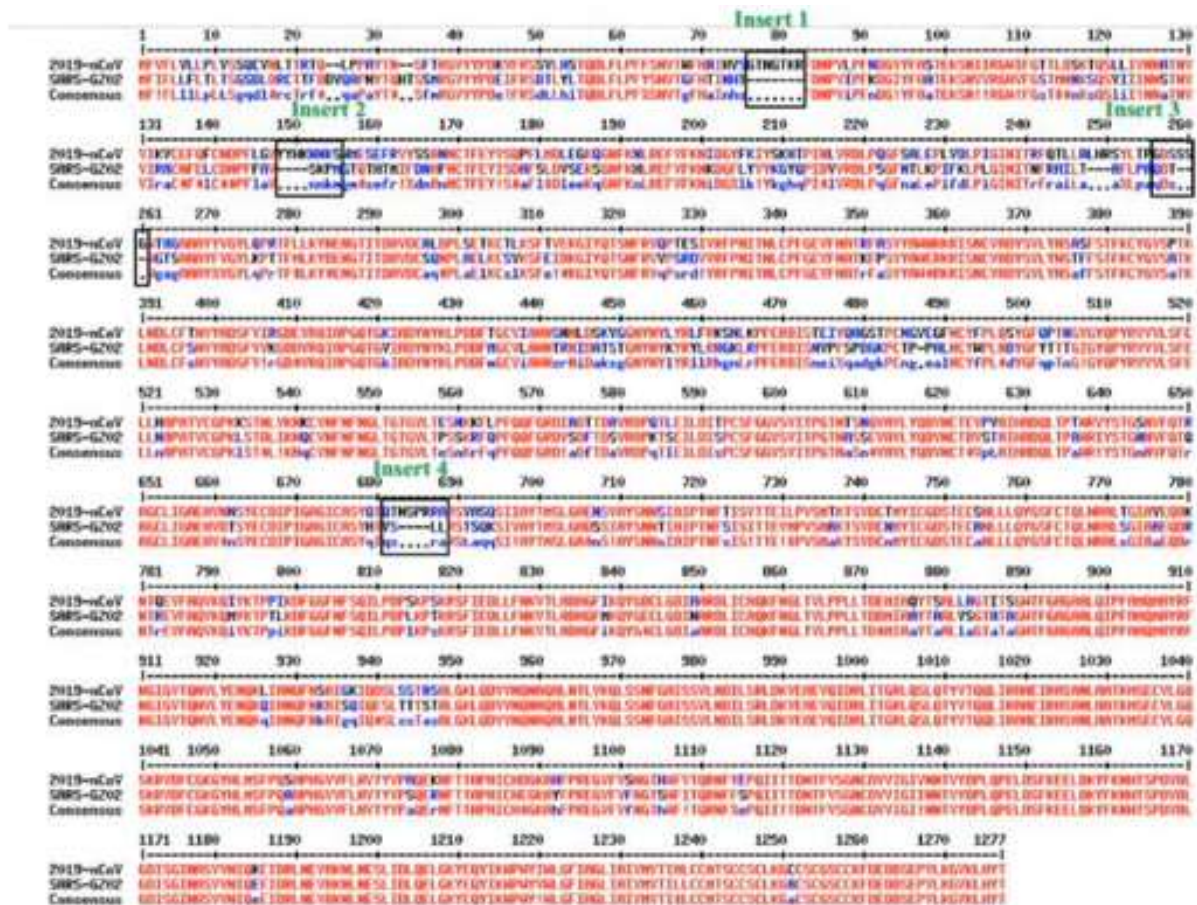


Figure 2: Multiple sequence alignment between spike proteins of 2019-nCoV and SARS. The sequences of spike proteins of 2019-nCoV (Wuhan-HU-1, Accession NC_045512) and of SARS CoV (GZ02, Accession AY390556) were aligned using MultiAlin software. The sites of difference are highlighted in boxes.

Because of this, COVID-19 qualifies and is considered to be a "man-made virus."

- Therefore, it is essential to understand that COVID-19:

- Is not a “regular virus”;
- Is a modified RNA virus; Genetically Modified Organism (GMO)

Messenger RNA

Messenger RNA (mRNA) carries copies of instructions for assembling amino acids into proteins.

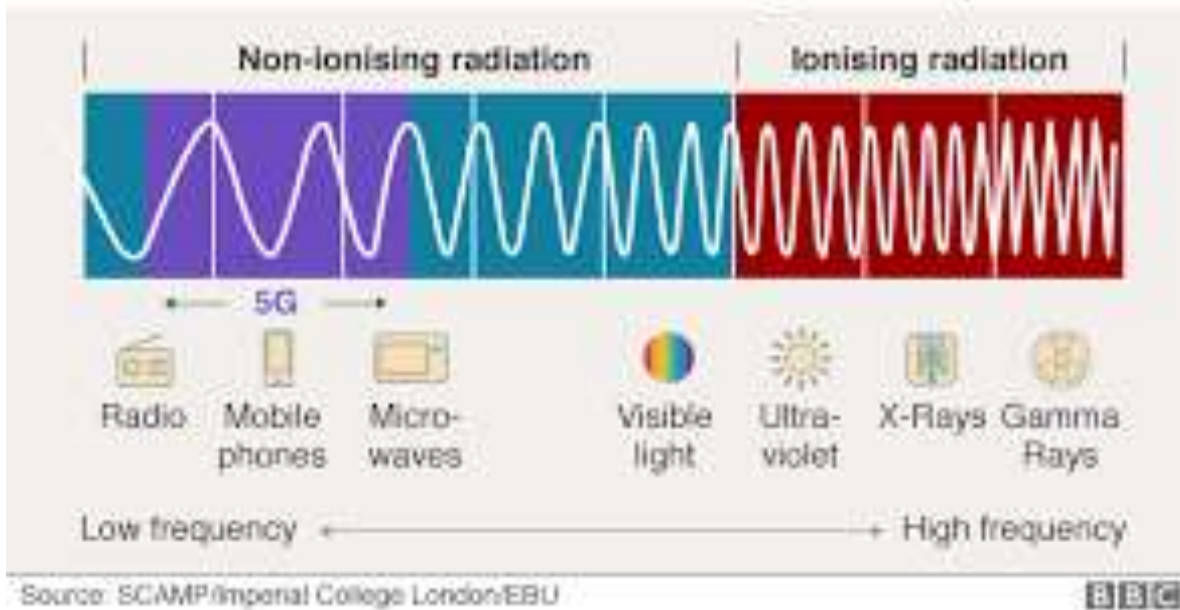


In other words, one may sporadically expect a fortuitous match for a stretch of 6-12 contiguous amino acid residues in an unrelated protein. However, it is unlikely that all 4 inserts in the 2019-nCoV spike glycoprotein fortuitously match with 2 key structural proteins of an unrelated virus (HIV-1). -Prashant Pradhan et al. (2020).

Therefore:

- The vaccine that is to be used to fight against COVID-19 infection cannot be a "regular vaccine."
- But must be a DNA-modified vaccine to attack at the DNA level of the virus.
- The problem is that if you take a DNA-modified vaccine, your DNA will be changed / altered. As an example, put a few drops of food coloring in a glass of water to understand what has just happened. There is no way of going back to any separation of the two liquid substances.
- The media is predicting a 2nd wave of the COVID-19 infection:
- The important challenge for DNA vaccines is getting the body's cells (DNA) to accept the introduced genetic (DNA) material, which is why 5G-related technology is needed to cause the opening of the cell to allow / force the DNA modified vaccine in.

Where 5G fits in the electromagnetic spectrum

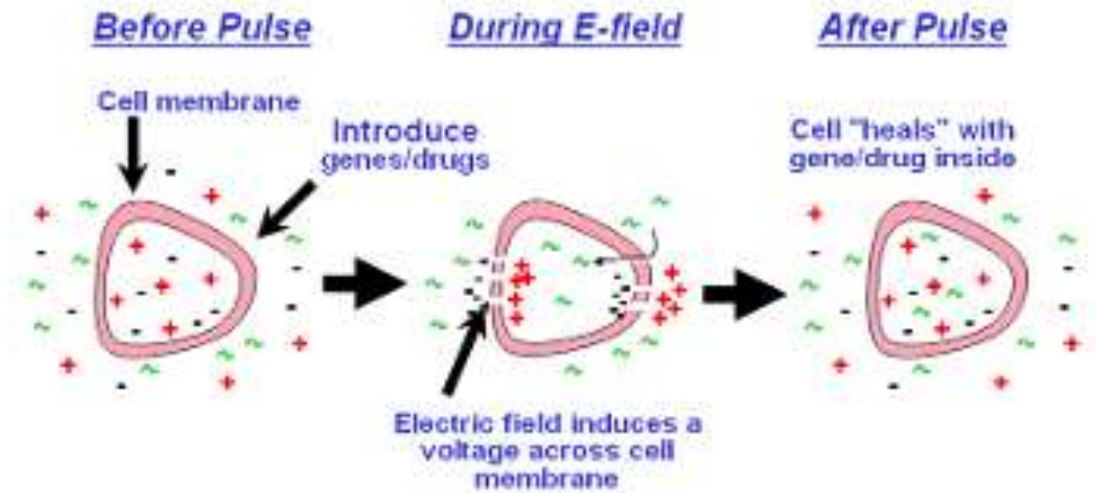


DNA Vaccine:

- The difference between a “regular” vaccine and a DNA-modified vaccine is that a genetically-modified vaccine allows the technical system to have access to the body’s cellular (DNA) level.
- The vaccine contains DNA biological components that will affect a person's DNA to the extent that it will modify / change a person’s DNA;
- DNA vaccines change DNA by inserting foreign DNA into the host body
- The most effective technique is electroporation, which delivers short pulses of electrical current to the person with the vaccine (i.e., via **5G**).
- The electricity creates temporary access to pores / openings in a person’s cell membranes, enabling the DNA to enter.
- Currently, no DNA vaccines have been approved for human use, but several are now on "fast-track" in humans (Phase 1 trial) due to the COVID-19 pandemic.
- Outstanding questions/concerns about DNA vaccines:
 - Chronic inflammation; Triggering of autoimmune responses;
 - Activation of cancer-causing genes;

- Problems with DNA replication; Mutations.

Vaccine Tattoo: (Patent) - Patent Excerpt : (The present invention provides a live, attenuated coronavirus comprising a variant replicase gene encoding polyproteins)"

Image #1. Microneedles are developed based on the fangs of a viper:

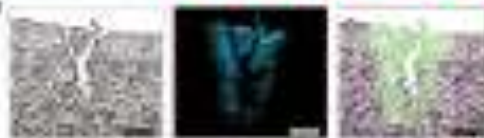
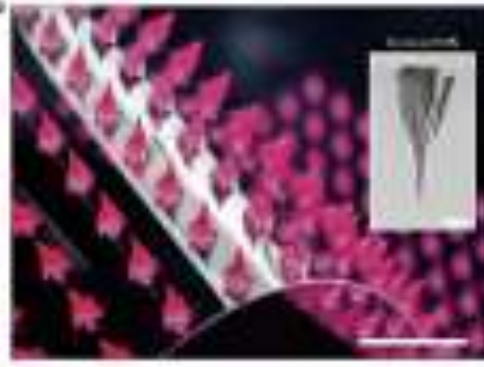
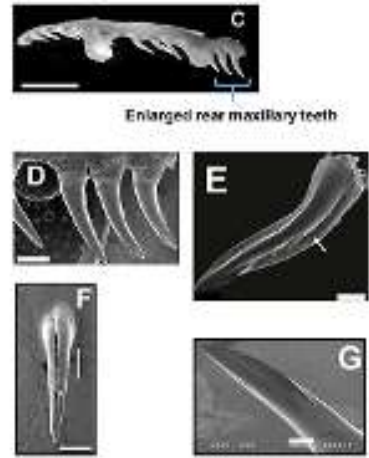
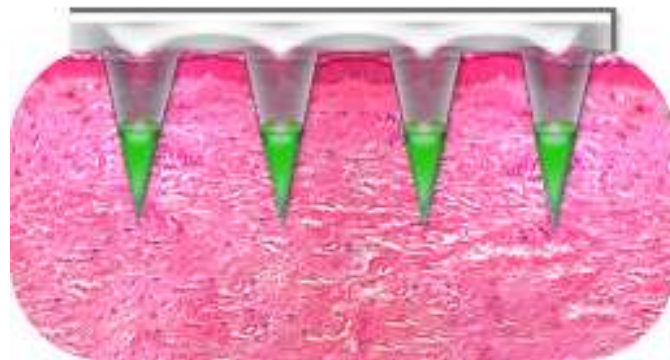


Image # 2: Three views showing as microneedles are being inserted and then



dissolved:

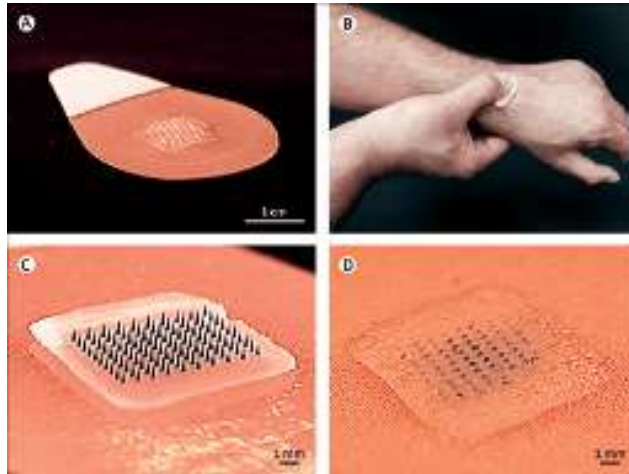
- 1st view shows the microneedles about to be applied to the skin;
- 2nd view shows how the microneedles are in the skin;
- 3rd view shows that the quantum dots are delivered through the hollow microneedles, which are now dissolved (needles disappear).

The DNA-modified vaccine administered via the microneedle patch does not require any temperature control management for storage and shipping.

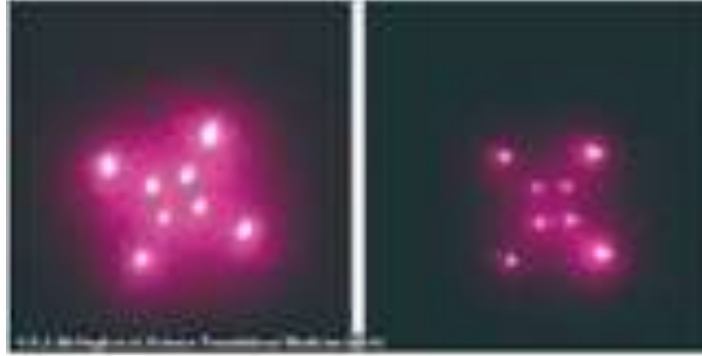
- Therefore, it is easily distributed by the U.S. Postal Office, Amazon, and Fed Ex.
- It can be applied by anyone, even at home; not even a child would mind having a “band-aid” applied.

Quantum dots:

- The microneedles deliver the quantum dots via the vaccine into the body.
- The quantum dots are not visible on the surface of the skin to the naked eye.
- The quantum dots are composed of nanocrystals and are only visible when scanned by near-infrared light (i.e., iPhone, Android application)
- The pattern of light displayed by the quantum dots is unique to each person, just as with a fingerprint pattern.

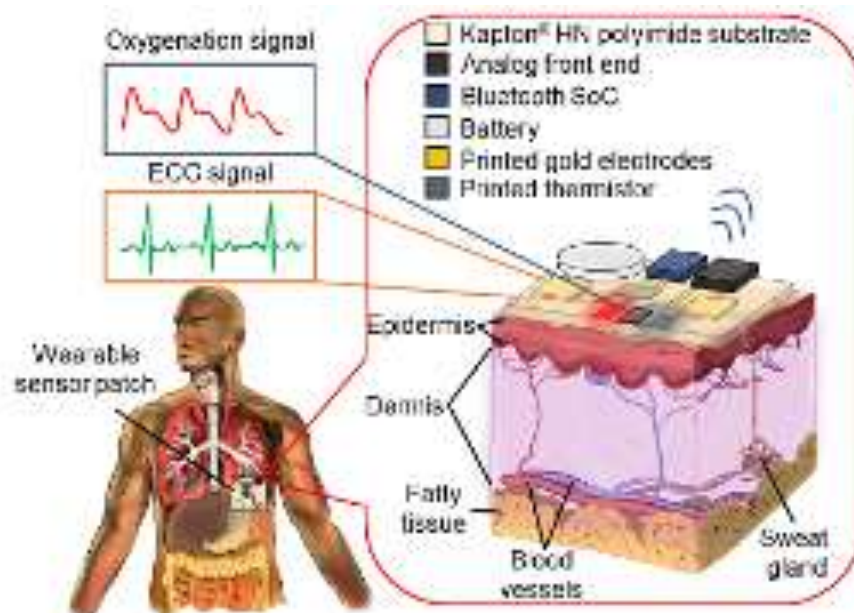
Note: This unique identifier is referred to as the **"Mark of the Beast."**

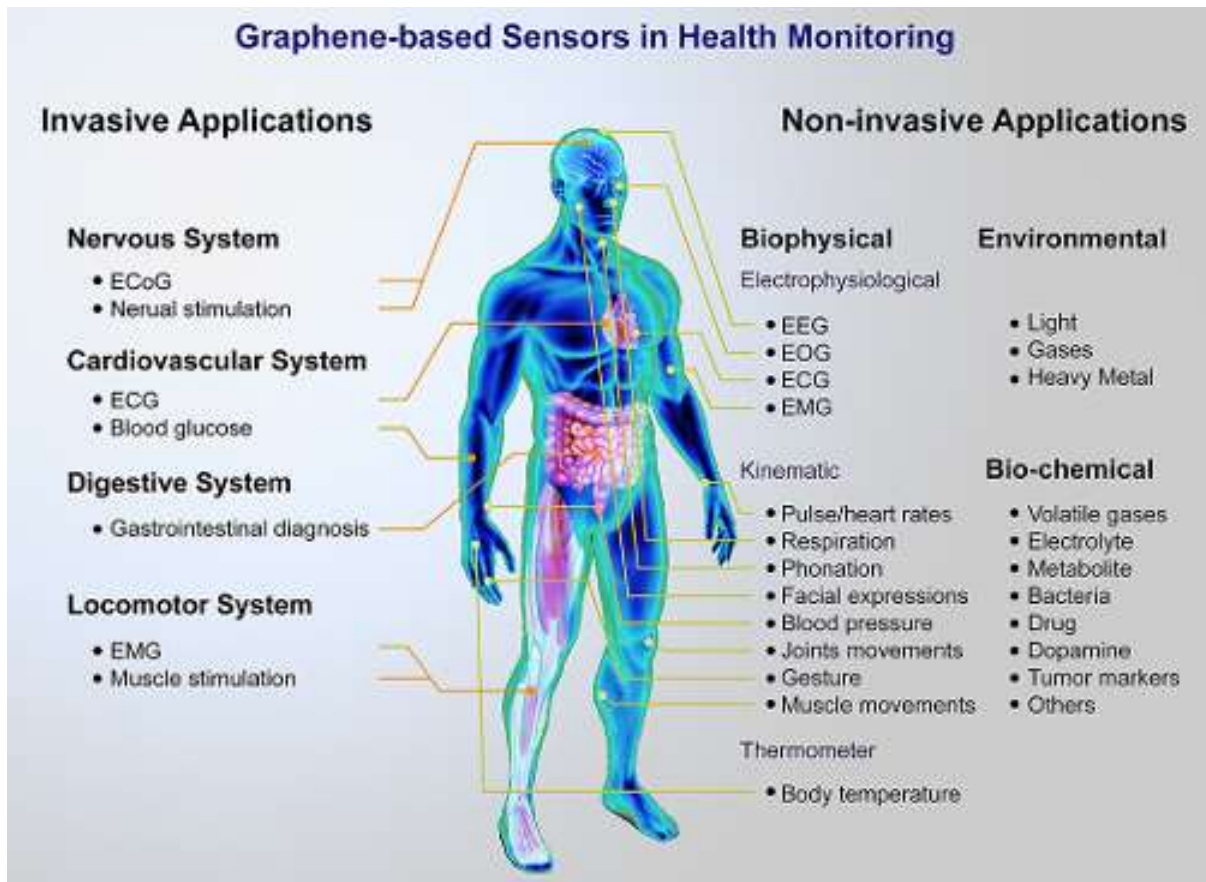
- Image #4: Shows the near-infrared beam of light displayed over the area of the quantum dots that are now embedded below the surface of the skin; Appears like an “X” (purple coloration - called “Luciferase”). The bioluminescence is like the biochemical emission of light by living organisms such as fireflies and deep-sea fishes. It is invisible to the human eye but when scanned by an infrared scanner becomes visible to the operator.



Vaccine Tattoo: (General)

- There are several names used: Vaccine Tattoo, Medical Dot Tattoo, Quantum Dot Tattoo, Microneedle Array Patch, etc.,
- For this document the term vaccine tattoo will be the common reference.
- This unique identifier has the ability to monitor the body internally continuously, as well as the person's behavior and mental state.
- It contains a DNA modified vaccine, which will change the DNA of the recipient without even the person's knowledge.





Vaccine Tattoo (Function)

- The vaccine tattoo functions to deliver / administer the genetically modified vaccine;
- It functions as an “on-record” identifying that you are who you say you are;
- The vaccine tattoo serves as an “on-person” vaccination / medical history record;
- It provides documentation detailing the type of vaccine given, which administered it; verifies that change occurred within your DNA; etc.;
- The vaccine record is to serve as a “certificate of proof”, allowing a person to go about freely, (work, school, travel, etc.).
- It functions as a tracker: Surveillance; Facial recognition; Remote sensing devices.

Vaccine Tattoo (Location)

- The tattoo / patch will be applied to either the hand / or forehead;
- This is a matter of personal preference and convenience:
- Currently, people are having their temperature taken before allowed into a building (shop, school, mall) and the forehead is used for easy access;
- A person wearing protective equipment (i.e., gloves) would have to pull back the glove to expose the hand and would choose the forehead.



5G: (General)

- **5G** is used to connect everything; sometimes referred to as the “Internet of Things”;
- **5G** will be used to trigger (forces the insertion of) the DNA derived vaccine through electroporation (opening the pores briefly) into the body's cell membranes.
- This "triggering" by **5G** results in changes at the body's DNA level without a person even knowing. This means that the person is connected to the “hive mind”.
- **5G** is the mechanism used to link the vaccine tattoo to the cloud.

- **5G** technology is used, among things, such as directed energy weapon; Phased-array weaponry such as crowd control; Contact tracing, Social distancing.

Once the vaccine tattoo is applied, it becomes the only proof of record that the vaccine is embedded in the skin; This is verified through interrogation by **5G** (i.e., phone app)

- It's Important to understand that:

- A person's full medical history will not be inserted subcutaneously;

- A person's complete medical information and all other private data will be stored in cloud-based server farms containing blockchains;

- The "tattoo" acts as an antenna to receive / send **5G** signals;

- Through the transmission of **5G** wave signals to the cloud, which is then transmitted to the blockchain, and it allows blockchains to verify the information.

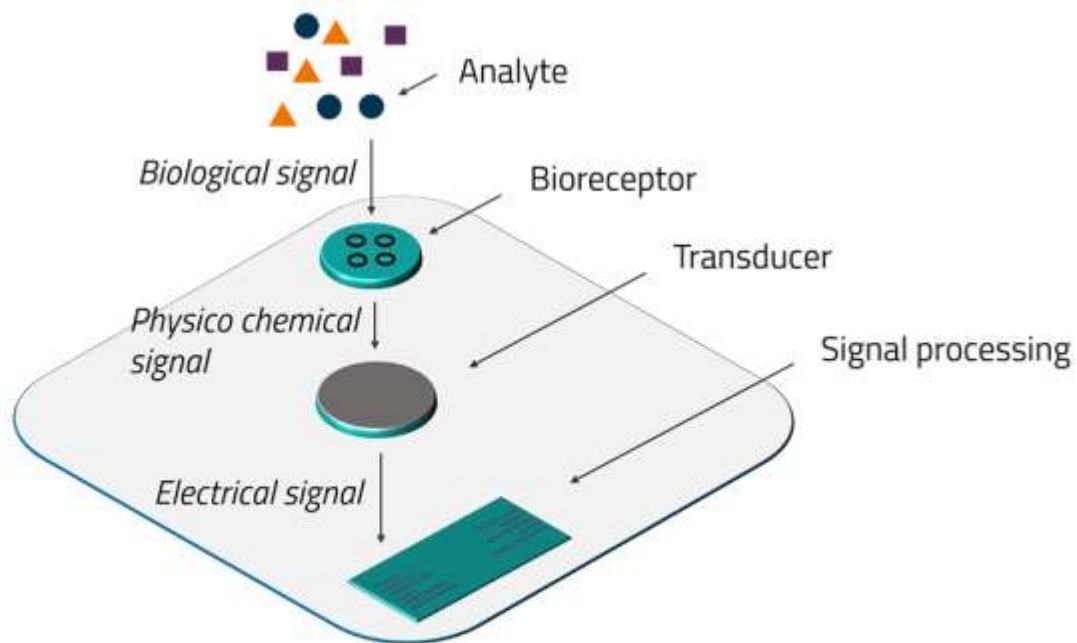

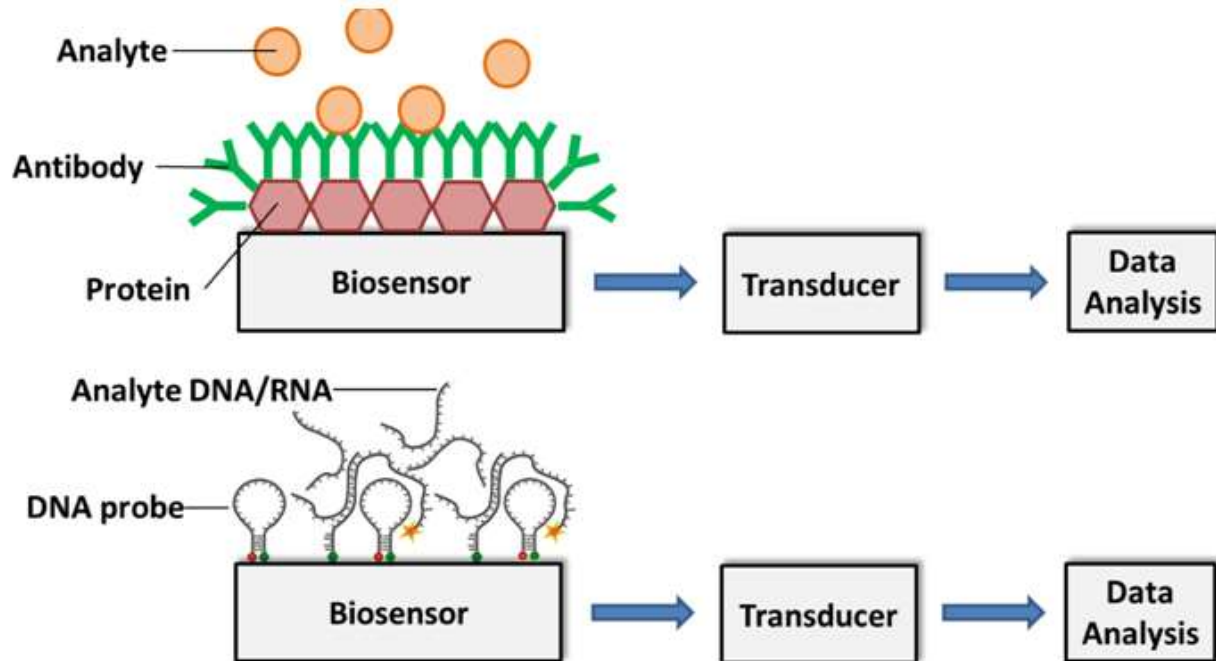

Biosensors:

- **Definition:** A biosensor is an analytical device used to detect a chemical substance that combines a biological component with a physicochemical detector.
- Biosensors, which are administered along with the vaccine, become fully embedded and fully part of a person's DNA.
- Biosensors are placed throughout the environment send results to the cloud.

ID 2020 (Digital Identity Alliance):

- **Goal: To create universal digital identities for everyone in the world, the entire population, without which the controlled population cannot access goods and services**

- **Embedded in this tattoo is digital technology that records and verifies that a person has received the vaccine.**

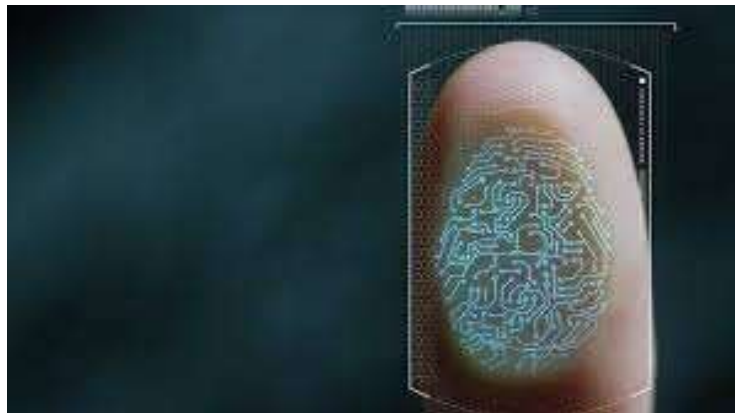
- The microneedle array / patch / tattoo: Meets the requirements of ID 2020.
Blockchain:

- A blockchain is an append-only public ledger to which anyone can write and read.

- At the core of the blockchain is a consensus mechanism that allows nodes to agree on changes to the ledger, while ensuring that changes once confirmed cannot be altered.

- Blockchain technologies are gaining popularity due to public indoctrination promoting privacy, security, convenience and distrust of mainstream banking systems.

- All of your **medical, personal, and financial information** become linked to the blockchain system.

- **Definition:** Cryptocurrency is a digital asset designed to work as a medium of exchange using cryptography to secure the transactions, to control the creation of additional units, and to verify the transfer of assets. Cryptocurrencies are classified as a subset of digital currencies and are also classified as a subset of alternative currencies and virtual currencies. Bitcoin was the first Cryptocurrency to be introduced as a “store of value” and used between individuals, companies, and financial institutions.

Background:

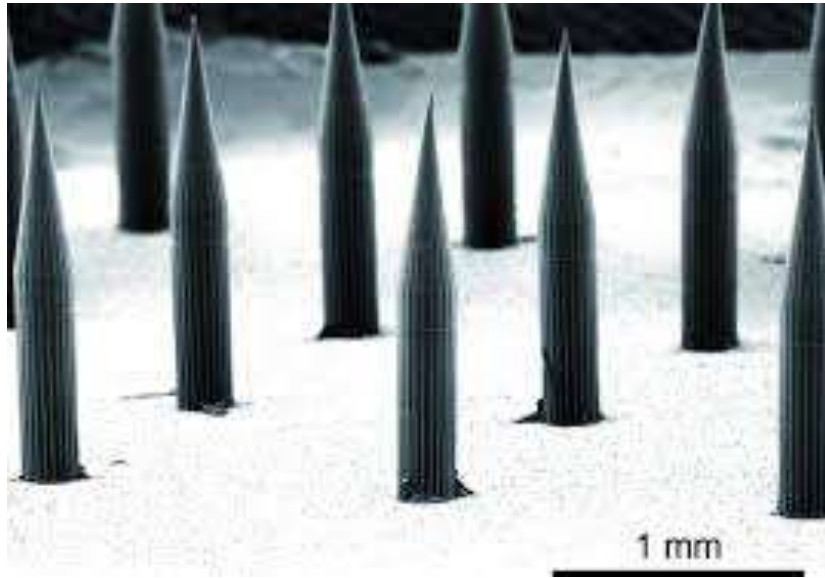

The Vaccine tattoo is multi-faceted: Physical; Mental; Spiritual.

- One cannot separate the physical from the spiritual.
- The spirit world affects our physical world, and our physical world is only temporary.
- Taking the DNA-modified vaccine alters the focal point of what makes us who we are:
 - Physically: Our DNA comprises the infrastructure of our body:

4,000 Giant-Sized 5G Antennas Proposed for NYC; Opposition Grows

Recently in late November, 2021, health advocates have learned that 4,000 enormous new 'Jumbo' **5G** antennas, on giant monopoles, have been proposed for New York City streets in 25 different zip codes throughout Manhattan, Brooklyn, Queens, Bronx and Staten Island, starting in more disadvantaged areas. Queens-based non-profit Wireless Broadband, Inc, as well as Manhattan Neighbors for Safer Telecommunications, and other local and national groups are protesting.

Despite growing awareness of biological and health risks from the radiation emitted by cell phones, wireless devices and wireless infrastructure, and of wireless technology inadequacies to close the 'digital divide' (as is claimed), or to

meet the growing demand for broadband capacity, wireless antennas in New York City are still rapidly going up all around us.

The new Jumbo 5G antenna structures planned for City streets, each containing multiple antennas, on multiple tiers, are starting to raise big questions.

What does it mean to “**Throw the Switch?**”

- Globally there is now a big push for **5G**, which is part of the infrastructure of the beast system. The goal is 100,000+ satellites by 2025.
- Not only are they accelerating the deployment of **5G**, but they're getting ready to throw the switch.
- Once the vaccine, along with the biosensors, has entered the body via the quantum dot tattoo, they are dispersed throughout the body.

- It's the Mark that we must not take - If we don't have the tattoo / mark; God will provide for us; God will take care of us.

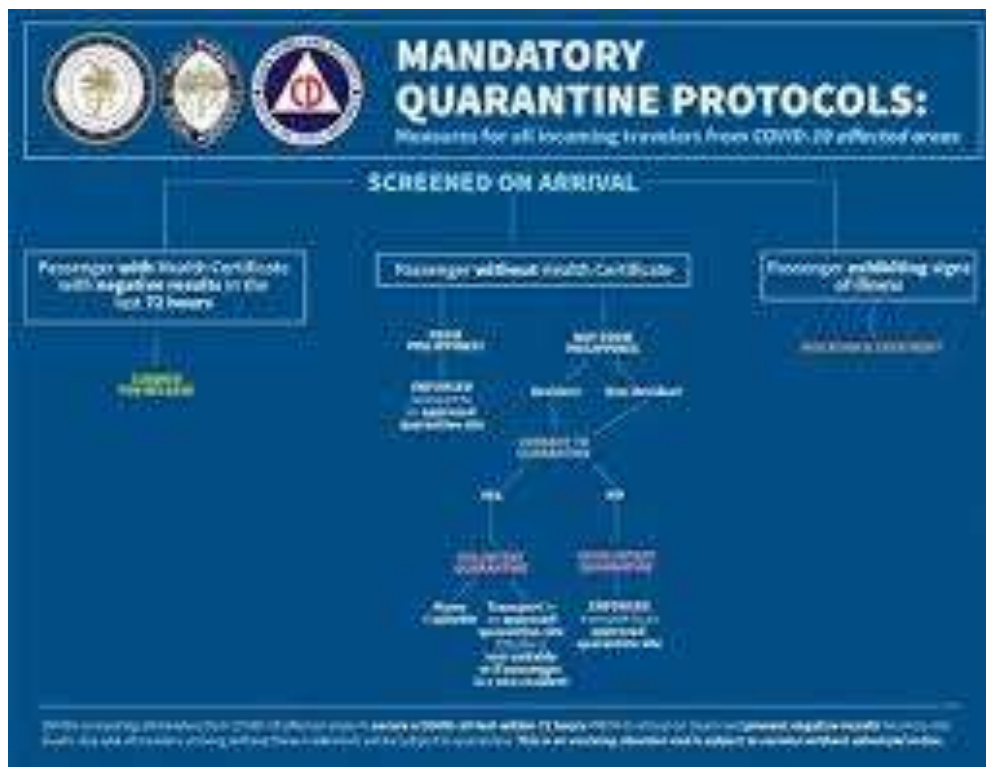
- DNA samples are easily obtained:

They've predicted that about 70% of the U.S. population, and about the same percentage in Europe, is going to disappear by 2025. It's hard to believe that anybody in their position would make a forecast like that. There's no logical business reason for it, especially since it was done before the COVID hysteria gripped the world. It stretches a reader's credulity.

Could it possibly happen? It would be the biggest thing in world history. Does it have a basis in reality, or is it just some bizarre trolling exercise? I'm not sure—it's hard to take almost anything from any source at face value these days. But for the last several years, I've been saying that World War III would basically be a biological war. Of course, it will have substantial conventional, nuclear, space-based, and AI/computer elements as well, but its most serious component will be biological. Essentially, it will involve the use of bacteria and viruses to wipe out the enemy. The odds are that it will be between the US and China. But since anyone with a CRISPR in their garage can hack the genome and DNA of almost anything and anybody... there are no limits to the possibilities.

Certainly, from the Chinese point of view, a biological war makes all the sense in the world. That's because the Han Chinese share a lot of genetic similarities. Presumably, a bacteria or virus can be bred to favor the Chinese and take out most everybody else. The fact is that anything that can be done eventually will be done. It's just the law of large numbers.

Somebody might respond, "Well, that's horribly racist." Of course it's racist. Notwithstanding rational and philosophical arguments against it, all ethnic groups and countries are quite naturally racist. A fear of different racial and ethnic groups has been bred into humans, as a survival mechanism, over the hundreds of thousands of years since we became biologically modern.

All races and ethnic groups like to think that they're "the best" or the most worthy, and that non-members are "other", perhaps only marginally human. Biological warfare plays directly into feeling.

Americans who—like everybody else—see themselves as "the good guys", believe we're immune to that. However, don't forget that the U.S. pioneered modern biowarfare. Fort Detrick, Maryland, has been an epicenter of it for over 70 years, and there are undoubtedly many other more clandestine sites where US government agencies are working on biological warfare. No doubt the Chinese and other major powers are working clandestinely as well. It's not something anybody wants to advertise for many reasons.

What shocks me is not that a biowar is being researched or even actively war-gamed, but that a connected organization like *Deagel* is actually saying it publicly. It's not like what goes on in the spook community is an open book.

Deagel doesn't explicitly say what, exactly, will cause the great die-off. But there are many advantages to biological warfare over other types of warfare, so it will probably be featured. It's probably inevitable, now that the technology has made it practical.

What are the advantages of biowar? What might war gaming generals like about it?

- First, it doesn't destroy materiel. That's a huge plus. After all, what's the point of conquering a country if all you have to show for it is a smoking radioactive ruin? That's the major advantage of the neutron bomb, of course; it kills the people but limits damage to buildings. Bioweapons essentially make atomic weapons obsolete.
- Second, bioweapons can be structured to attack only certain racial groups. That's potentially either a big advantage or disadvantage to China. The diverse population of the US could also be either an advantage or a disadvantage, depending on who strikes first. But, on the bright side, you can perhaps immunize your own population, or at least the military and "essential" workers, to control the damage.
- Third, bioweapons are very cheap and easy to fabricate. Anyone with access to a good high school chemistry lab is in business. There's no need for expensive and tricky U-235 or, for that matter, any of the junk toys the Pentagon spends hundreds of billions on.
- Fourth, bioweapons don't need sophisticated delivery systems; again, no need for B-2s, B-52s, cruise missiles, ICBMs, or any of that. A sick tourist or two, or a few packages sent in the mail, can get the job done.
- Fifth, bioweapons, whether they're viruses or bacteria, not only offer plausible deniability but the potential to blame a third party. You can launch an attack, and nobody can really be sure who did it. Or even that an attack is, in fact, being launched.

There's every advantage to biological warfare from an aggressor's point of view. And, the aggressor doesn't even have to be a nation-state, which is, of course, another excuse for governments to further clamp down on their populations, as COVID has shown. Guns are good self-defense weapons, and governments are trying to eliminate them; basement biowar labs are strictly offensive. Imagine the bureaucratic enforcement possibilities.

Scripture reassures born-again believers:

- **Per my interpretation of Scripture, the restrainer will be removed prior to the Antichrist and 7-year tribulation -(2nd Thessalonians 2:6).**

7 Key Facts About the Mark of the Beast

The Bible uses only a few words to describe the mark of the beast money system. But that description gives us an amazing amount of information. Here are just seven of the things it teaches us.

Number One — The system will be global. Revelation 13:7-8 says, ***“authority over every tribe and people and tongue and nation was given to him [the Antichrist]. And all who dwell on the earth will worship him.”*** The mark of the beast will be tied to his authority and will be part of the worship people give him.

Number Two — The mark will be required by law, and no one will be exempt. Revelation 13:16-17 says that the False Prophet ***“causes all, the small and the great, and the rich and the poor, and the free men and the slaves, to be given a mark on their right hand, or on their forehead.”*** Wealth will not buy an exemption, and neither will poverty.

Number Three — Some will reject the mark despite the law. At the time of the rapture, the dead in Christ will be resurrected into new heavenly bodies and caught up to meet the Lord in the air. Those in Christ who are still living will change. Their mortal bodies will change into immortal, heavenly ones. After the rapture, others will turn to Christ. These post-rapture followers of Jesus will be distinguished in part by the fact that they will refuse the mark of the beast. Revelation 20:4 says, ***“I saw the souls of those who had been beheaded because of the testimony of Jesus and because of the word of God, and those who had not worshiped the beast or his image, and had not received the mark upon their forehead and upon their hand.”***

Number Four — The mark of the beast will be the culmination of a great deception. Revelation 13:14 says the False Prophet ***“deceives those who dwell on the earth because of the signs which it was given him to perform in the presence of the beast.”*** This deception leads directly to the mark.

Number Five — Satan will empower the mark system. Daniel 8:24 makes this intriguing statement about the Antichrist. ***“His power will be mighty, but not by his own power.”*** We find that verse explained in Revelation 13:2. ***“The dragon gave him his power, his throne, and great authority.”*** Revelation 12:9 and 20:2 explains that the dragon is Satan.
