The Mystery of Iniquity

"For the mystery of iniquity doth already work: only he who now letteth will let, until he be taken out of the way." -(2nd Thessalonians 2:7)

I love to do word studies, and particularly word-phrases; over the past twenty years I did extensive computer analysis of Scripture like in my study of the "sevens" and how God distributed, sprinkled them throughout the Bible. One of those very unique applications is the "word-phrase" that occurs in patterns of "seven" or "multiples of seven" hidden throughout the text of Hebrew, Greek, and English. It is likely more interesting when one finds a word-phrase that appears in plain sight but as a unique single reference. I suspect that is due to the fact we have nothing to compare a single reference with as how it might be used elsewhere. We are left to draw our own conclusions.

I thought it is important enough and worth looking at as we are closer than ever to the Rapture as signs everywhere are converging in ways that validate our understanding of Dispensationalism. Prophecy scholars such as Bill Salus, Ed Hindson, Hal Lindsey, Dave Reagan, and many others have noted "convergence" of signs, events, are confirming the Rapture is near.

The many contradictory views on this verse (2nd Thessalonians 2:7) emphasizes how little anyone knows. Some interpreters of the "historic school" have held that the masculine "he" refers to the Roman emperor, others the apostle Paul, and still others the popes who stepped into the gap after the fall of Rome. Modern post-Tribulationists may think the withholding power is "law and order." Most Pre-Tribulationists hold that the neuter form of verse 6 and the masculine form of verse 7, the power and character which "withholdeth" the Antichrist, is the Holy Spirit.

Some pre-Tribulationists believe the power is the Christian Church. During this age the Holy Spirit works through believers, whose bodies are His temples. As a unit, believers comprise a temple of the Spirit -(1st Corinthians 3:16; 6:19). Thus the masculine words of verse 7 are thought to refer to the "gathered" believers who are caught up in the Rapture.

At least this much is clear: this passage speaks of a power and/or a person strong enough to withhold Satanic influences, so the man of sin cannot be revealed as long as this power is at work in the world. The times in which we are living suggest strongly we are talking about the Holy Spirit exclusively.

When this restraining influence is removed, the Antichrist, that wicked or lawless one, will immediately be revealed. One world leader at the UN Climate Change Conference COP26 a World leader just acknowledged the existence of the Coming World Ruler--the antichrist and revealed pertinent information concerning his role and his connections to... If you read my work, you already know who this man is and truly represents the "Mystery of Iniquity" at work in the world. But even at that very time his doom will already be sealed. When He comes in flaming fire (1:7, 8), Jesus will consume (destroy) him with the spirit (breath) of His mouth. The way Jesus will destroy the Wicked One parallels the actions of the Lord Jehovah in Isaiah 11:4: "He shall smite the earth with the rod of His mouth, and with the breath of His lips shall He slay the wicked." (See also Revelation 19:15.) One word from the Lord is all it will take. Just one word!

Two closely related words are used to describe the coming of Christ, *epiphaneia* ("appearing") and *parousia* ("coming"). That *epiphaneia* was used in the Septuagint to describe an epiphany or revelation of God -(2nd Samuel 7:23; 2nd Maccabees 2:21; 3:24). It was used in Hellenistic Greek to describe visits from emperors and other dignitaries (*New Century Bible*, 43:200). It was also applied to Jesus Christ's first coming (see 2nd Timothy 1:10). *Parousia* is the common term used to describe the second coming of Christ.

The very brightness of Christ's coming, a glory which blesses the believers, will help bring violent destruction to the Antichrist and his armies.

To the people who do not know the Antichrist is doomed, his coming will seem supernatural. It is also called a "coming" (*parousia*, presence). It will be according to the working or energizing of Satan in all sorts of deeds of power, miraculous signs, and amazing wonders. But all these will be lies. ("Lying" applies to all three. See John 8:44.) Satan will use these signs and lying wonders to get the attention of the people of the world.

These false signs and wonders will entice those who make pleasure or money their god. The Antichrist will tempt them with every kind of wicked deception. The connotation of this ties it in with the seduction that comes from wealth -(Matthew 13:22), sin -(Hebrews 3:13), reveling in deceptive pleasures -(2nd Peter 2:13), and every kind of deceitful lust - (Ephesians 4:22). This seductive deception will be effective in those who are *already* perishing, lost, gone astray, already on the broad road leading to their destruction - (Matthew 7:13).

Satan's false signs will also deceive those who did not welcome the love of the truth that they might be saved. That is, they did not become real disciples of Jesus but continued to follow their own ways. (Compare John 8:31, 32.)

"Saved" here does not refer to conversion, however, but to the salvation and inheritance which will be believers' when they are changed into Christ's likeness.

Because they have no love for the truth God will send them a strong, deluding influence. Bruce says that "a power is set in operation within them which makes them prone to embrace error" (Word Biblical Commentary, 45:174). This will lead them to "believe a lie" (literally the lie, not any lie that happens to come along, but the big lie, the false claims and pretensions of the Antichrist). A principle example today are those who in world health who have sold out medical science for bribes by the Rothschild's.



A week or so ago, Jacob Rothschild took personal credit for the Covid-19 "bioweapon" being executed in bringing down the world's economies. Henry Makow, a Canadian Jewish writer attracted the attention of Jacob Rothschild a number of years ago, and Henry Makow began sharing those verbal conversations on his web page.

The result will be that all who have not welcomed the love of the truth will "be damned" (judged, called to account, and condemned). The first and most important ground for their judgment will be the fact that they did not believe (and obey) the truth. Second, they took "pleasure in unrighteousness." They approved, considered good, took delight in, and sought satisfaction in wrongdoing, injustice, wickedness, and evil. In other words, they kept going along with sin, considered it normal, and promoted it as desirable. Strong delusion is already making many believe that those who practice the works of the flesh can still be acceptable to God.

But the Bible clearly warns that "they which do such things shall not inherit the kingdom of God" -(Galatians 5:19-21). God expects believers to cultivate the fruit of the Spirit and crucify the flesh with its affections and lusts or desires -(Galatians 5:22-24). Those who do not do so will be well prepared to accept the Antichrist's false claims.

Satan's lies have never been as effective as they have been since March of 2020. The director of the World Health Organization declared a pandemic on March 11, 2020. WHO director general Tedros A Ghebreysus addressing President Biden re-engaged with the WHO early in his presidency following the Trump administration's announcement that it would be terminating the U.S. relationship with the organization. At the time, Trump cited the WHO's handling of the pandemic, its purported pro-China bias and subsequent failure to enact reforms.

When the Biden administration rejoined in January, Dr. Anthony Fauci said that Tedros was his "dear friend." Tedros reportedly referred to Fauci as "my brother Tony." While the U.S. didn't nominate Tedros, 28 countries including France and Germany did. Unusually, his home country did not back him. Ethiopia was unwilling to give him its blessing due to accusations of him taking sides against the sitting government as the threat of a civil war grows in the African country. Tedros, who is not a medical doctor, had previously served as the Ethiopian health and foreign minister. Tedros is another bureaucrat of the UN body, backed by the CCP and Xi Jinping.

The Apostle Paul did not dwell long on the deceptions of the Antichrist. God has not only chosen that believers be brought into ultimate salvation where they will be changed into Christ's likeness -(1st John 3:2), He has also chosen the means to bring them to this goal. They only reach the goal through a continued sanctification by the Spirit and a steadfast belief of the truth. The Holy Spirit consecrates believers and separates them from sin, and at the same time He separates them to God and to obedience to His will. He also gives help and power to live a holy (dedicated) life. The believer's part is a continued faith in the truth, a faithful, obedient acceptance and practice of the truth.

Joining the Zoom conference (watch below) as a doctor, Chetty began by asking the following questions:

"I think the perspective around what is happening is vitally important. We need to understand what the aim is. Everyone knows that there's **inconsistencies**, that there's **coercion**, but we need to understand why. **Why is it there?**"

Although Dr. Chetty does not use the Biblical words of the Apostle Paul, most certainly he believes it is consistent with the thinking of the "*Mystery of Iniquity!*" at work in the 21st century.



He then identified the "most important" answer to these questions, the "pathogen that was causing all the death in COVID illness," the spike proteins common in both the vaccine and virus designed to be produced in a recipient's body.

"In my opinion of what's going on in the world, the spike protein is **one of the most** man-made toxins. And the purpose of this toxin is to kill billions of people without anyone noticing," he went on to add.

"What looks like transpired here, [is] they've engineered a virus and put this weapons-grade package onto it called 'spike protein."

The allergic reaction with the initial release of the "most elaborately engineered toxin," occurs in a small number of people, **resulting in more severe cases and death when the vaccine is administered**. According to Chetty, this usually happens eight days after the onset of symptoms.

Doctors say that due to the first 14-day international shutdown, people with the COVID-19 virus that caused it were arriving late to the hospital, and these facilities "to engineer death and damage in order to stir all the fear." [sic]

"But the game that they played with this engineered virus was to justify the vaccination of the planet," he continued.

Chetty added that these injections "expose us to the spike protein for a longer period."

"I often interview doctors online, and Dr. Pierre Kory, Ryan Cole, and Richard Urso have described how long a health risk begins to occur after death from an allergy in the first two weeks."

"We begin to see the **endothelial [blood vessel lining] injuries** that this vaccine causes with its spike protein, with its influence on its ACE2 receptors. **Those are the deaths that are meant to follow. And they will never be pinned onto the spike protein**, a very well-engineered toxin," he said.

"Now the spike protein is also a **membrane protein**. So, the mRNA will distribute this throughout our body. It will be made in various tissues around our body. It will be incorporated into those membranes around our body, and those specific tissues."

"Those tissues will be recognized as foreign and will **trigger a host of autoimmune responses**. So, the deaths that are meant to follow the vaccinations will never be able to be pinned on the poison! They will be too diverse, there will be too many, and they will be in too broad a timeframe for us to understand that we have been poisoned," he went on"

"Now this toxin in the **long term** is going to get people **with pre-existing illness to have those illnesses exasperated**," the doctor explained.

With some toxins, including "bits of HIV protein" within this "definitely engineered" spike protein, Dr. Chetty states "people with cancers are going to have their cancers flare up, and they will say they died of the cancer."

"People with vessel injuries or predisposition like our diabetics and [those with] hypertension are going to have strokes and heart attacks and the rest at varying times, and we'll attribute those to their pre-existing conditions," he said.

"People are going to develop, over time, autoimmune conditions, the diversity of which will never be addressed by any pharmaceutical intervention because they're far too targeted."

"But I think if people understand what the intention is, then they'll understand why what's happened has happened. The ill logic, the coercion, the suppression, is all warranted if you understand that there is a bigger plan.

This plan is to make sure that we can control and kill off a large proportion of our population without anyone suspecting that we were poisoned," the COVID specialist said.

"And so, I think the justification for everything we see is warranted in understanding the endgame," he concluded.

"I think there's a huge picture at play; otherwise the vaccines make absolutely no sense. We were sold the vaccine as our savior from the start, and if we look at the science, the science does not play out."

In this reflection on the "mystery of iniquity" I sense it coming from one of Satan's kids and forthcoming unveiling to the Antichrist's chief cheerleader!

The word around the Vatican is that they are quietly preparing for a conclave to elect a new pope. Whispers of Pope Francis is dying have been circulating in the corridors of the papacy. Furthermore, Gizzi asserts that sources inside the Vatican do not expect Francis (Jorge Bergoglio) to see the end of next year, 2022, and are in "pre-Conclave mode". A diagnosis has not been revealed or rumored, but colon cancer would be a possibility, considering Bergoglio's colon surgery back in early July. At the time, some in the Vatican expressed concern that this surgery had not been announced days or weeks in advance, as would have been customary.

Cardinal Peter Turkson is my spot-on replacement suggestion to watch. Peter Turkson is an African citizen of Ghana. Peter Kodwo Appiah Turkson is a senior ecclesiastical leader and the first Ghanaian Priest Cardinal to serve the Roman Catholic Church. Before being elevated to cardinal by Pope John Paul II, he was appointed as the Archbishop of Cape Coast. There are many reasons that have led me to the view that he is likely to replace Pope Francis. I have followed Archbishop Peter Turkson since 1975 when he graduated from St. Anthony Hudson Seminary in Renssealer, New York and his humble background and self-deprecating personality. Turkson will be quite comfortable with the "Sustainable Development" agenda of Prince Charles and the Klaus Schwab "Great Reset". What Pope Francis lacked in personality, Peter Turkson is abundantly blessed with in a persuasive charm and disarming demeanor. He and Prince Charles will evoke a huge deception that will be exhibited by the Antichrist and his False Prophet! The duo play well to what Scripture has to say about them.

Without doubt the Antichrist and his chief cheerleader will be an extremely charismatic, persuasive, cunning and deceptive individuals, a silver-tongued orator, and will be a perfect combination of a religious, political and economic leader/dictator.

Once I heard the Pope Francis might not live another year, Peter Turkson immediately came to mind, and you can expect Cardinal Turkson to be on a "short list" of candidates, I believe he will be elected on a first vote of the Curia gathering. Francis turns 85 this month and Peter Turkson is only 73 if my memory is correct. His parents were of an interesting religious mix, his mother was a Methodist and his father a Roman

Catholic and he has lots of siblings. Peter Turkson's name will become as common as Prince Charles of Wales. I would not be surprised if Pope Francis finds it a necessity to retire due to his recent surgery and developing cancer.

In responding to a question about a document U.S. bishops are drafting about Communion that critics fear could be used to deny the Eucharist to some politicians, Cardinal Peter Turkson said, "The Eucharist should not in any way become a weapon." In the interview, Cardinal Turkson, who heads the Vatican's Dicastery for Promoting Integral Human Development, said that denying the Eucharist should be used in the most extreme cases.

"If you say somebody cannot receive Communion, you are basically doing a judgment that you are in a state of sin," the cardinal said.

When asked specifically if he thought Communion should be denied to President Joe Biden, Cardinal Turkson said, "No."

Obviously, the "Mystery of Iniquity" is at work in the inner sanctum of the Vatican as well as its headquarters of Jesuit Georgetown University in Washington, D.C. Secrecy cloaks the crimes and corruption of the recognized voice of the false prophet.

Wars and rumors of wars continue to dominate the news media on the three global hot spots noted in a previous Blessed Hope.

Israel vs Iran

The Joint Comprehensive Plan of Action (JCPOA) Joint Commission met in Vienna last week with members of the G4 +1 group and the European Union to discuss the lifting of sanctions on Iran, with no apparent results or agreements. The sides are slated to meet again on Thursday.

The Biden administration is seeking to re-engage Tehran in talks on a new nuclear agreement, while Europe is seeking to salvage the one signed in 2015, which the U.S. under former president Donald Trump had left.

However, both European and American top officials have expressed frustration over lran's willingness to engage in the negotiations in recent days, indicating that Tehran's proposals are not realistic and hinting at other options in case Tehran does not change course.

In related news, the Israeli Air Force (IAF) has begun preparing in recent days for a military exercise that will include dozens of Israeli fighter jets and will simulate a comprehensive attack in Iran, 'Kan News' reported Wednesday.

The wide-scale drill, scheduled to begin in the spring of 2022, will take place over the Mediterranean Sea and will simulate actual conditions and distances required for

carrying out airstrikes on Iranian territory. We know they have been doing these drills for months so spring is seen as disinformation. The "*Mystery of Iniquity*" is well at work in this theater of conflict.

In August IDF Chief of Staff Aviv Kohavi said that the IDF had begun <u>developing</u> <u>operational plans</u> to strike Iran's nuclear facilities. Don't be surprised if that time frame is a lot sooner. Iran and Syria apparently have inked a deal where Iran will help Syria build a nuclear reactor.

China vs Taiwan

On the Asian front, previous reports about China's Evergrande collapse has been formally confirmed. This is fraught with apocalyptic implications. The coming weeks will see a collapsing stock market as much as an 80% decline in value. This will ratchet up the drums of wars. The Evergrande default result will be a huge Contagion risk will spread to crypto, institutional investors, pension funds and more.

The question has loomed over China's Evergrande Group for months: Is the world's most indebted developer too big to fail?

Investors finally have their answer. With a flurry of announcements that sent Evergrande bonds tumbling to record lows this week, the company and Beijing have made it clear that billionaire Hui Ka Yan's property giant is headed for one of China's largest-ever debt restructurings. There are nearly a dozen other Chinese property developers that are widely believed to be on the path to default. "This is not just a default of Evergrande, this is a default of China and the banking system," Dan David told Fox Business this morning.

Evergrande's public share price plunged on Monday, just one business day after Evergrande issued a letter stating it could not sustain its debt repayment schedule.

Importantly, Evergrande is prioritizing domestic debt holders in China and has been ordered by the Chinese government to bail on overseas debt holders. This means any non-China holders of Evergrande debt are going to be lucky to eventually get paid 10 cents on the dollar for the Evergrande paper they hold. More likely, they will get next to nothing. China has simply confirmed you can't "Trust" China and they do not honor their word!

The singularity of officialdom's narrative collapse is here, censorship is off the charts and Clif High says that we've now entered a period of increased novelty (aka "events") that won't trail off until sometime in February. The Evergrande default will take months to be felt around the world as investors, pension funds, and banks determine what they will experience in losses. There is no collective figure available to determine how many institutions are involved and to what degree they will be burned. Look for many more bankruptcies to ensue, both the near and distant future!

EVERGRANDE & DOLLAR DEATH

Clif says that Evergrande is now defunct and owned by the CCP, indicating that the Powers-that-Be are no longer able to maintain the Petrodollar financial system that has ruled the world during our lifetimes. The global elite have for all intent and purpose achieved their objective of destroying the Chinese empire and the U.S. empire.

Clif says, "The U.S. dollar died with the Evergrande. The willingness of the CCP to take the U.S. dollar was the last thing that was propping-up the 1971 Petrodollar. The Evergrande dying off means that they can no longer afford to take worthless dollars for anything they do..." China can no longer be "trusted" and the same goes for the U.S.! Henry Makow reported a few days ago that Jacob Rothschild admitted they created the Covid virus hoax to destroy global economies. Henry has been dialoguing with Jacob Rothschild, the titular head of the House of Rothschild. Henry lives in Canada but he gets a lot of viewing by the Zionist Jews headed up by the Rothschild's who owned the 189 central banks of the world.

"The ability of the central banks to control things is gone now," and the central banks will not be able to survive this bond crisis, because the deflationary trend is juxtaposed against an organic hyperinflationary trend. To grasp this, think of a string of dominos falling as each one hits the next, etc. The CCP Evergrande debacle represents as much as a half-trillion dollars in bonds, perhaps a trillion if all the derivatives are factored in at the end of the falling domino effect which can bring down the global financial system.

He explains that we're in now a deflationary environment, driven on the one hand by the restructuring of Evergrande by the CCP and on the other hand by the escalation of the vaxxine die-off.

He notes that the die-off is neither ubiquitous nor uniform and that certain geographic areas, such as those surrounding Silicon Valley are being spared, while other areas are seeing two and a half times as many people dying per month as during this time last year, many of them elderly because they were the ones vaxxed first.

"The die-off is moving up. This is deflationary. All of those people that are dying are not sucking up resources anymore; they're not competing for resources, so there's no pressure on prices relative to them..." The CDC expects the die-off to be 800,000 for 2021. Several doctors have said Dr. Fauci's recommendations resulted in the murder of a half-million. I'm reading Robert Kennedy's new book 'The Real Dr. Fauci' gets to the heart of why Dr. Fauci is directly to blame for the die-off. The book contains 2,200 foot notes that indict Dr. Fauci.

Deflation, basically in a financial system means there's weakening demand and a consequence of that is falling prices. The central bankers can't have deflation. But the genie is out of the bottle and out of control.

Clif High describes how when faced with a similar scare in 1932-1933, Roosevelt consulted with the central bankers in London and proceeded to seize the gold from American citizens.

He explains how hyperinflation is a function of resource deprivation and how hyperinflation in prices can come about from either the hyperinflation of the currency, which reduces its purchasing power; or it can come from too many people rushing at a limited-supply item and bidding up the price, which may partially explain Joe Biden's deliberate destruction of U.S. energy independence and his deliberate collapse of the supply chain. Canadian analyst Robb Kirby told Gregg Hunter, the U.S. Dollar is in stage 4 cancer yesterday. I've warned family that are vested in the stock market to cash out now but I doubt they are smart enough to see the hand writing on the wall.

THEY DON'T GET TO NUKE SEATTLE & AUSTIN

"They wanted to have a war, they wanted to kill off billions of humans, in order that they could get us into this Great Reset that monster, Klaus Schwab says that 'You will own nothing and you will be happy.' They wanted all of this. This was necessary."

"They didn't get their war. Trump and the Self-Organizing Collective screwed them over and they didn't get their war. Hillary Clinton was not allowed to destroy Seattle, she wasn't allowed to destroy Austin with nuclear weapons and claim it was the North Koreans at the behest of the Chinese and that 'we lost the war."

"They weren't able to do that. Obama didn't get to take our guns, so all of their plans are really getting messed up and now, they have to deal with stuff that had been set in motion when they were certain that Hillary Clinton could not lose."

"So Evergrande's current situation <u>originates from Obama's time</u>...and it built up a giant mass of financial instruments that were supposed to be used by the Chinese to seize most of Australia and seize other parts of other countries in a giant bond debacle – not the bond debacle that we've got now – but a different kind that would be relative to the created hyperinflation that they knew that they would be able to engineer after Hillary had destroyed a couple of cities in the United States, after Obama had seized all the guns and the CCP could say they 'won the war against the United States' and our Constitution was no longer valid and that we had to live under their rules and they would have just come on in and invade it."

"We'd be just like Australia. We'd have no guns to repel them. It would be a terrible situation. But that didn't happen. Universe doesn't want that sh*t to go down, in spite of the fact that the CCP does not grasp this and the Globalists don't grasp this..." Clif High thinks systemically, and can see the long-term effects much like a chess player seeing 4 moves away from where he sees the chessboard. I would bet Clif is a chess player himself.

CCP CANNOT SEIZE OUR ASSETS

"The Evergrande bond debacle that the CCP is in now is different from what they had anticipated. In the one that they'd anticipated, those people that had taken currencies – loans, in essence – would be seized; they'd have all their properties seized. As the...borrower failed, the lender would seize the assets."

"Now, we have a situation where the lenders' bonds are not being able to be paid. So all the investors outside of China are screwed. CCP is simply not going to pay them..." The consequence of this is investors around the world have lost all trust in China, a quality that is a must requirement in global finance.

"They've already been hardening China, in restricting access and bringing their people home over the last 4 months, 5 months, in a very accelerated fashion, that tells people like myself that they knew this day was coming and they needed to harden things up, because they're literally going to use force – navies, armies, etc. – to say, 'F* you. We default,' to all the foreign investors that had pumped-up the Evergrande."

"This is going to have some consequences that are going to be very far-reaching. Some nations may decide to send warships to China, because they're so desperate to seize assets from China, once the bonds default."

"But now, the CCP will not be able to seize the farmlands and the lands of Australia. If they want it, they'll have to invade it, because they won't have any legal claim to it, as they would have in this other scheme..."

HYPERINFLATION & A RETURN TO HARD CURRENCY

"And so the deflation here is going to prompt the remaining central banks; the Chinese central bank, the Federal Reserve, the Bank of London, the Vatican Bank...all of these banks are going to have to pump for hyperinflation like you would not believe, because of the amount of deflation that we're going to get from the Evergrande debacle."

And all of this hit the cryptocurrency market, causing them to tank relative the U.S. dollar price notation. Walmart's falling prices may soon break records at your local Walmart, and not because your local Walmart store can't move product. It could be taken down from the waves Evergrande spread around the world.

"So the message from the deflationary event that we've got going on now is that we're moving into a world of solid, hard currency. In a solid, hard currency world, everything changes."

For example, Clif High says that in a solid, hard currency world, you would have to give gold or silver to people to get an airplane go pick up people in Haiti to take them to our Southern Border so that they could sneak over and invade the U.S., because these pilots will no longer do that for U.S. dollars. So this kind of activity will no longer be happening.

"So many people and institutions will not be taking Chinese currency or U.S. currency...[that] those countries that have resources will be able to grab those resources and say, 'F* you!' to China and their quasi-legal claims, through the phony bond markets."

"This is also going to hit the derivatives, it's going to crash banks, it'll hit real estate globally, massive deflation in real estate globally, as a result of this, pockets of hyperinflation as the currency goes thrashing around, here and there, in response to what's going on, both the die-off and the machinations of the CCP and the other central banks, trying to create more hyperinflation, because that's all they've got."

"If they can't kill us off in a war and then reset the economy as a result of that, then we're all looking at them, as the purchasing power of the dollar drops, as the purchasing power of the yuan – of all currencies – drops to nothing, we're all looking at the central bank, saying 'OK, F*ers, you better open up that vault and give me some of that gold, or we're going to come and take it!'

REVERSAL OF FORTUNE

"Basically, over the course of the next few years, this right here [Evergrande and vaxx die-off] is the end of the financial system. It's the end of the Globalists..."

"They're going to do everything they can to repair this situation ...It won't work...This is usually the time that we get into the wars."

"1932-1933, note what was happening in Germany, as the bond crisis swept through the globe and caused this depression situation to go on. Germany was in the position of Australia. Germany had owed debts that were put on them by being the loser of the war." Clif is referring to the reparations issue imposed upon Germany at the Treaty of Versailles. The Rothschild agents controlled the events to settle war claims and the levied reparations placed upon Germany at Versailles. The impossible reparations provided the reason for World War II to break out!

"Had that would have happened to the United States. We would have had 'reparations' that we would have had to pay to China for some 'sin' that we'd done to them."

"Now, it's reversed...China – the CCP – is going to have to pay reparations all over the globe for the bioweapons they're releasing and all of this. They won't do it. There will be hard wars, as a result of this – brief, because the CCP's very brittle." The CCP will realize now they should never have tried to double cross the Rothschild's and thinking they could stiff the International Banksters and get away with it. Never happen Chairman Xi!

"In 1933, the bonds crashing globally basically created the social chaos that propelled the Brownshirts and Hitler into power – as was designed into the process." Clif High does understand the Zionist House of Rothschild. I don't believe he sees them out of

the picture by any means; rather they have taken a few licks from the CCP. This is why they globalist were trying to provoke a war between China and the U.S. They and their partners still own the world. They can take their game of monopoly (for real) and control it from Switzerland and their Black Nobility partners.

"Now, we've got something that isn't designed into the process. They actually had a different plan for the Evergrande bonds. They had the 1933 plan for the Evergrande bonds."

"Australia, at this point, there was supposed to be a crash in the money after the war and Australia, the U.S., etc. would owe vast quantities of money to the CCP, which we would not be able to pay and the CCP would come and take property, buildings, land, etc., in lieu of this debt that we owed them, theoretically."

"And so, now we don't have that. Now, instead, we have the Evergrande deflation. So, the bonds are going to deflate, they're worthless now – pennies on the dollar, if that. So valuations are going to fall, because who knows what any of this property is worth if there's no bidders for it." Remember, an antique car, is still an antique car unless someone wants to own it and will pay your asking price!

"It's going to roil the Forex market, all kids of chaos in the inter-fiat interchange system. It will, for a brief period of time cause the same kind of frothiness in cryptos and then, as they start pumping out the hyperinflation – which...maybe they'll ramp it up 30 days from now, maybe it'll take 60 but I don't think it'll take 90 – I don't think we'll go 3 months without the hyperinflation being deliberately pumped out as fast as they can..."

"They did not work their Plandemic plan absent the war. The Plandemic was supposed to come after we had been involved in the war, as part of that process. And then, they expanded that plan when they didn't get their war...because, bear in mind, in 1918 [during the Spanish Flu pandemic], we'd been through World War I. And so, we had conditions then that allowed the pandemic to go through and destroy everything, to the point where we got to 1933 and the hyperinflationary event, as a result of their brush with deflation."

"Now, we don't have a war as a prelude to the pandemic, we just got into the pandemic and then, they had to go batsh*t with it. It exposed them. The Self-Organizing Collective engineered much of this and allowed Nature to take the rest, so to speak and we're at that point now, where we're going to see the 'Rumors of Woo' – we're going to see the rumors come up out of the Woo and these rumors are going to dominate us from this point, all the way through, probably all the way through next year and the year after..."

"And unlike the 1932-'33 episode of bond default and the hyperinflation thing, here, we have the internet – so long as it lasts – and so, we'll have some level of communication about it all and people will be able to watch it happen in real time..."

CCP WILL NOT PAY FOREIGN INVESTORS

"Foreign investors globally will be really screwed as the knock-on on Evergrande starts falling off, because Evergrande is going to pollute all kinds of bonds and derivatives, everywhere and so the roll-on will be going for weeks, as various companies react to sudden changes in their bond status and so on, because a lot of them use bonds as a storage vehicle for money they accumulate along in time and if the bonds go belly-up, then when they go to the banks, they're not worth as much as they used to, so they can't get loans, that sort of thing."

Also, the loans, the money they get isn't worth much. This will affect cryptos positively, it likely will do so before the end of the month but there's going to be a lot of roiling in that market, as we go forward.

"This is going to seriously impact the Catholic Church – Vatican..."

"This is a period of time, as a result of this, we'll get into the next 60-to-90 days, so maybe February, first part of March, we'll get into a period where the government employees' paychecks just don't buy anything and they'll start walking off."

"We're going to see the breakdown of the university system. A lot of them are holding supposed value in bonds and paper assets that are going to die off as a result of the deflationary, the [vaxx] die-off, the Evergrande."

"Bear in mind, a lot of the older people that have been killed-off by the vaxx were investors. They had retirement money that they kept rolling over in bonds and that sort of thing. So, even...that aspect of the die-off is impacting the financial system and exacerbating the problem with Evergrande."

"There's going to be fewer people trying to buy the worthless bonds. That includes the university system. They're not going to be able to be buying anymore..."

So take what steps you may at this point, ahead of the events that are going to be hitting us as a result of the CCP taking over Evergrande, because the CCP is not going to pay the coupons of those bonds. Let me be perfectly clear, do not even think about buying on the dip, you will be swept away in the largest depression you could ever imagine. This was brewing for over two decades ago but has brought us to the precipice.

"They're going to make the people inside the country whole, in the sense that they may slack off and not demand as much money out of them but they're certainly not going to pay any of the foreign investors and this will lead to some ugly stuff, basically."

Russia vs Ukraine

The video summit between Russian President Vladimir Putin and his U.S. counterpart Joe Biden was dominated by the topic of the Ukraine, but touched on other important issues dogging the relationship between Washington and Moscow.

The two-hour conference call on Tuesday also addressed cybersecurity and ransomware in particular, as well as the ongoing crisis in diplomatic relations between the U.S. and Russian arms control negotiations, and attempts to restart the Iran nuclear deal that Biden's predecessor, Donald Trump, repudiated in 2018.

Russia warned the U.S. of "dangerous consequences" on Wednesday amid Russia's military buildup and growing concerns from the U.S. and NATO countries.

On Wednesday, Russia sent a letter to the U.S. Embassy in Moscow "warning about the dangerous consequences" the U.S. would incur if it continued military flights and naval ship activity near Russia's borders, according to Russian Foreign Ministry spokeswoman Maria Zakharova. She called the U.S. actions "provocations near Russia's borders."

The Russians would willingly give up on Europe almost entirely, even including the Baltic States to get back the parts of the Ukraine that are an inalienable chunk of their society. That should suit Washington quite well. That's not Joe Biden in the photo below!



Biden talks Russia's 'invasion' of Ukraine

Biden voiced U.S. concerns about the alleged Russian plan to "invade" Ukraine in January, an accusation by American spy agencies that Moscow has called "fake news." The U.S. president threatened new sanctions against Russia if such an invasion happens. In the wake of the meeting, however, the White House said it doesn't believe Putin has already decided to what it called "further invade" Ukraine.

Putin demands guarantees from NATO

Putin replied that it was NATO making aggressive moves against Russia, including in Ukraine, and said Moscow was interested in getting firm legal guarantees that the U.S.-led alliance would not expand any further to the east, or deploy offensive weapon systems in any countries bordering Russia, which includes Ukraine. He also denounced the "destructive" policy of the Kiev government, saying it aims to dismantle the peace agreements in eastern Ukraine.

Putin and Biden talk tit-for-tat sanctions

The Russian leader proposed to remove all the accumulated limitations on the functioning of embassies and consulates, imposed over the past seven years in tit-fortat sanctions, and thereby normalize diplomatic activity. The U.S. started the conflict by expelling Russian diplomats at the end of 2016; the back-and-forth reductions have since resulted in the closure of multiple consulates and inability of embassies in both countries to operate at full capacity.



Russia and US fighting hackers and ransomware

While the White House briefly mentioned "ransomware" had come up during the talks, the Kremlin said that both sides expressed readiness to "continue interaction" in fighting

cyber-crime, on both technical and law enforcement levels. Claims that 'Russian hackers' were involved in breaches of U.S. politicians and infrastructure have plagued relations with Moscow since the 2016 U.S. election. Moscow has accused the U.S. of "hunting" Russian nationals across the world on charges of cyber-crimes, while calling out Washington for ignoring hacking attacks made by US "client" states.

World War II alliance remembered

On the 80th anniversary of the attack on <u>Pearl Harbor</u>, which got the US openly involved in WWII, the two leaders agreed that those who fell in the cause of victory should not be forgotten. They also recalled the alliance between Washington and Moscow during that war, which they said could serve as an example for cooperation in the present day.

With the U.S. raising alarm about a supposed Russian military buildup opposite of Ukraine, and the Russians denying anything out of the ordinary is taking place it is tempting to conclude that this is just more of the typical NATO scaremongering about Russia. Trouble is that I don't believe that. On the contrary, I believe that something very serious is afoot. If I know that Joe Biden is not Joe Biden, you can well make odds that Vladimir Putin knows this guy is a fake "double" playing a role!

The reason I think so isn't that I have been listening to the Americans, but that I have been listening to the Russians. For years and years, the Russians have been complaining about the march of *American & vassal* missiles, training programs, weapon stockpiles, and units eastward. They have been complaining for so long that the picture of Russia as being all talk and never following up with real-world measures has become a meme among the more cynical Russia watchers.

Then, all of a sudden two things happened:

A.) Any and all talk of taking Donbass by force suddenly stopped in Ukraine. Instead, Kiev seems genuinely terrified it will be routed by the Russian military and is promising numerous Russian casualties (but tellingly not defeat) in a high-stakes attempt to deter the Russians.

B.) Biden initiated security talks with Vladimir Putin days after regime press revealed that something about the Russian military posture sent Washington into panic mode.

That tells me that the Russians finally did something that got Washington's full attention. I don't know what they did. It might be their superior fast new hyper glide missiles. Maybe it was the buildup opposite of Ukraine, maybe it was something else that we're not being told about. Maybe it doesn't even matter that much.

What does matter is that the Russian expectations of anything coming out of the initial Biden-Putin talk are nil, nada, nix! That means the Russian pressure — whatever it is — will continue.

The Russians aren't going to be bought out by talks. They held talks with Biden in the spring, and these were followed up by more provocations in the summer. Now they want real, tangible appearement. They have spelled out as much.

Trouble is, between the characteristic fecklessness and cowardice of the White House (whoever it is occupied by), and the vested Cold War interests I have no idea how they get that.

Any American president who works out a deal with the Russians and removes a missile or two will be denounced as "weak" by all the other institutions of the American Empire which stand to lose from peace, and which together are more powerful than a weak-willed presidency.

In reality, it is just the opposite, it is precisely the weakness of American presidents which makes a good deal with Russia impossible. What is better for the American and, say, the Romanian people, having some U.S. missiles in the land of Dracula, or peace in Europe? Obviously it is the latter. But any president who concedes as much will face resistance and sabotage by the Pentagon, the CIA, NATO, the posturing Congress, the liberal-interventionist State Department, the think tanks, and the media.

Honestly, I have no idea how Putin, Shoigu, and Lavrov get the security guarantees that they want out of this one. If they succeed they are infinitely better strategists than I give them credit for. Keep in mind that wars are often preceded by bluffs and threats. Even Mike Adams the Health Ranger opined on this nonsense. Insane U.S. leaders try to provoke NUCLEAR WAR with Russia... it's all an attempt to create chaos and collapse as a cover for the global financial reset.

Russia would devastate U.S. and NATO forces in Europe. Russia would mop the floor with U.S. and NATO forces if a war were to break out over Ukraine.

Russia already has hypersonic missiles in full deployment, while the U.S. military lags years behind and will probably never get them to work, since the entire military industrial complex has also gone full woketard. These missiles are game-changers in any theater of war because there are no defenses against them. They move so fast that radar can't track them due to the laws of physics as explained below.

As Military.com reports:

Hypersonic weapons such as Russia's 3M22 Zircon fly so fast and low — at speeds of up to Mach 6 and at a low atmospheric-ballistic trajectory — that they can penetrate traditional anti-missile defense systems.

The missile flies with an advanced fuel that the Russians say gives it a range of up to 1,000 kilometers. And it's so fast that the air pressure in front of the weapon forms a plasma cloud as it moves, absorbing radio waves and making it practically invisible to active radar systems.

Just a few days ago, Reuters reported on Russia's Zircon hypersonic missile test: "As part of "the completion of tests" of Russia's hypersonic missile weapons, the Admiral Gorshkov warship launched a Zircon missile at a target in the Barents Sea at a range of 400 kilometers," the defense ministry said. "The target was hit," the ministry said, describing the test as successful.

At 400 kilometers — which isn't even the full range of the missile — these hypersonic missiles can destroy any U.S. surface naval ship that attempts to harass Russian forces near Ukraine.

Even more astonishing is the fact that **Russia appears to have nuclear-powered cruise missiles**, which would put such weapons into a class all their own, far outside the capabilities of anything that's even on the drawing board in the US military. From Reuters:

Russia has boasted of developing several weapons that circumvent existing defense systems, including the Sarmat intercontinental missiles and Burevestnik cruise missiles. Western experts have linked a deadly blast at a test site in northern Russia in 2019 — which caused a sharp spike in local radiation levels — to the Burevestnik nuclear-powered cruise missile.

The Pentagon actually wants to see America's military defeated and destroyed If the U.S. even dared to attack Russia, most of the key U.S. military assets used in such an attack would likely be destroyed in less than 15 minutes, in my assessment. Shockingly, this appears to be the goal of the treasonous Pentagon which also oversaw the deliberately disastrous withdrawal from Afghanistan that left behind over ten billion dollars' worth of military equipment which immediately fell into the hands of the Taliban.

The Pentagon, it seems, is actually pursuing a strategy to **destroy as much U.S. military equipment as possible** while mass vaccinating U.S. troops with deadly mRNA covid "vaccines" that are designed to kill as many as possible. The Pentagon is literally running a treasonous, murderous campaign from inside the USA to destroy the USA. Striking up a war with Russia would help achieve that goal through what I call, "Russia-assisted suicide," which simply means U.S. military leaders invoking a Russian response to destroy more U.S. military equipment (naval vessels, land forces, aircraft, etc.) in order to weaken the United States.

The real long-term goal is the surrender of the USA to China. This is all being meticulously put into place with mandatory vaccines, economic collapse, domestic culture wars, anti-America media propaganda and Big Tech's open collusion with communist China. Prepare for WAR in 2022... and a cyber war false flag targeting US infrastructure The upshot of all this is that treasonous U.S. bureaucrats, senators and Joe Biden cabinet members have already made the decision to plunge the USA into war with Russia and China. In order to disrupt the 2022 mid-term elections, this war will need to

be launched no later than April of 2022, and it will likely be combined with a cyber-attack false flag operation targeting U.S. infrastructure (the power grid in particular).

This means the power grid will be taken down, **cutting off key communications such** as the internet and mobile phones. At that time, should this occur, the only functioning communications will be local radios and satellite phones.

Under this scenario, the dollar would of course suffer a catastrophic collapse, all timed as part of the global financial reset where "you will own nothing and be happy." (Or be dead, more likely.) Similarly, an engineered collapse of the crypto ecosystem looks to be shaping up in what we're now calling the "crypto reset" scenario. Read about the globalist attack on the crypto ecosystem here.

It almost goes without saying, but food supplies, medicine, ammunition and other critical gear will of course be wiped out and nearly impossible to find. Those who fail to prepare will be quickly starved into submission or death. Meanwhile, the genocidal vaccine depopulation scamdemic continues its march toward a global mass die-off.

Let's say it has indeed been a buildup opposite of Ukraine that forced the Americans to the table, now what? There is no doubt that if Moscow is willing to sustain the cost in lives and in sanctions (and in Ukrainian bitterness and enmity) that the Russian military can take most of Ukraine.

The Russian military is larger than the Ukrainian one and has more firepower per pound, The two also share a long flat border — there are no convenient bottlenecks. The Russians can force the Ukrainian military to stretch out over a long frontline, pin it down in place, and then apply defeat in detail to sectors with maneuver and firepower one by one.

Kiev is just 400 kilometers (248 miles) from the Russian border, and the Americans have already said — in so many words — that direct U.S. military intervention almost certainly isn't in the cards.

The trouble is this. If the DC Empire and the Ukraine were one organic being then guaranteeing the Russians a missile status quo in return for the Russians not overrunning Kiev would be an absolute bargain. Problem is that, not only are the Empire and the Ukraine not a single entity, but the American Empire itself is a hydra with many heads, most of which stand only to gain from a Russian war in the Ukraine.

The White House is the only imperial institution that stands something to lose, namely prestige for having failed to deter the Russians. However, it also stands to lose by being painted as appearing Moscow so it's something of a moot point.

In all other respects, the Empire and its institutions stand only to gain. NATO can get a huge lease on life, Pentagon could be looking at the return of full U.S. divisions to Europe, and the European vassals would be more regimented behind the U.S. than ever before. As the cherry on top Russia would be left with the odd problem of policing and rebuilding Ukraine — while under a total Western economic embargo. Perhaps the biggest "win" of all would be the endless opportunity for moral condemnation of Russia over its treatment of "subjugated" Malaya Rus'.

So again, I think Russia can relatively easily occupy land in the Ukraine, I just don't know how it can trade pieces of that land in return for NATO guarantees to stop carrying out provocations that are in its self-interest.

The problem is that Russia enjoying peace and stability on its borders is in Russia's interest but it is not in NATO's interest. Why do you think that Russia was willing to strong-arm Donbass into abiding by the Minsk Agreement but the West never applied pressure on Kiev to do the same? Because ultimately fighting Russia to the last Ukrainian and seeing the Russian-Ukrainian enmity deepen is the stuff of dreams for NATO.

The corporate press is inundated these days with the D.C. Uniparty members disseminating disinformation about the ongoing Russia and Ukraine spat, with many claiming the U.S. is somehow obligated to defend Ukraine's borders, citing an old nuclear agreement.

It was the U.S. who pressured the Ukraine to give up its nuclear arsenal under the guarantee that their borders would be protected but Putin ignored this agreement when he occupied the Crimea and two provinces in the southeast area of Ukraine. The problem is that this was as a result of any treaty. Bill Clinton and UK's John Major facilitated the agreement with the intent to appease Moscow. But it was only signed by one man Bill Clinton. Because it was not ratified by the U.S. Senate as a treaty, historical precedent tells us that in 2021 it is essentially meaningless.

Question – All I'm saying is that the percentage of people that have died is quite small compared to the tens of millions that have been vaccinated.

Answer – And all I'm saying is that if the vaccine is a lab-generated pathogen – and I have seen enough evidence that it is – then it certainly was not designed to kill people on the spot. It was engineered to produce a delayed reaction that gradually but relentlessly erodes the health of the vaccinee. In other words, the full impact of the blood clots, bleeding, autoimmune issues and other vaccine-generated injuries will only be fully felt at a later date via increasing incidents of heart attacks, strokes, vascular illness and even cancer. Was settling, then spike up again since late October." Scottish Unity – Edinburgh Group). Their data is graphed below on the next page.


Answer – The chart below shows why cardiac issues have garnered a lot of attention lately, but the damage to the immune system is even more concerning.

Question - Can you explain what you mean without getting too technical?

Answer – I can do better than that. I can give you a short clip from an article that covers the latest research. Check it out:

"A Swedish lab study (titled <u>"SARS-CoV-2 Spike Impairs DNA Damage Repair and Inhibits V(D)J Recombination In Vitro</u>", NIH) released in mid-October found that the spike protein... enters the nucleus of cells and significantly interferes with DNA damage-repair functions compromising a person's adaptive immunity and perhaps encouraging the formation of cancer cells....

"Mechanistically, we found that the spike protein localizes in the nucleus and inhibits DNA damage repair," they wrote. "Our findings reveal a potential molecular mechanism by which the spike protein might impede adaptive immunity and underscore the potential side effects of full-length spike-based vaccines." ("Spike protein in COVID virus and shots weakens immune system, may be linked with cancer: Swedish study", Lifesite News)



What the researchers found is that the spike protein blocks production of the enzymes that are needed to repair broken DNA which, in turn, prevents the "proliferation" of B and T cells that are needed to fight infection.

Question – Can you explain that in plain English?

Answer – Sure. It means the vaccine short-circuits your immune system which clears the way for infection, disease and an early death. Maybe, you think you can have a long and happy life with a dysfunctional immune system, but I think you're wrong. The immune system is the shield that protects you from all-manner of

potentially-lethal viruses, bacteria and infections. It is not just the first-line of defense; it's the only line of defense. Absent the full protection of B and T cells to fight-off foreign intruders, the prospects for survival are miniscule at best.

In order to underscore that point, check out this video of British Funeral Director, John O' Looney, who has provided regular updates on what he is seeing on the ground 10 months following the vaccination rollout. It's a disturbing account of the catastrophe that is now unfolding before our eyes:

(30 second mark) "So what we're seeing is an unnaturally large number of deaths due to heart attack, stroke, aneurism; and these are all the result of thrombosis ... Embolisms in the lungs the legs, various places that are causing these deaths that are well documented by the local coroners and well-documented across the country. And no one seems to be concerned about the alarming rise of (blood clots) I've seen more in this year than in the last 14 years..."

That's one kind of death we're seeing, the other kind is the people that are getting sick now as their immune systems finally give up. So, they've had the jabs maybe 6 or 8 months ago, and it's been eating away at their immune system, and now they're struggling to fight off things like the common cold. So, we're in winter and there are colds and flus around and these people can't fight them off. The government are very quick to label it "Omicron"... but they are sick with the common cold. Their immune systems are decimated. It's much like a cancer patient, who goes through chemotherapy and it decimates their immune system. And they have to be very careful because the common cold or flu can kill them. And this is what we're seeing now..."

"We're nearly 12 months since the first jabs began, so their immune systems are falling apart; that is the reality and that's what I'm seeing... and they can't cope with a cold anymore. ... When I went to the meeting in Westminster in September, the scientist predicted that this is what would happen and, lo-and-behold, that's what happening. The people are getting sick and dying... It's frightening." ("Omicron is 'vaccine injury'; it's nothing more than that." John Looney, Rumble)

Is he right? Is the uptick in fatalities NOT another wave of Covid but the knock-on effects of a cytotoxic injection that targets the immune system leaving millions of people defenseless against routine infections and disease?

It sounds feasible and it certainly fits with the depopulation agenda which requires a hybrid biologic that doesn't kill its target outright but basically dismantles the critical defense systems that make human survival possible. By disguising a "killer protein" as a harmless antigen, our pandemic managers have been able to access the bloodstreams of millions of people allowing them to insert a ticking time-bomb that ravages crucial T and B-cell populations leaving victims vulnerable to whatever bug happens to be circulating in the population. As Looney notes, scientists warned of this very outcome

when mass vaccination was first proposed. Naturally, opposing views were ignored and censored. Here's more from a pre-print research paper on the medRxiv server. It helps to explain the vaccine's impact on the immune system:

"Researchers in The Netherlands and Germany have warned that Pfizer-BioNTech's ... (COVID-19) vaccine induces complex reprogramming of innate immune responses that should be considered in the development and use of mRNA-based vaccines... Following vaccination, innate immune cells had a reduced response to toll-like receptor 4 (TLR4), TLR7 and TLR8 – all ligands that play an important role in the immune response to viral infection..."

"Multiple studies have shown that long-term innate immune responses can be either increased (trained immunity) or down-regulated (innate immune tolerance) after certain vaccines or infections."...

"These results collectively demonstrate that the effects of the BNT162b2 vaccine go beyond the adaptive immune system... The BNT162b2 vaccine induces reprogramming of innate immune responses as well, and this needs to be taken into account."...("Research suggests Pfizer-BioNTech COVID-19 vaccine reprograms innate immune responses", News-Medical net)

How many people would have gotten vaccinated if they'd known it would reprogram their immune system?

Probably no one; which is why our public health officials never broach the topic. Anything that veers even slightly from the "vaccines are good for you" narrative is omitted from mainstream coverage and erased on social media. But aren't people entitled to know what's going on, what is being injected into their bodies, and what impact it will have on their lives and health? Isn't that what is meant by "informed consent" or is that another casualty of the rush to inoculate all 7.8 billion people on planet earth? Here's a clip from a short interview with pathologist, Dr. Ryan Cole:

"When we give these shots, we can see the types of white blood cells in the body... and you have a broad array of immune cells that work together to fight off viruses and keep cancers in check. We're already seeing the signals in the laboratory of decreases in critically important T-cells you need... in your innate immune system. These are the Marines in your body; fighting off viruses fighting cancer.... But what we're seeing in the laboratory after people get these shots, we're seeing a very concerning locked-in, low profile of these important killer T-cells that you want in your body. (CD8 cells) And what they do, is keep all other viruses in check.

What am I seeing in the laboratory? I'm seeing an uptick of Herpes family viruses, I'm seeing Shingles, I'm seeing Mono, and I'm seeing a huge uptick in human papilloma virus... We are literally weakening the immune systems of these individuals.

Most concerning of all, is there's a pattern of these types of immune cells in the body that keep cancer in check. Since, January 1, (in the laboratory) I've seen a 20X increase of endometrial cancer over what I see on an annual basis." ("Pathologist Ryan N Cole of the Mayo Clinic on What We Are Seeing In Lab Results", Rumble; 2 minutes)

"Herpes, Shingles, Mono, and even cancer!" What the heck is going on? This can't be true, can it?

Yes, it is true; immuno-suppression leads to all kinds of terrible health outcomes. Some readers might recall how Canadian vaccinologist Dr. Byram Bridle made similar claims in an interview just a few weeks ago. Here's what he said:

"What I've seen way too much of is people who had cancers that were in remission, or that were being well controlled; their cancers have gone completely out of control after getting this vaccine. And we know the vaccine causes a drop in T-cell numbers, and those T-cells are part of our immune system and they are part of the critical weapons our immune system has to fight off cancer cells; so there's a potential mechanism there. All I can say, is I've had way too many people contact me with these reports for me to feel comfortable. I would say that is my newest major safety concern, and it's also the one that's going to be the most under-reported in the adverse data base, because if someone has had cancer before the vaccine, there's no way public health officials will ever link it to the vaccine." ("Dr. Byram Bridle speaks", Bitchute, :55 second-mark)

Once again, how many people would have decided to get vaccinated if they knew that it could trigger a flare-up of dormant viruses or cancers in remission? Who would take that risk?

But they don't know they're taking a risk, do they, because they haven't been told the truth. And the reason they haven't been told the truth is because they are a target in a war of extermination that is being waged on them. Sometimes it's very hard for people to admit to what they know to be the truth, but the truth is plain to see. Our pandemic managers and their foot-soldiers in the media, public health and government want to do us harm, want to inject us with a mysterious substance that will wreak havoc on our immune systems and shorten our lives. For those who don't know, this is extremely bad news. It's only on a few people so far, but the data does not look good so far. These T-cells are the so-called "killer cells". Their job... is to kill

virally infected cells that are showing foreign markers on their surface. So, if these populations are depleted, then that is very bad news, because we don't have a population of cells in the acquired immune system to remove virally-infected cells...."

"There are clear signs that are starting to emerge, that there is an "immunity deficiency syndrome" coming about as a result of these products (vaccines) As a result of hyper-stimulation...T-cells being (diminished), and the ever-presence of repeated injections of a cytotoxic protein... I would never, ever recommend that someone who is immuno-compromised to ever go near these things, because I can almost guarantee you, that your condition is going to get worse. Another thing we're seeing in VAERS is cancers coming out of remission and a lot of doctors are reporting this on the ground. And-by the way- this has never happened before, not on this scale; not even close... So, there's something going on here that warrants further investigation, and it doesn't look good." ("Viral Immunologist Dr. Jessica Rose explains the concerning information emerging about the compromised immunity of the vaccinated", Odysee)

Can you see the pattern yet? Can you see how they're all saying the same thing? Why is that, do you think?

It's because it's the truth, the pure, unvarnished truth.

The point we're trying to make cannot be overstated: The vaccine is a man-made, lab-generated "bioweapon" that disables the body's critical defense system which increases one's susceptibility to disease by many orders of magnitude. You can do a bad job yourself by leading an unhealthy life that is going to suppress your innate immunity, but even worse, is vaccine-induced antibodies that do suppress your innate immunity. And these vaccinal antibodies cannot substitute for it because they lose their efficacy against the virus, and become less and less effective. In contrast to the innate antibodies, they

cannot prevent infection, they cannot sterilize the virus. Therefore, they do not contribute to herd immunity..."

"If we suppress these innate antibodies in children, it could lead to autoimmune diseases. This is an absolute "No go" We cannot vaccinate our children with these vaccines. The suppression of innate immunity is already a problem among vaccinees, and they are, indeed, going to have a difficult time controlling a number of diseases, not just Covid-19, but other diseases too ...and it will require a very dramatic change in the strategies to help the vaccinees—and my heart goes out to them—because they will need extensive treatment in many cases...

... Boosting them—which means giving them a third dose— is absolutely insane, because what it will do, is increase the immune pressure of the vaccinal antibodies, on their innate immunity. So boosting is absolute nonsense; it is dangerous and should not be done....

So, what does the science tell us? It tells us that it's innate immunity that will protect us, not the vaccine." ("Geert Vanden Bossche on Vaccines and the suppression of innate immunity", Rumble)
