A COVID-19 mandatory vaccine requirement for all non-U.S. citizens coming across the borders from Canada and Mexico that includes truck drivers went into effect today, Saturday, January 22, 2022.

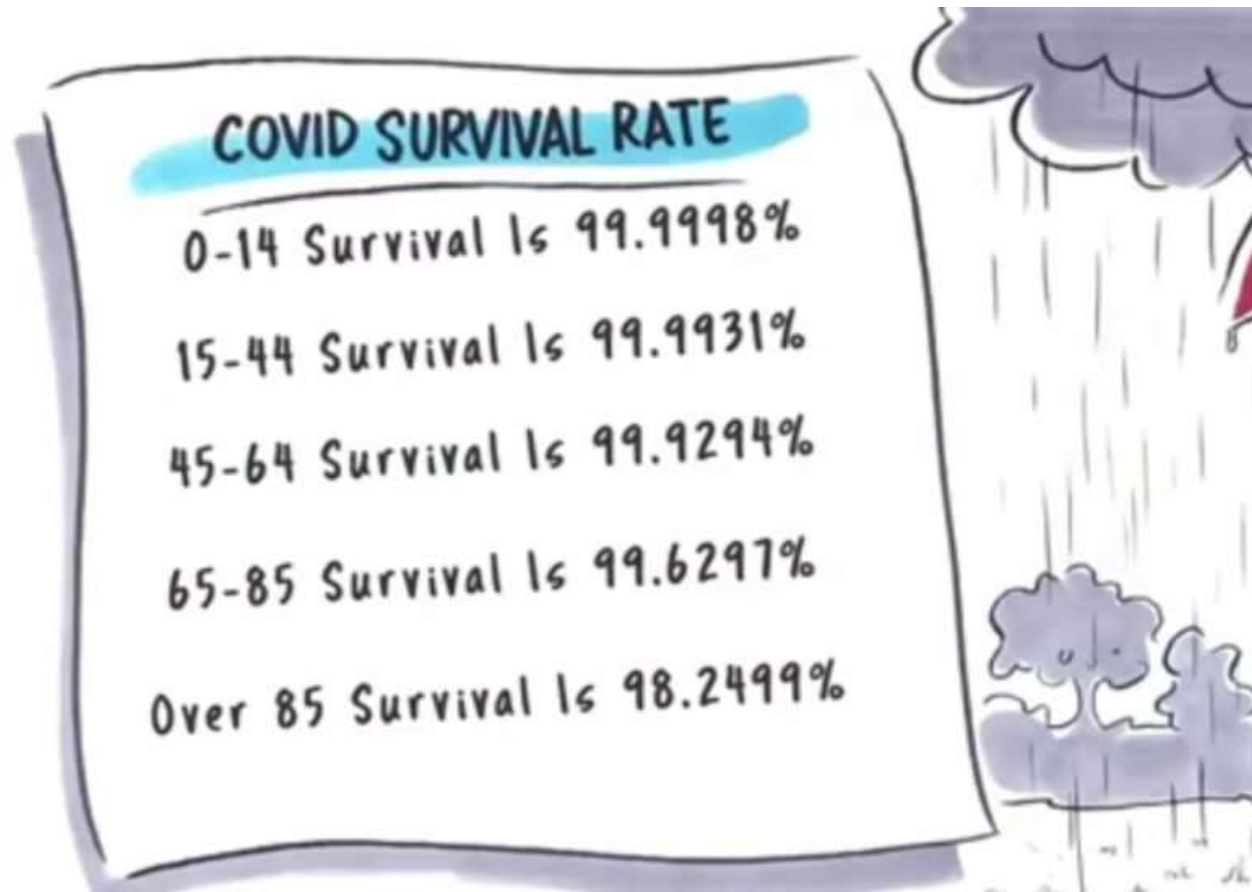
The U.S. Department of Homeland Security confirmed that it will require non-U.S. individuals – including truck drivers – seeking entry into the United States from Canada and Mexico to provide proof of vaccination beginning Saturday, Jan. 22.



“Starting on January 22, the Department of Homeland Security will require that non-U.S. individuals entering the United States via land ports of entry or ferry terminals along our northern and southern borders be fully vaccinated against COVID-19 and be prepared to show related proof of vaccination,” Secretary Alejandro N. Mayorkas said in a [news release](#). *“These updated travel requirements reflect the Biden-Harris Administration’s commitment to protecting public health while safely facilitating the cross-border trade and travel that is critical to our economy.”* ([Source](#).)



Now, let's get serious here on this bovine excrement they want you to believe. There never was a pandemic, not even an epidemic. This is not about public health or even safety. Canada implemented a similar COVID-19 vaccine mandate for U.S. truck drivers entering Canada last week, and it is already disrupting the supply chains in Canada.

Canada's COVID-19 vaccine mandate for cross-border truckers went into effect over the weekend. Now, the United States plans to implement a similar mandate beginning Saturday, Jan. 22.

Each country's rule prevents unvaccinated or partially vaccinated foreign national truckers from crossing the border. Both rules have been criticized because they could create more supply chain disruptions. That's pretty obvious and begs the issue, who is really in control and imposing these insane policies.

[Bloomberg reported](#) this week that Canada's rule already has led to a surge in produce prices. George Pitsikoulis, president of Montreal-based distributor Canada wide Fruits, told Bloomberg that the cost of transporting produce out of California and Arizona to Canada jumped 25%. In addition, a recent [Wall Street Journal article](#) stated that two-way trade in merchandise goods between the United States and Canada totaled more than \$600 billion in 2019. It is estimated that about 80% of those goods moved on trucks.

The rules could lead to a significant reduction in truckers willing to cross each country's border. The American Trucking Associations estimates that about half of truck drivers have not received the COVID-19 vaccine. According to an OOIDA Foundation survey from April 2021, about 75% of OOIDA's members who responded said they didn't plan to receive the vaccine.

Besides higher prices, food shortages have also been reported in Canada this past week.

Overwhelmed supply chains and truck driver shortages worsened when Canada imposed new border mandates prohibiting unvaccinated American truckers. With low vaccination rates among US drivers, Canadian supermarkets are already reporting rising food inflation and shortages of certain products, according to [Bloomberg](#).

Canada's vaccine mandate for truckers came into effect on Saturday. The new rule requires US truckers to be vaccinated to cross the border. We warned earlier this week such a mandate would have "[consequences](#)."

The vaccine mandate has [exacerbated the shortage of truck drivers](#) and made wait times at border crossings even longer. Eighty percent of trade between the US and Canada is transited by truck. America exports about 90% of Canada's fruits and vegetables during the winter season. As shipments decline because only about half of U.S. truck drivers are vaccinated, grocery stores report shortages.

"We're seeing shortages," said Gary Sands, senior vice president of the Canadian Federation of Independent Grocers. "We're hearing from members they're going into some stores where there's no oranges or bananas."

A rolling protest by a transport convoy at the Manitoba border crossing has already led to major delays for travelers hoping to cross into the U.S.



According to one driver, trucks are blocking all lanes at the border as they slowly follow a circular route along Hwy. 75 while blasting horns in opposition to the federal government.

“Truck drivers are circling MB-75 between Emerson Duty Free and the Commercial Inspection station blocking all lanes heading south to the United States and Northbound traffic coming from the USA,” Jamie Throp told Global News. ([Source.](#))

A Canadian truck convoy, *The Convoy for Freedom 2022*, has started with Canadian truck drivers from all parts of Canada heading to the Canadian capital in Ottawa for a rally next Saturday, January 29, 2022. There is a [Gofundme page](#) setup to solicit funds for the truck drivers to help with their expenses in driving to Ottawa, and it has already raised more than \$1.6 million.

A group of truckers is planning to drive across the country to protest a federal vaccine mandate in Canada’s capital.

The first leg of the convoy, dubbed [The Convoy For Freedom 2022](#) , is set to leave B.C. on Sunday. Convoy organizers plan to arrive in Ottawa on Jan. 29, where truckers from other provinces will join.

“I know a lot of drivers who are impacted by this. It has basically removed them from the workforce,” B.C. truck driver Colin Valentim told the [Vancouver Sun](#) .

Valentim will lead the B.C. leg of the convoy taking the western route and expects to be accompanied by others along the way. Two other convoys have different starting points: The eastern route is to begin on Jan. 27 in Enfield, Nova Scotia. The southern route will leave on the same day from Windsor, Ontario.

“We are taking our fight to the doorsteps of our Federal Government and demanding that they cease all mandates against its people,” wrote Go Fund Me organizer Tamara Lich. *“Small businesses are being destroyed, homes are being destroyed, and people are being mistreated and denied fundamental necessities to survive.”*

The decision for Canadian truckers to meet in Ottawa to protest the vaccine mandate comes as the industry struggles with issues, such as disruptions to the supply chain and a shortage of drivers.

The federal vaccine mandate could result in a loss of 12,000 to 16,000 cross-border commercial drivers, according to the [Canadian Trucking Alliance](#). ([Source](#).)

There is as of now no vaccine mandate for truck drivers entering Mexico, but depending on how strict they are at the Mexican borders on enforcing the U.S. mandate on Mexican truck drivers, this could have devastating impacts on the U.S. economy.

The top imports from Mexico are:

1. Machinery & Electrical

Over one-fifth (22%) of U.S. imports from Mexico are classified as machinery and electrical products—items like televisions, household appliances, and smartphones. Mexico is a major manufacturing hub for some of the largest global brands, including [Samsung](#). The South Korean electronics giant sources much of its Amazon-bound inventory from Querétaro.

2. Chemicals & Allied industries

Chemical products make up nearly 15% of U.S. imports from Mexico in 2020. This includes household staples like soap, garden fertilizer, and multivitamins. Some of the world’s largest brands source their chemical products from Mexico. [Colgate](#), for example, imports its toothpaste from Monterrey.

3. Vegetable Products

Just over 10% of the U.S.’s 2020 imports from Mexico are classified as vegetable products. A broad category, Vegetable Products includes plant products like fresh-cut flowers, dried fruit, and an Amazon staple: roasted coffee beans.

Beloved by caffeine lovers, Mexican beans account for much of the global supply of coffee, including [60% of the world's organic coffee](#). [Source](#).

The top imports from Canada are:

1. Crude oil and petroleum

Canada's largest export to the U.S., by far, is crude oil with the vast majority coming from Alberta's oil sands to the Western and Southern U.S.

2. Vehicles

Combining the large and medium-sized passenger vehicle categories, car exports make up approx. 13% of Canadian exports. Canada's automobile-related exports are a legacy of the Auto Pact under which American car companies set up plants in Canada and parts were shipped back and forth across the border.

3. Natural gas

Like oil, most of the natural gas is produced in Alberta. Using a similar distribution pattern as oil, Canadian exports go from Alberta into the Western and Southern U.S.

4. Potassium chloride

Potassium chloride is found in potash, which is used to make the world's fertilizers. Saskatchewan is the second largest producer of potash in the world.

5. Gold

Canada is a major exporter to the U.S. of non-monetary gold – bullion, powder or any other semi-manufactured form. It does not include watches or jewelry. Although the United States is a net exporter of gold, much of its production depends on higher prices for gold to make it profitable.

6. Wood

Canada is the United States' main supplier of wood.

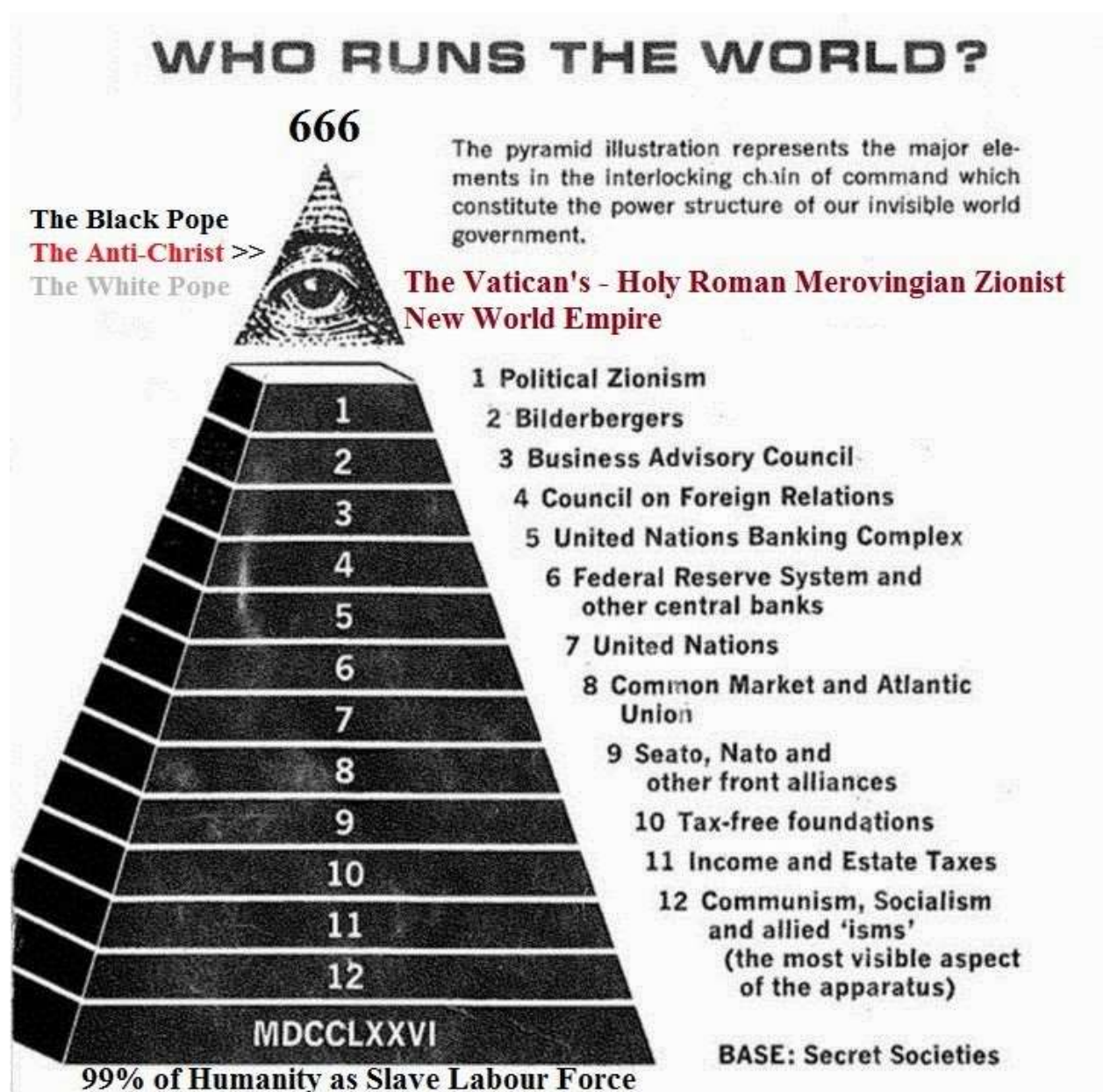

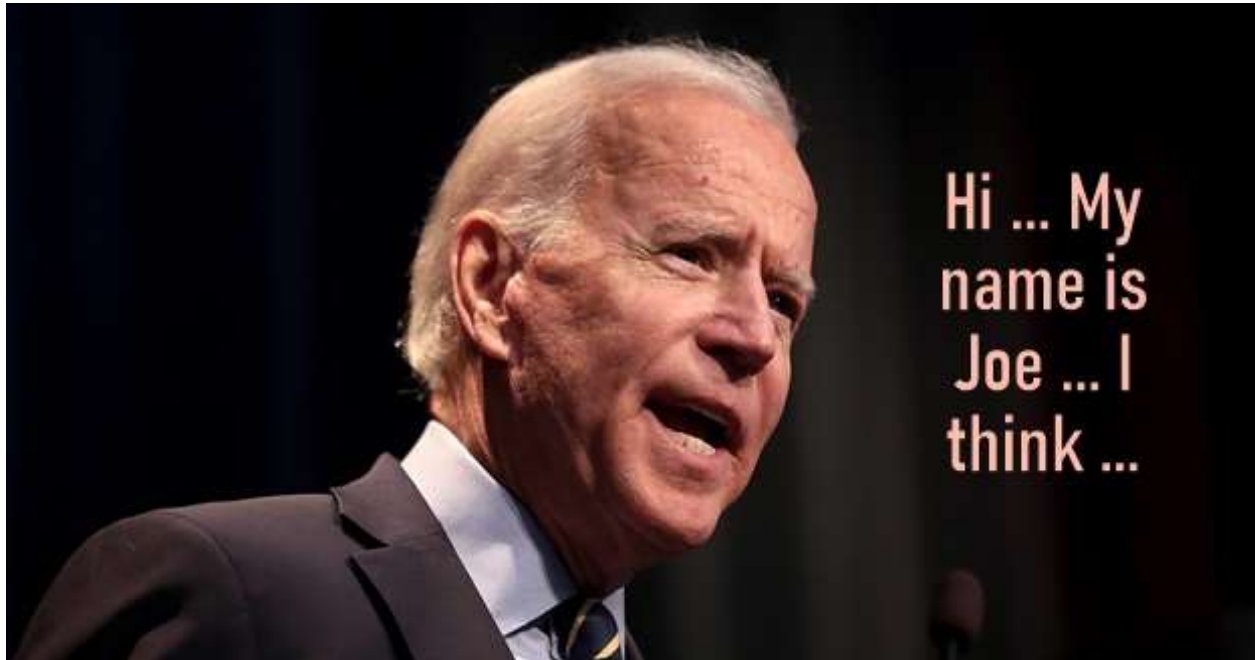
not. You can both add and remove a cleft chin with chin surgery, also called mentoplasty.

Five, on Jan. 14, 2022, it was reported that Pres. Nana Akufo-Addo of Ghana, Africa, went on national TV to tell Ghanaians about the Rockefeller plan:

- To spread a virus,
- Depopulate the earth, and
- Destroy the global economy

According to the article, Akufo-Addo told his people where they could find the proof of these things, how Fauci and Gates are involved, and he announced his intention to end all vaccinations.

(Note: concerning these three things: it is interesting that the Bible predicts global pandemics, the death of multitudes, and a global economic collapse during the Tribulation Period.)

Six, concerning the return of Israel at the end of the age: God said the barren land will be reforested (Isa. 60:13).

Returning Jews have set out millions of trees, and on Jan. 13, 2022, it was reported that riots have broken out in Israel over a tree-planting program in the Negev desert.

Bedouins are accusing the government of trying to seize land for a forest that belongs to them.

To make this spat more serious, one Arab member of the Israeli government's 61-member majority (61 are needed to prevent the collapse of the government) said he will stop voting with the government until it stops planting trees on the land claimed by the Bedouins.

Former Prime Min. Netanyahu is urging the government to keep planting trees and said he will vote with the government to keep it from collapsing over this issue.

In a sense, this seems like a small issue, but the Word of God is being fulfilled, and it is impossible to prevent it from being fulfilled.

Seven, concerning a rebuilt Temple early in the Tribulation Period: on Jan. 16, 2022, the Israeli government approved a \$35 million five-year plan to improve access to and increase the number of visitors to the Temple Mount Wailing Wall, and to help finance other existing development projects.

(Note: Some readers might remember that in 2018 Israel completed construction and started the operation of 2 trains—called the King David Railroad because King David established Jerusalem as the capital of Israel—to take visitors from the Ben Gurion Railroad to Jerusalem. After that, they decided to build a train station near the Temple Mount and name it after Pres. Trump because he recognized Jerusalem as the undivided capital of Israel. Since the days of Jesus, the current generation is the only generation to see a re-established Israel, a rebuilt Jerusalem, and a railroad to increase visitors to the Temple Mount, but unbelieving globalists and most preachers don't see what (or Who) is coming).

Eight, concerning an increase in lawlessness and the transformation of the U.S. into a globalist police state under the Antichrist: on Jan. 16, 2022, Hal Lindsey suggested that politicians could get U.S. citizens to go along with transforming the U.S. into a police state by stopping the prosecution of crime, releasing prisoners from jail, rewarding evil, and penalizing good.

Lindsey believes (and this writer agrees) doing these things would prompt law-abiding citizens to demand more government control, and the government would respond by passing laws to reduce our freedoms.

Stock prices have been falling for three weeks in a row, and last week was the worst week for U.S. stocks in a really, really long time. The S&P 500 is now down more than 8 percent from the peak of the market, and the tech-heavy Nasdaq is already in correction territory. At this point, the Nasdaq is off to its worst beginning to a year in decades, and many are extremely concerned about what is coming next. In fact, Bank of America is warning that all hell breaks loose if the Nasdaq closes below 14,000. Hopefully that won't happen this week. But it might.

Last week, one of the most respected names in the financial world made headlines all over the globe when he warned that the stock market crash which has now begun will end the “super bubble” that Wall Street has been enjoying for so many years...

Jeremy Grantham, the famed investor who for decades has been calling market bubbles, said the historic collapse in stocks he predicted a year ago is underway and even intervention by the Federal Reserve can't prevent an eventual plunge of almost 50%.

In a note posted Thursday, Grantham, the co-founder of Boston asset manager GMO, describes U.S. stocks as being in a “super bubble,” only the fourth of the past century. And just as they did in the crash of 1929, the dot-com bust of 2000 and the financial crisis of 2008, he's certain this bubble will burst, sending indexes back to statistical norms and possibly further.

According to Grantham, there have been five other “super bubbles” and they have all ended badly...

He noted that US stocks have experienced two such “super bubbles” before: 1929, a market fall that led to the Great Depression, and again in 2000, when the dot-com bubble burst. He also said the US housing market was a “super bubble” in 2006 and that the 1989 Japanese stock and housing markets were both “super bubbles.”

“All five of these super bubbles corrected all the way back to trend with much greater and longer pain than average,” Grantham wrote.

We should give some credit to the “geniuses” at the Federal Reserve for keeping the party going for as long as they have, but by inflating this bubble to such an absurd size they have set the stage for a meltdown that will be unparalleled in our entire history.

Another item we should be alert to is the fact that Russian and Syrian military pilots have conducted a joint air patrol mission along the Golan Heights and the Euphrates River, the Russian Defense Ministry said in a statement.

“The mission's route ran along the Golan Heights, the southern border, the Euphrates River and over northern Syria,” the statement reads. *“Russian pilots took off from the Hmeymim Air Base, while Syrians took off from the Seikal and Dumayr airfields outside Damascus,”* the ministry added.

According to the Russian Defense Ministry, the mission involved Russia's Su-34 and Su-35 aircraft and the A-50 early warning and control aircraft, as well as Syria's MiG-23 and MiG-29 planes. *“During the patrol mission, Syrian pilots controlled airspace and provided fighter cover, while Russian crews practiced attacks on ground targets,”* the statement specified. The ministry said that pilots had practiced strikes on air targets and ground targets at a training range in central Syria.

“The two countries’ pilots developed skills for cooperation in various situations. This kind of joint missions will now take place on a regular basis,” the Russian Defense Ministry stressed.

The U.S.-Russia talks in Geneva in the last two successive weeks could not produce a breakthrough. Fundamentally, there is a contradiction that cannot be resolved easily. Russia sees in existential terms the NATO’s advance into its immediate western neighborhood. But for Washington, it’s geopolitics, stupid!

Russia cannot tolerate any longer such NATO presence on its western border. Ukraine’s induction into the Western alliance system would mean that the U.S. missiles could hit Moscow in 5 minutes, rendering Russian air defense systems ineffectual and obsolete.

NATO deployments in the Baltic and the Black regions further deprive Russia of buffer in the west. Considering that all major decisions and most minor decisions in the NATO are taken in Washington, Moscow perceives all this as an American strategy to encircle it, erode its strategic autonomy and independent foreign policies.

The US, on the contrary, refuses to countenance any NATO rollback. It insists that Russia has no say in the alliance’s decisions. At best, Washington would discuss certain confidence-building measures, while NATO enlargement since 1997 — contrary to assurances given to Mikhail Gorbachev by western leaders in 1990 during the reunification of Germany — is a fait accompli that Russia should live with.

Basically, the U.S. has gained the high ground through sustained efforts through the past three decades since the Bill Clinton administration put into effect a concerted strategy in anticipation of a resurgent Russia in a matter of time. Now that the US has gained the upper hand, it is loath to give it up.

From Washington’s viewpoint, this is a key template of the geopolitical struggle unfolding over the new world order after China’s rise and the shift in power dynamic from the West to the East. Cutting down Russia to size and to be able to intimidate it is a pre-requisite of the situation before the U.S. tackles China comprehensively. Suffice to say, Ukraine has become a battleground where a titanic test of will is playing out.

Ukraine is in all practical sense a U.S. surrogate and its transformation as an anti-Russian state that began following the regime change in Kiev in 2014 is already at an advanced stage. Although Ukraine is not yet a NATO member, the alliance has established a significant presence in the country militarily and politically.

In the information war, the US portrays Russia as aggressor against a weak neighbor. In reality, though, it is a situation of ‘Heads I win tails you lose’. If Russia doesn’t do anything, it might as well resign to the inevitability of Ukraine being inducted into NATO and Russia having to live with the enemy at the gates. Of course, that would shift the global strategic balance for the first time in history in favor of the US.

On the other hand, if Russia acts militarily to prevent the NATO's march in Ukraine, Washington will play rough. Washington is all set to pillory President Vladimir Putin personally and to impose "sanctions from hell" on Russia, with a vicious game plan to wound that country's economy lethally and stifle its capacity to be a global player.

In the U.S. estimation, Putin personally will have to bear a heavy political cost of living conditions deteriorate within Russia between now and 2024 when the next Russian presidential election is due, and he may be compelled to relinquish power. From the American perspective, there's nothing like it if a Boris Yeltsin II were to succeed Putin.

Make no mistake, part of what is going on today is a demonization Putin's political personality to erode his towering popularity (65%), which forecloses the rise of a pro-western politician in Russia for a foreseeable future. All attempts by the US intelligence to create a "liberal" platform in Russian politics have failed so far. The fact of the matter is that the majority of Russian people dread the return of the "liberal" order of the 1990s.

The *'Washington Post'*, which is linked to the U.S. security establishment, featured a scurrilous report last Wednesday under the byline of a noted knave titled *"House Republicans aim sanctions at Putin, his family and his mistress"*. It says, *"The Biden administration's carefully crafted mix of diplomacy and threats of additional sanctions doesn't seem to be deterring Russian President Vladimir Putin from invading Ukraine and starting a war. Now, a large group of House Republicans is pushing President Biden to ramp up the pressure on Putin directly by going after him and his entourage for their long and well-established corruption."* Evidently, Washington will go to any extent to create dissensions among Russia's elite and undermine the country's political stability.

What lies ahead? Without doubt, Russia is acutely conscious of its limitations. Moscow too made some serious miscalculations. It was betting that Ukraine was not going to join the NATO and in due course, better sense would prevail in Kiev under a realistic and pragmatic leader who would give up on the "Ukrainization" agenda, repair ties with Russia (especially in the economic field) and importantly, accommodate the aspirations of the ethnic Russian eastern regions. But as it turned out, "Ukrainization" is only being galvanized with tacit American support. Moscow has sensed that time is no longer on its side.

Moscow expects something concrete from the American side, as its vital security interests are in jeopardy. The Kremlin leadership, including Putin, has starkly outlined Russia's "red lines." Washington, on the other hand, is simply kicking the can down the road. It estimates that time is on its side anyway. From the Russian viewpoint, this is not acceptable, since a point of no return is arriving as regards Ukraine's NATO membership.

Arguably, President Biden doesn't want to move in the direction of accommodating Russia's legitimate interests, given the pulls and pushes from the domestic scene in America and the divergent opinions among European allies, but primarily because the

encirclement of Russia with pro-Western states has been a strategic objective of Washington's policies toward Russia under successive administrations since Bill Clinton, and today it happens to be expedient too, being a "cause" that enjoys rare bipartisan support in the Beltway at a juncture when American opinion is deeply divided. In the present situation, wittingly or unwittingly, Washington has also tied its hands by committing that it won't negotiate over Ukraine's head. All factors taken into consideration, therefore, the probability is very high that Russia will intervene in eastern Ukraine with a view to create new facts on the ground to secure its national security interests while aiming at a political settlement for the medium and long term.

What does it entail?

Clearly, Russia is not seeking annexation of Ukrainian territory. Its preference will be to restrict its intervention in eastern Ukraine largely to the Russian populated regions and to create a buffer zone. Some American analysts have estimated that, broadly, any Russian intervention will be restricted to the territory up to the Dnepr river flowing through Belarus and Ukraine to the Black Sea. This seems plausible.

Of course, there are variables in any emergent military situation. Russia will firmly react to any form of Western intervention in Ukraine — although Washington has ruled it out. (In any case, the U.S.' capability to fight a massive continental war at such short notice is questionable.) The Russian military operations will be decisive with huge firepower and advanced weaponry on multiple fronts, with the intention to realize the political objective in the shortest time possible.

The U.S. journalists have written about "resistance" but that is a load of rubbish. The Russian operation will be short and decisive. The Ukrainian moral fiber today is such that the demoralized forces and the disillusioned people will simply cave in. In all this, what needs to be remembered is that despite the heavy dollops of U.S. indoctrination, Ukrainian people have profound civilizational affinities with Russians that lie submerged just below the surface.

Most important, the pervasive corruption in that country gives ample scope to buy off loyalties — in fact, there may not be much actual fighting at all in many sectors. It also needs to be factored in that the political situation in Kiev is highly unstable, as the latest sedition charges against former president Petro Poroshenko testify.

Zelensky won his mandate as president in 2019 on the basis of his promise to work for rapprochement with Russia. Today, he is a thoroughly discredited figure. People feel betrayed. A crushing military defeat will mean the end of the road for Zelensky.

The ensuing political turmoil within Ukraine is the "X" factor in the Russian intervention. American analysts deliberately sidestep this. Simply put, Russians have a deep understanding of the eddies of Ukrainian politics and the country's power brokers due to the shared history, culture, politics and societal links.

The ultimate Russian objective will be a federated Ukraine through constitutional reform with the country's sovereignty, national unity and territorial integrity intact while the regions enjoy autonomy. Europe may welcome this as the best way to stabilize the situation and remove the potential for future conflict.

Indeed, Russia's expectation will be that such a Ukraine can never become a part of NATO once constitutional underpinnings are put in place to ensure that all major policies pursued in Kiev would be based on national consensus.

The bottom line is that as Russia sees it, the only way out of this crisis is that Ukraine regains its national sovereignty and stops looking to Washington for navigating its destiny. That requires that the American operatives in Kiev who take the decisions for Ukraine go home and Ukrainians are once again the masters of their house, which ceased to be the case once the U.S. intelligence usurped power in February 2014 disregarding the pledge given by then (elected) president Viktor Yanukovich to hold fresh elections before deciding on Ukraine's EU membership.

Clearly, all this is not going to be as easy as it sounds and the outcome may turn out to be no better than an attempt to unscramble the omelet. But the good part is that there are signs already that Europe is skeptical about blindly tagging along with the U.S. any further on Ukraine.

The probability of discord in the transatlantic relationship is rising. NATO itself has never really been the robust united alliance that was made out to be. Polish President Andrzej Duda's decision to attend the Winter Olympics in Beijing is a harbinger of things to come. (Incidentally, Putin will also be in Beijing at that time.) Germany opposes not only the removal of Russia from Swift but also the supply of weapons by NATO countries to Ukraine as well as Lithuania's move (under U.S. advice) to switch ties to Taiwan!

U.S. made a strategic blunder to have encouraged a deeper NATO imprint in Ukraine. Making half-promises thereby to a non-NATO country is going to damage the U.S.' credibility in the downstream of a Russian intervention. But it is impossible for Washington to backtrack now, as the loss of credibility will be even more.

What remains to be seen, equally, is how the European Union survives this moment. The ardent Atlanticists in the European Commission in Brussels led by Ursula von der Leyen and the Russia-hater Josep Borrell are unilaterally setting the EU agenda currently, ignoring the glaring divergences of opinion among the member states. With Angela Merkel's departure, a vacuum has appeared which these Eurocrats hope to fill in.

But this is clearly unsustainable. [Addressing the European Parliament](#) in Strasbourg last week, French President Emmanuel Macron has urged Europe to invest in its own collective security framework and called for a "frank" EU dialogue with Russia. By the way, neither the EU nor France was involved in the direct talks between the U.S. and Russia in Geneva.

Much is being made out of the threat of sanctions against Russia. But such threats won't deter Moscow. For a start, even draconian sanctions have proved to be a weak coercive tool. Indeed, US sanctions had a poor coercive track record in North Korea, Cuba, Iran, Venezuela, Vietnam, etc.

Russia is a big power. It has huge reserves, which currently stand at a record \$638.2 billion — the fourth largest in the world. Russia's credit position is good and it owns much of its debts. It has no critical need of U.S. investors. Russia is in no desperate need to sell its currency.

Having gone through four traumatic shocks previously in its 30-year post-cold war history, Russia knows how to absorb shocks. Therefore, while Russia may take a big hit and there could be currency volatility causing outflow of capital initially following the sanctions, its reserves give it a big cushion.

At any rate, how far the Europeans will want to go on the sanctions path remains to be seen. Germany has voiced reservations about Washington's famous "nuclear option", namely, the expulsion of Russia from the Swift payment system. To be sure, any disruption in Russian energy supplies will hurt the European economies.

A little known fact is, Russia sells gas at very low prices to Europe, whereas, any LNG supplies from the U.S. to make up for Russian supplies will mean exorbitant prices jacking up the cost of industrial production. Central European countries depend on Russia for 100 percent of their energy needs. Germany has a 40% dependency.

According to reports, a highlight of Putin's forthcoming visit to Beijing will be the signing of the agreement of the mammoth Power of Siberia-2 gas pipeline project to construct an additional route to send gas to China gas from Siberia's Yamal Peninsula, where Russia's biggest gas reserves are, via Mongolia. The capacity of the pipeline is expected to be 60 billion cubic meters of natural gas annually (which exceeds the capacity of Nord Stream 2.)

Significantly, trade turnover between China and Russia has reached a record \$146.88 billion in 2021, up 35.8% from the previous year. Most certainly, the standoff between Russia and the West over Ukraine, which could bring new sanctions against Moscow, is likely to tighten the Kremlin's bond with Beijing even more. The two countries have vowed to raise their trade turnover to \$200 billion by 2024. Recent economic trends alone suggest the countries are likely to reach that goal.

The rising geopolitical tensions would add momentum to this effort by making stronger trade ties with China a necessity for the Kremlin. Moscow will need to increase sourcing capabilities elsewhere because of U.S. sanctions, and China will be one major avenue. The big picture is that on its part, China too cannot afford to see Russia going down under U.S. pressure.

Evidently, the U.S. hasn't thought through the escalatory ladder. The Kremlin has threatened Washington with a complete break in relations if push comes to shove. Trust Moscow to hit back. Russia conducted an anti-satellite test in May by taking out a satellite. Possibly, it was a signal that Russia has the capability to interfere with the GPS constellation in non-military fields, which can affect key sectors of the U.S economy.

Above all, any "sanctions from hell" will inevitably turn into a morality play on the world stage. There'll be increasing blowback in the world economy as countries get concerned about Washington's weaponization of the dollar. Some may even feel prompted to harden their economy. This can impact the international financial market. Washington backtracked previously when such situations arose. (Washington chose not to impose sanctions against India under CAATSA for its purchase of the S-400 missile system from Russia.)

Paradoxically, thanks to wave after wave of Western sanctions since 2014, Russia has become much more autarchic. Today, it needs no inputs from the West for its defense industry to develop new weapon systems. Pentagon officials have admitted that Russia has taken the lead in cutting edge technology such as hypersonic missiles, and catching up may take three to five years — that is, assuming that the Russian defense industry is resting its oars.

On January 18, 2022 Paul Craig Roberts, a former President Reagan cabinet member wrote a piece that states the issue succinctly, "Can Humanity Survive Washington's Delusional Belief in its Omnipotence?"

"The Russians called a security conference with Washington and NATO. The Russians explained that security is a joint undertaking and that security only exists if every country feels secure. The CIA responded with accusations against Russia handed to the CIA-puppet Biden regime and the CIA-puppet US media. The national security advisor read the script to us peons: Russia intends a false flag attack on its own troops so that it will have an excuse to invade Ukraine.

The national security advisor is so stupid that it does not occur to him that if Russia wants to invade Ukraine Russia will. Russia needs no excuse, and there is no one in Washington or NATO who can do anything about it.

The Russians explained that they do not feel secure. They are constantly demonized, sanctioned on the basis of accusations in the Western press, and their president insulted. Washington broke its word given to Gorbachev and has not only moved NATO to Russia's borders but also established

missile bases in Poland and Romania. Washington has overthrown the Ukraine government in an attempt to evict Russia from her Black Sea naval base, established a puppet Ukrainian government hostile to Russia and to the Russian population of eastern Ukraine, and is gradually invading Ukraine economically and militarily with Americans on the ground training Ukrainians in the use of the American supplied arms.

On top of all of this, Washington and NATO are talking about making Ukraine, formerly a province of Russia, and another former province of Russia, Georgia, members of NATO which shows indications of ringing Russia with bases in preparation for war.

Russia explained that the situation is so threatening that it is unacceptable. During the long Cold War the two powers tried to reduce tensions by stabilizing the relationship, but in the 21st century Washington has disavowed all the arms control agreements that were accomplished in the 20th century, and has behaved aggressively toward Russia.

Russia explained that she will no longer tolerate the implied threat of US/NATO bases on her borders and most certainly will not permit Ukraine and Georgia to be members of NATO. Any move by the West in this direction will result in "dire consequences."

As an old cold warrior as a member of the anti-Soviet Committee on the Present Danger and as a member of a secret presidential committee that helped Reagan end the Cold War, I can tell you that I am astonished that Washington has not heard what the Russians have, in all frankness, told them.

If the Committee on the President Danger had heard the Russians say this in the 1980s, we would have told President Reagan to acknowledge their concern and reduce the tension.

Today the situation is so different that to an experienced cold warrior such as myself it is extremely scary. According to Russian news reports, Russia is moving four entire armies from the far east to the Western front. These four armies, even without those already present in western Russia, are sufficient to instantly destroy any force NATO and the U.S. can muster and overrun all of Europe in a few days.

Moreover, Russia can likely mobilize 10 million troops quickly, and China, whose president has stated publicly that China has more than a treaty agreement with Russia, can mobilize 50 million soldiers. NATO, for all the bluster of its idiot Secretary General, has zero prospect of withstanding Russia in non-nuclear war.

This means, and the Kremlin knows this, that to save face Washington would have to go nuclear. This would mean the total destruction of the US and Europe. They would cease to exist.

For Russia with its extensive anti-missile defenses and nuclear bunkers for 40-50% of targeted populations, the war would be disastrous, but Russia would survive.

Russia does not want such a war. Russia doesn't want to destroy anyone, not even Ukraine. Russia has asked for a security guarantee. That is all.

If we experience Armageddon, it will be only because Washington refused a security guarantee to Russia."

For those I would classify "history challenged" they would have to go back a few hundred years to understand that this is Jesuit-revenge for being evicted from Russia. The Jesuits were expelled from St. Petersburg and Moscow in 1815, from the whole empire in 1820. Pope Clement XIV yielding to pressure from the Bourbon courts, fearing the loss of his Papal States, and anticipating that other European countries would follow the example of Henry VIII (who abandoned the Catholic Church and took his whole country with him), issued his brief *Dominus ac Redemptor* suppressing the Society of Jesus. This religious Society of 23,000 men dedicated to the service of the church was disbanded. The property of the Society's many schools was either sold or made over into a state controlled system. The Society's libraries were broken up and the books either burned, sold or snatched up by those who collaborated in the Suppression. As if unsure of himself the Pope promulgated the brief of suppression in an unusual manner which caused perplexing canonical difficulties. So when Catherine, Empress of Russia, rejected the brief outright and forbade its promulgation, 200 Jesuits continued to function in Russia.

That Jesuits take their special vow of obedience to the pope quite seriously is evident from their immediate compliance with distasteful papal edicts. Clement XIV's Suppression is one example. Another occurred earlier in 1590 when Pope Sixtus V wanted to exclude Jesus from the official name of the Society. Jesuits immediately complied and offered alternate names but Sixtus died unexpectedly before his wish could be carried out. Included among these occasional papal intrusions in the Society's governance was Pope John Paul II's appointment of a delegate to govern the Society during Superior General Arrupe's illness. So edified was he at the Society's immediate compliance that the pope later lavished extraordinary praise on the Jesuit Order.

The Society was restored 41 years after the Suppression in 1814 by Pope Pius VII. Although many of the men had died by then, the memory of their educational triumphs had not, and the new Society was flooded with requests to take over new colleges: in France alone, for instance, 86 schools were offered to the Jesuits. Since 1814 the Society has experienced amazing growth and has since then surpassed the apostolic breadth of the early Society in its educational, intellectual, pastoral and missionary endeavors.

In every major worldwide events such as civil wars, world wars, revolutions, rebellions, terrorism, assassinations, political, social and all kinds of turmoil's or chaos - the Jesuits are the orchestrator. Many historians and writers such as ERIC JON PHELPS, AVRO MANHATTAN, ALBERTO RIVERA, JOHN LOFTUS, EDMUND PARIS, DARYL EBERHART, DAVID GUYAT, ALEXANDER JAMES, CHARLES CHINIQUY, JOSE RIZAL, and OTHERS point their finger to the Jesuits and the Vatican as the culprits.

After the Great Schism of 1054, the eastern churches developed into the Eastern, Greek, and Russian Orthodox Churches, while the western churches formed into the Roman Catholic Church. The two branches remained on friendly terms until crusaders of the Fourth Crusade captured Constantinople in 1204. To this day, the schism has not been wholly mended.

Most contentious of all and the conflict which brought the Great Schism to a head was the issue of ecclesiastical authority—specifically, whether the pope in Rome held power over the patriarchs in the East. The Roman Church had argued for the primacy of the Roman pope since the fourth century and claimed that he held universal authority over the whole church. Eastern leaders honored the pope but refused to grant him the power to determine policy for other jurisdictions or to alter the decisions of Ecumenical Councils.

In the years leading up to the Great Schism, the church in the East was led by the Patriarch of Constantinople, Michael Cerularius (circa 1000–1058), while the church in Rome was led by Pope Leo IX (1002–1054).

At the time, problems sprang up in Southern Italy, which was part of the Byzantine Empire. Norman warriors had invaded, conquering the region and replacing Greek bishops with Latin ones. When Cerularius learned that the Normans were forbidding Greek rites in the churches of Southern Italy, he retaliated by shutting down the Latin rite churches in Constantinople.

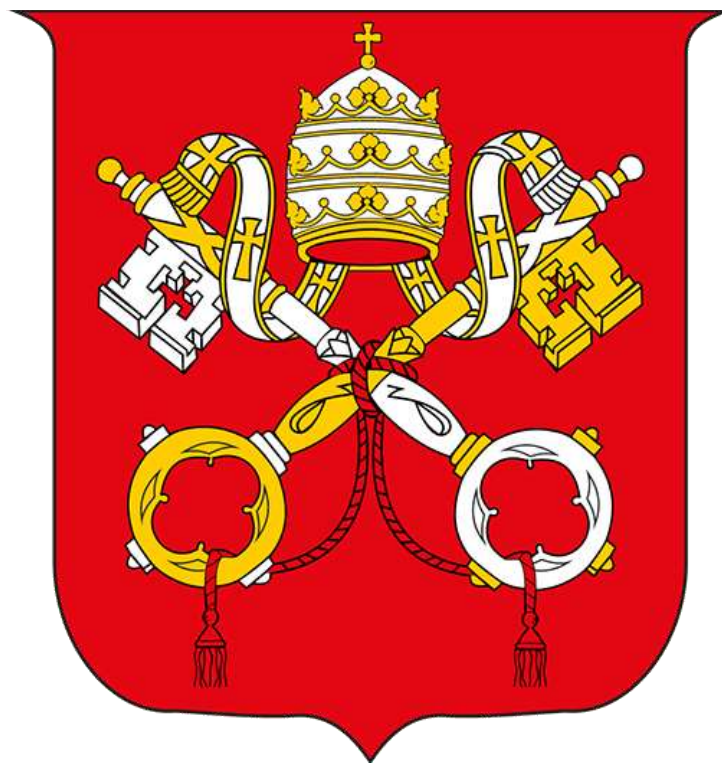
There have been many overtures to reconciliation but discord runs deep in history. The U.S. just sent 180 tons of weapons to Ukraine and more is on the way.

The U.S. has flown about 180 tons of weapons into Ukraine in the past three days, in an effort to bolster the countries defenses against a possible Russian invasion. So far, the U.S. has delivered the first two weapons shipments on military cargo flights, with more shipments to follow. The U.S. Embassy in Kyiv, Ukraine announced the arrival of the first 100 tons of weapons for Ukraine on Friday night.

“The first of several parties to the security package recently approved by President Biden for Ukraine arrived in Kyiv tonight. This cargo includes about 200,000 pounds of lethal weapons, including ammunition for the defenders of Ukraine on the front line,” the U.S. embassy said in a translated tweet.

On Sunday, a second 80-ton load of weapons arrived in Ukraine. Ukrainian Defense Minister Oleksei Reznikov tweeted several photos of the weapons shipment.

“The second bird in Kyiv! More than 80 tons of weapons to strengthen Ukraine’s defense capabilities from our friends in the USA!,” Reznikov wrote. “And this is not the end. P.S. the cargo arrived under dependable protection @WhiteHouse@congressdotgov@USEmbassyKyiv@UKRintheUSA.”

According to Reuters, the U.S. is sending a total of \$200 million in defensive aid to Ukraine. The tons of lethal aid comes to Ukraine as Russia has gathered around 100,000 troops on Ukraine's borders for months. Last week, the Biden administration warned Russia could invade "at any point."

In addition to these U.S. weapons shipments, the Biden administration is reportedly working through the process to [transfer ownership of five Mi-17 transport helicopters to Ukraine](#). The Russian-made transport helicopters were reportedly purchased to give to the U.S.-backed Afghan government before its collapse, and are already in the Ukraine where they were being prepared to hand over ownership.

Ukraine already uses Mi-17 transport helicopters and the five additional helicopters could theoretically be integrated into their fleet with minimal additional training required. Various versions of the helicopter can carry between 24 and 37 troops. Some variants can also be equipped as gunships, carrying rocket pods and machine guns.

The U.S. has also reportedly granted permission to North Atlantic Treaty Organization (NATO) allies Estonia, Latvia and Lithuania to begin transferring their own stockpiles of U.S. military equipment to Ukraine.

Latvia and Lithuania would reportedly provide the anti-aircraft missiles, which could help Ukrainian forces fend off Russian aircraft. Russia's helicopters and planes would likely prove crucial early on in a Russian invasion of Ukraine, attacking ground targets and rapidly moving troops and supplies to outmaneuver Ukrainian defenses.

U.S. Defense Secretary Lloyd Austin has placed 8,500 troops on "*heightened preparedness to deploy*" to Europe in case NATO decides to activate its rapid-response force over the ongoing situation in Ukraine, the Pentagon said Monday.

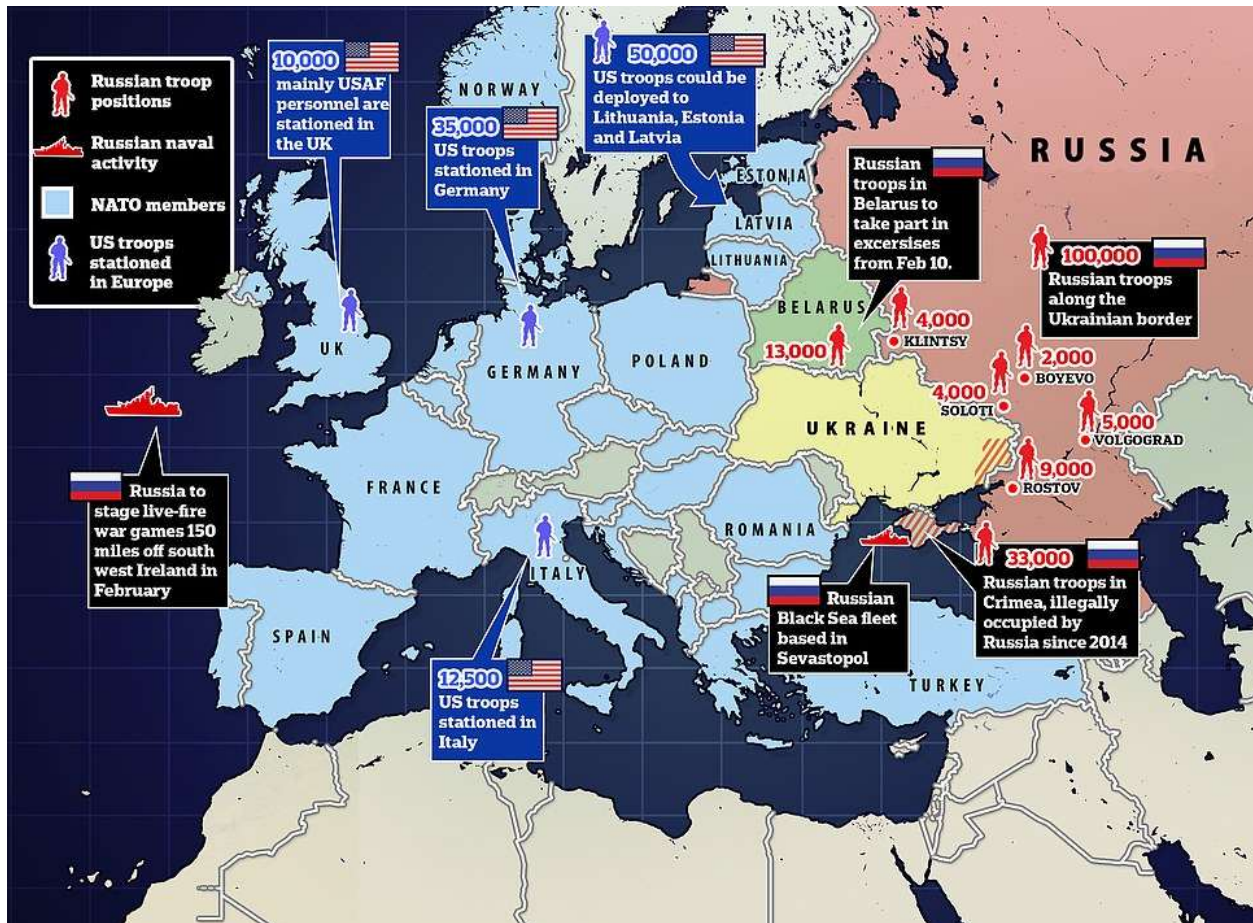
The troops have been placed on "*higher alert only*" and "no final decision has been made to deploy them," Pentagon spokesman John Kirby told reporters.

The deployment may happen if and when NATO decides to activate its rapid response force (NRF), which consists of about 40,000 troops from various member countries. Kirby said the US maintains "*significant combat capable forces forward in Europe to deter aggression.*"

Earlier in the day, the New York Times reported that the White House was considering a plan to send between 1,000 and 5,000 troops to the Baltics and Eastern Europe as a way to deter Russia from "invading" Ukraine. US intelligence has claimed an invasion was imminent since late October. Moscow has dismissed the accusation as "*fake news.*"

The map below is a close rendition of military forces at present in the region and may be somewhat higher at this point. I have been watching radar activity of "heavy lifters" flying to Europe from CONUS for weeks. "Heavy lifters" is a term for aircraft such as the

C-17, C-130s. The U.S. Air Force operates a fleet around 230 of an original 275 C-17s, the main work force of military air transports. Observations on Flight Watch show a steady flow of C-17s about one an hour around the clock departing for airports in the UK and Europe. This pattern is indicative of something much larger than the Biden administration implies. Nothing you hear from the mainstream media and government sources can be trusted, for good reasons or not.
