I came across a copy of the above the other day by sheer accident, well maybe it might not be an accident after all, and perhaps an act of providence. However you want to perceive it, it struck a chord with me since I did an article some months ago about Dr. Jeff Bradstreet, fellow physicians and genetic researchers investigating the causes of cancer, but they had all died mysteriously. Over a hundred physicians and genetic researchers met with an early and mysterious end of their lives. Many were murdered, poisoned, vehicle accidents, etc. It might have been what Dr. Bradstreet had

discovered that led to his murder. Dr. Bradstreet found the protein Nagalase in the bloodstream of hundreds of children he was treating for Autism. The death of Dr. Bradstreet got the attention of *'Health Nuts News'*, and *'All News Pipeline'*. This is what they wrote:

The 77 holistic doctors “murdered” since 2015 did not die from natural causes. This number doesn't reflect ALL of the holistic doctors who have died since 2015, just the ones under peculiar circumstances.

From the start, with the discovery of Dr. Jeff Bradstreet on June 19, 2015, found in a river with a gunshot wound to his chest, which was labeled a suicide, there have been strange circumstances surrounding these deaths, such as the rarity of someone shooting themselves in the chest, rather than the head, as a method of suicide.

The very same day in Mexico, three doctors went missing and when their bodies were discovered the families said the bodies were not those of their missing family members, and despite that fact, the government declared them dead.

When Rigoberto Hernandez stepped into the morgue, in late June, to identify his recently abducted son—he knew right away there had been a mistake. “It wasn't him,” Hernandez told *The Daily Beast* during a recent demonstration outside the state capitol building to protest the government's handling of the case. “I raised him from a baby, so I ought to know. The body presented [by the government] didn't look anything like my boy.” The Hernandez family joined about 50 doctors and nurses at the July 2 demonstration, braving the desert heat. The protesters chanted and waved signs outside the locked gates of city hall, demanding “Due process!” and “Security for health-care workers!” “Our family said we couldn't accept a body that wasn't ours,” Hernandez explained. “But the DA declared my son dead anyway.”

Two days later, in Florida, two chiropractors were found dead, separately, and to this date no cause of death has been reported.

On June 29, 2015, two more holistic practitioners were found dead in separate states, one murdered, the other went missing and when he was found, his death was ruled as a suicide by gun, yet even local news was calling the entire investigation a “mess,” and taking authorities to task for conflicting storylines and a lack of transparency in revealing results.

With those eight deaths within a two week time frame, *'Health Nut News'* “Unintended” series into the deaths of holistic doctors began, documenting each case, with updates, leading up to this most recent death of Annie Fairbanks and her whole family.

MYSTERIOUS DISAPPEARANCES AND DEATHS

While we will not “reinvent the wheel” by detailing each individual death leading to the 77th, because all the information can be found at the link above, we will highlight some of those that can logically be considered mysterious.

July 3, 2015 – Patrick Fitzpatrick MD went missing, has never been found and authorities say it is like he “vanished into thin air.”

July 21, 2015- Two doctors, Dr. Nicholas Gonzalez and Dr. Abdul Karim, died, both supposedly of heart attacks, although in Gonzalez’s case, the autopsy did not show any heart attack symptomology, and according to *‘Health Nut News’* *“Dr. Gonzalez also said in several interviews, including the last one before he died, that he thought big pharma wanted him to get hit by a bus or that he might die suddenly.”*

August 12, 2015 – Osteopath Mary Bovier is found slain to death in her home in Pennsylvania. Her significant other, who we’re told is also an osteopath, was questioned and released. There have been no further arrests and no other suspects.

From June to November 2015, *‘Health Nut News’* had documented the death 26 deaths, noting a “dozen plus accidental deaths and freak accidents, mostly holistic doctors.”

Under Elizabeth’s “Late December 2015 – January 2016” category, she notes that she hadn’t “included PhD’s in the series (unless they were also an MD, DO or DC),” but ran across another disturbing trend, which she describes as *“a spate of cancer researchers killed, which hadn’t happened previously.”*

Aside from the spate of cancer researchers, there are also very disturbing updates on earlier investigations, such as the saga shown below:

30) January 23, 2016 – A top MD, John Marshall, 49, former 4th generation Marine who’d served in Afghanistan and had survival training, was found dead in the Spokane River. His body was recovered that day. He was said to be in great shape and was on his usual run after his workout at the gym (the man was fierce). Authorities say he had somehow fallen into the river and drowned, and quickly concluded it was death by drowning.

UPDATE 1: A former detective was ordered to stop his investigation into the links between the suspicious deaths of Drs. John Marshall and Brenda Thurman.

UPDATE 2: Dr. Suzan Marshall (wife of Dr. John Marshall) believes her husband was murdered, despite a police investigation and autopsy report that determined it was an accidental drowning.

UPDATE 3: Dr. Marshall’s wife hired a private investigator, and is questioning the quick call by Seattle PD. She even said someone is trying to silence her. The prominent investigator states on CBS news that the “accidental death” of Dr. Marshall is most likely

a professionally staged murder by someone in the military or police. Again, more families are questioning these deaths and what some find absurd rulings by authorities.

In yet another instance, a friend of the doctor that started Health Nut News on this series, died and while she was not a holistic practitioner, she was a nurse who had warned that is anything happened to her, do not assume it was an accident.

35) February 1, 2016 – Just a week later, to the day, after losing our local friend and holistic doctor, Rod Floyd, we lost another friend from our holistic community. The wonderful, young Paige Adams FNP, B-C, who also lived up the road from us, was found dead in her home. She had worked closely for many years with her good friend and colleague Dr. Bradstreet, whose death started off this holistic series. Now we have his close friend and colleague found dead. This is particularly heartbreaking because she was so young. Paige Adams had asked to stop by our house to visit days before she died. I feel awful for not taking her up on that and my heart goes out to her family and patients. She's the only one in this series who's not a doctor—DC, MD, DO—but she was a board certified Nurse Practitioner whose patients raved about her endlessly. She also stated publicly (which you'll see in the link) that if anything happened to her, don't assume it was an accident.

Another strange coincidence of note:

50) June 11, 2016 – We discover that yet another holistic doctor has allegedly committed suicide. Dr. Alex Shvartsman, dentist and naturopathic doctor, killed himself at home over the weekend. We're now hearing that he, Mitch Gaynor MD (#11 in our series), and Nick Gonzalez MD (#8 or #9- we had two found dead that day) were all speaking at an event last fall that also included Steve "Sproutman". Steve was killed in a strange car accident. We wrote about what happened, but didn't include his case in the series. Dr. Gaynor allegedly took his own life, while Dr. Gonzalez allegedly had a heart attack. His wife then updated the public that it didn't appear to be the case, and that they couldn't find a cause of death. Now Dr. Alex (allegedly) took his life. All in a matter of months. All of them spoke at the same Health Expo in the northeast. This is breaking news I found out late Father's Day night.

From late December to January 2016, another 7 are listed. From January 2016 until 2017, another 34 deaths had been documented and another 15 so far in 2017.

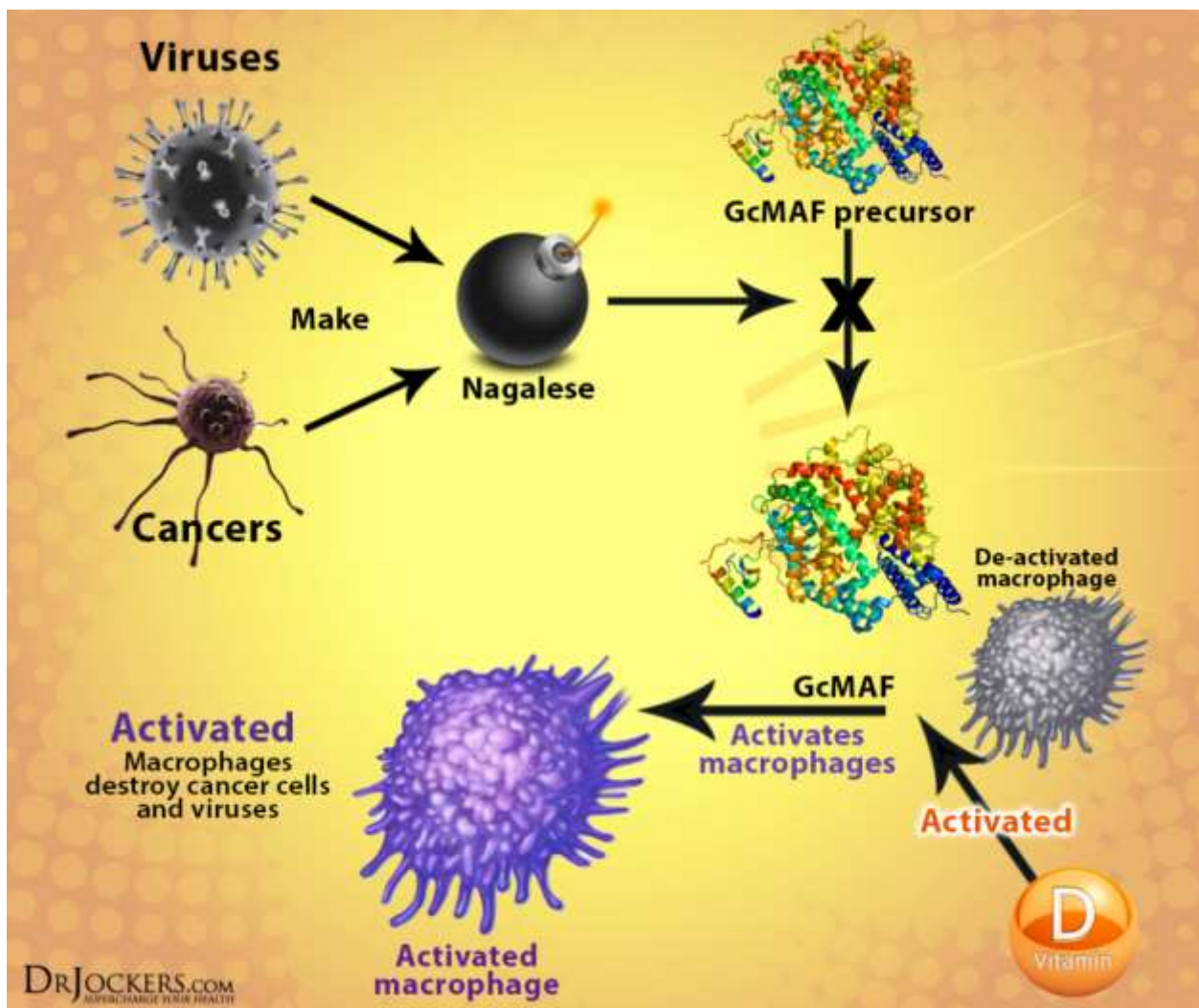
A lot of these doctors were studying the protein GcMAF.

A suspiciously high amount of holistic doctors have recently turned up dead or missing within a very short time. One thing these 8 doctors appear to all have had in common was their use of GcMAF in treating patients.

This new treatment is reported to produce amazing results for a great many ills, such as: cancer, autism, bacterial and viral diseases, neurological diseases like Parkinson's and Alzheimer's, as well as inflammatory conditions, such as arthritis.

Three days before he was found dead, U.S. govt. agents raided Dr. Bradstreet's medical facility to seize a breakthrough cancer treatment called GcMAF

Leading up to his death, Bradstreet was working with a highly controversial molecule that occurs naturally within the human body and is believed to be capable of treating and reversing autism.

Researchers claim that [GcMAF \(Globulin component Macrophage Activating Factor\)](#), which becomes the GC protein after combining with vitamin D3 in the body, is effective for treating HIV, diabetes and diseases of the liver and kidneys. More importantly, GcMAF experts predict that the natural molecule has the potential to be a universal cure for cancer. D3 is an important vitamin in so many areas, and has kept Mycoplasma in check in many known diseases.

Due to the controversial nature of Bradstreet's research, as well as the fact that his office was raided by officials with the U.S. Food and Drug Administration in the days leading up his death, the physician's family hired a private investigator in hopes of finding the truth about Bradstreet's untimely demise.

Finally, new details regarding Bradstreet's death have been revealed through a recent interview conducted by the producer of the documentary VAXXED. Polly Tommey sat down with Bradstreet's baby brother Thom and his lovely wife Candice at the Autism-One conference held towards the end of last month at the Loews Chicago O'Hare Hotel in Rosemont, Illinois.

Thom said that while the family knew in their hearts that Bradstreet was murdered, it wasn't until they had the opportunity to review the case forensically that they realized the evidence supports their theory that his death was in no possible way a suicide, as has been reported by police and the mainstream media.

"People who knew him knew he would never take his own life," said Thom, adding that information uncovered by a forensic scientist hired by the family validates that conjecture. After meeting with the medical examiner and reviewing case files and photographs, the private forensic scientist ruled that Bradstreet's death was absolutely not a suicide.

"It is our 100 percent belief that Jeff did not commit suicide. Not only because of who Jeff was as a person, but because we looked at the science of it; we looked at the medical proof and it's just not possible that Jeff took his own life," commented Thom.

"Unfortunately, there's an ongoing investigation so there's not a lot we can share about the specifics. But the way the bullet entered into the body, it's almost impossible for an individual to do that and it was far enough away that it left no tattooing, no significant burn marks or anything like that."

'Where would the world of autism be without Jeff Bradstreet?'

Bradstreet's younger brother noted that while it would be easy to say the murder was a conspiracy due to his controversial (and highly effective) work, they can't yet say for

sure, adding that they must know for sure before reaching any conclusions regarding the perpetrator(s)' identity.

The family said that while they are still overcome with immense sadness, they know that Bradstreet is in heaven because he was a “*great man of faith*” who loved God.

“The sadness is to know that there’s all these parents out here, existing patients of Jeff or recently diagnosed, where do they go? Where would the world of autism be without Jeff Bradstreet? [Without] his 20 years of knowledge and input and experience, where would we be?” asked Thom.

The Bradstreet’s asked the public for patience while they attempt to uncover who may have been behind their loved one’s death.

When I heard he died, I had a feeling he was bumped off by the pharmaceutical industry. The war has just begun, and it is going to be a war. Look at all the scientists they were afraid of being exposed that were suicided and died under suspicious circumstances. Look at all of the banksters that were suicided last year. Bradstreet has held a Florida medical license since 1984. He obtained his Bachelor of Science degree from the University of South Florida in 1976 in Natural Sciences, where he also went to medical school beginning three years later. His postgraduate research focused on aerospace medicine, and received his training in this field from Wilford Hall Medical Center. He is currently an adjunct professor of child development and neuroscience at the Southwest College of Naturopathic Medicine in Tempe, Arizona.

[4] Bradstreet has published some controversial autism research, which implicates vaccines in the causation thereof, in the fringe journal '*Journal of American Physicians and Surgeons*', which is not indexed by PubMed. This research has concluded that autistic children have a higher body burden of mercury,

[5] as well as that three autistic children have measles virus RNA in their cerebrospinal fluid.

[6] This research was originally presented to the Institute of Medicine before they published their report concluding that the evidence favors rejection of a relationship between vaccines and autism.

[7] Bradstreet treated an autistic child named Colten Snyder (who was one of the test cases in the autism omnibus trial) with chelation therapy. This he did in spite of the fact that, according to Denise Vowell, *"The April 29, 2000 hair test for mercury demonstrated a low level of mercury in Colten's hair, but one within the reference range of normal for the laboratory, and one well below the 90th percentile for U.S. children ages six to eight."* In addition, Vowell stated, *"The more disturbing question is why chelation was performed at all, in view of the normal levels of mercury found in the hair, blood and urine, its apparent lack of efficacy in treating Colten's symptoms, and the adverse side effects it apparently caused."*

[8] Over an eight-year period, Colten visited Bradstreet's office 160 times.

[9] Stephen Barrett has stated, *"It appears to me that Bradstreet decides which of his nonstandard theories to apply and records diagnoses that embody them,"* and describes Bradstreet's mercury provoked tests as "phony".

[8] His son has autism, which Bradstreet attributes to a reaction he experienced to a vaccine at the age of 15 months.

[10] In an interview with the *'Chicago Tribune'*, Bradstreet defended the use of intravenous immunoglobulin as an autism treatment, saying, *"Every kid with autism should have a trial of IVIG if money was not an option and IVIG was abundant."*

[11] Bradstreet has also published some research regarding the use of hyperbaric oxygen therapy for autism,

[12] some of which has concluded that it is ineffective,

[13] as well as a paper arguing that autistic children have an increased vulnerability to oxidative stress.

[14] Further treatments Bradstreet frequently uses on autistic children include Gc-MAF, which he claims to have treated 600 children with.

[15] In an article in *'Autism Science Digest'*, Bradstreet endorsed stem cell therapy as an autism treatment, writing, *"By natural design, the purpose of stem cells in the brain is regulation, healing, and repair. Biologically, therefore, stem cells appear to be better suited to heal the brain than any other current therapy. No matter how challenging the task of repairing the brain may appear to be, case reports have built an argument for supporting the reversibility of autism using immunological interventions."*

Multiple law enforcement officials said the U.S. Food and Drug Administration searched Bradstreet Wellness Center last week. On Monday, plastic sheets covered the windows of the two suites the office takes up in a complex off Commerce Drive, and the doors were locked."

JENNER, EDWARD (1749-1823), the discoverer of vaccination. was born at Berkeley, Gloucestershire, on May 17, 1749. His father, the Rev. Stephen Jenner, rector of Rockhampton and vicar of Berkeley, came of a family that had been long established in that county, and was possessed of considerable landed property; he died when the subject of this notice was only six years old, but his place was admirably taken by his eldest son, the Rev. Stephen Jenner, who brought his brother up with paternal care and tenderness. Edward received his early education in local schools at Wotton-under-Edge and Cirencester, where he already showed a strong taste for natural history. The medical profession having been selected for him, he began his studies under Mr. Ludlow, a surgeon of Sodbury near Bristol; but in his twenty-first year he proceeded to London, where he became a favorite pupil of the celebrated John Hunter, in whose house he resided for two years. During this period he was employed by Sir Joseph Banks to arrange and prepare the valuable zoological specimens which he had brought back from Captain Cook's first voyage in 1771. He must have acquitted himself satisfactorily in this task, since he was offered the post of naturalist in the second expedition, but declined it as other advantageous offers, preferring rather to practice his profession in his native place, and near his eldest brother, to whom he was much attached. His speedy success in practice did not engross his intellectual activity. He was the principal founder of a local medical society, to which he contributed several papers of marked ability, in one of which he apparently anticipated later discoveries concerning the rheumatic inflammations of the heart. He maintained a correspondence with John Hunter, under whose direction he investigated various points in biology, particularly the hibernation of hedgehogs and the habits of the cuckoo; his paper on the latter subject was laid by Hunter before the Royal Society, and appeared in the Philosophical Transactions for 1788. He also devoted considerable attention to the varied geological character of the district in which he lived, collecting fossils from the Oolite and Liss, and constructed the first balloon seen in those parts.

He was a great favorite in general society, from his agreeable and instructive conversation, and the many accomplishments he possessed. Thus he was a fair musician, both as a part-singer and as a performer on the violin and flute, and a very successful writer, after the fashion of that time, of fugitive pieces of verse, one of which—"The Signs of Rain"—has been frequently reprinted, and enumerates minutely all the signs of the weather in verse not unworthy of Crabbe. In 1788 he married Catherine Kingscote, a union destined to form a most important element in his happiness. In 1792

be resolved to confine himself to practicing as a physician, and accordingly obtained the degree of doctor of medicine from St Andrews. Finding that Berkeley could not support a physician, he began, a few years later, to visit Cheltenham annually.

Meanwhile the discovery that was to immortalize his memory had been slowly maturing in his mind. When only an apprentice at Sodbury, his attention had been directed to the relations between cow-pox and small-pox in connection with a popular belief which he found current in Gloucestershire, as to the antagonism between these two diseases. During his stay in London he appears to have mentioned the thing repeatedly to Hunter, who, being engrossed by other important pursuits, was not so strongly persuaded as Jenner was of its possible importance, but spoke of it to his friends and in his lectures. After he began practice in Berkeley, Jenner was always accustomed to inquire what his professional brethren thought of it; but he found that, when medical men had noticed the popular report at all, they supposed it to be based on an imperfect induction of facts. His first careful investigation of the subject dates from about 1775, and five years elapsed before he had succeeded in clearing away the most perplexing difficulties by which it was surrounded. He first satisfied himself that two different forms of disease had been hitherto confounded under the term "cow-pox," only one of which protected against small-pox, and that many of the cases of failure were to be thus accounted for; and his next step was to ascertain that the true cow-pox itself only protects when communicated at a certain stage of the disease.

At the same time he came to the conclusion that "the grease" of horses is the same disease as cow-pox and small-pox, each being modified by the organism in which it was developed--an opinion which is generally held at the present day. For many years, cow-pox being scarce in his county, he had no opportunity of inoculating the disease, and so putting his discovery to the test, but he did all he could in the way of collecting information and communicating what he had ascertained. Thus in 1788 he carried a drawing of the cow-pox, as seen on the hands of a milkmaid, to London, and showed it to Sir E. Home and others, who agreed that it was "an interesting and curious subject" but by no means realized its practical importance. At length, on the 14 of May, 1796, he was able to inoculate James Phipps, a boy about eight years old, with cow-pox matter. On the first of the following July the boy was carefully inoculated with variolous matter, but (as Jenner had predicted) no small-pox followed. The discovery was now complete, but he desired to act without precipitation, and was unable to repeat his experiment until 1798, owing to the disappearance of cow-pox from the dairies. He then repeated his inoculations with the utmost care, and prepared a pamphlet which should announce his discovery to the world. Before publishing it, however, he thought it well to visit London, so as to demonstrate the truth of his assertions to his friends; but he remained in London nearly three months, without being able to find any person who would submit to be vaccinated. Soon after he had returned home, however, Mr. Cline, an eminent surgeon, inoculated some vaccine matter over the diseased hip-joint of a child, thinking the counter-irritation might be useful, and found the patient afterwards incapable of acquiring small-pox. In the autumn of the same year, Jenner met with the first opposition to vaccination; and this was the more formidable because it proceeded from Dr. Ingenhousz, a celebrated physician and man of science. But meanwhile Mr. Cline's

case, and his advocacy of vaccination, brought it much more decidedly before the medical profession, of whom the majority were prudent enough to suspend their judgment until they had more ample information. But besides these there were two noisy and troublesome factions, the one of which opposed vaccination as a useless and dangerous practice, while the other endangered its success much more by their rash and self-seeking advocacy. At the head of the latter was one Dr. Pearson, who in November 1798 published a pamphlet speculating upon the subject, before even seeing a case of cow-pox, and afterwards endeavored, by lecturing on the subject, and supplying the virus, to put himself forward as the chief agent in the cause. The matter which he distributed, which had been derived from cows that were found to be infected in London, was found frequently to produce, not the slight disease described by Jenner, but more or less severe eruptions resembling small-pox. Jenner concluded at once that this was due to an accidental contamination of the vaccine with variolous matter, and a visit to London in the spring of 1799 convinced him that this was the case.

In the course of this year the practice of vaccination spread over England, being urged principally by non-professional persons of position; and towards its close attempts were made to found institutions for gratuitous vaccination and for supplying lymph to all who might apply for it. Pearson proposed to establish one of these in London, without Jenner's knowledge, in which he offered him the post of honorary corresponding physician. On learning of this scheme to supplant him, and to carry on an institution for public vaccination on principles which he knew to be partly erroneous, Jenner once more visited London early in 1800, when he had influence enough to secure the abandonment of the project. He was afterwards presented to the king, the queen, and the prince of Wales, whose encouragement materially aided the spread of vaccination in England. Meanwhile it had made rapid progress in the United States, where it was introduced by Dr. Waterhouse, the professor of physic at Cambridge, Massachusetts, and on the continent of Europe, where it was at first diffused by Dr. de Carro of Vienna, who practiced it with the greatest zeal and discretion, and thence spread to Geneva. In consequence of the war between England and France, the discovery was later in reaching Paris; but, its importance once realized, it spread rapidly over France, Spain, and Italy. It would be tedious and unprofitable to dwell minutely on the extension of vaccination over the whole world; but a few of incidents connected with it are too remarkable to be omitted. Perhaps the most striking is the expedition which was sent out by the court of Spain in 1803, for the purpose of diffusing cow-pox through all the Spanish possessions in the Old and New Worlds, and which returned in three years, having circumnavigated the globe, and succeeded beyond its utmost expectations. Many of the expressions of enthusiasm seem to us strained and almost ridiculous. Thus we read with surprise how clergymen in Geneva and Holland urged vaccination upon their parishioners from the pulpit; how in Sicily, South America, and Naples religious processions were formed for the purpose of receiving it; how the anniversary of Jenner's birthday, or of the successful vaccination of James Phipps, was for many years celebrated as a feast in Germany; and how the empress of Russia caused the first child operated upon to receive the name of "Vaccinoff," and to be educated at the public expense. The truth is that we who live in that security from the horrible and universal plague of small-pox for which we are indebted to Jenner's immortal discovery cannot

realize the greatness of the blessing he conferred upon mankind. This universal enthusiasm caused vaccination to spread over the whole world in the marvelously short period of six years, it being accepted with equal readiness by nations of the most diverse climes, habits, and religions. About the close of the year 1801 Jenner's friends in his native county of Gloucester presented him with a small service of plate as a testimonial of the esteem in which they held his discovery. This was intended merely as a preliminary to the presenting of a petition to Parliament for a grant. He was advised to apply for this, partly to obtain the formal approval of the highest court in this country for vaccination, but also for personal reasons. The premier, Mr. Addington, approved fully of this step, and fixed the 17th of March 1802 for the presentation of his petition. This was referred to a committee, of which Admiral Berkeley, one of his warmest friends, was chairman, which examined carefully into the utility of vaccination, and Jenner's claims to its discovery. The investigations of this committee resulted in a report in favor of the grant, and ultimately in a vote of £10,000.

Towards the end of 1802 steps were taken to form a society for the proper spread of vaccination in London, and the "Royal Jennerian Society" was finally established, Jenner returning to town (having retired to Berkeley for three months) to preside at the first meeting. This institution began very prosperously, more than twelve thousand persons having been inoculated in the first eighteen months, and with such effect that the deaths from small-pox, which in the latter half of the last century had averaged 2018 annually, fell, in 1804, to 622. Unfortunately the chief resident inoculator soon set himself up as an authority opposed to Dr. Jenner, and this led to such dissensions as caused the society to die out in 1808. Jenner was led, by the language of the chancellor of the exchequer when his grant was proposed, to attempt practice in London, but after a year's trial he returned to Berkeley. His grant was not paid until 1804, and then, after the deduction of about £1000 for fees, it did little more than pay the expenses attendant upon his discovery. For he was so thoroughly known everywhere as the discoverer of vaccination, that the correspondence of the whole world on this subject was upon him. As he himself said, he was "the vaccine clerk of the whole world"; and, at the same time, he continued to vaccinate gratuitously all the poor who applied to him on certain days, so that he sometimes had as many as three hundred persons waiting at his door. Meanwhile honors began to shower upon him from abroad: he was elected a member of almost the chief scientific societies on the Continent, the first being that of Gottingen, where he was proposed by the illustrious Blumenbach. But perhaps the most flattering proof of his influence was derived from France. He endeavored on several occasions to obtain the release of some of the unfortunate Englishmen who had been detained in France on the sudden termination of the peace of Amiens, but without success, until, in the case of two persons (Dr. Williams, a Radcliffe travelling fellow, and a Mr. Williams) he applied to the emperor Napoleon himself. It was on this or some such occasion (for he afterwards repeated his intercession) that Napoleon was about to reject the petition, when Josephine uttered the name of Jenner. The emperor paused and exclaimed-"Ah, we can refuse nothing to that name." Somewhat later he was of the same service to Englishmen confined in Mexico and in Austria; and during the latter part of the great war persons before leaving England would sometimes obtain certificates signed by him which served as passports. In his own country his merits were less recognized. His

applications on behalf of French prisoners in England were less successful; he never shared in any of the patronage at the disposal of the Government, and was even unable to obtain a living for his nephew George.

In 1806 Lord Henry Petty (afterwards the marquis of Lansdowne) became chancellor of the exchequer, and was so convinced of the inadequacy of the former parliamentary grant that he proposed an address to the crown, praying that the college of physicians should be directed to report upon the success of vaccination. Their report being strongly in its favor, the then chancellor of the exchequer (Mr. Spencer Perceval) proposed that a sum of £10,000 without any charge for fee or reward should be paid to Dr. Jenner. The anti-vaccinationists found but one advocate in the House of Commons; and finally the sum was raised to £20,000. Jenner, however, at the same time had the mortification of learning that Government did not intend to take any steps towards checking small-pox inoculation, which so persistently kept up that disease. About the same time a subscription for his benefit was begun in India, where his discovery had been gratefully received, but the full amount of this (£7383) only reached him in 1812.

The Royal Jennerian Society having failed, the National Vaccine Establishment was founded, for the extension of vaccination, in 1808. Jenner spent five month's in London for the purpose of organizing it, but was then obliged, by the dangerous illness of one of his sons, to return to Berkeley. He had been appointed director of the institution; but he had no sooner left London than Sir Lucas Pepys, the president of the college of physicians, neglected his recommendations, and formed the board out of the officials of that college and the college of surgeons. Jenner at once resigned his post as director, though he continued to give the benefit of his advice whenever it was needed, and this resignation was a bitter mortification to him. In 1810 his eldest son died, and Jenner's grief at his loss, and his incessant labors, materially affected his health. In the following year he happened to be in London when the town was much excited by the case of one of Lord Grosvenor's children, who took the small-pox severely, after having been vaccinated by Jenner ten years before. The boy's recovery was no doubt to be ascribed to vaccination, but the occurrence revived for a time all the clamor with which the discovery had been from the first greeted.

In 1813 the University of Oxford conferred on Jenner the degree of M.D. It was believed that this would lead to his election into the college of physicians, but that learned body decided that he could not be admitted until he had undergone an examination in classics. This Jenner at once refused; to brush up on his classics would, he said, "*be irksome beyond measure. I would not do it for a diadem. That indeed would be a bauble; I would not do it for John Hunter's museum.*"

He visited London for the last time in 1814, when he was presented to the allied sovereigns, and to most of the principal personages that accompanied them. In the next year his wife died after a long illness, and he felt her loss most acutely. It was the signal for him to retire from public life: he never left Berkeley again, except for a day or two, as long as he lived. He found sufficient occupation for the remainder of his life in collecting further evidence on some points connected with his great discovery, and in his

engagements as a physician, a naturalist, and a magistrate. In 1818 a severe epidemic of small-pox prevailed, and fresh doubts were thrown on the efficacy of vaccination, in part, apparently, owing to the bad quality of the vaccine lymph employed. This caused Jenner much annoyance, which was relieved by an able defense of the practice, written by Sir Gilbert Blane. But this led him, in 1821, to send a circular letter to most of the medical men in the kingdom inquiring into the effect of other skin diseases in modifying the progress of cow-pox. A year later he published his last work, *On the Influence of Artificial Eruptions in Certain Diseases*; and in 1823 he presented his last paper—"On the Migration of Birds"—to the Royal Society. In these pursuits the evening of his days passed happily away. On the 24th of January 1823 he retired to rest apparently as well as usual, and next morning rose and came down to his library, where he was found insensible on the floor, in a state of apoplexy, and with the right side paralyzed. He never rallied, and died the following morning, January 26, 1823.

A public subscription was set on foot, shortly after his death, by the medical men of his county, for the purpose of erecting some memorial in his honor, and with much difficulty a sufficient sum was raised to enable a statue to be placed in Gloucester cathedral. In 1850 another attempt was made to set up a monument to him; this appears to have failed, but at length, in 1858, a statue of him was erected by public subscription in London. Independently of that great discovery which will forever render his name immortal, Jenner possessed talents of observation and reflection that would have made him eminent as a naturalist and a physician. These qualities would have been more widely appreciated had not his tastes for rural scenes and domestic life led him to sacrifice such fame as is to be gained only amid the busy throng of men. This resolution was strengthened by his love for the simple pleasures of society, for which his varied accomplishments as well fitted him; indeed, there can be little doubt that he would never have had the perseverance to carry through his great discovery of vaccination had not his earnest benevolence pressed it on him, as a duty, to confer such a great and permanent benefit on the whole human race.

Jenner's life was written by the intimate friend of his later years, Dr. Baron of Gloucester. (2 vols. 1827, 1838), and this excellent work is almost the sole source from which the present and other biographies of him have been taken. (J. R. G.)

Edward Jenner was the father of modern vaccination!!

Edward Jenner—a quack doctor— was the father of the filthy practice of vaccination:



Edward Jenner S.J. (1749 — 1823).

Edward Jenner was an S.J. -- a Slick Jesuit -- who taught the *medical* world how to use the POISONED NEEDLE. He was the first to associate human diseases with that of animals. This idea paved the way for vaccination which is responsible for the deaths of multiplied millions of people around the world. The idea that humans and animals are related and share the same diseases led to the theory of evolution which is responsible for the *spiritual death* of multiplied millions more.

In the countryside in Gloucestershire, England, where Jenner lived, the farmers had a legend or superstition that catching cowpox (a disease of cows which was transferred to the cows' udders by unwashed or bleeding hands) would act like a charm or amulet to make them immune from catching the human disease of smallpox.

Medicine man Jenner took this local legend or old wives' tale and turned it into a scientific FACT. He did this by first getting some *scientific credentials* (M.D., F.R.S. - Fellow of the Royal Society). Next he wrote a book and on the title page *only* he used the term VARIOLAE VACCINAE. This means in Medieval Latin: smallpox of the cow. Thus associating a human disease with a disease of the cow. There never was such a disease as *smallpox of the cow* until "Dr." Jenner invented it for the title of his book.

Jenner invented a new disease—VARIOLAE VACCINAE—smallpox of the cow!!

Isis or Hathor— the Egyptian *holy* cow goddess.

Her name means "The Dwelling of Horus", for it was thought that Horus as the Sun God came to rest each evening on her breast before being reborn with the awakening dawn. Hathor is the great Sky-goddess that as a celestial cow gave birth to the universe. She was often represented as a cow or with bovine attributes such as a cow's head, cows' ears or horns on her headdress. Hathor was the goddess of Joy and Motherhood and the embodiment of all that is best in women. She was also considered the goddess of music, song, dance and lighthearted pleasure, but she was essentially a Moon goddess. She was considered the protectress of pregnant women and midwives. Her main cult center was at Dendera, where she was worshipped along with her husband, Horus. Hathor was the Supreme goddess of sexual love in Egypt, immediately identified with Aphrodite by the Greeks. Her temple at Dendera was in The House of Intoxication and Enjoyments. Her main attributes were two ritual instruments carried by her priestesses, the sistrum, a bronze sacred rattle and the menat, a necklace, thick with beads and a

counterpoise long enough to be grasped in the hand which was only worn by Hathor, but used by her priestesses as a healing instrument. In Greece she was also known as Diana of the Ephesians and in Rome as Venus. Papal Rome later *stole* her from the Egyptians . . . and called her the Virgin Mary!!

During the Dark Ages, Papal Rome had a death grip on Europe. The four horsemen of the Apocalypse -- war, famine, disease and death -- rode roughshod over the world for over 1000 years. Lack of personal hygiene and sanitation led to plagues and epidemics which caused the deaths of millions of people. The monkish orders set the course that history took during this dark night of the world:



Anthony (251 - 330) was the founder of the Roman Catholic monastic orders. Think of Dr. Anthony Fauci, Director of the NIAID, highest paid public servant at \$417,000 a year. This saint was the namesake of Dr. Fauci, who peddles his vaccines at the expense of public ignorance.

Anthony was an Egyptian hermit and the founder of the Roman monastic orders. He was the patron saint of *pigs*. In this illustration he is shown with his favorite animal under his habit. Owing to the fact that the Roman monks never bathed, nobody ever got too close to them to hear what they were saying.

With the dawning of the blessed Reformation morning, Satan saw the handwriting on the (door) wall. A restored Bible would bring the blessings of true Christianity, good health, hygiene, and sanitation that Europe had not seen for over 1000 years.

Satan was not about to roll over and die however. He raised up his champion, Ignatius LIEola, to resist and delay the dawning of the blessed day.

Jesuit priests made contact with the most powerful *medicine men* in order to find more *potent poison* to kill the Reformation.

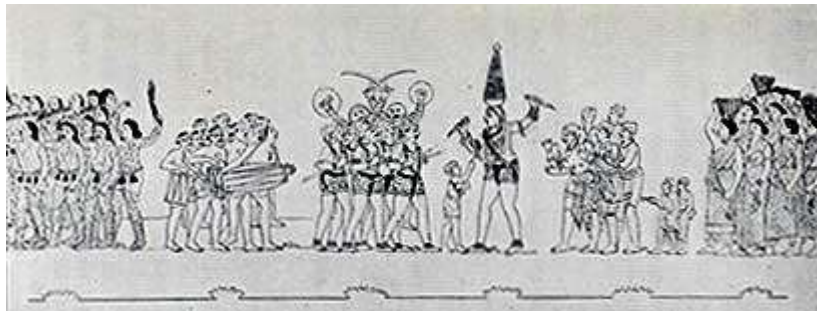


Francis Xavier (1506 —1552) was sent to India and Japan.

Francis Xavier was sent to India and he made contact with the powerful Brahmin priests and medicine men. It was there that the Jesuits learned the Brahmin mode of inoculating to appease the vicious, vengeful demon of smallpox.

A Religious Dramatic Representation of the Power of the Hindu goddess of Smallpox.

"The goddess stands with two uplifted crooked daggers, threatening to strike on the right and left. Before her is a band of the executors of her vengeance. Two of them wear grinning red masks, carry black shields, and brandish naked scimitars. White lines, like rays, issue from the bodies of the others, to indicate infection. On the left there is a group of men with spotted bodies, inflicted with the malady; bells are hung at their cinctures, and a few of them wave in their hands black feathers. They are preceded by musicians with drums, who are supplicating the pity of the furious deity. Behind the goddess, on the right, there advances a bevy of smiling young women, who are carrying gracefully on their heads baskets with thanksgiving offerings, in gratitude for their lives and their beauty having been spared. There is, besides, a little boy with a bell at his girdle, who seems to be conveying something from the right arm of the goddess. This

action may probably be emblematic of inoculation. In a country where every thought, word and deed are mere repetitions of those of their progenitors, a composition like this bears the stamp of great antiquity." (*History of Inoculation & Vaccination*, Lecture Memoranda, A.M.A., p. 18).

The Jesuits became willing students of the Brahmin *medicine men*:

"The man who after Xavier had the greatest success in India, but who also perverted the character of the mission, and introduced the most abominable idolatry, was Father Francis Nobili. He arrived at Madura in 1606, and was surprised that Christianity had made so little progress in so long a time, which he attributed to the strong aversion which the Indian had for the European, and to the fact, that the Jesuits, having addressed themselves more especially to the Pariahs, had caused Christ to be considered as the Pariahs' God.' He therefore resolved to play the part of a Hindu and a Brahmin. After having learned with wonderful facility their rites, their manners, and their language, he gave himself out as a Saniassi, a Brahmin of the fourth and most perfect class; and, with imperturbable impudence, he asserted that he had come to restore to them the fourth road to truth, which was supposed to have been lost many thousands of years before. He submitted to their penances and observances, which were very painful; abstained from everything that had life, such as fish, flesh, eggs; respected their prejudices, and, above all, the maintenance of the distinction of classes. It was forbidden the catechumen Pariah to enter the same church with the Sudra or Brahmin converts. All this was the beginning of those heathen ceremonies and superstitions with which the Christian religion was contaminated." (*History of the Jesuits*, J. B. Nicolini, p. 108).

Dr. J. Z. Holwell sent a most detailed account of these religious rites to the College of Physicians in London in 1767.

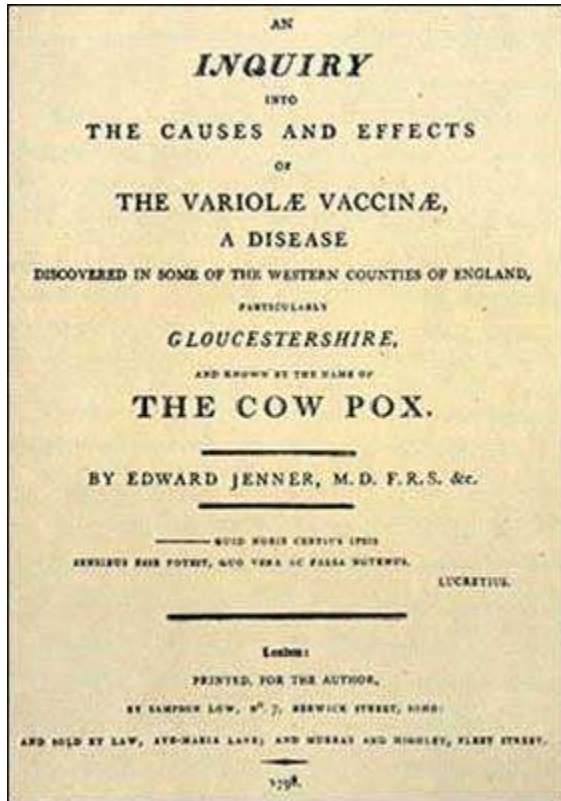
"Inoculation is performed in Indostan by a particular tribe of Bramins, who are delegated annually for this service from the different Colleges of Bindoobund, Eleabas, Benares, & c. over all the distant provinces: dividing themselves into small parties, of three or four each, they plan their traveling circuits in such wise as to arrive at the places of the operation consists only in abstaining for a month from fish, milk, and ghee (a kind of butter made generally of buffalo's milk); the prohibition of fish respects only the native Portugese and Mahomedans, who abound in every province of the empire."

Lady Mary Wortley Montagu (1689 -- 1762).

In the year 1717, Lady Mary Wortley Montagu was the *smokescreen* that the Jesuits used to introduce this Indian religious rite into England. Lady Mary was not even a doctor. Inoculation or *variolation* was given the sanction of the Royal Family when 2 daughters of the Prince of Wales were inoculated. Barbaric as this religious rite was; it was the human disease of smallpox that was injected into the bloodstream. Inoculation was the FOOT-IN-THE-DOOR to prepare the people for something *far worse*.

Notice how *medicine man* Jenner cleverly uses the scientific name for smallpox, VARIOLAE, and associates it with the cow disease of cowpox. He NEVER mentions the name VARIOLAE VACCINAE again in his book. It is mostly about HORSE GREASE being the cause of smallpox of the cow. Jenner figured that very few people would actually *read* the book but most would just *look* at the COVER and make a mental association between Smallpox and Cowpox.

"The title of Jenner's cowpox paper is: *"An Inquiry into the Causes and Effects of the Variolae Vaccinae, a Disease discovered in some of the Western Counties, especially Gloucestershire, and known by the name of the Cowpox."* An objection might be taken to "discovered," but let that pass. The leading line in this full and learned title is Variolae Vaccinae, which is the only name in the short title. Now Variolae Vaccine is Latin for *smallpox of the cow*. An affection of cows and milkers, which had been known to country people for generations as the cowpox, is suddenly introduced to the learned, who had never heard of it before, under a brand-new name. The new name is put in the forefront of the title, it overshadows the old country name both by its prominence and by its semblance of scientific precision, and, for purposes of short reference, it becomes the sole name. This startling novelty is on the title-pages, and only on the title-pages. Jenner never says, in the preface or text, that the name is a new one, hitherto unheard of in veterinary or medical writings; he never says a single word to justify its invention; he never once uses it in the preface or text at all. But there it stands in the title as the full, correct, and scientific name of the disease, to be copied in journals and repeated in a hundred ways when not one word of the essay would be copied or repeated, carrying with it, in short, all the power over the ideas that a descriptive synonym for an unfamiliar

thing does naturally carry with it." (*Jenner and Vaccination*, [Dr. Charles Creighton](#), p. 44).

This is like saying that a *horse chestnut* (a tree) and a *chestnut horse* are the same thing or that a beetle (an insect) is the same thing as a BEATLE (a decomposing rock musician).

The only correlation between smallpox and cowpox is that both names ended in POX. Heaven and Hell both start with the same letter H but they are vastly different places.

Highlights of the Life of *Medicine Man* Jenner.

Date	Event
1749	Jenner is born on May 17, in Berkeley, Gloucestershire, England, son of a clergyman in the "church" of England. The only difference between the "church" of England and the "church" of Rome is that it is popery without the pope!!
1763	At the age of 14 he was apprenticed for seven years to Mr. Daniel Ludlow, a surgeon of Chipping Sodbury, where he gained most of the experience needed to become a surgeon himself.
1770	At the age of 21 he was sent for two years as a pupil to Dr. John Hunter, of London, who undoubtedly was the most eminent surgeon of his day, and, like Jenner himself, a keen naturalist. While in London he became friends with Joseph Banks would later become president of the Royal Society.
1772	At 23, Jenner returned to his native village and started to practice as surgeon

	and apothecary. Here he remained for 17 years, just a plain <u>unqualified country surgeon and apothecary</u> , unknown to the world at large, but keeping up a correspondence with Hunter on a variety of natural history subjects.
1787	Jenner submits a paper on the nesting habits of the cuckoo.
1789	Thanks to his friends in high places, Jenner is elected a member of the Royal Society for his paper on the nesting habits of the cuckoo.
1790	Jenner becomes <i>Dr. Jenner M.D.</i> , by <u>buying a medical degree</u> from the University of St. Andrew's for the sum of £15.
1791	Edward Jenner vaccinates his 18 month old son with swine-pox. In 1798 he vaccinates his son with cow-pox. His son will die of TB at the age of 20.
1796	On May 14, Jenner inoculates James Phipps, the eight-year old son of his gardener with cowpox disease which he had obtained from a local milkmaid named Sarah Nelmes. The boy develops cowpox but lives. In July, he inoculates the boy with smallpox. The boy dies at the age of 21 from tuberculosis.
1797	Jenner sends a paper to the Royal Society about his newly invented disease: <i>variola vaccinae</i> or smallpox of the cow. The paper is rejected and returned with a warning "He had better not promulgate such a <i>wild idea</i> if he valued his reputation."
1798	Jenner publishes his <i>Inquiry into the Cause and Effects of the Variolæ Vaccinæ</i> . <i>Variolæ</i> was the common name for smallpox and vaccine was the scientific name for cow. So Jenner was able to equate smallpox (a human disease) with cowpox - a disease of animals.
1802	Royal Jennerian Society is formed in London but dies out in 6 years due to lack of interest.
1810	Jenner's son dies at the age of 21 from TB.
1813	For inventing a new disease, the University of Oxford awarded Jenner an honorary M.D. degree.
1819	James Phipps, the boy that Jenner used in his ghoulish experiments dies at 21 of TB.
1823	Jenner dies and goes to meet his Maker who created all things after its kind, in 6 days, 6000 years ago.
1838	John Baron writes <i>The Life of Edward Jenner</i> in 2 volumes. This panegyric was written by a man who was a consulting physician to the LUNATIC ASYLUM at

	Gloucester.

Date	Event
1534	Ignatius LIEola founds the Jesuit Order in Paris, France, on August 15.
1541	Francis Xavier is sent to India and Japan by LIEola.
1717	Jesuits introduce inoculation from India using Lady Montague as a smokescreen. Lady Montague wasn't even a doctor. Women doctors did not appear until over 100 years later.
1767	Dr. Holwell sends back his report on the Brahmins inoculation techniques.
1797	Jenner sends a paper to the Royal Society about his newly invented disease: variolae vaccinae or smallpox of the cow. The paper is rejected and returned with a warning " <i>He had better not promulgate such a wild idea if he valued his reputation.</i> "
1798	Edward Jenner publishes his <i>Inquiry</i> about his newly invented disease, variolae vaccinae, or smallpox of the cow.
1799	Doctrine and practice of vaccination spreads like the plague all over England.
1800	Doctrine spreads like wildfire all over the world. Benjamin Waterhouse of Harvard University brings it to the U. S.
1839	Smallpox epidemic sweeps England and kills 22,081 people.
1840	Inoculation is outlawed by the British Parliament.
1853	In England, the Compulsory Vaccination Act is passed by Parliament. Every parent is required to have their baby vaccinated within 3 months of birth or face a fine of 20 shillings.
1855	Medical Inquisition begins in U. S., as Massachusetts is the first State to adopt mandatory vaccination laws. Every State in the U.S. has them now.

1859	Charles <i>ape-man</i> Darwin publishes his <i>Origin of Species</i> --microbes to monkeys to men thesis. Since animals, especially monkeys, are our close relatives it should be no problem to inject animal diseases in the blood of humans.
1867	Nonpayment of fines for skipping smallpox vaccination result in harsher penalties. Thousands defy the medical Inquisition and leave Britain rather than submit their children to this barbaric rite.
1868	Anti-Compulsory Vaccination League is formed in Britain.
1870	Outbreak of smallpox all over Europe.
1871	Smallpox continues to rage all over Europe.
1889	In England, a Royal Commission is appointed to inquire into certain aspects of the vaccination question. The committee would be in session for 7 years and would issue 6 reports, with the final report in 1896. The result of the final report was the Vaccination Act of 1898.

1898	Vaccination Act removes penalties from vaccination law.
1900	The Rockefeller and J. P. Morgan syndicate buys <i>Encyclopedia Britannica</i> and all derogatory references to vaccination are removed.
1910	Flexner report is issued which calls for the elimination of over half the medical schools in the U.S.
1911	Vaccination is made mandatory in the U.S. armed forces. The U.S. always uses the military to introduce social engineering before imposing it on the populace.
1917	U.S. soldiers are vaccinated prior to going overseas to fight in WW I. They begin to drop dead by the thousands.
