Is it “Contagion” or really “Consequence” of something else ?

For a couple months I have been reading one of the most intriguing books which has been recently noted by medical and electrical engineering experts. I'm up by 7am most mornings but my wife sleeps longer than I do during this lock down, sometimes to 9am, but I can't do much until she is up and wraps my feet and legs with treatment and Ace-bandages up to my knee. In that empty space I read about twenty pages of Arthur Firstenberg's *The Invisible Rainbow*.

The human body resonates with the Earth's magnetic field at 7.83 megahertz. What has pretty much been considered as blessing to humanity, electricity is fraught with problems that cause many a disorder, health issue, and diagnoses. Dr. Firstenberg's book is sub-titled “The History of Electricity and Life”. Reading Dr. Firstenberg's book, you soon begin to realize that electricity might also be our biggest nightmare.

As early as 1799, researchers puzzled over the cause of influenza, which appeared suddenly, often in diverse places at the same time, and could not be explained by any theory of contagion. In 1836, Heinrich Schweich, author of a book on influenza, noted that all physiological processes produce electricity and offered the theory that an electrical disturbance of the atmosphere may prevent the body from discharging it. He repeated the then-common belief that the accumulation of electricity in the body causes the symptoms of influenza and that outbreaks were due to atmospheric “influences”—hence the name influenza.

Now that we know about the electrical nature of the Sun, we can make some interesting observations. The years 1645-1715 was a period that astronomers call the Maunder minimum, when the sun was very quiet; astronomers observed no sunspots during the time span and the northern lights were nonexistent; then in 1715, sunspots reappeared, as did the northern lights. Sunspot activity then increased, reaching a high in 1727, and in 1728, influenza appeared in waves on every continent. Sunspot activities became more violent until they peaked in 1738 when physicians reported flu in both man and animals, including dogs, horses and birds, especially sparrows. By some estimates, two million people perished during the ten-year pandemic. If you draw from this bit of information, that sunspot activity influences life on Earth, you are on the right track.

These and other facts about the relationship of influenza to disturbances in electricity come from a most remarkable book, *The Invisible Rainbow*, by Arthur Firstenberg. Firstenberg chronicles the history of electricity in the U.S. and throughout the world, and the outbreaks of

illness that accompanied each step towards greater electrification. The first stage involved the installation of telegraph lines—by 1875, these formed a spider web over the whole earth totaling seven hundred thousand miles, with enough copper wire to encircle the globe almost thirty times. Telegraph wires were strung along the railroads of the nation. Railroad telegraph operators tapping out Morse Code soon became sick from their exposure to electricity that created EMF along the wires and even the rails themselves.

With it came a new disease called neurasthenia. Outside of the U.S., scientists recognized electricity as one of its causes. Like those suffering today from “chronic fatigue,” patients felt weak and exhausted, unable to concentrate. They had headaches, dizziness, tinnitus, and floaters in the eyes, racing pulse, pains in the heart region and palpitations; they were depressed and had anxiety attacks. Dr. George Miller Beard noted that the disease spread along the routes of railroads and telegraph lines; it often resembled the common cold or influenza and commonly seized people in the prime of life.

1889 marks the beginning of the modern electrical era and also of a deadly flu pandemic, which followed the advent of electricity throughout the globe. Dr. Firstenberg states, *“Influenza struck explosively and unpredictably, over and over in waves until early 1894. It was as if something fundamental had changed in the atmosphere. . .”*

Physicians puzzled over influenza’s capricious spread. For example, William Beveridge, author of a 1975 textbook on influenza, noted *“The English warship Arachne was cruising off the coast of Cuba ‘without any contact with land. No less than 114 men out of a crew of 149 fell ill with influenza and only later were it learnt that there had been outbreaks in Cuba at the same time.”*

During the First World War, governments on both sides of the conflict installed antennas which eventually blanketed the earth with strong radio signals—and during the latter part of 1918, disaster struck. The Spanish flu afflicted a third of the world’s population and killed around fifty million people, more than the Black Death of the fourteenth century. Those living on military bases, where the antennas were routinely installed, were the most vulnerable. A common symptom was bleeding—from the nostrils, the gums, ears, skin, stomach, intestines, uterus, kidneys and brain. Many died of hemorrhage in the lungs, the victims literally drowning in their own blood. Tests revealed a decreased ability for the blood to coagulate.

Health officials in those days were very interested in the question of whether the Spanish flu was contagious. Doctors from the U.S. Public Health Service tried to infect one hundred healthy volunteers between the ages of eighteen and twenty-five by collecting mucous secretions from the noses, throats and upper respiratory tracts of those who were sick. They transferred these secretions to the noses, mouths and lungs of the volunteers, but not one of them got sick; blood of sick donors was injected into the blood of the volunteers, but they remained stubbornly healthy; finally they instructed those afflicted to breathe and cough over the volunteers, but none became sick. Researchers even tried to infect healthy horses with the mucous secretions of horses with the flu, but the results were the same. **The Spanish flu was not contagious.**

Being an inquisitive guy, I have read all about the Spanish Flu of 1917-18, even have a book or two or three on it.

The year 1957 marked the installation of radar worldwide. The “Asian” influenza pandemic began in February 1957 and lasted for a year. A decade later the U.S. launched twenty-eight satellites into the Van Allen belts as part of the Initial Defense Communication Satellite Program (IDCSP), ushering in the “Hong Kong” flu pandemic, which began in July 1968.

As Dr. Firstenberg observes, “In each case—in 1889, 1918, 1957 and 1968—the electrical envelope of the earth. . . was suddenly and profoundly disturbed,” and along with it the electrical circuits in the human body. Western medicine pays scant attention to the electrical nature of living things—plants, animals and humans—but mountains of evidence indicate that faint currents govern everything that happens in the body to keep us alive and healthy. From the coagulation of the blood, to energy production in the mitochondria, even to small amounts of copper in the bones, which create currents for the maintenance of bone structure—all can be influenced by the presence of electricity in the atmosphere, especially “dirty” electricity, characterized by many overlapping frequencies and jagged changes in frequency and voltage. Today we know that each cell in the body has its own electrical grid, maintained by the highly structured water inside the cell membrane. Cancer occurs when this structure breaks down, and cancer has increased with each new development in the electrification of the earth.

Chinese medicine has long recognized the electrical nature of the human body and has developed a system to defuse the “accumulation of electricity” that leads to disease. It’s called acupuncture. Many things that we do instinctively also help release any unhealthy buildup of current—the mother who strokes her infant’s head or who scratches her children’s backs to put them to sleep, the caresses of lovers, walking barefoot, massage, even handshakes and hugs—all now discouraged by the frowny faces of health authorities as we face the specter of bed police bursting in at midnight to make sure that Dad is sleeping on the sofa.

Am I making this up? The *‘Washington Post’* recently published an article in which a mother was explaining to her teenage son why she couldn’t hug him during quarantine; and a WHO official suggests that public health officials should enter people’s homes and “*in a dignified way*” remove those who test positive, to prevent infecting the rest of the family.

Fast forward to the Internet and cell phone era. According to Dr. Firstenberg, the onset of cell phone service in 1996 resulted in greater levels of mortality in major cities like Los Angeles, New York, San Diego and Boston. Over the years wireless signals at multiple frequencies have filled the atmosphere to a greater and greater extent, along with mysterious outbreaks like SARS and MERS. Today we face the installation of fifth generation wireless (5G), broadcast in the gigahertz range, at 60 gigahertz, a frequency that is highly absorbed by oxygen, causing the O² molecule to split apart, making it useless for respiration.

Now one may disagree with the evidence; however, one cannot explain away the increased levels of mortality found in the major cities across this nation. We have the same pattern of

mortality in the periods in which pandemics have occurred throughout the world. “Influenza” came and went over the centuries with little reason of explanation. It wasn’t until scientists began to study the impact of Sun spot activity which peaks at 11-year cycles, that we discovered a relationship between influenza and heightened Sun spot activity. It was 2001 when I began to study this phenomenon for an unrelated issue. Dr. Firstenberg sees this as a significant factor in electrical activity in the weather, human and animal life as well as nature.

Compare the pattern of 5G installation in the top map in the pattern of corona virus cases in the lower map on the next page. While correlation does not prove causation, the strong overlap between 5G rollout locations and corona virus cases should give one pause, especially given the history of pandemics following step changes in planetary electrification.

Is Coronavirus Contagious?

The premise that coronavirus is highly contagious and can cause disease provides the justification for putting entire nations on lockdown, destroying the global economy and throwing hundreds of thousands out of work. But is it contagious? Does it even cause disease?

On September 26, 2019, 5G wireless was turned on in Wuhan, China and also launched in parts of New York City (areas of uptown, midtown and downtown Manhattan, along with parts of Brooklyn, the Bronx and Queens), the difference being that the 5G grid in Wuhan was much denser, with about ten thousand antennas—more antennas than exist in the whole U.S.A., all concentrated in one city. Illness has followed 5G installation in South Korea, Italy and Iran. In South America, Ecuador is a hot spot for the respiratory illness, and it is in Ecuador that 5G first appeared. The 5G system is also installed on modern cruise ships and in many health care facilities. People who suffer from electrical sensitivity cannot go near many hospitals and nursing homes.

U.S. CDC Extends “No Sail Order” for All Cruise Ships

Reuters News reported on April 10, 2020 that the CDC extended a “No Sail Order” for all cruise ships.

Disease Control and Prevention extended its “no sail order” for all cruise ships, as it looks to prevent the spread of the novel coronavirus pandemic. The CDC [new order](#) says that cruise ships have to cease operations for up to 100 days, or the expiration of the Secretary of Health and Human Services’ declaration that COVID-19 constitutes a public health emergency, or if the CDC Director rescinds or modifies the order.

The order, dated April 9, comes as the cruise industry takes a hit from the novel coronavirus outbreak, with trips across the globe either canceled or suspended and refunds issued to customers. Many cruise ship lines have already voluntarily suspended most of their operations.

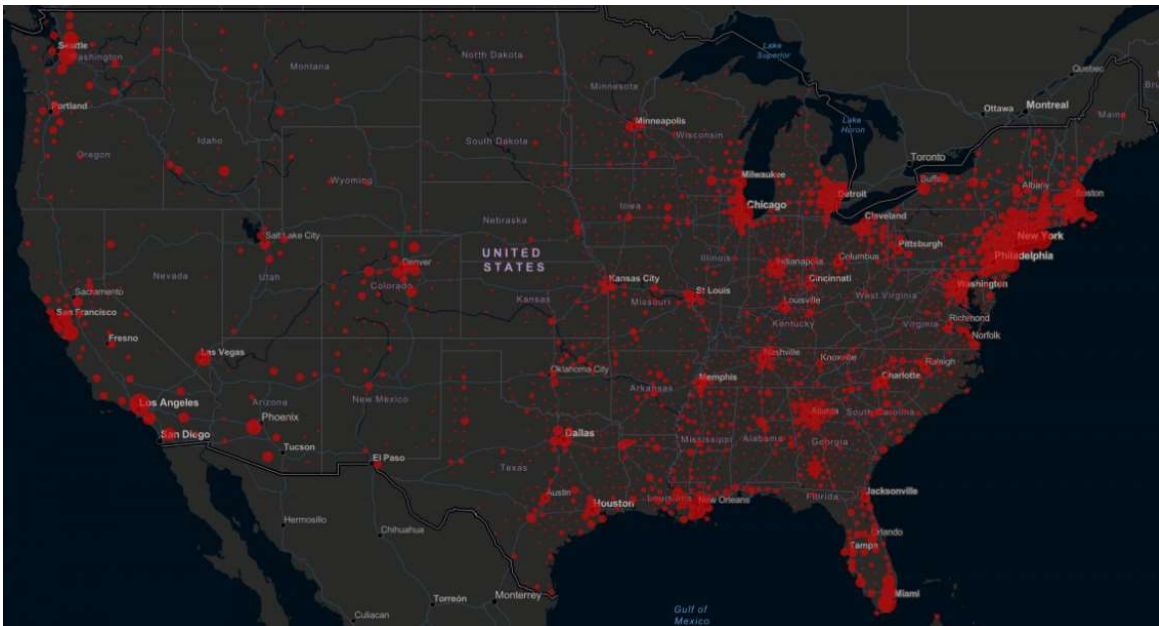

Four of the cruise lines belonging to the world's largest cruise operator Carnival Corporation said last month they would extend the suspension of all voyages by a month to May while rival Royal Caribbean Cruises Ltd said it would return to service by May 12.

Currently, there are about 100 cruise ships remaining at sea off the East Coast, West Coast, and Gulf Coast, with nearly 80,000 crew on board, the CDC noted, and said there are 20 cruise ships at port or anchorage in the United States with known or suspected COVID-19 infection among the crew who remain onboard. The earlier “no sail order” was issued on March 14.



What grabbed my attention when this order was posted was the fact that the Cruise Industry has been ahead of most on the installation of 5G 60-gigahertz technology. In a previous article on 5G, I noted the different packages that are being offered to cruise customers and that the Cruise lines had 20 dedicated satellites covering 80% of the Earth’s surface for their cruise passenger’s ability to have contact with family, work, etc.

What most of you do not know is that the technology has been brought on line operating at a level with a minimum of health issues. As I pointed out, 5G 60-gigahertz optimum level absorbs 98% of the oxygen in a human body. This has been confirmed as factual. It is the modulation (energy level) that was the missing connection between Corona virus and 5G technology and toxic electricity. You may have a new 5G phone and unaffected by 5G EMF, largely because the telecoms are not broadcasting at full power. At least that is happening up to around late September or early October, when it is supposed to be fully operational.

This issue of the Corona virus outbreak and 5G technology on cruise ships begs an answer. Many elderly are cruise passengers and are at greater risk to 5G EMF, particularly so with those having many health issues related to aging. Hence, the susceptibility to an outbreak of a virus may not be related to a viral pathogen but rather a consequence of electrical energy to that of onboard 5G technology. It begs the question of “cause and affect” for sure. In reading Dr. Firstenberg’s book, the growing body of evidence suggests there is more to the issue of the Corona virus which broke out in China at the very time of China’s roll out of 5G technology than any of the media are letting out. When addressing this issue one has to remember, none of what is impacting the human body is visible, which is the primary reason most of humanity will never know, let alone understand, what it is that will take their life.

At the start of the day on April 9th, the United States, which has [4.2% of the world’s population](#), had [28.7% of the world’s known Covid-19 \(or “coronavirus-19”\) cases](#).

This infection-rate tends to be higher in cities than in rural areas. [82% of America’s population is urban.55% of the world’s population is urban.](#) The most-urbanized nations (100% urban), and their respective number of COVID-19 cases as of April 9th (shown in parentheses), are Bermuda (39), Cayman Islands (45), Gibraltar (120), Hong Kong (961), Kuwait (855), Monaco (81), Nauru (none shown), and Singapore (1,623).

Hong Kong has a population of 7,483,870, and that’s 2.2% as large as America’s population. If Hong Kong had as high a percentage of its population as Covid-19 cases as the U.S. does, it would have 9,862 cases, not 961. If Singapore (population 5,839,210) did, it would have 7,697 cases, not 1,623.

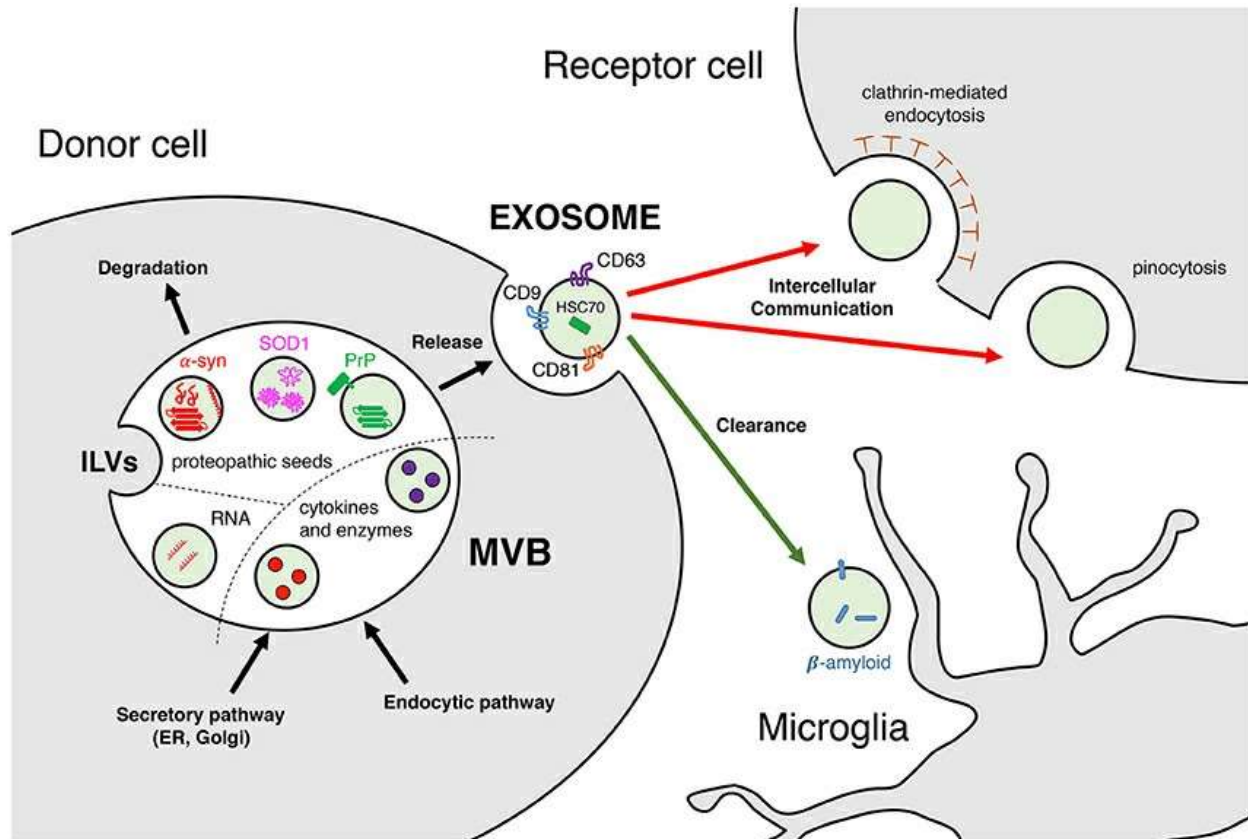
Japan is 92% urban, and has 4,667 cases, and if it had the same percentage of its population being infected with COVID-19 as U.S. does, Japan’s number of confirmed cases would be 12,227, instead of 4,667.

Russia is 74% urban (not much different from America’s 82%). If it had the same percentage of its population infected with coronavirus-19 as the U.S. does, it would have 192,454 cases. Instead, it has 8,672 cases. Russia does not have 5G technology in civilian applications, only military applications.

Why is this? The note about Russia and 5G is a clue to this mystery. Some of those differences between the U.S. and other countries are enormous, but all are multiples, not merely percentages. Regarding COVID-19 infections, the U.S. really has no competitor: it is the world’s lone giant. The references above to data for major global nations are very revealing. We can infer from the data that the outbreak of the so-called COVID-19 virus correlates to urban versus rural population and the level of electrical devices and Wi-Fi. This brings me to another aspect of the medical research that has bearing on human and animal life.

If you do a bit of surfing on the Internet, you will find that exosomes are the latest thing for diagnosis and therapy, with many medical uses—from cancer treatment, to wound healing, to hair restoration!

It's clear that we are making the same mistake with viruses that we have made with cholesterol and saturated fat—blaming a substance that is essential to life for causing disease. Just twenty years ago the medical profession “knew” that bacteria were killers—now we recognize that bacteria are essential to health. How long will it take us to learn that so-called viruses are our friends?



It's interesting to note that each wave of influenza has its own constellation of symptoms—during the Spanish flu epidemic the main problem was bleeding, the inability of the blood to coagulate; the main victims were healthy people in the prime of life, between the ages of twenty-five and forty. Today's victims are older, usually with pre-existing conditions. The main symptom of today's outbreak seems to be hypoxia, akin to high altitude sickness.

So is corona virus a contagious disease or virus? Remember that researchers could not show that the dreadful Spanish flu was contagious. The fact is that viruses are actually helpful exosomes, and that many who test positive are symptom-free, makes their role as a perpetrator highly unlikely. To settle this question once and for all, we need to do the same contagion studies that proved non-contagion in 1918.

What the CDC and WHO and Bill Gates and Dr. Fauci are not telling the public is that this virus was engineered as a bio-weapon to kill gently, if that is appropriate. The gene-sequencing by Indian scientists and other labs have shown us that 4 different elements of pathogens were inserted into the derivative that we are told is COVID-19. They are refusing to embrace vitamins C, D³, Potassium Iodine, and Zinc. They reject the Generic drug hydroxychloroquin that President Trump suggested which has world-wide acceptance by over 6,000 medical doctors.

Their one-track mind reflects a dogmatic belief that only a vaccine is the answer. The other fact that has not been mentioned in the media, and I reported in several articles recently, and that is, both the CDC and the Pirbright Institute of Surrey, UK hold patents on the COVID-19.

I even posted in previous articles the U.S. Patent for both the CDC and the Pirbright Institute, which was granted a few years ago. When a virus is patented, it means a vaccine has been created. Why have they not noted that and continue to keep telling the public that a virus is forthcoming in 12 to 18 months, when they already have it in their labs. They want to fire the flames of fear-mongering and panic so that the public will beg for it and not complain about the price. I am telling you, given what I know about Bill Gates and his foundation, this vaccine will have the "Kill Shot!"

As of Easter, 2020, we have data that shows 86% of New Yorkers who died with what is called the Chinese virus had other illnesses and health issue. Almost all were age 60 or older. Dr. Anthony Fauci, America's so-called top infectious disease expert, told CNN "New Day" host Alisyn Camerota that people could soon carry 'cards' proving their immunity to COVID-19. What we have been learning about Dr. Fauci suggests that he hides behind an image of something that he is not. Dr. Fauci the WHO, CDC, and Bill "Evil" Gates Mouth Piece Says the U.S. COVID-19 Deaths could be as low as 60,000 after warning "Millions Could Die". He is drunk on evil powers. Dr. Fauci and Bill Gates went from predictions of 65 million deaths world-wide, down to 240,000 in the U.S. and then to 60,000. This disparity in computer modelling is unforgivable, especially when the survival of the national economic depends on accuracy. In computer science this is known as "garbage in, garbage out". Dr. Fauci and Bill Gates owe an explanation to every citizen in this country and the world for that matter.

A few weeks ago, Dr. Anthony Fauci sat down in front of Congress and warned that millions of Americans could die if the federal government didn't take the outbreak seriously.

Perhaps the most telling numbers **are those that show** the vast majority who have died suffered underlying illnesses or conditions: 4,732 out of 5,489 of the deceased, or 86.2 percent.

For instance, of those victims 80 to 89 years old, 836 had high blood pressure, 488 had diabetes, and 227 had coronary artery disease. Another 157 suffered kidney disease, 148 had chronic obstructive pulmonary disease, 136 had cancer, and 132 had congestive heart failure.

Those figures are similar in the 60-69 age cohorts: 572 had high blood pressure and 444 had diabetes, while 133 suffered with kidney disease and 119 with coronary artery disease. Another 88 had cancer and 46 had congestive heart failure.

This data is a prima facie case of not just misreading the cause of death to other issues, but of much more. In addition to quarantines and lockdowns, some governments like those in China, Taiwan, and South Korea have been using a surveillance strategy called "contact tracing" to reduce the spread of the novel coronavirus.

While each country's contract tracing program has slight variations, all of them are essentially cell phone apps that keep a running record of the user's health and the health records of all the people they come into contact with.

If a cell phone comes in close contact with someone who might have the virus, the user receives a text message informing them and then instructing them to self-quarantine for 14 days.

However, the quarantine is not necessarily voluntary, depending on where you live. In some countries, phones have been used as a sort of house arrest ankle-bracelet that will notify authorities if the person being monitored leaves the house for any reason.

These apps are being touted as the way to end the shut down in both [Italy](#) and the [UK](#) and it appears that officials are going to be taking things in that direction.

At face value, it may appear that this could be a useful strategy in preventing the spread of disease, but privacy advocates and tech experts are concerned that this information could be misused and that the unprecedented surveillance capabilities could be kept and held by corrupt governments long after the pandemic is over.

In [a recent interview](#) with *Vice*, NSA whistleblower Edward Snowden expressed his concerns about the coming surveillance program, calling it the “*architecture of oppression.*”

“Do you truly believe that when the first wave, this second wave, the 16th wave of the coronavirus is a long-forgotten memory, that these capabilities will not be kept? That these datasets will not be kept? No matter how it is being used, what’s being built is the architecture of oppression,” Snowden said.

Snowden recognized that the virus was a serious threat and said that the intelligence community was well aware that it was only a matter of time before a massive pandemic crippled the country, even back when he was working in the NSA.

“There is nothing more foreseeable as a public health crisis in a world where we are just living on top of each other in crowded and polluted cities, than a pandemic. And every academic, every researcher who’s looked at this knew this was coming. And in fact, even intelligence agencies, I can tell you firsthand, because they used to read the reports had been planning for pandemics,” he said.

Snowden questioned the positive numbers that have come out of China in recent weeks and pointed out that the Chinese government has been credited with reducing the spread of the illness because they took such draconian measures during the lockdown.

Perhaps their extreme strategy is not working as well as they say it is, but since the government maintained tight control of any information coming out of the country, it is impossible to say for sure.

“If you’re looking at countries like China, where cases seem to have leveled off, how much can we trust that those numbers are actually true? I don’t think we can. Particularly, we see the Chinese government recently working to expel Western journalists at precisely this moment where we need credible independent warnings in this region,” Snowden said.

In a [statement](#) published on Friday, Apple and Google announced that they were teaming up in a rare partnership to develop compatible contact tracing apps, which they claim will work on an “opt-in” basis.

However, [according to Bloomberg](#), the companies are planning to eventually build the contact tracing into the device’s updates.

Apple and Google insist that you will still be able to opt-out of the program if you don't want to participate, but it is possible that rankings on these apps could be used to gain entry into grocery stores or larger businesses and events once the economy opens up again.

"As authoritarianism spreads, as emergency laws proliferate, as we sacrifice our rights, we also sacrifice our capability to arrest the slide into a less liberal and less free world," Snowden warned.

In the interim period for which the world has been plunged into chaos, it becomes imperative to look wide and far as to the real culprits, not just the Chinese, even though they are being dishonest or distrusting of the world, the fact is this so-called virus was a bio-weapon thrust on the world by a global power that stands to benefit if the Chinese and the U.S. went to war, since there is another nation that would benefit by such a war.

I'm suggesting that in the larger frame of view, at least a powerful force is being overlooked by the world as a causative consequence to what is being passed off as a virus, that being toxic electricity through the implementation of 5G technology. The symptoms of the virus mimic those of toxic EMF consequential 5G technology. When I sub-titled this question "contagion" or "consequence" I did so to provoke the reader to consider there is so much more that requires investigation before we be drawn into a war.
