The Vaxx, 5G, and Smart Phones Are Inextricably Linked

This report is perhaps one of the most significant articles that I have addressed or shared about the dangers of Wireless EMF toxic electrical energy. There is a huge disconnect and misunderstanding that exists when it comes to the dangers of Wi-Fi on the part of the general public.

There is an even larger disconnect between the science and the medical community in regards to what we are dealing with. Because of the invisible nature of electrical energy the assumption is that we are not in danger, yet that assumption would be completely wrong. The past month has taught me an important lesson, that being do not assume highly trained professionals in the medical community are able to see the larger picture and make the connection between the Covid-19 and **5G**.

This is a multi-disciplinary issue and it has been developed over a long time-frame. Those familiar with the science are playing catch-up with the consequences of wireless energy. By that, I am saying that we are dealing with the most diabolical of methods of eugenics to which I constantly refer back to the book '*Silent Weapons for Quiet Wars*'.

I came home from the hospital a few days ago after 12 days in an ICU. On February 24th, I was taken to the ER of the local hospital. I was gasping for breath when I went to bed a few days before and when the problem did not subside, I relented and my wife took me to the hospital. They admitted me and put me on 2% oxygen in the ICU. In the morning following two heart and lung physicians came and shared their preliminary findings from the tests done the evening before. They had a preliminary diagnosis of pneumonia and said they needed to do additional tests.

I asked the doctors to see if there were any signs of toxic poisoning since I may have been a target of directed-energy weapon. This was very similar to an incident that occurred a year ago February, 2021. We live in a rural county of some 47,000 people, which has been almost daily "chem-trailed" by C-130 aircraft. Since I have been homebound for the past seven years, the only way I could have been exposed to the aerial spraying was that it was brought into the kitchen on the shoes of those who come and go. In that first bout the only ones who came and went were my wife and our seven-year-old granddaughter. Shortly after the first incident I began running our HEPA UV air cleaner filter on a schedule daily basis to catch any pathogens that might be brought in on the bottom of shoes.

The following morning one of the hospital doctors came in and said that lab tests did not show that I had been exposed to any industrial chemicals or poisons but they were puzzled by what x-rays showed. They said that I had pneumonia on my lungs and that there was fluid in my lungs. They suggested that additional tests were available but since the hospital did not have a pulmonologist and they wanted to send me to Jewish Hospital in Louisville for a procedure that is conducted there. My wife and son encouraged me to consent and after a few hours of debate, I consented. I was told that I did not have Covid, and that my heart appeared healthy. There was expressed concern for some reason that I had A-Fib on the part of someone but the conclusion was negative.

A visiting nurse from the VNA who came to my residence on Thursday, March 18th was convinced that I had A-Fib after taking my vitals. She was concerned and when my wife told her that I was released to come home a few days prior without any oxygen, prescriptions, or meds of any kind the visiting nurse seemed alarmed.

The procedure of putting a wire down into my lungs could not be done at Jewish Hospital in Louisville due to a bed shortage linked to the Covid outbreak. It was decided that the procedure could be done at St. Joseph's Hospital in Lexington, KY, and on Friday night about 10pm, an ambulance technician pushed me into the back of the ambulance for a transfer to St. Joseph's Hospital in Lexington, KY. We arrived close to midnight and seen by the specialists the next morning. Both hospitals I was a patient are Roman Catholic hospitals part of the Catholic Hospital System. My concern the entire time was that I was not about to take any Covid vaxx should it be required and that I was not to be placed on a ventilator under any circumstances even though I specified DNR (do not resuscitate) in the event I expired. Long after the fact it became clear that elderly people in nursing homes were put on ventilators whether they had Covid or not. The fact was that upwards of 95% of so-called Covid patients died from being placed on a ventilator as the result of hypoxia. In my series on "Mass Murder" the average age of those who died as Covid victims remained steady at 74.7 years. As one in my 80s, you can imagine my concern about someone wanting to give me a Pfizer death shot!

I have too much to share and was anxious to being released from the hospital so that I could continue my information sharing relative to Covid, **5G**, and Wireless energy. My greatest fear was I would be silenced as a result of being side-lined from pneumonia and respiratory issues. I wanted to allow my mind and body to rest before getting around to telling my experience. This week I have had three different VNA nurses make their intake data gathering and beginning to work with my recovery. I first saw the case nurse, then a physical therapist and then an occupational therapist.

I thank the Lord for being discharged from the hospital without any required oxygen assistance and no prescriptions. The pulmonologist decided that the procedure was unnecessary and that treatment with antibiotics during my time in the hospital would be sufficient to enable me to heal at home.

Everything in a hospital is all about wireless EMF energy. I was plugged into remote heart monitor, blood pressure monitor, oxygen monitor, IV monitors, etc. For the duration of my hospitalization, it was one continuous background of beepers, alarms, buzzers, and devices hooked up to my body.

I am still tired from loss of sleep and being handled like a slab of beef on a work table. The facts are that a hospital is a hot spot for EMF Wireless energy, of any modulated level. I expect from what I am told, it will be a couple of months before I will feel like my old self. As such, my writing will depend on my energy level and mental sharpness. The essence of my sharing this report reflects on the fact the elite have not slowed down their war on humanity in the slightest. It remains inconclusive as to whether I was a target of a directed-energy weapons attack.

My wife and I received the CMS Covid-19 home tests in the past few weeks, and I put them in a plastic trash bag and placed them in a closet cupboard not to be used. Neither of us are taking the vax, or submitting to any tests whatsoever.

The report that follows speaks to a growing problem in the U.S. military. Sophie O'Hara wrote an article about the rising number of healthy U.S. Army airborne and special operations forces dying mysteriously.



“There is something very odd going on at Fort Bragg. So, incredibly odd that an investigative reporter and the contributing editor of *‘Rolling Stone’* magazine want to know what the heck is going on.

His name is Seth Harp, and he’s been following a disturbing story out of North Carolina, involving A LOT of servicemen who are turning up dead in their bunks at Fort Bragg, NC Here’s what Seth said in a tweet from February 9th, 2022:

“83 soldiers died at Fort Bragg in the 18 months ending June 2021. Only 11 of those deaths were from natural causes. Fort Bragg hasn’t announced any fatalities since then. They’re still happening, but the base has gone dark.”

Back in January 2022, Seth wrote about this for [Rolling Stone](#). In that piece, he discusses the MANY mysterious deaths occurring at Ft. Bragg since early 2020.

He writes:

meanwhile, Fort Bragg soldiers have been turning up “unresponsive” in their barracks on a disturbingly regular basis since the beginning of 2020, including Caleb Smither, Terrance Salazar, Jamie Boger, Joshua Diamond, Matthew Disney, Mikel Rubino, Michael Hamilton, and numerous others who have not been named.

Drugs may have been involved in the cases of Diamond and Disney, who were found dead on the same day in June 2021, just two weeks after an airborne master sergeant named Martin Acevedo III was charged with trafficking cocaine. Otherwise, there has been absolutely no explanation from the Army for how these apparently healthy young men died.

Likewise, in January 2021, an Army captain named Robert Latham died from an “apparent heart attack,” despite being 32 years old and seemingly in excellent physical condition. In October, a highly trained Green Beret and intelligence sergeant named Calvin Rockward died from a “sudden, unexpected medical event,” though he was only 38 and in even better shape, to go by his Instagram photos.

In total, a staggering 83 active-duty soldiers stationed at Fort Bragg died in the 18 months ending June 2021, according to data obtained by Rolling Stone. Only 11 of these deaths were from “natural causes.” Many, perhaps a plurality, were suicides. But in no fewer than 33 cases, the Army has classified the cause of death as “undetermined.”

In other words, the Army can’t or won’t say how a whole platoon’s worth of soldiers died at its largest installation, home of the Special Forces, the Airborne Corps, and the Joint Special Operations Command. Over this same 18-month period, just three Fort Bragg soldiers died in overseas combat, meaning these elite troops are a dizzying 27 times more likely to die stateside than in war zones such as Afghanistan, Iraq, and Syria.

And just yesterday, I saw this tweet from Seth:

Nine more soldiers, all in their 20s or 30s found “unresponsive” in their bunks. Incredibly scary and bizarre.

Here’s what Seth said:

“Here are nine more US soldiers, all in their 20s or 30s, who recently died at Fort Bragg from “undetermined” causes, or after being discovered “unresponsive” in their bunks. How can the US Army not know what is killing these soldiers? No comment from Fort Bragg.”

Could this be rampant drug use and overdoses? Yes, of course, it could be drugs or some other nefarious reason.

But while we're contemplating that, shouldn't we also look at the possibility this could be related to the vaccine?

After all, the military started "officially" injecting soldiers back in December 2020.

[Health.mil](#) reported that on Dec. 14, 2020, the Military Health System began administering the first COVID-19 vaccine shots.

A year later, the MHS has distributed more than 6.4 million doses of COVID-19 vaccine and reports 90.1 percent of active duty service members are fully vaccinated against COVID-19, with an additional 6.4 percent partially vaccinated.

It's encouraging to see that an investigative reporter is actually "curious" about these deaths, but let's see if he actually works to uncover what's really going on, or just provide "cover" for the government...

Whatever is going on, there must be a full-scale transparent investigation, and we the people need to speak out about it, and demand lawmakers get involved.

No matter what the cause, something very terrible is happening, and it's killing a lot of healthy young people, and we need to find out exactly what is going on at Fort Bragg — and also, is this happening at any other military bases?

There are a lot of questions right now, and not a lot of answers.

The gentlemen in this report and interview with SGT Report are all military trained and raising questions about the vaccines and have been pointing to the simultaneous roll out of **5G** and a larger "kill grid". I encourage you to weigh the information provided in this article. I have made myself clear that there is a direct relationship between the so-called Covid scam and **5G** wireless EMF technologies. It is my view, the proof of 5G wireless EMF radiating poison can be evaluated with all the evidence that led up to the cruise ship "Diamond Princess" and the time period between late September, 2019 and the formal so-called outbreak WHO declaration of March 10, 2020.

We've seen very clearly in recent days how the Biden Regime is waging war against Americans, by crashing the U.S. economy and the U.S. dollar with an engineered fuel- and food crisis.

This is clearly in tandem with the various genocidal initiatives that have been put in place in recent decades, like the glyphosate herbicides that have reduced human sperm counts by 90%, the forced-vaccination of school kids that has

resulted in autism rates of 1 in 17, the carcinogenic 60 Hz fields from our electric grids and the weaponized millimeter waves of **5G**, all of which are killing us softly.

This is to say nothing of the abiding demoralization campaign against life-affirming values that has been raging in pop culture since the 1960s.

Rights activist attorney, Todd Callender has been defending U.S. servicemen from being forced to take the death shot. He's joined by Dr. Pete Chambers, Special Operations Surgeon and Green Beret in the Texas National Guard, tech researcher, Nick Winters and medical researcher, Dr. John Lukacs, along with Sean at the SGT Report for an in-depth discussion about the experimental job technology, **5G** and smart phones, which they believe are all linked to the eugenicists' kill grid.

Sean plays a clip from [La Quinta Columna](#) which shows how the radiation output of a cellphone changes, depending on the video content being played on the phone. When the content is anti-establishment, the radiation becomes much higher and more toxic.

In short, **5G** is a bigger part of this picture than even the most paranoid among us may have thought.

John says that cell towers are ridiculously over-powered, saying, "To put it in perspective, a microwave oven is like a kilowatt – so it's a thousand watts. These towers, they have cables running up them; ten, twenty different cables that carry with them 300,000 watts max, each."

"So if you have ten cables, one of these towers has a maximum of three megawatts of power and these cables are not carrying data. This is not fiber optics. This is powering the [magnetron](#), basically."

"The FCC limits each array to 400 watts. But one watt from say, your phone can travel 25 miles. That's 1,000 of the stuff coming out of your microwave oven."

"What is concerning here is the modulation that is possible with the upgraded technology. They can dial this up, they can dial this back. My concern, here is that the amount of raw power, you couldn't imagine it."

"You literally could cook an entire city if you just crank the dial up to 11 for ten minutes. You could roast like a Thanksgiving turkey. And these towers are everywhere and there's multiple redundancies on all of them."

Based on the patents he's read, John thinks that the graphene oxide in the vaccines, in combination with cellphone tower radiation can create graphene hydroxide and cause self-assembly of different structures, based on the various nanoparticles present in a particular batch.

John says, ***"This is actually a manufacturing process that was a technological breakthrough that I came across reading trade papers."***

He says that glutathione can help us to de-toxify from graphene oxide (GO) and help to eliminate it from the body. However, he says if there are large accumulations of GO in our body, the first thing that happens with a certain frequency of non-ionizing radiation from a cell tower is it that it will hit these particles, causing them to multiply in physical mass by as much as 30 times.

"And it will combine with whatever else is around and form up whatever that recipe is specifically designed to tell it to form."

"So, if you want to take all the graphene oxide in your body and flip it into graphene hydroxide and flood your vasculature with little nano razor blades, as [Andreas Noack](#) warned us about, that's how it's done."

"They're using this infrastructure to create things, using the human body as a manufacturing plant."

John doesn't know what the various recipes are but he has an idea.

"These are signals that are sent – and they don't have to be terahertz frequencies, they don't need to be anything exotic. They can be from 1 gigahertz to 2.4; the stuff that cordless phones are running on."

"But it is the pattern. It's kinda like a Morse Code. So, you'll have a pulse at this frequency for ten seconds, followed by a pulse for five seconds, followed by three pulses at one second. Something like that. This is what's described in the patents I've been reading."

"They can dial in a disease or a death like you're tuning in a radio station. And they can do it across a broad area. So this is the most dangerous aspect of this, because it's so covert and it's so science fiction, almost that hardly anyone believes it."

"But I can tell you, it is very well-grounded in science. All of the different allotropes of that graphene oxide material can be generated spontaneously,

under the right EMF band. They can literally change the allotropes, from sheets to strings to Bucky Balls – there's like eight different ones."

The [essential points](#) of what Todd Callender believes are:

The Covid-19 and "vaccine" bioweapon operation is a planned genocide and war crime against humanity that is part of a multi-decade plan of the elites.

- Both Covid-19 and the injection are man-made bioweapons that include bioengineered, synthetic, chimeric, hybrid microorganisms that are both part viral and part bacterial. They use [chimeric](#) *e. coli*, Ebola, and Marburg in the shots.
- The injections contain lipid nano-particles that carry these pathogenic chimeric microbes that invade cells and genetically modify them to produce spike proteins. The HIV protein in the bioweapons disable the body's autoimmune system allowing these lipid nano-particles to invade cells. The "vaccine" gives VAIDS, or "Vaccine Auto Immune Deficiency Syndrome". All those who are "vaxxed" will now test positive for HIV. People who have taken 3 shots have no immune system left. There is no other way to characterize this program other than unlawful homicide/genocide.
- The military's own numbers in their DMED database show a 1,100% increase in all causes of mortality and morbidity among 1.8 million US soldiers from 2020 to 2021. This population group is aged between 18 and 40 years. These forecasts predict a 5,000% increase in morbidity and mortality in this same group this year (2022).
- Everyone who has taken the injections is participating in a Phase 3 Clinical Trial without having given informed consent.
- This is all tied in to the widespread introduction of **5G** communication system. The **5G** (18-60) Gigahertz EM signal produces symptoms in humans identical with Covid-19 and the "vaccine." Also, the materials in the injections are designed to be activated upon exposure to the 18 GHz frequencies emitted by **5G** antennas. Thus, **5G** transmitters (0 to 100 GHz) will be the trigger mechanism for the Zombie Apocalypse.
- The first major outbreaks of "Covid-19" occurred in Wuhan, China, Milan, Italy, and New York City just as these **5G** communications systems were being activated for the first time.
- The ADE response inside vaxxed people will turn loose the chimeric microorganisms that will turn them into N protein factories, which they will shed onto others and which are designed to be contagious. In this manner, **5G** will create the zombies of the Zombie Apocalypse.
