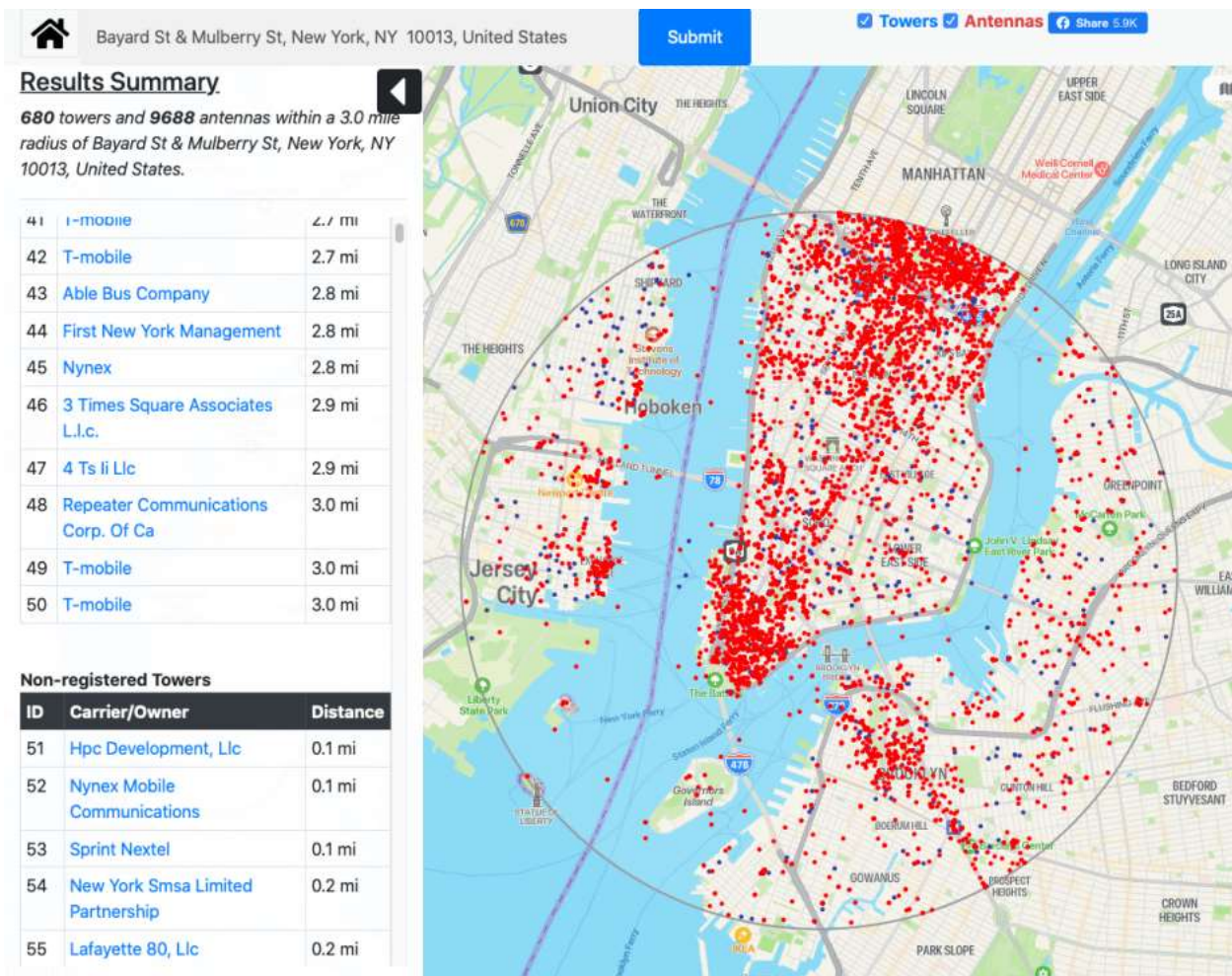

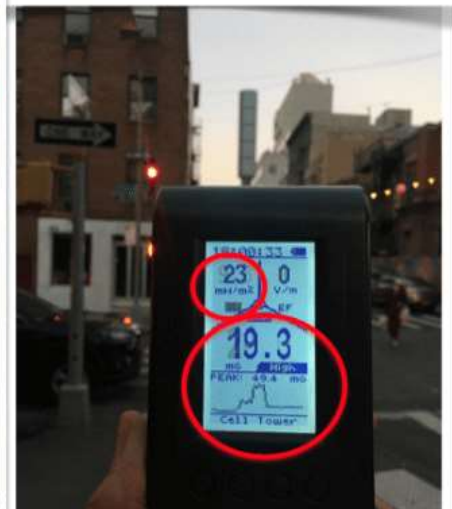
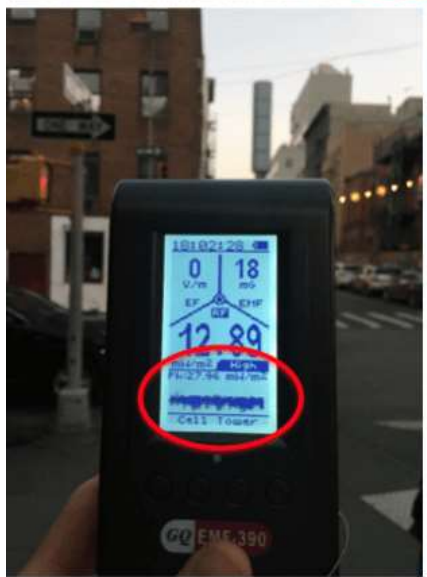

In Canada, guidelines for Radio Frequency Wave exposure lay under the jurisdiction of Health Canada. Safety code 6 was developed in 1999 and offers federal guidelines for safe RF exposure levels. These limits are in the range of 2,000,000 to 10,000,000 $\mu\text{W}/\text{m}^2$ and based solely on the short term thermal effects or the heating of body tissue. Adverse biological effects have been documented at levels far below Safety Code 6 guidelines. No Canadian biological exposure guidelines exist for long term exposure to low level Radio Frequency Radiation. This also holds true for the USA.

- $\mu\text{W}/\text{m}^2$ = millionths of a Watt per square meter (a measurement of power flux density)
- Power flux density (PFD) = the amount of electrical power that flows through a unit area: expressed as microWatts (μW) per square meter (m^2).
- PFD measures only the **rate of electrical power**, **NOT the total electrical power delivered over time**, which requires the rate to be multiplied by the time of exposure and then requires reporting the results in a **more relevant unit**: $\mu\text{W}\text{-seconds}/\text{m}^2$ or $\mu\text{joules}/\text{m}^2$
- Average $\mu\text{W}/\text{m}^2$ readings, as specified by the FCC, **significantly under-report** the levels of pulsed, data-modulated, RF microwave radiation exposures for two reasons —
 - Peak RF microwave radiation** exposures meter 100x-1000x higher than average RF microwave radiation for data-carrying, modulated, high-crest signals like Wi-Fi, 4G/LTE and 5G because of the **duty cycle**, inherent in these RF signals. Inexplicably, the FCC RF microwave radiation exposure guidelines *only consider average* RF microwave radiation exposures, which is a significant error because living organisms' biology reacts to the sharp changes of RF microwave radiation from zero to peak levels and back again. The UN ITU role of globally standardizing “**5G**” underscores a key governance flaw: Rather than following the Constitution by protecting the rights (and safety) of individuals, many public officials have been led to believe that the FCC, UN ITU, and industry guidelines trump local oversight and control.

This error was addressed by a Federal Judge in New York on July 29, 2022 in the case of [Extenet Systems Inc. v. The Village of Flower Hill](#). In a far reaching decision, the Court reaffirmed the power preserved to State and local governments by the United States Congress (47 U.S.C. § 332(c)(7)(A)) entitled “general authority,” to regulate placement, construction, siting, and maintenance of cell towers and wireless facilities within their respective jurisdictions.

THE STATE OF THE LAW

A wireless facility operator must comply with all of the following:

(1) the Federal 1934 Communications Act (CA) requirement at 47 U.S.C. §324 ch.652, Title III, 48 Stat.109 of "minimal amount of power necessary to carry out the communication";

(2) the primary purpose of CA at 47 U.S.C. §151, as reaffirmed in the 1996 Telecommunications Act (TCA) purpose at U.S.C. §332 (a)(1) Mobile Services: to "promote the safety of life and property";

(3) TCA requirements, including the circumscribed preemptions at 47 U.S.C. §332 (c)(7)(A) and (c)(7)(B) (iv) omitting the "health effects" and "operations" of wireless facilities, so as to avert any preemption thereof, and preserving state and local officials' authorities to promote health, safety, life and property; while acknowledging the actuality of "the environmental effects" of the radiation; stating positively, "Except as provided in this paragraph, nothing in this chapter shall limit or affect the authority of a State or local government or instrumentality thereof over decisions regarding the placement, construction, and modification of personal wireless service facilities";

(4) TCA's preemption bounds, which apply solely to mobile phone calls made outdoors and not to internet data or any other wireless communication, rendering all other communications outside the bounds of said preemption;

(5) TCA's Conference Report at H. R. Rep. No. 104-204, pt. 1, p. 94 (1995), leaving regulation of the operations of wireless facilities within state and local authorities and specifically citing "safety" as regulatory criterion, while warning that any further attempted preemptions "should be terminated";

(6) The U.S. Treasury's 2021 recommendation of internet ~~dataspeed~~ of 100 Mbps, both upload and download, as standard, so that people can efficiently work and study at home; which ~~dataspeed~~ is not achievable through wireless facilities without exceeding the CA's requirement of minimum power to carry out the communication, but which speed is easily achievable through fiber-optics to the premises (FTTP).

(7) The consistent decisions of the federal D.C. Circuit Court of Appeals in 2019 and 2021 declaring the FCC's ~~rulemaking~~ "arbitrary and capricious" and without "reasoned explanation" in connection with its further deregulated deployments of wireless facilities, and particularly to its exposure guideline as non-protective of health and environment, with no guideline now extant for ongoing and new transmission frequencies >6 GHz; and

(8) The federal Public Health Service Act Amendment of 1968, which states at §354: "The Congress hereby declares that the public health and safety must be protected from the dangers of electronic product radiation;" thus, the federal stance is clear, with health effects recognized and state authorities established and ongoing;

STATE OF THE SCIENCE

Tens of thousands of studies: Biological harm is positively ESTABLISHED.

As I recall I did two segments on “The Best Wi-Fi at Sea” in early 2020 that opened up the entire issue of **5G** being the real “virus” later labeled Covid-19. There are numerous articles on microwave radiation which exposed **5G** wireless EMF/EMR energy.

I knew back in 2019 that the real issue would be exposed, despite the media censorship and blocking of any reports of microwave radiation causing health issues. Majestic Princess Returns to Sydney: Over 800 People Infected With COVID-19

Princess Cruises' "*Majestic Princess*" returned to Sydney this morning after a twelve-day cruise which left port on October 31st. There reportedly are now over eight hundred (800) active COVID-19 cases on this ship. This is the biggest single outbreak since the "*Ruby Princess*" cruise ship arrived in Sydney in March 2020 with 900 infected passengers.

A Princess Cruises' spokesperson claims that the infected cruise guests are "*mildly symptomatic or asymptomatic and are isolating in their staterooms*" and all "*unimpacted guests are wearing masks and this will continue when they disembark in Sydney on 12 November.*"

But at least one media outlet, [9 News](#) in Sydney, reports that "*medical evacuations are required*" of sick passengers once the Princess cruise ship docks in Sydney.

There is some ambiguity regarding exactly how many cruise passengers and crew members are infected with the virus. There is no legal mandatory requirement for owners or operators of cruise ships to publicly disclose the number of COVID-19 cases on their cruise ships. Although Princess Cruises did in fact confirm that there is a COVID-19 outbreak on the "*Majestic Princess*", none of the news outlets in Australia indicated that the cruise line disclosed the number of infected passengers or crew

members. Some accounts mention that around twenty-five percent of the guests were positive for the virus; 25% of the 3,300 passengers would be around 825 infected guests. None of the Australian news media commented on how many crew members of the 1,300 ship employees are infected.

[New South Wales \(NSW\) has a three tier reporting system](#) where it reports and ranks cruise ships calling on NSW ports according to the percentage of cruise passengers and crew who test positive for COVID-19. NSW Health lists “% of Passengers & Crew Onboard who have Tested Positive to COVID-19 in Last 7 Days:” Tier 1 is “0.0% to <3%.” Tier 2 is “3% to <10%.” Tier 3 is “≥10%.” According to NSW Health, tier 3 likely results in an “operational compromise” of a cruise ship due to:

Major impact to staffing and/or resource shortages.

Unable to maintain critical services and/or imminent cessation of critical services. (Example: Reduction in critical staffing or resources that cannot be compensated (such as impact to healthcare workers, engineering staff, or shortages of food or PPE).

The “*Majestic Princess*” is currently designated at Tier 3 (risk level 3 of 3).

The Princess cruise ship just finished its last cruise which called on six ports in New Zealand.

There are dozens of people [tweeting their concerns that the *Majestic Princess* has been spreading COVID-19](#) in all of these ports of call. Others have rhetorically asked on [Twitter](#): “Where precisely in an overburdened health system do they have room for this?” [NSW Health](#) recently concluded that COVID-19 itself has been associated with an increase in out of hospital cardiac arrest and sudden deaths in young people.

This is not the first recent COVID-19 outbreak on the “*Majestic Princess*” which was quarantined after arriving in Tahiti last month with at least 116 cases of COVID-19, [according to a local newspaper](#).

In the last ten days, we reported that there were at least [290 people on the *Coral Princess*](#) and over [400 people infected with COVID-19 on the *Quantum of the Seas*](#) when these cruise ships ported in Australia.

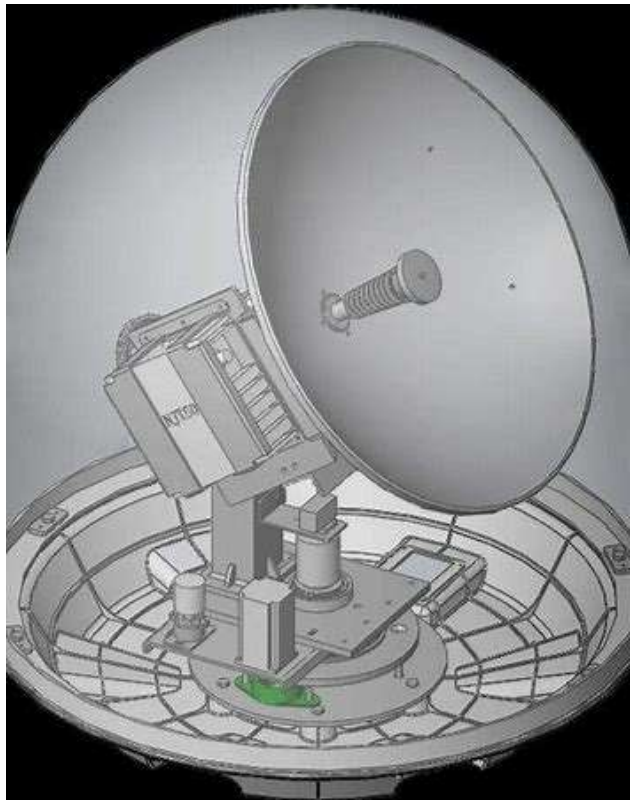
The over 800 people infected with COVID-19 on the “*Majestic Princess*” is the biggest single outbreak since the “*Ruby Princess*” cruise ship arrived in Sydney in March 2020 with 900 infected passengers, 28 of whom died prompting a class action case against Princess Cruises.



The above photo was taken October 12th, 2022 at Tahiti when the “*Majestic Princess*” made a stop the month before. Note the tourist casual clothing worn here on a warm day, the female tourist wears a mask and the male is wearing a shirt with the sleeves rolled-up!

Apparently this virus has no preference for climate zone. Tahiti on the map, also known as The Islands of Tahiti, or French Polynesia, is located in the South Pacific Ocean about halfway between California and Australia. Although, it seems half a world away, Tahiti is in the same time zone as Hawaii and is about as far south of the equator as Hawaii is north of the equator.

The above left illustration is what is behind the large white globes mounted on the top decks of floating cruise ships and most commercial and naval ships afloat today. The globes, called Radomes on cruise ships are usually made of fiberglass, a reinforced plastic using glass fibers, or a PTFE treated fabric. Radomes on cruise ships are constructed with materials that very minimally reduces the electromagnetic signal transmitted or received by the antenna.

The purpose of the Radomes is to provide protection from the elements at sea. These include ocean waves, rain, fog, cloud cover, dust, sea mist, and even snow. **5G** communications were first installed on cruise ships in the latter half of 2019 in order to provide telecommunications to areas of the Earth above 51-degrees latitude north of the equator and -51-degrees south of the equator. Every cruise passenger wants to be able to call home, send their latest pictures of where they are as well as be able to talk with their family, friends, and co-workers. But you really have to ask the question, is it worth my life?
