

# Trilateral Commission Declares “2023 is Year One of this New Global Order”

I want to preface Patrick Woods’ statement that we are at the threshold of the Biblical New World Order. **The Trilateral Commission formally has declared 2023 as Year One of the New Global Order.** This declaration goes in line with the coming Coronation of Prince Charles of Wales as King of the British Empire. Many commentators are quick to point out how these global groups are playing a major role in international affairs but almost never mention the name of Mr. Big who operates from the shadows behind the scene. As Tim Cohen said recently in a two-hour interview, even Klaus Schwab reports to Prince Charles. Klaus Schwab co-founded the World Economic Forum at the behest of Prince Charles of Wales in 1971. Unless he changes radically, there is absolutely no hope for a bright future with a king who supports the depopulation program and defies Christian values.

This announcement of the Trilateral Commission has huge Biblical significance in prophetic terms that most people are oblivious to and its implications. It indicates that the prophet Daniel’s 70<sup>th</sup> Week of Prophecy has begun or is about to begin on God’s Biblical Time Line! The corroborating evidence revealed in this article can only be explained through a Luciferian backdrop framework laid out both in Scripture and the world of the Occult; however, the collective data that is revealed pictures an incredible orchestrated scenario which seems impossible to comprehend. The Trilateral Commission’s 50th anniversary marks the culmination of its self-proclaimed “**New International Economic Order**”. On March 12, the Trilateral Commission held its plenary meeting in New Delhi, India to discuss issues relating to globalization. Trilateral Commission co-founder Zbigniew Brzezinski’s “Technetronic Era” has apparently officially arrived.

Amid the new world alliances that are forming as India and China seek to normalize relations and as China just brokered a relationship between Saudi Arabia and Iran, the globalist narrative has opened a new, and possibly final, chapter. According to [NikkeiAsia](#), one unnamed Trilateral Commission member addressed the plenary meeting and stated,

*“Three decades of globalization — defined as integrated, free-market based and deflationary — has been replaced by what will be a multi-decade period of globalization*

defined as fragmented, not-free-market-based but industrial-policy based and structurally inflationary. **This year, 2023, is Year One of this new global order.**"

This reflects Brzezinski's early strategy to transform the world as he wrote in 'Between Two Ages: America's Role in the Technetronic Era:'

*"The nation-state as a fundamental unit of man's organized life has ceased to be the principal creative force: International banks and multinational corporations are acting and planning in terms that are far in advance of the political concepts of the nation-state."*

The Trilateral Commission Gives The Signal To the WEF ~ It's GO Time!

Klaus Schwab, founder of the World Economic Forum (WEF), stated in 2020, "The pandemic represents a rare but narrow window of opportunity to reflect, reimagine, and

*reset our world*". This followed my analysis that the so-called pandemic was Technocracy's coup d'état that had been building up for over 45 years at the hands of the Trilateral Commission. In fact, I have argued consistently that the Commission's original "*New International Economic Order*" was nothing more than Technocracy warmed over from the 1930s. It was Brzezinski's Technetronic Era. It was the United Nations' Sustainable Development. It was Biden's Green New Deal – all one and the same and all strategized by members of the Trilateral Commission starting in 1973.

The WEF is thoroughly intertwined with the United Nations and vigorously promotes its "Sustainable Development Goals"; the hallmark of Prince Charles. The WEF website states,

*The COVID-19 pandemic has presented its fair share of challenges but has also offered opportunities. The World Economic Forum has assembled physical events for over 50 years, but we now have a unique opportunity to take the experience online.*

*As part of the Sustainable Development Impact Summit 2020, the World Economic Forum is experimenting with a 3D environment that allows spacial exploration of the Sustainable Development Goals, SDG-specific content discovery, and experiencing the ambience of a physical event from your computer. Watch the video below for a sneak peek of our exploration.*

When Schwab says that the WEF is "*reimagining the future*", he is flatly misleading. The future was already reimagined by early members of the Trilateral Commission such as Zbigniew Brzezinski, David Rockefeller, Richard Gardner and, Henry Kissinger (all founding members).

On June 3, 2020, Schwab wrote on the WEF [blog](#),

*To achieve a better outcome, the world must act jointly and swiftly to revamp all aspects of our societies and economies, from education to social contracts and working conditions. Every country, from the United States to China, must participate, and every industry, from oil and gas to tech, must be transformed. In short, **we need a "Great Reset" of capitalism.***

Now the Trilateral Commission, acting as quarterback, has relayed the call to the WEF that "***This year, 2023, is Year One of this new global order.***" In other words, pull out all the stops. The Great Reset has arrived. Execute the battle plan to terminate capitalism and free market economics.

What does this mean for 2023?

As I have written, we are already experiencing a "polycrisis of doom" where multiple crises are descending upon us at the same time. There is a man-made energy crisis that is warring against coal, oil and natural gas. There is a man-made food crisis that is warring against all traditional food systems. There is a man-made financial crisis that threatens total collapse of the existing financial system. There is a man-made military conflict between Russia and Ukraine that threatens WWII.

Any one of these pending crisis could be seen as a “scorched-earth” policy where total destruction is possible down to ground level. If all four are unleashed at the same time, it would be the equivalent of atomic warfare resulting in a literal “dark winter”. Such a collapsed world would then be ripe for total capture and rebuilding into Technocracy’s dystopia.

Don’t shrug your shoulders.

It is unfortunate that hardly anyone has given any credence to the Trilateral Commission over the years. I will say pointedly that the first person to bust them was the late scholar and professor Antony C. Sutton, with whom I co-authored *Trilaterals Over Washington, Volumes I and II* between 1978-1981. Few paid attention back then, just as few pay attention today. We were mercilessly censored back then, just as I am censored today. Nevertheless, our work has stood the test of time and now the endgame is at hand.

If you feel like you are in the dark on this, now is the time to start reading and studying Sutton’s and my combined works.

I have been a regular reader of Patrick Wood’s work for years until censoring started, and a few years ago my AOL subscription to Patrick’s daily posts weekly were being blocked only to find out that AOL was censoring my access. It became obvious that censors at AOL were doing what they could to block me from Patrick Wood’s site. Interestingly, Prince Charles name began to surface from behind the curtain of global events. Charles launched three related instruments at Davos 2020: the Terra Carta, the Sustainable Markets Initiative and the Sustainable Markets Council. If you have been following the Prince as long as I have, you know he has been a major “player” since the 1980s.

Two years ago, Prince Charles urges businesses to sign a Terra Carta pledge to put planet first. The Magna Carta-style project aims to ‘bring prosperity into harmony with nature’. Prince Charles was urging businesses to invest in the health of the planet and people at the launch of a sustainable finance charter backed by several international institutions.

Evoking the history of Magna Carta, the Prince of Wales launched the Terra Carta – the Earth charter – that asked signatories to agree to almost 100 actions to become more sustainable by 2030.

In the Terra Carta’s statement of intent, the voluntary commitments include supporting international agreements on the climate, biodiversity and desertification, backing efforts

to protect half of the planet by 2050, and make investment and financial flows consistent with a future of low greenhouse gas emissions.

The charter, launched in January, 2021 Monday before the One Planet summit in Paris, aims to raise more finance to invest in nature, citing the example of the Natural Capital Investment Alliance, which is looking to raise \$10bn (£7bn) by 2022.

*“I am making an urgent appeal to leaders, from all sectors and from around the world, to give their support to this Terra Carta, to bring prosperity into harmony with nature, people and planet over the coming decade,”* Charles will tell the conference on Monday.

*“I can only encourage, in particular, those in industry and finance to provide practical leadership to this common project, as only they are able to mobilize the innovation, scale and resources that are required to transform our global economy.”*

Companies supporting the launch of the Terra Carta included BlackRock, Bank of America and HSBC. While some signatories are big investors or financiers for the fossil fuel industry and sectors linked to biodiversity loss, the commitments signal an intention to transition to a low-carbon future that also backs biodiversity restoration.

In the foreword for the launch, Charles has written about the importance of mainstreaming sustainability into all aspects of the global economy.

*“If we consider the legacy of our generation, more than 800 years ago, Magna Carta inspired a belief in the fundamental rights and liberties of people. As we strive to imagine the next 800 years of human progress, the fundamental rights and value of nature must represent a step-change in our ‘future of industry’ and ‘future of economy’ approach,”* he stated.

*“With this in mind, nature, of which we are an integral part, lies at the heart of the Terra Carta. I am calling on CEOs from around the world to engage and play their part in leading the global transition.”*

The November, 2020 issue of *‘Executive Intelligence Review’* had this to say:

Nov. 7—In early June, the World Economic Forum (WEF) and HRH Charles, Prince of Wales, launched the Great Reset initiative, aimed at promoting policies to tighten elitist global financial and economic control—presented as a way to rebuild from the pandemic. On June 3<sup>rd</sup>, the keynote speech was given by Kristalina Georgieva, Managing Director of the International Monetary Fund (IMF). Other speakers included the chief executives of Microsoft, BP, and Mastercard.

Since then, the WEF platform has conducted a series of Great Reset conferences, involving hundreds of speakers, to promote their “rebuilding” theme, while in fact, spelling out specifics of their worldwide Green New Deal—cutting power, industry,



agriculture, infrastructure, and other means of life, wrapped up as commitments to goals of Zero Emissions and “new systems.”

All the while this evil campaign is underway, some have mischaracterized the Great Reset threat as a “*global health dictatorship*.” Some clarification on that is in order, given below.

It must be noted at the outset that the Great Reset is just a pandemic-period continuation of the pre-COVID-19 green, anti-development perspective of banker elites centered in London/Wall Street networks, and Prince Charles in particular, who, after all, is a close collaborator of Klaus Schwab, founder and Chairman of the World Economic Forum. The WEF supports Charles’ Sustainable Markets Council for developing ways to decarbonize the world. Charles gave the keynote on a green future at the 2020 WEF Davos meeting in January. In September, at the time of the UN General Assembly in New York, the WEF held a forum on “*Realizing a ‘Great Reset’ for Sustainable Development*,” where Charles held forth on how the scale of the Great Reset requires a worldwide green “Marshall-like plan” to decarbonize the behavior of consumers, businesses, agriculture, investors, and all.

The enforcement arm of this is Green Finance, and among its principal figures is Mark Carney, another pal of HRH Charles. Carney was Governor of the Bank of England (2013-2020), and is on the Foundation Board of the WEF. In 2018, on Charles’ 70th birthday, Carney gave a speech in which he said that, “His Royal Highness has provided inspirational leadership” for decades, on the need for a green horizon.

Today Carney—besides doing private banking in his home country of Canada—serves as UN Special Envoy on Climate Action and Finance. After the 2015 Paris Agreement on climate change, an agreement for reducing human existence in the false name of saving the planet from emissions-death, Carney and his banker and billionaire cronies, including Michael Bloomberg, set up a new association to restrict credit so that it goes for only select green purposes, and not for high-tech energy, industry, agriculture, and infrastructure. It is the Task Force on Climate-Related Financial Disclosure.

On November 9, Carney will be on the opening panel of a WEF Great Reset event titled, “Green Horizon Summit—The Pivotal Role of Finance.” It runs through November 11, and is co-sponsored by the City of London Corporation, in collaboration with the Green Finance Institute and the WEF. Other speakers on the first panel, which is titled, “Cartography of Post-COVID-19 Green Growth,” include Christine Lagarde, Chairman of the European Central Bank; Andrew Bailey, Governor of the Bank of England; and the IMF’s Georgieva again. On November 10, Bill Gates will speak, along with Larry Fink, CEO of BlackRock.

Just as the Great Reset features bankers and billionaires, in their own name, issuing their dictates on what they say is permissible to happen under their green rules, so other leading cartel and financial figures are active in many economic sectors for the Reset. For example, at a Great Reset summit on “Bold Actions for Food as a Force for

Good,” November 23-24 (online), the World Wildlife Fund (WWF) is a co-sponsor of a panel asserting the perspective that, unless their activity is limited, humans degrade the Earth. The panel is titled, “Boosting Nature—Positive Production.” This conference is the public relations side of WWF activity around the world, in league, for example, with Cargill—the huge agro-commodities cartel, McDonalds, and others, to dictate how food is produced.

### Three Pillars of the Great Reset

In her June 3 speech at the launch of the Great Reset, Ms. Georgieva stressed three pillars of the initiative. She said, *“From the perspective of the IMF, we have seen a massive injection of fiscal stimulus to help countries deal with this crisis, and to shift gears for growth to return, it is of paramount importance that this growth should lead to a greener, smarter, fairer world in the future”* [emphasis in the WEF transcript]. She ended her remarks saying, *“And I want to say—loud and clear—the best memorial we can build to those who have lost their lives in the pandemic is to build a world that is greener, smarter, and fairer. ...”* Think the exact opposite of what that might be!

Translated into reality:

With “*greener growth*,” the intent is to bail out the bankrupt financial system with measures creating a Green Bubble generated by massive government spending for an “energy transition” into a “carbon-free” economy. The blueprint for that is the Green Deal policy of the European Commission. Mark Carney is its champion.

Under “*smarter growth*,” special emphasis is given to the digital economy, and overcoming the digital divide among countries in the world. Digital technologies, although important, cannot replace energy, transport, industrial and agriculture improvements, and other basic infrastructure, without which economic growth is impossible, but which the Great Reset ignores.

The third pillar, “*fairer growth*,” emphasizes the “expansion of social programs.” Behind the nice words, however, is the intention to manage increased poverty with handouts, rather than eliminating poverty worldwide.

In sum, the Great Reset is just a newer version of the Keynesian policy adopted by Hjalmar Schacht, Hitler’s Finance Minister, to streamline the financial system in such a way as to bail out the assets of the super-rich, ruin the middle class, and destroy the poor. As John Maynard Keynes specified in the German edition of his work in 1936, *The General Theory of Employment, Interest and Money*, such policies are best implemented by authoritarian regimes.

### Missing the Target

Rather than exposing and rejecting this evil policy in those terms, some have adopted a distorted version of the Great Reset, claiming that it aims at a “health dictatorship” run by Bill Gates and the Chinese, to force vaccination on the population and threaten with expropriation those who refuse.

While trans-Atlantic governments have failed to control the pandemic, and are restricting liberties in order to stay in power, it is dangerously misguided to present mandatory vaccination as part of a health dictatorship. Vaccination is an achievement of humanity. It existed well before Bill Gates, and to oppose it because of Bill Gates is like being against motorways because Hitler built them. The no-vax movement is a product of the same "factory of irrationality" that has produced radical movements to stop global warming and other imagined threats.

Many royal watchers believed that the 7 year Tribulation would start in the year 2006 - 2012. William will be known as King Arthur and will be accepted by Israel as the Messiah of Peace in the year 2006, and will be destroyed in the year 2012. He will turn 30 years of age in 2012. The same age Christ was at the beginning of his kingship and ministry. But as we know, it did not happen. Prince William comes from the Royal Bloodline of Cain and the false throne of David.

With Prince Charles's Masonic/Islamic status he was welcomed as a hero throughout the Middle East Arab countries. He is behind three of the most important documents of the decades, the U.N's Global Security Program, the 7-year Oslo Accord, and the Rio Summit's Agenda 21. The holdings of the House of Windsor constitute enormous wealth.

Nostradamus was a member of the "*Protocols of the Learned Elders of Zion*" which was largely a Rothschild Freemasonry plan. In his quatrains he refers to the advent of "*Le Grand Monarch*" indicating that this sovereign will ultimately derive from the Merovingian dynasty; implying a double hegemony of the Papacy and the Empire, or both the Vatican and of the Habsburgs. He frequently referred to the Knights Templars and to the house of Lorraine which is now synonymous with the Habsburgs.

### **British Israelism**

In the belief system of 'British Israel' it is taught that the literal descendants of the lost ten-tribe House of Israel are found today in the British Commonwealth of Nations, the United States of America, and certain areas of northwestern Europe, particularly Denmark, Sweden, Norway and Holland.

Traditional Protestant teaching takes issue with the view of British Israelism made popular in the U.S. by Herbert Armstrong and the Worldwide Church of God. At his death in the late 1980s, under Garner Ted Armstrong, his son's leadership, the WCG splintered into various factions like the United Church of God, and other Christian Identity. My dad emigrated to the U.S. from Belfast, Ireland as a teenager, and as long as I could remember, Armstrong's publication '*The World Tomorrow*' came in my dad's mail.

The primary goal behind British Israelism is to claim that England and the United States have inherited the covenant promises God made to Israel. While England and the United States have been blessed by God in many ways, it is not because God's promises to Israel have been transferred to those two nations. God's covenants with Israel always involved the specific land of Israel. Abraham's descendants would inherit the land. The blessings of God to Israel were always in connection with the specific land that was promised. These promises, therefore, cannot apply to England or the United States, as those two nations do not possess the Promised Land. Further, while a significant number of Americans have English heritage, there are far more American immigrants from other nations combined than from England.

British Israelism (and other forms of Israelism) should be rejected because it does not have a solid basis Biblically or historically. That has not stopped or prevented the Royals from propagating it in their claims to what is taking place these days as Prince Charles Coronation event is slated for **May 6<sup>th</sup>, 2023**.

Israel has become **"a nation and a company of nations"** -(Genesis 35:11) - the U.S.A. (a nation), and the British Commonwealth (a company of nations).

The people to be reigned over by David's throne were to be descendants of the tribes of Israel, who migrated from Palestine through Europe to the **"appointed place"** -(2<sup>nd</sup> Samuel 7:10), identified as the (British) "Isles" -(Isaiah 41:1).

### **Coat of Arms**

The British Coat of Arms, like all heraldry, contains much symbolism and provides strong evidence of the nation's origin and ancestry. It clearly displays the national emblems of ancient Israel.

The lion and the unicorn supporting the shield are both identifications of the Israel nation. Speaking of Israel, the Bible says, **". . . he hath as it were the strength of a UNICORN ... he couched, he lay down as a LION, and as a GREAT LION who shall stir him up?"** -(Numbers 24:8-9).

In the beginnings of the Bible story we read how Israel, whose former name was Jacob, obtained the God-given birthright of an everlasting national covenant.

Under the British Coat of Arms is a motto, **"Dieu et mon droit"** meaning "GOD AND MY RIGHT", referring to this birthright.

The other motto around the shield, **"Honi soit qui maly pense"** means "SHAME ON HIM WHO THINKS EVIL OF IT." This again was God's covenant promise to Israel, when He declared, **"I will bless them that bless thee, and curse him that curseth thee"** - (Genesis 12).

The shield is symbolic of God's assurance to David, King of Israel, that his house and kingdom would be established forever -(2<sup>nd</sup> Samuel 7).

The two quadrants (first and third) containing the lions passants represent England, whilst the second quadrant, containing the lion rampant, represents Scotland.

The Harp, displayed in the fourth quadrant of the shield, is associated with David (as recorded in 1<sup>st</sup> Samuel 16:23) and represents Ireland.

The Crowns surmounting the helmet and on the lion and unicorn symbolize Kingship. Abraham and Sarah were promised that their descendants would be kings -(Genesis 17:5-6). This was to be Israel's high calling -- to be a nation of kings ruling as God's instruments of blessing.

The British Coat of Arms stands today as a reminder of God's great and unfailing promises, that undergirds all that British Israelism stands for and its legacy as a world power.

The book *'The Bloodline of the Holy Grail'* by Laurence Gardner writes about a 'Virgin' from the Merovingian Bloodline to marry into, in effect, finally legitimizing their long held occult power and authority claimed of them as well as pouring the most Holy Blood of Christ into any child to come from such a union, and so, a Merovingian Virgin was sought by the Windsors and found in Diana Spencer.

This Magdalene heresy prepared in secret by the Knights Templar, a shadowy blood cult who had its birth in the dark recesses underneath Jerusalem near the Temple Mount at the time of the Crusades, is where most Grail lineage theorists begin. However, the actual plan to bring about a Messiah from the Merovingian line did not begin with these nine men, it can be traced as far back to the ancient Celtic Druids, and far beyond them to a magical priesthood some label only as Atlantean.

The British Royal ends with the greatest Occult secret being revealed to the world, to their own future horror. Many of today's occult and "fraternal orders" such as the Scottish Rite Freemasons and many others trace their spiritual roots to Templarism as they are the gatekeepers, perhaps to hell itself.

A British-led Anglo-Empire uniting the world in 'peace' while bringing forth a Merovingian Arthurian - like leader to the forefront and we have all the makings of a grand global conspiracy. We aren't directly told who this future ruler might be, yet the Occult underground is supposedly preparing their ranks for a young and charismatic Prince who will be seen by many in the future as King Arthur returned.

Both Prince Charles and Prince William carry the name 'Arthur' as middle names. *"...King Arthur is not dead, but he shall come again and he shall win the Holy Cross. I will not say it shall be so, but rather I will say there is written upon his tomb this verse: Hic Jacet Arthurus, Rex Quondam, Rexque Futurus...Here lies Arthur, the Once and Future King."*

Antichrist has 33 titles in the Old Testament and 13 in the New.

### **HIS COAT OF ARMS / CREST - THE BEAST**

***"And the beast which I saw was like unto a leopard, and his feet were as the feet of a bear, and his mouth as the mouth of a lion: and the dragon gave him his power, and his seat, and great authority."*** -(Revelations 13:2). The composite beast of Revelation 13:2, with the head of a lion, body of a leopard and feet of a bear is symbolic for other people - but not for Prince Charles. It is on his Coat of Arms. It represents the emperors of the Holy Roman Empire. These are the animal symbols for France, the Leopard; Germany, the Bear; and England, the Lion. These nations represented the western arm of the Holy Roman Empire. His Coat of Arms contains ten



heraldic beasts, which is a first for the British Monarchy. All previous British Monarchs had either three or six, but none have ever had ten.

### **HIS COAT OF ARMS / CREST - THE RED DRAGON**

Revelations 13:2 also says, ***"And the dragon gave him his power and his throne and great authority."*** The dragon is "symbolic" to others, but not to Prince Charles. He has a red dragon on his coat of arms. It comes from the flag of Wales, and it is in this title, Prince of Wales, that Charles is heir-apparent to the throne of Great Britain. At his coronation (investiture as Prince of Wales) in 1969, he sat on a chair with a large red dragon emblazoned on it. During the ceremony, his mother Queen Elizabeth II said, *"This dragon gives you your power, your throne and your own authority."* His response to her was, *"I am now your Liege-man, and worthy of your earthly worship."* Liege is an old English word meaning "Lord". ***"I am now your Lord-man, and worthy of your earthly worship."*** Another reference to the red dragon is in Revelations 12:3 ***"And there appeared another wonder in heaven; and behold a great red dragon, having seven heads and ten horns, and seven crowns upon his heads."*** Prince Charles is the ONLY person in the world to whom ***"And the dragon gave him his power and his throne and great authority"*** can literally be applied to!

### **HIS COAT OF ARMS / CREST - THE ORDER OF THE GARTER**

Another symbol on Prince Charles' Coat of Arms is that of The Order of the Garter. The Order of the Garter is the parent organization over Free Masonry, worldwide. When a man becomes a 33<sup>rd</sup> Degree Mason, he swears allegiance to that organization, and thereby to Prince Charles. According to *'The 'Morals and Dogma' of the Ancient and Accepted Rite of Freemasonry'* written by Albert Pike (Grand Commander, Sovereign Pontiff of Universal Freemasonry, July 14, 1889) Lucifer is the GOD of Freemasonry (see page 321 of the 1942 edition). On page 819 you will find just one example of why there are many people in Freemasonry who believe that it is natural to be a Christian and a Mason. Masonry intentionally misleads the lower degree initiates and hides the truth that the god of Freemasonry is Lucifer, except to those in the 30<sup>th</sup> and higher degrees. *"The Blue Degrees are but the outer court or portico of the Temple. Part of the symbols is on display there to the Initiate, but he is intentionally misled by false interpretations. It is not intended that he shall understand them; but it is intended that he shall imagine he understands them."* Further proof of Lucifer worshipping amongst Freemason can be seen in how they measure the year. For instance the year 1998 (up until September) is according to Freemasonry the year 5997 AL (that is 5997 anno Lucifer).

### **ONE WORLD RELIGION - CHARLES CONVERTS TO ISLAM?**

Various reports have appeared in London and Arab newspapers over the last few years, claiming that Charles has converted to Islam. This supposedly took place when he met with the mufti of Cyprus Shaykh Nazim Adil (in 1993). Now while there's no actual evidence to prove that he has converted to Islam, there is no evidence to prove that he hasn't. In fact his lecture delivered in February 1994 at Oxford extolling the virtues of Islam, his frequent visits to Islamic holy places, his dedication of a South London mosque, outfitted in traditional Sunnah attire; and his 1993 trip to see the Quran of

Sayiddina `Uthman (in Tashkent, Uzbekistan) with Shaykh Hisham Kabbani, only lend credence to the claim. Of course, this is just the sort of tactic to expect from the antichrist. That is to say, if he were to openly come out and say that he had converted to Islam, this would make many Jews wary of him. Whereas, if he were to spread rumors that he was a Muslim and not publicly deny them, then he could get Muslims on his side whilst not alienating Jews.

### **JACOB'S PILLAR (THE STONE OF DESTINY)**

On June 2nd 1953, with the knights of the garter carrying and holding the canopy over her head, Elizabeth II was anointed and crowned as *"Queen of thy people Israel"*. Both Prince Charles and his mother believe that the throne upon which the queen was crowned, the famous coronation chair at Westminster Abbey in London, is the rightful throne of King David. One of the reasons for this is because up until recently it contained a 336 pound stone known as Jacob's Pillar (also referred to as Jacob's head-rest, the stone of Scone, or the stone of destiny)

It was at least a decade after her death the public learned about the fact that Princess Diana's mother was a Rothschild, the press headline read: Prince Williams Antichrist Princess Diana's Mother is a Rothschild!

BBC News UK 29 April, 2002, Prince calls for greater tolerance. Prince Charles met religious leaders in Birmingham. The Prince of Wales has launched a campaign for greater tolerance and understanding between different faiths and religions. The campaign, named Respect, is part of the prince's contribution to the Golden Jubilee celebrations.

At the launch of the campaign at Birmingham's International Convention Centre on Monday, the prince met religious leaders from different faiths and called for greater understanding. Although the campaign will initially focus on greater tolerance between faiths, it will also target people in all areas of society over two years.

## **Embrace cultures**

Speaking at the conference, the prince said there had been too many examples of intolerance over the past few years.

He said: *"Good neighbourliness is perhaps one of the things most in need of repair."*

*"In the next two years, I hope the movement we are launching today will be able at least to help in the repair work."*

*"It is about the young Muslim mowing the lawn for the elderly Hindu lady down the street or the choir from the Catholic Church singing to entertain the Jewish old people's club."*

*"It is the small things above all that will make our communities a better place to live."*

The prince particularly hopes to encourage children to embrace others from different backgrounds and spend more time learning to understand new cultures. The idea is that volunteers, mostly young people, will be urged to work together and share more leisure time with strangers from other backgrounds. Schools will be sent information packs and be invited to take part.

Prince Charles' plan is born out of several meetings he has held over the years with various religious leaders, including the Archbishop of Canterbury.

## **'Faith defender'**

He took a close interest in the riots in Bradford last summer and hosted a dinner at his Highgrove home for leading Muslim figures shortly after September 11.

In 1994, he declared his intention to reign as *"defender of faith"* rather than *"defender of the faith"*. In Birmingham, the prince met, among others: Chief Rabbi, Dr. Jonathan Sacks; The Anglican Bishop of Liverpool, the Right Reverend James Jones.

Muslim scholar, Dr. Zaki Badawi Chairman of the Sikh Network, Indarjir Singh Hindu representative, Dadi Janki The campaign was put together with the government-backed TimeBank charity, which raises awareness of volunteering.

It's plans was to mobilize hundreds of volunteers to endorse the Respect project. Spokeswoman Helen Thompson said: *"It's all about giving people more time with each other."*

In the early stages of the project, faith networks will be used to distribute leaflets. Later, nationwide campaigns will be run to encourage people to display greater respect and understanding to others at work and in the street.

The BBC's Nicholas Witchell reports from Birmingham *"Promoting inter-faith understanding is a priority of the Golden Jubilee"*

In summary, once a ten-nation Western confederacy has been formed based on the ancient and western Roman Empire, which occurred in January 1981, then "*Number Eleven*" comes to power, the Little Horn (or Little Prince). **666** = AOM HA (111 x 6), THERION (Beast), ANKH-AF-NA-KHONSV(T), SVRTh (Spirit of the Sun), and ShMSh IHVH (the Sun of Tetragrammaton). **666** is the Most Holy Number of the Sun. It is symbolized by the letter Shin made of three Vavs (= **666**). Shin is the letter of Path 31 on the Tree of Life and 31 = AL (The All). **666** is the mystical number of all the Paths of The Concealed Glory, for there are in fact 36 Paths of the Tree of Life, 32 of which are known, and four of which are secret. **666** is the occult number of the Hexagram, the symbol of the Sun, for a single line of the Hexagram contains three equal parts, each of which may be represented by the number 1, so that every line can be symbolized by the number 111. There are six lines in all, so that 111 x 6 = **666**, the most Holy Number of the Sun. Each angle of the Hexagram is 60 degrees. 60 is the number of the Hebrew letter Samekh, which is the letter of the Holy Guardian Angel or the Solar Self in Man. Six angles of 60 degrees each equals 360 degrees, and 360 is the number of the Hebrew letter Shin spelled in full. Shin is the letter of the Sun and of **666**. Also **666** is the number of a "Man" who lives in the Sun.

In '*The Lost Keys of Freemasonry: The Secret of Hiram Abiff*', it states,

*"The day has come when Fellow Craftsman (Freemasons) must know and apply their knowledge. The lost key to their grade is the mastery of emotion, which places the energy of the universe at their disposal. Man can only expect to be entrusted with great power by proving his ability to use it constructively and selflessly. The seething energies*

*of LUCIFER are in his hands, and before he may step onward and upward, he must prove his ability to properly apply [this] energy. He must follow in the footsteps of his forefather, Tubal-CAIN."*

Tubal-Cain\* was the great Vulcan of the era, the holder of Plutonic theory (knowledge of the actions of internal heat) and was, therefore, the prominent alchemist. [\*Tubal-Cain; well-known Cainite Patriarch adored within secret societies; see also Genesis 4:22; Tubal-Cain was a sixth descendant of Cain] Qayin (Cain/Kain) - properly Q'ayin or 'Smith' - Qayin's heritage was that of the ancient Sumerian metallurgists and the supreme Master of the Craft was Qayin's father Enki, described as 'the manifestation of all knowledge.'

The Thirteenth Bloodline has been traced as far back and east into Ancient Egypt, Sumeria, and Persia, as well as in Rome. This is important and makes a vital connection to many because their "sacred" symbol, the All-Seeing Eye above the Pyramid, which is originally traced even farther back to Atlantis, was also found throughout much of the ancient world and wherever their 'secret societies' went. The All-Seeing-Eye over the pyramid represents the totality of the Great Work, which is to place one King on the world throne. The Eye above the 13 steps is the Egyptian god Horus, Son of Osiris (Lord of the Underworld). With this we can determine that the Eye therefore represents Lucifer's Son, the Antichrist. It is also said the entire symbol itself denotes the Satanic trinity thru its Egyptian counterparts in the Father Osiris, Mother Isis, and their magical Child, Horus. [the exact same archetypes in SATAN, DIANA, and WILLIAM].

Great Britain is certainly the mother country of Satanism and the British Royal Family has long been involved with the Occult, Masons even refer to the Queen of England in one of their own Satanic rites as the 'Queen of Babylon.' For more information on Satanic lineages within Britain, there is a detailed examination in the book '*The Prince and the Paranormal -the Psychic Bloodline of the Royal Family*' by John Dale (1987). The Royal Family has also been actively involved with Freemasonry and most notably, the Garter Order, as well as the Scottish Knights Templar. British Intelligence MI6 has been a major vehicle for the Satanic hierarchy working behind the secret veil of Freemasonry to control world events thru assassinations, sabotage, and intrigue.

The marriage of Charles to Diana was so extremely important because Diana brought one aspect of the Merovingian bloodline back to the English crown: Greatest among the princess's forbearers were the Stuart kings, Charles II and James II. In marrying Prince Charles, she has unwittingly given this Bloodline to the current Royal Family in England, and thus, her son Prince William is the first child to claim lineage from every English king who has left descendants.

'Committee of 300' by Dr. John Coleman

According to John Coleman, The Committee of 300 is a secret society of top royalty, politicians, businessmen, economists, military commanders, intellectuals, scientists and religious authorities who work towards the Illuminati plan via another organization, The

Round Table. This Arthurian symbolism suggests British influence, dating from the British Empire (which included such figures as Cecil Rhodes, H. G. Wells and the Fabian socialists) . . . which some hoped would provide the basis for a world government. Most people believe the British Empire is long gone, but Coleman suggests the Empire is still very much with us. Its overt power has simply been replaced by covert power, behind the scenes.
