The Religion of the Climate Change Cult

“The clock is ticking...We are in a fight for our lives... We are losing... We are on a highway to climate hell with our foot still on the accelerator...”

Sensible students of history and the actions and motivations of global organizations are left to question the motivations and the new urgency and trustworthiness of the doomsday rhetoric. Just fifty years ago the United Nations warned that *“mankind had*

only ten years to stop the catastrophe.” And forty years ago the United Nations said: *“We have until the year 2000 to prevent the equivalent of a nuclear holocaust.”* While just fifteen years ago, the United Nations warned that *“..if climate change wasn’t stopped by 2012, it would be too late!”*

The world has not only failed to end, the world’s Co2 emissions are now 50% higher than they were twenty years ago!

After 26 previous summits, and trillions of dollars spent on the climate, the United Nations still does not have a working blueprint to lower the earth’s temperatures. For the 27th attempt, the self-proclaimed climate envoy, John Kerry said that what is needed is trillions of dollars more!

There is also support for hundreds of billions in loss and damage payments for poor nations. Basically, these are climate reparations. Joe Biden told the summit that the United States would become the world leader in fighting climate change. Protesters were constantly interrupting in protests and claiming that more radical action is necessary to *“save the planet.”* Climate activists such as Greta Thunberg denounced the climate summit as a scam and *“green washing”* which is when a company fakes its environmental commitment. Yet there were more corporate sponsors than at any previous summit with support by U.S. tech companies Microsoft, Google, IBM, Meta, Coca Cola, Cisco, and over 400 others.

And Al Gore was there promoting his *“Climate Trace”* initiative to *“track, fine, and shut down”* offenders of climate *“protocols”* around the world. It is a CO2 tracker that is explicitly intended to help the UN enforce *“climate treaties”* and its not a significant leap to presume that corporate monitoring will be closely followed by *“personal climate monitoring”* and Google is one of Climate Traces six funding organizations.

Additionally during the Climate Summit, clergyman held what was called *“The World’s First Multi-faith Climate Repentance Ceremony”* to seek forgiveness for climate sins. Activists went up to Mount Sinai and smashed what were supposed to be *“the climate 10 commandments.”*

Globalist 10 Commandments for Climate

1. We are stewards of this world
2. Creation manifests divinity
3. Everything in life is interconnected
4. Do no harm
5. Look after tomorrow
6. Rise above ego for our world
7. Change our inner climate
8. Repent and return
9. Every action matters
10. Use mind, open heart

The leaders of business, banking, religion and nations gathered in Egypt near Mount Sinai, at the specific location understood to be the biblical site where Moses received the ten commandments from God. While this location may not be the the actual site where God delivered the commandments to Moses, what is important is not the actual location per se but what the understood location signifies. The location represents a place where God met with Israel and gave His instructions to them for righteous living. Thus, the gatherings and acts that took place at this location near Mount Sinai are intentionally seeking to legitimize the environmental agenda of the New World Order.

The Great Reset utilizes environmental issues to usher in a dystopic Huxleyan New World Order to subjugate and enslave humanity, was pushed further at COP27. As part of the COP27 climate conference, faith leaders gathered to pray as they endeavour to push the Great Reset on their followers.

The faith hirelings gathered and repented for how humanity has treated the earth, pledging their collective support to the climate ten commandments and zero carbon. The faith leaders seem all to eager to push forward a zero carbon program and conveniently avoid its connection to depopulation and enslavement of humanity.

Aside from resembling the level of scholarship of a junior science project from an indoctrinated grade school student, the individual “*commands*” are intended to create sorrow, remorse, unreasonable worry and concern, and a religious devotion to rule following directly tied to “*complying with*” or “*adhering to*” the increasingly mandated climate religion.

It is worth making an important contrast between the climate religion and Ten Commandments of the globalist client cult with the actual Ten Commandments and purpose of the “law” delivered by God to Moses.

The Ten Commandments are ten laws in the Bible that God gave to the nation of Israel shortly after the exodus from Egypt. The Ten Commandments are essentially a summary of the 613 commandments contained in the Old Testament Law. The first four commandments deal with our relationship with God. The last six commandments deal with our relationships with one another. The Ten Commandments are recorded in the Bible in [Exodus 20:1-17](#) and [Deuteronomy 5:6-21](#) and are as follows:

1) ***“You shall have no other gods before me.”*** This command is against worshiping any god other than the one true God. All other gods are false gods.

2) ***“You shall not make for yourself an idol in the form of anything in heaven above or on the earth beneath or in the waters below. You shall not bow down to them or worship them; for I, the LORD your God, am a jealous God, punishing the children for the sin of the fathers to the third and fourth generation of those who hate me, but showing love to a thousand generations of those who love me and keep my commandments.”*** This command is against making an idol, a visible representation of God. There is no image we can create that can accurately portray

God. To make an idol to represent God is to worship a false god.

3) ***“You shall not misuse the name of the LORD your God, for the LORD will not hold anyone guiltless who misuses His name.”*** This is a command against taking the name of the Lord in vain. We are not to treat God’s name lightly. We are to show reverence to God by only mentioning Him in respectful and honoring ways.

4) ***“Remember the Sabbath day by keeping it holy. Six days you shall labor and do all your work, but the seventh day is a Sabbath to the LORD your God. On it you shall not do any work, neither you, nor your son or daughter, nor your manservant or maidservant, nor your animals, nor the alien within your gates. For in six days the LORD made the heavens and the earth, the sea, and all that is in them, but he rested on the seventh day. Therefore the LORD blessed the Sabbath day and made it holy.”*** This is a command to set aside the Sabbath (Saturday, the last day of the week) as a day of rest dedicated to the Lord.

5) ***“Honor your father and your mother, so that you may live long in the land the LORD your God is giving you.”*** This is a command to always treat one’s parents with honor and respect.

6) ***“You shall not murder.”*** This is a command against the premeditated murder of another human being.

7) ***“You shall not commit adultery.”*** This is a command against having sexual relations with anyone other than one’s spouse.

8) ***“You shall not steal.”*** This is a command against taking anything that is not one’s own, without the permission of the person to whom it belongs.

9) ***“You shall not give false testimony against your neighbor.”*** This is a command prohibiting testifying against another person falsely. It is essentially a command against lying.

10) ***“You shall not covet your neighbor’s house. You shall not covet your neighbor’s wife, or his manservant or maidservant, his ox or donkey, or anything that belongs to your neighbor.”*** This is a command against desiring anything that is not one’s own. Coveting can lead to breaking one of the commandments listed above: murder, adultery, and theft. If it is wrong to do something, it is wrong to desire to do that same something.

Many people mistakenly look at the Ten Commandments as a set of rules that, if followed, will guarantee entrance into heaven after death. In contrast, the purpose of the Ten Commandments is to force people to realize that they cannot perfectly obey the Law ([Romans 7:7-11](#)), and are therefore in need of God’s mercy and grace.

Despite the claims of the rich young ruler in [Matthew 19:16](#), no one can perfectly obey the Ten Commandments ([Ecclesiastes 7:20](#)). The Ten Commandments demonstrate that we have all sinned ([Romans 3:23](#)) and are therefore in need of God's mercy and grace, available only through faith in Jesus Christ.

By contrast the climate summit commandments are a collection of manmade rules intended to manage and control and manipulate individuals by an increasingly authoritative, tyrannical world government.

The climate agenda is not about saving the planet but rather enslaving humanity within an ecological dictatorship. Plans are being formed and put into place that will, "for the planet's good", take away people's freedom of movement. Leaders at G20 recently signed an agreement pledging support for an ID passport. Such a move will enable the total surveillance of humanity globally. Furthermore, when synced with the soon-coming digital monetary system, people will be monitored and restricted from buying "*unethical products*" or from entering "restricted zones".

We are currently living in a "*pre-Christian world*" where people worship the creation instead of worshiping the Creator of the world. It is similar to the time prior to the arrival of Jesus where there was a pre-Christian worldview.

As you look back in history, people would worship creation, and then by the grace of God, the Gospel of Jesus Christ would be preached in these different lands and people would be drawn to and trust Christ, revival would break out, and influencing and changing those societies. And as those societies were changed and radically transformed, reflecting more of a Judeo-Christian worldview, the next generation would be moving toward a post-Christian worldview and eventually we move back into a pre-Christian worldview where people worship the creation and not the Creator God.

This is what we are seeing in our day where people kill the children through abortion, mutilate the young through what is called gender-affirming care, affirm, fuel, and reaffirm sexual perversion, and fully embrace the pagan practice of worshiping the creation. The climate change cult is demanding our worship.

Is the Science Real?

All of this really demands that there be answers to several questions:

How scientific is the climate change science?

Is man really destroying the world?

Is the ocean really rising?

Are these Ten Commandments a blasphemous act?

Is there really a "third covenant" between man and earth?

Is this the repentance that God calls us to?

Was everyone at the COP27 eating bugs and living and transacting as they demand that other around the world do?

Never! Everyone in attendance and especially the loudest voices at these climate change events “do not practice what they preach.”

They show up in hundreds of private jets

They feast on caviar and steak and Champaign

They stay at incredibly fancy hotels (thousands per night)

Meanwhile they lecture us that we need to ride our bicycles and eat bugs!

But is this really tied to science? Consider the interview with MIT climate scientist Dr. Richard Lindzen who bravely rips ‘the imaginary climate crisis’ – stating that ‘The whole narrative is pretty absurd.’

In his presentation: *“The Absurdity of the Conventional Global Warming Narrative.”* Dr. Lindzen remarks: *“I have intentionally chosen this title because most of us have gone along with the popular narrative without considering whether it is a significant factor in actual climate change. It turns out that it isn’t. As usual, capturing the narrative is the goal in propaganda. It certainly has succeeded when it comes to climate alarm.”*

When considering the actual science of “*climate change*” almost all current discussions of global warming are based on an overly simplified planetary view of the earth, and this is largely because of its simplicity. Briefly, one begins with an atmosphere that has a preindustrial value for CO₂, and asks how much warming will be associated with a doubling of CO₂? It turns out that the contribution is about 3.5 Watts per square meter which leads to warming of about 1C. This result is not considered controversial. Normally, one might consider 2% to be small since common fluctuations in upper level cirrus, low level clouds, ocean currents, etc. routinely produce this level of variability in the radiative budget, and the climate system is amply capable of opposing such forcing. The problem is that our gross inadequacy of understanding of clouds and other factors is openly acknowledged by the Intergovernmental Panel on Climate Change (IPCC), and its concerns over global warming.

Egregious Assumptions

Assumptions by the IPCC presume that variations in water vapor, clouds, etc. act to amplify rather than oppose the impact of CO₂; i.e., they are assumed to be positive rather than negative feedbacks.

It is on the egregiousness of these assumptions rather than on the greenhouse effect itself that most skeptics (including myself) have focused.

The graphs are worth including here to show how small the changes are which have been observed. It may be worth repeating that the Working Group 1 report (ie the part dealing with the science) of the UN’s Intergovernmental Panel on Climate Change never suggests that 0.5C will be catastrophic. Indeed it doesn’t suggest catastrophes at all.

The changes are small as can be observed in the previous illustration. Even in this example where the variations in “average temperature anomalies” are plotted in yellow

points, it is the “*orange boundaries*” that attempt to show an upward trend over 120 years but the change is minuscule.

The BEST Seasonal Global Temperature Anomalies chart above breaks a cardinal rule of data science and that is contracting an axis (typically the vertical axis filling the screen from upper to lower with the range of data, and thereby attempting to “excite” the reader into perceiving that the change is large and dramatic over the range shown on the horizontal (time) axis.

This is the technique being deployed in this 120-year range where the temperature change is still in the neighborhood of about a single degree centigrade. Until the 1970’s, the meteorological literature on climate didn’t emphasize, or even mention, the greenhouse effect. Climatology, Haurwitz and Austin, 1944., Climate, Pfeffer, 1955, Atmosphere, Weather and Climate, Barry and Chorley, 1970. Instead, they were concerned with understanding the numerous different climate regimes as illustrated in the diagram below that shows a world map of the climate classifications for 1901 to 2010.

It is absurd to assume that the complex three-dimensional climate is defined by the small difference of large numbers that is the average temperature anomaly, and that the controlling factor is the small contribution of CO₂. The earth’s climate has, indeed, undergone major variations, but these variations offer no evidence of a causal role for CO₂. For the glaciation cycles, CO₂ clearly follows rather than precedes ‘temperature.’ For earlier variations, there is no suggestion of any correlation at all.

It is total pseudoscience that man’s insignificant emission of CO₂ is controlling the planet and causing temperature increases or decreases is preposterous and an example can give some perspective:

Human emissions of CO₂ make up a fraction of one percent of all the greenhouse gasses that are in the atmosphere naturally, and nobody will disagree with that including the most alarmist climate scientists. And yet, one volcanic eruption could dwarf all of humanities CO₂ emissions throughout all of human history combined.

So from a scientific perspective it is totally ridiculous that this is “*pollution*” and this is the “gas” that we “*exhale*” and we exhale about two pounds of this per day. And the real truth is that the earth is “*starving*” for more CO₂. Plants were designed to live in an atmosphere with far more CO₂ than we have now. And there have been many times in earth’s history where CO₂ levels have been for or five times what they are now with no problems whatsoever with temperatures on the planet.

The Green agenda, will exert itself with stronger than previously experienced covid-19 measures, and this will further enslave humanity. The cost-of-living crisis is further intensifying and this is resulting in many people losing hope and their desire to live. Additionally, as economies collapse, and global wars expand, there will also be increasing famine and pestilence. It is during this time of trouble that humanity will be

presented with what they believe to be a global saviour who will usher in the ultimate Great Reset.
