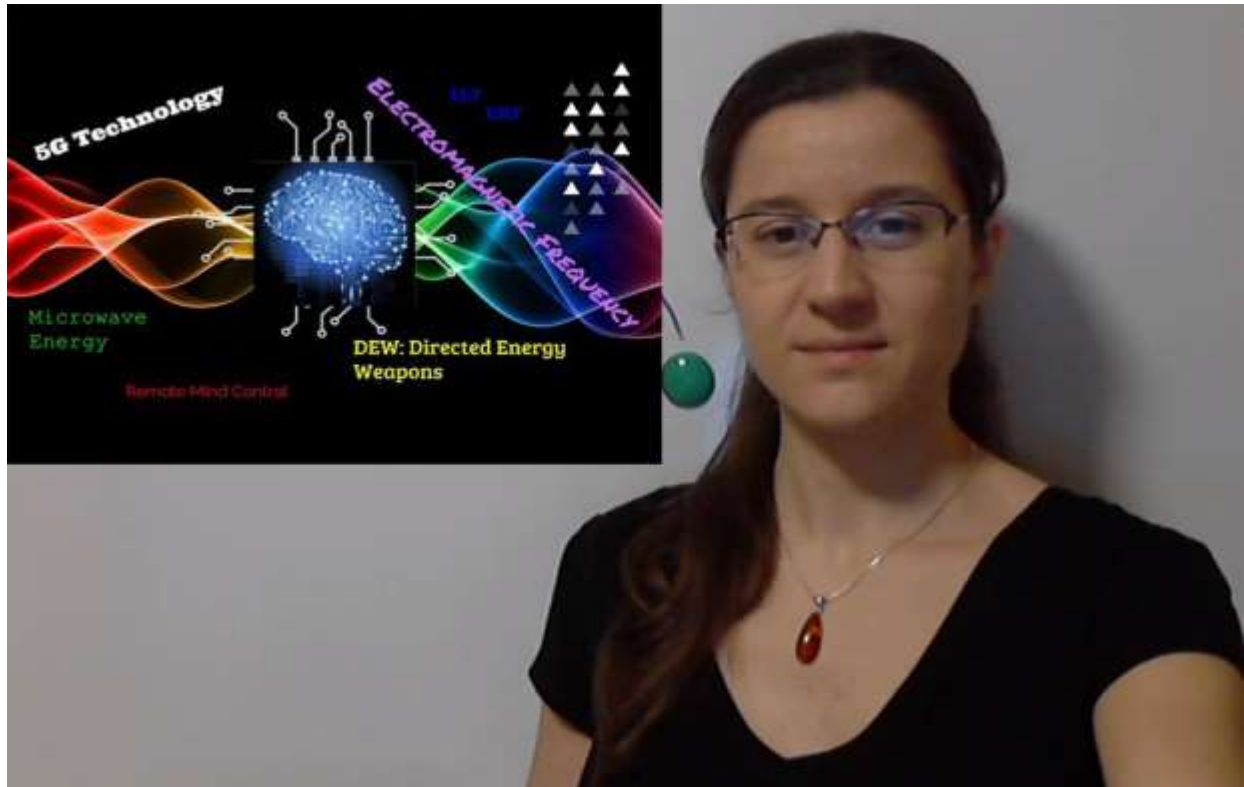


# The Really Silent Weapon For the Quiet War

Was 5G developed as a *Directed Energy Weapon* system?

5G Is the Ultimate Directed Energy Weapon System, says Particle Physicist Dr. Katherine Horton argues, and based upon her research and personal experiences, that the 5G network is intended as a Directed Energy Weapon system that aligns with the goals of the global elite to enslave humanity.

Dr. Katherine Horton sees the current rollout of the 5G network in a way that is different from mainstream perception. And for very good reasons!

To begin with, she is a particle physicist with a PhD from prestigious Oxford University. She worked as a high energy physicist on the particle collider at the German Electronsynchrotron DESY in Hamburg, Germany, and on the infamous Large Hadron Collider at CERN in Geneva, Switzerland.

At Oxford, Dr. Horton worked as a research fellow at St John's College, a position that allowed her to expand her research from particle physics into medical physics and **the physics of complex human systems**. As part of the latter, she conducted systems

analysis research of the English legal system, economies, the financial system, currencies, as well as white collar crime and organized crime.

In other words, she has the credentials to be public enemy number one to the global elite that are trying to deceptively use technology as a key cog in their plan to enslave humanity under a totalitarian world government.

### **A Targeted Individual**

During her childhood in Romania, Dr. Horton alleges that she and her family experienced intimidation and terrorism because they were highly educated and refused to take part in the snitching and informant criminality being promoted by mob networks there.

Dr. Horton says that stalking and other such activities ramped up in November 2011, as she was attending a High Court case in London as part of her systems analysis research into the English legal system. She says she was openly being stalked on her way home from court and started noticing a thug waiting for her outside her home every morning to follow her to the train station.

Attempts to face these forces head-on, through the courts and through activism, have led to a rise in these attacks upon her which include not only human intimidation but torture through Directed Energy Weapons. ### **Trying To Contextualize the 5G Network**

In the extensive interview below hosted by Alfred Lambremont Webre, Dr. Horton attempts to bring to bear her vast knowledge of the capabilities of energy weapons, and awakens us to the fact that these are the true modern weapons of warfare of today, not the ballistic weapons that we still see portrayed in movies and talked about in geopolitical conflicts.

She also employs her knowledge and personal experience of the 'Targeted Individuals' phenomena, as well as her run-ins with the shadow government and their military and intelligence tentacles to create a broad context for what the 5G network really is:

The average person struggles so much understanding what all this is about and that's what they [Global Elite] are banking on. So they are banking on the fact that, for example, there is a very simple con hidden in this marketing ploy that is 5G. For example when they brought up 3G and 4G, everybody assumes that 5G is just a better 3 and 4G so what's all this fuss about? Is it just Luddites who are just, you know, they just, they are scared, and they are tree-huggers, and they just don't really enjoy watching happy kitten videos super-fast on their phone? But that's not what it is. So 5G is a fundamentally different system.

In my previous articles on 5G what I was aiming to do is to take all the people who are maybe even more overwhelmed than I am, you know, I want to pick them up where they're at, maybe, and then bring them up to speed and tell them everything I know, so by the end of the day they at least know what I think and what I know, so that they can make up their own mind what they think. And there are several discoveries I had, trying to research the subject, and I should say that my main focus is not even 5G or 6G. My main focus is emphasize that to have all the Directed Energy Weapons systems shut down, which includes also satellite weaponry, weaponry hidden in cars, weapons carried by gang stalkers in rucksacks, and all this sort of stuff and out of all that, 5G is, if you like, the state system. It encapsulates everything. It can do a bit of everything and it will be everywhere.

So your 5G system is like a gang stalker with a Directed Energy Weapon in his rucksack who shoots you in the face as you're walking behind him, you know, on the pavement for example. But it will not be a gang stalker; they can do away with those, if they just have these 5G antennas every 50 or 100 meters. So the 5G system will do everything that the current global weapons systems can do and, it can also, I strongly believe, it can also instantly kill. Ok?

So in other words, if you want to cut to the chase, Dr. Horton's view of the 5G system, and I'll show you why I think that's the case, the 5G system should be best imagined as the government, or **this shadowy group that has infested the government**, taking over every city on the planet and every village and even the smallest town and even then, you know, the forest, where you think there is nothing, and putting up hidden machine guns that follow you and your family pointing right at you and these are, you know, set sharp so that they can shoot you dead at the speed of light if somebody so wishes. Ok? So that is the best description of the 5G system that Katherine Horton is identifying.

### **A Complex System with Grisly Motives**

The above description and much of her explanation in her videos may strain credulity for many readers. It certainly challenges the mainstream worldview that our elected leaders are the flawed but ultimately legitimate authorities of our world, that wars and killing are conducted for justifiable reasons, that intelligence agencies protect us and will not try to harm us, or that we are not in some way victims of complex social engineering designed to turn us all into obedient slaves.

How clearly is the depopulation agenda coming into view? In the interview Dr. Horton points us to the website [deagel.com](http://deagel.com), a website that monitors the sale and distributions of military weapon technology all over the world. She shows us that plans for genocide are actually reflected in published estimates of depopulation within the next decade. As you can see from the page below, which can be directly accessed [here](#), the population of the United States is predicted to be 100 million by 2025, down from 327 million in 2017. Thousands of homes have been destroyed by DEW or Directed Energy Weapons in the past eight year, many captured on cell phones with the signature "laser" beam from the sky, exploding the "Smart" meters on the owner's homes.

The deagel.com page correlates with the Georgia Guide Stones, about reducing the world's population to 500-million, no small task by conventional terms. But with 5G it is achievable with modest cost and effort, not to mention the infrastructure that will be left behind for the CCP.

For Dr. Horton, this insidious decline in the American population over the next few years is likely contingent upon a successful implementation of the 5G network in the US. But this does not mean her overall message is one of doom and gloom, meant to evoke fear and hopelessness. Rather, as someone who has fought against this authority for the better part of her life, she believes that this rush to roll out 5G is a desperate attempt on the part of the global elite, the 'criminal cartel' as she calls it, to hold on to the power they have held since Biblical times:

*"I want to show what the 5G system really looks like in practice, then I want to show, you know, how the industry is actually gloating with it, they know that this is a weapon, they're gloating, they're jeering at us, and they're making fun of us and then I will show you what this weapon is planned to be used for and is already being used for right now.*

*So what I'm talking about is not just, oh, it's five years in the future, no, this system is killing people right now. And now, the only question is: the time lag between us 'realizing,' accumulating a critical mass, and shutting this system down, and arresting the criminals—whoever thought of putting this into the mangle, knowing full well [the consequences]—now that time delay pretty much maps out how many people are going to die, ok?"*

And this crime cartel...they know what they're doing, and their goal is to kill as many people as they possibly can, and that is because they realize that with the population growing and the Internet coming in, they cannot hold the same type of control on humanity - it is mathematically impossible to hold the same type of control on humanity - that they used to have, you know, back in the 1980s, even the 1990s and the control they had up until the 1990s was pretty much the control they had going back to Biblical times, and Babylonian times and before.

Dr. Horton reviews some of the presentations that the technical companies have put into the public domain about 5G and shows many instances where these companies seem to be mocking us at our expense, putting in plain sight, with thinly-veiled images and symbols in their drawings, their plans to roll out a weapons system that can target any individual they choose.

It is perhaps this hubris of the ruling class that will be the main cause of their downfall, as they are just helping to accelerate human awakening. For Dr. Horton, the most important thing is that those who receive her message spread it far and wide, because we are actually the ones who will determine how long the time window is before we reach a critical mass and are able to stop the operations of this criminal cartel altogether. From her own personal experience of being a Targeted Individual, her collaborations with other victims, and her research, Dr. Horton truly believes that the more quickly we awaken to these truths and take our power back, the more quickly we end the needless suffering and killing of innocent people.

### **The Takeaway**

While some things are uncertain in these times, there can be no doubt that as a collective, humanity is beginning to awaken to what has actually been going in the world. Zbigniew Brzezinski noted this in 2008, and it was a sage warning to his global elite partners:

*“For the first time in human history almost all of humanity is politically activated, politically conscious and politically interactive. There are only a few pockets of humanity left in the remotest corners of the world that are not politically alert and engaged with the political turmoil and stirrings that are so widespread today around the world. The resulting global political activism is generating a surge in the quest for personal dignity, cultural respect and economic opportunity in a world painfully scarred by memories of centuries-long alien colonial or imperial domination.”* ([source](#))

The frantic attempts to roll out 5G networks across the globe during the Corona virus release may come to backfire on the global elite. I say *may*, since the involvement of awakened citizens around the world is not guaranteed. The only way that a critical mass of people powerful enough to change humanity's trajectory can be reached will be if those of us who are in a position to do so make the effort to speak and act in ways that raise the awareness of others to the agenda and dangers of 5G.

In the roll out of the telecoms it has been revealed that the public consumer is not going to be benefiting from the so-called 5G download of their favorite movies, or global spectrum convenience of the cruise industry passengers. Actually, we find that it may be another five years before the consumer is supposed to benefit from the 5G rollout. This information begs a huge question, Why was installation of infrastructure considered “essential” business when so much of the United States was locked down and considered not to be essential?

When I discovered this fact, three months after we began to receive AT&T, DISH Network, as well as two other networks, promotional advertisement for their superfast Internet, I began to be suspicious of something else in the mix. I live in a rural county and wondered why the telecoms would promote something that is not going to become available for another 3 or 4 more years. I called the AT&T sales office in Louisville, and was informed it would be at least 2-3 years before it became available in my area.

I have viewed many of Dr. Horton’s videos and Dr. Katherine Horton is an Oxford-educated particle physicist and systems analyst with a Master of Physics (1st class) and doctorate in particle physics, both from the University of Oxford.

At Oxford, Dr. Horton worked as a research fellow at St John’s College, a position that allowed her to expand her research from particle physics into medical physics and the physics of complex human systems. As part of the latter, she conducted systems analysis research of the English legal system, economies, the financial system, currencies, as well as white collar crime and organized crime. Dr. Horton much like Dr. Martin Pall, are well qualified to discuss matters of Magnetic Biology and the effects that 5G has on the human body at all spectrums of the electrical signal.

Dr. Horton’s first experience of Secret Services and their boundless criminality was in Communist Romania, where she was born to Hungarian-German parents. Growing up as a young child, she experienced the non-stop terrorism of her family by the Romanian Secret Services Securitate, an organization known for its brutality and uneducated idiocy. Dr. Horton’s family were a prime target of the Secret Service thugs as they were highly educated and refused to take part in the snitching and informant criminality that was used by the mob networks of the Secret Services to take over the society in Romania.

After fleeing Communist Romania with her parents, Dr. Horton grew up in Germany where she excelled at school, skipping year 9 on merit and coming top of her year in the German Abitur. Based on her school results and high aptitude for maths and physics, Dr. Horton was accepted for a place at the University of Oxford where she completed her undergraduate and doctorate before becoming a research fellow, as mentioned above.

It was during her first week as an undergraduate at Oxford, that Dr. Horton witnessed the very same tactics used on her that the Securitate had used on her family during Communist times. A group of older men began to stalk her to lectures in the morning

and were waiting for her at various points on the way upon her return to the College. They repeatedly took photographs of her and made their stalking and harassment as overt as possible.

At the time, Dr. Horton ignored the spectacle as life in a foreign country and keeping up with studies at an elite university was overwhelming enough. The stalking and harassment by older men continued intermittently throughout her undergraduate degree, but it wasn't until a decade later that it exploded into a high-intensity terror campaign by British Secret Services.

In November 2011, as Dr. Horton was attending a High Court case in London as part of her systems analysis research into the English legal system, MI5 openly stalked her home from court and placed a thug to wait for her outside her home every morning to follow her to the train station. This overt Secret Service terror campaign, that began with MI5 in 2011 has not stopped to this day and has followed Dr. Horton abroad to all European countries through the terror networks of MI6. So at the time of writing, Dr. Horton has been stalked and harassed by MI5 and MI6 for almost two decades.

What began as overt surveillance became intrusive harassment, overt stalking, physical mutilation and sex trafficking by a group of British men mostly in their 50-70s after the end of the court case. Eventually, it morphed into open, rampant criminality by people connected to the Secret Services and the police. Dr. Horton suffered a Stasi-style break-in, sex stalking by those perverts in Oxford and wherever she went, regular street theatre and harassment by strangers. One of the barristers from the court case, Jonathan Sumption, began to stalk her as part of this criminal network and took prominent part in her abuse.

During this period he also became a judge of the UK Supreme Court and acquired the courtesy title of Lord Sumption. Due to the timing of his promotion, which saw him leapfrog the entire English judiciary by becoming a Supreme Court Judge without ever having served as a judge in England, and the sexual nature of the abuse that Dr. Horton suffered and continues to suffer, it appears likely that Lord Sumption's abuse of her is for the accumulation of a control file that a lot of establishment figures need to have to be promoted up in the cartel world of the ruling establishment.

The violations of the members of this criminal network grew ever more sadistic and brutal with time. They followed her across Europe, subverted her medical care and eventually escalated into systematic physical mutilation of her with Directed Energy Weapons. These assaults that started overtly in 2011 have not abated to this day.

After leaving academia and returning to Germany, where she had grown up, Dr. Horton set out to launch a company. Her endeavor was sabotaged and destroyed by MI6 and German Intel BND with the methods of Zersetzung, which had been developed by the East German Stasi. The criminals from BND also began to openly assault Dr. Horton physically, including launching an attack from a helicopter on her as she was standing

on her rooftop terrace in Munich-Solln and a similar attack on her in bed at night that was launched from a neighbor working for BND.

After having to abort the company due to the incessant Secret Service terror, Dr. Horton worked briefly for an asset management firm in Switzerland, a job she obtained by predicting the unprecedented money printing of the European Central Bank. Dr. Horton was forced to leave the job because she began to fear for her life when MI6 and BND increased their intimidation campaign using collaborating criminals from Swiss Intel NDB.

The subsequent attempt to launch a consultancy in Switzerland was brutally squashed when Swiss Intel NDB began to machine-gun Dr. Horton with Directed Energy Weapons around the clock in January 2016.

With the explosion of the Secret Service terror campaigns into non-stop mutilation with Directed Energy Weapons, life became impossible for Dr. Horton as she found herself assaulted 24/7 in a torture program that had her death as its goal. The continuous assaults during the day exploded at night when she was lying defenseless in bed.

She made several reports to the local police in Unterengstringen (Zurich) and to the German Federal Police Agency, Bundeskriminalamt. However, it became clear that they were involved in the criminality as they refused to take action. So Dr. Horton was forced to take up the investigation herself full time.

After extensive online research and after flying to London to attend the High Court case of Philip Kerr v MI5 and speaking to the business man Philip Kerr and his partner after the hearing, Dr. Horton discovered that her case and that of Philip Kerr were almost identical.

Dr. Horton realized that during her time at the University of Oxford, she had become the victim of criminal operations by MI5, which used her in non-consensual human experimentation and covert sex trafficking. Upon this realization, she took MI6 (called SIS these days), MI5 and GCHQ to court but was thwarted by the defendants who sabotaged her case in every possible way, including a death threat on the way to court in London that MI6 executed with an assassination attempt 3 days later in Switzerland. In the end, the court case was "terminated" and attempts were made to make it disappear off the record.

After this experience, Dr. Horton tried to withdraw but the attacks only escalated further until it became clear that they would not stop until the Secret Services would have succeeded in murdering Dr. Horton.

In an attempt to understand what was happening, Dr. Horton travelled to Manchester to attend the court case of Dr. Stephen Frost v MoD at the end of October 2016. There, Dr. Horton was brutally assaulted in the hotel room with Directed Energy Weapons. Upon reporting the assault to police the Greater Manchester Police lied to Dr. Horton



and sent her back to her hotel room promising to send a police officer to the scene. There, MI5 waited until they expected her to have gone to bed and then staged criminal intimidation theatre by faking the call out of a “mental health ambulance” (no such thing existence in the UK) and pretended to try to section Dr. Horton.

After this experience, Dr. Horton went public on the Richie Allen Show about the Directed Energy Weapon assaults on her by the Secret Services. Through this publicity, she was put into contact with several other women, including Karen Melton-Stewart, who had worked almost 30 years for the NSA and had become a whistleblower about internal corruption. Through the exchange it became clear that the Secret Service criminality was identical between the U.S. and Europe and there were indications that it was founded on a global genocide programs run by the Secret Services worldwide for “population control” and “sustainability”.

In May 2017, through the work of the Joint Investigation Team, Dr. Horton discovered that she had been covertly implanted with military bio-technology and neurotechnology and used as a torture and mutilation slave for almost two decades.

In spring 2016, when the physical attacks with Directed Energy Weapons on her became insane, Dr. Horton fled to London and was desperately seeking an emergency injunction from the London High Court against British Intelligence. Her court case:

Dr. Katherine Horton vs. SIS, MI5, GCHQ [2016] EWHC 2095 (QB)

was violently sabotaged by British Secret Services who committed every imaginable criminal act to stop her litigation and disappear it off the record:

- The court case was not listed on the day as it should have been.
- The High Court did not give the case a case number. (This is why the first two transcripts do not appear with a case number).
- The transcripts of the hearing were falsified by British Intel to remove questions by the judge and Dr. Horton’s answer.
- British Intel’s barrister openly lied to the court.
- Dr. Horton received a death threat on the way to the first hearing and survived an assassination attempt 3 days later. The number 3 (and the number 7) is often used as cartel-signaling by Intel.
- At the 3rd hearing Judge Holgate terminated the case as “frivolous or vexatious” and used the pretext that it was not even a case to start with because, allegedly, it didn’t contain a claim. The reason for the lack of claim was that none of Dr. Horton’s court documents had the title “Particulars of Claim”. This judgement went against the previous two High Court judges, Justice Spencer and Justice Edis, who did not have a problem recognizing the content of the claim. It also went against the rule that when litigants are forced to represent themselves more attention has to be given to content than form by the judge. This rule was confirmed to Dr. Horton by an internationally known war crimes judge.

In retaliation just for daring to approach the High Court, Dr. Horton received a death threat from MI6 who were reading her email live and listening to all her phone conversations and knew that she was travelling to London to go to the High Court. An MI6 agent approached her in gas-lighting theatre on her way from Heathrow airport to her hotel after midnight, and after involving her in small talk said out of the blue “there is crime in every country, in some it is just well hidden”; he repeated that sentence and after a meaningful pause he asked “Did they kill Diana?”, making a reference to Princess Diana and her death that pointed to MI6 as her killers. The implication was that if MI6 was willing to murder a Princess, they would just as easily murder Dr. Horton.

Straight after the first hearing of her court litigation, MI6 stalked Dr. Horton demonstratively all the way back to her hotel. There, the attackers waited until she came out of her shower wrapped in a towel before assaulting her with intense machine-gunning from Directed Energy Weapons into the back of her head so that she collapsed from pain. The emphasis on nudity and humiliation in Secret Service attacks is a recurring theme in the victim cases and appears to result from mental illness, sexual depravity and sadistic psychopathy that is rampant in Western Secret Services and the military. The attackers repeated the attack a second time when Dr. Horton’s husband arrived back at the hotel as she stood up to tell him what had happened. She collapsed again in pain in front of her husband from the agonizingly painful machine-gunning.

Three days later, Dr. Horton and her husband survived an assassination attempt on the Swiss motorway as Dr. Horton, the driver of the car, was machine-gunned in the head as from a car in front as they were travelling at 100km/h through a tunnel. Had Dr. Horton lost consciousness during the attack as intended, she and her husband would have crashed in the tunnel and likely died in an accident reminiscent of the death of Princess Diana.

On the day of the attack, a life-size black plastic goat was placed by Ms. Nitschke a neighbor of Dr. Horton on a flat roof of a neighboring property in a prominent place that could be seen from almost every room of Dr. Horton’s home. Comparison with other victim cases identifies this as a Satanic symbol of death that the Secret Services like to harass their victims with. Subsequently, the mutilation of Dr. Horton with Directed Energy Weapons became even more psychopathic.

As a result of the refusal by the police and the courts to assist, Dr. Horton was forced to investigate these rampant crimes herself. She came across the testimony of hundreds of victims online who were begging for help like her on YouTube, Facebook on Twitter. All of them were being mutilated like she was and had also been maliciously treated by the authorities. It was at that point that Dr. Horton realized that the police, judiciary and secret services are all knowingly complicit in a global Nazi extermination program that is using Directed Energy Weapons to place victims into invisible concentration camps and commit silent genocide.

Dr. Horton gradually realized that she, as well as her family and friends, were being used as target practice for modern military weapons and subjects of human

experimentation with non-consensual body implants and neurotechnology. The crimes against her and her family and friends were committed with egregious impunity because all police services, Intelligence Agencies and courts were in Deep Capture by a global criminal network that owned the Secret Services and had infiltrated every area of public life.

Dr. Horton as well as her family members and those of her friends experienced brutal assaults and survived assassination attempts. Dr. Horton was permanently mutilated and repeated brutal premeditated assaults and had to begin fighting for her life.

Dr. Horton also discovered that she had been non-consensually implanted without her knowledge with microchips. The radio-frequency emissions from these illegal chip implants that form an interconnected system, called a Body Area Network in the scientific literature, were measured by experts in a professional Faraday cage at a Belgian university.

She also discovered that members of her family and friends had equally been implanted.

Dr. Horton has begged for help from the human rights charities, Swiss & UK & German police, Swiss criminal police, Swiss military police, the German Federal Crime Squad BKA, the Swiss & UK Attorney Generals, the UK Investigatory Powers Tribunal, the Heads of MI5 & BND and the German ambassador to Switzerland. All committed dereliction of duty by refusing to help. The police even took active steps to intimidate her.

As a result of having been let down by all law enforcement agencies in 3 countries and having come across so many victim reports that it became clear that there were larger genocide programs in action in Europe and the U.S., Dr. Horton linked up with 4 other high-profile women who were victim of these attacks and founded the Joint Investigation Team US-Europe looking into Directed Energy Weapons, military neuro/biotechnology and systemic corruption.

The Joint Investigation Team (JIT) publishes a weekly public interest broadcast where they report about the ongoing investigation and the crimes committed by the Secret Services and the military, called the Techno Crime Fighters' Forum which is broadcast Thursday's at 11am-1pm ET / 4-6pm UK time / 5-7pm CET.

Dr. Horton also publishes a German video series with her JIT colleague Melanie Vritschan called Techno-Kriminalermittler

Since 2011, Dr. Horton has been stalked and harassed continuously. Her private life has been under intrusive and overt surveillance and interference. All her communications (voice, phone, email etc.) have been intercepted and sometimes overtly acted upon by agents. Furthermore:

- Her home was broken into countless times.
- Her computers were hacked.
- Her website was sabotaged and her email was service taken offline.
- Her private sex life was commented on by strangers in the street.
- Two of her business endeavors was destroyed.
- Her family and friends were attacked, some near-lethally.
- Her medical care was infiltrated and sabotaged.
- Her blood sample was stolen.
- Her emergency medication was swapped for an unknown tablet.
- There were repeated attempts to break up her marriage.
- Her hip and knee were permanently damaged in physical attacks.
- She was sexually denigrated and humiliated repeatedly.
- She received several death threats.
- She survived several assassination attempts.
- Since January 2016, she is being mutilated with Directed Energy Weapons 24/7.
- She is being tortured non-stop with the non-consensual body implants and neurotechnology that was illegally implanted in her.
- She is being raped several times daily by remote-control with non-consensual chips that were illegally implanted in her genitals.

What on Earth are Directed Energy Weapons?

Microwave emitters, or more generally, electromagnetic weapons or Directed Energy Weapons are a new type of assault and murder weapon currently being manufactured in very large numbers (and very cheaply) by arms companies around the world, for example Diehl, Rheinmetall, Aaronia and Siemens (yes!). They are also known as directed energy weapons, scalar weapons, no-touch torture devices and, euphemistically, non-lethal weapons (ha!).

The nasty thing about them is that they penetrate the walls of a home. That is because microwaves pass through concrete, brick and wood effortlessly (like the beam from a laser-pointer passes through the glass walls of a conservatory). However, they get absorbed in the human body, where they cause pain and incredible damage. Microwaves damage cells, organs, cause tumors and cancer. And they can kill (think of a sausage in a microwave oven).

By this means, it is possible to assault a person inside his home from the outside (from even large distances!), cause cancer, organ damage, brain damage, a heart attack and death without leaving a visible trace of the assault. These weapons thus allow people to commit the perfect crime – on the cheap!

Telecom companies did not take military technology and adapt it to cell towers. Both technologies rely on the same radio-frequency spectrum, but they were developed separately and concurrently. The U.S. Air Force has been experimenting with millimeter wave since the 1980s, but it doesn't work with the telecom industry.

It's also important to note that the military's Active Denial System is specifically meant to be a non-lethal weapon. Under normal conditions, it's not meant to cause organ failure or any lasting damage (although, like most non-lethal weapons, the possibility for that is still present during misuse).

### **1. Long Range Acoustic Device (LRAD)**

Long range acoustic device is a non-lethal anti-piracy device which uses pain inducing sound beam to drive away the pirates. The sonic weapon produces high-pitched noise that is higher than the tolerance level of an average human being. LRAD has been used on a few cargo and cruise ships until now.

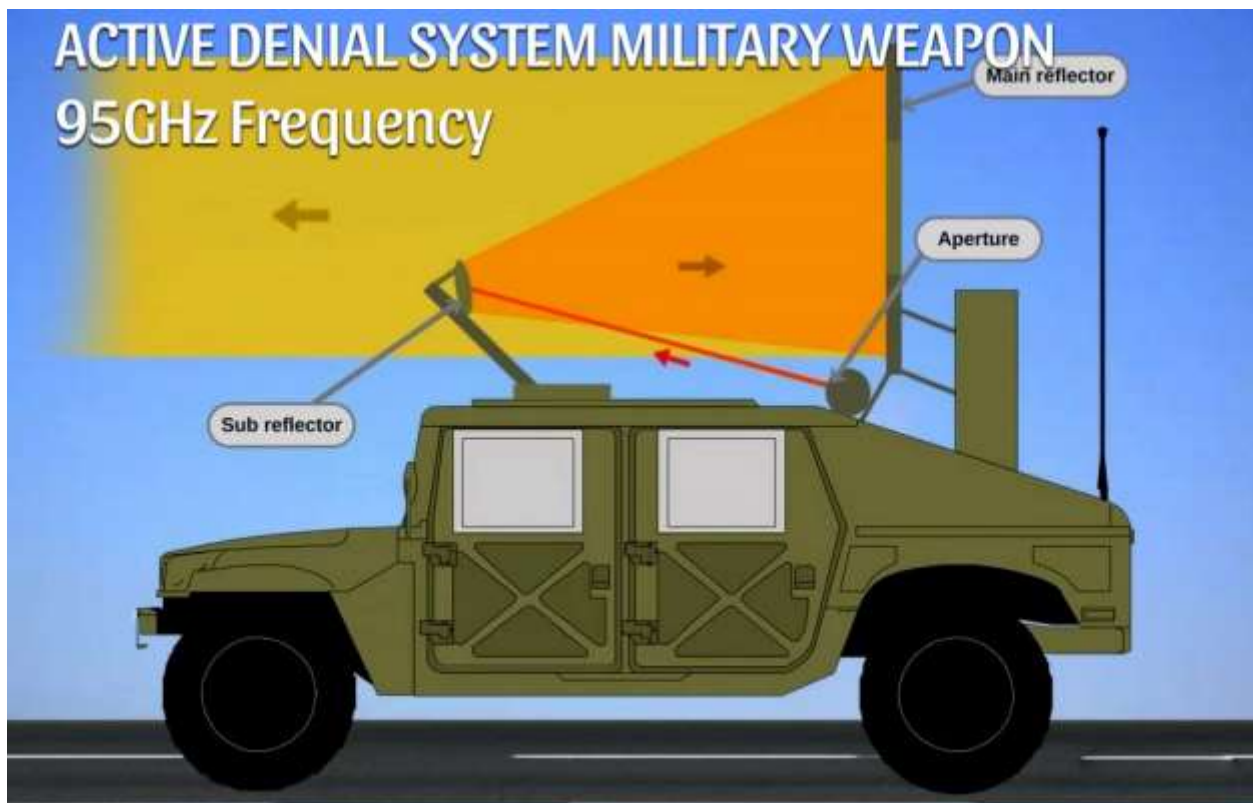
### **2. Anti-Piracy Laser Device**

The anti-piracy laser device uses a non-lethal laser beam to provide a visual warning to pirates and distract them temporarily. The laser device can be used during both day and night and can be easily operated by the ship's crew.

These are just two of the DEW or Directed Energy Weapons. Though they all will say these systems are non-lethal, they fail to tell you that the energy range can be modulated to levels not demonstrated for obvious reasons. The illustration on the next page indicates a military ADL system on a Humvee platform that can deliver 95 Gigahertz of 5G EMF wireless energy. 95 gigahertz can kill in seconds, and we know from studies conducted, that 5G at 60 Gigahertz consumes 98% of the oxygen in the lungs of a person, resulting in death virtually in an instant!

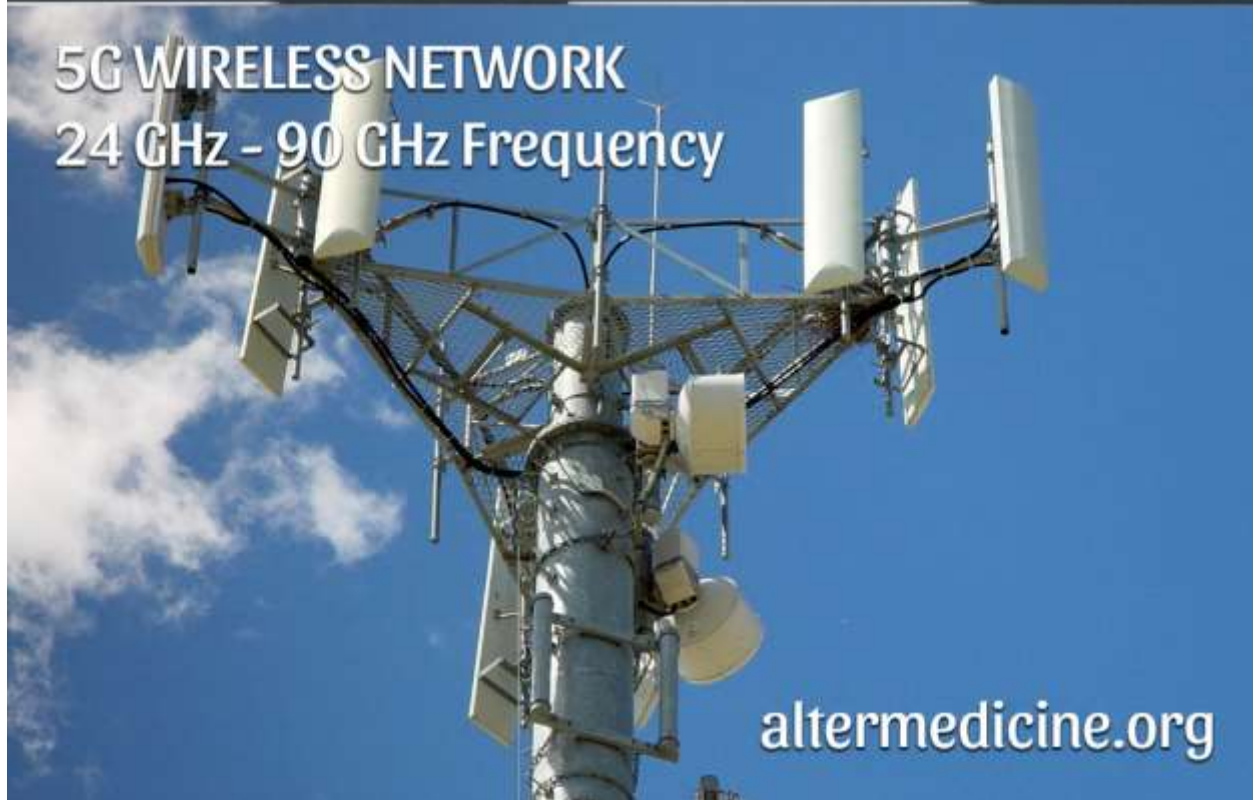

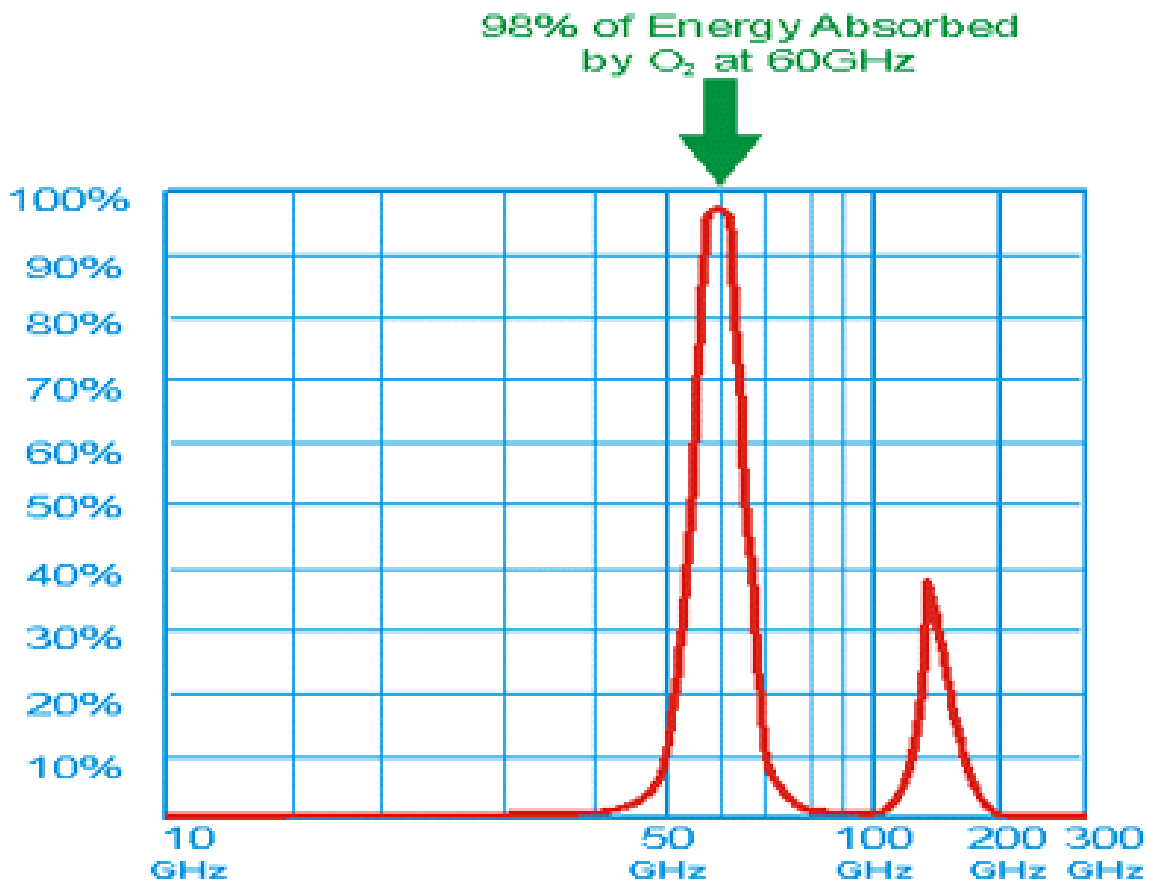
5G technologies that utilizes electromagnetic waves that are smaller than 4G technology is being built and installed despite not having been tested by the government or the industry for negative health effects.

Joe Imbriano warns that 5G technology will broadcast at 60 GHz, which is the absorption spectrum of oxygen molecules, which means it, can kill at a distance. At the molecular level, these frequencies affect the orbit of electrons, and that affects the ability of blood hemoglobin to bind with oxygen. If blood cannot hold oxygen, the result is death by suffocation. In short, 5G technology has the potential of being used as a weapon to quickly weaken, disable, or destroy individuals or populations.

### **Smart Meters**

#### **Day 1 (October 28th)**

**Day 15-17 (November 12th thru 14th)**

Day 15, cell towers in the “kill” zone 50 gigahertz. By Day 16, ALL LIFE in the “kill” zone is dead. Inside “kill” zone there are “pockets” of “safe” zones. Deep inside the “safe” zones, people are still alive. (People living on the fringes of the “safe” zone are dead.)

People who are alive deep inside the “safe” zones do not know they are now trapped inside the “safe” zone. Cell towers in the “safe” zones still 4G (~7 gigahertz).

Day 18-21 (**November 15th thru 18th**)

Day 18 “kill” zone towers cranked up to 60 gigahertz. Absolutely nothing will be able to survive in the “kill” zone now. People are still alive deep inside the “safe” zones. They believe they are safe. However, they begin to experience oxygen deprivation from the effect of the “kill” zone towers’ 60 gigahertz frequency. “Safe” zone towers are still at 4G (~7 gigahertz).

    3. choice, select, i.e. the best of its kind or class, excellence preeminent: applied to certain individual Christians

There is no need to get into word disputes here as to the meaning of the word "chosen". There are nuances that are clearly defined in the first category above. ***"For by grace are ye saved through faith; and that not of yourselves: it is the gift of God:" - (Ephesians 2:8).***

Many are invited or called via the general call of the gospel, which is presented through the Bible, churches, missionaries, and any type of evangelism. Few are chosen means that, of those **invited**, only the **elect (true followers of Jesus) will remain at the wedding feast in the kingdom of God.**

For many of you, this could soon be your last chance to discover your Lord and Saviour is Jesus Christ, He desires to know and mark you as one of His elect/chosen. The Bible provides a number of parables of the lost "theme".

The parables of The Lost Sheep, the Lost Coin, and the Lost Son portray God is concerned about the lost, and willing and anxious that they be returned to Him.

The three parables about the lost being found illustrate the kindness and mercy of God. When those who are lost are found, there is much rejoicing in all the household of God - (Luke 15:4-32).

I suspect that given there are only a few days left before the Rapture, this might be my final article. I hope you will accept the "Promises" of Jesus Christ and you will be there for the wedding and the wedding supper with the Lamb!
