

The Truth Will Really Set You Free!

But We Also Know, There Is No Free Lunch



Catherine Austin Fitts often states that *“Death is not the worst thing that can happen to you”*. She goes on to note that slavery is worse than death. Catherine was Assistant Secretary of Housing in the President Reagan administration, She is the publisher of the *‘Solari Report’*. A few months ago, Catherine was interviewed on a program, if my memory is correct, it was with internet journalist Gregg Hunter. It was Catherine Austin Fitts who first exposed the fact that \$21-trillion has been stolen from the U.S. government. I am going to share the transcript of her interview and there is much you can learn, provided that you are a teachable spirit!

“My response to living at war with agencies of the U.S. government for a time was to answer the questions of people who were sufficiently courageous and curious to solicit my opinion. Over many years, that response transformed into two businesses. One was The Solari Report, which continues to grow as a global intelligence network – we seek to help each other understand what is happening, to navigate and contribute to positive outcomes. The other was serving as an investment advisor to individuals and families through Solari Investment Advisory Services. After ten years, I converted that business to doing an ESG screen. What those who use it want—that is not otherwise readily

available in the retail market—is a screen that reflects knowledge of financial and political corruption. Tracking the metastasizing corruption, it's an art, not a science.

When you help a family with their finances, it is imperative to understand all their risk issues. Their financial success depends on successful mitigation of all risk – whether financial or non-financial – they encounter in their daily lives. All non-financial risks impact the allocation of family resources – attention, time, assets and money.

Many of my clients and their children had been devastated and drained by health care failures and corruption—and the most common catalyst for this devastation was vaccine death and injury. After their lengthy and horrendous experiences with the health care establishment, they would invariably ask, “If the corruption is this bad in medicine, food and health, what is going on in the financial world?” Chilled by the thought, they would search out a financial professional who was schooled in U.S. government and financial corruption. And they would find me.

The result of this flow of bright, educated people blessed with the resources to pay for my time was that, for ten years, I got quite an education about the disabilities and death inflicted on our children by what I now call “the great poisoning.” As a result, I had the opportunity to repeatedly price out the human damage to all concerned—not just the affected children but their parents, siblings and future generations—mapping the financial costs of vaccine injury again and again and again.

These cases were not as unusual as you might expect. Currently 54% of American children have one or more chronic diseases. Doctors that I trust assure me the number is much higher as many children and their families cannot afford the care and testing necessary to properly diagnose what ails them.

One of the mothers featured in VAXXED—a must-watch documentary for any awake citizen, as is its sequel VAXXED II:

The People's Truth—estimated that a heavily autistic child would cost present value \$5MM to raise and care for over a lifetime. When my clients who were grandparents insisted that they would not interfere with their children's vaccine choices because it was “none of their business,” I would say, “Really? Who has the \$5MM? You or your kids?”

When your kids need the \$5MM to raise their vaccine-injured child, are you going to refuse them? You are the banker, and it is your money that is at risk here, so it is your business. Do you want to spend that \$5MM on growing a strong family through the generations or on managing a disabled child who did not have to be disabled?” Often, that \$5MM in expenditures also translates into divorce, depression and lost opportunities for siblings.

My clients helped me find the best resources—books, documentaries, articles—on vaccines. You will find many of them linked or reviewed at The Solari Report, including in our Library.

Of all the questions that I had, the one that I spent the most time researching and thinking about was why. Why was the medical establishment intentionally poisoning generations of children? Many of the writers who researched and wrote about vaccine injury and death assumed it was a mistake—resulting from the orthodoxy of a medical establishment that could not face or deal with its mistakes and liabilities. That never made sense to me. Writings by Forrest Macready, Jon Rappoport, Dr. Suzanne Humphries and Arthur Firstenberg have helped me understand the role of vaccines in the con man trick of saving money for insurance companies and the legally liable.

Here is one example of how the trick may play out. A toxin creates a disease. The toxin might be pesticides or industrial pollution or wireless technology radiation. The toxin damages millions of people and their communities. Companies or their insurance provider may be liable for civil or criminal violations. A virus is blamed. A “cure” is found in a “vaccine.” The pesticide or other toxic exposure is halted just as the vaccine is introduced, and presto, the sickness goes away. The vaccine is declared a success, and the inventor is declared a hero. A potential financial catastrophe has been converted to a profit, including for investors and pension funds. As a portfolio strategist, I admit it has been a brilliant trick and likely has protected the insurance industry from the bankrupting losses it would experience if it had to fairly compensate the people and families destroyed.

Thanks to the work of Robert Kennedy and Mary Holland of Childrens Health Defense, I now understand the enormous profits generated by so-called “vaccines” subsequent to the passage of The National Childhood Vaccine Injury Act of 1986 and the creation of the National Vaccine Injury Compensation Program – a federal no-fault mechanism for compensating vaccine-related injuries or death by establishing a claim procedure involving the United States Court of Federal Claims and special masters.

Call a drug or biotech cocktail a “vaccine” and pharmaceutical and biotech companies are free from any liabilities – the taxpayer pays. Unfortunately, this system has become an open invitation to make billions from “injectibles” particularly where government regulations and laws can be used to create a market through mandates. Unfortunately, various schemes have developed for government agencies and legislators as well as corporate media to participate in the billions of profits – resulting in significant conflicts of interest.

The Public Readiness and Emergency Preparedness Act became law in 2005, adding to corporate freedoms from liability. The Act “is a controversial tort liability shield intended to protect vaccine manufacturers from financial risk in the event of a declared public health emergency. The act specifically affords to drug makers immunity from potential financial liability for clinical trials of avian influenza vaccine at the discretion of the Executive branch of government. PREPA strengthens and consolidates the

oversight of litigation against pharmaceutical companies under the purview of the secretary of Health and Human Services (~ Wikipedia.)”

Over time, this has evolved to the engineering of epidemics—the medical version of false flags. In theory, these can be “psyops” or events engineered with chemical warfare, bio-warfare, or wireless technology. If this sounds bizarre, dive into all the writings of the “Targeted Individuals.”

I learned about this first-hand when I was litigating with the Department of Justice and was experiencing significant physical harassment. I tried to hire several security firms; they would check my references and then decline the work, saying it was too dangerous. The last one took pity and warned me not to worry about electronic weaponry, letting me know that my main problem would be low-grade bio-warfare. This bio-warfare expert predicted that the opposing team would drill holes in the wall of my house and inject the “invisible enemy.” Sure enough, that is exactly what happened. I sold my house and left town. That journey began a long process of learning how poisoning and nonlethal weapons are used—whether to move people out of rent-controlled apartments, sicken the elderly to move them to more expensive government subsidized housing, gangstalk political or business targets, or weaken or kill litigants—and the list goes on. Poisoning turned out to be a much more common tactic in the game of political and economic warfare in America than I had previously understood.

After I finished my litigation, I spent several years detoxing from heavy metal toxicity – including of lead, arsenic, and aluminum. As I drove around America, I realized it was not just me. Americans increasingly looked like a people struggling with high loads of heavy metals toxicity. In the process of significantly decreasing my unusually high levels of heavy metals, I learned what a difference the toxic load had made to my outlook, my energy, and my ability to handle complex information.

This brings me to the question of what exactly a vaccine is and what exactly is in the concoctions being injected into people today as well as the witch’s brews currently under development.

In 2017, Italian researchers reviewed the ingredients of 44 types of so-called “vaccines.” They discovered heavy metal debris and biological contamination in every human vaccine they tested. The researchers stated,

“The quantity of foreign bodies detected and, in some cases, their unusual chemical compositions baffled us.” They then drew the obvious conclusion, namely, that because the micro- and nano-contaminants were “neither biocompatible nor biodegradable,” they were “bio-persistent” and could cause inflammatory effects right away—or later (see this).

Aborted fetal tissue, animal tissue, aluminum, mercury, genetically altered materials—and what else?

Whatever the ingredients of vaccines have been to date, nothing is more bizarre than the proposals of what might be included in them in the future.

Strategies—already well-funded and well on the way—include brain-machine interface nanotechnology, digital identity tracking devices, and technology with an expiration date that can be managed and turned off remotely. One report indicated that the Danish government and US Navy had been paying one tech company in Denmark to make an injectible chip that would be compatible with one of the leading cryptocurrencies.

I was recently reading Mary Holland's excellent 2012 review of U.S. vaccine court decisions ("Compulsory vaccination, the Constitution, and the hepatitis B mandate for infants and young children," Yale Journal of Health Policy, Law, and Ethics) and I froze and thought, "Why are we calling the injectibles that Bill Gates and his colleagues are promoting 'vaccines'? Are they really vaccines?"

*Most people are familiar with how Bill Gates made and kept his fortune. He acquired an operating system that was loaded into your computer. It was widely rumored that the U.S. intelligence agencies had a back door. The simultaneous and sudden explosion of computer viruses then made it necessary to regularly update your operating system, allowing Gates and his associates to regularly add whatever they wanted into your software. One of my more knowledgeable software developers once said to me in the 1990s—when Microsoft really took off—"Microsoft makes really sh***y software." But of course, the software was not really their business. Their business was accessing and aggregating all of your data. Surveillance capitalism was underway.*

The Department of Justice launched an antitrust case against Microsoft in 1998, just as the \$21 trillion started to disappear from the U.S. government—no doubt with the help of specially designed software and IT systems. During the settlement negotiations that permitted Gates to keep his fortune, he started the Gates Foundation and his new philanthropy career. I laughed the other day when my tweet of one of Robert Kennedy Jr.'s articles from Children's Health Defense—describing the gruesome technology Gates is hoping to roll out through "injectibles"—inspired a response: "Well, I guess he is finally fulfilling his side of his antitrust settlement."

If you look at what is being created and proposed in the way of injectibles, it looks to me like these technological developments are organized around several potential goals.

The first and most important goal is the replacement of the existing U.S. dollar currency system used by the general population with a digital transaction system that can be combined with digital identification and tracking. The goal is to end currencies as we know them and replace them with an embedded credit card system that can be integrated with various forms of control, potentially including mind control.

"De-dollarization" is threatening the dollar global reserve system. The M1 and M2 money supply have increased in the double digits over the last year as a result of a new round of quantitative easing by the Fed.

The reason we have not entered into hyper-inflation is because of the dramatic drop in money velocity occasioned by converting Covid-19 into an engineered shut down of significant economic activity and the bankruptcy of millions of small and medium sized businesses. The managers of the dollar system are under urgent pressure to use new technology to centralize economic flows and preserve their control of the financial system.

Just as Gates installed an operating system in our computers, now the vision is to install an operating system in our bodies and use “viruses” to mandate an initial installation followed by regular updates.

Now I appreciate why Gates and his colleagues want to call these technologies “vaccines.” If they can persuade the body politic that injectible credit cards or injectible surveillance trackers or injectable brain-machine interface nanotechnologies are “vaccines,” then they can enjoy the protection of a century or more of legal decisions and laws that support their efforts to mandate what they want to do.

As well, they can insist that U.S. taxpayers fund—through the National Vaccine Injury Compensation Program—the damages for which they would otherwise be liable as a result of their experiments – and violations of the Nuremberg Code and numerous civil and criminal laws – on the general population. The scheme is quite clever. Get the general population to go along with defining their new injectible high-tech concoctions as “vaccines” and they can slip them right into the vaccine pipeline. No need to worry about the disease and death that results from something this unnatural delivered quickly. The notion of an emergency along with contact tracing and freedom from liability can protect you from the millions of likely deaths from such human experimentation. Ideally, you can blame the deaths on a virus.

A colleague once told me how Webster’s Dictionary came about. Webster said that the way the evildoers would change the Constitution was not by amending it but by changing the definitions—a legal sneak attack.

I believe that Gates and the pharma and biotech industries are literally reaching to create a global control grid by installing digital interface components and hooking us up to Microsoft’s new \$10 billion JEDI cloud at the Department of Defense as well as Amazon’s multi-billion cloud contract for the CIA that is shared with all US intelligence agencies.

Why do you think President Trump had the military organizing to stockpile syringes for vaccines? It is likely because the military is installing the roaming operating system for integration into their cloud. Remember—the winner in the AI superpower race is the AI system with access to the most data. Accessing your body and my body on a 24/7 basis generates a lot of data. If the Chinese do it, the Americans will want to do it too. The role out of human “operating systems” may be one of the reasons why the competition of Huawei and 5G telecommunications has become so fractious. As Frank Clegg,

former President of Microsoft Canada has warned us, 5G was developed by the Israelis for crowd control.

In the face of global “de-dollarization,” this is how the dollar syndicate can assert the central control it needs to maintain and extend its global reserve currency financial power. This includes protecting its leadership from the civil and criminal liability related to explosive levels of financial and health care fraud in recent decades.

Which brings me back to you and me? Why are we calling these formulations “vaccines”?

If I understand the history of case law, vaccines, in legal terms, are medicine. Intentional heavy metal poisoning is not medicine. Injectable surveillance components are not medicine. Injectable credit cards are not medicine. Injectable brain-machine interface is not a medicine. Immunity for insurance companies is not the creation of human immunity.

We need to stop allowing these concoctions to be referred to by a word that the courts and the general population define and treat as medicine and protect from legal and financial liability.

The perpetrators of this fraud are trying a very neat trick—one that will help them go much faster and cancel out a lot of risk at our death, disease and expense. I understand why they are doing it.

What I don’t understand is why we are helping them. Why are we acquiescing in calling these bizarre and deeply dangerous concoctions “vaccines”? Whatever they are, they are not medicine.

So, what shall our naming convention be? What name shall we give to the relevant poisons, neurological damaging metals and digital shackles?

*Whatever we call them, I know one thing. **THEY ARE NOT MEDICINE, WHICH MEANS THEY SURE ARE NOT VACCINES.***

In high school many of my teachers came to know me as a contrarian. It was not because I was a trouble maker, when rejecting hived-mind opinion; going against current practice. Rather, in my blue collar family background and way of thinking, I was seeking sensible answers. I was a deep thinker and really wanted sound answers. My dad would say frequently, “son get a good education, learn to use your mind and not your back!” I was always taught to be respectful and never cause trouble in school. So, when a teacher would punish a class with detention, I would never stay for after-school detention. I would tell my parents what happened and why I did not stay for detention.

I don’t want to get side-tracked here and in the course of life, many find themselves controlled like the sheep in the meme. It seems that so much of our world is controlled

by sociopaths and psychopaths, and they all seem power driven and want to control your life. I've been a 'truth-seeker' since 1956. I even said I wanted that on my grave marker, but looks like I may not be concerned about that anymore.

“And ye shall know the truth, and the truth shall make you free.” -(John 8:32)

The result of abiding in His Word is that the Word will progressively become clear. This statement is similar to John 7:17, ***“If any man will do his will, he shall know of the doctrine....”*** The word ***“know”*** means ***“come to know”*** and connotes a knowledge that is learned through experience. The ***“truth”*** is Jesus Christ himself -(John 14:6). It is so because He is the revelation of God to man -(see John 1:14). To be ***“free”*** is to be released from the bondage of sin, to have light instead of darkness. Verse 36 states that it is the Son who makes one free. The Scriptures teach that to live in sin, to practice sin, is to be in bondage to sin. Sin has power over the unbeliever. It must be broken by the power and authority of the Word of God. Yet a person must yield to the Lord so that He will work within the individual to bring deliverance.

An article in *‘The New York Times’*, published May 3rd, 2021, reveals a dramatic shift in the narrative concerning coronavirus and the future. This was never about a virus. I hope you realize that by now. I have been saying it since January of 2020!

The *‘NYT’* article said, Gone are the declarations that Covid is a temporary phenomenon, to be defeated by masks, lockdowns and herd immunity. Quoting Rustom Antia, who is a virologist with Emory University, the article promotes the hypothesis that Covid is now forever.

Dr. Antia stated that “*The virus is unlikely to go away.*” The article goes on to quote Dr. Anthony Fauci, a previously strong prior promoter of the herd immunity thesis as saying: *“People were getting confused and thinking you’re never going to get the infections down until you reach this mystical level of herd immunity, whatever that number is.”* I reject that premise in its totality. Those are words of sociopaths and psychopaths.

In a paragraph that might send chills down the spine of those yearning to be free from the yoke of virus restrictions, the *‘Times’* article reports that “*Polls show that about 30 percent of the U.S. population is still reluctant to be vaccinated*”. That number is expected to improve but probably not enough. “*It is theoretically possible that we could get to about 90 percent vaccination coverage, but not super likely, I would say,*” said Marc Lipsitch, an epidemiologist at the Harvard T.H. Chan School of Public Health.”

In a dramatic reversal from the promises that we would sooner or later return to normal, the article goes on to explore the apparently novel conclusions that viruses spread persistently, and that a vaccination skeptical populace is aiding and abetting the persistence of this spread. The article states *“...experts now calculate the herd immunity threshold to be at least 80 percent. If even more contagious variants develop, or if scientists find that immunized people can still transmit the virus, the calculation will have to be revised upward again.”*

WHAT IS MISSING FROM THIS NARRATIVE?

A source in Canada, writing under a request for confidentiality, points out that the narrative has shifted entirely away from treatment towards an emphasis on vaccine imperatives. She writes, *"The mainstream media revealed, early in the COVID scenario, that there are several remedies that work just fine and there is no need whatsoever for any vaccine."* She goes on to say that *"For some reason, nobody, even doctors, remembers those remedies."* She includes the following list:

COVID-19 REMEDIES WHICH HAVE BEEN REPORTED AS WORKING:

(This is a simple list - reader should do their own research where validation is needed.)

- ◆ hydroxychloroquine ... opens cell walls so zinc can enter
- ◆ + azithromycin ... inhibits bacteria which transport the virus
- ◆ + zinc ... zinc, key ingredient, enters cells and inhibits virus replication

Note: Studies claiming HCQ doesn't work omitted the ZINC.

Note: Some doctors report that supplement QUERCETIN may function similar to HCQ (assists zinc entering cells)

- ◆ ivermectin
- ◆ + doxycycline
- ◆ + zinc ... zinc, key ingredient, enters cells and inhibits virus replication
- ◆ budesonide ... common asthma drug "Pulmicort"
- ◆ + antibiotic ... inhibits bacteria which transport the virus
- ◆ quercetin ... common supplement
- ◆ injectable vitamin C ... injection increases efficacy
- ◆ vitamin D ... exposing skin to sun effective
- ◆ stem cell therapy ... stops COVID and repairs lung damage as well

This information has been broadcast on different national and international radio stations throughout the duration of the COVID crisis. Some commentators are medical professionals, others are reporters quoting official sources.

I would imagine that many reading this article may be aware of these proposed remedies. The point here is not to provide new treatment information but to question why a treatment strategy has been entirely dropped from the narrative.

The Canadian source writes, *“To me, the forgetting of those remedies is so total that it really suggests that it is the result of electronic mind control. Ditto for all the other bizarre behavior of the various leaders and players in the many current events.”*

Without dipping into concerns that the electronic rhetoric is now thick with signals that may invade the brain and disrupt normal behavior, her statements need to be looked at closely in terms of the mass amnesia that has afflicted the world’s population. The only item on the table at this juncture appears to be the question: *“To vaccinate or not to vaccinate?”* Given what we know at this very moment in time, the answer is ABSOLUTELY NOT! Getting an injection is to sign your own death warrant.

Clearly, the powers-that-be are creating a scenario wherein choosing not to receive the jab is most inconvenient for one’s continued viability as a worker, a traveler and a social being. One could present a compelling argument that the creation of a two-tier society, the vaccinated and the lepers – that is, the unvaccinated – is being rolled out.

However, the statements by our Canadian colleague transcend this analysis. Her statements point to concerns about an effort to subliminally affect our thinking and decisions, in ways which we would neither be aware nor in control of.

Certainly the media is directing our focus at this juncture. For those seeking to free their minds and to exercise their natural ability for discernment, it would be useful to review the claims made not only by electronically targeted individuals, aka experimental subjects, but also the state of the science at this point in time.

Elon Musk’s project for Neuralink has gotten significant coverage of late. A recent article in *‘New Scientist’* headlines *“Elon Musk’s plans for mind-controlled gadgets: what we know so far.”* However, the article fails to differentiate between mind-controlled gadgets and gadget-controlled minds. This difference has some scientists concerned.

Dr. Robert Duncan has worked on projects for the CIA and for DARPA. Writing in his book, *‘The Matrix Deciphered’*, Duncan states:

“I have interviewed over two hundred people and worked on the highest level of military projects for the U.S., NATO, and U.K. and have given videotaped testimony to senators and representatives on this topic resulting in lip service since they have no real power to enforce. Two high level FBI agents and a couple CIA agents have come forward to validate the existence of an MKULTRA-like project that continues to grab random people for mind control experimentation.”

Neuroscientist Dr. James Giordano’s bio includes work for the Pentagon, DARPA, Georgetown University and the HHS. In a presentation to the United States Military

Academy cadets titled, "The Brain is the Battlefield of the Future," Giordano states that "The concept of the brain as the battlescape is very important." I have listened to Dr. Giordano's lecture twice in previous viewings, I find lectures and presentations given to students at West Point provide us a glimpse of what the minds of the Pentagon are engaged with in future warriors.

He goes on to state that *"Disruption and influence will be the key to creating peer capabilities and asymmetric relations and engagements."*

For emphasis, when he stated *"disruption and influence,"* he quoted from a recent article in 'Scientific American' which began with this bold pronouncement: "The ability to detect electrical activity in the brain through the scalp, and to control it, will soon transform medicine and change society in profound ways."

Could it be that this technology is now being deployed to encourage us to become lab rats for an experimental mRNA operating system, aka the Covid vaccine? And how would we know? In the last week, two news sources raised the very question, why does the government always experiment on us?

This 'SA' reporter previously uncovered a secret ward at UCLA Neuropsychiatric Institute, designated as A-South, where non-consensual experiments were being conducted on welfare patients, experiments dealing with brain electricity. This unit, headed by a Dr. Barry Guze, was certainly up and running into the first decade of the new millennium, though UCLA has attempted to deny the unit ever existed.

The secrecy surrounding this project could be compared with the level of secrecy surrounding the entire MK ULTRA (mind control) projects which were exposed to some degree in the Church and Pike hearings of the 1970s and allegedly discontinued. The reports of MK ULTRA having been discontinued are now largely considered to be fraudulent. The acronym "MK" stood for "Mind Kontrol" when it commenced.

It is something to consider, in any case. I have recognized this possibility with the unveiling of 5G, and more so with the 6G which is where it is all headed. As people line up to take the jabs, oblivious to the plethora of information that has been provided concerning valid countermeasures, it might be worthwhile to wonder why. Is it simply that our ever faithful media has shifted our attention away from treatments or is there something more nefarious at play?

From reading the writings of Dr. Duncan and Dr. Giordano you can see where the human brain is the battle field of the future against humanity. The future is the here and now and so let's be honest about it. ***"Fear is ultimately what strips us of our human rights and drives a society into totalitarianism. The only way to circumvent such a fate is to bravely resist."*** Ironically, those are the opening words on the inside flap of the cover to 'The Truth About Covid-19' authored by Dr. Joseph Mercola and Ronnie Cummins. You see, Dr. Mercola two weeks ago was forced to remove all that he has taught about Vitamins C, D3, and certain therapies.

In the summer of 2020, the Center for Science in the Public Interest (CSPI) — a consumer advocacy group partnered with Bill Gates' agrichemical PR group, the Cornell Alliance for Science, and bankrolled by billionaires with ties to Monsanto, the Gates Foundation, the Rockefeller Foundation, the Rockefeller Family Fund and Bloomberg Philanthropies — launched a social media campaign to put an end to Mercola.com. Dr. Mercola was the first name on a list of a dozen this gang of billionaires wants to destroy. The FDA tried to have Vitamin D³ classified as a drug, but lost in the courts. Vitamin D is the greatest natural vitamin that comes from the Sun.

From what I have read, there have been personal threats on Dr. Mercola and his family members. While we can understand his decision, the truth will never be shut-down. Others as well as myself will continue to wage the information war against tyranny and totalitarianism.

The CSPI is trying to censor Dr. Mercola's efforts to educate people on how to avoid vitamin D deficiency which, without doubt, places them at far higher risk of complications and death from respiratory infections. Well, I am not going to allow people to die from COVID-19 and other respiratory infections due to vitamin D deficiency.

In October 2020, Dr. Mercola co-wrote a paper together with William Grant, Ph.D., and Dr. Carol Wagner, both of whom are on the GrassrootsHealth vitamin D expert panel, demonstrating the clear link between vitamin D deficiency and severe cases of COVID-19. This paper was published in the peer-reviewed medical journal 'Nutrients'.

With that, Dr. Mercola has established his medical and scientific merit, and will continue to express his professional opinions, based on the available science, and defend his freedom of speech as the U.S. Constitution provides for.

Dr. Judy Mikovitz, a virologist who exposed Dr. Fauci was recently asked by Jeff Rense of Rense.com, given the issue of 'shedding' and the mRNA spike protein, what can we do to protect those unvaccinated from the vaccinated. **Dr. Judy Mikovitz said those who are not vaccinated should continue with Vitamin C, D³, Zinc, and regimen and maintain a healthy immune system. She did not express any need for concern if one was following this therapy method. The important thing is to keep your God-given immune system healthy.**

Since I have lymphedema/lymphoreah, I take a different regimen that is part of a gluten-free diet. Being a health advocate, I do take a full range of vitamins and supplements as well. I can honestly say that I have never had the flu, and went thirty years without so much as a cold until two years ago when a granddaughter accidentally sneezed directly in my face.

There is much, MUCH, more to the extremely dangerous and deadly Covid vaccines than what we all have already figured out.

Everything points to a highly sophisticated bioweapon that relentlessly attacks the immune system in a similar way that HIV does, which can eventually develop into full-blown AIDS. Strains of Covid-19 contain 18 fragments of HIV plus 4 fragments of SARS-2, none of which are natural to the SARS2-CoV-19 virus. The HIV genome has discovered by several countries and promptly alerted to the WHO, where the discovery was buried from view. In June, 2020, we knew three different strains of the Coronavirus had entered the country from either coast. The CDC, NIH, WHO, all know much more than they let on or share with the medical world.

This particular feature of the Covid-19 bioweapon makes it particularly pernicious to human life because it will eventually drag down every Covid vaccinated individual with some degree of autoimmune disease, disorder and/or dysregulation. As follows:

Why is LYMPHADENOPATHY by far the major dangerous adverse reaction to Covid injections? In this manner, the American Healthcare System and Big Pharma will have countless vaccine-injured patients for the next 100 years and beyond.

This stark reality is best explained by the following single data point regarding the most common adverse side effect — LYMPHADENOPATHY — from taking any of the various Covid vaccines. In fact, the European agency equivalent of VAERS shows this issue being ten times larger numerically than that of death, and the leading side-effect from all of the pharmaceutical firms being given.

“Lymphadenopathy may be the only clinical finding or one of several nonspecific findings, and the discovery of swollen lymph nodes will often raise the specter of serious illness such as lymphoma, acquired immunodeficiency syndrome [AIDS] or metastatic cancer.”

Several months ago I shared an article by a hundred doctors, in which the physicians stated what they recommend to their patients and what they personally took in the way of Vitamin D³. The one hundred doctors recommend and took a minimum of 4,000 IU and a maximum of 5,000 IU of Vitamin D³. That fact alone is sufficient evidence for me as to the importance of Vitamin D³. Dr. Fauci who has never treated a patient in a hospital for any health issue, went to work for the U.S. Health Service in order to avoid the military draft of doctors subject to the draft during the Vietnam War. During the war the military drafted medical doctors coming out of medical school to become field surgeons or MASH doctors. Dr. Fauci chose to become a medical bureaucrat, and was dubbed wearer of the ‘yellow’ beret. In 1968, the newly minted doctor joined NIH to dodge medical service with the U.S. military.

Fauci earned a medical degree at Cornell in 1966 but if he ever practiced medicine it was only for a short time. As Raymond S. Greenberg explains at Historynet.com, the

mid-1960s were the days of “a compulsory draft of American physicians,” to serve in military hospitals in Vietnam. One of the few alternatives to that service was a position in the Public Health Service. Newly minted physicians could join the clinical associate program at the National Institutes of Health in Bethesda, Maryland.

These doctors were dubbed “Yellow Berets,” the opposite numbers of the Special Forces Green Beret troops in Vietnam. The Omens, a Detroit group, even wrote a song about it, “The Ballad of the Yellow Beret,” a parody of “Ballad of the Green Berets” by Sgt. Barry Sadler, a Special Forces medic who also treated the Montagnards and other civilians.

Instead of attending wounded American troops in Vietnam, Fauci joined the entering NIH clinical associate class of 1968. As Fauci told Greenberg, the yellow beret tag was “very much derogatory,” but the NIH recruit didn’t mind. “In general, the spirit on campus was much more a liberal leaning than a conservative leaning because that is generally the case with scientists.”

Fauci contends “*most people were against the war,*” but not all physicians were against serving in the military field hospitals in Vietnam or anywhere else. Those who did regarded the yellow berets askance. As Fauci noted, the physicians who did not go into the service had a “*cushy job*” at the NIH.

Fauci’s bio showed no advanced degrees in biochemistry or molecular biology but by 1984 the Yellow Beret was heading the National Institute of Allergy and Infectious Disease (NIAID). Back in the 1990s Nobel laureate Kari Mullis, inventor of the polymerase chain reaction (PCR), said Fauci “*doesn’t understand electron microscopy and he doesn’t understand medicine. He should not be in a position like he’s in.*”

As Michael Fumento noted in ‘*The Myth of Heterosexual AIDS*’, Fauci was hopelessly wrong that AIDS would ravage the heterosexual population. As UC Berkeley molecular biologist Peter Duesberg showed in inventing the AIDS Virus, Fauci was a pioneer of cancel culture, quashing media appearances by better qualified persons of different views. Despite his costly blunders, Fauci remained in his “*cushy job*” at the head of NIAID, with steadily increasing salary and power.

Millions of Americans got their first dose of Dr. Fauci in early 2020, when he recommended the destructive lockdowns that crushed the powerful Trump economy, infringed on Americans’ constitutional rights, and enabled massive voting by mail. Fauci issued prophecies based on computer models but shied away from hard, scientific data. On the origin of the pandemic, the NIAID boss remains evasive.

“*What is your opinion on how COVID became so well adapted to humans?*” Margaret Brennan of CBS News asked Fauci on March 28. “*You know, Margaret, that’s an argument that goes back and forth,*” Fauci said. “*A very plausible explanation for this is that this virus jumped from an animal host, a bat to maybe an intermediate host and then to a human.*”

The “*other theory*” is that the virus “*accidentally escaped*” from “a lab.” As Dr. Fauci concluded, “I think the most likely one that in nature, in the wild, it adapted itself.” No word from the NIAID boss about dangerous “gain of function” research.

According to the Office of Science Policy of the National Institutes of Health, gain of function research can “enhance the pathogenicity or transmissibility of potential pandemic pathogens (PPPs)” and that can raise “biosafety and biosecurity concerns. ” *In 2012, Fauci cited the risks of such research, wondering, “what if that scientist becomes infected with the virus, which leads to an outbreak and ultimately triggers a pandemic?”* The NIH banned gain of function research in 2014 but revived it in 2017 with no objection from Fauci.

Fauci’s NIAID also funded the Wuhan Institute of Virology (WIV) in Communist China, where gain of function research could be conducted in secret, with no accountability, and which received shipments of deadly pathogens from a lab in Canada. The pathogens included the Nipah virus, able to jump between humans and as Tom Blackwell of Canada’s ‘*National Post*’ explained, “*a threat to cause a widespread outbreak.*”

“*Emerging Pandemic Diseases: How We Got to COVID-19,*” Fauci’s August 2020 paper, authored with NIAID adviser Dr. David Morens, does not flag gain of function research as a possible contributor to the pandemic. On the other hand, Fauci called for “*strengthening the United Nations and its agencies, particularly the World Health Organization.*” Like the notion that the COVID-19 virus somehow “adapted itself” to humans, that is not a scientific statement. With Fauci, now 80, it’s always been about politics, power and money.

With a current salary of \$417,608, more than the president of the United States, Dr. Anthony Fauci is the highest paid bureaucrat in the federal government. Fauci’s NIAID now boasts a budget of more than \$6 billion, an increase of 3.1 percent from the previous fiscal year. By all indications the destructive lockdowns that punished millions of Americans affected Dr. Fauci not at all. Senator Rand Paul took Dr. Fauci to task in hearings on May 10th, bringing up the issue of Dr. Fauci funding “Gain-of-Function” work in China. The story has become national news after Senator Rand Paul’s interrogation!

Threats will not shut down the truth, whether it be coming from Dr. Joseph Mercola, Dr. Judy Mikovitz, Dr. Sherri Tenpenny, Dr. Carrie Madej, Dr. Lee Merritt or a nobody like myself!

How do you know if the people around you have been vaccinated? A new wearable device aims to show you, and some in San Diego are already buying in.

“If we had something where you can say, ‘Hey, I support the vaccine effort, I’ve been vaccinated, I’m safe to be around,’ then that would help us as we start to open back up,” Dr. Toshof Bernton, the man behind the idea for the new accessory, told NewsNation affiliate KSWB.

His bracelet, the Immunaband, runs about \$20 and stores vaccine records on it so people don’t have to haul around their vaccine cards. Once purchased, the customer sends in a copy of their vaccine card and the company loads the record to its encrypted website. The bracelet then comes in the mail with a QR code on it. If someone wants to verify the wearer’s vaccine records, they pull out their cell phone, snap a picture of the QR code and see the record.



“Let’s say somebody stole it,” Dr. Bernton adds. “They can get to the website, but unless they know your pin, they can’t get to your card.”

Dr. Bernton sold his first bracelet about three weeks ago, and thousands of them have gone out the door since then. In fact, he said one customer sent him a photo from a Knicks game at Madison Square Garden in New York. The policy at MSG reads:

“Guests can now enter with proof of a negative antigen COVID-19 test or full vaccination.”

Dr. Bernton said the fan told him he was allowed in with the bracelet after an employee at the gate pulled up the website through the QR code. Additionally, he says a lot of companies in the travel and hospitality industry are buying the bracelets for their employees, including a restaurant owner in Los Angeles.

“It’s a little too much,” said one San Diego woman who FOX 5 interviewed on the streets of Little Italy Wednesday. *“Sometimes you go to a restaurant and you don’t even know the waiter’s name. I don’t need to know their medical history like that.”*

Others thought the idea sounded helpful.

“I think that’s actually pretty good because a lot of people have doubts about going to certain areas,” Keshawn Slaughter, who was also out in Little Italy Wednesday, said.

This all sounds so reminiscent of how the Nazis treated Jews and Gypsies, giving them hexagrams to wear on their clothing, and I.D. numbers tattooed on their wrists.

Now that 147 million Americans have been vaccinated, public interest in the COVID-19 vaccine is sharply declining. So the Biden administration is looking for new ways to pressure 80 million more reluctant Americans into getting their shots.

"Now we are going to have to bring the vaccine to people who are less eager," Joe Biden said on Tuesday. "So, we also know that there are millions of Americans who just need a little bit of encouragement to get the shot."

We saw this coming, didn't we? At first they told us, Two weeks to flatten the curve! Now it has been 59 weeks to flatten the curve. What will come next? At first it was, We are just going to make it available to as many Americans as want it. Now it is, We are going to give the less eager *"a little bit of encouragement."* What will come next?

What's coming right now is the Biden administration calling on businesses to offer paid time off to employees who get vaccinated and giving away tax credits to reimburse these businesses with taxpayer dollars for the associated costs. The government also started airing television ads in English and Spanish telling people to get vaccinated. Biden said the government is even helping launch merchandise discounts and ticket giveaways with major sports leagues and is getting involved with businesses like grocery stores to provide special discounts to shoppers who get vaccinated in their shops. Yes, you now live in a world where the federal government is literally mixing mass experimental vaccination coercion with \$5 off your next in-store purchase at Target.

More than half of adults in the United States have been inoculated with at least one dose of a Covid-19 vaccine. The speed is a triumph of modern science and a relentless effort by the Biden administration to increase availability. However, roughly 30 percent of the population is still hesitant to be vaccinated, according to polls, and daily vaccination rates are dropping. As the country moves from a lack of supply to a potential lack of demand, the White House will need to adapt its strategy to try and reach a level of herd immunity. Results from recent experiments by the UCLA Covid-19 Health and Politics Project provide clues about what incentives may move the needle for different segments of the population.

One experiment run by the UCLA project found that a cash payment would make roughly a third of unvaccinated people more likely to get a shot. Researchers trialed different levels of cash payments and, unsurprisingly, found that a \$100 cash payment increased willingness more than a \$25 or \$50 payment.

The idea of paying individuals to get vaccinated is not new. A proposal by Robert Litan, a non-resident Senior Fellow in the Economic Studies Program at the Brookings Institution, late last year offered a solution that harnesses the power of one of the most basic economic principles, incentives, to nudge human behavior by paying individuals

\$1,000 to get vaccinated. Litan's proposal was championed as "textbook economics" by Gregory Mankiw, a Harvard economist and former chair of George W. Bush's Council of Economic Advisors, who, not so coincidentally, has authored leading economic textbooks. The UCLA results show that a much lower payment could still be effective.

The finding also substantiate a criticism of Litan's proposal, which is that offering a cash payment may actually dissuade some from getting inoculated. In the UCLA experiment, 15 percent of unvaccinated individuals said being offered a cash payment would actually decrease their willingness to get a vaccination. However, as Lynn Vavreck, a principal investigator of the U.C.L.A. Covid-19 Health and Politics Project, noted in *The New York Times*, "at this later stage of a vaccine campaign — when attention has now turned to the hesitant — the net benefit seems to be tilting toward payment."

UCLA's findings may provide more ammunition for state and local leaders who have been offering different forms of cash payments. Governor Larry Hogan of Maryland announced a \$100 payment to incent state employees to get the vaccine. *"Incentives like this are another way to reinforce the importance of getting vaccinated, and we strongly encourage businesses across the state to consider offering incentives to their workers as well,"* Mr. Hogan, a Republican, said. *"These vaccines are safe and effective, they're free, and they're readily available with or without an appointment."*

Like pretty much else in the United States at the moment, there was a partisan split in the effectiveness of monetary payments. 48 percent of Democrats said they would be more willing to get vaccinated if they received a \$100 payment, whereas a much lower

percentage of Republicans were motivated by cash. Luckily, another experiment showed a method that resonated more with Republicans.

Early experiments by the UCLA team found that different messaging strategies only had a small effect on individual's willingness to get vaccinated. For example, framing the benefits in a self-interested way compared to a more socially-minded approach ("it will protect you" versus "it will protect you and those around you") didn't change uptake significantly. The team found similar results when vaccinations were endorsed by prominent figures or personal medical sources.

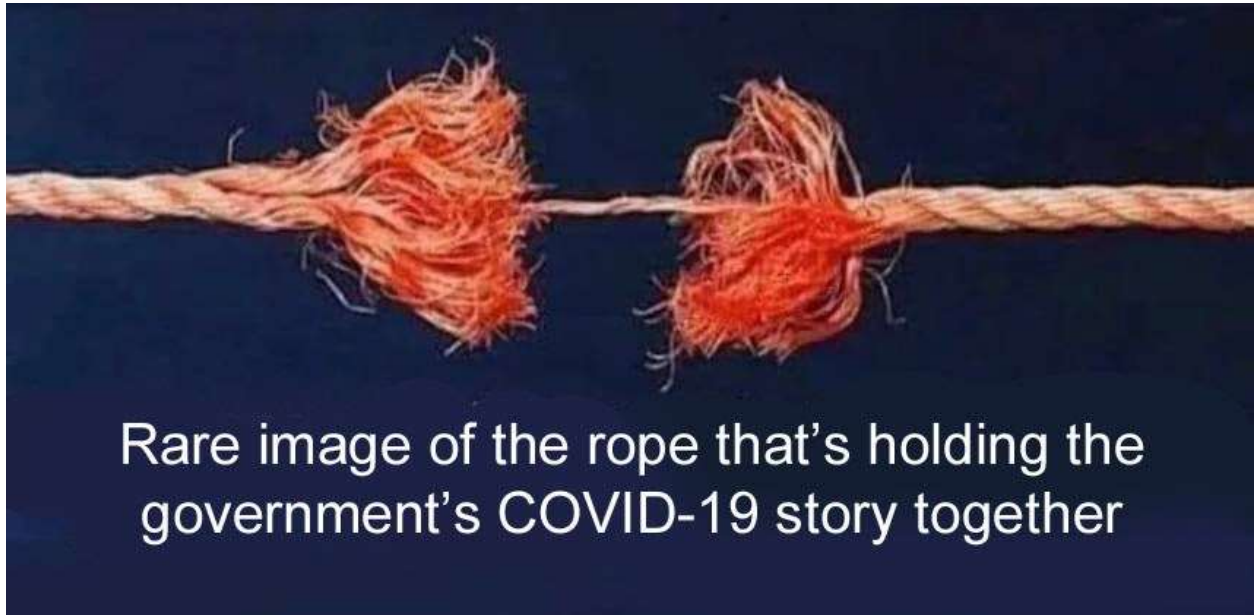
However, in more recent experiments, a specific message did seem to work. *"The incentive to stop wearing a mask and social-distancing in public also had a strong result,"* wrote Vavreck. *"On average, relaxing the mask and social distancing guidelines increased vaccine uptake likelihood by 13 points. The largest gains came from Republicans, who reported an 18-point increase in willingness to get vaccinated."*

The Biden administration's vaccination effort is shifting into high gear, including a strategy to lean on employers, houses of worship, and many community organizations to reach individuals who have yet to be vaccinated. *"We need to be more creative about meeting people where they physically are,"* Erica Johnson, chairwoman of the American Board of Internal Medicine's infectious diseases specialty board and Johns Hopkins assistant professor of medicine, told Axios. Working with trusted individuals *"can help remove structural barriers and provide persuasive pro-vaccine messages,"* Johnson said. The administration is also targeting more surgical approaches by moving away from mass vaccinations and towards community clinics and even door-to-door campaigns to reach holdouts, especially in rural areas.

The results from the UCLA experiments "show both the difficulty of getting the remaining unvaccinated people to clinics and the promise of efforts aimed at doing so." Adopting a more holistic and multi-prong approach may help to move the needle even further. It behooves the Biden administration to tailor to consider these tactics and adapt its strategy to different constituencies.

If those plans fail, there's always the approach that Governor Phil Murphy of New Jersey is trying: free beer. *"Any New Jerseyan who gets their first vaccine dose in the month of May and takes their vaccination card to a participating brewery will receive a free beer,"* Murphy tweeted. Perhaps free beer is a stronger motivating force than the prospect of not dying.

When you consider the death rate from the alleged virus, and the media has shared that data enough at this point in time that the fear of death and the odds relative to one's age is simply a no brainer. 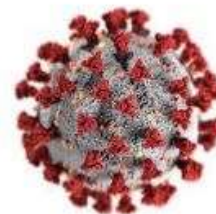

The average width and height of a cloth pore is **10 micrometers (μm) (A)²**

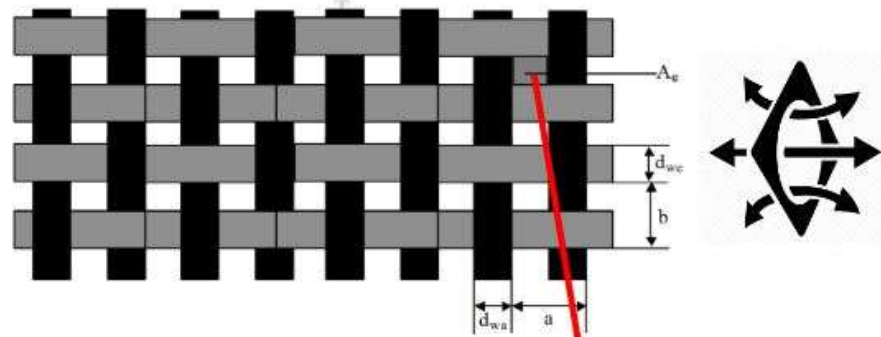


Figure 1. Plain woven fabric structure

The average number of face mask cloth pores covering your mouth used in this example is **300 pores**.³

Each cloth pore of a face mask is big enough to allow **6,084 particles per pore** to pass in and out.

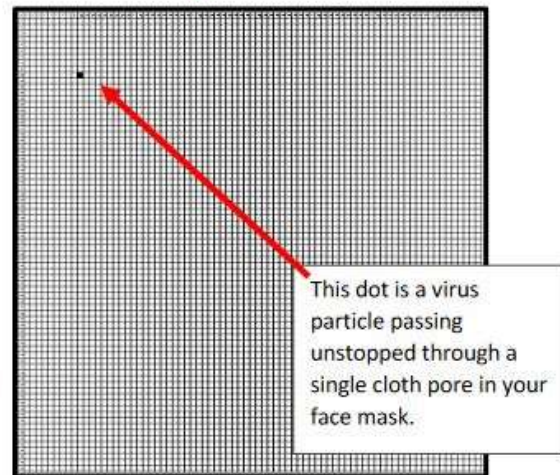


Figure 1: Area (A) of one (1) pore in a cloth face mask.

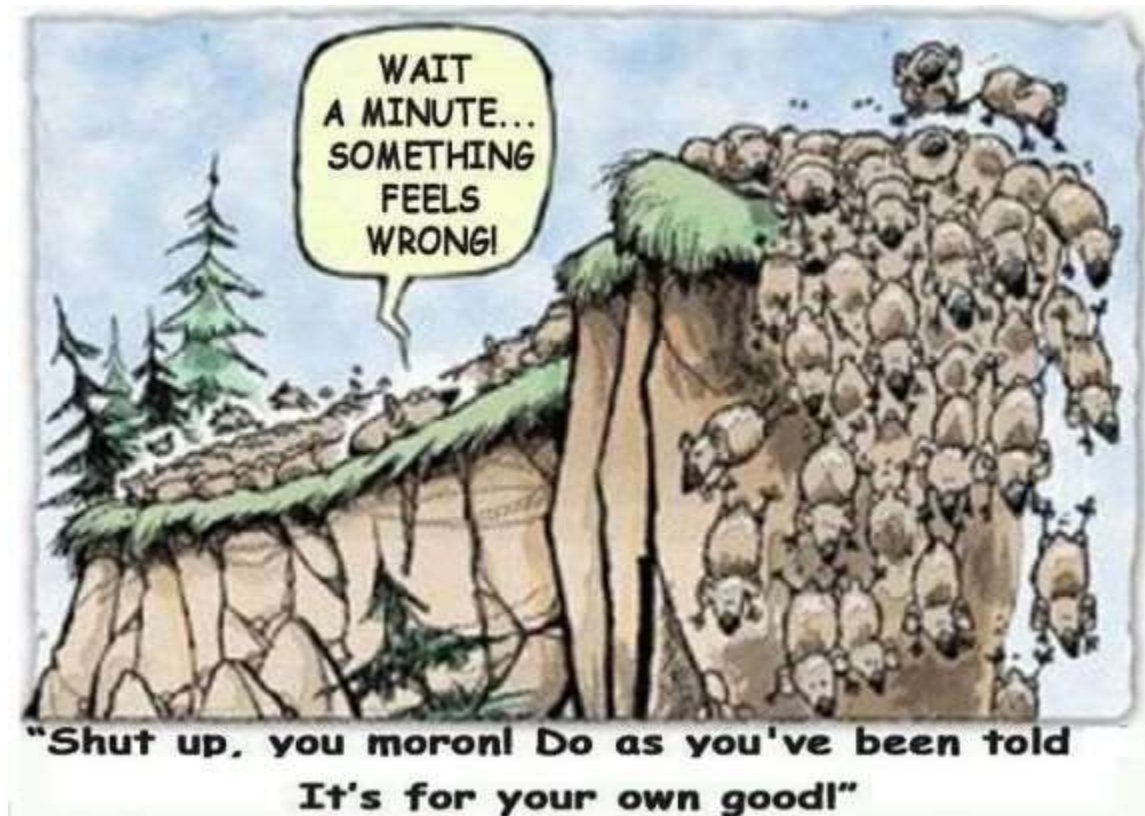
