


The district's Covid-19 response center has registered just 11 cases since the start of the pandemic, and no deaths. At the regional hospital, the wards are packed — with malaria patients. The door to the Covid isolation ward is bolted shut and overgrown with weeds. People cram together for weddings, soccer matches, concerts, with no masks in sight.

Sierra Leone, a nation of eight million on the coast of Western Africa, feels like a land inexplicably spared as a plague passed overhead. What has happened — or hasn't happened — here and in much of sub-Saharan Africa is a great mystery of the pandemic.

The low rate of coronavirus infections, hospitalizations and deaths in West and Central Africa is the focus of a debate that has divided scientists on the continent and beyond. Have the sick or dead simply not been counted? If Covid has in fact done less damage here, why is that? If it has been just as vicious, how have we missed it?

The answers "are relevant not just to us, but have implications for the greater public good," said Austin Demby, Sierra Leone's health minister, in an interview in Freetown, the capital.

The assertion that Covid isn't as big a threat in Africa has sparked debate about whether the African Union's push to vaccinate 70 percent of Africans against the virus this year is the best use of health care resources, given that the devastation from other pathogens, such as malaria, appears to be much higher.

In the first months of the pandemic, there was fear that Covid might eviscerate Africa, tearing through countries with health systems as weak as Sierra Leone's, where there are just three doctors for every 100,000 people, according to the World Health Organization. The high prevalence of malaria, H.I.V., tuberculosis and malnutrition was seen as kindling for disaster.

That has not happened. The first iteration of the virus that raced around the world had comparatively minimal impact here. The Beta variant ravaged South Africa, as did Delta and Omicron, yet much of the rest of the continent did not record similar death tolls.

Into Year Three of the pandemic, new research shows there is no longer any question of whether Covid has spread widely in Africa. It has.

Studies that tested blood samples for antibodies to SARS-CoV-2, the official name for the virus that causes Covid, show that about two-thirds of the population in most sub-Saharan countries do indeed have those antibodies.

Since only 14 percent of the population has received any kind of Covid vaccination, the antibodies are overwhelmingly from infection.

A new W.H.O.-led analysis, not yet peer-reviewed, synthesized surveys from across the continent and found that 65 percent of Africans had been infected by the third quarter of 2021, higher than the rate in many parts of the world. Just 4 percent of Africans had been vaccinated when these data were gathered.

So the virus is in Africa. Is it killing fewer people?

Some speculation has focused on the relative youth of Africans. Their median age is 19 years, compared with 43 in Europe and 38 in the United States. Nearly two-thirds of the population in sub-Saharan Africa is under 25, and only 3 percent is 65 or older. That means far fewer people, comparatively, have lived long enough to develop the health issues (cardiovascular disease, diabetes, chronic respiratory disease and cancer) that can sharply increase the risk of severe disease and death from Covid. Young people infected by the coronavirus are often asymptomatic, which could account for the low number of reported cases.

Plenty of other hypotheses have been floated. High temperatures and the fact that much of life is spent outdoors could be preventing spread. Or the low population density in many areas, or limited public transportation infrastructure. Perhaps exposure to other pathogens, including coronaviruses and deadly infections such as Lassa fever and Ebola, has somehow offered protection.

Since Covid tore through South and Southeast Asia last year, it has become harder to accept these theories. After all, the population of India is young, too (with a median age of 28), and temperatures in the country are also relatively high. But researchers have found that the Delta variant caused millions of deaths in India, far more than the 400,000 officially reported. And rates of infection with malaria and other coronaviruses are high in places, including India, that have also seen high Covid fatality rates.

So are Covid deaths in Africa simply not counted?

Most global Covid trackers register no cases in Sierra Leone because testing for the virus here is effectively nonexistent. With no testing, there are no cases to report. A research project at Njala University in Sierra Leone has found that 78 percent of people have antibodies for this coronavirus. Yet Sierra Leone has reported only 125 Covid deaths since the start of the pandemic.

Most people die in their homes, not in hospitals, either because they can't reach a medical facility or because their families take them home to die. Many deaths are never registered with civil authorities.

This pattern is common across sub-Saharan Africa. A recent survey by the United Nations Economic Commission for Africa found that official registration systems captured only one in three deaths.

The one sub-Saharan country where almost every death is counted is South Africa. And it's clear from the data that Covid has killed a great many people in that country, far more than the reported virus deaths. Excess mortality data show that between May 2020 and September 2021, some 250,000 more people died from natural causes than was predicted for that time period, based on the pattern in previous years. Surges in death rates match those in Covid cases, suggesting the virus was the culprit.

Dr. Lawrence Mwananyanda, a Boston University epidemiologist and special adviser to the president of Zambia, said he had no doubt that the impact in Zambia had been just as severe as in South Africa, but that Zambian deaths simply had not been captured by a much weaker registration system. Zambia, a country of more than 18 million people, has reported 4,000 Covid-19 deaths.

"If that is happening in South Africa, why should it be different here?" he said. In fact, he added, South Africa has a much stronger health system, which ought to mean a lower death rate, rather than a higher one.

A research team he led found that during Zambia's Delta wave, 87 percent of bodies in hospital morgues were infected with Covid. *"The morgue was full. Nothing else is different — what is different is that we just have very poor data."*

The Economist, which has been tracking excess deaths throughout the pandemic, shows similar rates of death across Africa. Sondre Solstad, who runs the Africa model, said that there had been between one million and 2.9 million excess deaths on the continent during the pandemic.

"It would be beautiful if Africans were spared, but they aren't," he said.

But many scientists tracking the pandemic on the ground disagree. It's not possible that hundreds of thousands or even millions of Covid deaths could have gone unnoticed, they say.

"We have not seen massive burials in Africa. If that had happened, we'd have seen it," said Dr. Thierno Baldé, who runs the W.H.O.'s Covid emergency response in Africa.

"A death in Africa never goes unrecorded, as much as we are poor at recordkeeping," said Dr. Abdhalah Ziraba, an epidemiologist at the African Population and Health Research Center in Nairobi, Kenya. "There is a funeral, an announcement: A burial is never done within a week because it is a big event. For someone sitting in New York hypothesizing that they were unrecorded — well, we may not have the accurate numbers, but the perception is palpable. In the media, in your social circle, you know if there are deaths."

Dr. Demby, the Sierra Leone health minister, who is an epidemiologist by training, agreed. "We haven't had overflowing hospitals. We haven't," he said. "There is no evidence that excess deaths are occurring."

Which could be keeping the death rate lower?

While health surveillance is weak, he acknowledged, Sierra Leoneans have the recent, terrible experience of Ebola, which killed 4,000 people here in 2014-16. Since then, he said, citizens have been on alert for an infectious agent that could be killing people in their communities. They would not continue to pack into events if that were the case, he said.

Dr. Salim Abdool Karim, who is on the African Centers for Disease Control and Prevention Covid task force and who was part of the research team tracking excess deaths in South Africa, believes the death toll continent-wide is probably consistent with that of his country. There is simply no reason that Gambians or Ethiopians would be less vulnerable to Covid than South Africans, he said.

But he also said it was clear that large numbers of people were not turning up in the hospital with respiratory distress. The young population is clearly a key factor, he said, while some older people who die of strokes and other Covid-induced causes are not being identified as coronavirus deaths. Many are not making it to the hospital at all, and their deaths are not registered. But others are not falling ill at rates seen elsewhere, and that's a mystery that needs unraveling.

"It's hugely relevant to things as basic as vaccine development and treatment," said Dr. Prabhat Jha, who heads the Centre for Global Health Research in Toronto and is leading work to analyze causes of death in Sierra Leone.

Researchers working with Dr. Jha are using novel methods — such as looking for any increase in revenue from obituaries at radio stations in Sierra Leonean towns over the past two years — to try to see if deaths could have risen unnoticed, but he said it was clear there had been no tide of desperately sick people.

Some organizations working on the Covid vaccination effort say the lower rates of illness and death should be driving a rethinking of policy. John Johnson, vaccination adviser for Doctors Without Borders, said that vaccinating 70 percent of Africans made sense a year ago when it seemed like vaccines might provide long-term immunity and make it possible to end Covid-19 transmission. But now that it's clear that protection wanes, collective immunity no longer looks achievable. And so an immunization strategy that focuses on protecting just the most vulnerable would arguably be a better use of resources in a place such as Sierra Leone.

"Is this the most important thing to try to carry out in countries where there are much bigger problems with malaria, with polio, with measles, with cholera, with meningitis, with malnutrition? Is this what we want to spend our resources on in those countries?" he asked. "Because at this point, it's not for those people: It's to try to prevent new variants."

And new variants of Covid pose the greatest risk in places with older populations and high levels of comorbidities such as obesity, he said.

Other experts cautioned that the virus remained an unpredictable foe and that scaling back efforts to vaccinate sub-Saharan Africans could yet lead to tragedy.

"We can't get complacent and assume Africa can't go the way of India," Dr. Jha said.

A new variant as infectious as Omicron but more lethal than Delta could yet emerge, he warned, leaving Africans vulnerable unless vaccination rates increased significantly.

"We should really avoid the hubris that all Africa is safe," he said.

A former chairman of the Council of Europe Health Committee, and a former Chief Science Officer (CSO) and Vice President for Pfizer, say there is a unusual <u>pattern in</u> the data from the CDC's own <u>Vaccine Adverse Events Reporting System</u> (VAERS) which anyone with the time and skills can reproduce, which suggests that massive, and deadly, medical experimentation is taking place upon the American, if not the global, population.

Since the COVID vaccine roll-out, over <u>32,000 possibly directly-related deaths</u> have been reported to VAERS, <u>triple over all other vaccines</u> combined over 30 years. One website which catalogues the stories of victims is <u>Real Not Rare</u>. Real Not Rare also runs a <u>Facebook page</u>. In June of 2022, to no media coverage, people who had suffered serious injuries upon taking the COVID vaccines gathered for a <u>rally in Los Angeles</u>. On December 7, 2022, US Senator Ron Johnson held a roundtable discussion in Washington DC entitled "COVID-19 Vaccines: What They Are, How They Work, and Possible Causes of Injuries" (see videos below.) In Florida, <u>Gov. Ron DeSantis has initiated hearings</u> and possible legal action to hold COVID vaccines makers "accountable" for harm.


Pfizer Whistleblower Case in Limbo

Scientists Say Great Differences in COVID Vaccine Batch Lethality Cannot Be Accidental, as Elon Musk Enters the COVID Fray

Dr. Mike Yeadon, a former Chief Science Officer (CSO) and Vice President for Pfizer, says that given what he says is a history of lies from health authorities and government surrounding the COVID saga, he has no choice to conclude from the VAERS data that the vaccines may well be part of a program to "kill people intentionally."

Within minutes of Musk's tweet, hashtags such as #ProsecuteFauci and #FauciForPrison took flight.

Musk's call follows the release of Robert F. Kennedy Jr.'s scorching <u>documentary</u> <u>movie</u>, based on his <u>New York Times bestseller book</u> of the same title, <u>The Real</u> <u>Anthony Fauci</u> (version here contains Romanian subtitles but is in English.)

Fauci has been under fire many times before. Last year he drew outrage for funding what scientists said were unnecessary and <u>cruel experiments on beagle puppies</u>, in which puppies' heads were trapped in cages to be bitten at and eaten by sand flies.

But now a steady stream of news items daily undermines everything the public thought it knew about the government's COVID response.

Pfizer Admits COVID Vaccines Do Not Stop Transmission from Person to Person For example, this October, in a European Parliament hearing, it was admitted by a Pfizer president that the vaccine never did and was <u>never tested for stopping the</u> <u>transmission</u> of COVID from person to person. 

Doctor Yeadon and Dr. Wolfgang Wodarg say that vast differences in the <u>number of</u> <u>deaths</u>, <u>permanent disabilities</u>, and other "adverse events" which are associated with different batches of the COVID vaccines cannot possibly be accidental, given the highly precise nature of drug manufacturing. 

"Dose Range Finding"

Upon examining the data and analysis originally performed by <u>Craig Paardekooper</u>, Dr. Yeadon said that, as a pharmaceuticals scientist, he immediately recognized a process called "dose range finding." In dose range finding, varying strengths of dosage are administered in order to accurately peg the number of deaths and injuries which can be associated with each dosage level. One of Dr. Yeadon's specialties at Pfizer was toxicology, which involves these methods.

As can be seen, batch deadliness forms a progressive line sloping downward, as if early batches start out at high dosage strength and then are cut down in a methodical manner. Yeadon and Wodarg say this would never happen unless planned this way, since drugs are manufactured to be the same dose and formula across thousands of batches and billions of doses, with an extraordinarily high level of precision.

This would allow one to estimate how many deaths can be expected for a particular dosage strength, within a certain period of time. Dr. Yeadon says that in the pharmaceuticals business this is called "dose range finding." Wodarg, Yeadon, and others express being stunned at the logical conclusion, that a massive long-term depopulation program may be underway.

COVID Vaccines Set Up to "Kill People Intentionally"?

Despite the qualifications of Dr. Yeadon and Dr. Wodarg, and the origin of the data from the CDC's own reporting system, the FDA has not given an explanation for the data. Dr. Yeadon says the variability in the number of adverse event reports per batch, alone, is enough to shut the COVID vaccine programs down, if safety were a concern.

The findings have been met by dead silence in the media, and the accuracy of the calculations has never been challenged.

In the <u>interview</u> with attorney <u>Reiner Fuellmich</u>, who in the past brought successful lawsuits against Deutsche Bank and Volkswagon, Dr. Wolfgang Wodarg says: *"It is not true that there is the same stuff in each shot,"*

Dr. Wodarg says:

"Now is the time they can do it because we are afraid...it is worse than Nuremberg...and they kill people...intentionally."

In 2010 as head of the Council of Europe Health Committee, <u>Dr. Wodarg led an</u> inquiry into the controversial 2009 Swine Flu "pandemic."

Dr. Mike Yeadon says:

"if you harboured any residual doubts about whether there is or not a depopulation agenda, this presentation destroys that doubt."

Dr. Yeadon said in the interview:

"I am worried that this is the calibration of a killing weapon...I have got no reason to make this stuff up. I've never been a conspiracy theorist,"

Dr. Yeadon wrote to his Telegram audience:

"You'll be aware that one of our assiduous researchers noticed a short while ago that adverse events are not occurring randomly throughout the batches & lots of vaccines made by a given manufacturer.

Instead, it appears that just 5% of the batches / lots are associated with almost all the deaths.

Given the tight requirements of consistency associated with an authorised product, it's absolutely impossible that this is a chance event."



Autopsies Show Direct Casual Link Between Unexpected Deaths and COVID Vaccines

Internationally recognized pathology professors in multiple countries have concluded that there is a direct link between the COVID vaccines and many sudden, unexpected deaths, especially in younger age people not near the end-of-life years.

Two of these pathologists are Dr. Arne Burkhardt and Dr. Walter Lang.

<u>Dr. Arne Burkhardt has taught</u> at the Universities of Hamburg, Berne and Tübingen. He has published more than 150 scientific articles in German and international scientific journals, and has audited and certified institutes of pathology in Germany.

<u>Prof. Dr. Walter Lang</u> was a pathologist at the Hannover Medical School from 1968-1985. Afterwards, for 25 years, Lang directed a private institute for pathology, which he founded, specializing in transplant pathology, extragynecological cytology, thyroid tumors, and lung/pleural pathology.

In a German <u>pathology conference series</u> which began in 2021, Doctors Burkhardt and Lang reported never-before-seen immune system attacks on the body's own organs.

The webpage for the <u>2nd Pathology Conference</u> on Dec. 4, 2021 in Berlin, Germany, <u>said of Dr. Burkhardt's findings</u>:

"The findings confirm Prof. Dr. Peter Schirmacher's finding that among more than 40 corpses he autopsied who had died within two weeks of COVID19 vaccination, approximately one-third of those deaths were caused by the vaccination."

<u>The Epoch Times</u> reported on September 22, 2021 (click on Google translate from German to English):

"The doctors suspect autoimmune phenomena, reduction in immune capacity, acceleration of cancer growth, vascular damage "endothelitis", vasculitis, perivasculitis and erythrocyte "clumping" as further corona vaccination side effects with potential fatal consequences...Burkhardt described it as "extreme" that among the ten deceased examined, three very rare autoimmune diseases were found, namely Sjögren's syndrome, leukoclasic vasculitis of the skin and Hashimoto's disease."

The Epoch Times wrote:

In its <u>official statement</u> on the autopsy findings, Doctors for COVID Ethics, a co-sponsor of the symposium, writes:

Doctors for COVID Ethics concludes:

CDC Fudges Data in Order to Make COVID Vaccines Appear Safer

Apparently seeking to blunt autopsy studies by pathologists who say they are seeing never-before-seen phenomena in cadavers who died unexpectedly soon after COVID vaccination, a <u>study</u> by scientists affiliated with Kaiser Permanente, in contrast, concludes that vaccinated persons have lower, non-COVID, all-cause death rates than unvaccinated persons.

The Kaiser study would seem to throw cold water on the idea that the vaccines are killing people. But the study employs a critical deception.

Rather than count from the time that the shot begins to have effects on the body, which would be immediately, a person who is negatively impacted is not counted as being vaccinated <u>until 14 days</u> after the second shot in the case of Pfizer and Moderna, or 14 days after the J&J single shot. This is particularly deceptive because <u>80% of VAERS</u> reports of unexpected deaths post-vaccine occur within 14 days after taking a shot.


A <u>CDC</u> advisory on breakthrough COVID infections, which means infections in vaccinated people, shows that a person is considered "vaccinated" only after 14 days have passed since the final shot:

"a vaccine breakthrough infection is defined as the detection of SARS-CoV-2 RNA or antigen in a respiratory specimen collected from a person ≥14 days after receipt of all recommended doses of an FDA-authorized COVID-19 vaccine."

<u>Children's Health Defense reports</u> that one-third of unexpected deaths after vaccination takes place_within 48 hours, after receiving a shot.

This means that anyone who took a COVID vaccine shot, walks out, and falls over dead in the parking lot of a heart attack or stroke is counted as a death of an "unvaccinated" person.






COVID Vaccine Injury Claims in Compensation Court Now Many Times More Than For All Other Vaccines Combined, Animal Safety Trials All but Skipped

Unreported by Media, Younger People are Dying at Unprecedented Rates

Recent insurance company data for the US and other countries shows an <u>unprecedented rise in all-cause mortality</u> since the roll-out of the COVID vaccines, as much as 40%. This would put the US on track for 1.4 million more deaths of all causes than usual by the end of 2022. Normally about 3 million people die in the US every year.

German Pathologists' Findings Square with Other Pathologists

Dr. Burkhardt's and Dr. Lang's findings are similar to those of other pathologists. The UK Daily Expose writes:

"The director of the Pathological Institute of the University of Heidelberg, Peter Schirmacher, has carried out over forty autopsies on people who died within two weeks of receiving a Covid-19 vaccine and has <u>expressed alarm over his findings</u>. Schirmacher stated that 30 to 40 per cent of people he examined died from the vaccine and that in his opinion, the frequency of fatal consequences of vaccinations is "underestimated."...He has warned that the high number of unreported cases of vaccination deaths is partially due to the fact that "pathologists do not notice anything about most of the patients who die after and possible from a vaccination."

German News Site <u>Augsburg General</u> (right-click to use Google translate from German to English):

"The doctor now wants to get to the bottom of the rare, serious side effects of vaccination – such as cerebral vein thrombosis or autoimmune diseases. The problem from his point of view: Vaccinated people usually do not die under clinical observation. "The doctor examining the corpse does not establish any context with the vaccination and certifies a natural death and the patient is buried," reports Schirmacher. "Or he certifies an unclear manner of death and the public prosecutor sees no third-party fault and releases the body for burial.""

The UK Daily Expose:

"Despite the criticism, Schirmacher did receive support from his own ranks, and the Federal Association of German Pathologists stated that more autopsies of vaccinated people who died within a certain time frame after vaccination should be performed....The Federal Association of Pathologists already requested this in March in a letter to Health Minister Jens Spahn (CDU), but it went unanswered."

Another pathologist, <u>Dr. Ryan Cole, MD</u>, who holds medical degrees from Virginia Commonwealth University School of Medicine and the Mayo Clinic School of Medicine, has made similar warnings about the vaccines. Dr. Cole shows his own lab evidence that Pfizer and Moderna mRNA spike protein injections may be quietly killing injection recipients through "micro-clots," inflammation, and immune suppression.

Doctors for COVID Ethics last April sent letters to all members of European parliaments who were mandating the experimental vaccinations that they are committing Crimes Against Humanity. The average time for bringing any new drug or vaccine to general use is 10 years, including typically three to six years of animal trials before human testing.

In June of 2021, enlisting the aid of certain doctors and scientists, the media launched <u>into attack mode immediately</u> after a Canadian immunologist warned that the Pfizer/Moderna injections might pose a danger to the body's organs, in particular the heart, brain, and through blood clotting issues.

The immunologist, <u>Professor Dr. Byram Bridle, said</u> in an interview in May 2021 that data led him to conclude that **"We made a big mistake"** by rushing the drugs into mass circulation. Dr. <u>Bridle had just received a \$230,000</u> grant for coronavirus vaccine development.

Soon, the Internet was rife with "debunks" of Dr. Bridle's concerns. A <u>Reuters "fact</u> <u>check</u>" proclaimed *"There is no proof that spike proteins created in response to mRNA vaccines are harmful to the body, scientists have told Reuters."*

An anonymous Internet user even created a website using Dr. Bridle's name, <u>ByramBridle.com</u>, and made the doctor and immunology professor out to be a

"quack." Thus an all-out campaign with unknown funding sources was at work smearing Dr. Bridle.

Dr. Bridle's concerns were echoed by <u>Dr. Robert Malone, one of the inventors of the</u> mRNA technology now being used by Pfizer and Moderna. Dr. Malone said that, prior to the drugs' emergency authorization use approvals, the <u>FDA knew of these</u> risks, because he himself had told them. 
Dr. Lang Resigns from Professional Association Citing "Corruption" and Cover-Up

In the December 4th presentation of the series, the pathologists said they had shown their findings to the leaders of their professional organizations, but had encountered what could only be described as "corruption." Professor Dr. Walter Lang showed his letter of resignation from the German Pathological Association, of which he was an early member, in protest of this "corruption."

Dr. Lang concluded that the leader of the group was interested only in "burying" his findings, *"along with the dead."*



In closing an interview of pathologist Dr. Burkhardt this February, 2022, <u>Dr. Sucharit</u> <u>Bhakdi said:</u>





French Attorney Working with Reiner Fuellmich Arrested and Released, is Working on Crimes Against Humanity Charges Against Bill Gates, Fauci, Schwab, Others
