Freemasons Acclaim Pope's New Encyclical



Pope Francis' new [encyclical](#), *Fratelli Tutti*, embodies one of the guiding principles of Freemasonry — this according to Spain's main Masonic lodge, the Gran Logia de España.

In a statement this week, the Gran Logia proclaimed that, in the 300 years of modern Freemasonry, it has been based on a *"universal fraternity of human beings who call each other brothers and sisters despite their respective creeds, ideologies, skin color, social background, language, culture or nationality."* This principle, the statement read, clashed with *"religious fundamentalism"* on the part of the Catholic Church, which *"issued severe texts condemning the toleration of Freemasonry in the 19th century."*

The statement claimed that the pope's most recent encyclical "demonstrates how far away the present Catholic Church is from its former positions. In *Fratelli Tutti*, the pope embraces Universal Fraternity: the great principle of modern Freemasonry." The Catholic Church and Freemasonry have long been at odds, given their very distinct philosophical and theological differences.

The statement quoted a relevant passage by the pope in the [encyclical](#): "It is my desire that, in this our time, by acknowledging the dignity of each human person, we can contribute to the rebirth of a universal aspiration to fraternity. Fraternity between all men and women."

In *Fratelli Tutti*, the pope embraces Universal Fraternity: the great principle of modern Freemasonry.

The pope [quoted](#) St. Francis of Assisi, who once said that a Christian should love his neighbor *"as much when he is far away from him as when he is with him."*

The statement from the Freemasons cited the pope's tribute to the saint: *"In his simple and direct way, Saint Francis expressed the essence of a fraternal openness that allows us to acknowledge, appreciate and love each person, regardless of physical proximity, regardless of where he or she was born or lives."*

What the encyclical and its Freemasonic cheerleaders ignore is that St. Francis actually sought conversions of nonbelievers to Christianity, even to the extent of martyrdom.

The Freemasons' statement went on to say of the encyclical, *"The letter addresses the disintegrating role of the digital world, whose operation favors closed circuits of people who think the same way and facilitates the spread of false news that encourages prejudice and hatred."*

The statement quoted Francis' encyclical:

We should also recognize that destructive forms of fanaticism are at times found among religious believers, including Christians; they too *"can be caught up in networks of*

verbal violence through the internet and the various forums of digital communication. Even in Catholic media, limits can be overstepped, defamation and slander can become commonplace, and all ethical standards and respect for the good name of others can be abandoned." How can this contribute to the fraternity that our common Father asks of us?

As various comments have **reported**, the encyclical refrains from mentioning "evangelization" or the "proclamation of the gospel" and instead brandishes its own breed of fanaticism — the Marxist Left's repeated pronouncements on migration, markets, populism, nationalism, redistribution of wealth, private property and the death penalty, among others. Globalists are also leveraging the encyclical with the help of Marxist clergy to push for women clergy — "structures" that they feel must be altered in step with its "teaching and morals" in pursuit of a "revolution."

Already, feminists have attacked the encyclical for its "sexist" title.

At least one theologian has warned that encyclicals not in step with Scripture and Tradition **risk eroding the trust of the faithful** in the ordinary Magisterium — a demolition that has **long been the goal** of Freemasonry.

Growing Acceptance of Freemasonry

Freemasonry has achieved greater acceptance in Spain, and elsewhere in Europe, in recent years. As noted by the Freemason's Spanish website, the Spanish dictator Francisco Franco had a dim view of Freemasonry. Principal political leaders of the Spanish Republic, including government cabinet members, were Freemasons who contributed to stripping Catholic religious orders of property and eliminating Catholic education in state schools, for example, during a period when anarchists, communists and others were murdering priests, as well as male and female religious.

Following his 1939 victory over anarchists, socialists, libertarians, atheists and communists in the fratricidal civil war that overthrew the Spanish Republic, Franco outlawed Freemasonry. Apologists for the secret society contend that it had merely wished to establish democracy in Spain, however. Historian Manuel Según Alonso claimed in a Spanish television interview with La Sexta that Franco hated Freemasonry for that reason. Freemasonry has been legal in Spain for the last 40 years.

As an expert on Freemasonry, Según Alonso told La Sexta: *"Franco proclaimed that Masonry sought to subjugate nations by using democracy as a means."* Following the Spanish civil war, Según Alonso said, *"Many Freemasons went into exile. Those who were left were subject to the Special Tribunal for the Repression of Freemasonry and Communism."*

While Franco wanted to subject captured Freemasons to the death penalty, the historian claimed that an appeal by the American ambassador at the time convinced the dictator to reduce the penalty to 30 years imprisonment. Franco was one of the most enduring European leaders of the 20th century. He died in 1975.

The legislature of Galicia, one of the autonomous regions of Spain, declared unanimously in February 2019 its support for the "honorability" of Freemasonry. Galicia thus became the second of Spain's various regions to declare its support, following the lead of numerous city councils.

Elsewhere in Europe, Freemasonry garnered support from at least one religious figure. Chief rabbi Riccardo Di Segni visited with Stefano Bisi, the Grand Master of the Great Orient of Italy. Speaking in January 2019, said that the Order has been a place to *"express a new conception, which merged the ideas of equality, freedom, progress and even a different form of spirituality."*

The rabbi said that it has prevented the revival of the theories of a Judeo-Masonic conspiracy, which he claimed that fascist European governments made their own in the 20th century in promoting anti-Semitism and opposition to Freemasonry. He said that that it had its origins *"during the second half of the 19th century within the Catholic Church, which represented the soul and the justification of of the ancien régime," before the French Revolution, when "freedom and emancipation were making their way."*

However, the rabbi stressed that *"the Church has changed profoundly,"* even while expressing concern over the possible rebirth of anti-Semitism and anti-Masonic ideas.

The Popes Speak on Freemasonry

Historically, several popes have denounced Freemasonry as antithetical to the Faith. Since 1738 and the publication of *In Eminenti Apostolatus*, Catholics are prohibited from joining. Some confusion has clouded the minds of Catholics since then, however. While a 1983 change in canon law appeared to eliminate excommunication as a penalty for membership, Cdl. Joseph Ratzinger (the future Pope Benedict XVI) wrote that anyone who enrolls in Masonry is in a state of grave sin and may not receive Holy Communion.

Over 100 years ago, Pope Leo XIII addressed the supposed aims of Freemasons. In *Humanum Genus*, the Pope asserted that Freemasonry's *"fundamental doctrine ... is that human nature and human reason ought in all things to be mistress and guide,"* which means that *"they deny that anything has been taught by God; they allow no dogma of religion or truth which cannot be understood by the human intelligence, nor any teacher who ought to be believed by reason of his authority."*

"And since it is the special and exclusive duty of the Catholic Church fully to set forth in words truths divinely received, to teach, besides other divine helps to salvation, the authority of its office, and to defend the same with perfect purity, it is against the Church that the rage and attack of the enemies are principally directed."

The title of chapter XXXV of *'Codeword Barbelon'* is "Novus Ordo Seclorum: A Jesuit-Masonic Enterprise" The world is oblivious to the larger agend that brings together the

Jesuits and Freemasonry. As an aside to the global crisis that has brought immense wealth to the Rothschild's and the world elite, you should know that the elite of the 0.001% of the world has been sheared of \$590-billion dollars of profits from the suffering and pain brought to the world's masses.

James 5:3 has something to say regarding their illgot wealth. ***"Your gold and silver is cankered; and the rust of them shall be a witness against you, and shall eat your flesh as it were fire. Ye have heaped treasure together for the last days."*** -(James 5:3). Their silver and gold would lose their value. They would become as worthless as thoroughly rusted iron. In the Day of Judgment, whatever the nature of the wealth possessed, it would have absolutely no positive value. In fact, the wealth they had dishonestly acquired and selfishly hoarded, and which they valued so highly, would become a witness against them in the Day of Judgment. It would insure their condemnation and intensify the fires of judgment (see Romans 2:5). Only treasures of righteousness will stand the test.

"Ye have heaped treasure together for the last days" reads *"in the last days"* in a few translations. At a time when people should be laying up treasures in heaven -(Matthew 6:19-21), they were spending time and effort to accumulate inappropriate wealth to live in selfish extravagance. In those days there were no labor laws, and the rich often treated workers very unfairly. It appears they had cheated these people out of their just wages. Now, like the blood of Abel -(Genesis 4:10), which cried out for vengeance, the defrauded wages in a sense cried out for condemnation of the rich. A just God would not ignore the cry that came from the defrauded workers and defrauded wages. This is why those who had obtained their riches in a way that was illegitimate should weep, because they can anticipate certain judgment -(James 5:1-3).

"Saba-oth" is a transliteration from the Hebrew and means "hosts." It is a powerful expression of God's omnipotence. In the Old Testament He was seen not only as the God of Israel's army, but of heavenly bodies and angelic forces -(Judges 5:20; 2nd Kings 6:17).

Students of the Bible somehow miss the prophecy revealed in the book of James. While it is intended for the Jews of the Tribulation period, it allows the believer in Jesus Christ a view of what is in store for these religious frauds. James says, ***"Ye have lived in pleasure on the earth and been wanton."*** Weymouth translates this sentence, ***"Here on earth you have lived self-indulgent and profligate lives."*** The living here on earth is in sharp contrast with what these people will face at the judgment. Without concern about life after death, these rich people lived in selfish luxury. "Wanton" suggests waste. Like the Prodigal Son, they squandered their substance -(Luke 15:13) rather than administering it judiciously as a stewardship.

Some understand ***"ye have nourished your hearts, as in a day of slaughter"*** to mean unrestrained feasting after a victorious battle. Others, like the RV, omit the word ***"as"*** and understand the ***"day of slaughter"*** as the Day of Judgment and in contrast to ***"on the earth."*** The rich, by presumptuous, unrestrained living, were preparing

themselves for the Day of Judgment like animals gorging themselves for the day of slaughter. The rich were not satisfied with cheating workers out of their wages. They went so far as to use their influence to condemn and kill righteous people in violation of God's command not to pervert justice -(Exodus 23:6; Deuteronomy 24:17). Some who were wrongfully drawn "**before the judgment seats**" (2:6) were through harsh treatment put to death.

The situation of the poor was so hopeless that they could not or would not resist those who mistreated them. It is possible that they reacted according to the guidance of Paul in Romans 12:19: "**Avenge not yourselves.**" God would avenge them. Over the years the House of Rothchild have exploited the masses, stealing them blind, relentlessly!

The Greek word translated "**be patient**" (**makrothumēate**) basically means "be longsuffering." Just as God suffers long with difficult people -(Psalm 86:15; Jonah 4:2; 2nd Peter 3:9), believers are to do likewise -(1st Thessalonians 5:14). Long-suffering is a fruit of the Spirit -(Galatians 5:22). I would agree that this is perhaps one of the hardest things to do when we know the history of these magots.

Believers were assured that oppression would not continue indefinitely. The coming of the Lord would bring about a change. The second coming of Christ is a "**blessed hope**" for believers -(Titus 2:13) and a source of comfort -(1st Thessalonians 4:18).

His skeleton over the HIV/AIDS corruption is awaiting full disclosure. Many have challenged Dr. Fauci's mis-branding Chronic Fatigue Syndrom as AIDS. Dr. Fauci is not simply a government bureaucrat, he oversees a massive bureaucracy made up of 10 branches pushing the Tony Fauci story. In research, it is common understanding that you do not cross Dr. Fauci if you want government grant money. AIDS was Dr. Fauci's claim to fame. Since 1984, Dr. Fauci has received a half-trillion dollars for the purpose of finding a cure for AIDS, and we have yet to learn of a cure of AIDS. In 1984, Dr. Fauci promised a cure for AIDS! Dr. Fauci controls the AIDS playbook today. Dr. Fauci exploited the HIV using the

Dr. Collins also is leading the charge to blind naïve evangelicals to the dangers of the vaccination agenda through his organization Biologos.^[5] They seek to nullify the Biblical interpretation of Genesis and replace it with modern revisionist theory of evolution.^[6]

If their efforts succeed, the consequences for Bible believers in various nations could be grave. Hence, it is necessary to analyze the other two major players. Are the similarities between Fauci and Francis mere coincidence? Or do they reflect a larger and ominous agenda?

The Jesuit Education of Dr. Anthony Fauci

Dr. Anthony Fauci is the director of the National Institute of Allergy and Infectious Diseases, a position he has held since 1984.^[7] He has been intimately involved in public affairs and policy for the past six presidential administrations.

Fauci's role has expanded significantly to being a player in Operation Warp Speed, the campaign to rapidly develop a vaccine against COVID.^[8]

Fauci has also been a player on the global stage as a member of the Leadership Council for nearly a decade. "The World Health Organization, UNICEF, the National institute of Allergy and Infectious Diseases and the Bill & Melinda Gates Foundation have announced a collaboration to increase coordination across the international vaccine community and create a Global Vaccine Action Plan."^[9]

Fewer people know that Dr. Anthony Fauci is a poster boy for the Roman Catholic Jesuit educational system. His academic curriculum vitae spans nearly two decades. Starting with Our Lady of Guadeloupe Grammar School in Brooklyn, NY, Fauci continued his [Jesuit indoctrination at Regis High School](#),^[10] a no-tuition Jesuit college-prep school on New York City's Upper East Side. He credits this Jesuit education for getting him to where he is today.

["I went to Regis High School, a Jesuit high school, which had a major impact on my career even up to today."](#)^[11]

"Fauci often credits part of his professional success to the inculcation of [Jesuit intellectual rigor](#) that was a core part of his education: an emphasis on organization and logic, on succinctness and clarity of expression. Arguably, the twinning of science and the humanities has proved useful in his dual roles as physician and researcher as well... He graduated from the [College of the Holy Cross](#) in Massachusetts, said to be the oldest Catholic [Jesuit] college in New England, where he received a bachelor's degree in the classics."^[12]

“I take great comfort in knowing that when he speaks that he is speaking the truth and nothing but the truth,” Jesuit Fr. Daniel Lahart, Regis’ president, told NCR. [\[13\]](#)

Should this give you “great comfort”?

This is a fascinating comment, especially when one realizes that Fauci has equivocated and even contradicted himself on several occasions in a matter of weeks! Merely ascribing it to changes in *“the data”* or *“the science”* does not whitewash Fauci’s equivocation.

Dr. Fauci Equivocates on Masks

Masks: to wear or not to wear? Dr. Fauci appeared on the national news program “60 Minutes” on March 6, 2020. He unequivocally declared:

“Right now, in the United States, people should not be walking around with masks.’ Upon the interviewer challenging him with the question, ‘You’re sure? Because people are listening really closely to this,’ Dr. Fauci responds. ‘No, there’s no reason to be wearing a mask. When you’re in the middle of an outbreak, wearing a mask might make people feel a bit better, and it might even block a droplet, but it’s not providing the perfect protection that people think that it is, and often there are unintended consequences – people keep fiddling with the masks and they’re touching their face.” [\[14\]](#)

However, only 1 month later, Dr. Fauci contradicted himself and urged Americans to wear masks. [\[15\]](#) Fauci’s change in mind had nothing to do with any new facts about the efficacy of masks at all! Rather he rationalized his lying by saying he had to protect mask supplies for medical workers. [\[16\]](#)

Yet, the prestigious *New England Journal of Medicine* in its May 21, 2020 issue still believed masks for most people are useless!

“We know that wearing a mask outside health care facilities offers little, if any, protection from infection. Public health authorities define a significant exposure to Covid-19 as face-to-face contact within 6 feet with a patient with symptomatic Covid-19 that is sustained for at least a few minutes (and some say more than 10 minutes or even 30 minutes). **The chance of catching Covid-19 from a passing interaction in a public space is therefore minimal.** In many cases, the desire for widespread masking is a reflexive reaction to anxiety over the pandemic.” [\[17\]](#)

It is also noteworthy that Dr. Fauci does not even follow his own prescription consistently. He neglected to wear his mask while watching a baseball game. [\[18\]](#)

Do riots and public protests spread contagion of COVID?

Dr. Fauci warned of a potential spike in cases on June 7. [\[19\]](#)

Yet again, barely 2 months later, Fauci changed his tune.

Before a Congressional hearing on July 31, Dr. Fauci was asked by Representative Jim Jordan about whether riots and protests in US cities following the murder of George Floyd could spread the contagion of COVID and necessitate potential government crackdown. Dr. Fauci equivocated and refused to answer.

James Gagliano, a retired FBI officer and CNN analyst, remarked:

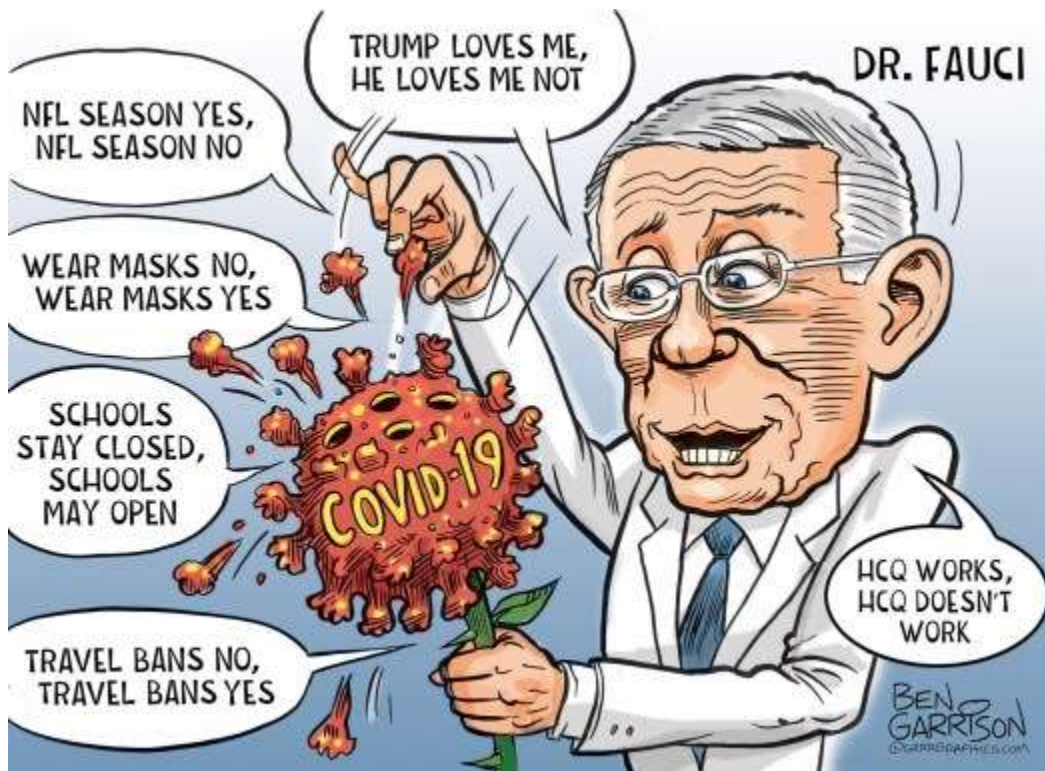
“Stunning response from an infectious disease expert whom I have been supportive. You can’t be loquacious and willing to weigh in on EVERY aspect of American society (dating apps, baseball, etc.) during the pandemic, and suddenly fall mute when questioned about organized protests.” [\[20\]](#)

Dr. Fauci’s equivocation resembles the quizzical response of Pope Francis to a question on whether homosexuality is sin: *“Who am I to judge?”* [\[21\]](#)

Time does not permit review of Dr. Fauci’s equivocation on a host of other issues: the severity and duration of the COVID crisis, the efficacy of hydroxychloroquine treatment, and the effectiveness of lockdowns. [\[22\]](#)

Indeed, Jesuit moral theology justifies lying, “equivocation”, and perjury if the liar believes it will advance a “greater cause”. [\[23\]](#)

[Daniel Lahart](#), president of Regis High School and Jesuit, said this about Dr. Fauci: “He’s got a relatively good poker face. But not all of the time.”^[24] Let the discerning reader call Dr. Fauci’s bluff.



The Jesuit Agenda of Pope Francis “in the Age of Pandemic”

What in the world does Pope Francis have to do with the coronavirus? In fact, the Jesuit Pope has much to say! He also employs a whole army of clerics and academics to speak on his behalf.

Francis wants any vaccine to prioritize the poor.^[25] On the surface, that position appears noble. Yet, deeper examination reveals that Pope Francis has a broader and more ambitious agenda.

On July 27, 2020, the Pontifical Academy for Life put out an encyclical entitled “*Humana Communitas in the Age of Pandemic*”.^[26] The Academy advises the Vatican on bioethics. The letter itself addresses lessons to be learned from the crisis and prescribes improvements in global society and government.

Pope Francis named Archbishop Vincenzo Paglia head of the Academy in 2016.^[27] Like his benefactor, Paglia holds positions contrary to the Bible beyond the false gospel of Rome. As former head of the Pontifical Institute on the Family, Paglia introduced Catholic sex education materials inviting youth to imbibe movies with explicit content at the World Youth Day in Poland in 2016.^[28]

The letter “*Humana Communitas in the Age of Pandemic*” continues a letter written by Pope Francis a year ago. The Pope’s original letter “*Humana Communitas*” observes the 25th anniversary of the Academy and reminds it of its purpose in the 21st century. He makes a rather curious statement:

“...that **science and technology**, at the service of the human person and his fundamental rights, **contribute to the overall good of man and to the fulfillment of the divine plan of salvation.**’ (Saint John Paul II, *Motu Proprio Vitae Mysterium* [11 February 1994]).” [29]

In affirming the error of a previous Pope, Jesuit Pope Francis also denies the truth of “the divine plan of salvation”. Christ has already and perfectly fulfilled God’s plan!

“For **Christ is the end of the law for righteousness to every one that believeth.**” [30]
“Think not that **I am come to destroy the law, or the prophets: I am not come to destroy, but to fulfil.**” [31]

Beyond denying the complete and perfect atonement of Christ, Pope Francis also exalts an opposing philosophy called “**Progressivism**”. This belief posits that human progress will lead to “paradise on earth” and the perfection of man. [32]

The letter “*Humana Communitas in the Age of Pandemic*” further prepares the reader to “a **conversion of thought and action** to be experienced **in our common responsibility** for the human family...” [33]

This word choice is deliberate. The letter demands obedience to what the Academy (the Pope) commands. “*Conversion of thought*” involves changing what the reader knows in exchange for what Rome tells you to believe, regardless of reality. The motive is “our common responsibility” strongly echoes “the common good” [34] where the rights, including property, are placed second to the interests of the collective, whose head naturally is the Papal See.

This idea is repeated again: “*With the pandemic, our claims to autonomous self-determination and control have come to a sobering halt, a moment of crisis that elicits deeper discernment.*” [35] In other words, stop thinking independently of Rome and use “discernment”, the first “*Universal Apostolic Preference*” of the Jesuit order. [36]

In what areas does Jesuit Pope Francis wish us to convert our thinking? [37]

1. Environmentalism

“The Covid-19 epidemic has much to do with our depredation of the earth and the despoiling of its intrinsic value. It is a symptom of our earth’s malaise and our failure to care; more, a sign of *our own* spiritual malaise (*Laudato Si*, n. 119).” (1.2)

“Will we be able to remedy the fracture that has separated us from our natural world... a menace to one another? Consider the chain of connections that link the following

phenomena: increasing deforestation pushes wild animals in the proximity of human habitat... The exaggerated demand for meat in first world countries gives rise to enormous industrial complexes of animal farming and exploitation..." (1.2)

2. Open borders (Loss of National Sovereignty)

"...efforts in *international cooperation*. In this context, a privileged place belongs to the World Health Organization (WHO)." (2.2)

"The narrow mindedness of national self-interests has led many countries to vindicate for themselves a policy of independence and isolation from the rest of the world, as if a pandemic could be faced without a coordinated global strategy." (2.2)

3. Economics

"For sure, in all countries the *common good of public health* needs to be balanced against economic interests." (1.3)

"The contrast between the two situations throws into relief a strident paradox, recounting, once more, the tale of disproportion in wealth between poor and rich countries." (1.2)

"As a duty, solidarity does not come for free, without cost and the readiness of the rich countries to pay the price required by the call for the survival of the poor and the sustainability of the entire planet." (2.3)

"The dream recently envisaged for the Amazon region might become a universal dream, a dream for the whole planet to "integrate and promote all its inhabitants, enabling them to enjoy 'good living'" (*Querida Amazonia*, 8)." (2.3)

4. Social Justice

"Access to quality health care and to essential medicines must be effectively recognized as a universal human right (cfr. *Universal Declaration on Bioethics and Human Rights*, art. 14)." (2.2)

"At the same time, we need to flesh out a concept of *solidarity* that extends beyond generic commitment to helping those who are suffering. A pandemic urges all of us to address and reshape structural dimensions of our global community that are oppressive and unjust, those that a faith understanding refers to as "structures of sin". The common good of the *humana communitas* cannot be had without a real conversion of minds and hearts (*Laudato si'*, 217-221). A call for *conversion* is addressed to our responsibility: its shortsightedness is imputable to our unwillingness to look the vulnerability of weakest populations at a global level..." (2.2)

Conclusion: We Need to Discern the Truth of Christ from False Jesuit Science

Dr. Fauci and Pope Francis flock together like "birds of a feather". Though in different hemispheres, both come from a similar Jesuit background. Both mask their service of the Roman Jesuit agenda. Both aspire to "reshape structural dimensions" of our "oppressive and unjust" society through "conversion".

The fruits of “Jesuit science” are obvious. Coercion to take an unproven vaccine,[\[38\]](#) economic depression[\[39\]](#) and social disintegration[\[40\]](#) from lockdowns, and official repression of church gatherings[\[41\]](#) (in contrast with leniency for violent riots)[\[42\]](#) manifest a far greater plan than merely curing a virus.

The Jesuit Vatican is unquestionably is a third-part of the triad that we commonly call the "Illuminati" or the New World Order. C.J. One of the hallmarks of totalitarianism is mass conformity to a psychotic official narrative. Not a regular official narrative, like the "Cold War" or the "War on Terror" narratives. A totally delusional official narrative that has little or no connection to reality and that is contradicted by a preponderance of facts.

Nazism and Stalinism are the classic examples, but the phenomenon is better observed in cults and other sub-cultural societal groups. Numerous examples will spring to mind: the Manson family, Jim Jones' People's Temple, the Church of Scientology, Heavens Gate, etc., each with its own psychotic official narrative: Helter Skelter, Christian Communism, Xenu and the Galactic Confederacy, and so on.

Looking in from the dominant culture (or back through time in the case of the Nazis), the delusional nature of these official narratives is glaringly obvious to most rational people.

What many people fail to understand is that to those who fall prey to them (whether individual cult members or entire totalitarian societies) such narratives do not register as psychotic. On the contrary, they feel entirely normal. Everything in their social "reality" reifies and reaffirms the narrative, and anything that challenges or contradicts it is perceived as an existential threat.

These narratives are invariably paranoid, portraying the cult as threatened or persecuted by an evil enemy or antagonistic force which only unquestioning conformity to the cult's ideology can save its members from. It makes little difference whether this antagonist is mainstream culture, body thetans, counter-revolutionaries, Jews, or a virus. The point is not the identity of the enemy. **The point is the atmosphere of paranoia and hysteria the official narrative generates, which keeps the cult members (or the society) compliant.**

In addition to being paranoid, these narratives are often internally inconsistent, illogical, and ... well, just completely ridiculous. This does not weaken them, as one might suspect. Actually, it increases their power, as it forces their adherents to attempt to reconcile their inconsistency and irrationality, and in many cases utter absurdity, in order to remain in good standing with the cult. Such reconciliation is of course impossible, and causes the cult members' minds to short circuit and abandon any semblance of critical thinking, which is precisely what the cult leader wants.

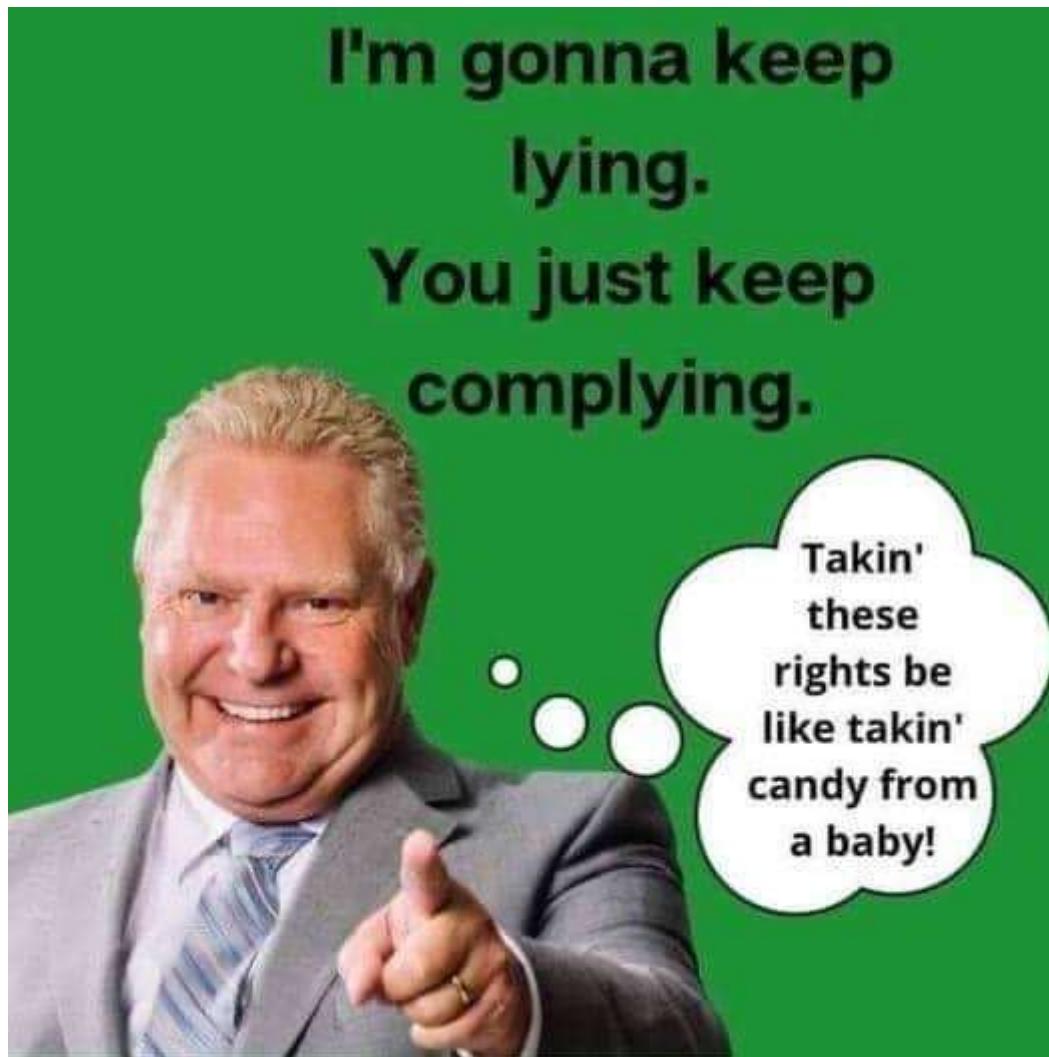
Moreover, cult leaders will often radically change these narratives for no apparent reason, forcing their cult members to abruptly forswear (and often even denounce as "heresy") the beliefs they had previously been forced to profess, and behave as if they had never believed them, which causes their minds to further short circuit, until they eventually give up even trying to think rationally, and just mindlessly parrot whatever nonsensical gibberish the cult leader fills their heads with.

Also, the cult leader's nonsensical gibberish is not as nonsensical as it may seem at first. Most of us, upon encountering such gibberish, assume that the cult leader is trying to communicate, and that something is very wrong with his brain. The cult leader isn't trying to communicate. He is trying to disorient and control the listener's mind. Listen to [Charlie Manson "rapping."](#) Not just to what he says, but *how he says it*. Note how he sprinkles bits of truth into his stream of free-associated nonsense, and his repetitive use of thought-terminating clichés, described by Robert J. Lifton as follows:

"The language of the totalist environment is characterized by the thought-terminating cliché. The most far-reaching and complex of human problems are compressed into brief, highly selective, definitive-sounding phrases, easily memorized and easily expressed. They become the start and finish of any ideological analysis." — *Thought Reform and the Psychology of Totalism: A Study of "Brainwashing" in China*, 1961

If all this sounds familiar, good. Because the same techniques that most cult leaders use to control the minds of the members of their cults are used by totalitarian systems to

control the minds of entire societies: Milieu Control, Loaded Language, Sacred Science, Demand for Purity, and other standard mind-control techniques. It can happen to pretty much any society, just as anyone can fall prey to a cult, given the right set of circumstances.



It is happening to most of our societies right now. An official narrative is being implemented. **A totalitarian official narrative. A totally psychotic official narrative, no less delusional than that of the Nazis, or the Manson family, or any other cult.**

Most people cannot see that it is happening, for the simple reason that it is happening to them. They are literally unable to recognize it. The human mind is extremely resilient and inventive when it is pushed past its limits. Ask anyone who has struggled with psychosis or has taken too much LSD. We do not recognize when we are going insane. When reality falls apart completely, the mind will create a delusional narrative, which appears just as "real" as our normal reality, because even a delusion is better than the stark raving terror of utter chaos.

This is what totalitarians and cult leaders count on, and exploit to implant their narratives in our minds, and why actual initiation rituals (as opposed to purely symbolic rituals) begin by attacking the subject's mind with terror, pain, physical exhaustion, psychedelic drugs, or some other means of obliterating the subject's perception of reality. Once that is achieved, and the subject's mind starts desperately trying to construct a new narrative to make sense out of the cognitive chaos and psychological trauma it is undergoing, it is relatively easy to "guide" that process and implant whatever narrative you want, assuming you have done your homework.

And this is why so many people — people who are able to easily recognize totalitarianism in cults and foreign countries — **cannot perceive the totalitarianism that is taking shape now, right in front of their faces (or, rather, right inside their minds). Nor can they perceive the delusional nature of the official "Covid-19" narrative, no more than those in Nazi Germany were able to perceive how completely delusional their official "master race" narrative was.** Such people are neither ignorant nor stupid. They have been successfully initiated into a cult, which is essentially what totalitarianism is, albeit on a societal scale.

Their initiation into the Covidian Cult began in January, when the medical authorities and corporate media turned on The Fear with [projections of hundreds of millions of deaths](#) and [fake photos of people dropping dead in the streets](#). The psychological conditioning has continued for months. **The global masses have been subjected to a constant stream of propaganda, manufactured hysteria, wild speculation, conflicting directives, exaggerations, lies, and tawdry theatrical effects. Lockdowns. Emergency field hospitals and morgues. The singing-dancing NHS staff. Death trucks. Overflowing ICUs. Dead Covid babies. Manipulated statistics. Goon squads. Masks. And all the rest of it.**

Eight months later, here we are. The Head of the Health Emergencies Program at the **WHO has basically confirmed [an IFR of 0.14%](#), approximately the same as the seasonal flu.** And here are [the latest survival rate estimates](#) from the Center for Disease Control:

- Age 0-19 ... 99.997%
- Age 20-49 ... 99.98%
- Age 50-69 ... 99.5%
- Age 70+ ... 94.6%

The "science" argument is officially over. An increasing number of doctors and medical experts are breaking ranks and explaining how the current mass hysteria over "cases" (which now includes perfectly healthy people) is essentially meaningless propaganda, for example, [in this segment on ARD](#), one of the big mainstream German TV channels.

And then there is the existence of Sweden and other countries which are not playing ball with the official Covid-19 narrative, which makes a mockery of the ongoing hysteria.

I'm not going to go on debunking the narrative. **The point is, the facts are all available. Not from "conspiracy theorist" websites. From mainstream outlets and medical experts. From the Centers for Fu&ki#g Disease Control.**

Which does not matter in the least, not to the members of the Covidian Cult. **Facts do not matter to totalitarians and cult members. What matters is loyalty to the cult or the party.**

Which means we have a serious problem, those of us to whom facts still matter, and who have been trying to use them to convince the Covidian cultists that they are wrong about the virus ... for going on eight months at this point.

While it is crucial to continue reporting the facts and sharing them with as many people as possible — which is becoming increasingly difficult due to the censorship of alternative and social media — it is important to accept what we are up against. **What we are up against is not a misunderstanding or a rational argument over scientific facts. It is a fanatical ideological movement. A global totalitarian movement ... the first of its kind in human history.**

It isn't national totalitarianism, because we're living in a global capitalist empire, which isn't ruled by nation-states, but rather, by supranational entities and the global capitalist system itself. And thus, the cult/culture paradigm has been inverted. **Instead of the cult existing as an island within the dominant culture, *the cult has become the dominant culture*, and those of us who have not joined the cult have become the isolated islands within it.**

I wish I could be more optimistic, and maybe offer some sort of plan of action, but the only historical parallel I can think of is how Christianity "converted" the pagan world ... which doesn't really bode so well for us. While you're sitting at home during the "second wave" lockdowns, you might want to brush up on that history.

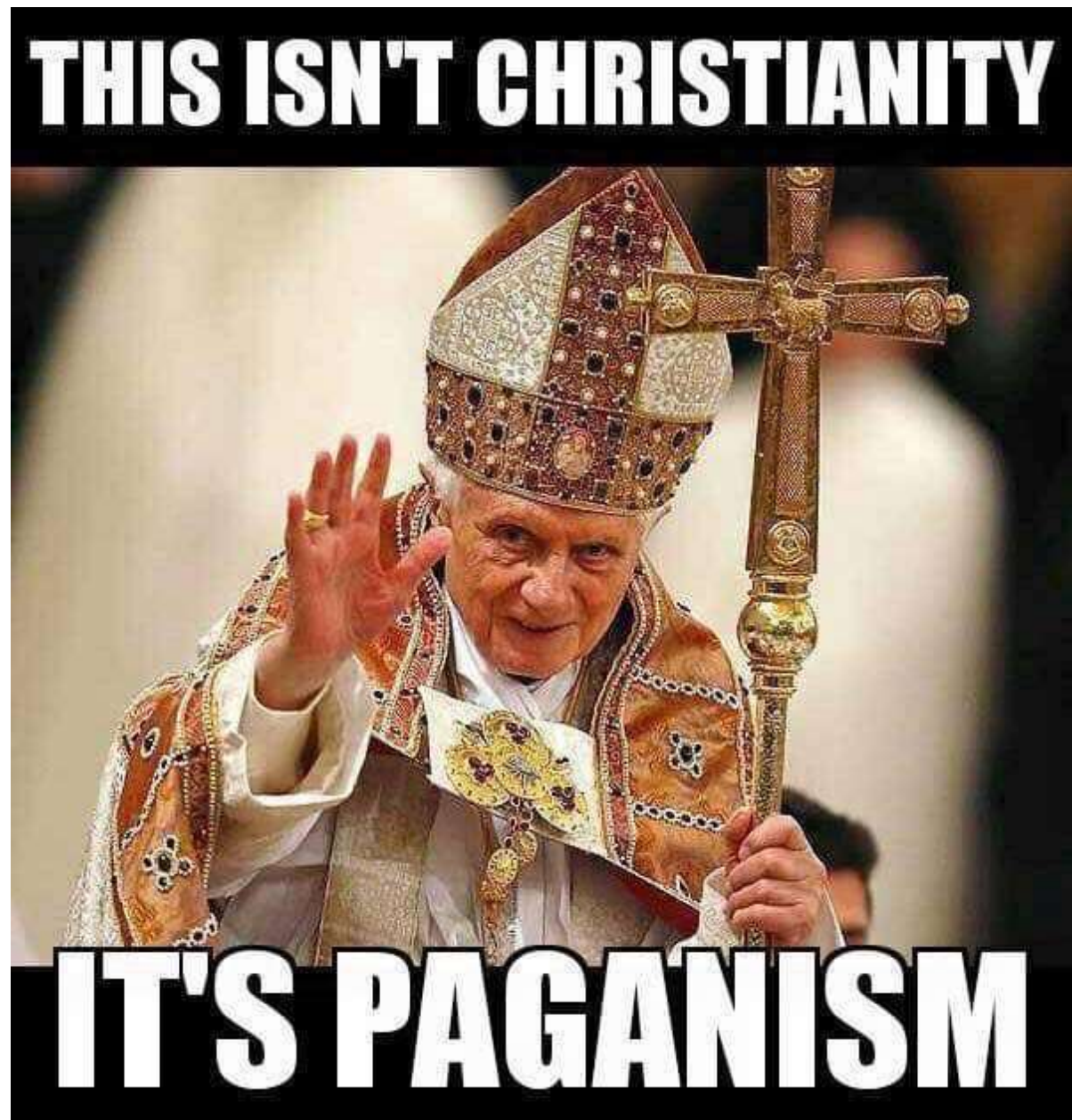

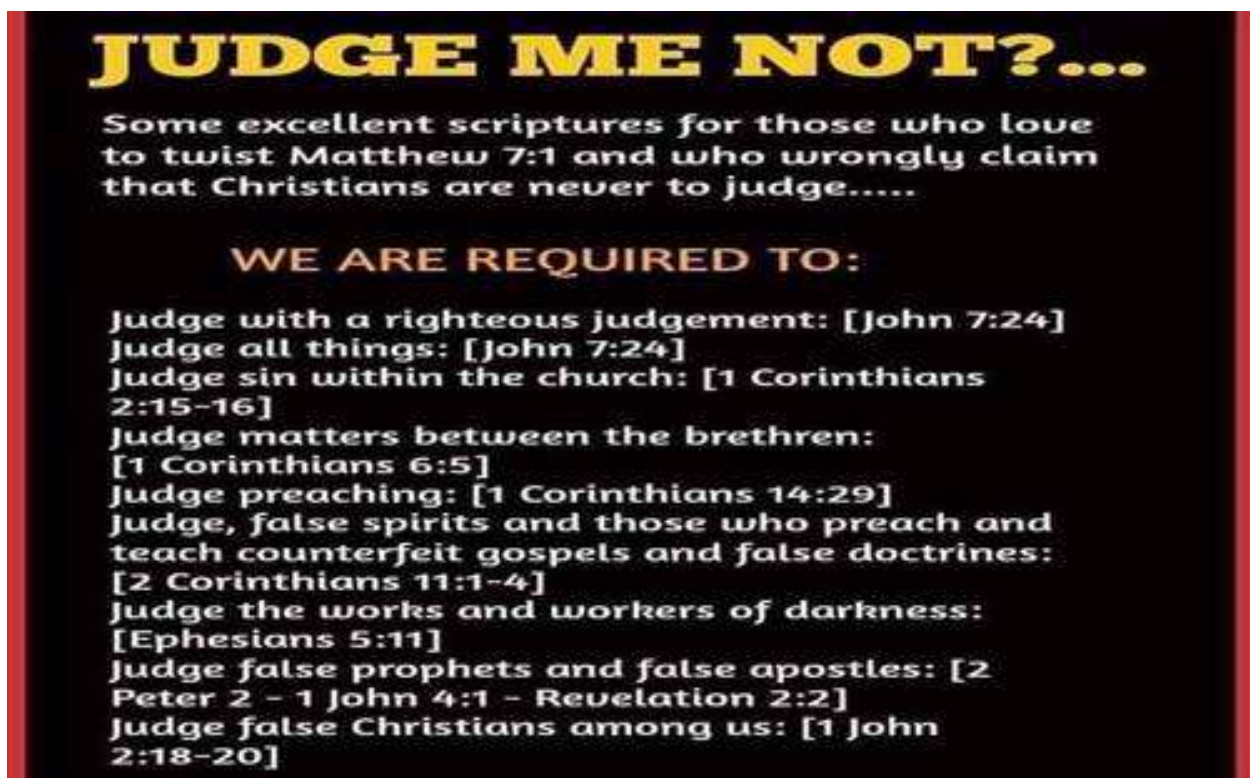
And that’s just to ask the Supreme Court to hear the case. If the justices agree, which they rarely do, then we’re talking really big numbers. “About the cheapest you can get
