

Voices of Truth in the Wilderness

Until recently, Dr. Christiane Northrup was a rock star of the Liberal media, with three *New York Times* Bestsellers, 10 appearances on *Oprah!* and numerous TV appearances on *The Dr. Oz Show*, *Today*, *Rachel Ray Show*, *The View*, *20/20* and eight PBS Specials, which raised millions of dollars for the network. She was a celebrated Feminist on the front lines of women's Mind-Body Medicine, when doing this was still OK – before the Big Pharma global coup d'état.

Today, she is eviscerated on her Wikipedia page for having "embraced QAnon ideology during the COVID-19 pandemic," based on [this article](#), which is totally laughable. "QAnon" has become the latest iteration of the term, "conspiracy theorist", used to discredit truth-telling opponents of the criminal establishment.

I've seen it used against others and it was recently used against me, as if I live and breathe "QAnon" and therefore, I am garbage, so don't listen to anything I say.

It looks to me like low-rent journalists are being hired to systematically deploy the "QAnon" label in hit pieces against those who question the corporatist narrative that has hijacked the planet since March, 2020. These derogatory articles are designed to appear in internet searches of the target's name.

The "QAnon" trope is one of total disparagement, falsely associating those to whom it is ascribed with "extreme right wing" "white supremacist" "domestic terrorism" (despite Q promoting none of this); even PBS' very own Dr. Northrup, with eight blockbuster seasons, not including re-runs is now a suspected Nazi. The patent absurdity of it beggars belief.

As Dr. Northrup explains here, ***"In 2013, I was one of Reader's Digest Most Trusted People in America, and now, in 2021, I am one of the 'Disinformation Dozen', along with Sherri [Tenpenny], those of us accused of 70% of the disinformation about vaccines on the internet – which is an astounding fall from grace, until you understand who is determining what grace is."***

That "who" is Big Pharma and the world's largest corporations, which have been weaponized by the Globalists to bypass the world's legal systems and to commit a litany COVID crimes against humanity over the past 14 months, not the least of which are the so-called "vaccines".

In this short video, Dr. Northrup, who unlike Clif High is a physician and was a clinical assistant professor of OBGYN for 25 years corroborates [Clif's report last week](#) of miscarriages and other [reproductive dysfunction](#) in both men and women.

Disturbingly, she also corroborates what Clif said about these problems being seen in non-vaccinated women working in proximity to vaccinated people, all but confirming his most serious concern that the synthetic spike protein antibodies shed by the vaccinated could conceivably lead to the complete sterilization of the human species – including the unvaccinated.

Dr. Sherri Tenpenny has described the spike protein antibodies produced by the COVID injection as "[Absolutely deadly.](#)" According to her, these injections and their synthetic spike proteins have so far been found to do the following, usually by Day 19 after exposure:

- **Attack your lung tissue and break it down.**
- **Attack your pancreas: Cause diabetes in non-diabetics and aggravate diabetes symptoms in diabetics.**
- **Cause adverse reactions in 27 out of 55 of the tissue types exposed to the serum.**
- **Cause anaphylaxis, probably from the [polyethylene glycol.](#)**
- **Inhibit your anti-inflammatory [M2 macrophages](#), sometimes resulting in a deadly [cytokine storm.](#)**
- **Attack your [astrocytes](#) and [oligodendrocytes](#), which are two different kinds of brain/nerve cells; attacking by two different mechanisms, through the inner mitochondria membrane and through the neurofilament protein of the motor neurons, leading to uncontrolled seizures.**
- **Cause debilitating fatigue by attacking your mitochondria and the intracellular antigen, [GAD 65](#) inside of your mitochondria.**
- **Cause autoimmune disease in roughly 48 weeks.**
- **Cause mutant strains of COVID, in what Dr. Tenpenny describes as "A perfectly-designed kill machine."**

Worst of all, there is no "off" switch to stop the cells' manufacture of these spike protein antibodies, once the messenger RNA (mRNA) in the COVID shots instruct the cells to start making them. Therefore, this mRNA may not only be a runaway train of adverse health consequences for the vaccinated but it may also lead to the mass sterilization of the unvaccinated.

During her speech at [Clay Shaw's Health & Freedom conference](#) in Tulsa, Dr.

Northrup warned those who wished to remain unvaccinated about the potential hazards of being exposed to the bodily fluids of those who are.

In this video, Dr. Northrup says, "My feeling on this is there is [some kind of bioweapon](#); some kind of bioweapon that the body is now secreting, transmitting, as it were, as you said, Sherri, from somebody who's had the shot.

"Because, as we know: this is not a normal immunization. This is something that causes the body to make a synthetic protein against a SARS-CoV-2 spike protein. It is a synthetic protein that's never been seen and the body begins to produce this as a factory. It doesn't shut off.

"I've had people say 'Well, maybe, you know, in two weeks, this will stop.' There is no way this is going to stop, because it's made your body into a factory for a synthetic protein that's never been seen before, that theoretically can be in your saliva, urine, feces, sweat, seminal fluid, blood, flatus, maybe.

"And so when you're around a person, then I think this is coming out of their bodies and possibly adversely affecting the most delicate hormonal system. I mean, to get pregnant and stay pregnant is an enormously complex system and **we know that that spike protein antibody cross-reacts with [syncytin 1](#) and 2, and those are proteins absolutely essential for the placenta, for fertilization, for maintaining a pregnancy.**

"We now have women who are miscarrying, they are unable to get pregnant, and they're having heavy bleeding. We don't know why. But my feeling about this is that something is being produced by the body of a vaccinated person that is possibly adversely affecting others and it is of great concern to me."

The Coronavirus is Man-Made, a "bioweapon" and this is from the most qualified scientist alive today qualified to speak on the topic. Dr. Luc Montagnier is the man who discovered HIV.

Contrary to the narrative that is being pushed by the mainstream media that Covid-19 virus was the result of a natural mutation and that it was transmitted to humans from bats via pangolins. Dr. Luc Montagnier, the man who discovered the HIV virus back in 1983 disagrees and is saying that the virus was man-made.

Professor Luc Montagnier, 2008 Nobel Prize winner for Medicine, claims that SARS-CoV-2 is a manipulated virus was accidentally (maybe and maybe not so) released from a laboratory in Wuhan, China. Chinese researchers are said to have used coronaviruses in their work to develop an AIDS vaccine. HIV RNA fragments are

believed to have been found in the SARS-CoV-2 genome.

According to the 2008 Nobel Prize for Medicine professor, a plausible explanation would be an accident in the Wuhan laboratory. He also added that the purpose of his work was the search for an AIDS vaccine.

In April of 2020, a group of eleven Indian scientists said that the Coronavirus had 18 fragments of HIV inserted along with 4 fragments of SARS-CoV-02 inserted into the genome. Professor Montagnier says, “in order to insert an HIV-sequence into this genome, molecular tools are needed, and that can only be done in a laboratory. The molecular tools Professor Montagnier refers to are “gene” editing electronics known as CRISPR-Cas9. You have not read or heard of this anywhere else. I was sharing that evidence in April of 2020.

DNA vaccine work began thirty years ago, but as yet there are no licensed DNA vaccines and must remain in Phase 1 testing.

The key challenge associated with DNA vaccines is that they must penetrate the cell nucleus (crossing two membranes; the cytoplasm and the nucleus). The DNA must then be transcribed in the nucleus into mRNA before moving to the cytoplasm to stimulate antigen production.

Once inside the nucleus, DNA vaccines have a risk of permanently changing a person’s DNA. Actually, that is an inadequate statement, but I did not want to go into this in great depth here. I have read two books on CRISPR technology and the authors do believe it does permanently change a person’s DNA. The point I wanted to make here is that these women doctors noted at the beginning are correct in their claims to the damage that can be done by the alleged vaccines being offered the public from Pfizer, Moderna, AstraZeneca, and J&J are largely an experiment in which the public at large is being given are guinea pigs for Phase 1 testing.

The story of the Coronavirus is so much larger than anyone can understand or comprehend. Its very complexity speaks to the fact that it was never about a rogue natural or novel virus as the public was told over a year ago. Dr. Fauci lied then and has lied continuously since. It involves Dr. Anthony Fauci’s illegal contracting NIAID work on “gain-of-function” aspects with the CCP; the insertion of 18 fragments of the HIV genome and 4 fragments of the SARS-CoV-2; the creation of a bioweapon, and the various labs, universities, and governments involved in the collaborative work.

The evidence heretofore clearly suggests that this bioweapon was intended as a genocidal “depopulation” event with the vaccines themselves serving as the “kill shot”. It was part and parcel of a plan to provoke a war between China and the U.S. The virus itself was engineered to be merely a trick to frighten people into thinking it was akin to the bubonic plague, and people would not question the vaccine’s

effectiveness and safety. It is true people died, elderly people, and they were placed on ventilators which were responsible for their death, and they were being treated for the wrong health issues. What has happened heretofore is proof positive that there is more tragedy ahead for humanity. The alleged Covid was being used as a cover for the roll out and testing of the new 5G “smart” cities technology. 5G has an aspect that has the capacity to kill millions. I have addressed this in many previous articles and how 5G wireless energy consumes the oxygen in people’s lungs. We know that Bill Gates, Richard Rothschild and others patented the virus several years before the virus was “leaked” and I contend was released deliberately. Pirbright Institute remotely hijacked by hacking the Chinese 5G base stations. I’ve named enough aspects here to show you that this was never about a cold virus which the Coronavirus family of viruses really is part of. 5G wireless communications is a key element in those who are diagnosed and sickened with the alleged Covid, even those who die from the alleged Covid. Since the field of microbiology, biochemistry, virology, immunology, are all beyond the education and intelligence of the public at large, it has been easy for the world health agencies to deceive and gas-light the public. The CDC has never been able to produce petri dish slides of this alleged Covid-19 virus. Countries from all over the world have repeatedly asked for slide samples for their research labs to have something to compare against with testing of their citizens. NO samples were ever given to 40+ nations requesting this vital information. How can you test and verify your people have a virus if their public health agencies have nothing to compare it against. The term “five eyes” is a label given to a group of five nations committed to spy on each other and share that information with each other. It goes back to project “Echelon” exposed in the mid-1990s. They got around their own national laws forbidding spying and surveillance on their own citizens through the use of one of the five eyes countries.

In the past 14 months, I have purchased and read books on topics that are central to this plandemic, and how easy it is to wipe a population out. In the 1950s and 1960s, 65-100 million American school children were vaccinated for polio, which did not exist; polio was caused by the spraying of DDT. Polio virtually disappeared from the scene in the U.S. when DDT was banned in 1972. Those given the polio vaccines by the Salk brothers received shots laced with SV-40 (a cancer causing gene).

Although the pesticide was banned in many countries, some countries in Africa, Asia, and South America needed the pesticide for mosquito control in order to reduce the risk of malaria. In 2006, WHO supported the indoor use of DDT in African

countries where malaria remained a major challenge. The organization stated that the benefits of the pesticides to African countries outweighed the adverse effects it had on the environment. India and North Korea have continued the use of the pesticides for agricultural use despite the ban. Approximately 4,000 tons of DDT are produced annually for the vector control program. It is legal to manufacture DDT in the U.S., though it can only be exported for use in foreign nations. DDT can only be used in the U.S. for public health emergencies, such as controlling vector disease. Today, DDT is manufactured in North Korea, India, and China. India remains the largest consumer of the product for vector control and agricultural use. China produces 4,500 metric tons of the product of which 80–90% is used to produce Dicofol, an acaricide. African countries do not use the product for agricultural purposes but countries such as Ethiopia, South Africa, Uganda, and Swaziland use it to control malaria.

While these countries have used DDT, the WHO, the U.N., and the Gates Foundation continue to administer their chemically laced polio vaccine as if they are fighting polio, which is caused by local use of DDT.

More than a decade ago, a protein blocker known as Nagalase was found in the blood stream of children that had been vaccinated for the MMR shots. The pharmaceutical industry is ripe with corruption, cover-up, and fraud, protected by our own Department of Justice. I have written about these issues in other articles.
