RT reports that Russia's Defense Ministry on Monday laid out more evidence that US-funded laboratories were working in Ukraine, at least one of which was financed by Hunter Biden.

Documents and materials recovered by Russian troops showed that Western pharmaceutical companies operating in territory under Kiev's control conducted HIV/AIDS research on Ukrainian military personnel.

The commander of Russia's Nuclear, Biological and Chemical Defense Forces, Lieutenant General Igor Kirillov, presented Ukrainian-language documents referring to HIV infection studies that began in 2019. The list of targeted groups shows service members alongside prisoners, drug addicts and other "patients at high risk of infection."

According to Kirillov, the Russian military has recovered more than 20,000 documents and other materials related to the biological programs in Ukraine, while interviewing eyewitnesses and participants. The evidence "confirms the focus of the Pentagon on creating biological weapons components and testing them on the population of Ukraine and other states along [Russia's] borders," the general told reporters.

Based on documents originating with the Pentagon's Defense Threat Reduction Agency (or DTRA), the Russian military identified eight more individuals involved in the US-funded research in Ukraine. Among the names Kirillov singled out was Karen Saylors of Labyrinth Global Health, previously of Metabiota, a company that was financed by Hunter Biden's firm, Rosemont-Seneca.

Karen Saylors is also a member of USAID and she conducted bat coronavirus research with Metabiota's Nathan Wolfe as recently as 2022. Saylors and EcoHealth Alliance CEO, Peter Daszak were co-authors of "Predicting the potential for zoonotic transmission and host associations for novel viruses" along with Zhengli Shi of the Wuhan Institute of Virology in 2022.

Kirillov said the latest trove of documents, belonging to the company Pharmbiotest, was unearthed in Luhansk early in January, He said, quote:

"Clinical samples and patient records with their personal data were buried, and not cremated or destroyed in a proper fashion. This suggests that the destruction of this evidence was carried out in extreme haste."

This ties in with a decree sent out by Ukrainian President Zelenskyy a year ago for government officials to destroy all information on the Ukrainian facilities that worked with Metabiota scientists, who were funded by Hunter Biden, as reported by Clandestine on his Substack last summer.

"A Ukrainian document released to Russian media outlet, Izvestia, showing the decree from Zelenskyy to destroy all files on Ukrainian defense service members, employees and staff of the state, and any involvement with Hunter Biden's biolab Metabiota, was dated February 24th, 2022, the same day the air strikes on Ukraine began."

At this stage, they are essentially marketing shields or the corporate "face" of the military program. But Ms. Latypova is clear, by the U.S. EUA regulations, COVID-19

mass vaccination is a DOD operation, and the signal to "go" is given by the U.S. Secretary of Health and Human Services (HHS). Under Trump, it was Alex Azar, and now with Biden, it's Xavier Becerra.

Essentially if the HHS Secretary believes a national medical emergency exists, then DARPA, the branch of the military dealing with biological threats, is activated, and the process starts. Here is a quote from the DARPA website:

"As part of the Autonomous Diagnostics to Enable Prevention and Therapeutics (ADEPT) program in 2011, DARPA began investing in nucleic acid vaccines. The hypothesis was that rather than delivering antigens to the immune system, we could deliver genes that encode the antigen and allow the human body to produce the antigen from its own cells, triggering a protective immune response. In December 2020, former ADEPT performer Moderna's RNA vaccine received FDA Emergency Use Authorization (EUA) approval for the prevention of COVID-19."

So, it is fully disclosed that the genetic vaccines were not a product of Operation Warp Speed and developed in just a few months; rather, DARPA has been working on them with companies such as Moderna since 2011. What is the role of the FDA?² Latypova points out it is largely "theatre." One of the earliest on revelations on SARS-CoV-2 and its ties to Covid-19 was the work of Dr. Luc Montagnier, the 2008 Nobel Peace Prize recipient for his work in identifying HIV1. Dr. Montagnier confirmed the work of a group of Indian scientists who quickly identified elements of key inserted HIV1 and SARS2 into the Coronavirus. Their work was published their findings of the presence of 18 genomic fragments of HIV-1 within the mRNA sequence of SARS-CoV-2.

"Gain-of-Function" was introduced into the mRNA sequence of SARS-CoV-2, weaponizing as a "bio-weapon".

Since the 1983 discovery of the virus, HIV, by Dr. Luc Montagnier and his group at the Pasteur Institute, and his receiving of the 2008 Nobel Prize in Physiology or Medicine, research into the development of a vaccine against HIV has been ongoing. During the early months of the outbreak of the SARS-CoV-2 virus, Dr. Luc Montagnier and fellow scientists, published their findings of the presence of 18 genomic fragments of HIV-1 within the mRNA sequence of SARS-CoV-2. They concluded that the virus was manmade as part of ongoing gain-of-function research in Wuhan, China involving the genomes of both mRNA SARS and HIV-1.

In summary, it would appear that crossovers in research regarding the treatment of HIV, and now SARS-CoV-2/COVID-19, have been underway since the 1980s. Given the widespread employment of draconian measures in vaccinating the global population against SARS-CoV-2, I believe it is appropriate to surmise such early research was diverted into the weaponization of the SARSvirus. A new, synthetic SARSvirus, according to scientists like Dr. Luc Montagnier, was man-made in the Wuhan, China Level 4 biolab, and either accidentally, or, purposefully released upon the world.

The National Human Genome Research Institute describes a retrovirus, including HIV-1: a retrovirus is a virus that uses RNA as its genetic material. When a retrovirus infects a cell, it makes a DNA copy of its genome that is inserted into the DNA of the host cell. There are a variety of different retroviruses that cause human diseases such as some forms of cancer and AIDS.

In this case, the DNA resides within the nucleus of human cells. Once fused, the DNA copy of HIV-1 and 2019-nCoV/COVID-19 permanently alters the existing DNA of the human host.

This process illustrates how SARS-CoV-2 accomplishes two tasks. First, acting as a vector for the entry of HIV-1 fragments into the cytoplasm of a cell. Second, entry of both HIV-1 fragments and the SARS-CoV-2 virus into the cell nucleus, thereby gaining access to the host (human) cell's DNA to permanently alter it.

There is a biological symmetry between SARS-CoV-2 and HIV-1, with one requiring the natural characteristics of the other. They work in concert with one another, each acting as a vector for the other. A vector is an organism that does not cause disease itself but which spreads infection by conveying pathogens from one host to another.

Within their respective papers, research scientist s Prashant Pradhan, et al., and (cited below) Dr. Montagnier and his co-researcher Jean Claude Perez noted within the complete genomic mRNA sequence of SARS-CoV-2, the fragments (inserts) of HIV-1. Meaning, the SARS-CoV-2 virus itself exists due the presence of these fragments of HIV-1. The spread, or transmissability of SARS-CoV-2 is also dependent upon these same 18 fragments. This is the aforementioned "gain of function". Once infected, the

DNA of the host cell produces a new single strand of m RNA. One consisting of both the original DNA of the host, and the new (chimeric) DNA of SARS-CoV-2 and genomic fragments of HIV-1.

The conclusions of these scientists and others cited herein are; the genome of SARS-CoV-2 was man-made in a laboratory and contains not simply 4 inserts as cited by Prashant, et al. but 18 of human or simian retroviruses (HIV-1).

With respect to the "gain of function" objective, this is for the purpose of increasing the rate of infection, the pathogenic transmissibility (morbidity) of a virus within a host population. Not necessarily leading to an increased number of mortalities. This is leveraging the natural processes of a virus in increasing the quantity of infected hosts, without killing them off.

This is accomplished by enhancing the ability of a virus to penetrate into a host cell. The presence of HIV-1 genetic material, the 18 RNA fragments, indicates the targeting of host cell DNA. The natural molecular biological process of all retroviruses like HIV-1 is to fuse its genetic material to that of the host DNA, thus permanently changing it . From there, this modified (chimeric) DNA naturally produces a single strand of m RNA containing the virus and moves on as a Provirus to infect the next host cell. It "goes viral".

Further statements by Montagnier were made during an appearance on the French podcast, Pourquoi Docteur, dated April 17, 2020, in which he said: "Covid 19 derives from a failed HIV vaccine". Montagnier said the coronavirus had escaped in an "industrial accident" while Chinese scientists at the Wuhan city laboratory were trying to develop a vaccine against HIV. "In order to insert an HIV sequence into this genome, molecular tools are needed, and that can only be done in a laboratory," said Montagnier. One has to question whether this was a failed HIV vaccine; or an intentional effort to "Depopulate" the human species. Dr. Montagnier may have been too generous in his remarks and not skeptical of the source attended purpose.

HIV preferentially infects immune cells carrying a cell surface protein called CD4. Once HIV attaches to the cell, it fuses with it. In many cases, the virus makes copies of itself that are active and can continue infection. But in some cases the RNA virus makes a DNA copy of its genome, which gets integrated into the host 's DNA as a Provirus.


