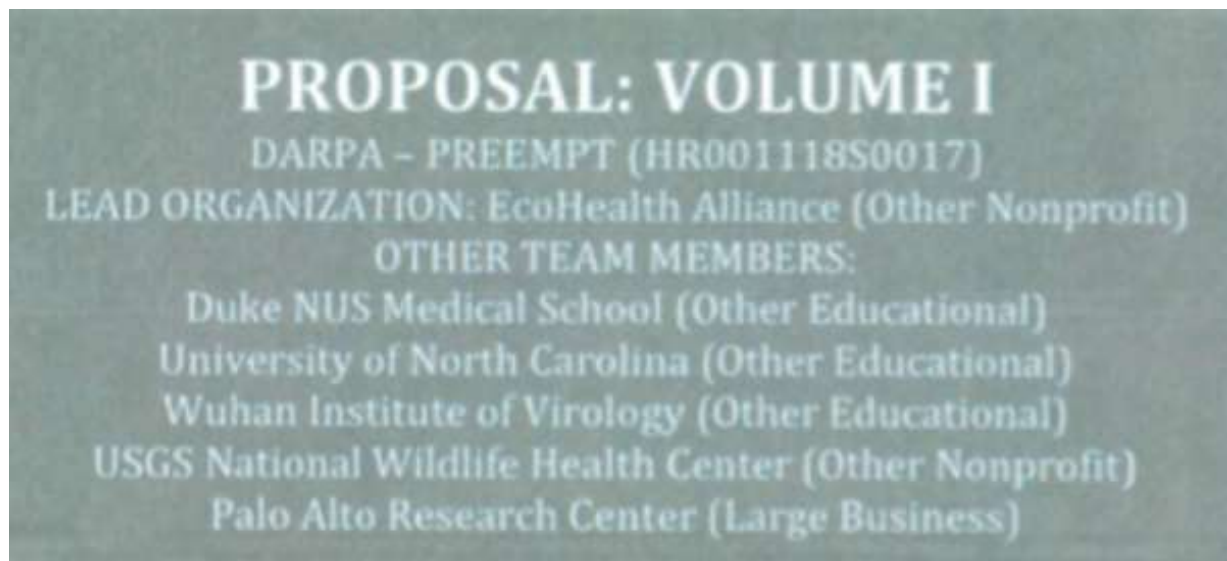

DARPA originally funded MERS but refused to support any effort to release it into the wild. They wanted to keep it as a strategic, last-ditch biological weapon for extreme emergencies.

Fauci and EcoHealth Alliance finagled a way to get their hands on MERS, which became the template for the gain of function research that was laundered through the WIV, using US taxpayer money. Elements from MERS, HIV, SARS and other viral strains were engineered together to create the “chimeric” bioweapons with special affinity for human ACE2 receptors.

Daszak and Fauci approached DARPA to request funding to release their bioweapons in China. DARPA refused. But they found funding through globalist sources that support depopulation.

Had DARPA agreed to the funding, Daszak and Fauci had **planned to invite Shi Zheng Li (the “Bat Lady”) to a celebration announcement at DARPA headquarters!**

SARS-CoV-2 was never designed to kill. It was designed to spread rapidly, with low fatality, to create worldwide panic and demand for vaccines, along with government lockdowns and global communism due to “cases” diagnosed via fraudulent PCR tests.

But MERS is a super deadly bioweapon. **This will be released next**, a souped-up version of MERS that has been weaponized via Fauci, the NIH and the WIV under the control of the PLA (People’s Liberation Army).

The EcoHealth Alliance project proposal to DARPA mentions their plans to develop three to five coronavirus bioweapon strains each year. **This was to be an ongoing, never-ending assault on humanity via biological weapons, all funded by the US military working with communist China.**

We don’t yet know the official designation of this MERS bioweapon, but I’ll call it “Super MERS” for now. Super MERS is already in the hands of PLA operators who have crossed into the United States via Mexican narco smuggling routes. The CCP / PLA has hundreds of military advisors working with Mexican narcos, with the promise that the narcos will receive a piece of the southern USA once China occupies and defeats the United States.

These Chinese bioweapons operatives are told to simultaneously release “Super MERS” across U.S. cities when given the activation command, which could come via public means such as the *‘New York Times’* being ordered by China to use a certain phrase on a certain day. This Super MERS strain will kill at least 30% of those who are infected, under normal circumstances. But because the covid vaccines have destroyed the immune response among vaccinated individuals, the death rate in the vaccinated may be significantly higher. (50%?)

The Super MERS strain is effectively the second half of the **binary weapon system**, with the first half being the vaccine. This is why tyrannical government has pushed so hard for mass vaccinations. It’s the setup for the kill. The Biden administration has been working with China all along to try to achieve a 70% vaccination rate in the USA, which would translate into an overall kill rate of at least 20% of the U.S. population once Super

MERS is released. This translates into about 70 million people, roughly speaking. Or more than ten times the death statistics of the Nazi Holocaust.

The release of Super MERS cannot be stopped. The agents are already in place. The border has long been penetrated. America's military was ordered to stand down during all this, via treasonous Pentagon criminals like Milley and Austin. The left-wing media is all in on this, as is Big Tech. They are all taking orders from China.

The release of Super MERS will be called a "variant" by the criminal government, and they will blame the unvaccinated while activating the CDC's covid death camps to round up political dissidents and begin mass executions.

China will very shortly initiate the bioweapons release in America, likely followed by cyber attacks and financial system tactics

While the exact timing on all this is always difficult to know, it appears China will soon initiate its bioweapons attack on America, making covid look like child’s play. Once this commences, anyone who doesn’t take Super MERS seriously will be in grave danger. **This will be a time to truly stay away from public places and avoid large cities where it is likely that Chinese operatives will use drones to disperse aerosolized, skin-penetrating toxic nanoparticles based on the MERS research.**

Yes, America’s cities are about to be “gassed” / sprayed with deadly poison, much like Zyklon B (except at a much larger scale).

 - Mass executions of political dissidents
 - Medical kidnappings, quarantines and executions of large populations in order to achieve depopulation
 - Total government control over all movement, speech and medical interventions
 - Expect highway checkpoints, vaccine papers, on-site executions, door-to-door medical kidnappings and every nightmare of government terrorism against the people that you could possibly imagine.

Prepare to be sprayed with aerosolized, skin-penetrating toxic nanoparticles. It's all in the DARPA proposal (which DARPA refused to fund, thankfully), and the depopulation agenda is now abundantly obvious to everyone paying attention. But can we trust DARPA? They do not have a trustworthy track record!

Heavy chemtrail spraying has been conducted across the U.S. since 1996 using Air Force C-130 aircraft at altitudes below 15,000-ft. They use military and commercial jet aircraft for flights conducted at altitudes up to 30,000-ft. The ability to spray through drone aircraft, allows spraying coverage at much lower heights up to 400-ft., which enables them to reach smaller venues, such as parks, sports stadiums, protestor gatherings, public gathering locations, etc.

Read the document at the top of page 2. This is the official proof titled “Project Defuse”. DARPA PREEMPT HR001118S0017). This document was shared anonymous. Do not assume that DARPA chose not to defund the project that it is not interested in the research work of using Chemtrail vector methods of aerial spraying of the public, be it an adversary country, or even its own population. The government has a decades-long history of spraying the general public as experimental subjects.

We have evidence and proof the U.S. has sprayed the American public with Brucellosis Mycoplasma going back twenty years. In the articles that I have researched and written about, Brucellosis Mycoplasma was a classified secret of military biological warfare agencies since 1950. I note this fact since any chemical, biological, warfare weapons are a two-edge sword. The impression that they are for an adversary nation does not preclude their use against you! All of what is revealed in the document merely confirms that U.S. agencies have worked closely with China in the weaponization of common viruses.

The December, 2020 issue of ‘Entangled’ magazine confirmed that Covid-19 had been weaponized with the insertion into the genome of 18 fragments of HIV1 and 4 fragments of SARS2 genome. The net result was that the Covid-19 virus had a 92% payload of

the HIV1 genome. A Covid-19 victim received a milder form, if you want to call it that, of the HIV1 that leads to AIDS. The net result is that a victim unaware is likely to get sick and die slower as the virus overcomes the human immune system over time and succumbs to death.

The “virus was created for the Vaxx” as a fear tactic to get people to take an even more dangerous “gene” therapy, which contains a variety of toxic ingredients: Graphene oxide; the spike Protein (PEG); Polysorbate 80; and most recently the Hydra. All of these toxic ingredients have been found in those having been vaxxed and who had side effects of various forms or who died from the shots they received. It is estimated that 1-billion people will die from the vaxx as winter weakens the immune system from colds and the flu. We have seen reports that people’s immune systems are becoming less effective at the rate of 2-4% a month. This confirms what Dr. Sherri Tenpenny and Dr. Cary Madej predicted late 2020 and early 2021.

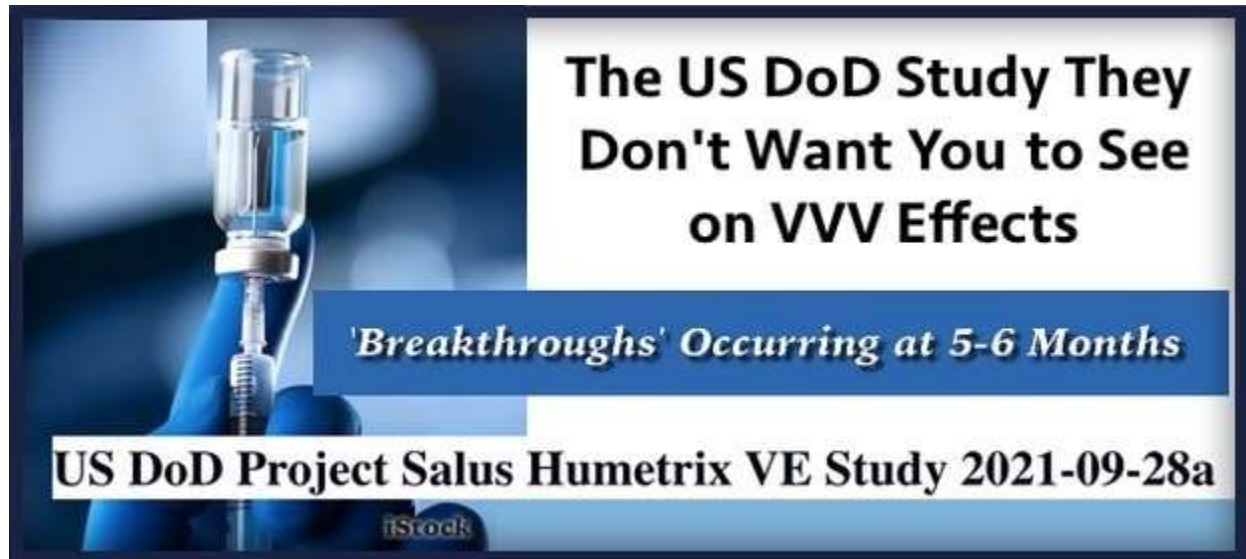
The discovery of fragments of HIV1 in the virus was discovered by eleven scientists from India, also discovered by Australian scientists early in 2020. Australia shut down their \$2-billion vaccine program upon discovery of HIV1 in the vaxx. Their findings were confirmed by the 2008 Nobel Peace Prize winner, Dr. Luc Montagnier. His confirmation of this evidence was made in late March or early April of 2020. The team of Indian virologists withdrew their white paper under pressure by Dr. Anthony Fauci who threatened to withhold future research money. The paper was retracted under pressure but remains accessible to scientists.

The individuals in the DARPA “Project Defuse” were all working on the virus SARS2-CoV and its variants, confirming Dr. Anthony Fauci lied about his involvement in funding “Gain-of-Function” technology in consort with the Chinese Communist Party scientists at the Wuhan Institute, a BSL4 lab.

What’s even a bigger deal is that Fauci and the NIH knew about this well before the COVID pandemic ever began. According to the NIH, they reviewed documents in 2018 related to gain of function research in Wuhan. Dr. Anthony Fauci bears a lot of the responsibility for the COVID-19 pandemic and Congress is doing nothing about it. As you can see, Sen. Rand Paul realizes how big of an issue this really is. He called this from the beginning when the Democrats and mainstream media wanted to blow past the issue. I began feeding Sen. Rand Paul, my state senator, with documents, which should have resulted in criminal prosecution as early as April, 2020. Dr. Fauci is still director of the NIAID, the highest paid bureaucrat in D.C. He should be behind bars for treason, murder, and a series of other charges.

Over the past ten months, almost weekly leakers within our government leak documents and evidence that confirms Covid was NOT an accident. If you have any doubt that the U.S. government has your life on its priority list I would suggest you forget that and face the facts.

Brandon Campbell stated the following in a post on October 22, 2021. “We are inclined to agree with those who believe mass vaccination/injection is just designed to perpetuate the problem of ‘Covid’. Regarding the truth about ‘Breakthrough Infections’.” – There is a DoD study they don’t want you to see.



As a point of detail, we don’t believe **Colin Powell’s death** was due to Covid post-vaccination, but that is by the by in terms of the article. According to his family, Colin Powell had been fully vaxxed and had the first booster shot as well.

We have long pondered what a **‘breakthrough infection’** is. We know enough by now to say that **it isn’t ‘what the PCR test tells us’**. **Is it due to:**

- the toxic, proliferating **spike protein** in our bodies making us sick?
- **graphene oxide** in the vaccines, which is known by itself to mimic ‘Covid’ symptoms? Which is now believed to be activating **synthetic ‘parasites’** found in some of the vaccines.
- **adverse events** (cancer, heart problems, stroke, paralysis, thrombosis/hemorrhaging, etc.) due to the vaccines?
- **Antibody Dependent Enhancement**, whereby the antibodies raised by the ‘vaccine’ make us more prone to being sick from the virus (or whatever it is) naturally circulating in our environment?
- a set of symptoms corresponding to a **specific bioweapon** released some time ago that is now regarded as a ‘circulating virus’? (this would be an aspect of ADE...)
- a bioweapon designed to create problems at **timed intervals** following vaccination?
- some other reason?

The broad brush of ‘Covid’ symptoms could include many things. In France, for example, this list has officially changed since March 2020, when some people were

getting sick to our personal knowledge according to the then-list of symptoms the French government was providing. From being quite broad with some telling specifics (burning in the upper respiratory tract, a return of symptoms after 15 days), it went to 'loss of taste and smell'.

What we learn from this conveniently overlooked US Department of Defense study is that **a portion of vaccinated people are getting unusually sick at the 5-6 month mark**, and that natural immunity trumps so-called vaccinated immunity.

At any rate, we are inclined to agree with those who believe mass vaccination/injection is just designed to perpetuate the problem of 'Covid'.

The Truth About Breakthrough Infections

The sad death of Colin Powell should bring more needed attention to the phenomenon of **breakthrough COVID infections of the fully vaccinated**. You can choose to believe the establishment that breakthrough infections are nothing to worry about. Just a minor inconvenience because COVID vaccines are not and cannot be 100% effective. Or you can **consider real world data that show how serious breakthrough infections really are**.

Department of Defense study

A recent release of data from an important study by the Department of Defense merits very serious attention.

It is called the Project Salus study. One indication of how important the data are is that the **official website giving the data was taken down**. A logical interpretation is that the federal agencies running the pandemic, namely NIH, CDC and FDA, were upset with the data that I am about to give you.

Why? Because the data undercuts the establishment argument in favor of COVID vaccines and downplaying of breakthrough infections. It should be noted that this study has received no attention by mainstream media.

The title of the report is "Effectiveness of mRNA COVID-19 Vaccines Against the Delta Variant Among 5.6 Million Medicare Beneficiaries 65 Years and Older," dated September 28, 2021.

The DOD study got access to the medical data for those people who were fully vaccinated. Of that group, 2.7 million got the Pfizer shot and 2.9 million got the Moderna one. Here are key findings:

- There were 161,000 breakthrough cases.
- There were 33,000 hospitalizations.
- There were 10,400 intensive care unit admissions.
- There were 3,381 deaths for a death rate of 2.1%.

The first reaction from establishment vaccine advocates is that all *these numbers are very small* percentages of the **total sample of 5.6 million fully vaccinated people**. That is correct. All that illustrates is the tyranny of small percentages when looking at health impacts of vaccines.

But there are reasons why the DOD data undercount the true negative impacts of breakthrough infections. The principal one is that the study **followed CDC procedure in NOT counting any negative health impacts occurring within 14 days of the last vaccine shot**. This is important, because some analyses have found that high fractions of negative health impacts, such as vaccine induced blood problems *happen within a few days of vaccination*. **This omission is a deliberate deception aimed solely at undercounting negative health impacts of vaccines.**

It should also be noted that this study did not examine **serious adverse health impacts, including death, resulting from vaccines** without any COVID infection long before and possibly long after breakthrough infections.

Another consideration is that the DOD study was on a cohort of about 10 percent of the entire Medicare population. And it is reasonable to believe that the 65 and older demographic very likely was **vaccinated to a very high degree**. The 'New York Times' said in August that at least 80 percent of people 65 and older are vaccinated in the U.S. Thus, the total number of deaths for this large group resulting from breakthrough infections could be large; perhaps over 10,000.

Indeed, it has been widely reported that **over 80 percent of COVID deaths are in that demographic**. The tragic end to Colin Powell, 84, who had two major underlying medical problems also pertains to the 65 and older population. They [elderly] are especially vulnerable to having immune systems unable to block a breakthrough infection when the vaccine immunity seriously degrades. Powell surely had his initial vaccinations many months earlier.

Another cause of undercounting breakthrough deaths is that many are likely counted as only COVID deaths, not taking into account full vaccinated status.

Taking all these factors into account, the total number of breakthrough deaths for the nation is likely in the 10,000 to 20,000 range. And it is rising as more vaccinated people have declining vaccine effectiveness.

The study emphasized that the above data represented a marked improvement of analogous data from March to December 2020 period when COVID was rampant and before vaccination. For example, the death rate of 2.1 percent for breakthrough infections of the vaccinated compared to 12 percent in the pre-vaccination period.

Fine. That is correct. **But consider that some 3,000 deaths for the 9/11 calamity was considered of enormous news media importance. So, why are the 3,381 deaths**

reported in the DOD study of little mainstream media interest? It exposes the media's compliance with pushing a false agenda on Covid-19!

State data

- In Massachusetts, it was reported this month that the total number of breakthrough cases was **44,498, with 345 deaths (.8%)**.
- In South Carolina, it was reported this month that there had been **14,992** breakthrough cases with **350** deaths, showing a much high death rate (2.3%).
- In Oregon, it was reported this month that out of **28,075** breakthrough cases there were **237** deaths (.8%).
- For Indiana, the reported number of breakthrough cases was **39,000** with **334** deaths (.8%).
- In Minnesota, the total cases reported were **32,796** with **185** deaths (.6%).

As of **October 12**, CDC reported **7,178** breakthrough deaths, with **85% over 65**. It no longer counts all breakthrough cases, just deaths and hospitalizations. However, **CDC data are notoriously unreliable**. So, extrapolating the data for the above six states to the entire nation (using population data) results in **14,510 breakthrough deaths** for **1.6 million cases** and a **death rate of .9%**.

This is lower than the 2.1 percent in the DOD study; this might be explained by many breakthrough infections happening in people younger than 65 and some under-reporting of breakthrough deaths probably because they are counted as COVID deaths.

Declining vaccine effectiveness

The deaths are important because they show the true limitation of current COVID vaccines. It is now recognized that their effectiveness quickly diminishes over time. Generally speaking, after about six months they become ineffective. It was found in this study that **breakthrough infection rates 5-6 months post-vaccination are TWICE AS HIGH as 3-4 months post-vaccination**. Also noted was that the data showed mRNA vaccine effectiveness falls short of what was predicted in the drug company studies that got them FDA sanctioned, and that the Moderna vaccine was better than the Pfizer one in sustaining effectiveness.

An unpublished graph of CDC data (made available on a Rational Ground newsletter, October 14, 2021) showed a **marked increase in COVID deaths in hospitals starting in April 2021, rising from 3.1 to 15.1 percent for vaccinated patients in May 2021**. This corresponds to the **FIVE months since the onset of the mass vaccination program**; a period when vaccines lose their effectiveness. As time goes on, more people lose protection from vaccines causing more breakthrough infections.

This serious decline in vaccine effectiveness should lead rational, objective people to conclude any vaccine that only provides just a few months of protection should not be described as a medical solution worthy of wide use and mandates. And, in terms of ineffectiveness against the delta variant, does it make sense to believe that requiring repeated booster shots of the same vaccines will produce better results? At best, they may only delay breakthrough infections.

The worsening of health outcomes after vaccination has been interpreted as resulting from damage to the immune system caused by vaccines. This is referred to as **Antibody Dependent Enhancement (ADE)** in the medical research literature. It refers to immune system weakening from vaccines. Dr. Luc Montagnier predicted this as early as April, 2020!

As to declining vaccine effectiveness it should be noted that two studies from Israel and Qatar that were published in the *'New England Journal of Medicine'* supported this threat to the fully vaccinated. And in Israel the rise of COVID-19 cases in fully vaccinated people has been reported. According to Dr. Haviv, **the vaccinated account for 85-90% of all new hospitalizations and 95% of "severe" cases at the Herzog Medical Center in Jerusalem.**

Impacts of being vaccinated

There have also been reports that **very high fractions of hospital admission in the US are for fully vaccinated people.** One whistle blower reported that, where she worked, while the vaccination rate was less than 50% in the community, about 90% of hospital admissions had been fully vaccinated.

And it has been reported from several states that 40% of hospitalized COVID patients had been fully vaccinated, including from New York: Since July 1, nearly 40% of all Onondaga County residents who tested positive for the novel coronavirus had been fully vaccinated.

Recently reported for Maryland was that over the past three months in Anne Arundel County, about 30% of the people hospitalized with COVID are fully vaccinated. In neighboring Howard County health officials said roughly 30% to 40% of people hospitalized with COVID are fully vaccinated. That is a lot of breakthrough infections.

A recent report from Public Health England shows that 163 of the 257 people (63.4%) who died of the delta variant within 28 days of a positive COVID test between February 1 and June 21, had received at least one dose of the vaccine.

Natural immunity

A very important finding of the DOD study that in itself deserved attention by mainstream media was that the one variable that explained substantial resistance to serious negative health impacts from breakthrough infections was natural immunity resulting from prior COVID infection.

If we want to face reality with honesty, then **natural immunity must be viewed as the enemy of mass vaccination.** Those governments refuse to credential natural immunity as they increasingly mandate vaccination is a disgraceful rebuttal of medical science. Indeed, there is now indisputable medical evidence that natural immunity is more effective, especially against variants, and longer lasting than vaccine immunity. All this makes it a threat to mass vaccination.

St. Lukes University Hospital in Pennsylvania has recognized natural immunity by offering their workers with it at least a one-year deferment to get vaccinated. With workers in many sectors refusing vaccination, even with loss of their jobs and with a huge impact on our economy and society, perhaps the federal government and major companies will be compelled to act in a similar fashion by recognizing natural immunity.

Vaccine immunity impacts

Finally, newly reported research is worth noting: High viral load was found in “158 of 232 unvaccinated (68%...) and 156 of 225 fully vaccinated (69%...) symptomatic individuals.” This means there is no difference between the symptomatic vaccinated and unvaccinated in terms of who was carrying, and therefore spreading, the virus. It also found high viral loads in “7 of 24 unvaccinated (29%...) and 9 of 11 fully vaccinated asymptomatic individuals (82%...)” **Meaning, among asymptomatic individuals, the vaccinated had a higher percentage with a high viral load.**

A valid conclusion is that the unvaccinated that catch the virus are more likely to be at home in bed with symptoms, **while the vaccinated that catch the virus (breakthrough infection) may often have no symptoms and hence continue their daily routine unknowingly spreading the virus.** This is why many medical experts refer to the vaccinated as **super spreaders.** Indeed, the eminent Dr. Robert Malone, inventor of mRNA vaccines, has emphasized that vaccinated people in their normal activities are *“going to be spreading the virus like crazy.”*

As to breakthrough infections and deaths, what must be remembered is that there is likely to be a lot of COVID virus circulating, mostly delta variant now. And that is happening as fully vaccinated people have declining vaccine effectiveness. Booster shots just delay such a loss. All of this means **increasing breakthrough cases**, some of which result in death, especially in the most vulnerable; that is, the elderly, those with compromised immune systems (like Colin Powell), those with serious comorbidities, including obesity.

In bringing this article to a close, we cannot ignore this statement on page 1 above: **[DRASTIC has confirmed that Daszak and Fauci, working via the Wuhan Institute of Virology (WIV) were able to create 180 strains of coronavirus bioweapons and put them under the control of the communist Chinese (an act of treason).]** In the larger picture of the Covid outbreak, it is deeply troubling, if not unnerving, that our own government is complicit in a multiple number of ways through the public health system responsible for the public health and safety is as guilty as sin in this entire global crisis. Central figures can obfuscate all they want by blaming China as the cause of this crisis,

but the facts remain that the leaders of these agencies responsible for creating bioweapons were irresponsible and negligent if not criminally responsible for the deaths of hundreds of thousands. If you are going to genetically tweak viruses you are placing at risk of humanity, and should be treated as such. All of the major names associated with this crime against humanity need to be prosecuted for their “gain-of-function” research work and their treasonous activities with China and the CCP. In China all biological research is ultimately military even if it is tagged public health.

I read and gather information from over 150 sources on virtually everything that is made available on the Internet, and the cover-up is blatantly obvious by the fact that evidence that has been known as early as March of 2020, remains today hidden from the public eye. None of the elements found in the Vaxxes are mentioned or discussed by the health or public health agencies, such as Graphene Oxide, Spike Protein (PEG), Polysorbate 80, and recently what is called a fresh-water “Hydra”, Dr. Carrie Madej and others have found what are believed to be a “parasite”. Hydra Vulgaris is immortal in its own environment according to researchers and there is no accountability. This later organism has a neural network and is not something that belongs in a vaxx. The transhumanism network is known to be interested in the Hydra Vulgaris because of its ability to reproduce itself.

Dr. Franc Zalewski claims to have found a carbon based life-form in the COVID vaccines. He also presents several questions as to why they are only found in some vaccines.
