

Was It Coincidence That Rush Limbaugh Died A Couple Weeks Before Covid Was Declared A Pandemic?

On Feb. 17, 2021, long-time radio personality Rush Limbaugh died at the age of 70 after battling lung cancer. In the wake of his death, various quotes from his life on the airwaves were shared on social media. One such claim was that Limbaugh said that the novel coronavirus was nothing more than “the common cold.” Even dishonest fact checker Snopes said Rush Limbaugh’s statement was true.

The World Health Organization (WHO) on March 11, 2020, declared the novel coronavirus (COVID-19) outbreak a global pandemic. At a news briefing, WHO Director-General, Dr. Tedros Adhanom Ghebreyesus, noted that over the past 2 weeks, the number of cases outside China increased 13-fold and the number of countries with cases increased.

A Snopes transcript from part of “The Rush Limbaugh Show” on February 24, 2020 was headlined: “Overhyped Coronavirus Weaponized Against Trump.” I know the date above does confirm that it was a re-broadcast from weeks earlier because the media reported Rush’s death a few weeks earlier on February 17, 2020. I listened to Rush and did hear the specific segment which is accessible on the Internet but do not have the original date for the specific transcript below.

RUSH: *“Folks, this coronavirus thing, I want to try to put this in perspective for you. It looks like the coronavirus is being weaponized as yet another element to bring down Donald Trump. Now, I want to tell you the truth about the coronavirus. (interruption) You think I’m wrong about this? You think I’m missing it by saying that’s... (interruption) Yeah, I’m dead right on this. The coronavirus is the common cold, folks.”*

The Drive-By Media hype of this thing as a pandemic, as the Andromeda strain, as, “Oh, my God, if you get it, you’re dead.”

He also added: *“Be very leery of this, folks. It probably is not what the media’s leading you to believe it is.”* And just as Rush said, the media has been the biggest fear-mongers pushing the pandemic bovine excrement scare. It has not backed-off, and doubles down on each of the so-called variants.

On March 9, U.S. President Donald Trump compared influenza to coronavirus. The tweet read:

So last year 37,000 Americans died from the common Flu. It averages between 27,000 and 70,000 per year. Nothing is shut down, life & the economy go on. At this moment there are 546 confirmed cases of CoronaVirus, with 22 deaths. Think about that!

He compared the COVID-19 pandemic to the flu once again months later. These two tweets were somewhat similar to Limbaugh's claim about the common cold.

On March 12, Limbaugh said that *"the one thing missing in all of this panic-driven coronavirus news" was "the number of deaths in the United States!"* At the time, around 39 people were reported to have died of COVID-19 in the U.S. The headline of the transcript was: *"Why Isn't the Coronavirus Death Toll the Big Story?"*

However, this was misleading according to Snopes. News organizations were indeed reporting death numbers.

On March 7, an NBC News story said that 19 people had died in the U.S. A CBS News article that was originally published on March 9 cited 26 deaths. CNN reported 38 deaths on March 11. On March 12, ABC News published a story that mentioned 40 deaths.

From the first U.S. death on Feb. 6, 2020, and moving more than 12 months later, the COVID-19 pandemic has NOT shown that the virus was far more deadly than the common cold or influenza. Snopes left out NOT in their post on this. The Health agencies own data showed that Snopes was wrong!

On Feb. 17, 2021, Johns Hopkins University of Medicine reported that the U.S. was preparing to surpass 500,000 deaths from the COVID-19 pandemic. Published February 17, 2021.

I began compiling the daily government data reported on the alleged Covid-19 in December, 2020. I then did a complete statistical report for the, day by day, entire year of 2020.

When I closed out the 2021 data of alleged deaths to Covid-19, I did a summary section of the reported government data and I shared that summary below. Anyone can verify this data by referring to the official government data. **As the information below shows, this was precisely what Rush Limbaugh said it was only (0.248 or ¼ percent).**

The official Covid-19 2021 death report of **822,914** is the equivalent or **0.24861450151057%** of 331,000,000 or just **2/10th of one percent**. Because of inflated numbers encouraged by CDC, NIAID, NIH, and WHO we will never know the true figures.

I ask you, in all honesty, does that sound like a pandemic to you? Statistically speaking, it wasn't even an epidemic. Maybe a scandemic!

In light of what we know today, about the insertion of 18 fragments of the HIV1 genome (92% of the viral load of HIV1), and 4 fragments of the SARS2 genome, which Dr. Anthony Fauci still denies his spending \$3.5 million for gain-of-function sub-contract work by the Chinese scientists at Wuhan BSL4 Lab, and a second payment for an equal amount. Two other sources from France and Australia confirmed the same evidence found in the analysis of the Corona virus tagged as Covid-19.

Almost two years later when I read the thousands of reports on how the government health agencies have deceived the public, I kept coming back to what Rush said about it

being the simple seasonal cold. With each passing day my suspicions about the timing of Rush's cancer death have grown.

Below is the 'EIB' taped complete transcript of what Rush Limbaugh said:

"RUSH: Folks, this coronavirus thing, I want to try to put this in perspective for you. It looks like the coronavirus is being weaponized as yet another element to bring down Donald Trump. Now, I want to tell you the truth about the coronavirus. (Interruption) You think I'm wrong about this? You think I'm missing it by saying that's... (Interruption) Yeah, I'm dead right on this. The coronavirus is the common cold, folks.

The Drive-By Media hype of this thing as a pandemic, as the Andromeda strain, as, "Oh, my God, if you get it, you're dead." Do you know what the — I think the survival rate is 98%. Ninety-eight percent of people get the coronavirus survive. It's a respiratory system virus. It probably is a ChiCom laboratory experiment that is in the process of being weaponized. All superpower nations weaponize bioweapons. They experiment with them. The Russians, for example, have weaponized fentanyl. Now, fentanyl is also not what it is represented to be.



If you watch cop shows, then you probably... Stick with me on this. If you watch cop shows, you probably believe that just the dust from a package of fentanyl can kill you if you're in the same room with it. Not true. Not true. Even the cheap kind of fentanyl coming from China that's used to spike heroin... They use fentanyl 'cause it's cheap. It gives a quick hit, doesn't last very long, which is really cool if you're trying to addict people.

But it doesn't kill people the way it's projected on TV. It can if you OD on it. But inhaling a little fentanyl dust is not going to cause you to lose consciousness and stop breathing as they depict on cop shows. It's dangerous. Don't misunderstand. The stock market's down like 900 points right now. The survival rate of this is 98%! You have to read very deeply to find that number, that 2% of the people get the coronavirus die. That's less than the flu, folks. That is a far lower death statistic than any form of influenza, which is an annual thing that everybody gets shots for. There's nothing unusual about the coronavirus. In fact, coronavirus is not something new. There are all kinds of viruses that have that name. Now, do not misunderstand. I'm not trying to get you to let your guard down.



Nobody wants to get any of this stuff. I mean, you never... I hate getting the common cold. You don't want to get the flu. It's miserable. But we're not talking about something here that's gonna wipe out your town or your city if it finds its way there. This is a classic illustration of how media coverage works. Even if this media coverage isn't stacked, even if this is just the way media normally does things, this is a hyped, panic-filled version. It's exactly how the media deals with these things to create audience, readership, interest, clicks, what have you.

It originated in China in a little — well, not a little town. It's a town that is 11 million people, Wuhan, China. One of the reasons they're able to hype this is that the doctor what warned everybody about it came down with it and died. So if a doctor got it, "Oh,

my God, Rush! A doctor got it? You can't possibly be right if a doctor can't protect himself." He didn't know what he was dealing with. He discovered it back in December. I'm telling you, the ChiComs are trying to weaponize this thing. Here's the story on Russians and fentanyl.

Fentanyl is a very, very powerful opiate — and for those of you that haven't had any experience with opiates, the people that get addicted to 'em take them and they get very euphoric. They kill pain. They do wonderful things. But they make you very, very euphoric. They act like speed. Other people take 'em, and they hate 'em. It makes 'em vomit, throw up, feel nauseous. So in Moscow the Chechens, way back... I'm gonna go back now — what is it — maybe 10 years or longer. He'd turned it into a gas, an invisible gas. He just put it in the ventilation system of this opera house or whatever it was (I'm giving you the sketchy, short version of this) and everybody in there fell asleep and died. And if you go deeper into China, you will see that all of the high-tech Silicon Valley firms are said to be terribly exposed. “They could be suffering a disastrous year. Why, you may not be able to buy a new iPhone of any model this whole year! Do you know that? Because the coronavirus is so bad that the factories may never open — and if they do, they may not be anywhere near full capacity.” So Apple may not be able to release any new product. You think that’s not gonna panic investors? It most certainly is.

So Apple is trying to do what they can to suggest that these rumors are not true. They got new products coming this year. But the tech media hates Apple. They love anti-Apple stories. They love anything that will let them report that Apple’s on its last legs. Of course, that’s not true. Warren Buffett came out today and said, “Apple is the best run company ever.” He’s a big stockholder. So people will say he’s biased about it. But the bias you have to pay attention to is how much money he invested. He got \$36 billion in Apple stock that Berkshire Hathaway has.



They sold \$800 million of Apple stock last week, and everybody said, “Oh, my God, he’s getting out!” No, he’s not. He’s got \$36 billion. He sold \$800 million. No big deal. He wanted to allocate it somewhere else. So this is... I think the coronavirus is an effort to get Trump. It’s not gonna work. It’s one of the latest in a long line of efforts that the Drive-By Media’s making to somehow say that Trump and capitalism are destroying America and destroying the world. Just keep in mind where the coronavirus came from.

It came from a country that Bernie Sanders wants to turn the United States into a mirror image of: Communist China. That’s where it came from. It didn’t come from an American lab. It didn’t escape from an American research lab. It hasn’t been spread by Americans. It starts out in a communist country. Its tentacles spread all across the world

in numbers that are not big and not huge, but they're being reported as just the opposite. Just trying to keep it all in perspective.

BREAK TRANSCRIPT

RUSH: Here's Neil in Orlando. Great to have you on the program, sir. Hello.

CALLER: Hello, Rush. Man, I'm blessed to have the chance to talk to you. I cannot believe it. So you were talking about the coronavirus a little bit a while ago, and what's the one thing that disappeared when the coronavirus came out?



RUSH: Well, let me see. What one thing? Just hang on. What disappeared? What disappeared? What disappeared? Oh, the protests in Hong Kong went away.

CALLER: Yes. That's it.

RUSH: That's a big...

CALLER: Yup.

RUSH: (whispering) Talent on loan from God.

CALLER: That sure is.

RUSH: That's probably the big one, the protests in Hong Kong.

CALLER: That's my take from it. I don't know. I've got a friend over there that sends me stuff. But there's a lot... We don't want to start any conspiracy theories, but this will be my only time I ever get through to you 'cause I've been calling since '92. But I just want to say about your talent on loan from God: Just in the time, I was on hold listening to you, and it got me to the point where I just wanted to say that Trump got no notice about Russian meddling like Sanders did. So why not? I wonder about that. When Carter was president, my first home buying — I was a first-time home buyer — the rate was 13.33%. I'll never forget it, and that was a first-time homeowner!

RUSH: I know. I know.

CALLER: That was a deal!

RUSH: I know. I know.

CALLER: That was a deal at 13.33%!

RUSH: I bought my first shack, you know, at that time in Overland Park, Kansas. I had no business buying it. But everybody said, "You gotta buy! Don't rent. You're throwing money away if you rent."

CALLER: Mmm-hmm.

RUSH: So, you know, my one time I became a conformist, it got me. I didn't want to live in this shack! I never wanted to move into this shack. But it's what I bought, so I had to move into the thing.

CALLER: And one more —

RUSH: I didn't even want people to take me home. I didn't want people to see this shack that I lived in. One day, we're playing football — the Chiefs front office, the Royals front office — after the baseball season. Thursday afternoon flag football. George Brett's playing and he offered to take me home. I said (chuckles), "No, George, I'm fine." I didn't want Brett to see where the shack was. Brucellosis was a prime candidate for weaponization in the development of the biological weapons program in the United States beginning at the close of World War 2. The U.S. developed the bacteria in the 1950s due to its low lethality, manufacturing ease, and the fact it does not cause uncontrollable epidemics. It was code named Agent U.S. and was considered a 'humane' weapon.

Brucellosis is a systemic zoonotic disease caused by one of four species of bacteria: *Brucella melitensis*, *B. abortus*, *B. suis*, and *B. canis*; virulence for humans decreases somewhat in the order given. These bacteria are small gram-negative, aerobic, non-motile coccobacilli that grow within monocytes and macrophages. They reside quiescently in tissue and bone-marrow, and are extremely difficult to eradicate even with antibiotic therapy. Their natural reservoir is domestic animals, such as goats, sheep, and camels (*B. melitensis*); cattle (*B. abortus*); and pigs (*B. suis*). *Brucella canis* is primarily a pathogen of dogs, and only occasionally causes disease in humans. Humans are infected when they inhale contaminated aerosols, ingest raw (unpasteurized) infected milk or meat, or have abraded skin or conjunctival surfaces that come in contact with the bacteria. Laboratory infections are quite common, but there appears to be no human-to-human transmission; isolation of infected patients is, therefore, not required.

Brucella species long have been considered potential candidates for use in biological warfare. The organisms are readily lyophilized, perhaps enhancing their infectivity. Under selected environmental conditions (for example, darkness, cool temperatures, high CO₂), persistence for up to 2 years has been documented. When used as a

biological warfare agent, Brucellae would most likely be delivered by the aerosol route; the resulting infection would be expected to mimic natural disease.

Brucellosis presents after an incubation period normally ranging from 1-4 weeks, but may be as short as 1 week or as long as a year. Clinical disease presents typically as an acute, non-specific febrile illness with chills, sweats, headache, fatigue, myalgias, arthralgias, and anorexia. Cough occurs in 15-25%, but the chest x-ray usually is normal. Complications include sacroiliitis, arthritis, vertebral osteomyelitis, epididymo-orchitis, and rarely endocarditis. Physical findings include lymphadenopathy in 10-20% and splenomegaly in 20-30% of cases. Untreated disease can persist for months to years, often with relapses and remissions. Disability may be pronounced. Lethality may approach 6% following infection with *B. melitensis*, but the disease is rarely fatal (0.5% or less) after infection with other serotypes (usually after endocarditis develops).

The initial symptoms of brucellosis are usually nonspecific, and the differential diagnosis is therefore very broad and includes bacterial, viral, and mycoplasmal infections. The systemic symptoms of viral and mycoplasmal illnesses, however, are usually present for only a few days, while they persist for prolonged periods in brucellosis. Brucellosis may be indistinguishable clinically from the typhoidal form of tularemia or from typhoid fever itself. The disease in humans is characterized by a multitude of somatic complaints, including fever, sweats, anorexia, fatigue, malaise, weight loss, and depression. Localized complications may involve the cardiovascular, gastrointestinal, genitourinary, hepatobiliary, osteoarticular, pulmonary and nervous systems. Without adequate and prompt antibiotic treatment, some patients develop a 'chronic' brucellosis syndrome with many features of the 'chronic fatigue' syndrome.

The recommended treatment is doxycycline (200 mg/day) plus rifampin (900 mg/day) for 6 weeks. Alternative effective treatment consists of doxycycline (200 mg/day) for 6 weeks plus streptomycin (1 gm/day) for 3 weeks. Trimethoprim-sulfamethoxazole given for 4-6 weeks is less effective. In 5-10% of cases, there may be relapse or treatment failure. Laboratory infections with brucellosis are quite common, but there is no human-to-human transmission and isolation is not required.

Mycoplasma has been implicated in the formation of cancer. Specific reports include:

Mycoplasma can "induce malignant transformation of host mammalian cells" by means of "aberrant expression of oncogenes and tumor repressors".

A "Mycoplasma hyorhinis-encoded protein known as p37..(could) infect humans and may facilitate tumor invasiveness".

A "significantly high existence of Mycoplasma sp. DNA" has been reported "in the tissues of patients with conventional (renal cell carcinoma)" as opposed to normal controls.

"Mycoplasma infection can be detected in many tumor tissues, continuous infection of mycoplasma can lead to transformation of mammalian cells, up-regulating expression of oncogenes, and some biologic changes of tumor cells, suggesting association of Mycoplasma infection with tumorigenesis"

A number of other bacteria have associations with cancer, although their possible role in carcinogenesis is unclear. Salmonella typhi is associated with gallbladder cancer, Streptococcus bovis is associated with colorectal cancer and Chlamydia pneumoniae with lung cancer.

Mycoplasma is responsible for infecting the colon, lungs, stomach, prostate and renal system with malignant cancer. It is also linked to cancer in the mammary gland as it can form an association with the growth factors present on the cell membranes of cells, thus interfering with normal cell division. The interesting aspect of this carcinogen is that they do not infect cells the usual way i.e. ligating their DNA with the host DNA, in fact the actual mechanism of infection is still a mystery to scientists though there are some theories that have been formulated.

Several strains of mycoplasma have been "engineered" to become more dangerous. They are now being blamed for AIDS, cancer, CFS, MS, CJD and other neurosystemic diseases.

I - PATHOGENIC MYCOPLASMA A Common Disease Agent Weaponized

There are 200 species of Mycoplasma. Most are innocuous and do no harm; only four or five are pathogenic. Mycoplasma fermentans (incognitus strain) probably comes from the nucleus of the Brucella bacterium. This disease agent is not a bacterium and not a virus; it is a mutated form of the Brucella bacterium, combined with a visna virus, from which the mycoplasma is extracted.

The pathogenic Mycoplasma used to be very innocuous, but biological warfare research conducted between 1942 and the present time has resulted in the creation of more deadly and infectious forms of Mycoplasma. Researchers extracted this mycoplasma from the Brucella bacterium and actually reduced the disease to a crystalline form. They "weaponized" it and tested it on an unsuspecting public in North America.

Dr. Maurice Hilleman, chief virologist for the pharmaceutical company Merck Sharp & Dohme, stated that this disease agent is now carried by everybody in North America and possibly most people throughout the world.

Despite reporting flaws, there has clearly been an increased incidence of all the neuro/systemic degenerative diseases since World War II and especially since the

1970s with the arrival of previously unheard-of diseases like chronic fatigue syndrome and AIDS.

According to Dr. Shyh-Ching Lo, senior researcher at The Armed Forces Institute of Pathology and one of America's top mycoplasma researchers, this disease agent causes many illnesses including AIDS, cancer, chronic fatigue syndrome, Crohn's colitis, Type I diabetes, multiple sclerosis, Parkinson's disease, Wegener's disease and collagen-vascular diseases such as rheumatoid arthritis and Alzheimer's.

Dr. Charles Engel, who is with the U.S. National Institutes of Health, Bethesda, Maryland, stated the following at an NIH meeting on February 7, 2000: *"I am now of the view that the probable cause of chronic fatigue syndrome and fibromyalgia is the mycoplasma..."*

I have all the official documents to prove that mycoplasma is the disease agent in chronic fatigue syndrome/fibromyalgia as well as in AIDS, multiple sclerosis and many other illnesses. Of these, 80% are U.S. or Canadian official government documents, and 20% are articles from peer-reviewed journals such as the *'Journal of the American Medical Association'*, *'New England Journal of Medicine'* and the *'Canadian Medical Association Journal'*. The journal articles and government documents complement each other.

Since I first began researching and studying Mycoplasma, some 6 years ago, many scientists have been pointing at COVID-SARS-COV2 as engineered Mycoplasma! This makes sense and from dozens of scientific papers published since the outbreak of the Coronavirus in Wuhan, China, Mycoplasma is a prime candidate for greater study as causal for Covid-19. –(Pastor Bob Reid)

How the Mycoplasma Works

The mycoplasma acts by entering into the individual cells of the body, depending upon your genetic predisposition. It attacks inherent weak points of the human body.

You may develop neurological diseases if the pathogen destroys certain cells in your brain, or you may develop Crohn's colitis if the pathogen invades and destroys cells in the lower bowel.

Once the mycoplasma gets into the cell, it can lie there doing nothing sometimes for 10, 20 or 30 years, but if a trauma occurs like an accident or a vaccination that doesn't take, the mycoplasma can become triggered.

Because it is only the DNA particle of the bacterium, it doesn't have any organelles to process its own nutrients, so it grows by up taking pre-formed sterols from its host cell and it literally kills the cell; the cell ruptures and what is left gets dumped into the bloodstream.

II- CREATION OF THE MYCOPLASMA A Laboratory-Made Disease Agent

Many doctors don't know about this mycoplasma disease agent because it was developed by the U.S. military in biological warfare experimentation and it was not made public. This pathogen was patented by the United States military and Dr. Shyh-Ching Lo. I have a copy of the documented patent from the US Patent Office.

All the countries at war were experimenting with biological weapons. In 1942, the governments of the United States, Canada and Britain entered into a secret agreement to create two types of biological weapons (one that would kill, and one that was disabling) for use in the war against Germany and Japan, who were also developing biological weapons. While they researched a number of disease pathogens, they primarily focused on the Brucella bacterium and began to weaponize it.

From its inception, the bio-warfare program was characterized by continuing in-depth review and participation by the most eminent scientists, medical consultants, industrial experts and government officials, and it was classified Top Secret.

The U.S. Public Health Service also closely followed the progress of biological warfare research and development from the very start of the program, and the Centers for Disease Control (CDC) and the National Institutes of Health (NIH) in the United States were working with the military in weaponizing these diseases. These are diseases that have existed for thousands of years, but they have been weaponized—which means they've been made more contagious and more effective. And they are spreading.

The Special Virus Cancer Program, created by the CIA and NIH to develop a deadly pathogen for which humanity had no natural immunity (AIDS), was disguised as a war on cancer but was actually part of MKNAOMI. Many members of the Senate and House of Representatives do not know what has been going on. For example, the U.S. Senate Committee on Government Reform had searched the archives in Washington and other places for the document titled "The Special Virus Cancer Program: Progress Report No. 8", and couldn't find it. Somehow they heard I had it, called me and asked me to mail it to them. Imagine: a retired schoolteacher being called by the United States Senate and asked for one of their secret documents! The U.S. Senate, through the Government Reform Committee, is trying to stop this type of government research.

Crystalline Brucella

The title page of a genuine US Senate Study, declassified on February 24, 1977, shows that George Merck, of the pharmaceutical company, Merck Sharp & Dohme (which now makes cures for diseases that at one time it created), reported in 1946 to the U.S. Secretary of War that his researchers had managed "for the first time" to "isolate the disease agent in crystalline form".

They had produced a crystalline bacterial toxin extracted from the Brucellabacterium. The bacterial toxin could be removed in crystalline form and stored, transported and deployed without deteriorating. It could be delivered by other vectors such as insects, aerosol or the food chain (in nature it is delivered within the bacterium). But the factor that is working in the Brucella is the mycoplasma.

Brucella is a disease agent that doesn't kill people; it disables them. But, according to Dr. Donald MacArthur of the Pentagon, appearing before a congressional committee in 1969, researchers found that if they had mycoplasma at a certain strength—actually, 10 to the 10th power—it would develop into AIDS, and the person would die from it within a reasonable period of time because it could bypass the natural human defenses. If the strength was 10 to 8, the person would manifest with chronic fatigue syndrome or fibromyalgia. If it was 10 to 7, they would present as wasting; they wouldn't die and they wouldn't be disabled, but they would not be very interested in life; they would waste away.

Most of us have never heard of the disease brucellosis because it largely disappeared when they began pasteurizing milk, which was the carrier. One salt shaker of the pure disease agent in a crystalline form could sicken the entire population of Canada. It is absolutely deadly, not so much in terms of killing the body but disabling it.

Because the crystalline disease agent goes into solution in the blood, ordinary blood and tissue tests will not reveal its presence. The mycoplasma will only crystallize at 8.1 pH, and the blood has a pH of 7.4 pH. So the doctor thinks your complaint is "all in your head".

Since first beginning my own research on Mycoplasma, Garth L. Nicholson published a lengthy paper on Mycoplasma and Covid-19. I am only posting the Abstract portion of that paper in this article. The actual paper is lengthy, containing well over a hundred footnotes.

COVID-19 Coronavirus: Is Infection along with Mycoplasma or Other Bacteria Linked to Progression to a Lethal Outcome?

Abstract

Most patients with COVID-19 disease caused by the SARS-CoV-2 virus recover from this infection, but a significant fraction progress to a fatal outcome. As with some other RNA viruses, co-infection or activation of latent bacterial infections along with pre-existing health conditions in COVID-19 disease may be important in determining a fatal disease course. Mycoplasma spp. (*M. pneumoniae*, *M. fermentans*, etc.) have been

routinely found as co-infections in a wide number of clinical conditions, and in some cases this has progressed to a fatal disease. Although preliminary, **Mycoplasma pneumoniae** has been identified in COVID-19 disease, and the severity of some signs and symptoms in progressive COVID-19 patients could be due, in part, to Mycoplasma or other bacterial infections. Moreover, the presence of pathogenic Mycoplasma species or other pathogenic bacteria in COVID-19 disease may confer a perfect storm of cytokine and hemodynamic dysfunction, autoimmune activation, mitochondrial dysfunction and other complications that together cannot be easily corrected in patients with pre-existing health conditions. The positive responses of only some COVID-19 patients to antibiotic and anti-malaria therapy could have been the result of suppression of Mycoplasma species and other bacterial co-infections in subsets of patients. Thus it may be useful to use molecular tests to determine the presence of pathogenic Mycoplasma species and other pathogenic bacteria that are commonly found in atypical pneumonia in all hospitalized COVID-19 patients, and when positive results are obtained, these patients should be treated accordingly in order to improve clinical responses and patient outcomes.

Makia Freeman published an overview of the harm of **5G** EMF wireless energy. From that paper, there is a strong causal relationship between **5G** EMF wireless, Mycoplasma, and a host of diseases.

5G Danger: 13 Reasons 5G Wireless Technology Will Be a Catastrophe for Humanity

The **5G** danger can't be overstated.

5G (5th Generation) is now being actively rolled out in many cities around the world. Simultaneously, as awareness over its horrific health and privacy impacts is rising, many places are issuing moratoriums on it or banning it, such as the entire nation of Belgium, the city of Vaud (Switzerland) and San Francisco (USA). Radiofrequency radiation (RF or RFR) and electromagnetic fields (EMF) are being increasingly recognized as new types of pollution – environmental pollution. Here are 13 reasons exposing the **5G** danger, which could turn into an unmitigated health and privacy catastrophe if enough people don't rise up to stop it.

1. **5G** Danger: Hijacking Your Sweat Duct Antennae

The **5G** network uses and broadcasts frequencies which affect our sweat ducts, which act as antennae. In other words, our largest organ, the skin, can be influenced and manipulated by **5G**. As I reported in this article **5G** and IoT: Total Technological

Control Grid Being Rolled Out Fast, scientist Dr. Ben-Ishai exposed the connection between **5G** and our body's sweat ducts in this video:

"[The **5G** frequencies] will zap [us] with wavelengths that will interact with the geometrical structure of our skin ... We found that sweat ducts work like helical antennas ... the sweat duct was an integral part of the mechanism for the absorption of energy, electromagnetic, between 75-100 GHz, and that if you changed the character of the sweat duct, i.e. made it work, you could actually change that absorption at some point, and if you could do that you could trace how a person is under stress."

2. **5G** Danger: **5G** Amplifies EMF Damage via VGCCs

Wireless radiation and EMF scientist Dr. Martin Pall has done groundbreaking research in explaining exactly how EMFs cause premature aging and injury to the human body, including damage to fertility, brains, hearts and even DNA! He pioneered research showing how EMFs activate the body's VGCCs (Voltage-gated calcium channels) which causes them to release excess calcium ions into the cell. This then leads to nitric oxide (NO) and superoxide which react nearly instantaneously to form peroxynitrite and free radicals. Many studies like this show peroxynitrite damages DNA. Dr. Pall has stated unequivocally that the "**5G** rollout is absolutely insane."

3. **5G** Danger: Pulsed Wave Far More Damaging than Continuous Wave Radiation

A significant and unique feature of Smart Meters is that they emit pulsed wave radiation not continuous wave radiation. In other words, they run in start-stop cycles of emitting a burst of EMF then going temporarily inactive. This happens an incredibly high amount of times per day; court documents with testimony from utility companies (like Pacific Gas and Electric Company of California) reveal that smart meters send pulsed waves between 9,600 and 190,000 times per day!

In this 2018 video, Dr. Pall states there are 13 studies which show that pulsed wave EMFs are more active (and dangerous) than continuous wave EMFs. You can read the evidence here.

4. **5G** Danger: **5G** Promotes Deep EMF Penetration

The main reason why cell or mobile phones are more dangerous for children than adults (apart from the fact that radiation absorption is cumulative over a lifetime) is due to EMF penetration.

Dr. Pall writes:

"The industry has also made claims that more conventional microwave frequency EMFs are limited in effect to the outer 1 cm of the body. We know that is not true, however because of the effects deep in the human brain, on the heart and on hormone systems. Perhaps the most important two studies demonstrating effects deep within the body are

the studies of Professor Hässig and his colleagues in Switzerland on cataract formation in newborn calves. These two studies clearly show that when pregnant cows are grazing near mobile phone base stations (also called cell phone towers), the calves are born with very greatly increased incidences of cataracts.”

Hässig wrote in his 2009 study:

“Of 253 calves, 79 (32%) had various degrees of nuclear cataract, but only 9 (3.6%) calves had severe nuclear cataract. Results demonstrate a relation between the location of veals calves with nuclear cataracts in the first trimester of gestation and the strength of antennas. The number of antennas within 100 to 199 meters was associated with oxidative stress and there was an association between oxidative stress and the distance to the nearest MPBS (Mobile Phone Base Station).”

5. **5G** Danger: **5G** is a Weapons System Disguised as a Consumer Convenience

Mark Steele has been very outspoken against **5G** and has now been widely interviewed, including by Project Camelot and also by Sacha Stone in his documentary **5G** Apocalypse: The Extinction Event. Steele claims that although widespread reports state that **5G** is operating in the 24-100 GHz range, it is actually sub-gigahertz (meaning under the GHz threshold, so still measured in MHz). He says **5G** is a weapons system like long-range radar, phased array radar and directed energy (DEW was used in 9/11 and various fires like the Paradise fires). He claims that when you examine **5G** hardware, it has a dielectric lens which is proof it is a weapons system. Autonomous vehicles can use **5G** to shine in mirrors of other drivers (which is so strong and damaging it is equivalent to assault). Mark talks about how **5G** is powerful enough to kill babies in wombs. He states:

*“**5G** is a weapons system, nothing more, nothing less. It’s got nothing to do with telecommunications for humans. **5G** is a machine to machine connection for autonomous vehicles.”*

6. **5G** Danger: LA Firefighters Develop Ailments After Being Too Close to Towers

In this video a 25 year veteran firefighter from Los Angeles compares cell towers to cigarettes. He calls for a stop to the cell/mobile phone base stations being built on or near fire stations. Firefighters are not the only ones suffering the effects; it was reported that hundreds of birds fell from the sky in the Netherlands during a **5G** test.

7. **5G** Danger: Same Frequencies as used for Crowd Dispersal

5G purportedly uses millimeter wave (MMW) frequencies, so called because the frequencies are so high (in the 24-100 GHz range). Since 1 GHz = 1 billion Hz, we are talking about frequencies with very very short wavelength (the distance between the peak of one wave and the next). The distances are so tiny they are measured in millimeters, hence the term millimeter wave. These are the exact same frequencies

used by the military for their non-lethal weapons such as Active Denial Systems for crowd dispersal. These weapons have the capacity to cause tremendous injury. Dr. Paul Ben-Ishai said, "If you are unlucky enough to be standing there when it hits you, you will feel like your body is on fire."

8. **5G** Danger: Mutagenic (Causing DNA Damage) and Carcinogenic (Causing Cancer)?

The MMW frequencies of **5G** cause mitochondrial DNA damage – which is then passed down through generations. **5G** is mutagenic. These mutations are inherited by the next generation! This has grave implications for genetic purity. How many people are thinking about this when they can't stop looking at their screens? This website lists many studies showing the mitochondrial damage that occurs after exposure to EMF radiation.

With mutagenesis usually comes carcinogenesis. In other words, once something is powerful and dangerous enough to cause DNA damage, chances are high it will lead to cancer. Mark Steele says **5G** is a class 1 carcinogen, although the WHO (World Health Organization) very conservatively classifies cell phone towers as a class 2b possible carcinogen. It's important to note, however, that the WHO is an agency of the UN which was set up by the Rockefellers, an illustrious NWO Illuminati family who plan to use the UN as a vehicle to usher in a One World Government.

5G is being rushed out without the proper safety testing done, so we don't have much data on how **5G** specifically causes cancer, but there is an abundance of evidence showing how 2G, 3G and 4G EMFs are implicated in many kinds of cancer, including brain cancer. This website has a good collection of the many studies done.

9. **5G** Danger: Phased Array Densification

5G requires significantly more transmitters or broadcasters than earlier generations. It is a plan of massive infrastructure creation, with stations, towers and bases planned to be put almost everywhere, including in the heart of residential neighborhoods. The effects of this kind of densification could be disastrous.

5G is powerful enough to 3D map the inside of your home and other buildings. Mark Steele specifically highlights the 868 MHz frequency, previously used for battlefield interrogations and which can travel with ease through bricks and concrete. He claims this frequency can single out specific people ... interesting given all the electronic harassment and gang stalking which occurs against TIs (Targeted Individuals).

5G infrastructure will consist of small phased array antennas shooting out radiation at their targets like a bullet. The rays of microwaves they produce will be strong enough to pass through walls and human bodies. We will be blanketed with this 24/7/365, and what's worse, the coverage area is slated to be broader than the current 4G, eventually encompassing every square inch of Earth.

10. **5G** Danger: Killing All the Insects?

Insects, birds and children are the most vulnerable to **5G** due to their body size. Claire Edwards is a former UN staff editor who brought the EMF/**5G** issue to their attention of UN Secretary General Antonio Guterres. She stated in an anti-**5G** rally speech in Stockholm:

*“It’s interesting to note that in the last 20 years we have lost 80% of our insects. And if we get **5G**, we’re going to lose 100% of our insects. When the insects go, we go too.”*

Both insects and **5G** need antennas: insects use them, among other things, in their sense of smell, while **5G** uses them to propagate waves. Not surprisingly, insects are sensitive to **5G** EMF waves; this recent study showed that insects exposed to **5G** radiation experienced an increase in their body temperature.

*“Studies have shown that the frequencies used by **5G** increase the body temperature of insects. This phenomenon was not observed with 4G or Wi-Fi.”*

Meanwhile the study Exposure of Insects to Radio-Frequency Electromagnetic Fields from 2 to 120 GHz concludes:

“Future wavelengths of the electromagnetic fields used for the wireless telecommunication systems will decrease and become comparable to the body size of insects and therefore, the absorption of RF-EMFs in insects is expected to increase.”

11. **5G** Danger: Space-Based **5G**

5G is planned to be an inescapable grid – with plans afoot to beam it down from space! This ties into the Space Fence agenda as I discussed in my article Space Fence: Connecting the Surveillance and Transhumanist Agendas. The organization International Appeal Stop **5G** on Earth and in Space writes:

*“At least five companies are proposing to provide **5G** from space from a combined 20,000 satellites in low- and medium-Earth orbit that will blanket the Earth with powerful, focused, steerable beams. Each satellite will emit millimetre waves with an effective radiated power of up to 5 million watts from thousands of antennas arranged in a phased array.”*

It is vital to understand the bigger picture of the grand conspiracy here. All these disruptive and hazardous technologies – **5G**, wi-fi, wireless radiation, HAARP, ionospheric heating, geoengineering, GMOs, etc. – are going to be woven into one giant integrated system of surveillance, command and control. Just as one small example, geoengineering involves the spraying of chemtrails loaded with metal particulates – which **5G** can use.

12. **5G** Danger: Re-Radiation Inside the Body

Way back in 2002, RF researcher Arthur Firstenberg published an analysis of **5G** long before the technology was approved. He explained how, due to 5G EM pulses being extremely short and delivered in bursts, they actually replicate inside the body – and end up creating tiny new **5G** antennas internally. Firstenberg wrote:

“... when extremely short electromagnetic pulses enter the body, something else happens: the moving charges themselves become little antennas that re-radiate the electromagnetic field and send it deeper into the body ...”

“These re-radiated waves are called Brillouin precursors ... They become significant when either the power or the phase of the wave changes rapidly enough ... This means that the reassurance we are being given – that these millimeter waves are too short to penetrate far into the body – is not true.”

This echoes a previous point made – that **5G** penetration is a serious danger.

13. **5G** Danger: Insurance Companies Refuse to Underwrite Big Wireless. What Do They Know?

Insurance companies (the most famous of which is Lloyds of London) have made headlines by refusing to insure Big Wireless (the telecommunication corporate conglomerate) against wi-fi and 5G-related illnesses and claims:

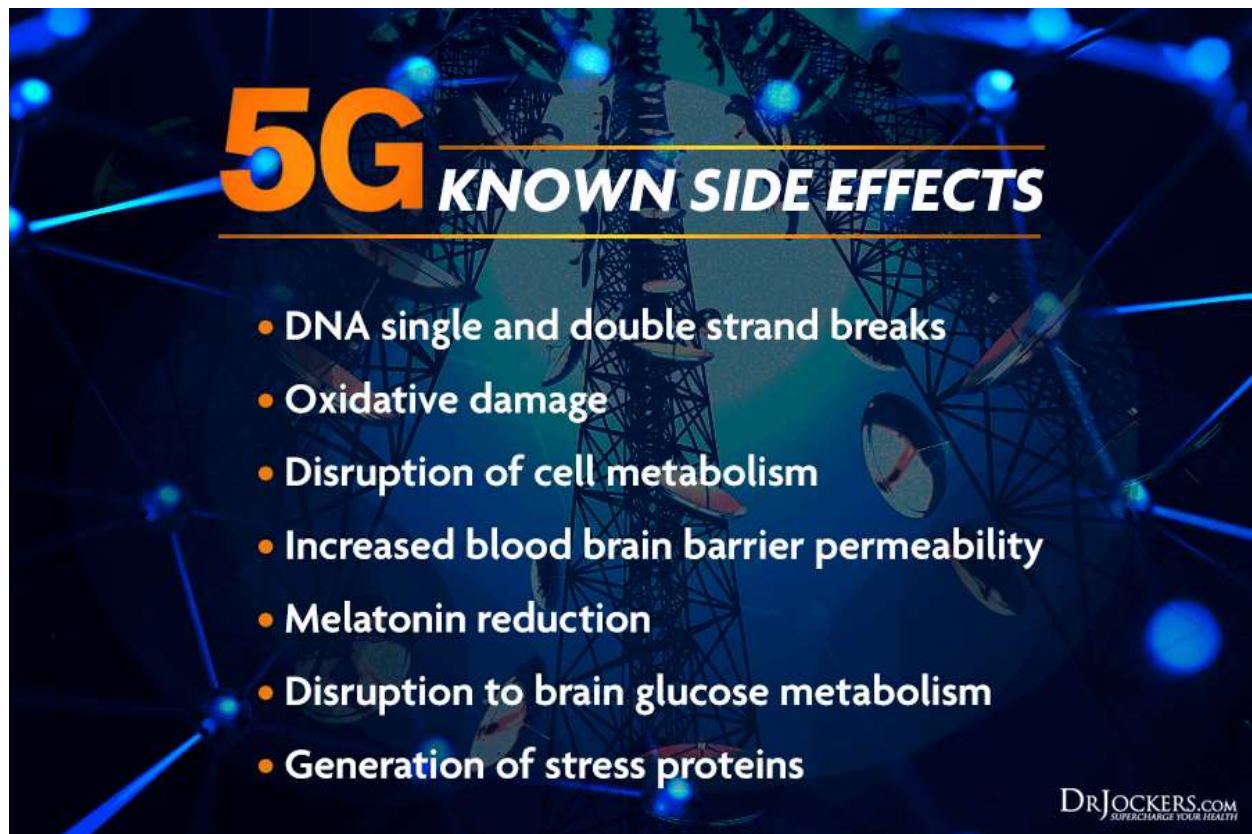
“Well, Lloyd’s November 2010 Risk Assessment Team’s Report gives us a solid clue: the report compares these wireless technologies with asbestos, in that the early research on asbestos was “inconclusive” and only later did it become obvious to anyone paying attention that asbestos causes cancer. Keep in mind that Lloyd’s Risk Assessment study of wi-fi was published over 8 [now 9 – Ed.] years ago. Even back then, however, their Risk Assessment Team was smart enough to realize that new evidence just might emerge showing that the various wi-fi frequencies do cause illness.”

Conclusion: **5G** Grid Part of Larger Command, Control, Surveillance and Artificial Intelligence (AI) Agenda

5G is qualitatively and quantitatively different to 4G. It is much more than just the next step up from 4G. **5G** will not only beam tens to hundreds times more radiation than 4G, but the introduction of MMW technology means a whole new host of hazards. History repeats itself. Just like it took some time for real science to catch up with tobacco/cigarettes, and just like it took some time for real science to catch up with the monstrosity that are GMOs (now rebranded as BioEngineered Foods), so too will real science catch up with **5G**. In the meantime, you can expect all sorts of junk science to be put forth to justify it, including mis-directions and distractions like only focusing on the

5G – A Type of Directed Energy Weapon

For the deeper background to **5G**, read Makia's 2017 article "**5G** and IoT: Total Technological Control Grid Being Rolled Out Fast." Many people around the world, including concerned citizens, scientist and even governmental officials, are becoming aware of the danger of 5G. Numerous scientists have warned of the dangerous health effects of **5G**. For instance, in this **5G** Appeal from 2017 entitled Scientists and Doctors Warn of Potential Serious Health Effects of **5G**, scientists warned of the harmful of non-ionizing RF/EMF radiation:

"Effects include increased cancer risk, cellular stress, increase in harmful free radicals, genetic damages, structural and functional changes of the reproductive system, learning and memory deficits, neurological disorders, and negative impacts on general wellbeing in humans. Damage goes well beyond the human race, as there is growing evidence of harmful effects to both plants and animals."

Guess what virus they happen to choose for their ‘simulation’? A coronavirus! Guess what animal cells they use? Pig cells! (COVID-19 was initially reported to be derived from a seafood market, and the fish there are known to be fed on pig waste). Event 201 includes the UN (since the WEF now has a partnership agreement with UN), Big Pharma (Johnson and Johnson), Bill Gates (key figure in pushing vaccines, human microchipping and Agenda 2030) and both China and America’s CDC. Participants in Event 201 recommended that governments force social media companies to stop the spread of ‘fake news’ and that ultimately the only way to control the information would be for the WHO (World Health Organization, part of the UN) to be the sole central purveyor of information during a pandemic.

Inovio, Electroporation and 5G

As reported on January 24th, 2020, U.S. biotech and pharmaceutical company Inovio received a \$9 million grant to develop a vaccine for the coronavirus. Inovio got the money grant from the Coalition for Epidemic Preparedness Innovations (CEPI), however they already have an existing partnership with CEPI; in April 2018 they got up to \$56 million to develop vaccines for Lassa Fever and Middle East Respiratory Syndrome (MERS). CEPI was founded in Davos by the governments of Norway and India, the Wellcome Trust ... and the participants of Event 201: the Bill and Melinda Gates Foundation and the WEF. CEPI’s CEO is the former director of BARDA (U.S. Biomedical Advanced Research and Development Authority) which is part of the HHS. Inovio claimed they developed a coronavirus vaccine in 2 hours! On the face of it such a claim is absurd; what is more likely is that they are lying or that they already had the vaccine because they had the foreknowledge that the coronavirus was coming and was about to be unleashed.

So who owns and runs Inovio? Two key men are David Weiner and Dr. Joseph Kim. Weiner was once Kim’s university professor. Weiner was involved with developing a vaccine for HIV and zika (you can read my articles about zika here and here where I exposed some of the lies surrounding that epidemic). Kim was funded by Merck (a large Big Pharma company) and produced something called Porcine Circovirus (PCV 1 and PCV 2). As mentioned above, there is a link between pig vaccines/pig DNA and the coronavirus; Annie Logical notes that it “has long been established that seafood in the area is fed on pig waste.” Kim served a 5-year tenure as a member of the WEF’s Global Agenda Council – yet another organ pushing the New World Order One World Government under the banner of Agenda 2030 Global Governance.

Weiner is an employee and advisor to the FDA, is considered a DNA technology expert and pioneered a new DNA transference method called electroporation – a microbiology technique which uses an electrical pulse to create temporary pores in cell membranes

through which substances like chemicals, drugs or DNA can be introduced into the cell. This technique can be used to administer DNA vaccines, which inject foreign DNA into a host's cells that changes the host's DNA. This means if you take a DNA vaccine, you are allowing your DNA to be changed! As if vaccines weren't already horrific enough ... but here's the kicker: electroporation uses pulsed waves. Guess what else uses pulsed waves? **5G**! This is either a startling coincidence or evidence or a sinister coronavirus 5G-connection. Annie writes:

"[T]he same action that **5G** technology uses in pulsed waves and the coronavirus was reported to have started in an area in China that had rolled out **5G** technology! So we can see how geneticists using scientists are tampering with the building blocks of our existence and what is disturbing is that Prof Wiener is a HIV pioneer and we know that soon after the Polio vaccines were given to millions in Africa that HIV emerged. They have perfected the art of injecting animal or bird DNA into human chromosomes which alters our DNA and causes things like hemorrhaging, fever, cancers and even death."

Coronavirus manmade quote:

Speaking of HIV (which is not the same things as AIDS, but that is another story), remember also that a group of Indian scientists put out their research that the virus was manmade and had HIV inserts. They found that 4 separate HIV genes (inserted) were randomly embedded within the coronavirus. These genes somehow converged to create receptor sites on the virus that were identical to HIV, which was a surprise due to their random placement. They also specifically stated that this was not likely to happen naturally ("unlikely to be fortuitous in nature"). In yet another example of egregious censorship, these scientists were pressured to withdraw their work.

5G and Electroporation DNA Vaccines – Both Producing Pulsed EMF Waves

Consider the implications of this for a moment. The technology exists to use EMFs to open your very skin pores and inject foreign DNA into your bloodstream and cells. This is an extreme violation of your bodily sovereignty, and it can have long-term effects, because of genetic mutation – changing your very DNA which is the biological blueprint and physical essence of which you are.

What if **5G** mimics electroporation? What if **5G** can do on a large scale what electroporation does on a small scale? We already know that **5G** has the potential to be mutagenic (DNA-damaging). The frequencies that **5G** uses, especially 75-100GHz, interact with the geometrical structure of our skin and sweat ducts, acting upon them like a transmission reaching an antenna, and fundamentally affecting us and our mood.

What if **5G** is being used to open up the skin of those in Wuhan so as to allow the new bioweapon coronavirus to infiltrate more easily?

Mandatory Vaccines, Depopulation and Transhumanism

So, what's at the bottom of the coronavirus-5G connection rabbit hole? I would suggest we find mandatory vaccine agenda, the depopulation agenda and transhumanist agenda (via DNA vaccines). The key figures and groups who appear to have planned this already have the vaccine in place, just as they did for the other epidemics that fizzled out (SARS, Ebola and zika). Weiner even has links to HIV/AIDS, and if you dive into that as Jon Rappoport did, you find gaping holes in that story.

It's the same epidemic/pandemic game played out every 2-3 years. There's a couple of versions. In the first version, you invent a virus, hype it up, get people scared, do ineffectual and inconclusive tests (e.g. like the PCR test which measures if a viral fragment is present but doesn't tell you the quantities of whether it would actually causing the disease), inflate the body count, justify quarantine/martial law and brainwash people into thinking they have to buy the (toxic) vaccine and introduce mandatory vaccination. You don't even need a real virus or pathogen for the version. In the second version, you create a virus as a bioweapon, release it as a test, pretend it was a natural mutation, watch how many people it kills (which helps with the eugenics and depopulation agendas), again justify martial law, again justify the need for mandatory vaccines and even pose as the savior with the vaccine that stops it. As a variation on this second version, you can even develop a race-specific bioweapon so as to reduce the population of rival nations or enemy races as a geopolitical strategy. This article suggests that the coronavirus targets Chinese people/Asians more than others, and certainly the official death count attests to that, although it's always hard to trust governmental statistics. Annie Logical gives her take:

"The con job goes like this.

Step 1) poison the population purposely to create disease that does not and would never occur naturally

Step 2) parlay the purposely created disease as being caused by something invisible, outside the realm of control or knowledge of the average person

Step 3) create a toxic vaccine or medication that was always intended to further poison the population into an early grave

Step 4) parlay the vaccine or medication poisoning as PROOF the disease, which never existed, is much worse than anticipated

Step 5) increase the initial poisoning, which is marketed as a fake disease, and also increase the vaccine and medication poisoning, to start piling the bodies into the stratosphere

Step 6) repeat as many times as possible upon an uninformed population because killing a population this way (the art of having people line up to kill themselves with poison.....known as a "soft kill" method) is the only legal way to make sure such eugenic operations can be executed on mass and in plain sight."

DNA vaccines are a disturbing new advancement for transhumanism. After all, the objective of the transhumanist agenda is to merge man with machine, and in doing so, wipe out what fundamentally makes us human, so we can be controlled and overtaken by a deeply sinister and negative force. It's all about changing us at the fundamental level, or attacking human sovereignty itself. DNA vaccines fit right in with that – literally changing your DNA by forcefully inserting foreign DNA to change your genetics, with consequences no one could possibly fully foresee and predict.

One Last Coronavirus-5G Connection

Finally, I will finish with another coronavirus-5G connection. The word coronavirus itself refers to many kinds of viruses by that name, not just COVID-19. Guess who owns a patent for a coronavirus strain that can be used to develop a vaccine? The Pirbright Institute. And guess who partially owns them? Bill Gates! As you can read here Pirbright is being supported in their vaccine development endeavors by a British company Innovate UK ... who also funds and supports the rollout of 5G. Innovate UK ran a competition in 2018 with a £15 million share out to any small business that could produce vaccines for 'epidemic' potential.

The Motivation to Hype and the Motivation to Downplay

History has shown that in cases of epidemics (or fake epidemics) there is almost always a morass of conflicting reports and contradictory information. In such situations, it can be very difficult to get to the bottom of the matter and find the truth. The conflict stems from the different motivations of nations, governments and other interested groups. Essentially, there are 2 main motivations: the motivation to hype (exaggerate and use fear to grab attention, sell something, make a group look bad/incompetent, make people scared, make the public accept mandatory vaccination and martial law) and the motivation to downplay (cover up and hide the true extent of the damage, morbidity or mortality so as to appear competent and in control, to lessen possible anger, backlash or disorder). Sometimes, these 2 motivations may drive the behavior of the same group, e.g. in the case of the Chinese Government, it has the motivation to hype (to get people afraid so they easily follow its draconian quarantine rules) and the motivation to downplay (so as to appear in the eyes of its people and the rest of the entire world to have the situation under control, to ensure saving face, credibility and a good reputation).

Final Thoughts on the Coronavirus 5G Connection

Governments around the world have experimented with bioweapons both on their own citizens and foreign citizens, and even sold that research to other governments for their own benefit (e.g. Japan's notorious Unit 731 which developed bioweapons in China, only to hand over that research to the U.S. after losing World War 2). See Bioweapons: Lyme Disease, Weaponized Ticks, Plum Island & More for a brief history of the USG's usage of weaponized ticks which resulted in Lyme Disease. **The evidence that COVID-19 is a bioweapon is overwhelming – and so is the evidence that 5G is involved to either cause the flu-like symptoms/pneumonia people have been experiencing, and/or to exacerbate the virility of the virus by weakening people's immune systems and**

subjecting them to pulsed waves of EMF to open up their skin to foreign DNA fragments (including viruses).

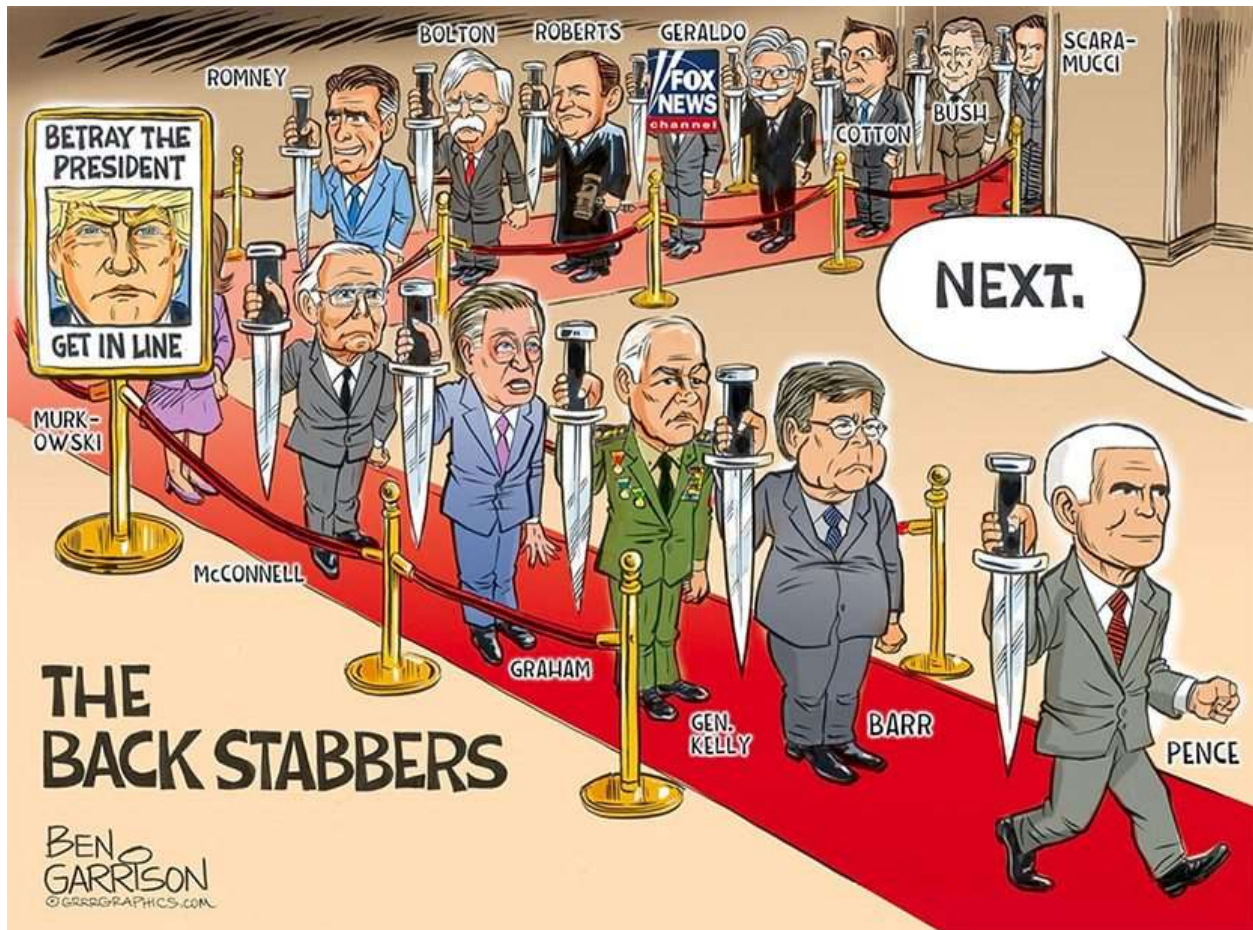

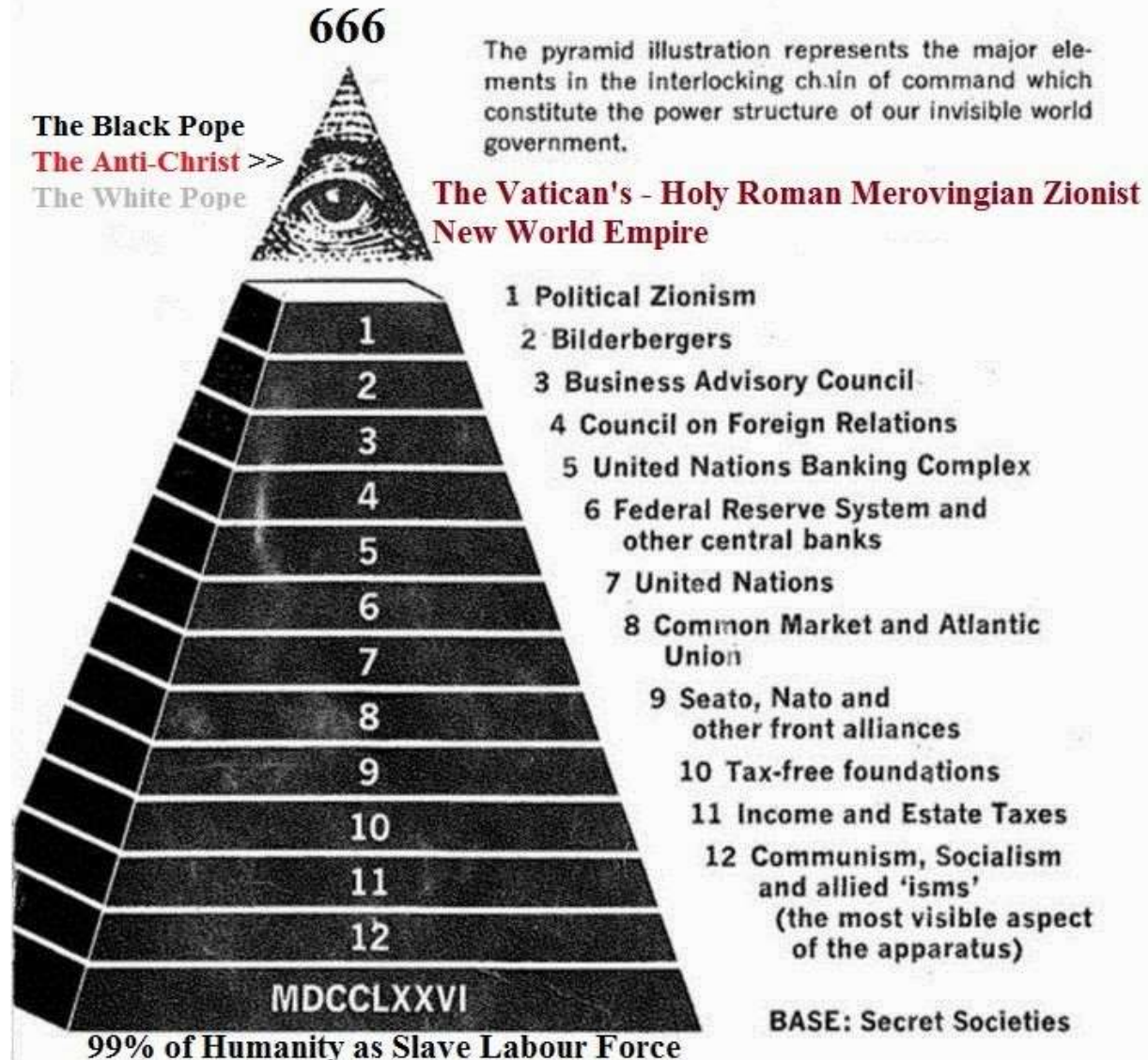
