

Study Analyzes Wireless Radiation- COVID Connection

AT A GLANCE...

□THE STORY: A new study from January 2021 analyzes the close similarities and effects that EMF radiation and COVID have on the human body.

□THE IMPLICATIONS: While the study doesn't prove causation, it shows a preponderance of evidence that wireless radiation effects could easily be called 'COVID.' There is no need for a strange new virus.

A new study that analyzes RFR and EMF in light of the SARS-CoV-2 virus has found compelling evidence of a radiation-COVID connection.

The wireless radiation-COVID connection cannot be ignored if one is truly committed to discovering the underlying medical causes of whatever this COVID thing is. I have dedicated most of my articles to exposing the scandemic, the fake death count, the fake numbers, the fake PCR test, the fake vaccine, the non-existent virus and more. However, I am writing this to bring some focus back to what could be a major factor in causing the genuine and legitimate illness some people have experienced from what is called COVID. Early on in the pandemic I talked about the 5G-coronavirus connection. Now, I'd like to broaden the focus to EMF (Electromagnetic Fields or Frequencies) and RFR (Radio Frequency Radiation) in general, both of which are forms of non-ionizing radiation. A study this year from January 2021 entitled "Evidence for a Connection between COVID-19 and Exposure to Radiofrequency Radiation from Wireless Telecommunications Including Microwaves and Millimeter Waves" analyzes this theme and finds some compelling evidence to support the radiation-COVID connection.

Uncovering the Wireless Radiation-COVID Connection

A hallmark of Operation Coronavirus has been the invention of an entirely new disease (COVID-19) with such broad and vague symptoms that virtually anything, but especially the common cold, flu and pneumonia, could be reclassified and recategorized as this new disease. My April 2020 article pointed out how it was crucial to avoid the trap of thinking COVID was some new thing, when there was not 1 disease and not 1 cause. That being said, it is beyond coincidence that many COVID symptoms match up with many effects of radiation exposure. The authors of the study state they have examined "a large body of peer reviewed literature, since before World War II, on the biological effects of wireless radiation that impact many aspects of our health" and that from this research they were able to discover "intersections between the pathophysiology of

COVID-19 and detrimental bio effects of wireless radiation exposure.” Pathophysiology is defined as “a convergence of pathology with physiology” and is the study of the “disordered physiological processes that cause, result from, or are otherwise associated with a disease or injury.” In simple English, the study found that many of the so-called effects or symptoms blamed on COVID are identical or remarkably similar to ones caused by wireless radiation.

Hypoxia and Hypoxemia

Let’s start with these 2 terms; hypoxia and hypoxemia, which both refer to conditions of under-oxygenation in the body. In the article *Masks Cause Damage: Study Reveals Mask-Hypoxia-Blood Clot Connection*, I highlighted how wearing masks limits oxygen intake which can then lead to potentially fatal blood clots. This study also found very similar effects between EMF/RFR and COVID when analyzing the blood:

“Two recent studies documented the formation of erythrocyte aggregates (Havas, 2013) and erythrocyte aggregates and echinocyte formation upon human exposure to 4G-LTE smart phone radiation (microwaves) (Rubik, 2014) ... Exposure to radiation from a cell phone for two consecutive 45-minute periods caused two types of effects: initially increased stickiness of peripheral red blood cells and rouleaux formation (rolls of stacked red blood cells) and subsequently formation of echinocytes (spiky red blood cells). Similar red blood cell changes have been described in peripheral blood of COVID-19 patients (Lakhdari et al., 2020). Rouleaux formation is observed in 1/3 of COVID-19 patients, whereas spherocytes and echinocytes have been observed at variable levels. Rouleaux formation impedes the microcirculation. These blood changes may also impede oxygen transport, contributing to hypoxia, and increase the risk of thrombosis (Wagner et al., 2013) and therefore stroke, which can manifest in COVID ... In short, both RFR exposure and COVID-19 can cause deleterious effects on red blood cells and reduced hemoglobin levels contributing to hypoxia in COVID.”

The tendency for blood to coagulate (thicken) in dangerous ways accompanies both EMF and COVID, and has been pointed out by doctors such as Dr. Robert Young who speaks of the corona effect. Coincidentally (or not), the AstraZeneca Oxford vaccine (one of the COVID vaccines which is not a mRNA vaccine) is being suspended by 20+ nations due to its apparent tendency to cause blood clots. Hmmm...

Oxidative Stress

Next, the study found that that oxidative stress was another indicator of a radiation-COVID connection. It defines oxidative stress as a “condition reflecting an imbalance between an increased production of ROS [Reactive Oxygen Species] and an inability of the organism to detoxify the ROS or to repair the damage they cause to biomolecules and tissue”:

“Immune dysregulation ... has been identified in the cytokine storm accompanying severe COVID-19 infections and generates oxidative stress (Cecchini and Cecchini, 2020). Oxidative stress and mitochondrial dysfunction may further perpetuate the cytokine storm, worsening tissue damage, and increasing the risk of severe illness and death. Similarly low-level RFR generates ROS in cells that cause oxidative damage. In fact, oxidative stress is considered as one of the primary mechanisms in which RFR exposure causes cellular damage. Among 100 currently available peer-reviewed studies investigating oxidative effects of low-intensity RFR, 93 studies confirmed that RFR induces oxidative effects in biological systems (Yakymenko et al., 2015) ... Oxidative stress is also an accepted mechanism causing endothelial damage (Higashi et al., 2009). This may manifest in patients with severe COVID-19 in addition to increasing the risk for blood clot formation and worsening hypoxemia (Cecchini and Cecchini, 2020).”

Immune Dysregulation, Calcium Levels, Heart Disease and More

The study proceeds to look at all the ways that COVID elicits the same kind of response as EMF radiation, including the immune response, intracellular calcium levels, heart disease and arrhythmias. In all cases, there is strong evidence of a radiation-COVID connection:

“In short, COVID-19 can lead to immune dysregulation as well as cytokine storm. By comparison, exposure to low-level RFR as observed in animal studies can also compromise the immune system, with chronic daily exposure producing immunosuppression or immune dysregulation including hyper activation ... cardiac arrhythmias are more commonly encountered in critically ill patients with COVID ... regarding RFR exposure bio effects, in 1969 Christopher Dodge of the Biosciences Division, U.S. Naval Observatory in Washington DC, reviewed 54 papers and reported that RFR can adversely affects all major systems of the body, including impeding blood circulation; altering blood pressure and heart rate; affecting electrocardiograph readings; and causing chest pain and heart palpitations (Dodge, 1969). In the 1970s

Glaser reviewed more than 2000 publications on RFR exposure bio effects and concluded that microwave radiation can alter the ECG (electrocardiogram), cause chest pain, hyper coagulation, thrombosis, and hypertension in addition to myocardial infarction (Glaser, 1971; 1976).”

The study also specifically mentions 5G:

“Most recently, Bandara and Weller (2017) present evidence that people who live near radar installations (millimeter waves: 5G frequencies) have a greater risk of developing cancer and experiencing heart attacks. Similarly, those occupationally exposed have a greater risk of coronary heart disease. Microwave radiation affects the heart, and some people are more vulnerable if they have an underlying heart abnormality (Cleary, 1969).

In short, both COVID-19 and RFR exposure can affect the heart and cardiovascular system, directly and/or indirectly.”

The Conclusion of the Study

The point of the study was not to prove causation, but rather to show there is some kind of radiation-COVID connection that needs to be further investigated. The authors write that:

“evidence from the literature summarized here suggests a connection between several adverse health effects of RFR exposure and the clinical course of COVID-19. The evidence indicates that RFR may weaken the host, exacerbate COVID-19 disease, and thereby worsen the pandemic. This evidence presented here does not claim causation. Clearly COVID-19 occurs in regions with little wireless communication. In addition, the relative morbidity caused by RFR exposure in COVID-19 is unknown. The question of causation could be investigated in controlled laboratory experiments.”

Here is their conclusion:

“We conclude that RFR and, in particular, 5G, which involves 4G infrastructure densification, has exacerbated COVID-19 prevalence and severity by weakening host immunity and increasing SARS-CoV-2 virulence by (1) causing morphologic changes in erythrocytes including echinocyte and rouleaux formation that may be contributing to hyper-coagulation; (2) impairing microcirculation and reducing erythrocyte and hemoglobin levels exacerbating hypoxia; (3) amplifying immune system dysfunction, including immunosuppression, autoimmunity, and hyper-inflammation; (4) increasing cellular oxidative stress and the production of free radicals exacerbating vascular injury and organ damage; (5) augmenting intracellular Ca²⁺ essential for viral entry, replication, and release, in addition to promoting pro-inflammatory pathways; and (6) worsening heart arrhythmias and cardiac disorders. In short, RFR is a ubiquitous environmental stressor that contributes to adverse health outcomes of COVID-19. We invoke the Precautionary Principle and strongly recommend a moratorium on 5G wireless infrastructure...”

This study is not the first to make the connection between 5G/RFR and COVID. As I covered in my article 5G Induces Coronaviruses: New Study Models Millimeter Wave Influence on DNA, there has been other attempts analyzing this, although that study was later retracted.

Final Thoughts on the Radiation-COVID Connection

It’s always going to be more sexy and spectacular to sell a story of a killer virus rather than explain that each individual is responsible for their own state of health according to how well they cultivate, much like a farmer, their own inner bio-terrain. It’s always going

to be more preferable for Big Gov and the Corporatocracy to blame an invisible enemy rather than admit that, in their unbridled quest for domination and control, their poisoning of the environment – even if by unseen frequencies in the airwaves – is contributing to major disease and sickness in the population. It's just too easy and convenient for the dark forces that rule this world to blame it all on a virus, especially when the alleged effects of a coronavirus so closely mimic the effects of EMF radiation. The COVID op is a chance for us to wake up to a broader picture of reality, particularly in terms of understanding health, disease, viruses, radiation and the worldwide conspiracy.

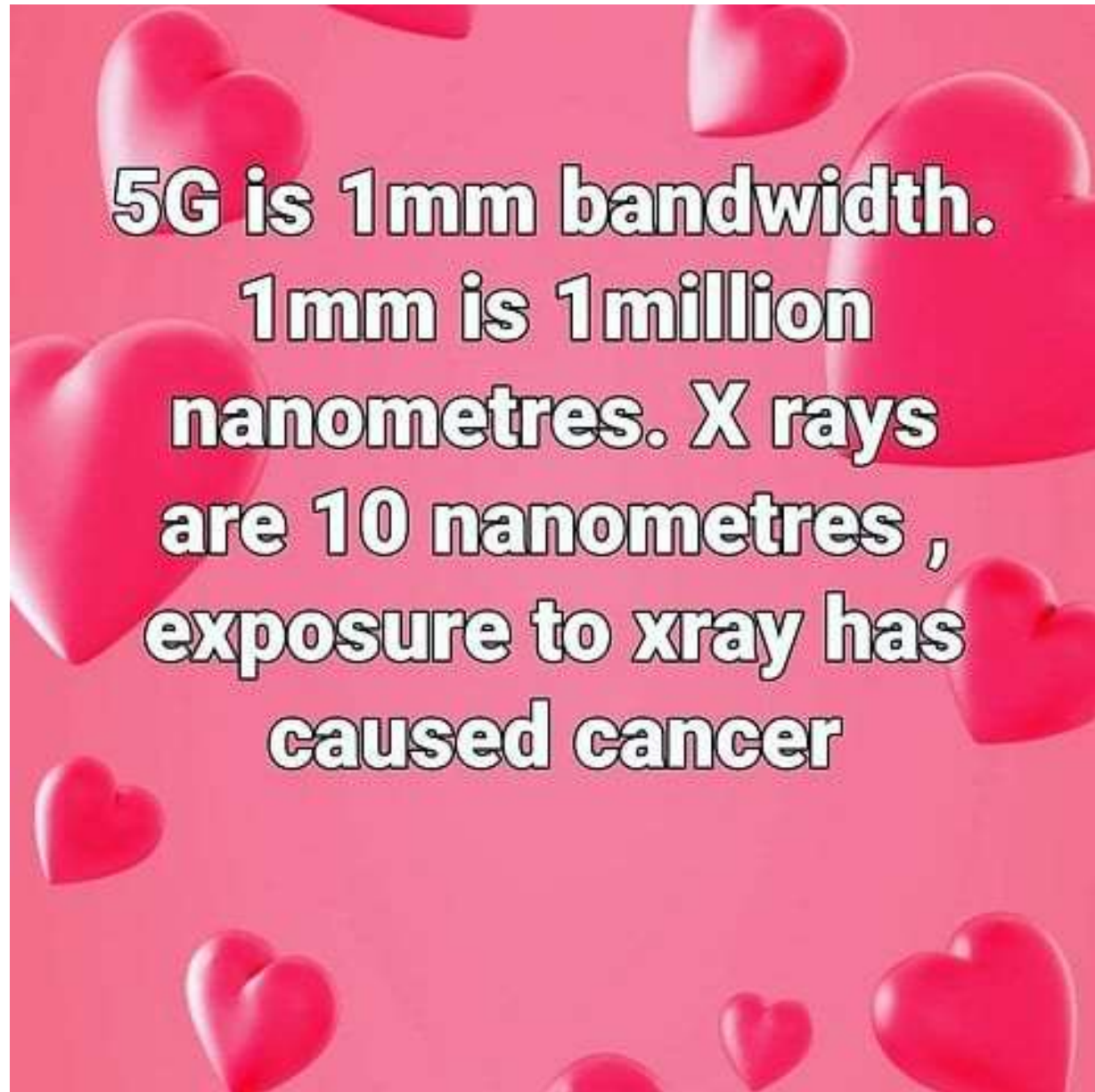

Since exposure to EMF wireless energy is a cumulative thing, it means you will get ill that much faster over a period of years.

Cell phone communications became a reality for the consumer in 1996. Experts in the science of physics and wireless energy knew way back then there would be a latency period before health issues began to manifest in society. The cell phone industry has not updated its safety standards since originally written in 1996. The 5G network utilizes existing 4G infrastructure but with the added energy power needed to keep the signal strength needed to reach point-to-point.

5G EMF uses a millimeter band-width. An illustration on page 7 below provides you a guide for comparison. Study that for a while and let it sink it as to what it implies. The millimeter band-width can be compared to a classroom teacher's laser pointer pen used to focus a classroom of student's attention on the subject of instruction. This millimeter band-width requires sufficient energy level to go from one antenna received to another on down the street. These mini-cell towers because of trees, and other obstructions

have to be within line of eye-sight, and usually are installed on telephone poles roughly every other house on the street.



Once you install the telecom networks high speed Internet, you bring those 5G EMF toxic energy signals right into your living space. As it stands currently, 5G cannot penetrate walls or structures, so long as you do NOT have it wired into your residence. 5G has an Achilles Heel. 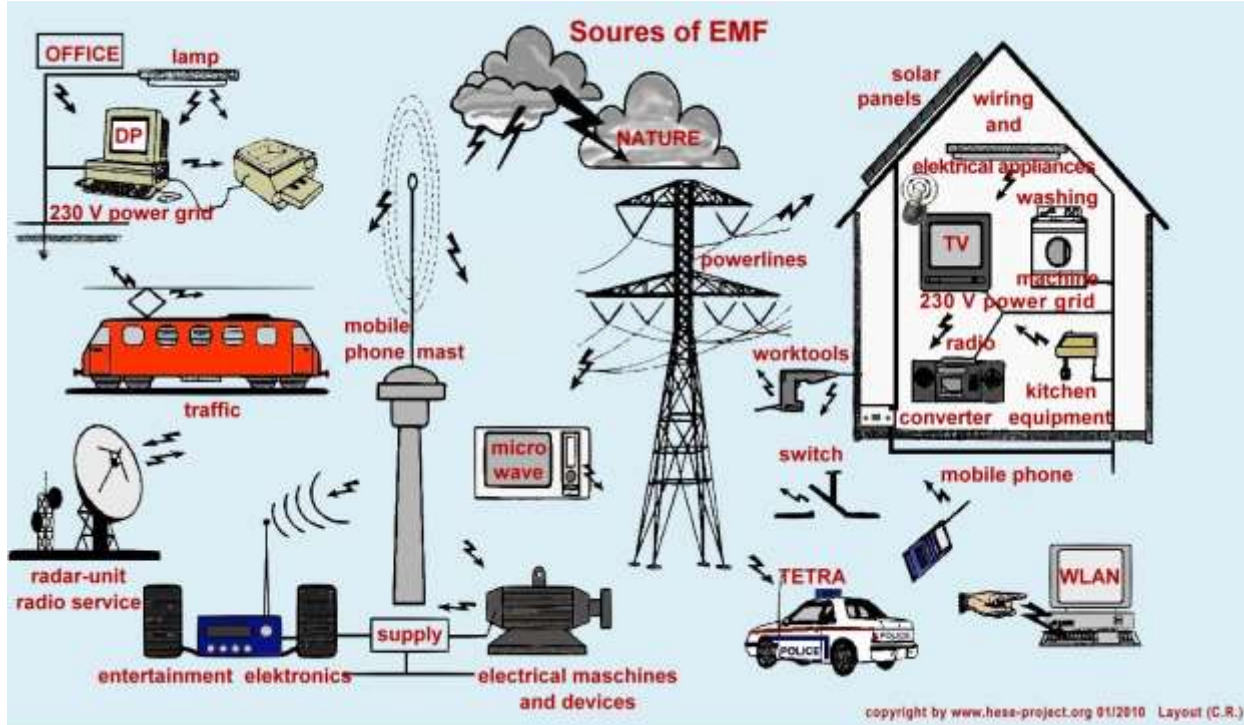

After six years of trying to conceive a child my urologist determined my sperm level was a direct reaction to the exposure of gamma rays from atomic weapons.

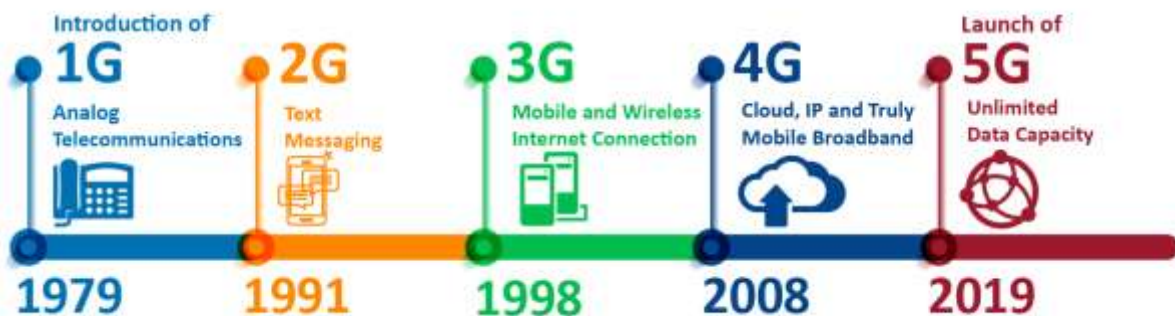

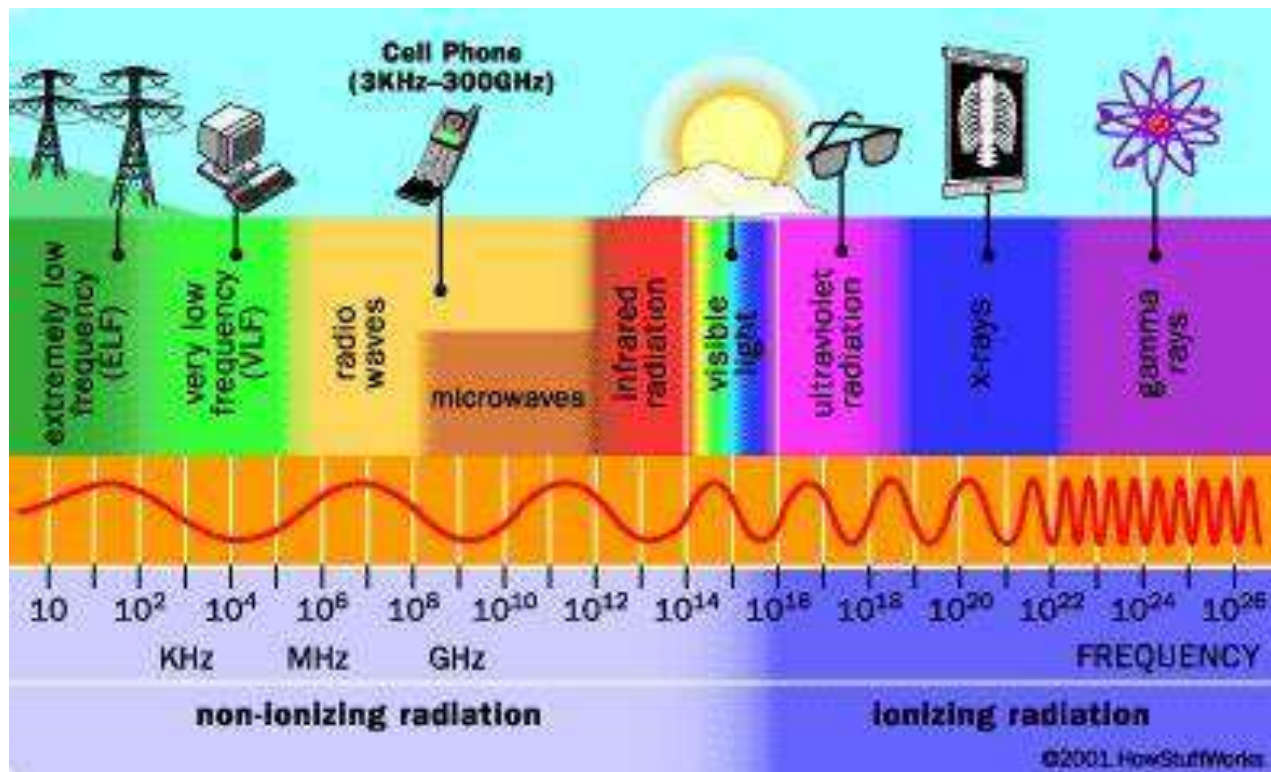
5th Generation (5G) and 5Ghz are not the same thing. Routers use 2.4 GHz and 5 GHz bandwidths to transmit while 5G mobile technology uses much higher frequency ranges and won't even be detected by ordinary wireless EMF sensing devices.

The Evolution of 5G



The U.S. Army deployed 5G weapons in the first Gulf War in 1990, and the chart on the following page was first published in 1972, originally classified, and it reveals that the U.S. Navy was doing studies in EMF and related aspects of weaponry in both in Microwave wireless and Laser technology. Both are deployed as Directed Energy Weapons (DEW). The point of this chart below is to confirm military research in these weapons systems goes back to the early 1970s.

The U.S. Army deployed ADL System at the G8 Summit in 2009 held in Pittsburgh, PA more than a decade ago as a non-lethal means to breakup protestors and crowd demonstration. Advertised as a “non-lethal” heating of the skin is an under-statement to what it is capable of doing. The fact that in a public presentation of the Anti-Denial System an Army full-colonel stated it can produce 100 GHz, we know with certainty that it can drop people dead, literally, in their own footprint! Its lethality is a certified fact by the nature of what I have shared previously and further down in this article.




There are many ways to illustrate and compare the energy spectrum, and the above illustration is easy enough for the non-technical individual; energy is measured in signal frequency of cycles per second, Kilohertz as being the low range, increasing to Megahertz, and Gigahertz being at the upper range.

The “smart” utility meters being installed across the country operate on 4-5 GHz, and airport scanners operate at 10 GHz. It was the health issue of scanners that heightened awareness of the public and became a major issue when TSA operators for an 8-hour shift began to develop cancer and die around the nation’s airports. The original scanners were replaced with newer ones offering better shielding to the operators manning the full body scanners.

It was once believed that non-ionizing radiation was not a serious health issue. Scientists and health professionals have in recent years raised concern about this non-ionizing radiation. The health issues listed on the chart on page 12 have been the major reason for the heightened concern.

The chart below issued by the U.S. Naval Medical Research Institute and the one by U.S. military veterans on page 8, are not exclusive of health issues, and by that I am saying we are learning that other health issues are showing correlation and causal relationship with wireless energy. In my own case, we can identify my Lymphedema began within one week of installation of Verizon Wi-Fi. 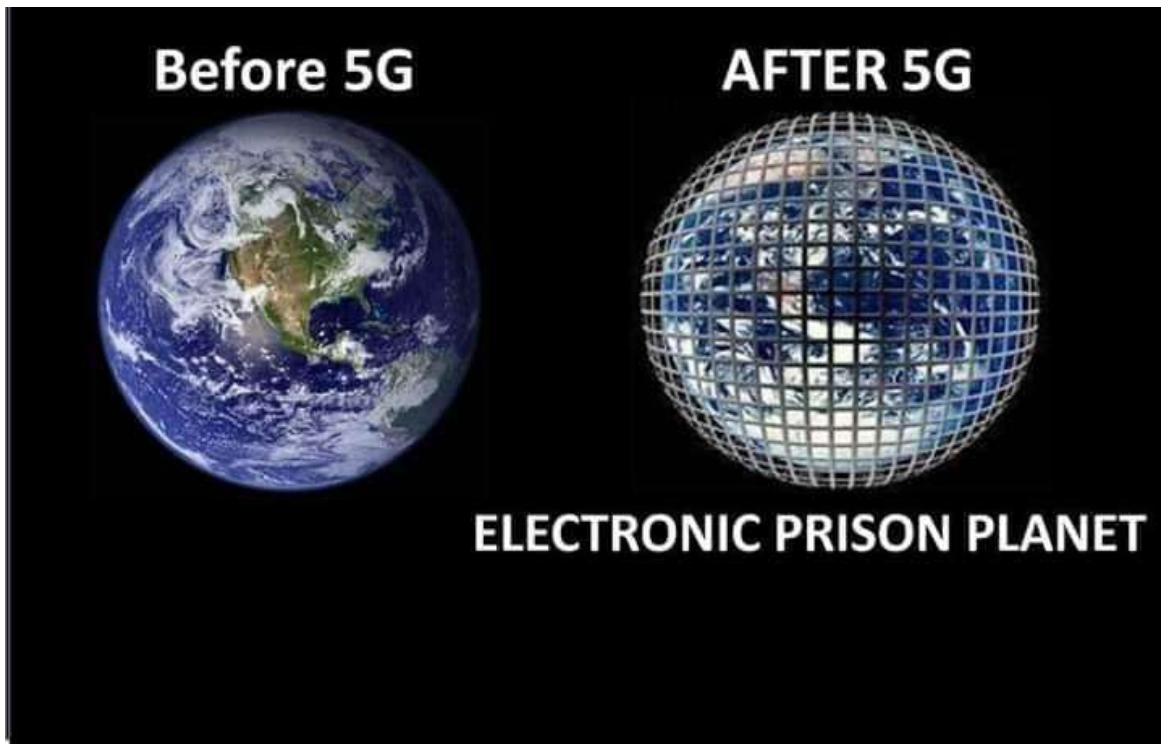

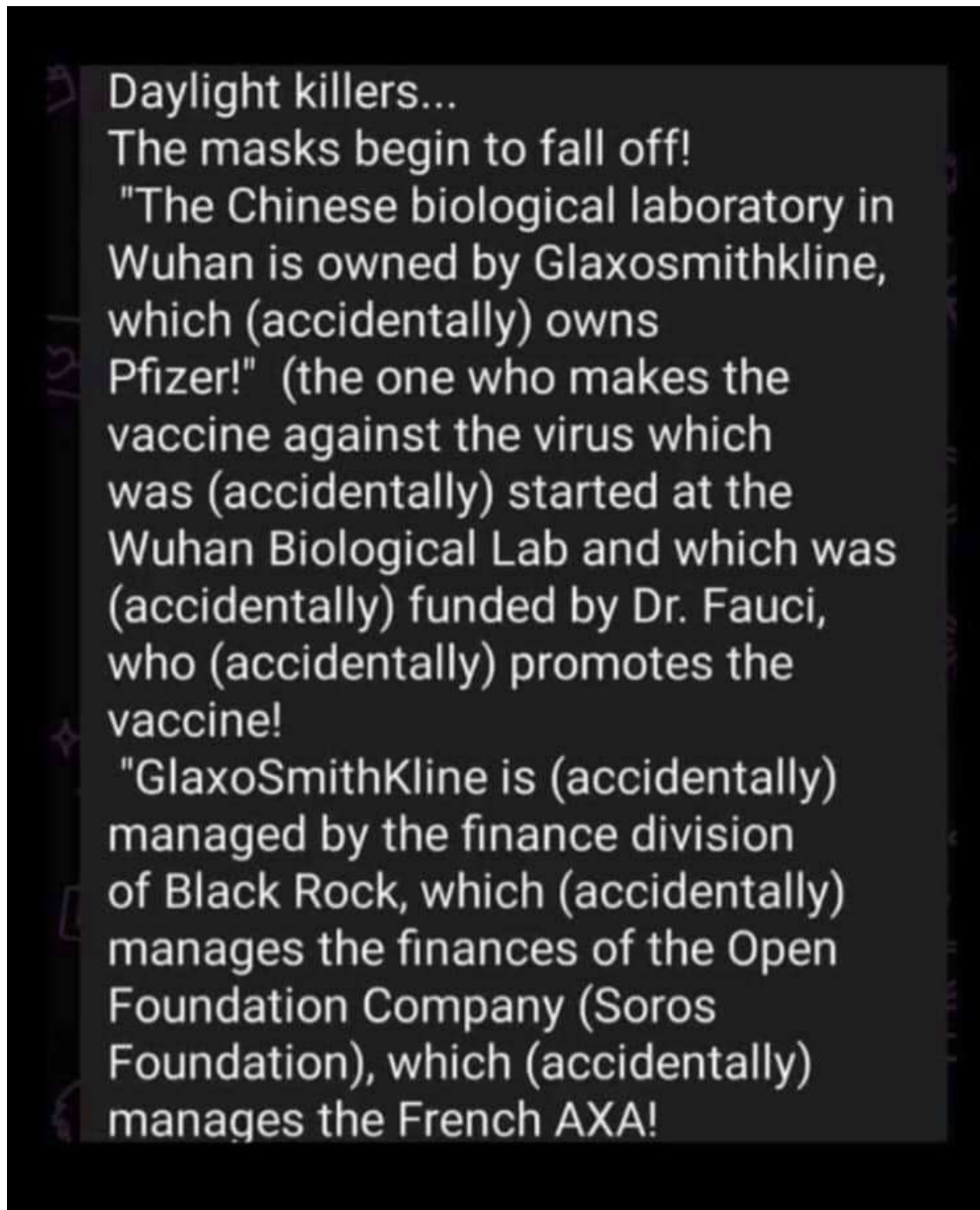

The meme above provides us one of those “connect-the-dots” opportunity, when you begin to piece together the pieces of the puzzle.

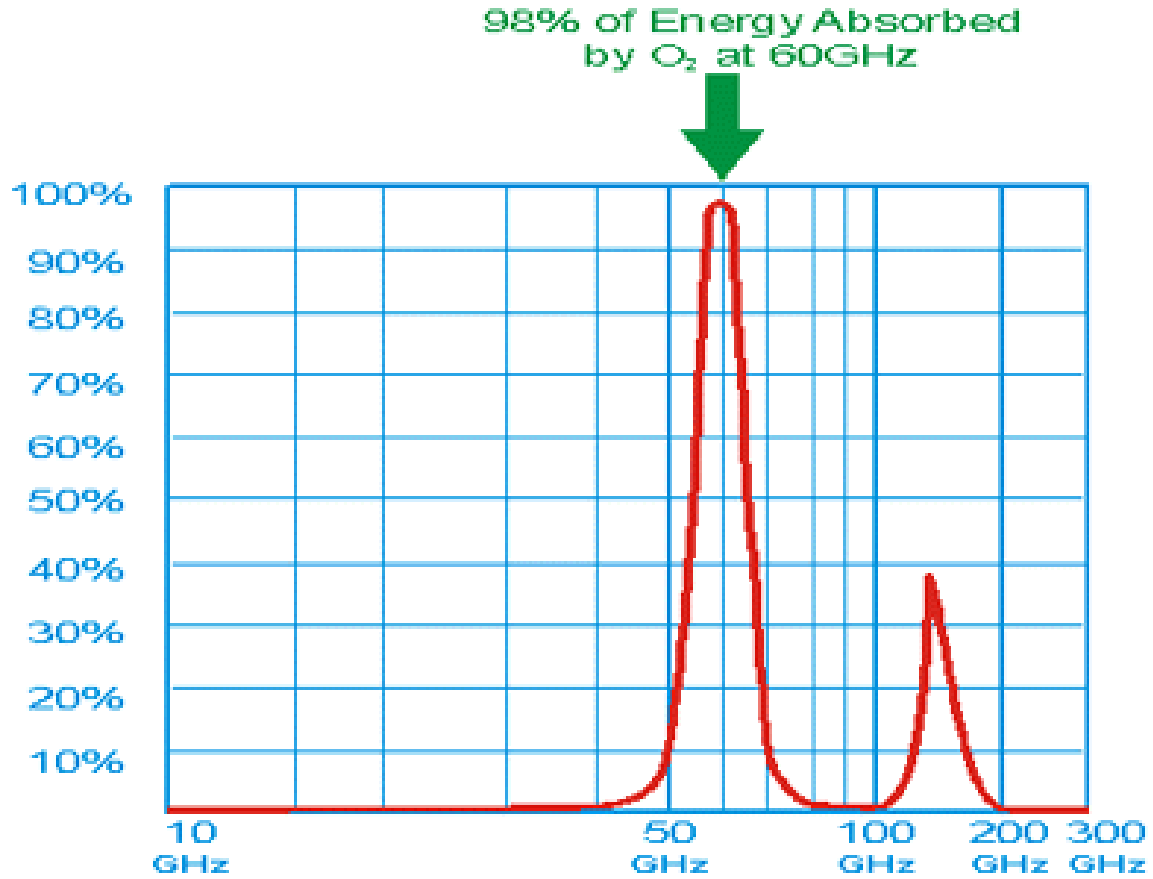
The NWO globalists are very clever, aren't they?

The one thing unknown, something that has proved hard to obtain, is where the cabins, staterooms, compartments of those that were sickened and especially those that died would be an important thing to know in getting to the bottom of the mystery. Another detail that would be important was the physical location of their cabins in relation to one of the many 5G antenna receivers on the “Diamond Princess” sky deck level. The “Diamond Princess” has 14 passenger decks in addition to service decks.

During a cruise that began on 20 January 2020, positive cases of COVID-19 linked to the COVID-19 pandemic were confirmed on the ship in February 2020. 712 people out of 3,711 became infected (567 out of 2,666 passengers and 145 out of 1,045 crew), and 14 people, all of them elderly passengers, died. At the time, the ship accounted for over half the reported cases of SARS-CoV-2 outside of mainland China.

The Diamond Princess departed from the Port of Yokohama on 20 January 2020 for a round-trip billed as a tour of Southeast Asia during the Lunar New Year period, with 2,666 passengers and 1,045 crew on board.

An 80-year-old passenger from Hong Kong, China, had embarked in Yokohama on 20 January. He had been in Shenzhen, Guangdong Province, China on 10 January, then returned to Hong Kong and flew to Tokyo on 17 January to board the ship. He developed a cough on 19 January, but he went on board. He left the cruise when the ship reached Hong Kong on 25 January.

The cruise continued. On 31 January, the ship docked in Taiwan, which according to Vice Premier Chen Chi-mai was *"the earliest country to activate epidemic prevention measures against this disease."* A paper in the *'Journal of Medical Internet Research'* authored by Chen, describes how the passengers of the COVID-19 stricken cruise ship were later traced using mobile phone geolocation, and how their 627,386 contacts were alerted through text messaging.

On 1 February, the ship called at Naha Port in Okinawa and was quarantined. On the same day, the 80-year-old man who disembarked in Hong Kong six days earlier tested positive for COVID-19. Having a fever, he went to the hospital and got tested. Hong Kong's Department of Health immediately contacted the agent of the ship's operating company, but the ship did not immediately inform the passengers and they were notified about that on 3 February, two days later. Over the next few days, the cruise ship had shows and dance parties as usual and also continued to open public facilities that attract large crowds, including fitness clubs, theatres, casinos, bars, and buffet-style restaurants.

On the evening of 3 February, the cruise ship returned to Yokohama Port and anchored off the coast of Daikoku Pier without docking. The Japanese government decided to re-

quarantine the ship unusually because there may be infected persons. Officials of the Ministry of Health, Labor and Welfare boarded the ship for quarantine.

On 4 February, tests revealed infections of 10 out of 31 people tested. The authorities immediately decided to isolate all passengers on board for 14 days. On 5 February, the authorities announced positive test results for SARS-CoV-2 for 10 people on board, the cancellation of the cruise, and that the ship was entering quarantine for 14 days based on World Health Organization guidelines. A total of 3,700 passengers and crew were quarantined by the Japanese Ministry of Health, Labor and Welfare for what was expected to be a 14-day period, off Yokohama.

This is the Petri Dish moment that suggests our cause and correlation of what might be the real cause of this virus. Also SARS-CoV-2 is a common cold virus.

Notice on this 14 day quarantine, passengers were confined to their cabins with little activity and entertainment, except for the newest in 5G installed electronics, cellular phones, wireless Wi-Fi Internet. I can't imagine a single passenger on a cruise without a cell phone. The picture is coming into sharper focus as each day of quarantine passes. Each day shows an increase in those being infected yet restricted to their rooms.

On 7 February, the total number of people on board with confirmed SARS-CoV-2 infections grew to 61.

Another three cases were detected on 8 February, bringing the total to 64.

On 9 February, six cases were detected, while another 65 were detected on 10 February, bringing the total to 135. The numbers overwhelmed local medical facilities, and stricken passengers were divided into three groups according to condition, and evacuated to suitable locations, allowing intensive care to perform as intended.

On 11 February, 39 more people tested positive for the virus, including one quarantine officer, bringing the total to 174. Passengers with confirmed cases were reported to be taken ashore for treatment.

On 13 February, 44 more people tested positive for the virus, bringing the total to 218.

On 15 February 67 more people were reported to be infected, bringing the total to 285.

On 16 February 70 more people were reported to be infected, bringing the total to 355.

The next day on 17 February, the Ministry of Health, Labor and Welfare confirmed 99 more cases, raising the total to 454, 33 of whom were crew members.

On 18 February, another 88 cases were confirmed, bringing the total to 542.

On the morning of 17 February (Japan time), two U.S. government-chartered planes departed for the United States, carrying hundreds of U.S. citizens who were passengers of the cruise ship. Among about 400 cruise passengers, 328 boarded the planes, excluding those who expressed their intention to stay on the ship and 44 under treatment in Japan. The U.S. government initially asked Japan to keep them on board for 14 days based on the CDC guideline despite the proposal by the Japanese government to bring American passengers back home early. The U.S. government, however, changed its policy to return home on 15 February. The first plane landed at Travis Air Force Base in California at midnight on 16 February (U.S. Time), and the other plane landed at Joint Base San Antonio in Texas on the early morning of 17th (U.S. Time). Canada, Hong Kong, Australia and Italy also followed the United States within a few days. There were 164 Australian passengers, of which 24 were infected, and eight were sent for 14 days quarantine to Darwin.

On 18 February, Michael J. Ryan, Executive Director of the World Health Organization's Health Emergencies Programmed, said that Japan's measures to quarantine passengers and staff on board at the Yokohama Port for two weeks were preferable to having them scattered throughout the world. However, he said that he was disappointed at the continued increase in the number of infected people.

On 18 February, Kentaro Iwata, an infectious disease expert at Kobe University, uploaded a video on YouTube in which he raised questions about the measures taken to prevent epidemics on the "Diamond Princess" shortly after boarding the ship. He removed it on 20 February.

On 19 February, passengers with negative test results began to disembark.

On 20 February, the World Health Organization's Director-General reported the total number of the cases outside of China to be 1,076, and stated that over half of these cases occurred among the passengers on the Diamond Princess. By late March, it was stated that 712 of 3,711 people on the Diamond Princess, or 19.2%, had been infected by COVID-19.

By 1 March, all passengers and crew members had disembarked from the ship.

In early March 2020, Indonesia evacuated 69 Indonesian crew of Diamond Princess, after their COVID-19 test results in Japan were negative. However, an Indonesian naval hospital ship bringing them to Sebaru Island for a mandatory quarantine period had two crew ill. All were tested again; 67 passed the second test, but two did not and were retested with a more accurate, different test, with one negative and one positive result. The 68 people with negative tests disembarked at Sebaru Island for observation and the one positive case was evacuated by helicopter to Persahabatan Hospital. Eventually, all 69 crew members received negative COVID-19 test results.

Passengers on the Diamond Princess cruise ship got their first piece of bad news on February 4: 10 people on board had tested positive for the novel coronavirus.

It was the beginning of a nearly month-long ordeal of quarantine orders and disease response that has been widely criticized as a failure. As of Friday, Japan's Ministry of Health reported that 705 people from the ship had contracted the virus, as well as one quarantine officer who worked on the ship. The US Centers for Disease Control and Prevention (CDC) announced Friday that 44 passengers flown back to the US had tested positive.

"The quarantine was not justified, and violated the individual rights of the passengers while allowing the virus to literally pick them off one-by-one," Dr. Amesh Adalja, who works at the Johns Hopkins Center for Health Security, told Business Insider in an email.

Adalja and other experts have criticized the decision to keep passengers and crew on the ship and said poor hygiene practices helped spread the virus.

"I'd like to sugarcoat it and try to be diplomatic about it, but it failed," Dr. Anthony Fauci, the director of the National Institute of Allergy and Infectious Diseases, told USA Today. "People were getting infected on that ship. Something went awry."

On February 1, a man who'd been on the Diamond Princess tested positive for the coronavirus six days after leaving the ship. The cruise docked in the port of Yokohama, Japan, three days later.

The man, who is from Hong Kong, boarded the ship in Japan and stayed for five days, then disembarked in his hometown.

When it docked in Yokohama, the ship had 3,711 crew members and guests.

According to The New York Times, it took Japanese officials more than 72 hours to lock down the ship after they were notified about the Hong Kong man's case.

By the following morning, 10 people on the ship had tested positive for the virus. Japan's Ministry of Health placed the entire boat under a 14-day quarantine.

Passengers had already been on the ship for two weeks because the quarantine came at the end of their scheduled cruise.

Japanese health officials tested passengers and transported those who tested positive to health facilities on land.

However, testing takes a day or more because it involves collecting and submitting spit and mucus samples.

Spencer Fehrenbacher, an American grad student on the ship, told *'Business Insider'* he experienced a "wall for information" about test results. He said on February 6 that he

had been waiting to get his own results for two days. He eventually learned that he tested negative.

Other passengers reported long delays in getting tested at all, even after they reported symptoms.

From the beginning, those quarantined on the ship reported confusion and a lack of information.

"There wasn't much information," passenger Masako Ishida told The New York Times on February 5. She said many passengers did not immediately understand that they may have been exposed to the coronavirus.

Passengers tallied the ambulances lined up on the pier to get a sense of how many infections had been confirmed on the ship, The New York Times reported.

Fehrenbacher told the *'Business Insider'* that he stood very close to a woman who was clearly sick when he got his medical screening.

"You could hear that cough that's deep down in your lungs. I empathized with her and felt so bad," Fehrenbacher said. But he said he also recalled thinking to himself, *"OK, I don't want to be in this room."*

Ishida also reported concerns about the screenings: *"They didn't put the thermometer into our ears properly,"* she said.

She said her husband's first temperature measurement was about 90 degrees Fahrenheit, well below the normal body temperature. When she asked for a second measurement, it was 95 degrees.

Ishida added that meals had been chaotic in the first days as well, with breakfast arriving at 2 p.m., quickly followed by lunch.

Three days into the quarantine, people on the ship began unfurling signs that read *"Lack of medicine"* and *"Thank you, media."*

On February 11, a crew member told passengers that as many as 1,850 people on board (who had not expected to be on the ship for so long) had requested and received more prescription medications.

Passengers were confined to their rooms, the least expensive of which have no windows or balconies.

At about 160 square feet, the rooms are the size of a shipping container and include two twin beds, one queen bed, or, in some cases, bunk beds.

Honeymooners Alan and Wendy Steele told *The Washington Post* that they were going *"stir crazy"* on February 5.

"We're basically being treated like we're prisoners and criminals at the moment; that's how we feel," Alan Steele said. He added that lunch on the first day had been stale bread with ham.

The next day, the ship's operator, Princess Cruises, said it had *"activated new in-room entertainment offerings,"* including games, trivia, arts and crafts, movies, eight new TV channels, and newspapers printed in 36 languages.

Passengers tweeted pictures of their meals and gave the room service mixed reviews.

***"We began to live for meal times,"* Rachel Torres, another honeymooner on the ship, wrote in a commentary in *'The Dallas Morning News'*.**

"We developed a system," she [wrote](#). "When we heard the carts roll down the hallway, we rushed to put on masks, swing the balcony door open, and fling the door to the hallway open for meal collection so our friends in inside staterooms across the hallway could feel some fresh air and sunshine."

Passengers were given face masks.

The masks are not great at preventing wearers from contracting the novel coronavirus, but they may help keep sick people's germs from passing to others.

Those in the interior windowless cabins were allowed to walk around the deck for a few minutes each day with face masks on.

Officials advised passengers to stay 6 feet apart from each other.

Experts criticized the decision to keep people on the ship.

"From a virologist's perspective, a cruise ship with a large number of persons on board is more an incubator for viruses rather than a good place for quarantine," Anne Gatignol, a microbiologist who studies viruses at McGill University, told the 'Montreal Gazette'.

Keeping people in a confined space may have helped the virus spread.

"They've basically trapped a bunch of people in a large container with [the] virus," David Fisman, an epidemiology professor at the University of Toronto, told Vox. "So [I'm] assuming 'quarantine' is generating active transmission." [Absence of any idea that 5G is the issue!]

"Cruise ships are made of surfaces that are really sticky for viruses," Kelly Hills, a bioethicist, told the 'Business Insider'.

"Lots of chrome and polished metal, things with grooves and nicks and scratches. It just makes a good home," she said.

The infectious-diseases expert Kentaro Iwata said poor hygiene practices on the ship made him "so scared" of contracting the virus when he visited.

"The cruise ship was completely inadequate in terms of the infection control," Iwata says in a YouTube video. "There was no distinction between the green zone, which is free of infection, and the red zone, which is potentially contaminated by the virus."

As the case count on the ship continued to rise, some Indian crew members begged their government to rescue them.

The group shared a series of videos on Facebook. One of them, Binay Kumar Sarkar, told Business Insider that the situation on the ship was "out of control."

"There are lots of people who don't have coronavirus, so why are we all being confined here?" he said. "Please save at least those of us who are healthy."

Crew members brought meals to passengers' rooms, but the workers continued to eat together in the ship's mess hall.

According to a 'New York Times' report, infected crew members ate in the mess hall alongside their coworkers.

"We all are really scared and tense," Sonali Thakkar, a worker on the cruise ship, told CNN.

The 'New York Times' reported on Saturday that 85 crew members had tested positive for the virus, and Japan's Ministry of Health announced that an additional 55 crew members tested positive on Sunday. That brought the total to 140 infected workers.

"There are many places where we all are together, not separated from each other," Thakkar told CNN. "Especially when we sit in the same mess hall and eat together, the place where it can spread very fast."

Dr. Norio Ohmagari, director of Japan's Disease Control and Prevention Center, later told CNN that keeping the crew on board had been a "tough decision."

"We suspected some of the cruise staff may have already been infected, but ... they had to operate the cruise ship itself, they had to see the passengers, they had to deliver the meals," Ohmagari said.

Another government advisor, Dr. Shigeru Omi, said that officials were "very grateful" to crew members at a press conference on February 24.

"On human rights, of course we sympathize, but you know, as long as the passengers are still there, they have to provide the service," Omi said.

As the case count rose past 200, passengers expressed fear.

"I can't wrap my head around the fact that I could die from this cruise," Gay Courter, a 75-year-old novelist confined to a cabin on the ship with her husband, told 'The Wall Street Journal'.

"The 14-day stipulation was meaningless in a context with new infections and new transmission episodes," Adalja said.

"The whole idea of the cruise-ship quarantine was ill-conceived, and the resultant slew of infections it spawned was completely predictable," he added.

On February 12, the Japanese Ministry of Health announced that some passengers older than 80 could finish their quarantine on land.

The [offer](#) applied to passengers over 80 who had windowless cabin rooms or preexisting medical conditions. They had to test negative for the virus before they could leave the ship.

On Valentine's Day, passengers were gifted roses, chocolates, and (courtesy of the Japanese Health Ministry) new iPhones with a special app for medical support.

Crew members danced below deck and children drew pictures. The first group of healthy people was also allowed to leave the ship that day: 11 passengers older than 80.

After nearly a month on board, the remaining passengers finally began to leave the ship on February 16.

Officials in Canada, Australia, Hong Kong, and the US are requiring their residents to undergo an additional 14-day quarantine once they return home.

By then, the number of people infected with the coronavirus on the ship had skyrocketed to 621 — more than half of all cases outside China.

More than half of the infected people (322) showed no symptoms at all, which suggests that some coronavirus carriers in China could be going undetected.

Researchers still aren't sure to what extent people can spread the virus when they have no symptoms, though a report published on February 21 documented a case in which a woman who was asymptomatic passed the coronavirus to five family members.

Fourteen US citizens who tested positive for the virus flew home in an isolation box on the back of a plane with other healthy Americans who had been on the ship.

Their tests came back positive after they already left the ship and were traveling to the plane, the State Department and Department of Health and Human Services said in a joint statement on February 17.

The agencies also said the passengers had been evaluated, and *"all were deemed asymptomatic and fit to fly before being processed for evacuation."* In all of this, no one mentions that the particular SARS-CoV-2 is really only a low-level cold virus.

But on Friday, the CDC reported that 30 of the other US evacuees had tested positive for the coronavirus.

Those people had sat in the two evacuation planes' main cabins.

Dr. Nancy Messonnier, the director of the CDC's respiratory-diseases center, had warned this could happen: *"We do think based on epidemiology and risk assessment that there may be additional cases,"* she said in a press conference on February 21.

Scott Pauley, a spokesperson for the CDC, told The San Francisco Chronicle that *"we don't want to take [the tests done in Japan] at face value."*

Fehrenbacher said one of the infected people sat behind him on the plane.

"Realizing I spent the last 12 hours right in front of her was concerning, to say the least," he told Grand Canyon University, his alma mater.

"I'd spent 12 or 13 days in isolation to now be in close proximity with people hacking up a lung — it's hard not to be worried," he added. *"The thought of taking off my mask seemed ludicrous to me. But the woman next to me was snacking the entire flight."*

CDC officials argued against the decision to have sick and healthy people fly on the same plane.

The 'Washington Post' reported that CDC officials lost that argument on the tarmac, then insisted they be left out of the news release announcing that 14 infected Americans had shared a plane with more than 300 others.

President Donald Trump agreed that sick people should not fly on the same plane as people who hadn't tested positive for the virus, *The Post* [reported](#). He was not informed of the change of plans.

Six people who were on the cruise ship have died, according to Japanese officials.

Japanese officials announced the first two deaths on February 18. The passengers — an 87-year-old Japanese man and an 84-year-old Japanese woman — were taken to local hospitals on February 11 and 12, and both had underlying health issues, *The 'New York Times'* reported, citing the Japanese broadcaster NHK.

The third death, reported Sunday, was a Japanese man in his 80s who'd been among the first cases on the ship, ABC News reported. The fourth death, reported Tuesday, was a man from Tokyo in his 80s. The first four deaths were in their 80's.

On Friday two more people died: a Tokyo woman in her 70s and a UK man of unspecified age.

Crew members finally began leaving the ship on Thursday, though Japan's Ministry of Health said it would take several days to unload them all.

The ministry said in a statement that 240 crew members who had tested negative will be transported to the National Tax College in Wako, a campus outside Tokyo, for another 14 days of quarantine.

Princess Cruises is preparing the ship to set sail again on April 29.

"The expectation is that the ship would be fully sanitized and then taken into dry dock for a period of time," Negin Kamali, the public-relations director for Princess Cruises, told The Wall Street Journal.

A year later the story of the "Diamond Princess" remains a primary subject as to this alleged Covid-19 fraud. Since the incident occurred many questions remain unanswered. Of the 14 passengers who died on the "Diamond Princess", the data shows 4 were in their 80s; 6 were in their 70s; 1 was in the 60s; and 3 have no known age of death.

Since then, 40 cruise ships have had alleged cases of Covid-19. 14 U.S. Naval ships have also had alleged cases of Covid-19, with 3 deaths. 6 hospital ships also have had alleged cases of Covid-19. This is a grand total of 60 ships reporting alleged cases of Covid-19. Still the story line is this is an airborne virus, but no real proof of existence other than it is the common cold.

What stands out here or what do they have in common, that links them together in this larger picture? They all recently had newly installed 5G satellite receivers.

As we look back on the data provided by health agencies such as the CDC, the WHO, we see something askew or incongruent in this picture.

712 total on board out of 3,711 were sickened – or 19.18%

567 passengers out of 2,666 were sickened – or 21.27%

145 crew out of 1,045 were sickened – or 13.86%

14 deaths out of 3,712 – 0.377%

In the events leading up to the quarantine of the "Diamond Princess" could it be that the "Diamond Princess" was a deliberate set-up, not an accident per se? 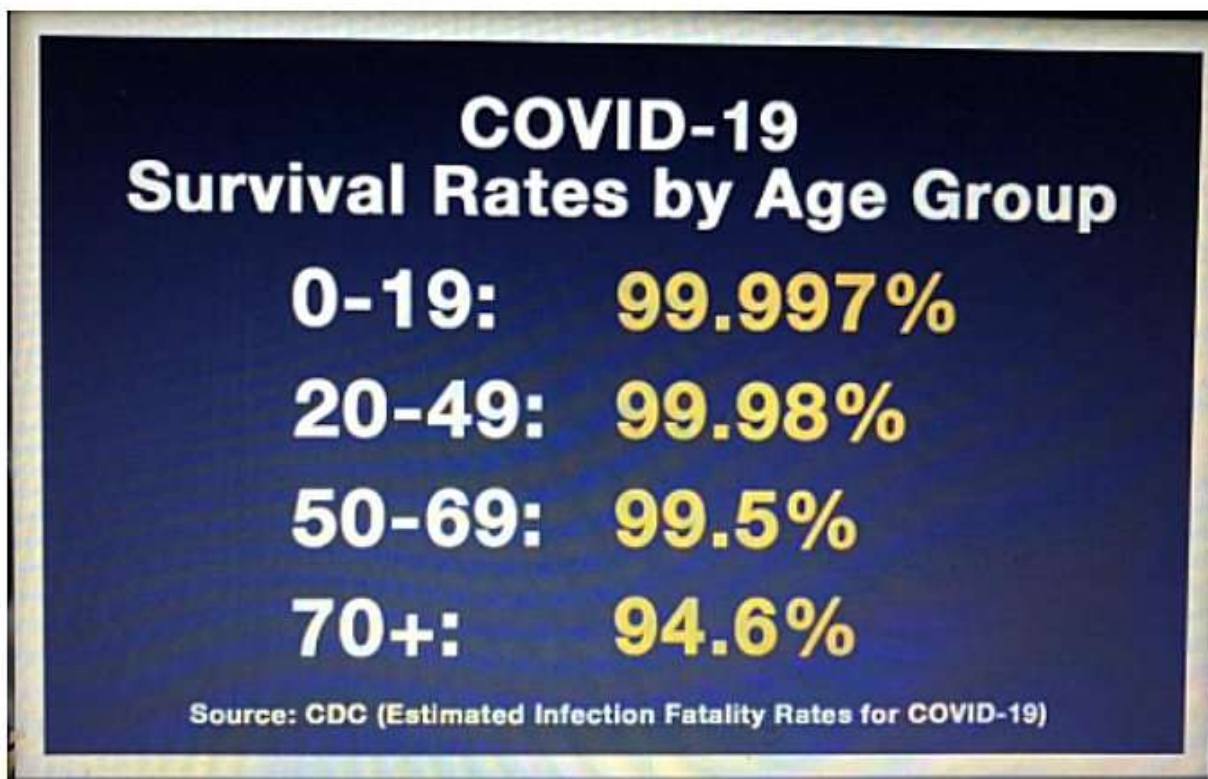

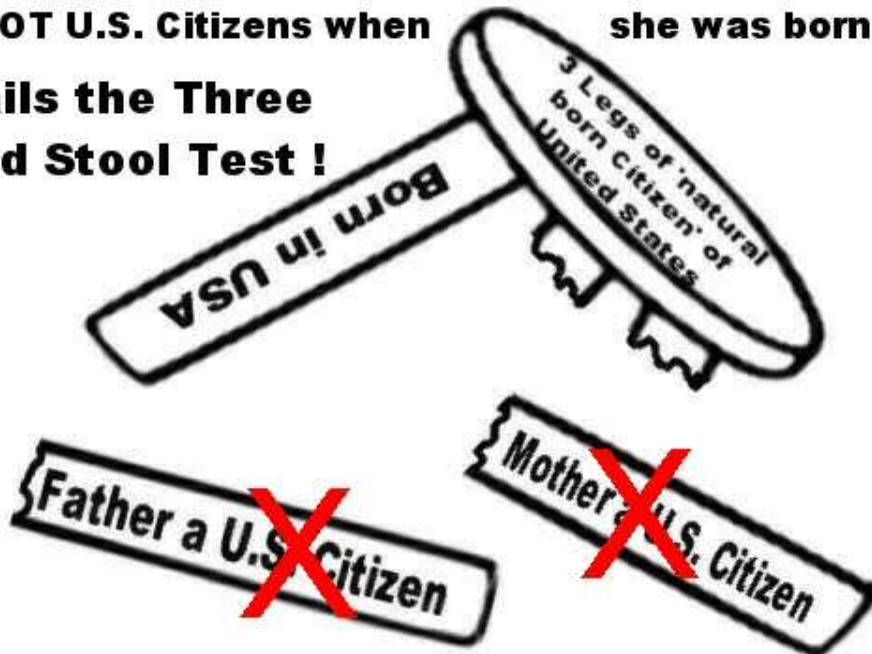

God Not Welcome in Congress?

Could it really be possible that in the U.S. House of Representatives, during a deliberation on the Equality Act that proposes to elevate homosexual behavior, a statement was made declaring: **"...what any religious tradition describes as God's will is no concern of this Congress."**?



The setting: a deliberation on the Equality Act that proposes to elevate homosexual behavior to a special protected status under the anti-discrimination code. Another congressman had just read Deuteronomy 22:5 (forbids crossdressing) into the record to illustrate the Biblical view of transgender deviancy.

"The woman shall not wear that which pertaineth unto a man, neither shall a man put on a woman's garment: for all that do so are abomination unto the LORD thy God."

The congressman reading the Deuteronomy verse was specifically targeting the transgender (gender identity) aspect of homosexuality. The greatest concern about the Equality Act is in this area. Making it illegal to discriminate against people who claim they are in the wrong body will disrupt many areas of civil society.

One of those areas that have been getting considerable attention lately is in women's sports. Men who decide they are women in a man's body are winning sports awards in contests against women athletes. The state of Connecticut has approved this

foolishness and men have stolen trophies in at least 15 events from the girl athletes. Then the girls must dodge these men in the dressing rooms and restrooms.

Another disturbing aspect of transgenderism teaches children that before they reach puberty they may possibly be in the wrong body. If so, then, “we can sneak you away (sometimes without parental consent) for puberty blockers and later, surgery to make you into the true you. Never mind that it will probably totally destroy your general health and prevent you from ever having any babies.”

But anyone who tries to talk you out of it may end up in jail for performing illegal “conversion therapy.”

Several states have passed laws against any professional counselor who attempts to help someone overcome a same-sex attraction or better to accept their birth sex. If this becomes Federal law, pastors could fear even praying with someone over their sexuality.

Speaking of jail, this Equality Act specifically nullifies the 1993 Religious Freedom Restoration Act that protects churches, Christian owned businesses, and parachurch organizations against lawsuits, fines and imprisonment for refusing transgenders from joining and homosexuals from leadership.

Church leaders are alarmed by a provision forbidding discrimination for gender identity in “any stadium or place of establishment that provides exhibition, entertainment, recreation, exercise, amusement, gathering, or display.” Churches that have changed from “worship services” to worship “gatherings” should note this terminology. Pastors who refuse to officiate same-sex weddings could be sued.

For several years, some Christian-operated businesses have been under attack such as cake bakers and florists who refused service to weddings and ceremonies that they deemed sinful. These are covered by a provision in the Equality Act forbidding discrimination by “any establishment that provides a good, service, or program, including a store, shopping center, online retailer, or service provider, etc.”

Jack Phillips of Masterpiece Cake Shop in Colorado Springs, Colorado has been sued three times for refusing to cooperate in homosexual ceremonies. Florest Baronella Stutsman faced a fine of over \$100,000 dollars by Washington state for refusing to create flowers for a same-sex wedding. These were state actions, but the Equality Act would codify these into Federal law cancelling any state freedoms that now exist.

A possible scenario might include a lawsuit against a food service that refuses to cater a transition party for a transgender who then approaches a church for a same-sex marriage ceremony and threatens legal action if they refuse.

When we think of this as absurd, we need to remember that 20 years ago we would not have believed a scantily dressed drag queen reading children's books to kiddies in the local library.

As Jesus warned in Luke 17 that, as it was in ***“the days of Noah”*** or in ***“the days of Lot,”*** the debauchery would become so widespread that sudden destruction was the only solution.

God demonstrated to Jonah (See "Jonah" by Jack T. Chick on Amazon) His concern for the children in Nineveh (Jonah 4:11). Will He not be equally concerned when we prescribe puberty blockers for 12-year-olds and genital mutilation at 18?
