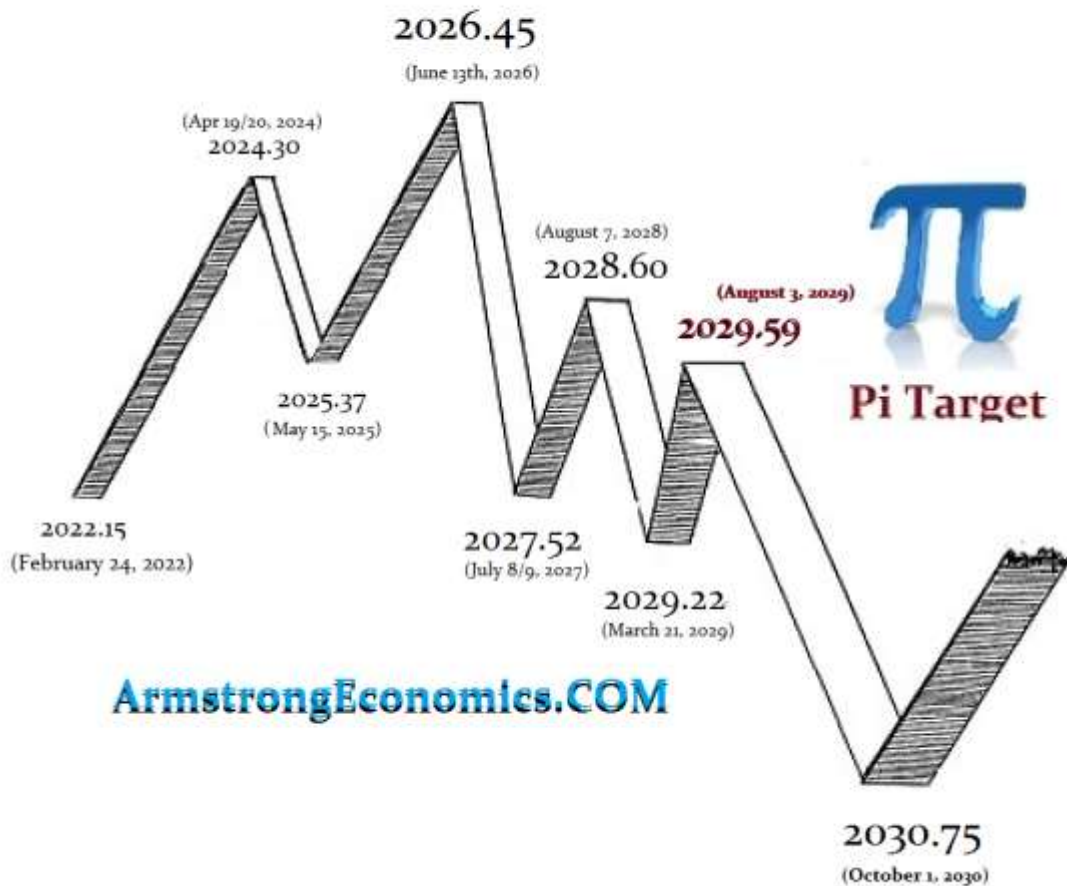

World Bank, IMF, WEF, G20, Gates Foundation, EU, and India push Digital ID

The president of the World Bank wants governments to create digital identities and link them to private sector and existing infrastructures, joining a host of other global interests

The president of the World Bank wants governments to create digital identities and link them to private sector and existing infrastructures, joining a host of other global interests, [The Sociable](#) reports.

World Bank president Ajay Banga told the World Bank Group’s inaugural Global Digital Summit that digital ID should be embraced in all nations. He also called for governments to own the IDs, so they can guarantee their citizens privacy and security.

“Creating a digital identity platform for citizenry is kind of foundational and I believe your government should be the owner of your digital ID; private companies should not own that,” said the World Bank president.

“It is the social contract of the citizens of their countries to have an identity, a currency and safety. We should not take that away from them.”

“They should have the digital identity; that digital identity should guarantee the privacy of that citizen; it should help them with their security, but the government should give the identity.”

“Once you do that, then connecting them to the infrastructure that a private company, either Ericsson or Verizon, or combinations of them, in fact mostly it’s a combination, then the question is, ‘What do you do with it that requires a digital ID?’ so you can start connecting with that citizen.”

The World Bank president insists government has to have the IDs so they can guarantee privacy. Otherwise, people won't trust the scheme.

“You must ensure that governments guarantee the privacy of that citizen. Because if you don’t do that, you will run into trouble with the acceptance of the idea,” Banga said.

“So, if you want this to be embraced around the world, yes, get the infrastructure, get a digital ID. Get that going and then move from there.”

Digital ID would become a necessary and foundational aspect of financial services, insurance, healthcare, education and the process of starting a new business.

At last year's International Monetary Fund (IMF) Spring Meetings India's digital ID architect Nandan Nilekani said, *"If you think, 'what are the tools of the New World?' Everybody should have a digital ID; everybody should have a bank account; everybody should have a smartphone."*

"Then, anything can be done. Everything else is built on that."

Nilekani strongly advocates a digital public infrastructure (DPI) with the components of digital identity, digital payments systems and mass data sharing.

In 2023, the G20 India Leaders' Declaration stated: *"We endorse the voluntary and nonbinding G20 Policy Recommendations for Advancing Financial Inclusion and Productivity Gains through Digital Public Infrastructure. We take note of the significant role of digital public infrastructure in helping to advance financial inclusion in support of inclusive growth and sustainable development."*

Prior to the G20 Summit, the B20 India Communique recommended that members, *"Roll out digital public infrastructure to boost financial inclusion and healthcare access."*

The conference acronym of RAISE seemed to align technology with UN Sustainability Goals with its themes of *"responsible", "accelerated", "innovative", "sustainable", and "equitable."*

Last November, the United Nations, the Bill and Melinda Gates Foundation, and their partners launched the [50-in-5](#) campaign to help *"50 countries design, launch, and scale components of their digital public infrastructure"* within the next five years.

Despite the objections of a few vocal MEPs, on February 29, the EU parliament adopted an updated regulation to the digital identity wallet. According to a EU press release, *"The EU wallet will be used on a voluntary basis" while "updating the European digital identity framework"*

"During negotiations, MEPs secured provisions to safeguard citizens' rights and foster an inclusive digital system by avoiding discrimination against people opting not to use the digital wallet," the release said.

A briefing adds that *"The wallet is voluntary and free of charge for individuals, while businesses may incur costs. It does not replace existing identification and authentication means but complements them."*

A similar approach in India has drifted over the past ten years, making its digital identity scheme of Aadhaar a must for most dealings.

“Enrolment for Aadhaar is entirely voluntary,” read a government press release from December, 2013. Yet, that same year, Forbes India already reported, *“More and more states and government agencies were making its use mandatory for a host of services, from buying cooking gas to registering marriages and renting houses.”*

in 2017, Reuters reported that, *“Various ministries make Aadhaar mandatory for welfare, pension and employment schemes. Aadhaar made mandatory for filing of income tax returns. Aadhaar holders crosses 1.14 billion.”*

Also in 2017, the Reserve Bank of India clarified that Aadhaar linking with bank accounts was mandatory for certain benefits and subsidies. The “myth-busters page on Aadhaar confirmed this.

Despite court challenges, Aadhar has become needed for just about everything, as *Business Today* noted in May 2022.

“Aadhaar has emerged as the national identity and treated as a preferred/ mandatory identity proof for avail services such as obtaining a SIM card, hospitalization, opening a bank account or availing government subsidies and benefits of various government-run welfare schemes, even for the COVID-19 vaccination.”

Stripe, Substack Demand Financial Details from Authors

Another step towards implementing a Social Credit system

Financial privacy is a right under the constitution, as is free speech.

Under the guise of “credit review”, Stripe is now rolling out a requirement that appears to target conservative or “anti-vax” Substack authors. Stripe is requiring that these authors provide all of their current and historic financial records associated with the bank account into which Stripe deposits Substack subscriber payments (after taking 10% off the top for Substack and 3% for Stripe). Stripe already has information concerning this bank account (including deposits from Stripe), as we have been doing business with Stripe via this account for over two years.

If I or anyone else agrees to these new terms, this newly implemented arbitrary, capricious and overreaching requirement will provide Stripe with complete records of all financial transactions associated with this account. Consequently, this will provide Stripe with comprehensive information on all of my customers, patients and clients, all of my

travel (historic and planned), all of my purchases, and any donations (and donor information). This information from my account and those of any others who comply with this demand can be hacked or sold, provided to the U.S. Government, used to fuel predictive algorithms (AI), used to derive insights into my political orientation, weaponized against me by press or other hostile actors, or used to support future social credit score-based restrictions.

Stripe has a history of financially de-platforming (or de-banking) for political reasons, including removing support for Donald Trump's presidential campaign. Despite its relatively recent entry into the financial transaction business, Stripe has become a major global financial organization, and processed one Trillion U.S. Dollars in payments during 2023, and is now expanding its credit charge program.

Substack requires that authors use Stripe for all Substack-related financial transactions including subscriptions. This policy on all subscriber transactions is despite the availability of alternative payment processing organizations, which refuse to engage in debanking. In other words, Stripe has been granted a monopoly over all Substack transactions, and so if a Substack author wishes to accept paid subscriptions, they must use Stripe. This enables Stripe to function as a gatekeeper for Substack content. Although Substack has touted its commitment to free speech, the reality is far different from the pretty words.

For example, although Substack claims to not permit harassment, there are multiple Substack authors who continually harass and cyberstalk me (and others), including expressing claims that that I am a mass murderer and should be tried and hung. Complaints to Substack fall on deaf ears. Cyberstalking is a crime.

With that in mind, we commit to keeping Substack wide open as a platform, accepting of views from across the political spectrum. We will resist public pressure to suppress voices that loud objectors deem unacceptable. ... Of course, there are limits. We do not allow porn on Substack, for example, or spam. We do not allow doxxing or harassment. We have content guidelines (which will evolve as Substack grows) with narrowly construed prohibitions with which writers must comply. But these guidelines are designed to protect the viability of the platform at the extremes, not act as a filter through which we see the world. There will always be many writers on Substack with whom we strongly disagree, and we will err on the side of respecting their right to express themselves, and readers' right to decide for themselves what to read.

And now this. Stripe is requiring access to all financial transaction records from selected (targeted) authors' bank accounts which receive subscription revenue from their Substack work product. The following is the key clause included in Stripe's demand statement. While the initial message indicates that this is a request, subsequent communication from both Stripe and Substack has demanded that I comply within seven days or Stripe will cease transferring funds into my account.

“When you first set up your Stripe account, we asked you to connect your bank account in order to receive payouts. We are now requesting that you link your bank account, which involves sharing details and activity relating to your bank account with Stripe. This includes your current account balance and transactions, as well as historical transactions.”

In light of this email from Stripe, I reviewed the Stripe “Know Your Customer” (KYC) obligation. (<https://support.stripe.com/questions/know-your-customer-obligations>). The KYC policy derives from requirements that government regulators put upon Stripe such as Passport or driver’s license (<https://support.stripe.com/questions/passport-id-or-drivers-license-upload-requirement>).

While there is a page as a part of the KYC policy that talks about sensitive information, nothing in the sensitive information indicates that a person has to link their account and show all their transaction history. <https://support.stripe.com/questions/why-do-i-need-to-provide-sensitive-information>

Stripe does include a page that talks about required verification information for customers in the U.S. (<https://docs.stripe.com/connect/required-verification-information>). Nothing on this page talks about one having to link an account. In fact, the only thing of interest is that after you have \$500,000 in lifetime transaction, they do require that you provide them with a Social Security Number.

In reviewing the Stripe 2023/2024 U.S. Verification Requirements Update and Services Agreement, I do not see anything that requires a linking of an account to continue doing business. It appears that this may be unfair targeting of this account.

In response to this financial threat, I immediately retained an experienced California-based first amendment Attorney (Mark Meuser of the Dhillon Law Group) to guide my response. This comes at considerable personal expense, but I knew that if I did not respond immediately and appropriately, I would lose my only source of revenue and many others would likely be targeted by the same policy. This was clearly another case of needing to promptly *“do the right thing”* to push back against this new form of censorship, which appears to be an attempt to vacuum up financial transaction data from myself and others which can then be weaponized, traded and/or sold to third parties including the U.S. Government. I have been told to anticipate that the legal case against this new Stripe/Substack policy will require approximately \$100,000 to prosecute.

I have now been contacted by other politically conservative Substack authors who have received the same demand correspondence from Stripe and Substack.

Since Mr. Mark Meuser responded with a formal legal letter to Stripe and Substack one week ago, as of this moment Stripe has NOT followed through with their threat to stop processing Substack subscriber payments.

In their correspondence, Stripe indicates that selected Authors must link the account for Stripe review due to the U.S. Government's KYC policy, and with this KYC policy Stripe is that they are just doing what the government bureaucrats are telling them to do. As such, if they are really being required to link Author accounts because the government is telling them to, they should have no problem producing the evidence that the government has told them to link your account. This evidence has not been provided to date, despite a legal letter sent to Stripe (with a copy to Substack) by the Attorney which I have retained to guide me in my response to this demand.

To date, neither Stripe nor Substack have responded to the legal letter regarding this matter sent a week ago by Mr. Meuser. I have received multiple inquiries by Substack suggesting that I speak personally and informally to their corporate liaison at Stripe, but they refuse to communicate directly with Mr. Meuser, so he has again sent an email requesting a meeting. Based on the nature of their outrageous demands, I have been advised to not enter into informal discussions with Stripe, and have redirected these inquires back to my Attorney.]

HOW NATO POWERS ARE USING THE U.K.'S WORLD WAR I MODEL TO LURE RUSSIA INTO THE NEXT BIG GLOBAL WAR

Using duplicity, deception and secret alliances, the U.K.'s inner circle of top elites led by Nathaniel Rothschild, King Edward VII, and Lord Alfred Milner backed the German Kaiser into a corner and intentionally set the Germans up to blame them for starting the First World War, when in fact it was the British who provoked the Germans to the point where war was the only option.

German generals were caught strategizing several weeks ago on how to bomb Russia's main bridge to Crimea. This would be an act of aggression that Russian President Vladimir Putin described as guaranteed to draw a harsh military response from Russia, possibly even including a nuclear strike against Berlin.

And that has led to an admission by German officials that their military is woefully unprepared to take on Russia. If German generals and politicians truly want to provoke a war with Russia, they had better slow down and wait for their military to catch up to the political rhetoric coming out of Berlin.

A March 14th article by John Cody at *Remix News* shows that the German Army lacks the personnel, equipment and infrastructure to wage a major war of any kind, let alone with a nuclear-armed military superpower like Russia.

"Germany's own military and government are painting such a dire picture of the armed forces that there are now calls from some of the most powerful politicians in the country to reinstate mandatory military service," Cody writes.

Yes, a military draft. A video produced by *Remix News* details testimony provided by Eva Högl, German Parliamentary Commissioner for the Armed Forces, who provided catastrophic details about the state of the German military. It is shocking in terms of its candor regarding the current state of the German armed forces.

She finds it “*really impressive*” that Germany has emptied out its military defense stocks by handing it over to Ukraine to be wasted in a losing war with Russia. That sounds like an admission of treason in the wide open.

But wait. There’s more. Germany knows it is incapable of taking on Russia so it is negotiating a secret deal with the insane leaders of two other European countries, France and Poland, for the very purpose of sending troops into Ukraine separate from NATO, although I do not believe this could truly be done without the acquiescence of Washington and London.

An organization called the **Weimar Triangle** – composed of France, Germany and Poland – has been in existence since 1991 at the fall of the Soviet Union.

The stated purpose of the Weimar Triangle was to assist Poland’s emergence from Communist rule. It’s strange that it still exists but it may have found a new purpose – instigating World War III with Russia.

According to Wikipedia, “the Weimar Triangle exists mostly in the form of summit meetings between the leaders of the three countries and of their foreign ministers. The collaboration between member states includes inter-parliamentary contacts, **military**, scientific and cultural co-operation. The most recent summit of leaders occurred in Paris on June 12, 2023.”

There’s been almost no media coverage of it, but *Reuters* reported yesterday, March 13, that the three nations of the Weimar Triangle are meeting Friday, March 15, in “*hastily arranged talks*” regarding how to move forward in aiding Ukraine in its war against Russia. This meeting may produce an agreement, possibly secretive, to build up their military personnel using conscription and other means for the purpose of ultimately inserting some combination of French, German and/or Polish troops into the Ukrainian battlefield against Russia.

Russia has won phase one of this war and the NATO nations are having to get creative if they want to continue the fight. And there is absolutely no question in my mind that they do want to continue the war against Russia. Why? Because Russia, even more than China, is the focal point of the BRICS coalition of nations that are challenging the U.S.-led world economic order which is tied to the U.S. petro dollar and U.S. military supremacy.

All of the military experts I’ve been listening to over the past two years seem to miss the economic reasons for why the war will widen beyond Russia and Ukraine. It was never

about Russia and Ukraine. It was about challenges and shifting realities related to the global economic order.

Military analysts have talked in terms of Ukraine or Russia winning or losing the war but few, if any, have really seriously considered the possibility of a third outcome – that neither Ukraine or Russia will “win” this war because the real war is not between Ukraine and Russia. It is between NATO and its allies and Russia and its allies. Ukraine is just a proxy and it’s about to be forced to limp off the battlefield. If a new influx of troops doesn’t come from somewhere, the war is over and Russia wins. But because of the economic reasons stated above and other reasons related to the West’s liberal social agenda that is at odds with Russia’s more conservative culture, NATO won’t let that happen.

Take for example, the “*husband*” of the U.S. Secretary of Transportation Pete Buttigieg, leading a group of children in a “*Pledge of Allegiance to the Rainbow.*” This would never be welcomed or allowed in Russia. Putin sees himself as the guardian of Orthodox Christianity.

So, if NATO can figure out a way to insert troops into Ukraine now that Ukraine has lost the war, and do it under the auspices of it being “*separate from NATO,*” then look for them to do exactly that.

The question is, will Putin buy the phony excuse that NATO has nothing to do with the fact that he’s now got Polish, German and French troops to fight in his back yard? When troops arrive in Ukraine from France, Germany and Poland, will he play along and say, oh, this is a separate endeavor and not really NATO, even though all three countries are NATO members? I don’t think so. I would bet against it. But, this is exactly what NATO wants. It’s hoping to trick Putin into invading a NATO country.

The lie works something like this: French, German and Poland troops fighting in Ukraine are not doing so as part of NATO, but if Putin responds to this provocation by launching any direct attacks on cities or infrastructure in France, Germany or Poland, then he has “*attacked*” a NATO country and all of NATO now has the legal pretense to invade Russia. Remember, the U.S. dominates the NATO alliance.

I know it sounds crazy but look who is in charge of these NATO countries. They are all madmen and puppets of the World Economic Forum, the United Nations, the British Royal Family and the intel agencies in Washington and London.

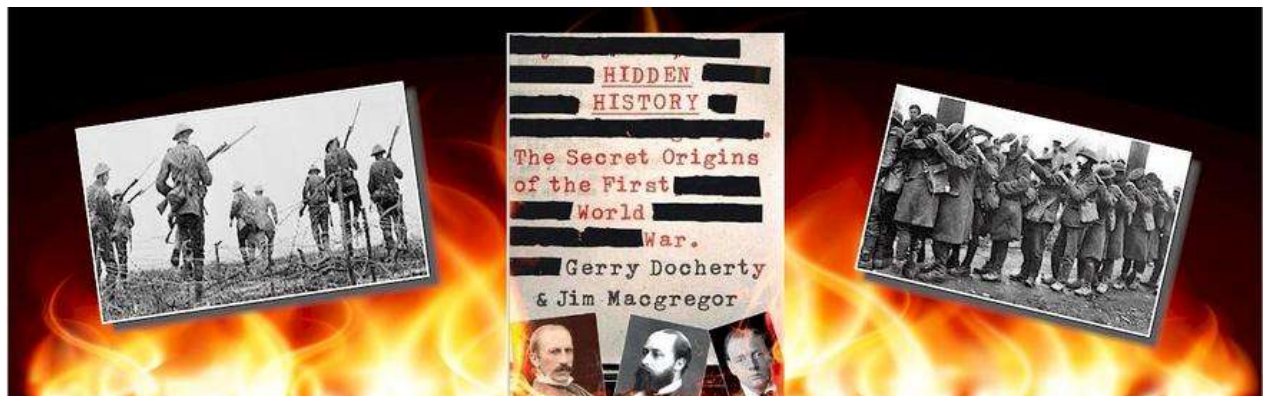

But before they can launch World War III against Russia they must position themselves as the “*victim*” by tricking Russia into attacking one of their NATO members. The Western media will

be fully on board with this international chicanery and will intensify its propaganda war against Russia, characterizing that country and its leader as the “aggressor.” They will continue with the big lie about Putin wanting to “re-establish the old Soviet Empire.” Even though they have zero evidence of that, they will treat it like a foregone conclusion. History repeating itself?

Dr. David Martin: Almost 20 years ago the spike protein was known to be bioweapon

In a September 2023 lecture in Dornach, Switzerland, Dr. David E. Martin detailed how it is known that SARS-CoV-2 is a man-made biological weapon whose development began 58 years ago.

Dr. Martin said that the "coronavirus" virus was first described in 1965. Two years later, healthy British military personnel were infected with coronavirus pathogens from the US *"as part of our biological weapons program."*

In 1992, Ralph Baric at the University of North Carolina, Chapel Hill, took a pathogen that used to infect the gut and lungs and altered it with a chimaera to make it infect the heart, causing cardiomyopathy. This research was part of the effort to develop an HIV vaccine.

The Covid injections were 19 years in the making by the time they were rolled out. These injections were rolled out despite the mRNA spike protein being publicly referred to as a bio-weapon almost 20 years ago. - 2016 – Proceedings of the published National Academy of Sciences article [‘SARS-Like W1V1-COV Poised for Human Emergence’](#). W1V1-COV refers to the first Covid-like virus that was produced by the Wuhan Institute of Virology. The article states that the virus is ready for release and describes in detail how it can best be released.

He also exposed more outrageous Covid crimes that include collusion, racketeering and criminal conspiracy murder.

Dr. Martin named the chief culprits as Peter Daszak, Ralph Baric, Jeremy Farrar, Chris Elias, Tedros Ghebreyesus, Bill Gates, Anthony Fauci, the World Health Organization, the Defense Advanced Research Projects Agency ("DARPA"), the United Nations, Rockefeller Foundation, the Wellcome Trust and the Gates Foundation.

To avoid criminal investigation or responsibility, the GAVI Vaccine Alliance's research projects have been placed under the World Health Organization ("WHO") and, according to the WHO Charter, they cannot be investigated or prosecuted for crimes committed. GAVI, based in Geneva, Switzerland, also enjoys diplomatic immunity and cannot be prosecuted by the local authorities.

To help with the transition and change the minds of other doctors and scientists, Rockefeller gave more than \$100 million to colleges, hospitals and founded a

philanthropic front group called the “General Education Board”. This is the classic carrot and stick approach.

• *"Dear representatives of indigenous communities and dear men and women of science, I thank you for your efforts and I encourage you to draw from the patrimony of the wisdom of your forebears and from the fruits of your scientific research the vital energy needed to continue to cooperate in the service of truth, freedom, dialogue, justice and peace." A group of 10 bishops from three different Methodist churches in the United States embarked on a study pilgrimage in Rome, Italy, from March 5-8, 2024. The bishops were drawn from the African Methodist Episcopal Church, the Christian Methodist Episcopal Church, and The United Methodist Church; all three churches are member churches of the World Methodist Council, the international Christian communion of Methodist, Wesleyan, and Uniting churches. **The three churches underwent separation during the 19th century due to the sin of slavery and racism. Since 2012, the churches, along with 3 other Methodist churches, are in a special full communion relationship.**

The trip was organized by the Methodist Ecumenical Office Rome with the generous support of the Kentucky-based Magee Christian Education Foundation. The Rev. Dr. Jean Hawxhurst, ecumenical staff officer of the Council of Bishops of The United Methodist Church, also provided leadership, collaboration, and program development for the study pilgrimage.



The bishops began their program on March 5th with a visit to the necropolis under St. Peter's Basilica, where the group prayed the Lord's Prayer near the tomb of Peter the Apostle.

During their visit to Rome, the bishops met with leaders from various departments of the Vatican to learn about dialogue, theologies of Christian unity, and Methodist-Catholic

relations. The delegation first met with H.Em. Cardinal Kurt Koch of the Dicastery for Promoting Christian Unity along with dicastery officials to discuss current trends in the modern ecumenical movement and the need for greater consensus on the definition and goal of Christian unity. Additionally, the delegation learned about the Catholic Church's synodal process at the Synod Office, where they were welcomed by Sr. Nathalie Becquart XMCJ, undersecretary of the Synod Office, and taught by Synod official Sr. Marie Kolbe Zamona.

The delegation of 10 bishops from the African Methodist Episcopal Church, Christian Methodist Episcopal Church, and The United Methodist Church visited the Synod Office of the Catholic Church to learn about the synodal process of the Catholic Church. The delegation was greeted by Sr. Nathalie Becquart XMCJ, undersecretary of the Synod Office, and briefed by Sr. Marie Kolbe Zamora, a Synod official. The encounter was marked by listening, mutual learning, and sharing about how Methodists and Catholics seek to be listening churches.

The bishops also visited the headquarters of the Methodist-Waldensian Church in Italy and the Federation of Protestant Churches in Italy. At the Methodist-Waldensian headquarters, the delegation was received by Deacon Alesssandra Trotta, a Methodist deacon serving as the moderator of the General Board (Tavola Valdese), and Pastor Luca Anziani, president of the Methodist permanent committee. The Methodist Church in Italy and the Waldensian Church formed a union in 1975. Pastor Luca Baratto, executive secretary, welcomed the group to the Federation of Protestant Churches in Italy and overviewed the Federation's ministries. Ms. Marta Bernardini and Ms. Fiona Kendall of Mediterranean Hope presented on the Federation's work with migrants and refugees. Additionally, the Rev. Sarah Mae Gabuyo, a United Methodist elder serving as the pastor of Ponte Sant'Angelo Methodist Church in Rome, led the group in a time of prayer during their visit to the church.

Deacon Alessandra Trotta, moderator of the General Board of the Union of Methodist and Waldensian Churches, and Rev. Luca Anziani, president of the Methodist Churches in Italy, met the pan-Methodist bishops to share the history and mission of Methodists and Waldensians in Italy, their church unity, and models of sharing and growing as diverse churches together.

Data will be worth more than gold as we move forward with a cashless society. The Canadian Press outlined the true motive in plain sight: "*One of the biggest areas of growth is in credit assessments. Under open*
